FIG. 3 is an opposing side view thereof;

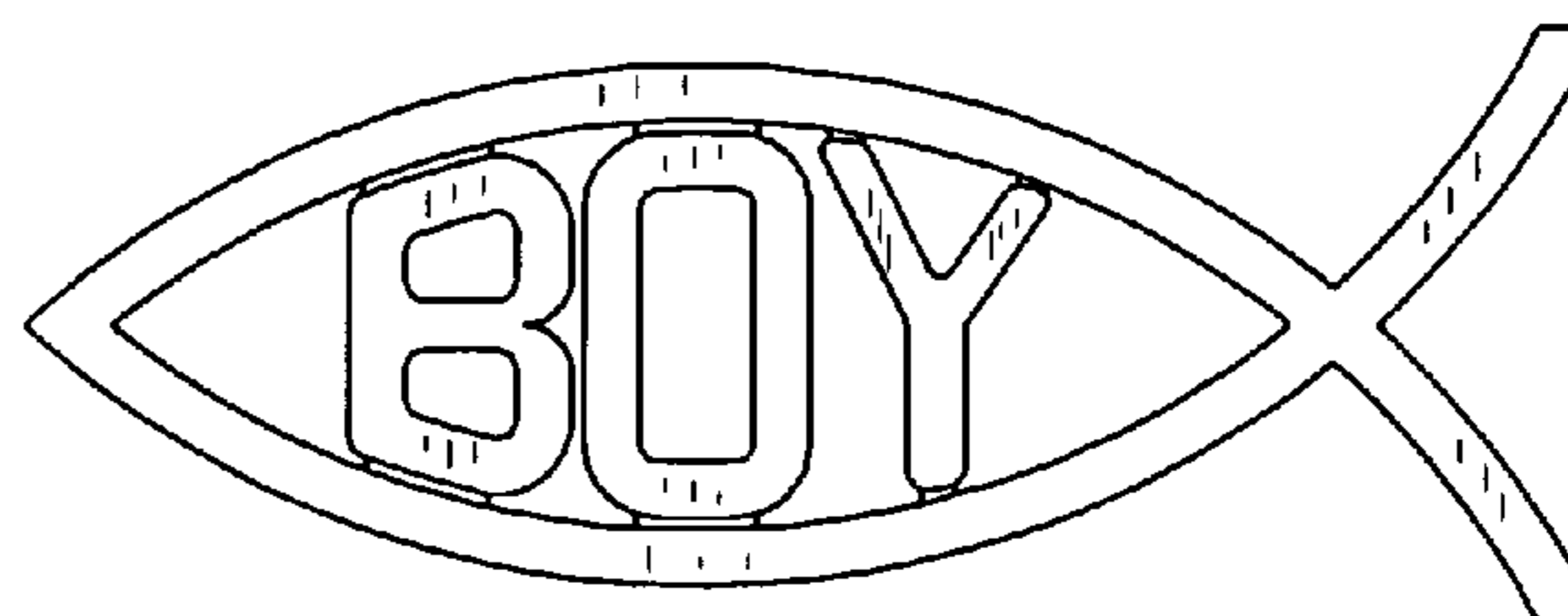
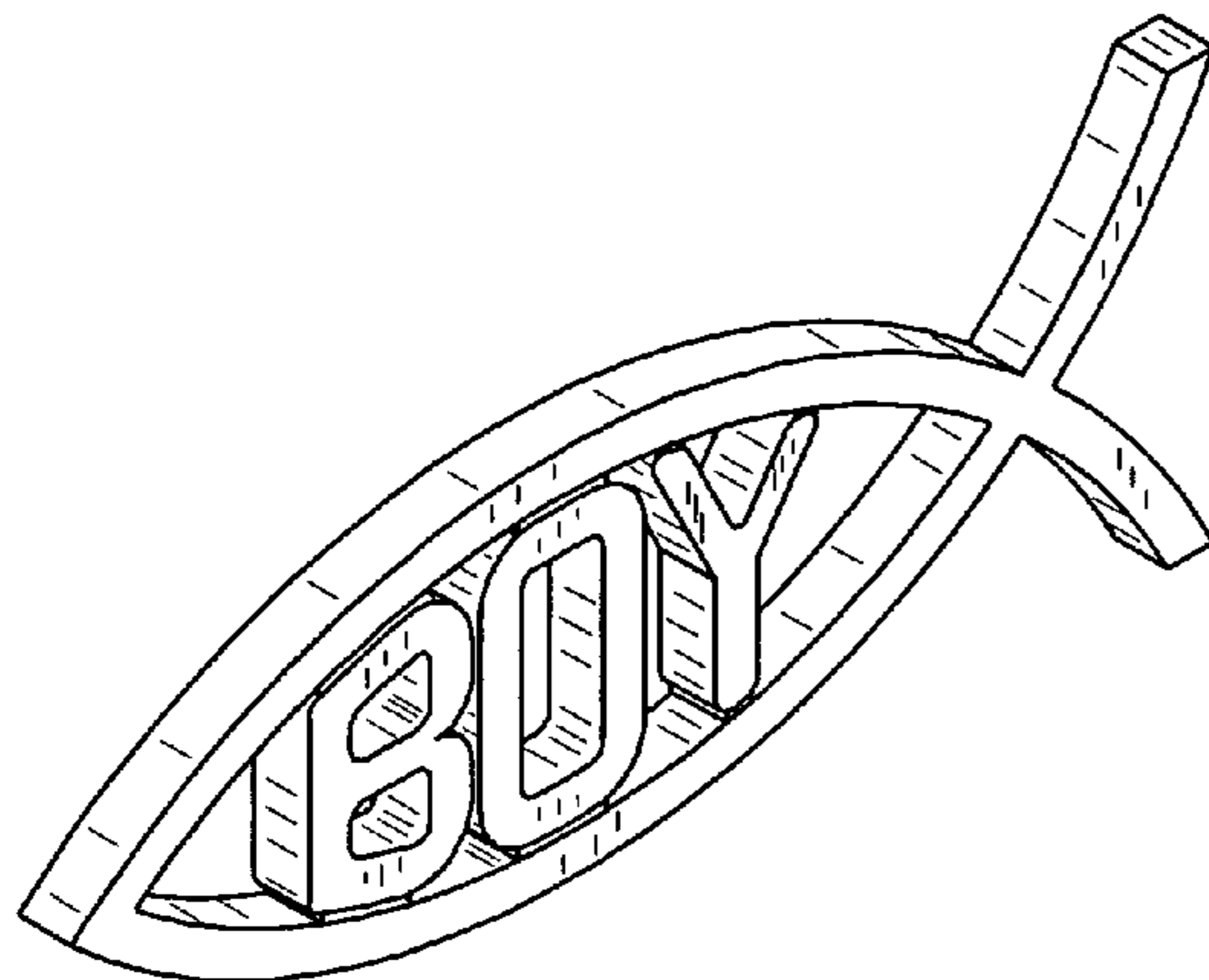
FIG. 4 is a top view thereof;

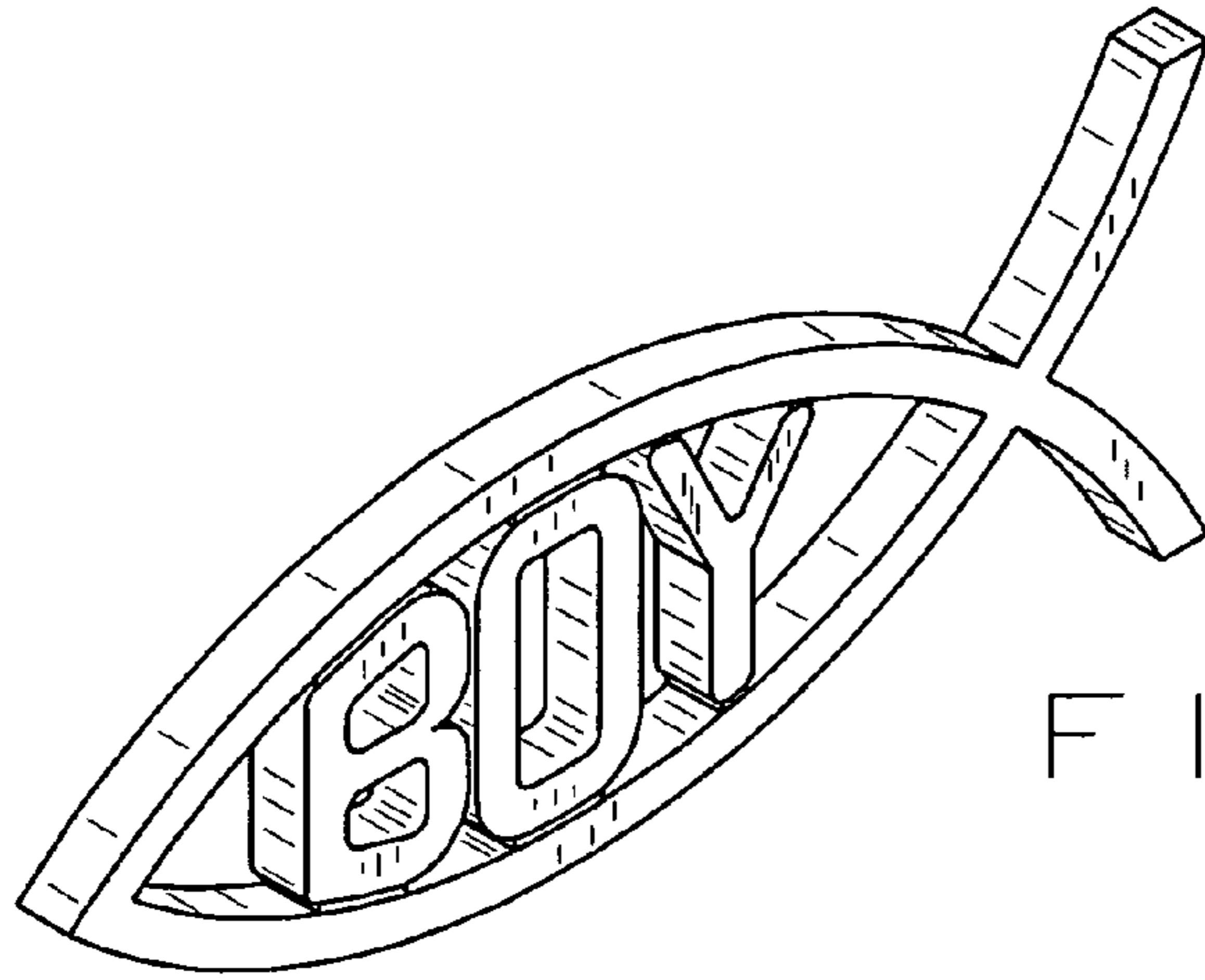

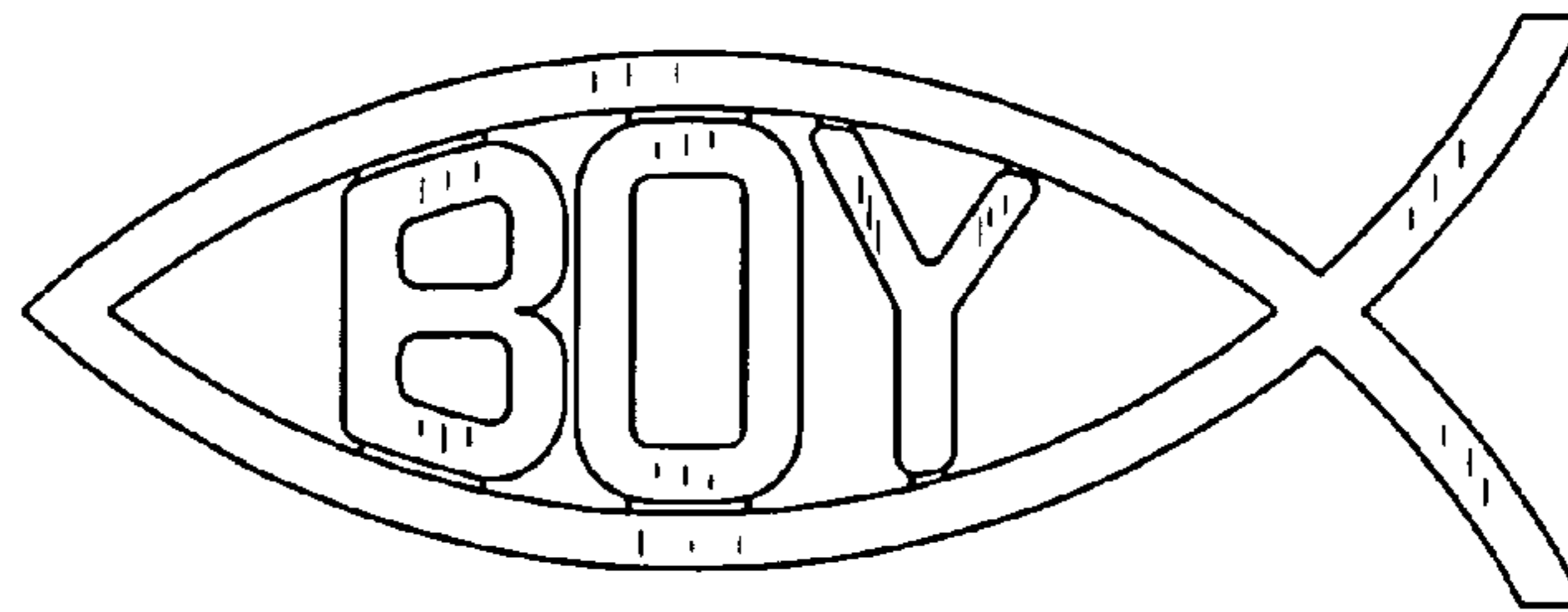

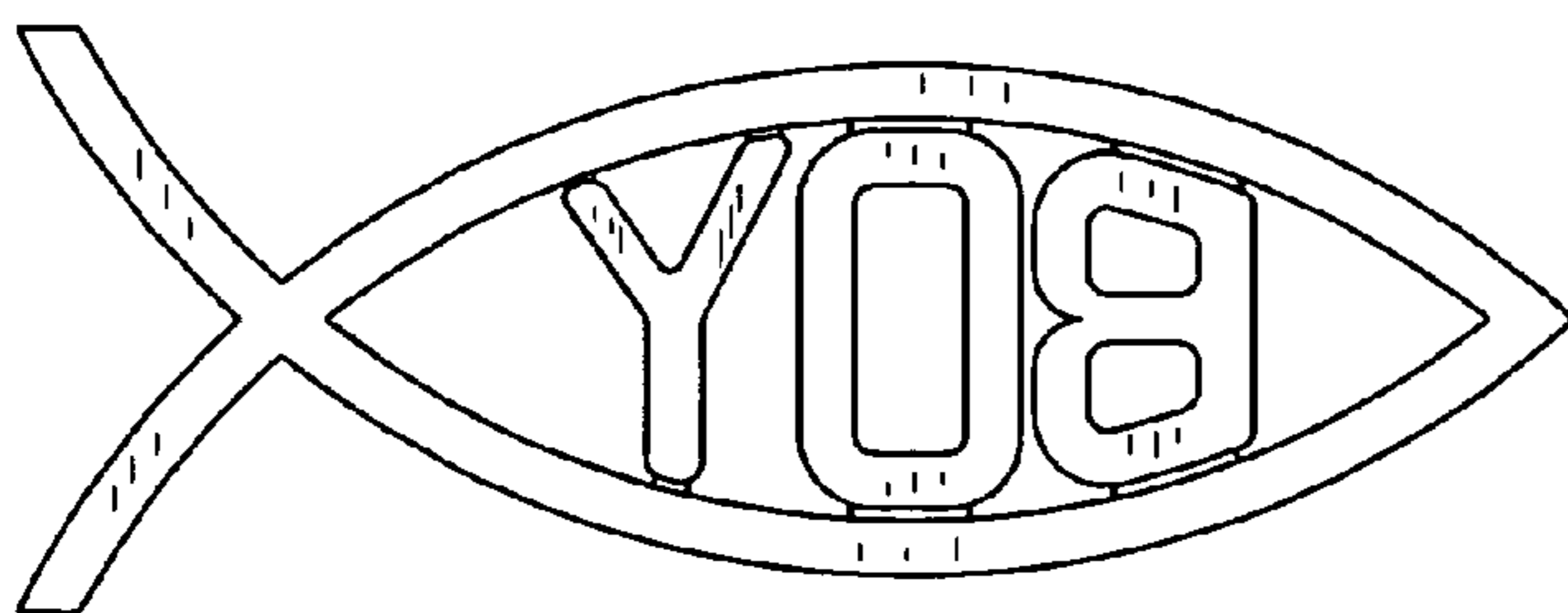

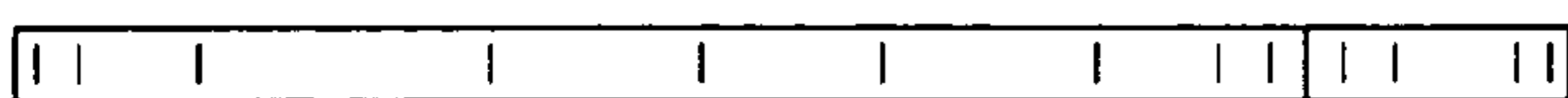

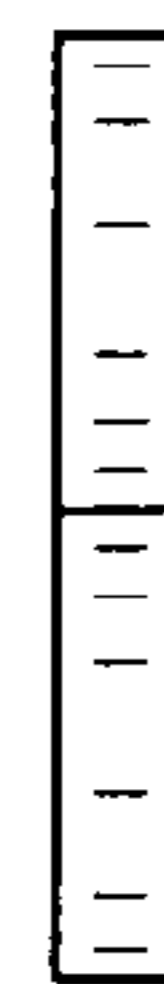
