**DESCRIPTION**

FIG. 1 is a perspective view of a self-supporting live goods cage showing my new design;

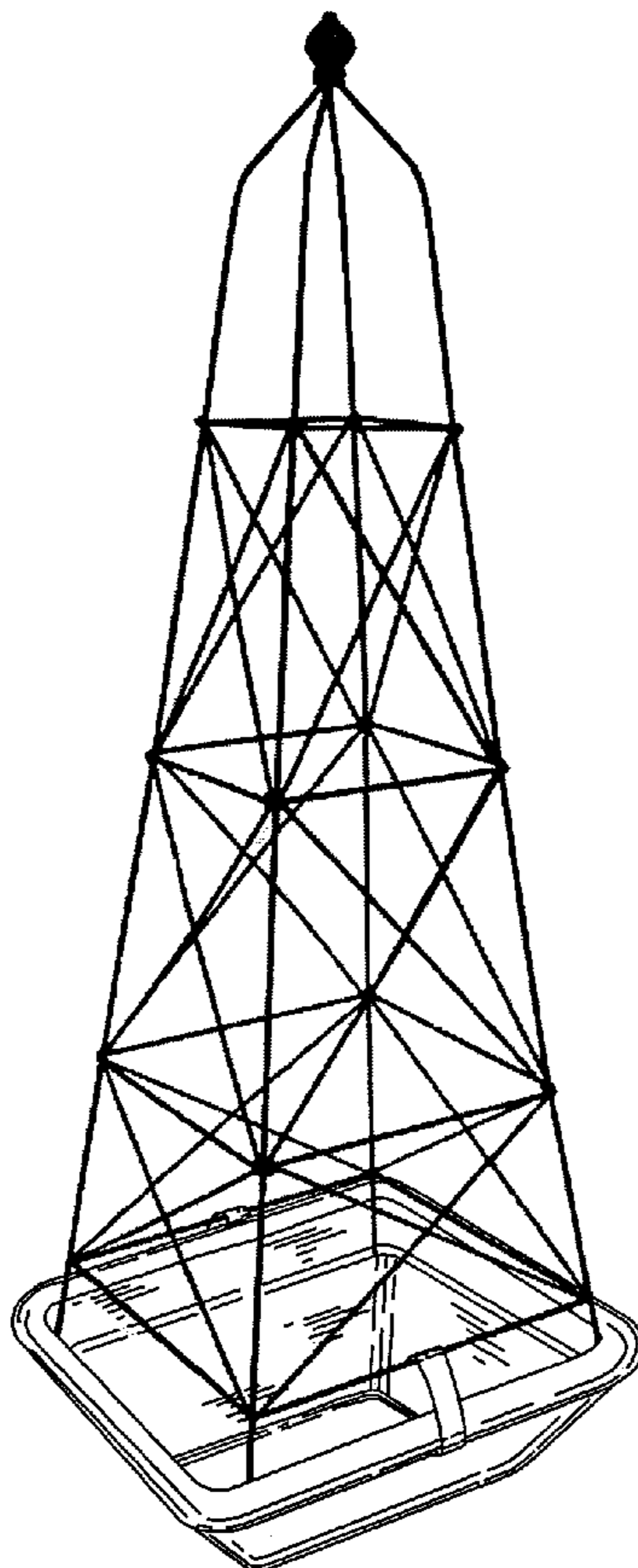
FIG. 2 is a front elevation view, the rear elevation view being identical thereto;

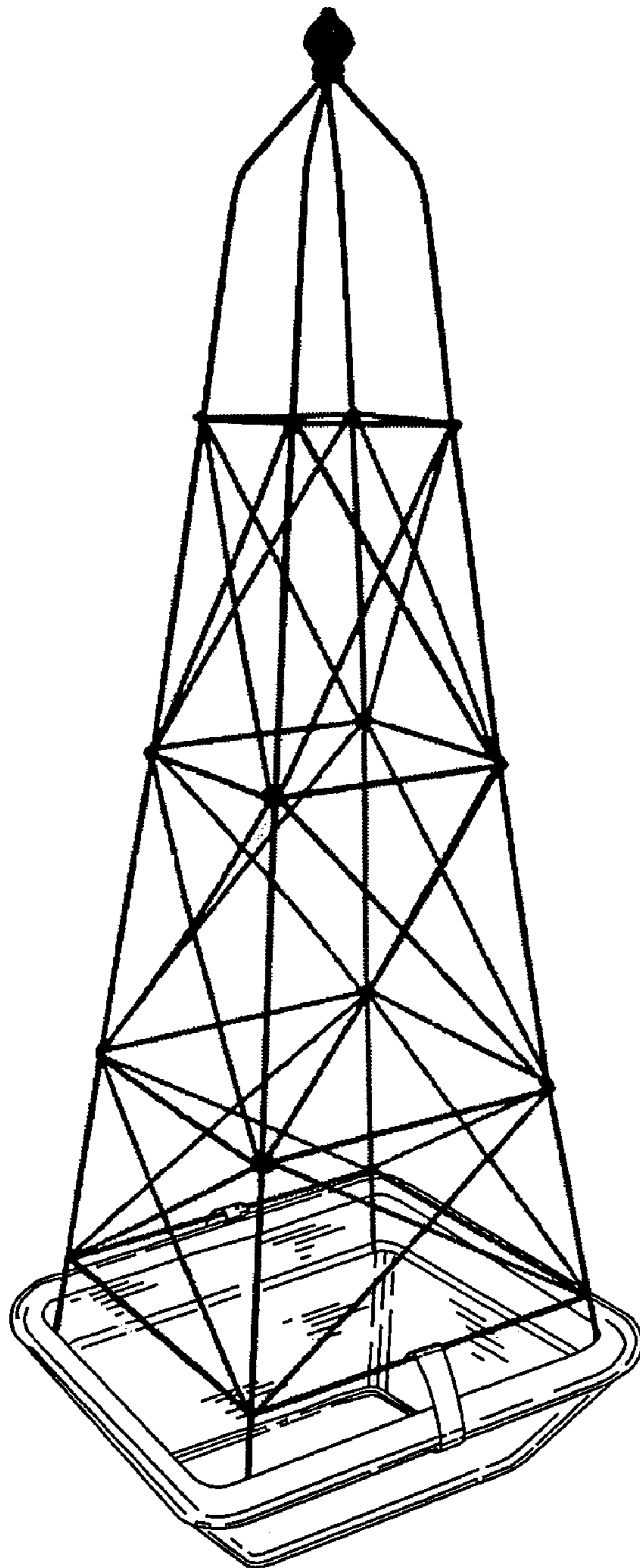

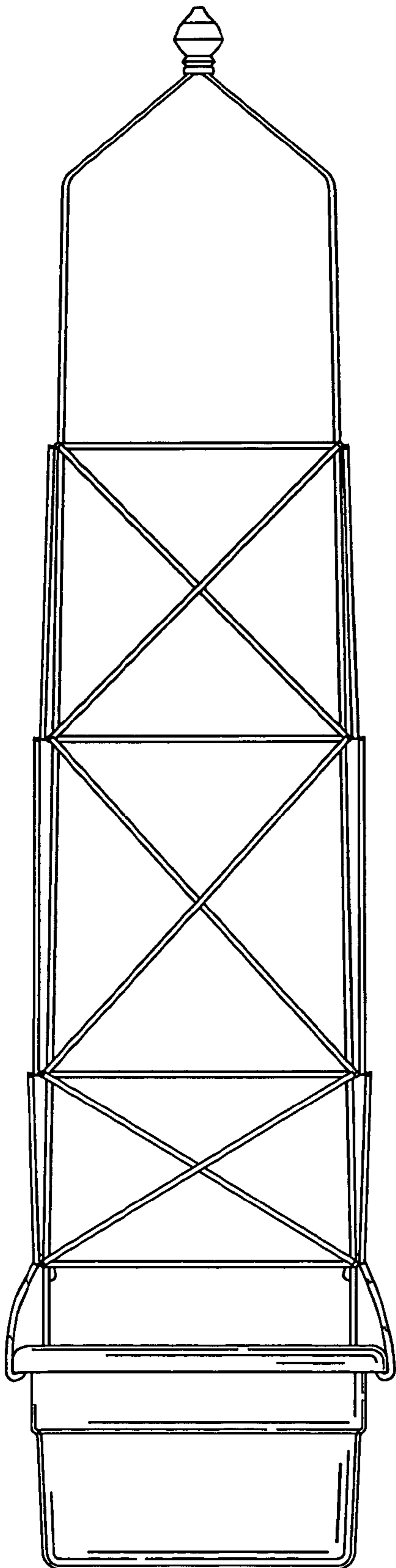

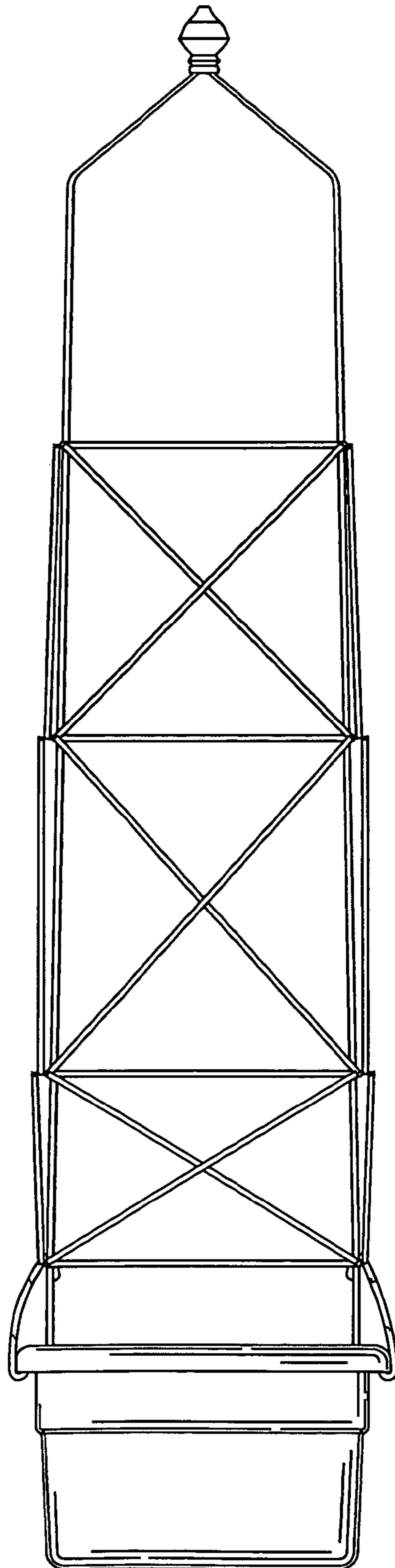

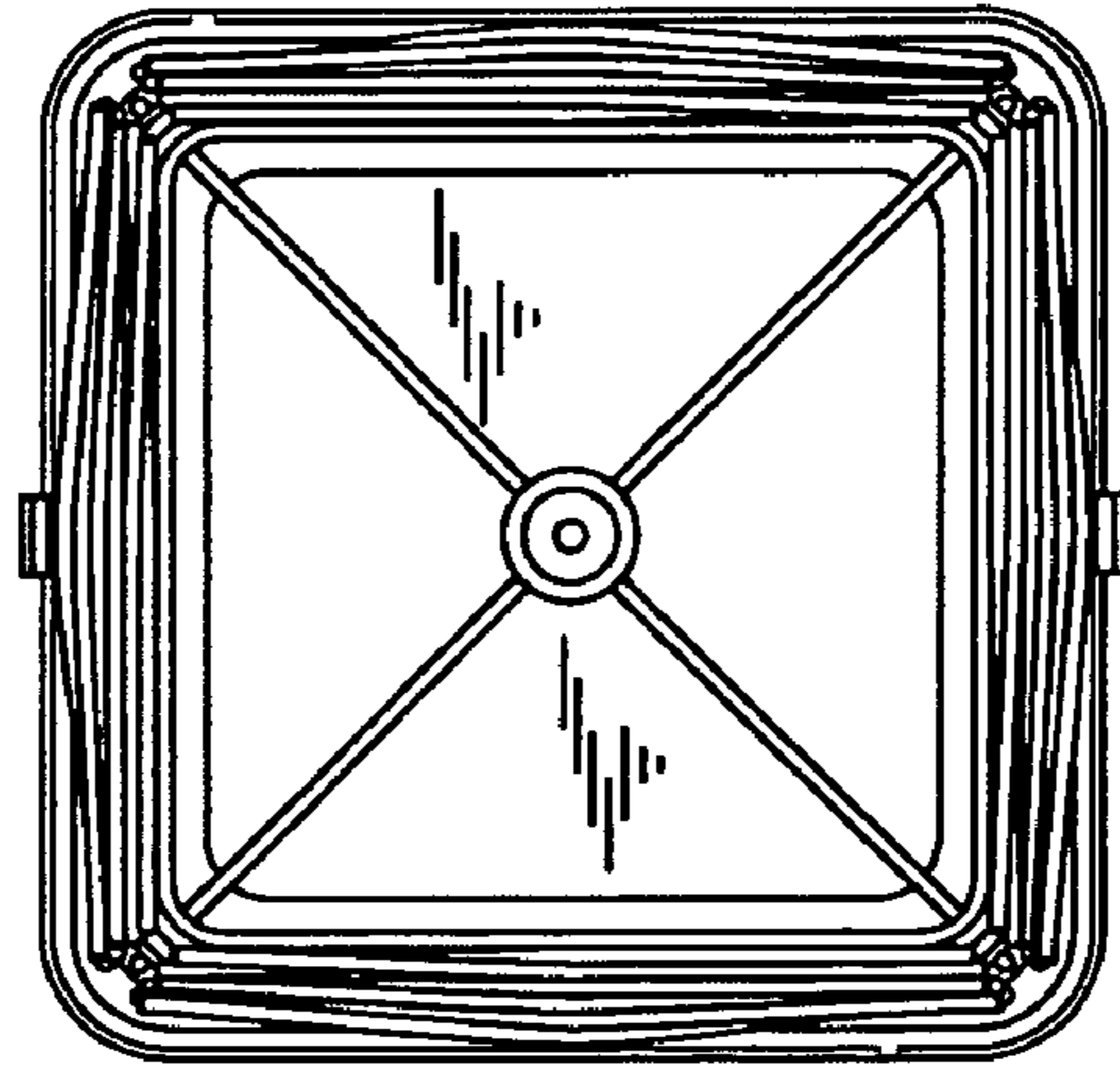

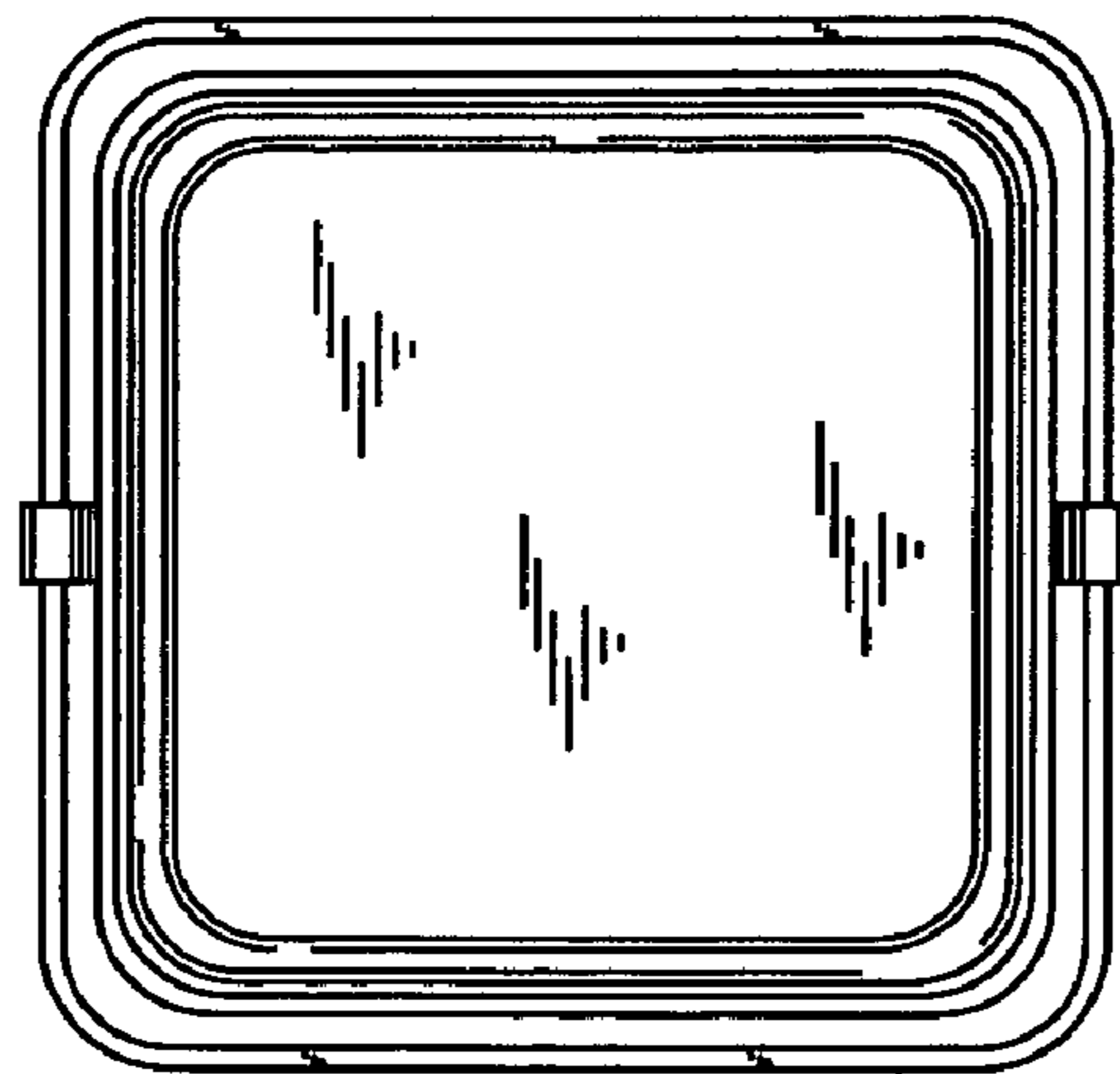
