(57) **CLAIM**

The ornamental design for a remote controller, as shown and
described.

FIG. 1 is a top perspective view of a remote controller show-
ing our new design;

FIG. 2 is a right elevation view of the design illustrated in FIG.
1, the left elevation view being a mirror image thereof;

FIG. 3 is a front elevation view of the design illustrated in
FIG. 1;

FIG. 4 is a rear elevation view of the design illustrated in FIG.
1;

FIG. 5 is a bottom plan view of the design illustrated in FIG.
1;

FIG. 6 is a top plan view of the design illustrated in FIG. 1;

FIG. 7 is a bottom rear perspective view of the design illus-
trated in FIG. 1;

FIG. 8 is a right elevation view of the design illustrated in FIG.
1 showing a cover in a second position of use, the left eleva-
tion view being a mirror image thereof;

FIG. 9 is a front elevation view of the design illustrated in
FIG. 8;

FIG. 10 is a rear elevation view of the design illustrated in
FIG. 8;

FIG. 11 is a top plan view of the design illustrated in FIG. 8;

FIG. 12 is a right elevation view of the design illustrated in
FIG. 1 showing the cover in a third position of use, the left
elevation view being a mirror image thereof;

FIG. 13 is a front elevation view of the design illustrated in
FIG. 12;

FIG. 14 is a rear elevation view of the design illustrated in
FIG. 12;

FIG. 15 is a top plan view of the design illustrated in FIG. 12;
and,

FIG. 16 is a perspective view showing the remote associated
with the dashboard of a vehicle.

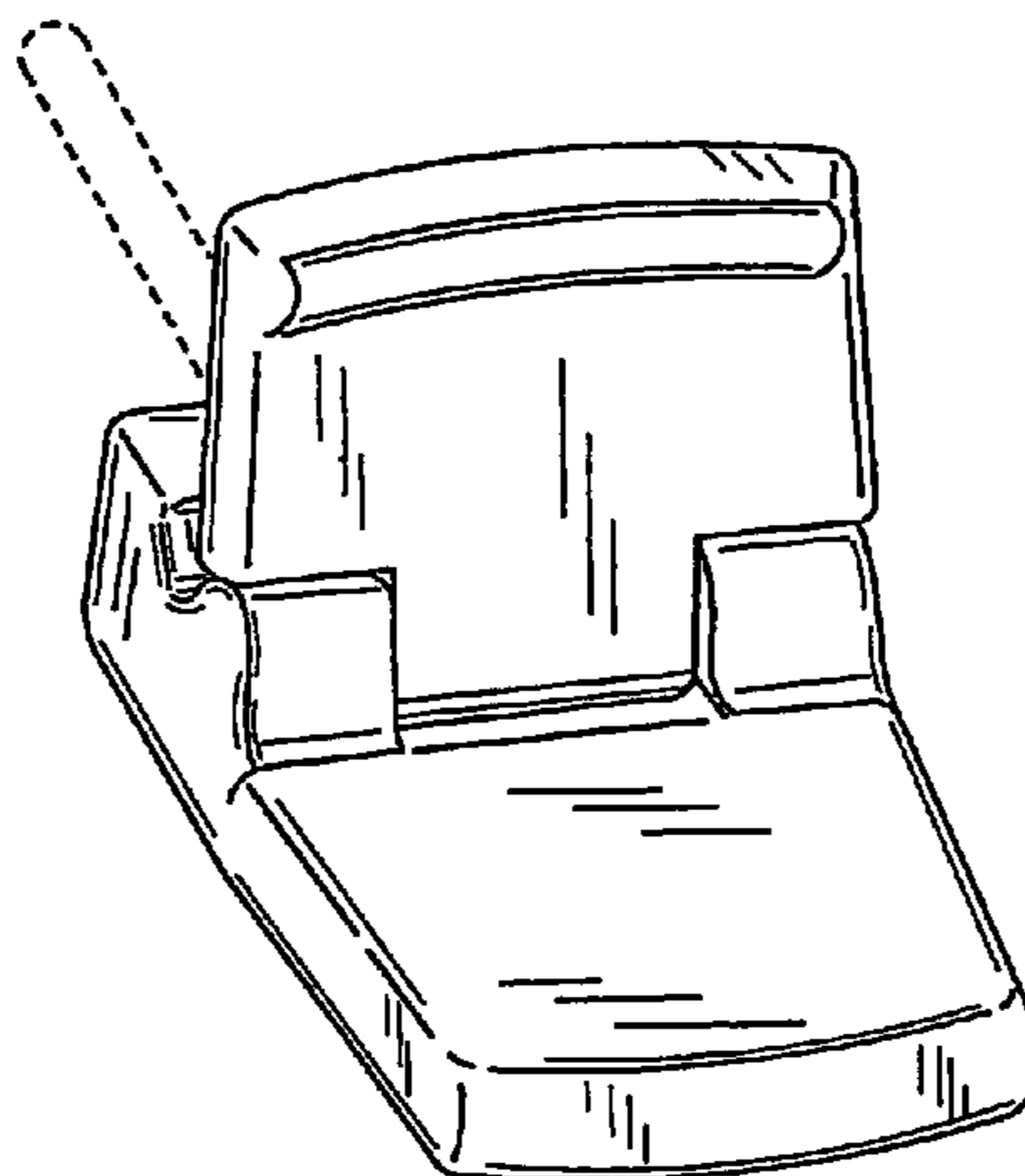
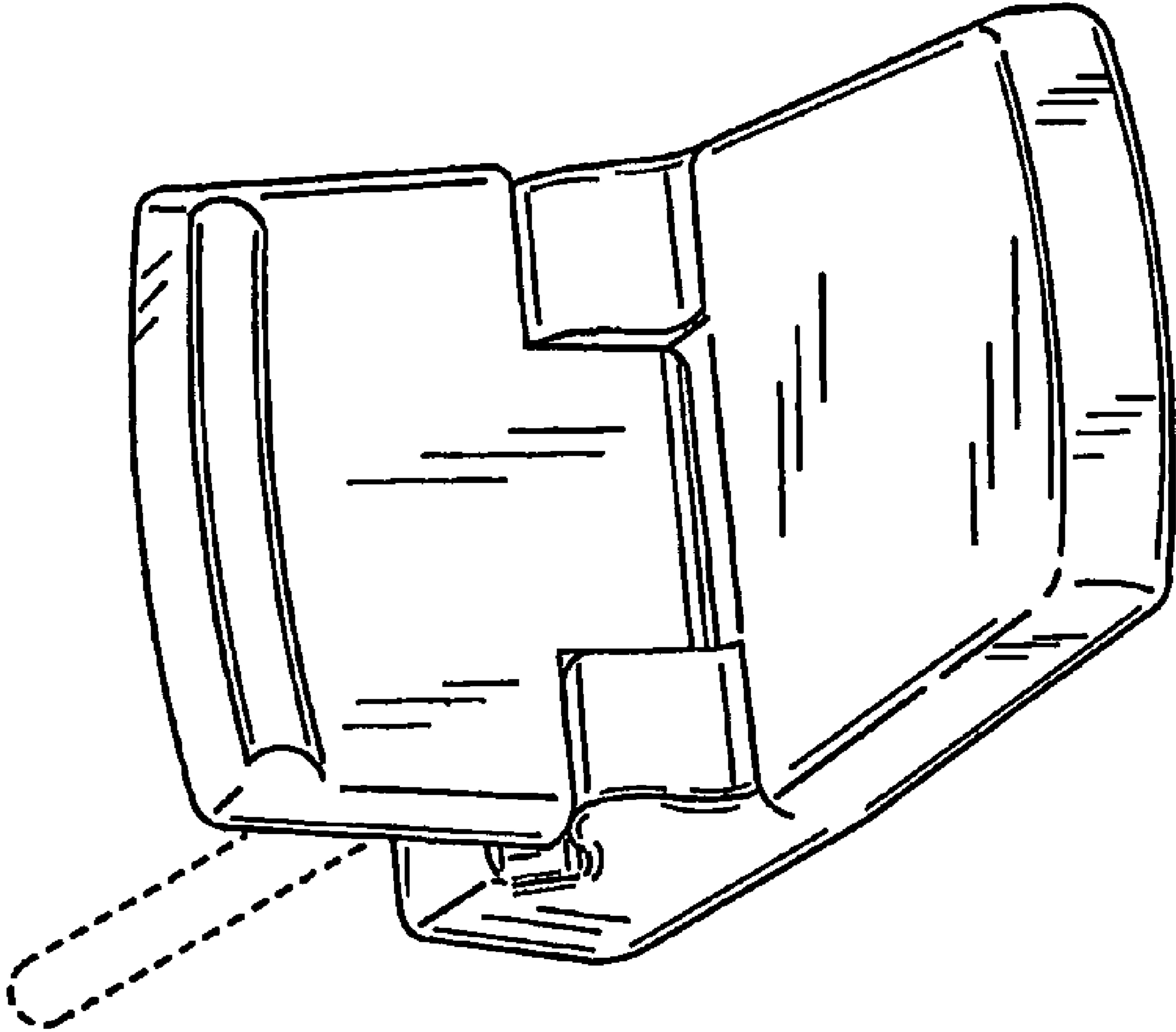

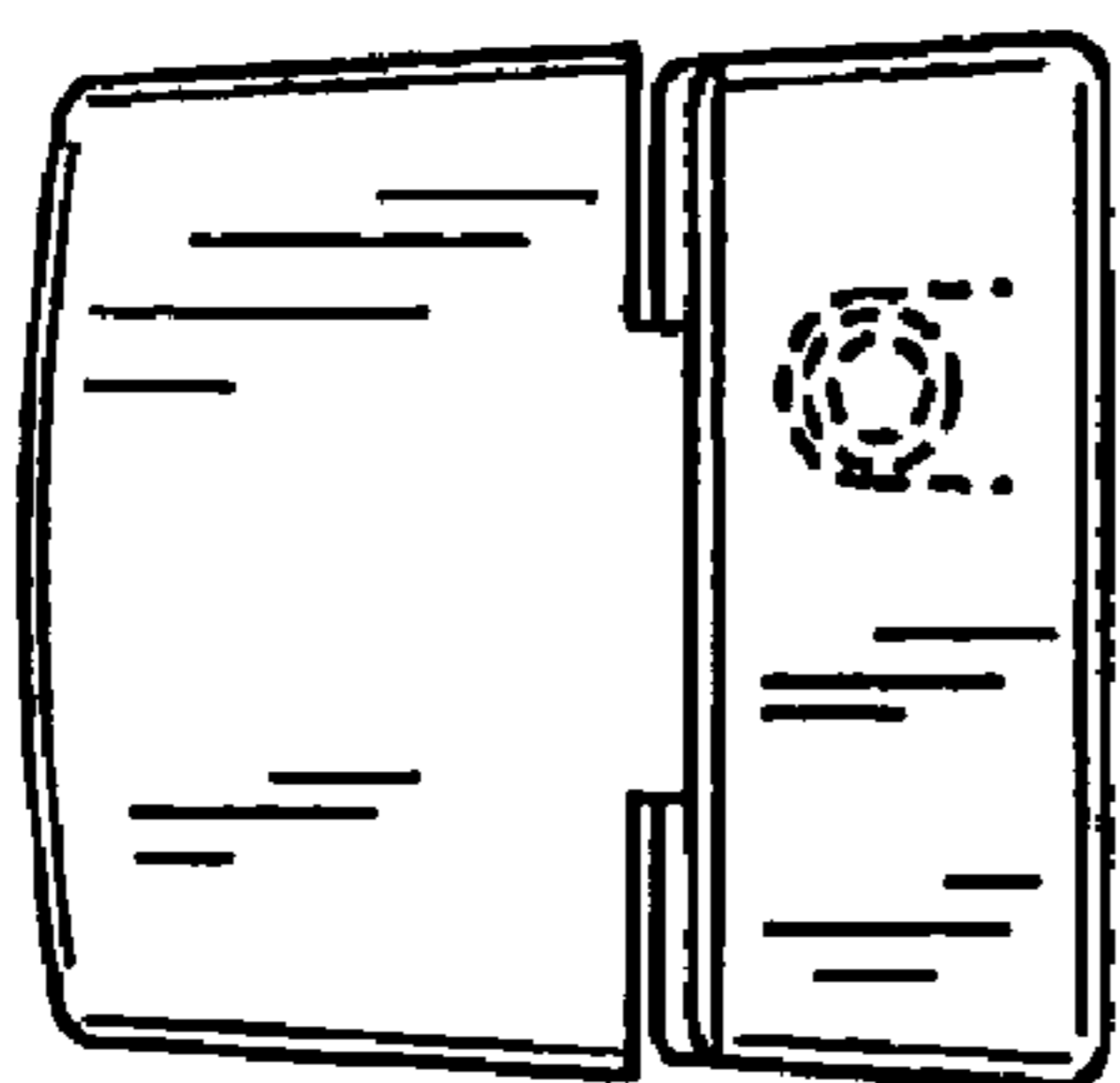

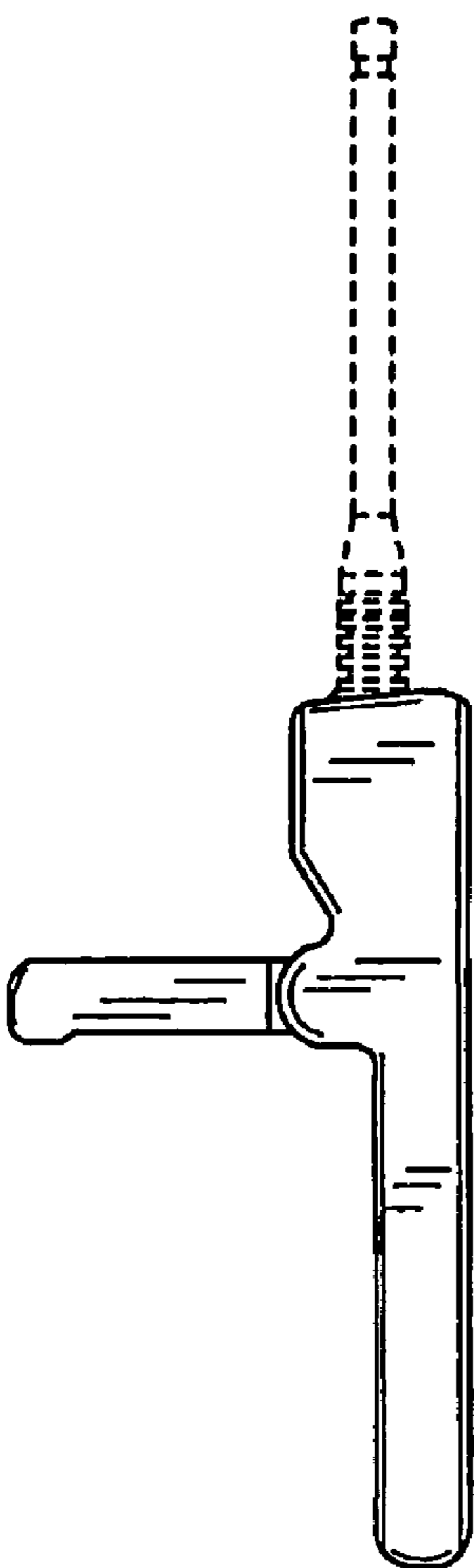

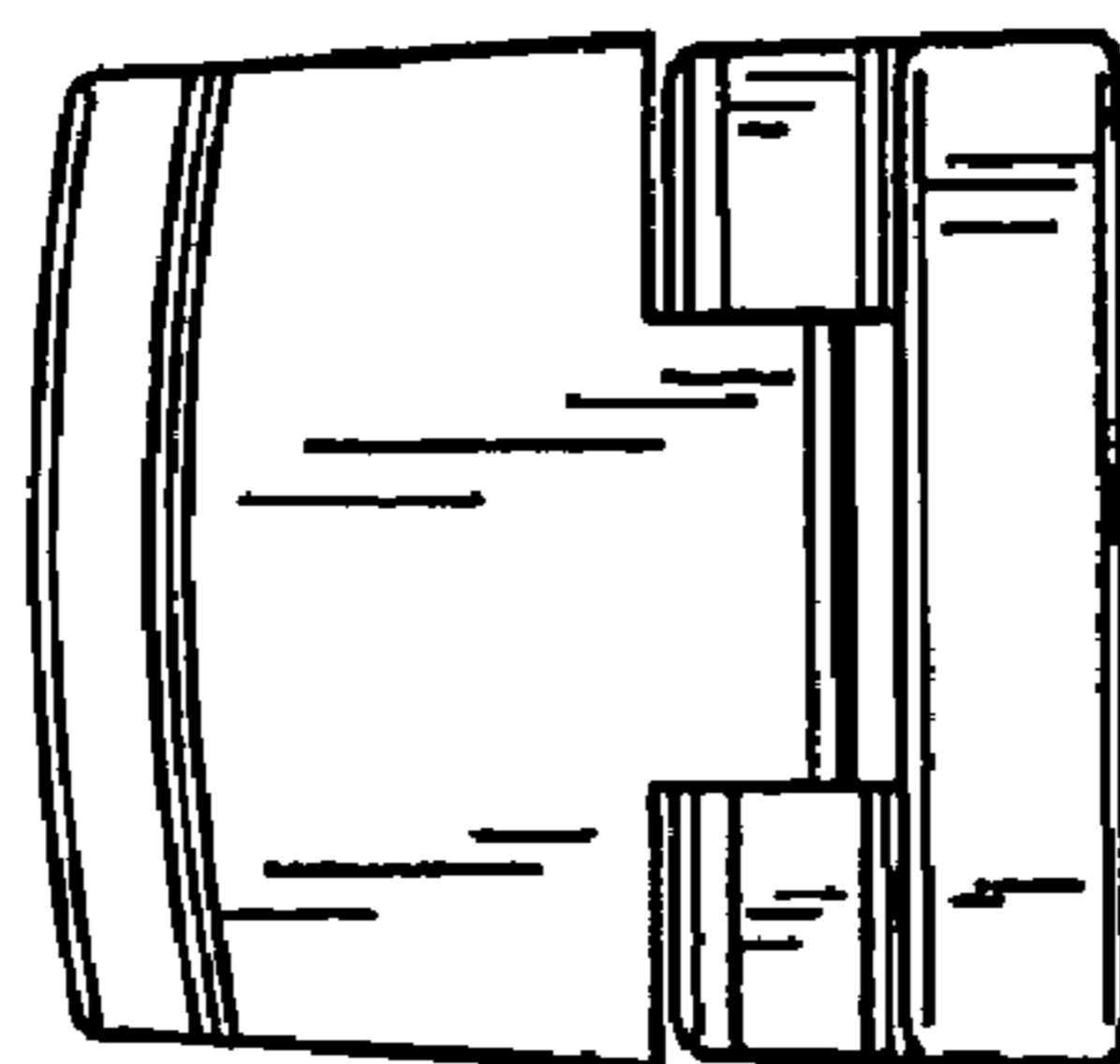

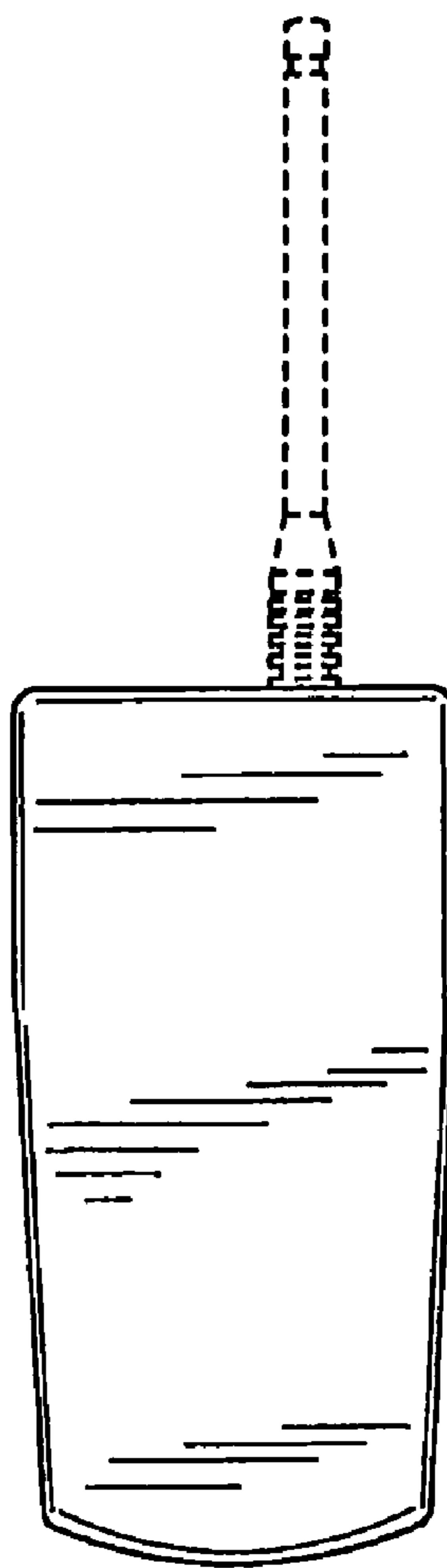

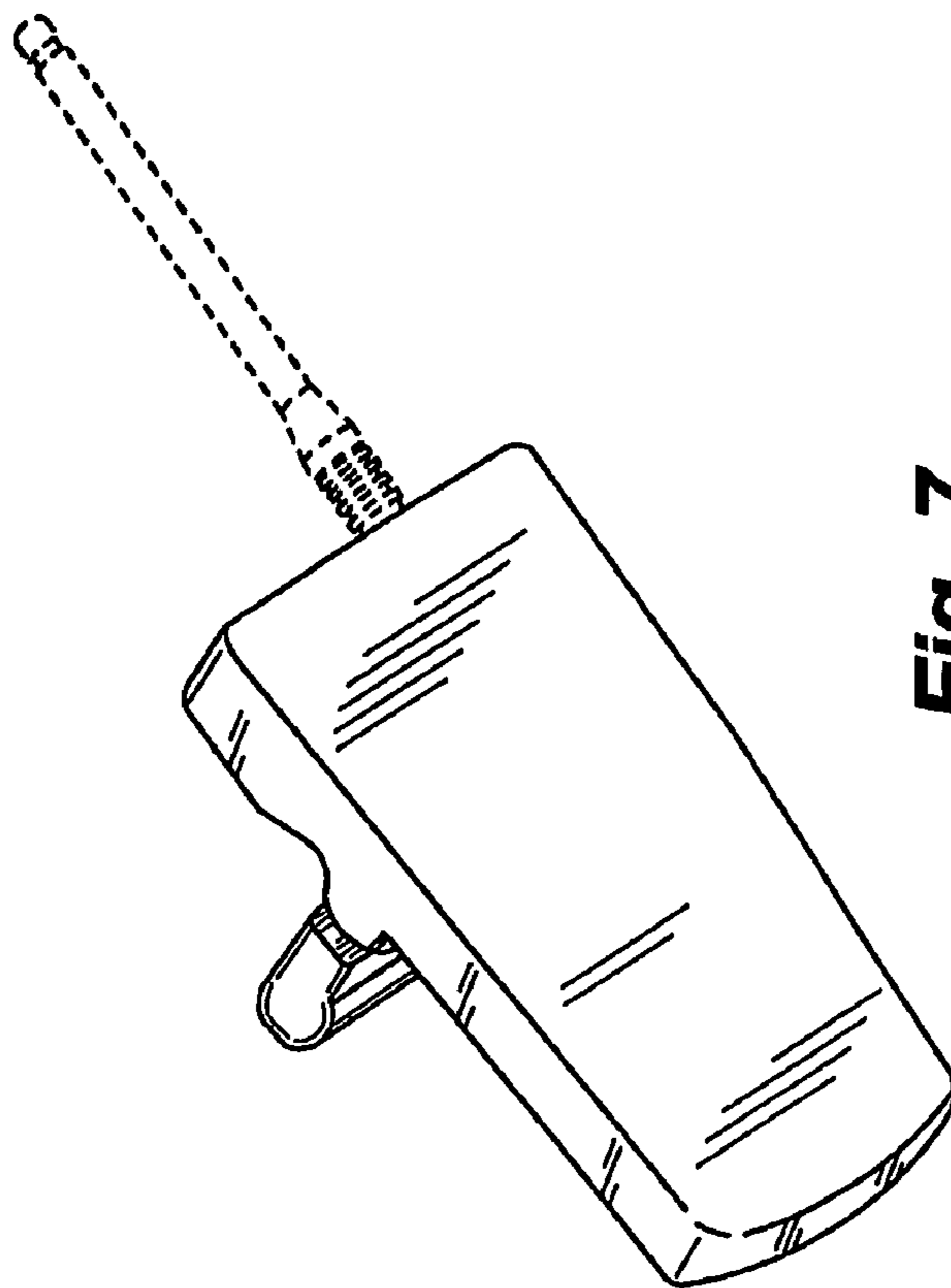

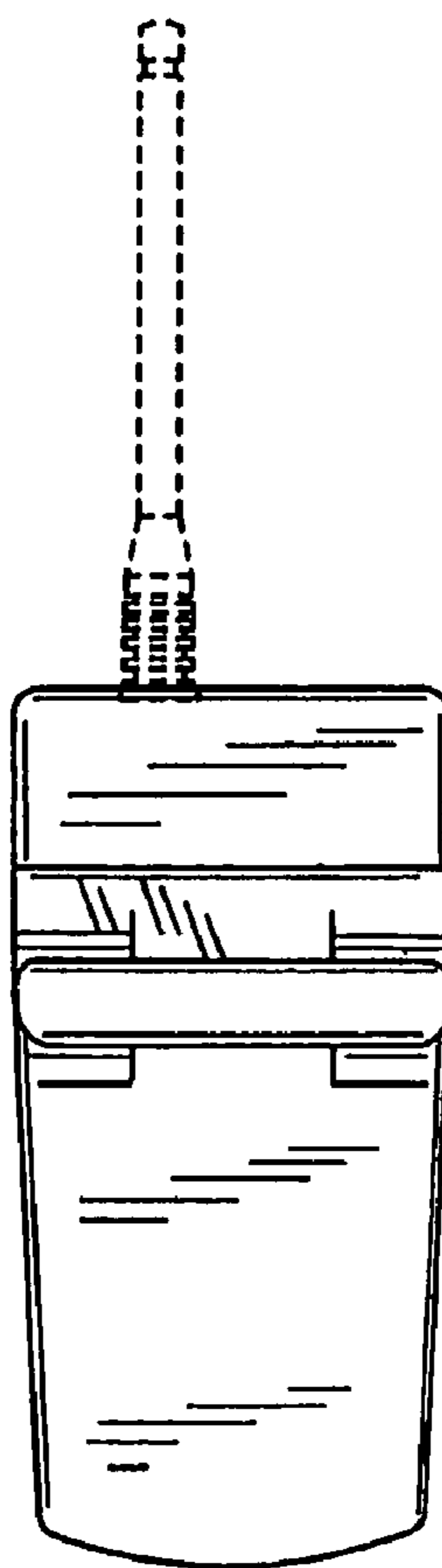

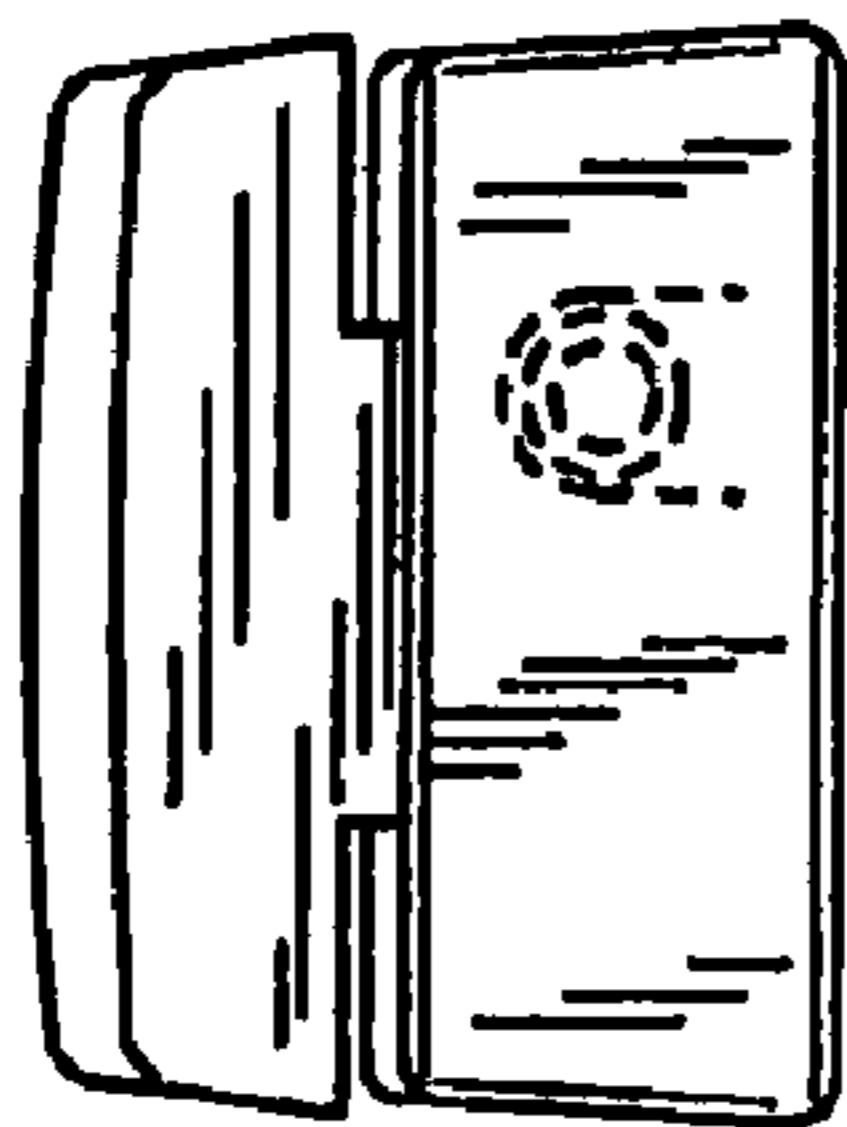

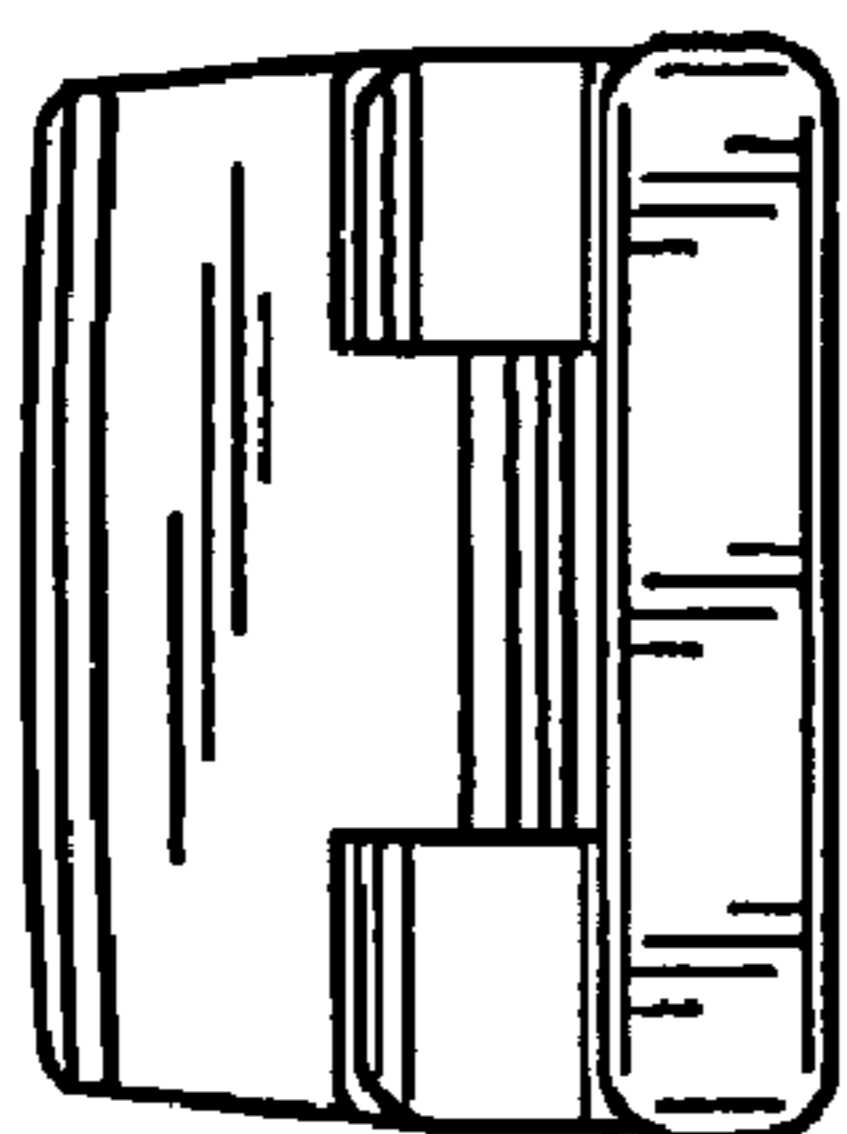

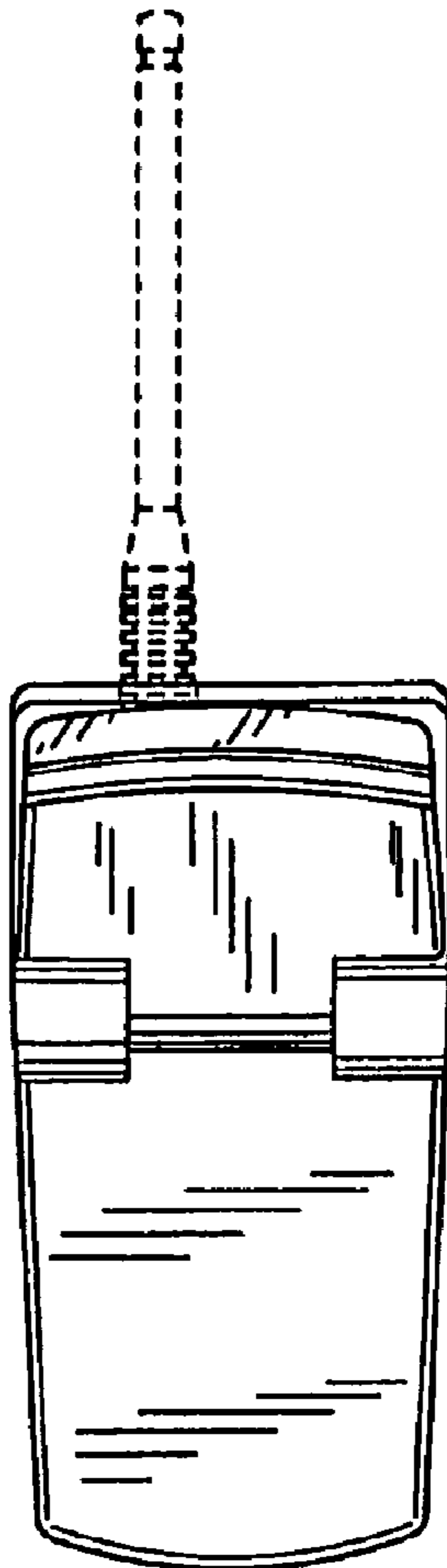

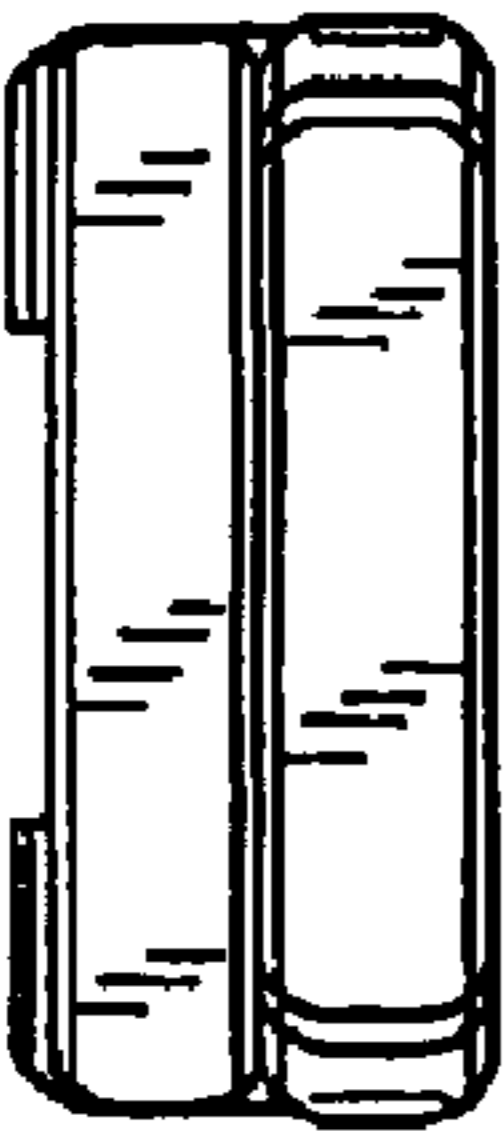

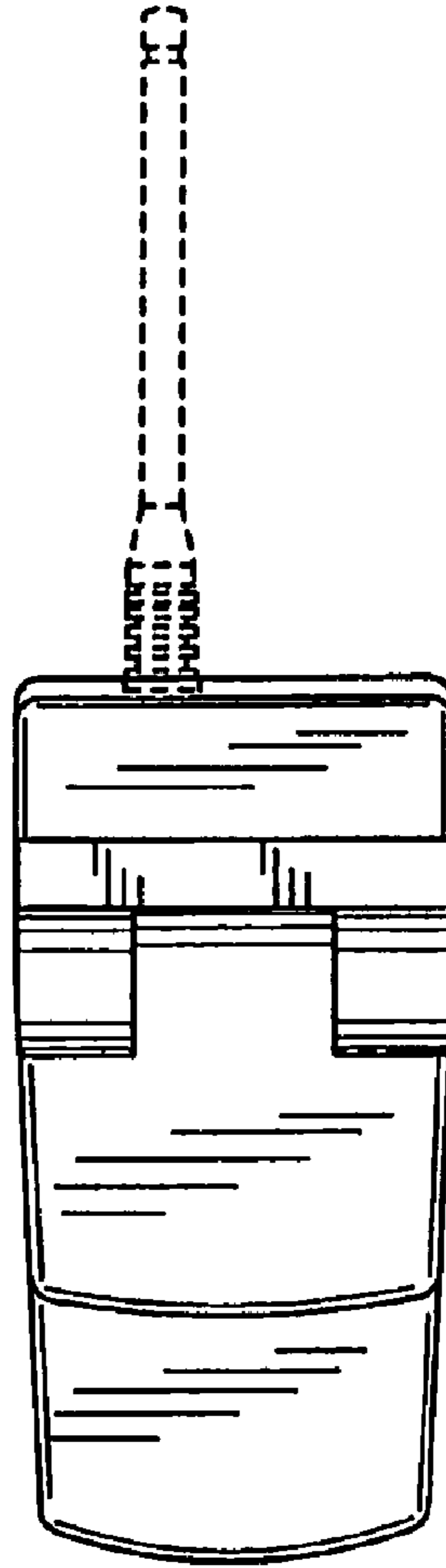

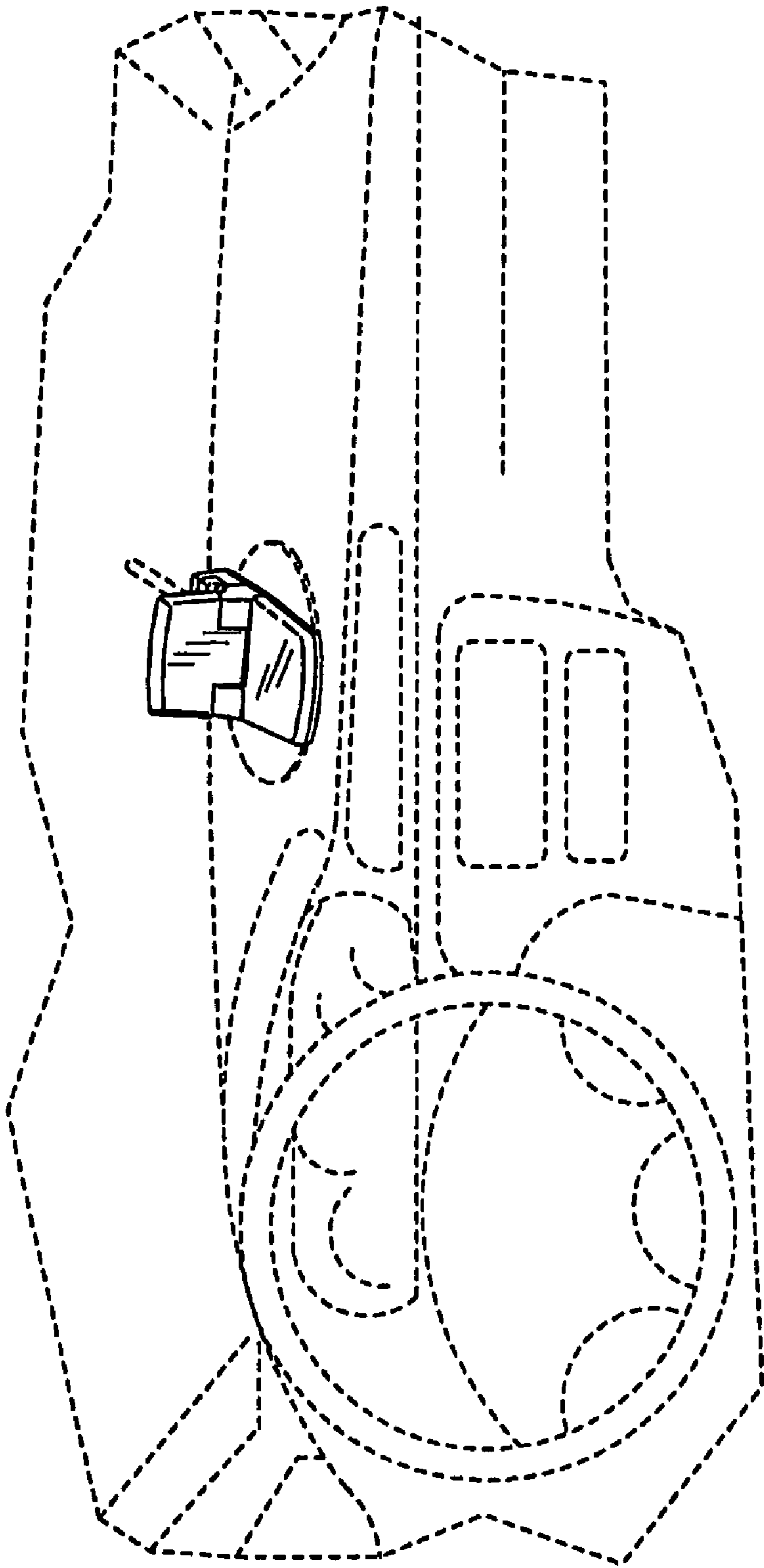
