(57) **CLAIM**

The ornamental design for a video image display for portable phone, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a video image display for portable phone;

FIG. 2 is a front view of the video image display for portable phone of FIG. 1; and,

FIG. 3 is an enlarged front view of the video image display for portable phone of FIG. 1.

The broken line showing of portions of a portable phone is included for the purpose of illustrating environmental structure and forms no part of the claimed design.

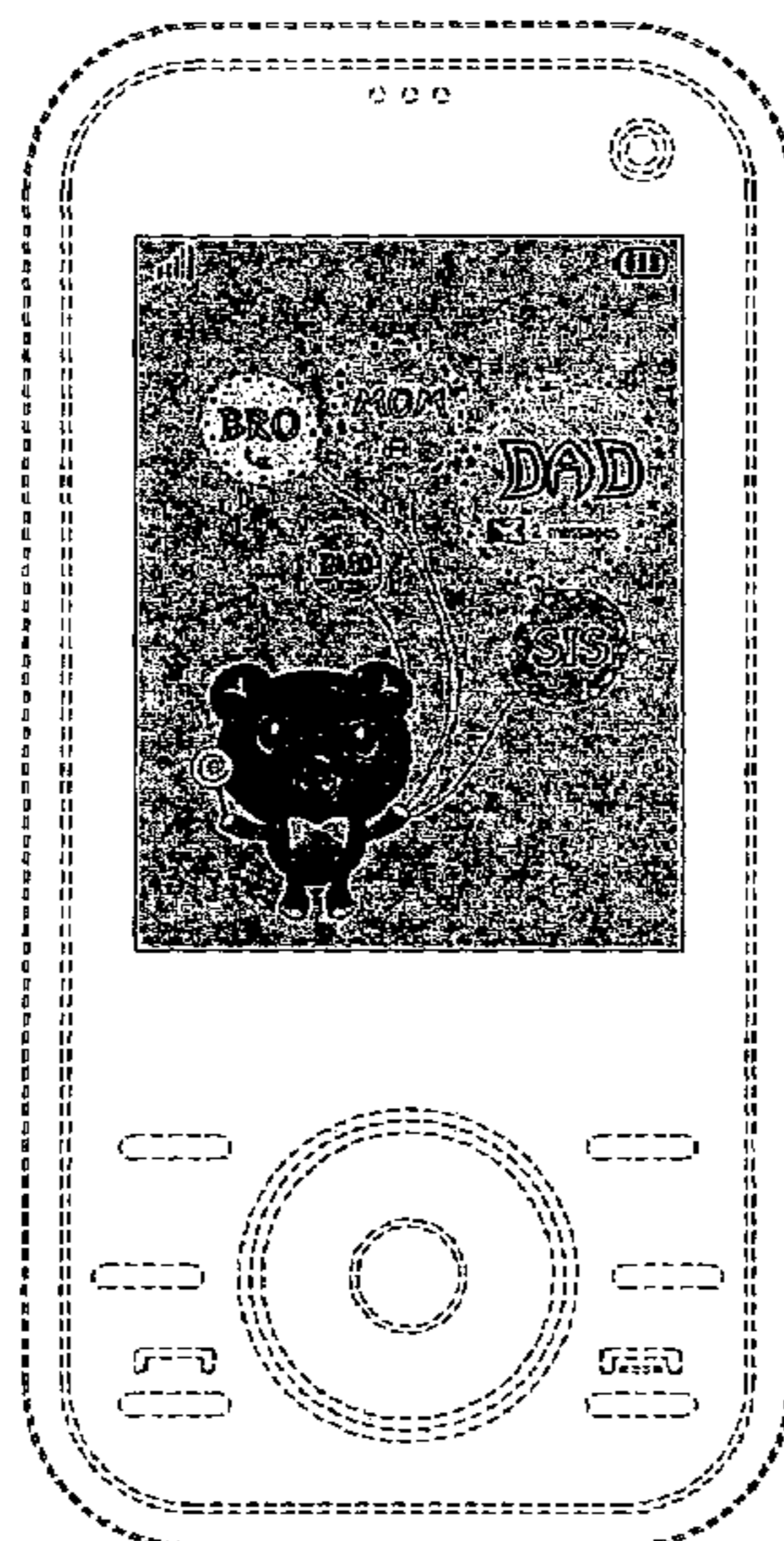

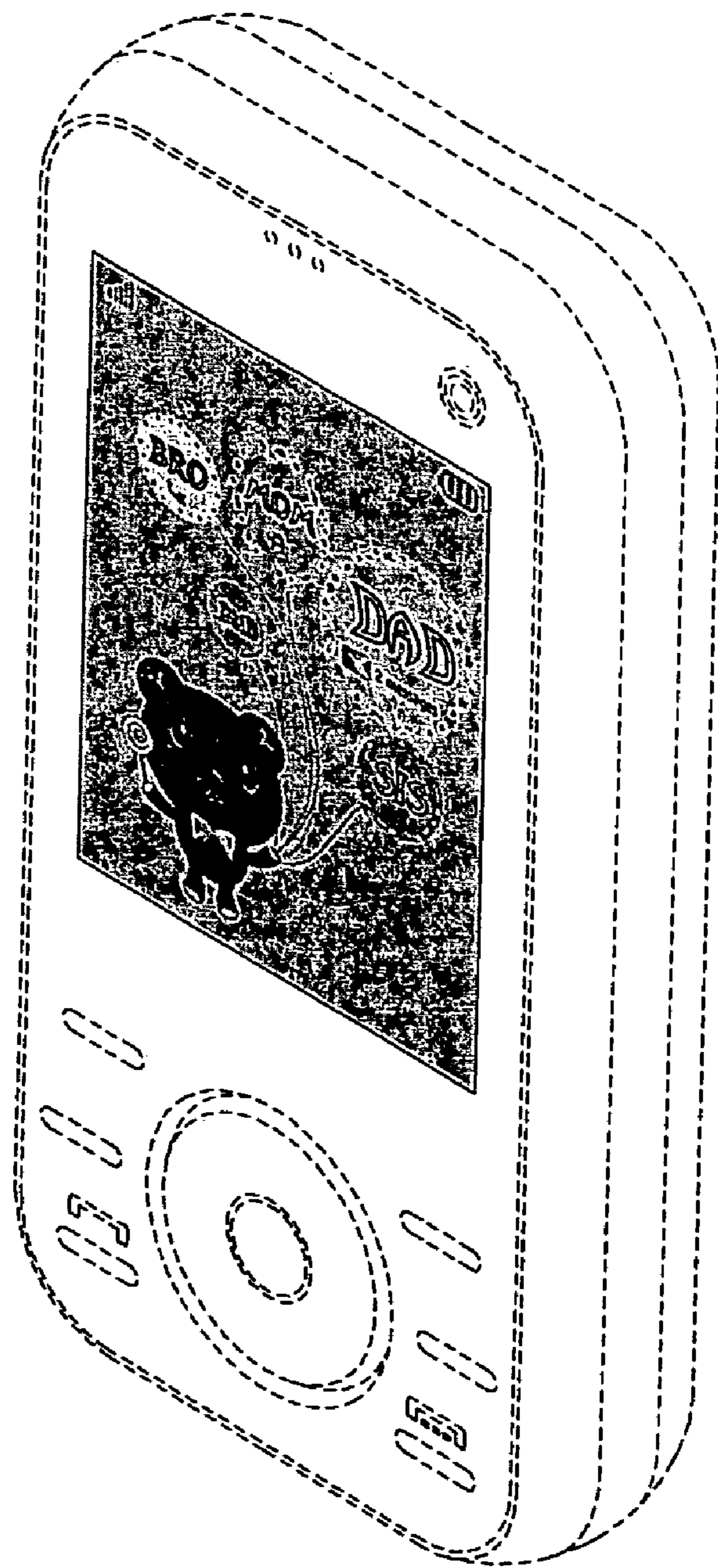

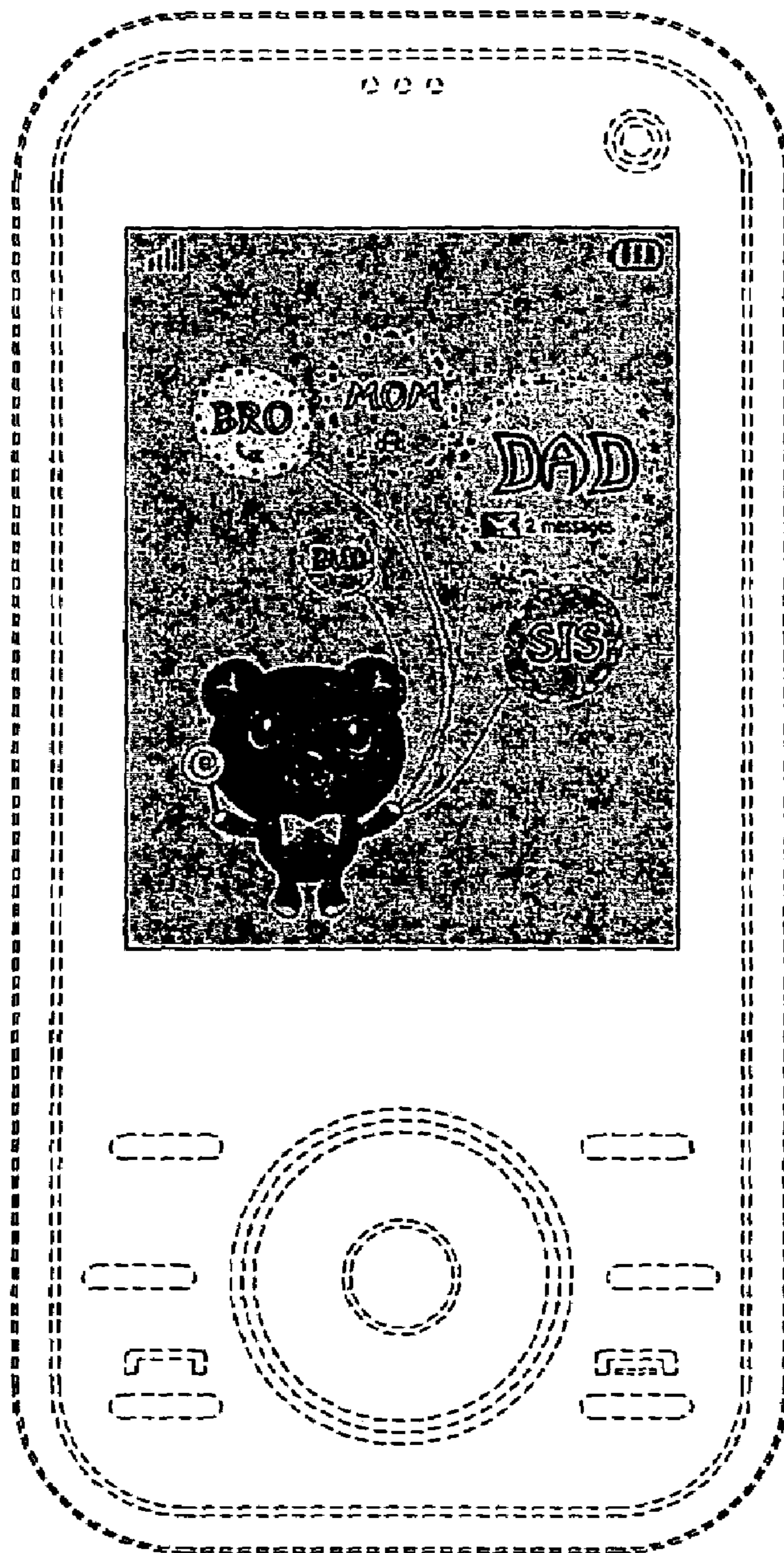
