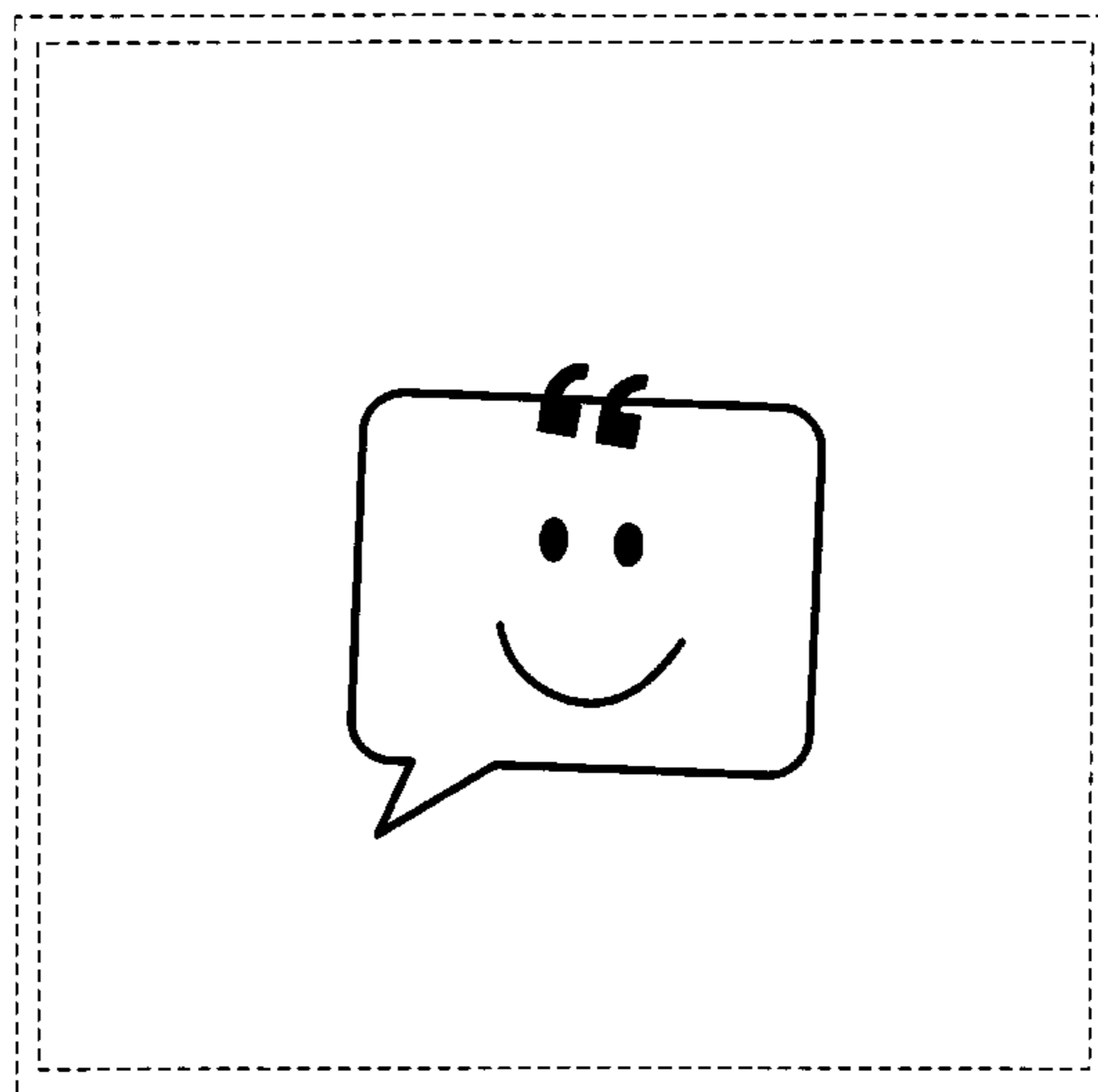

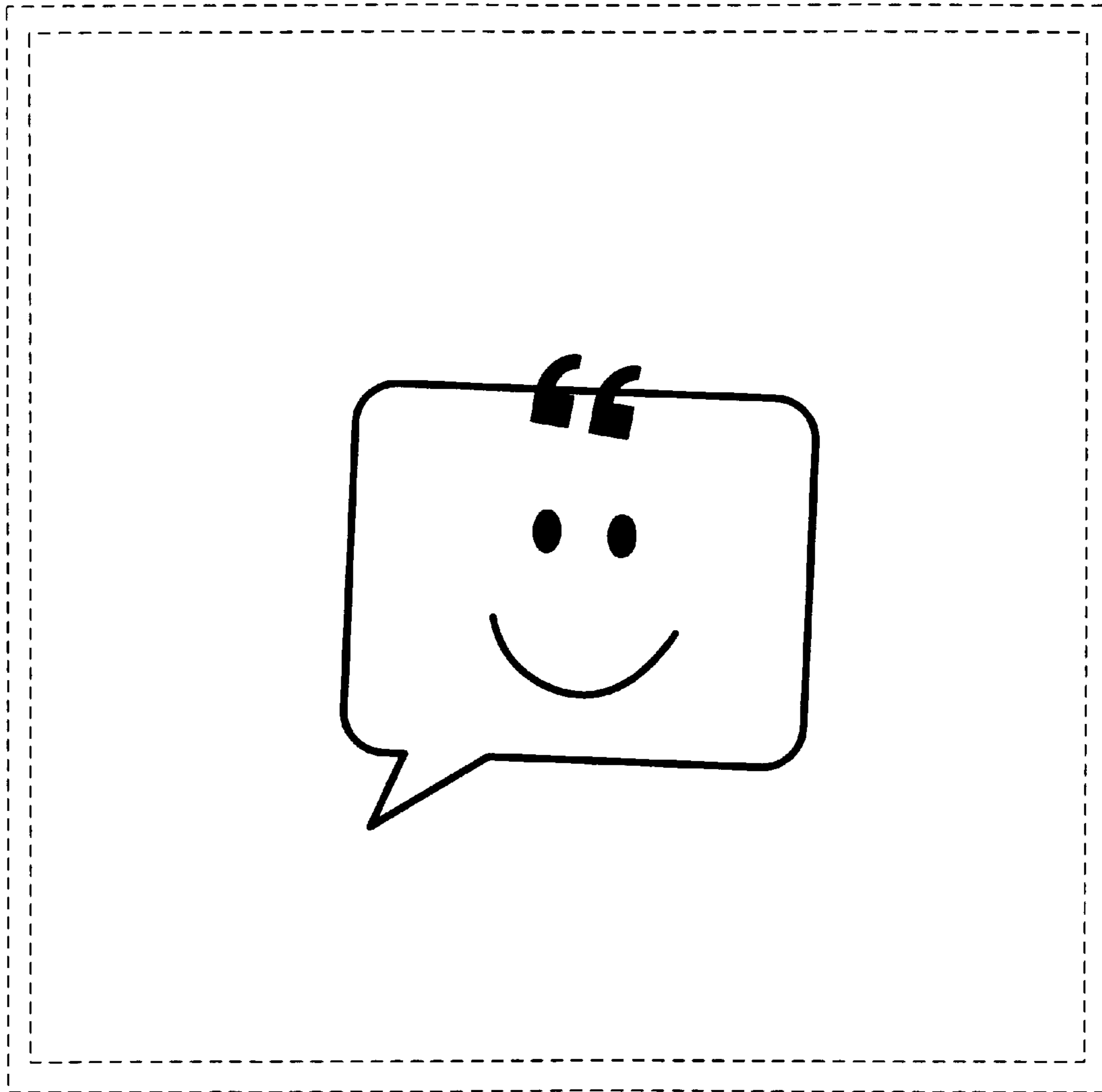
DESCRIPTION
