showing our new design;

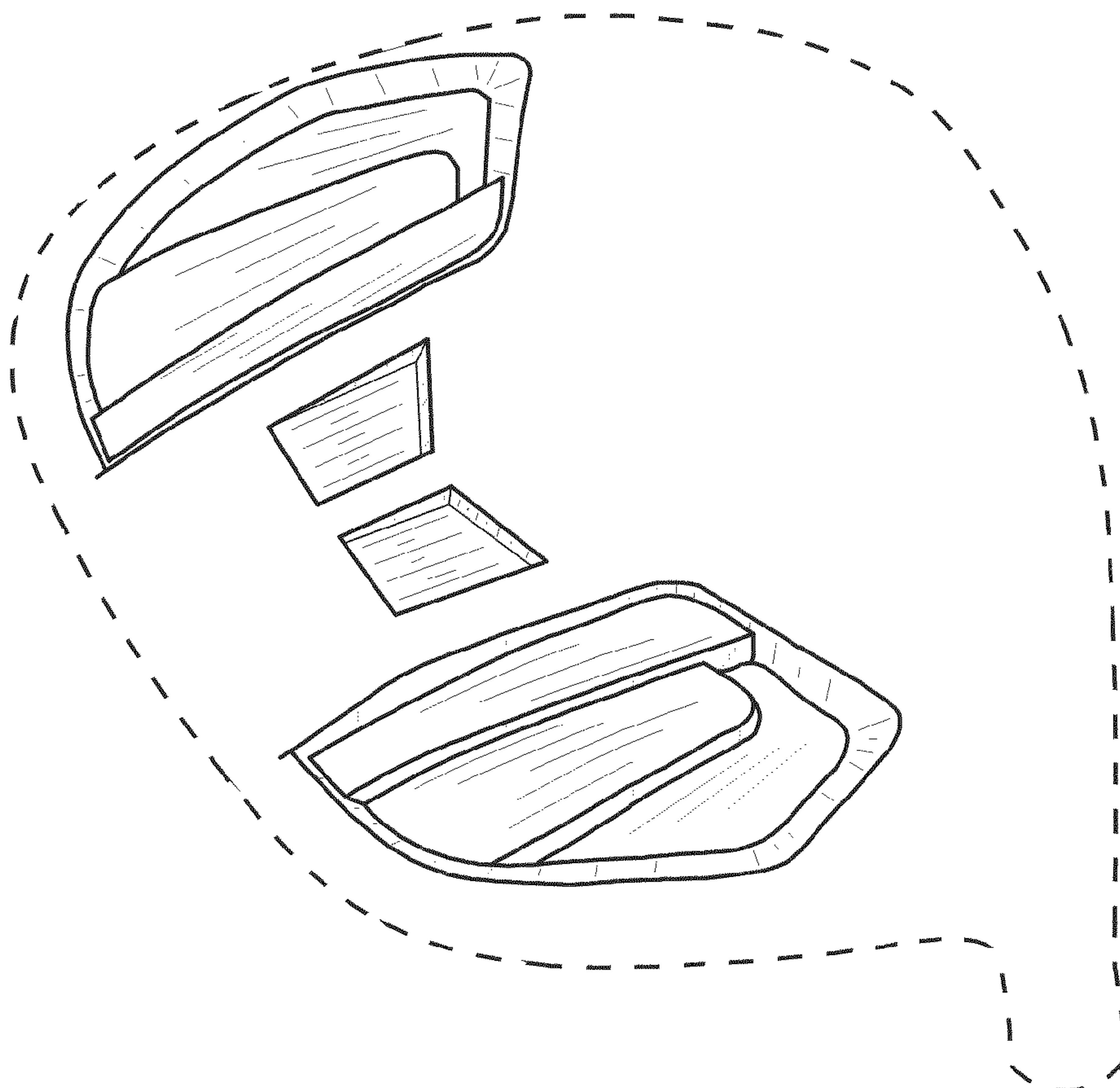
FIG. 2 is a bottom plan view thereof;

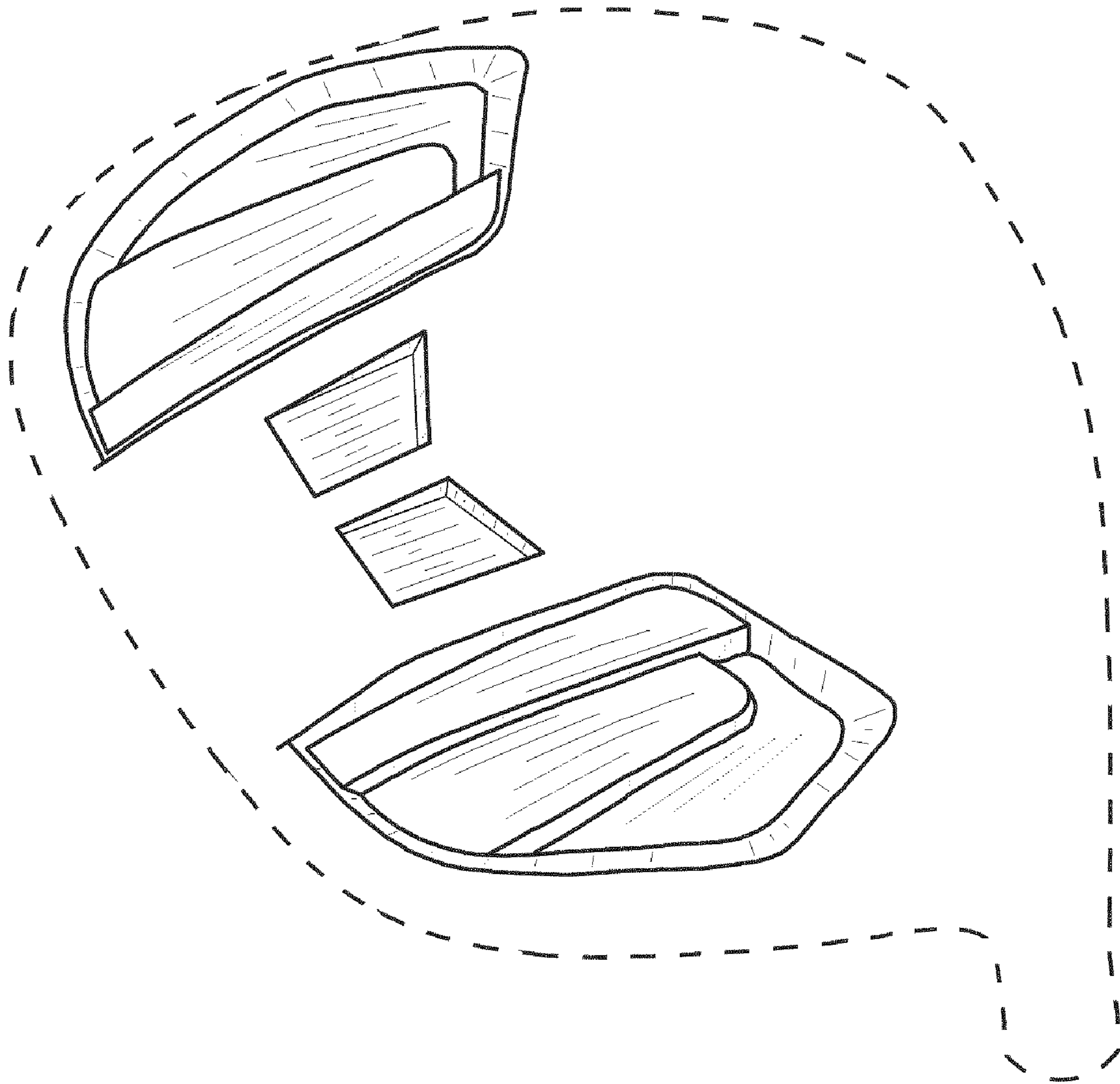

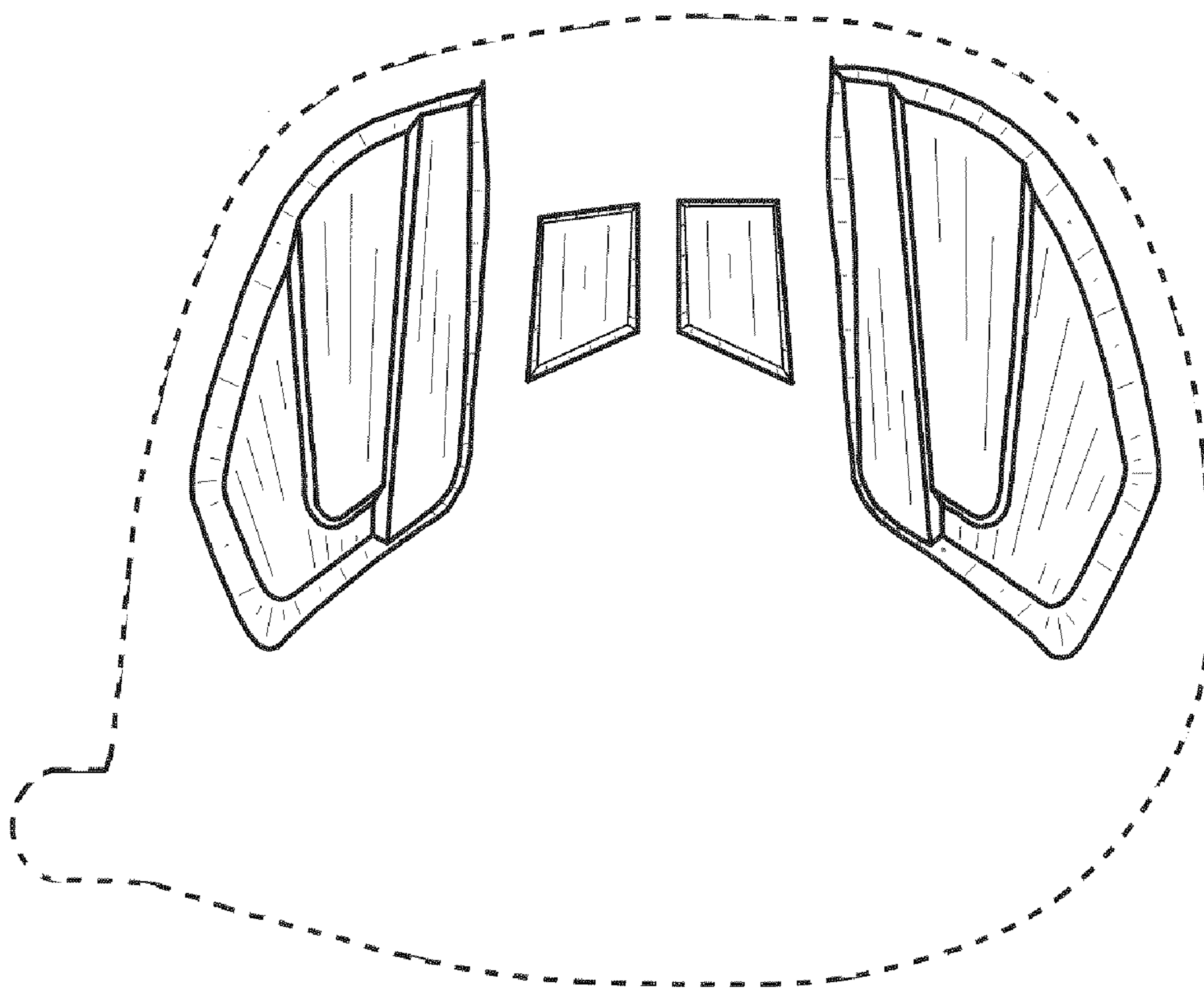

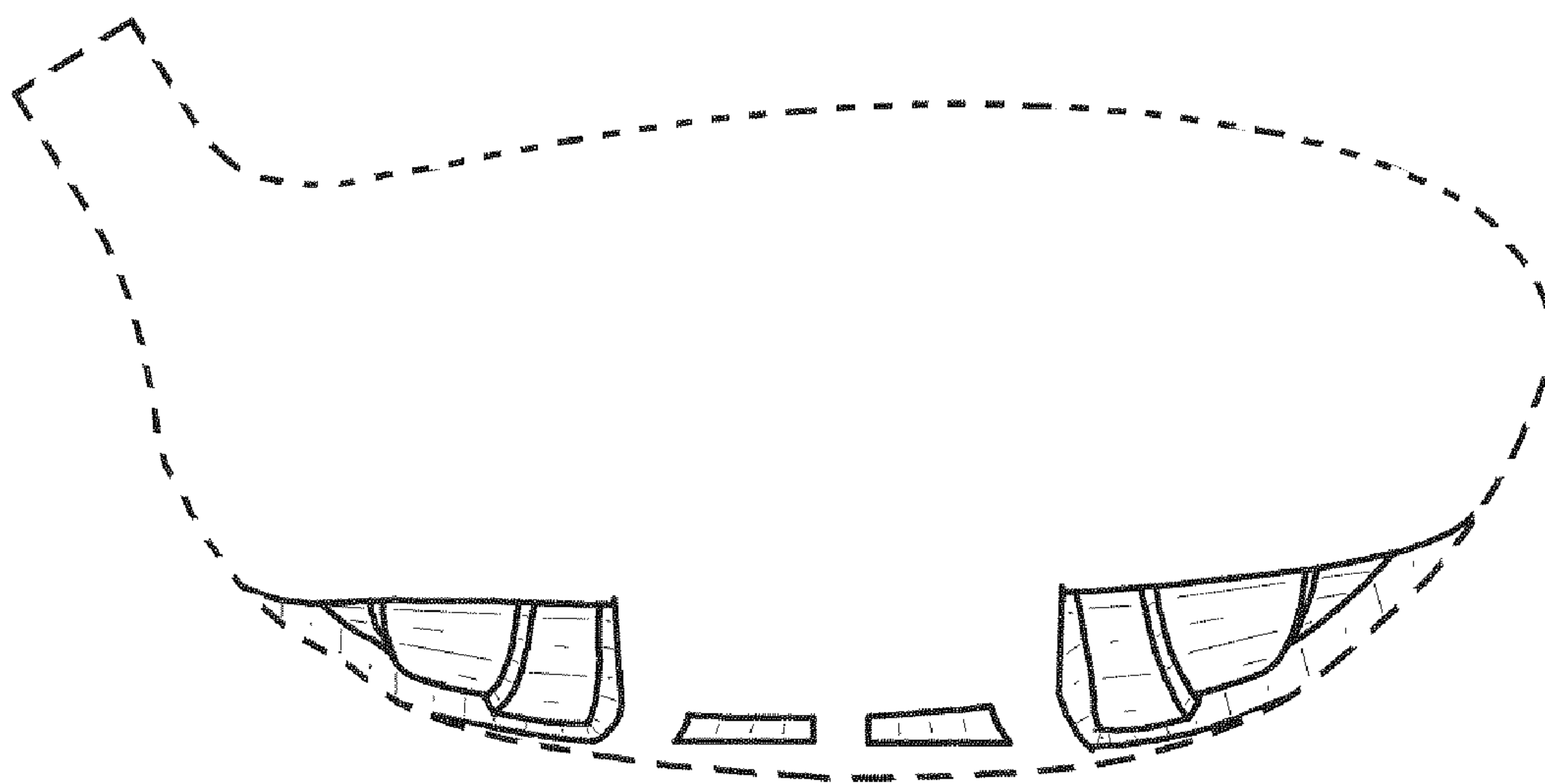

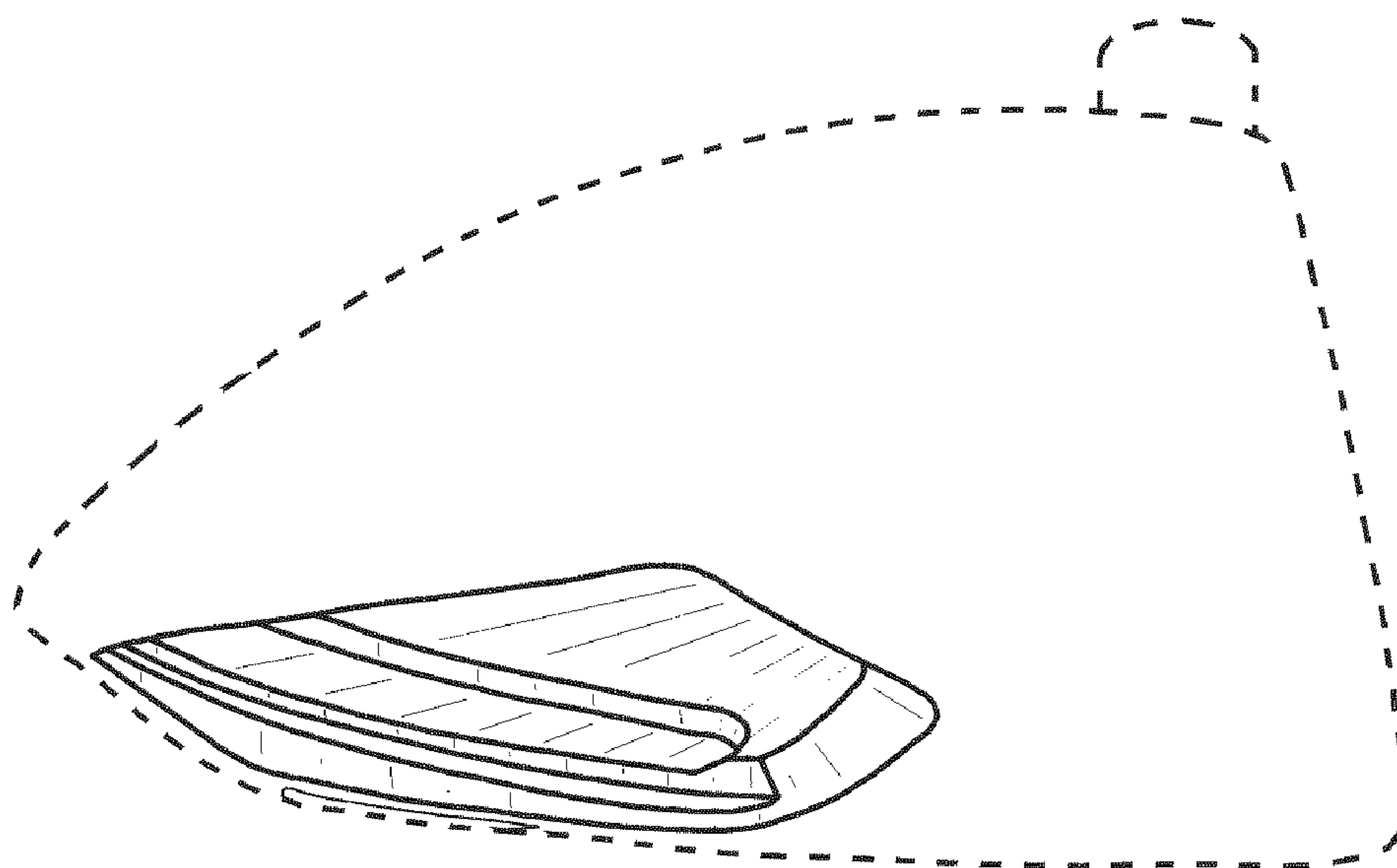

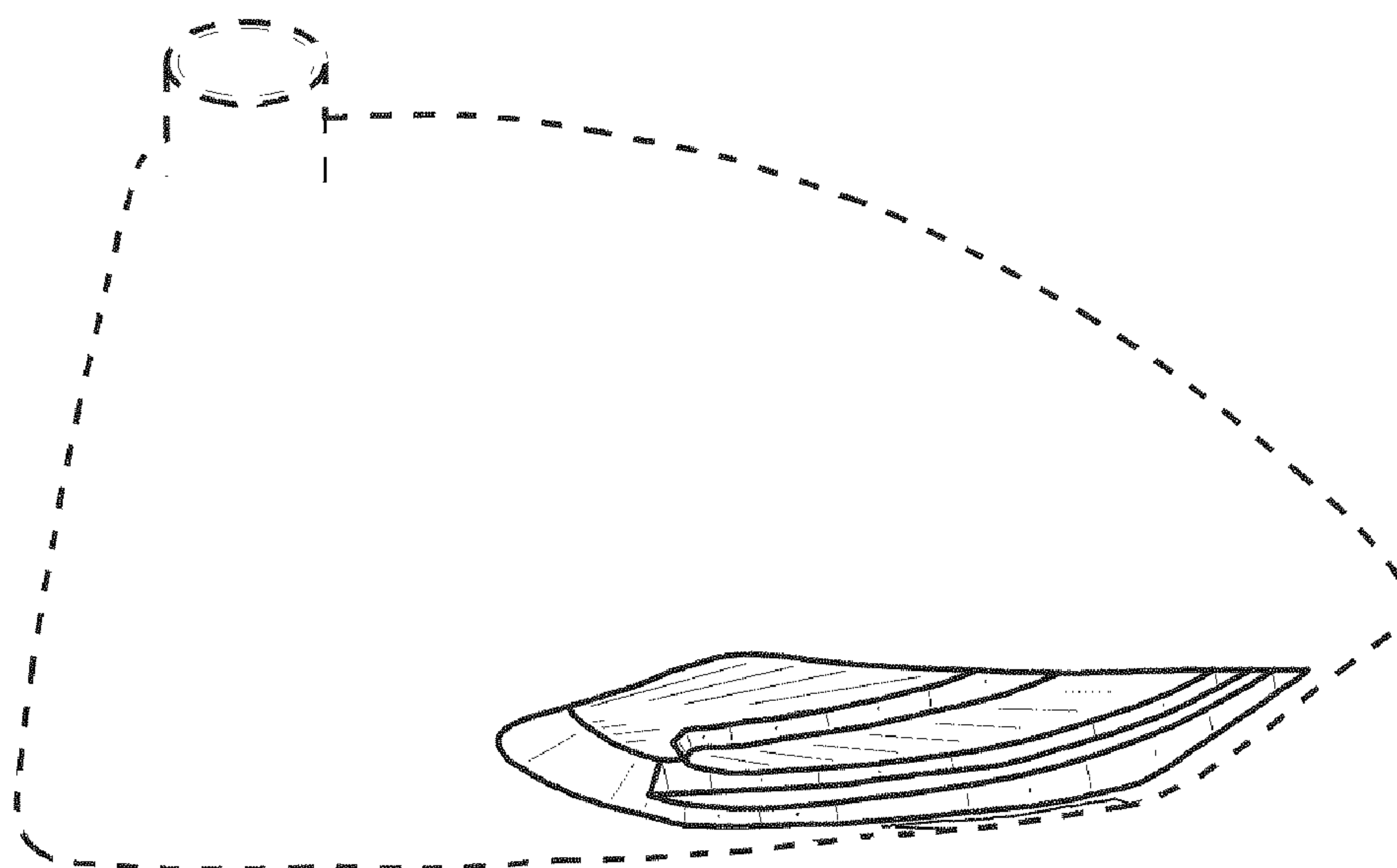
