The ornamental design for a golf club head, as shown and described.

DESCRIPTION

FIG. 3 is a heel-side elevational view thereof.

FIG. 4 is a front elevational view thereof.

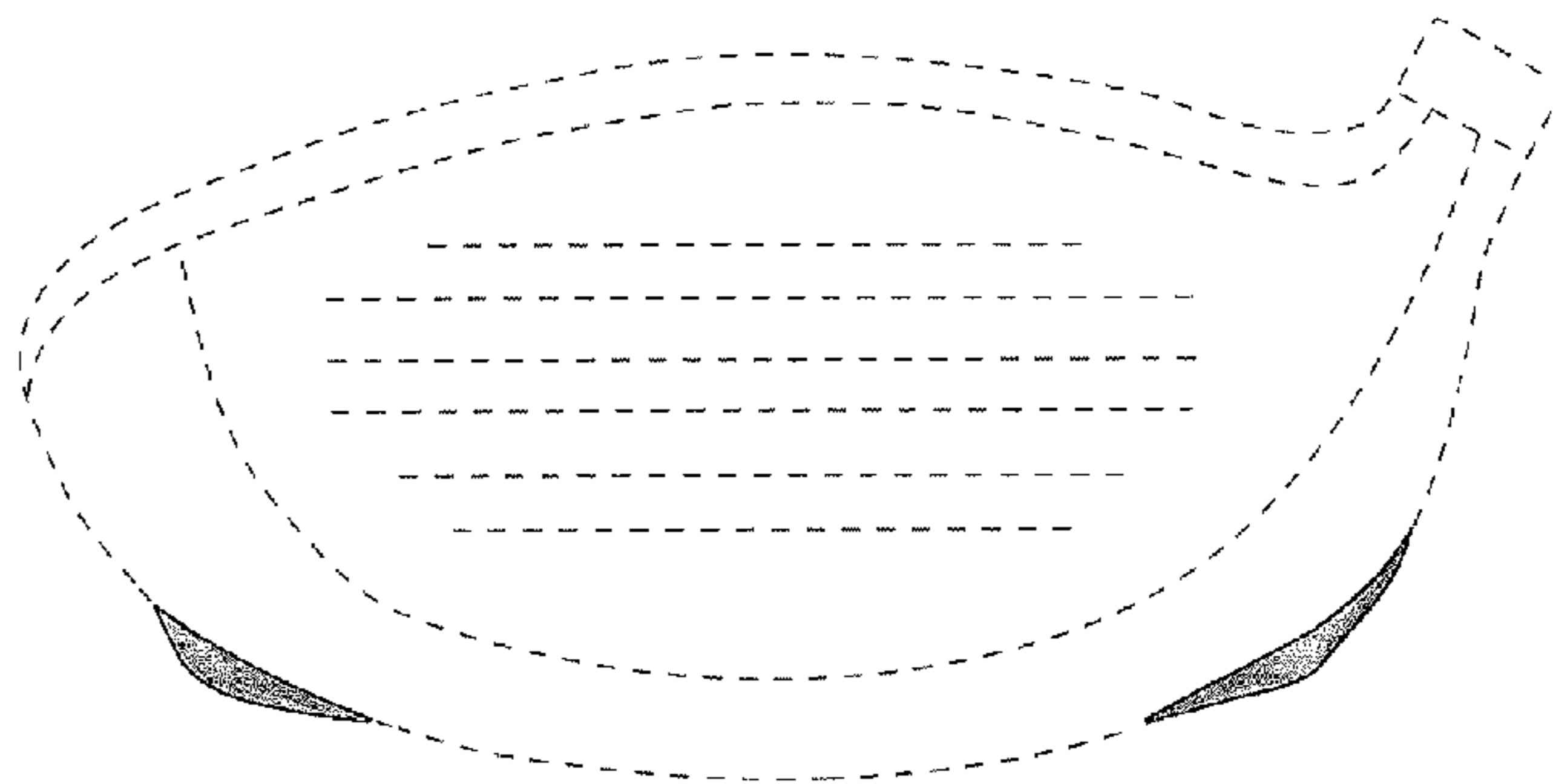
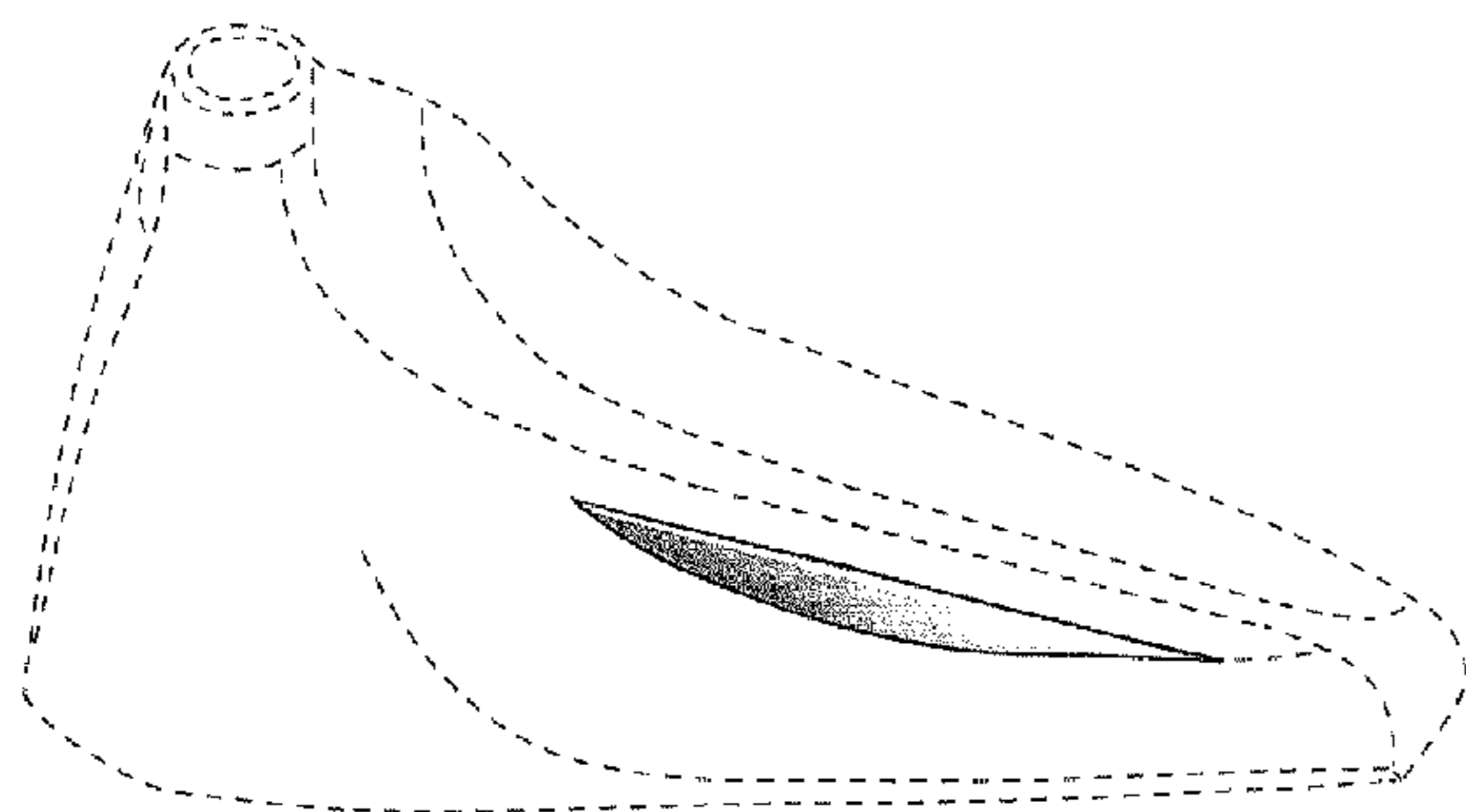
FIG. 5 is a rear elevational view thereof.

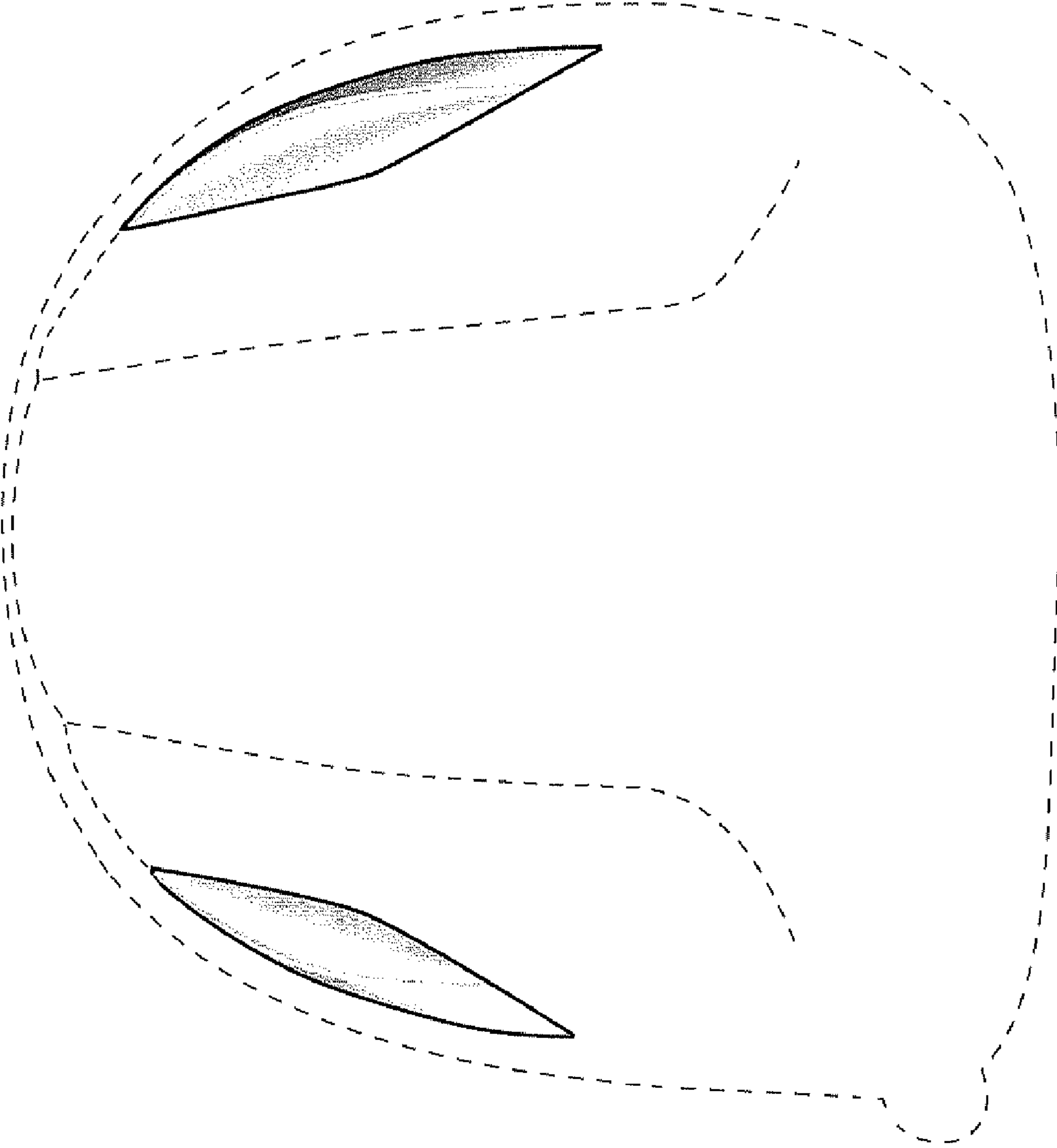

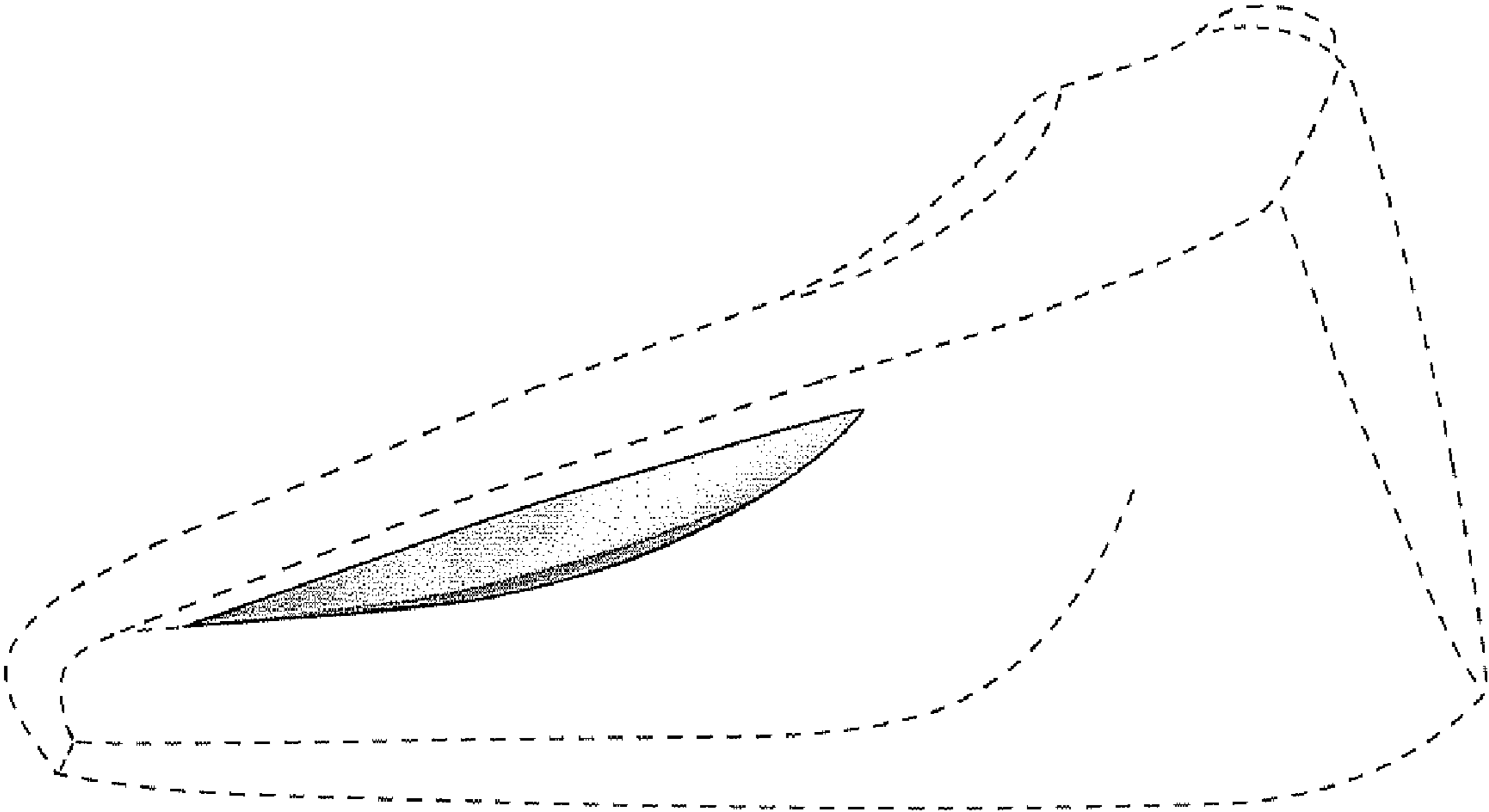

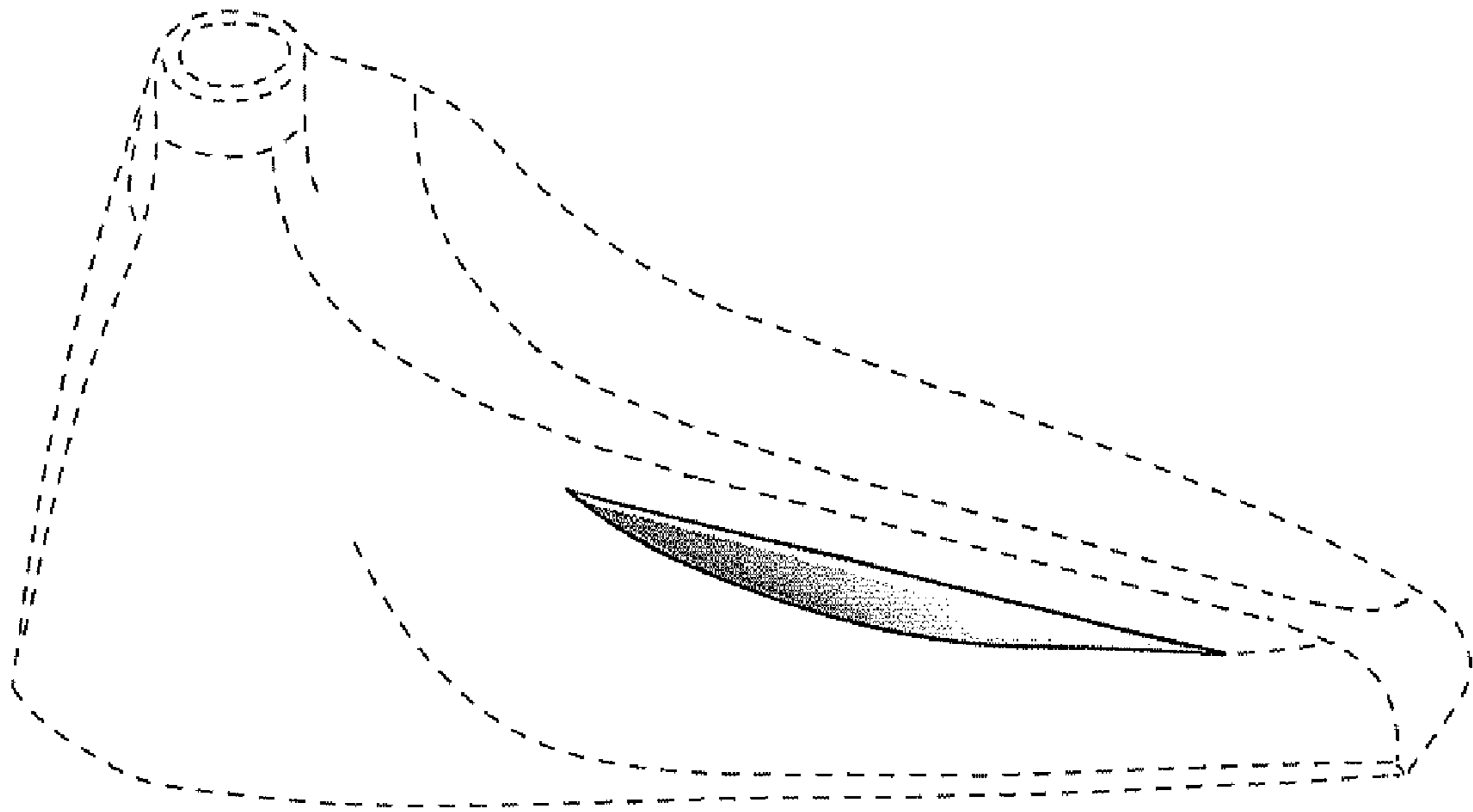

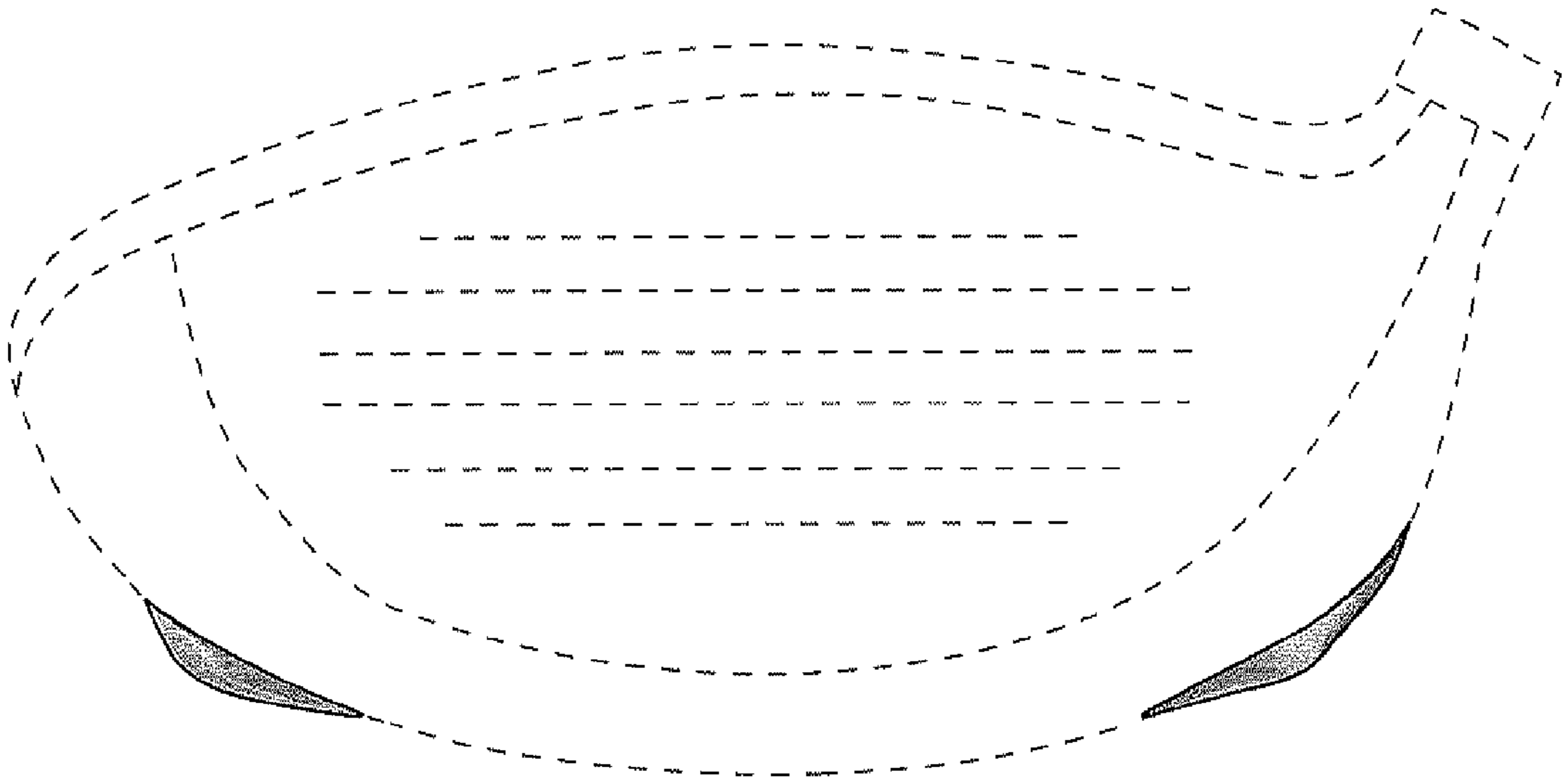

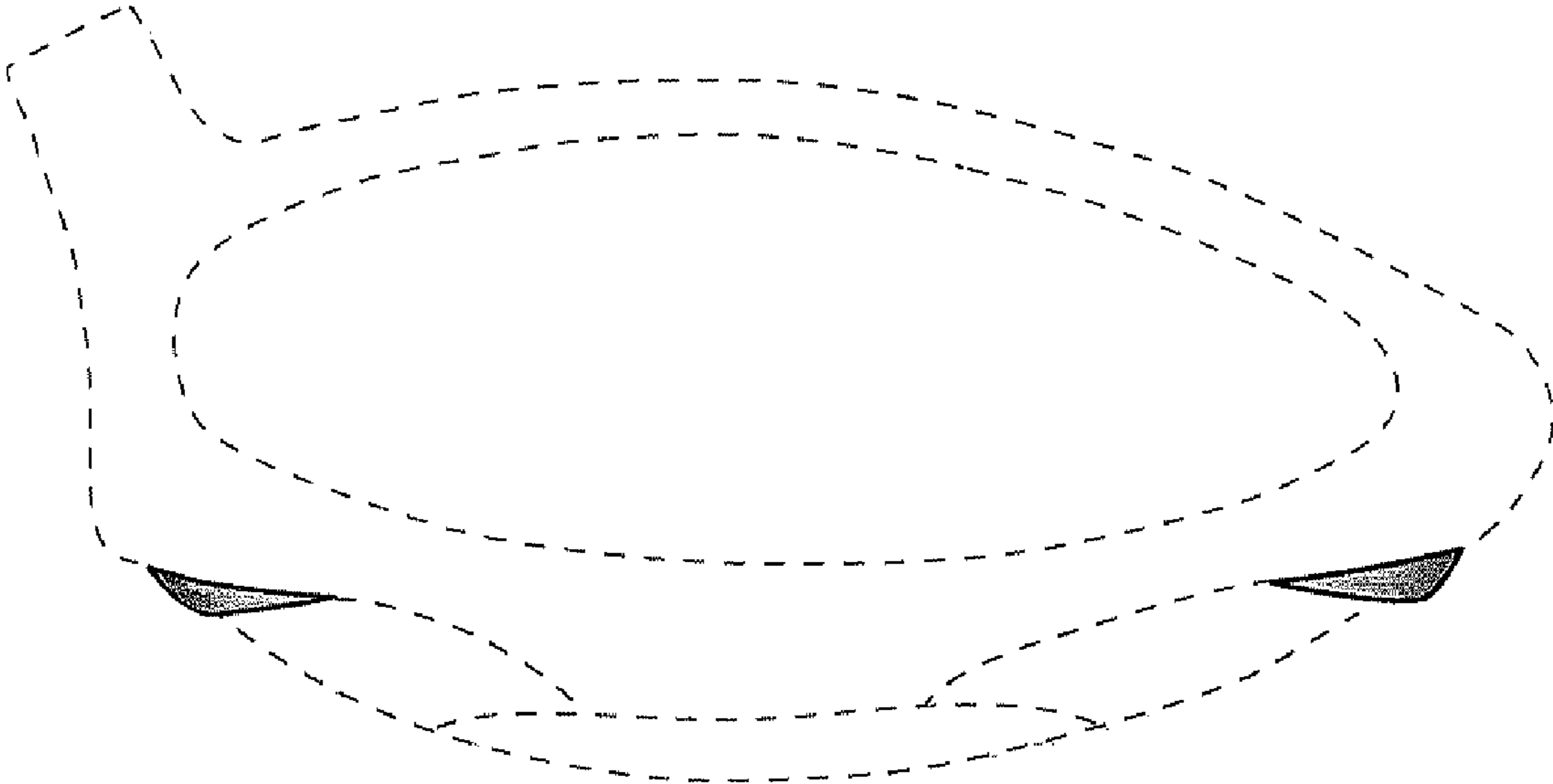

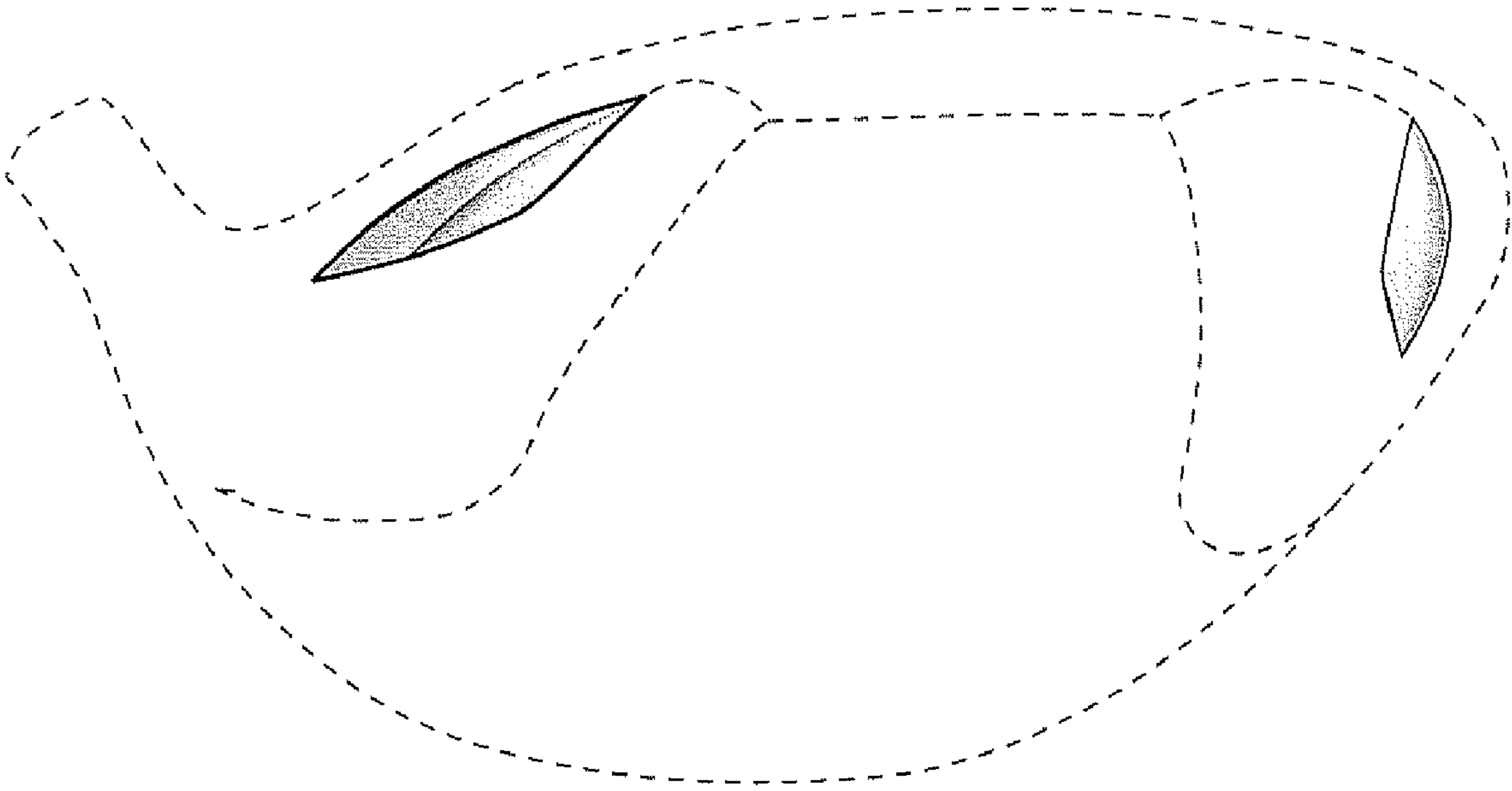

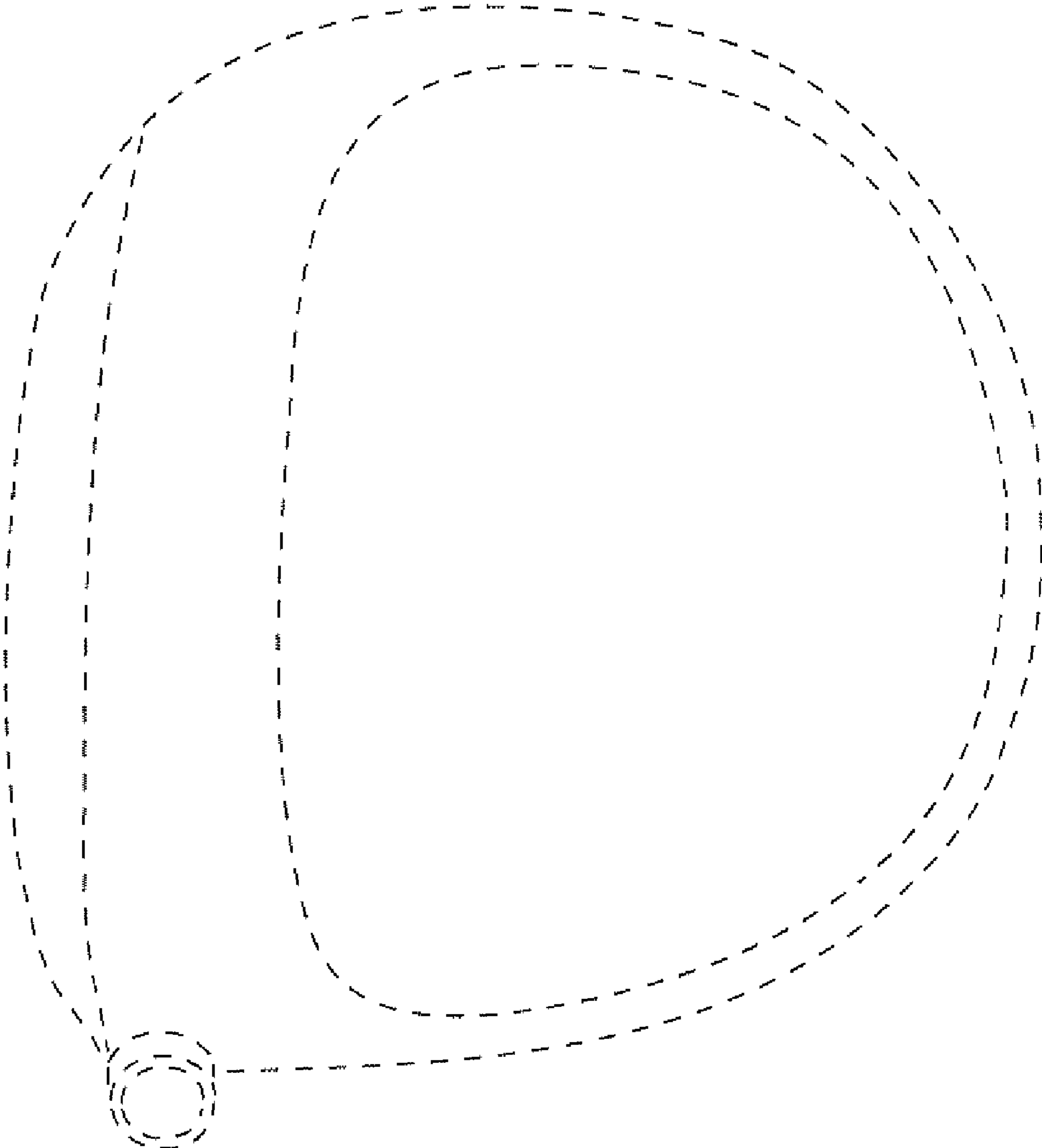
