The ornamental design for the tiki treehouse, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the tiki treehouse, showing my new design;

FIG. 2 is a side view of the tiki treehouse shown in FIG. 1;

FIG. 3 is a front view of the tiki treehouse shown in FIG. 1;

FIG. 4 is another side view of the tiki treehouse shown in FIG. 1;

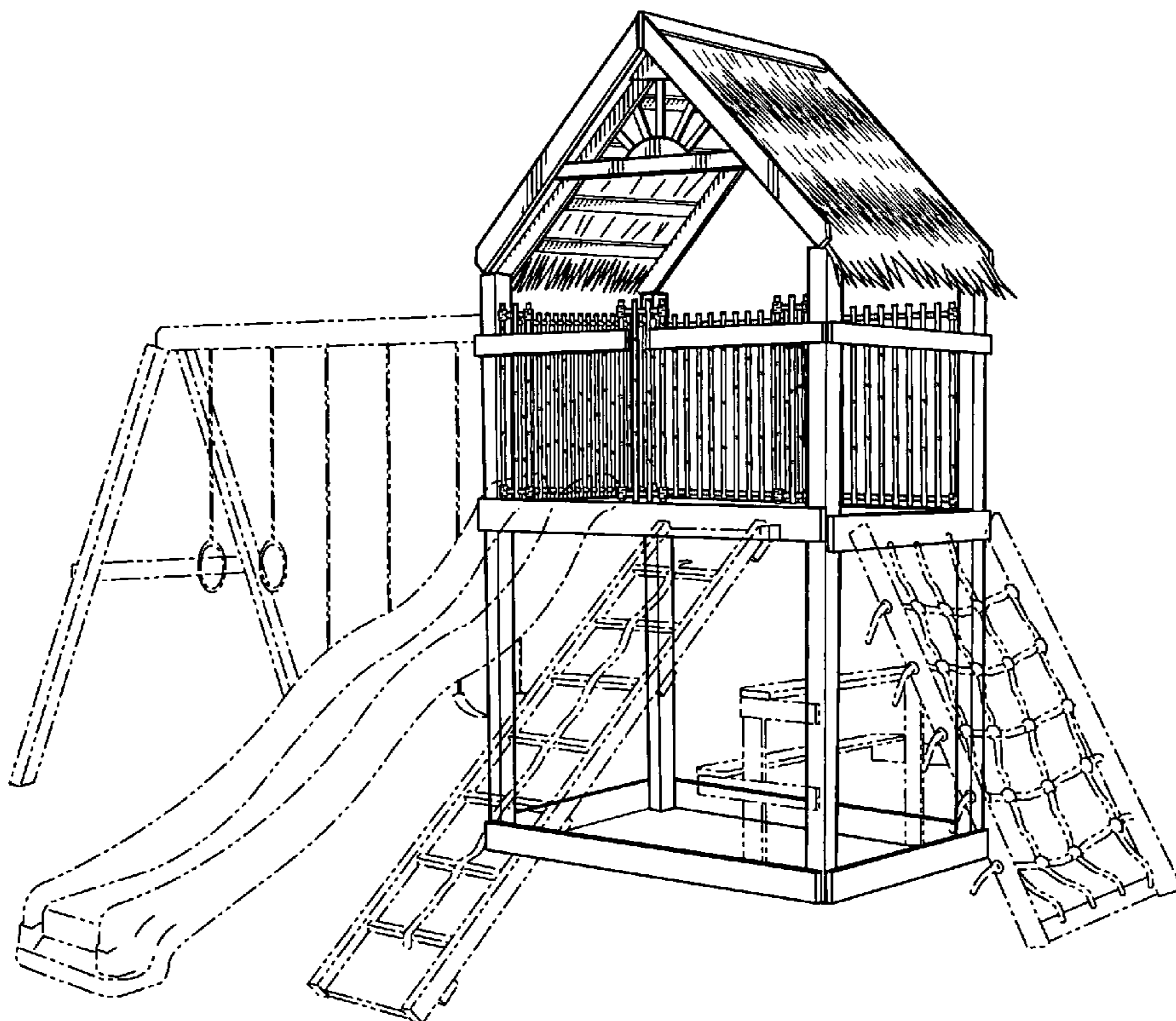
FIG. 5 is a back view of the tiki treehouse shown in FIG. 1;

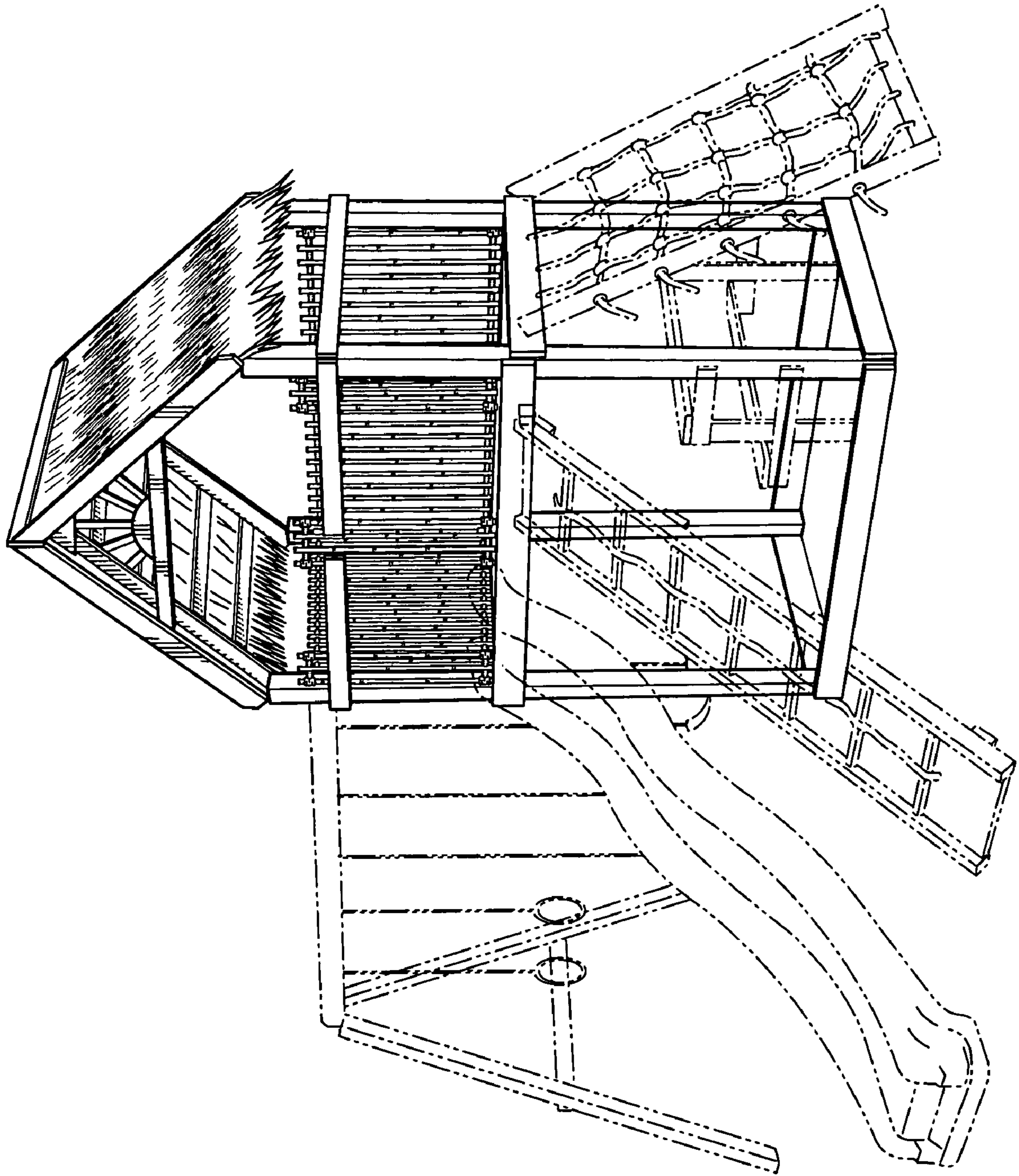

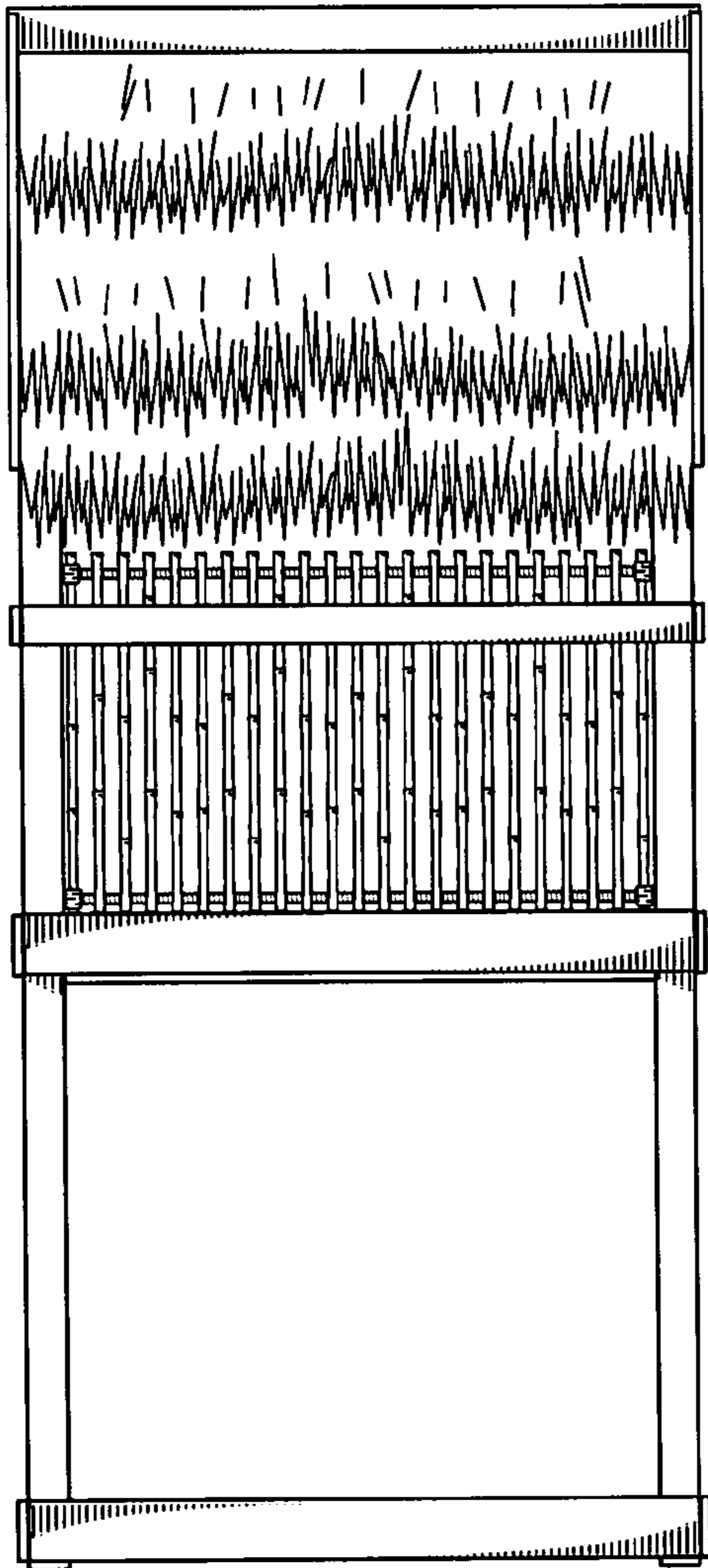

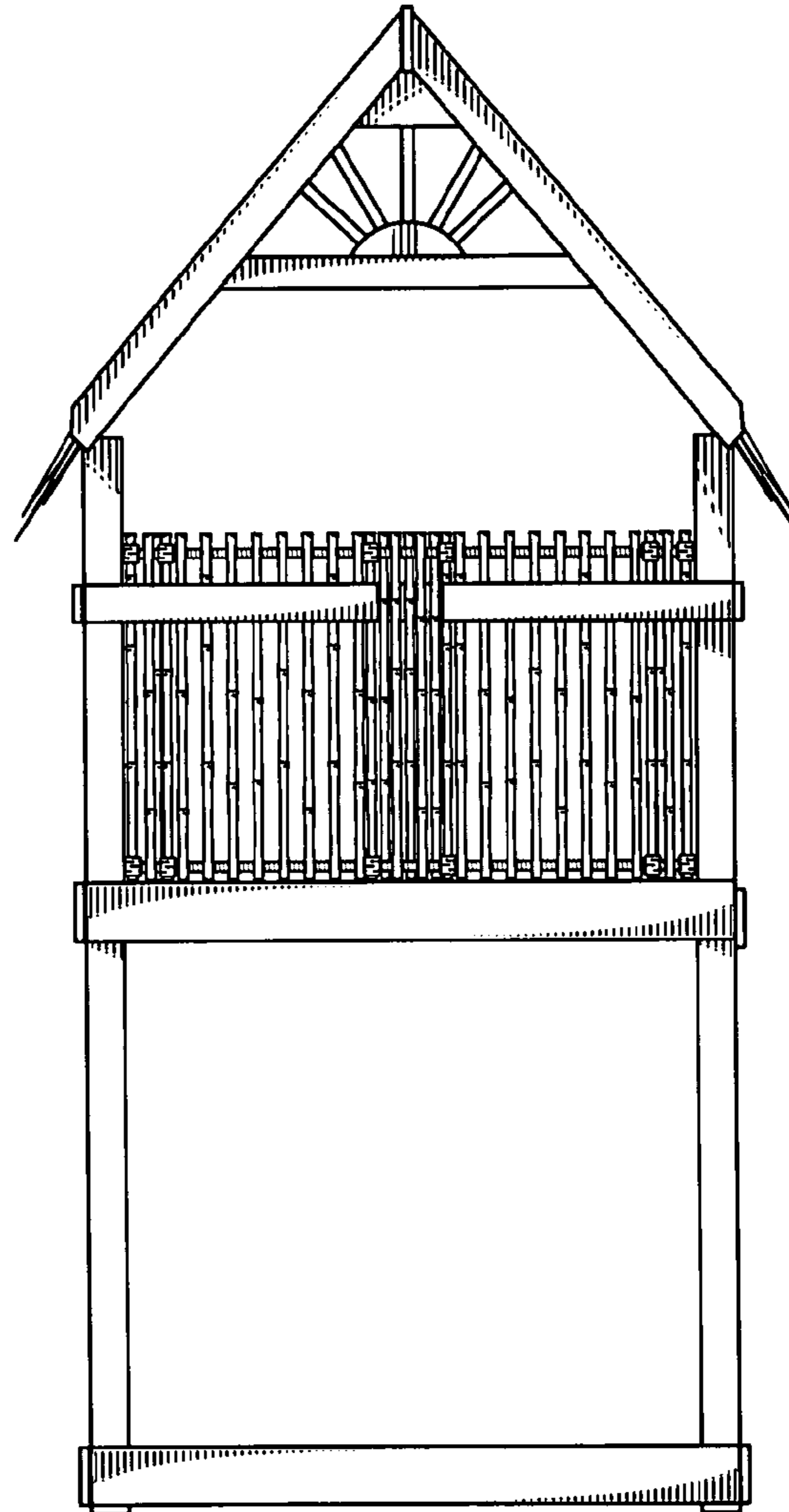
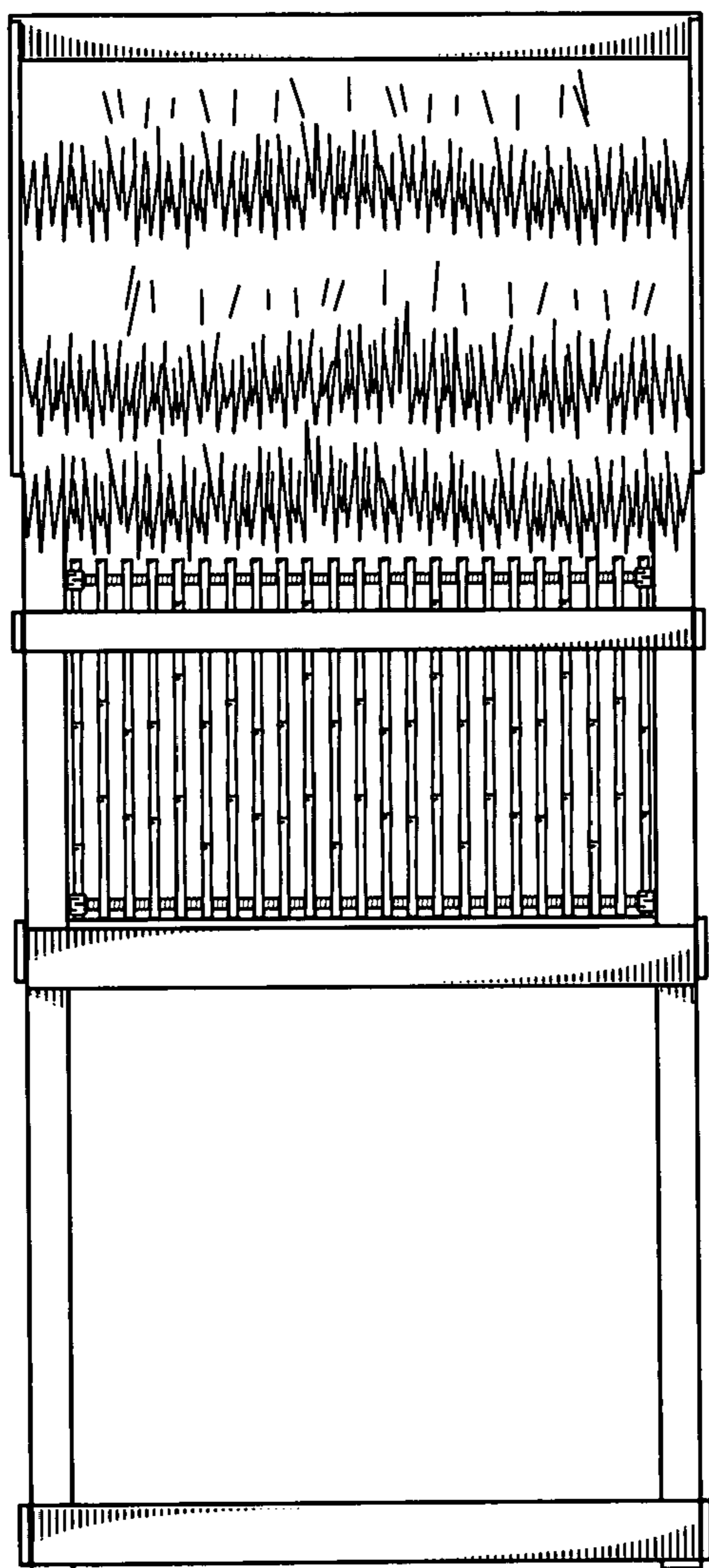
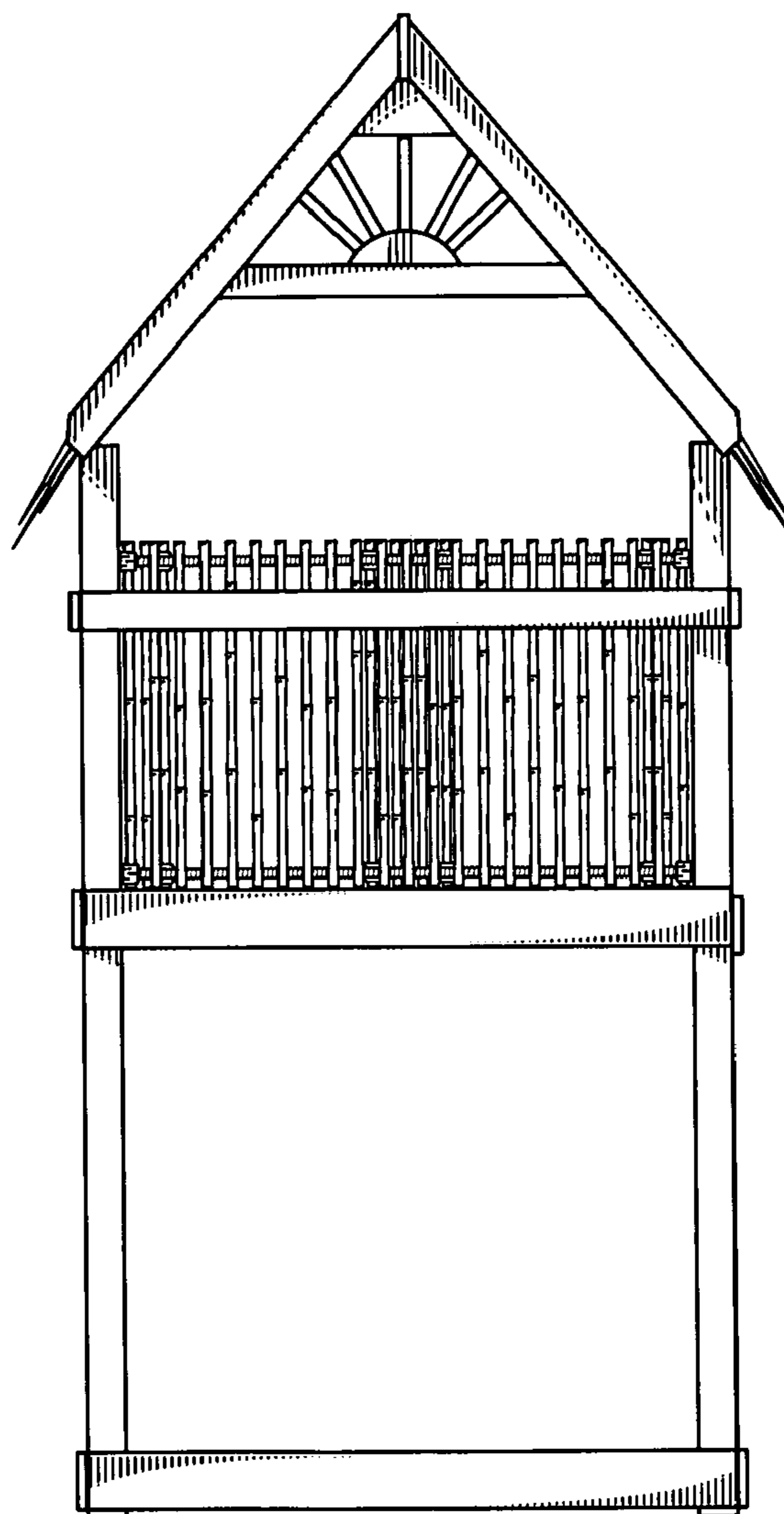


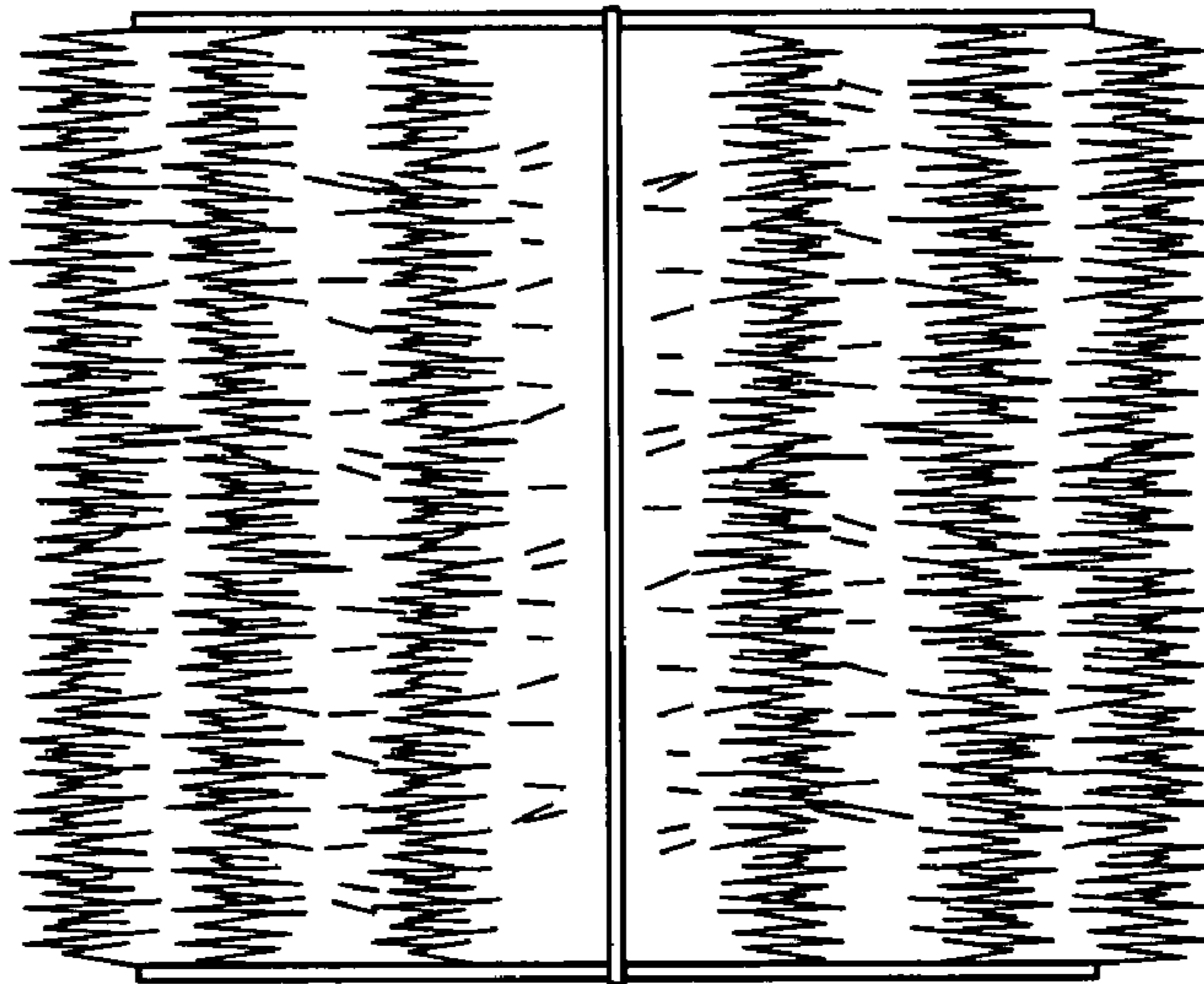

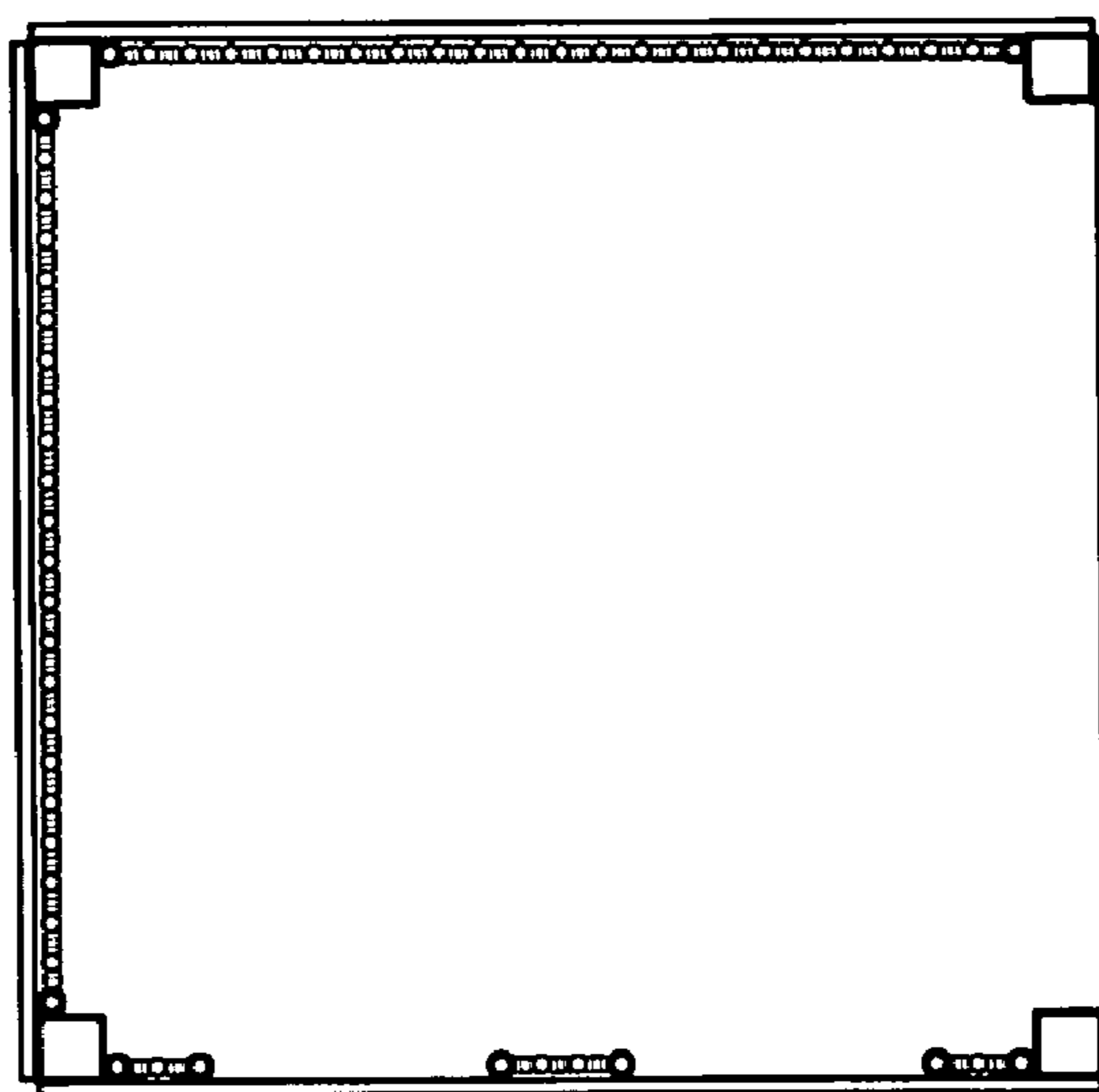
