(57) **CLAIM**

The ornamental design for a surgical suture anchor, as shown and described.

**DESCRIPTION**

FIG. 1 is a front and rear view of the surgical suture anchor, said front and rear views of said surgical suture anchor being identical.

FIG. 2 is a left and right side view of said surgical suture anchor, said right and left side views of said surgical suture anchor being identical.

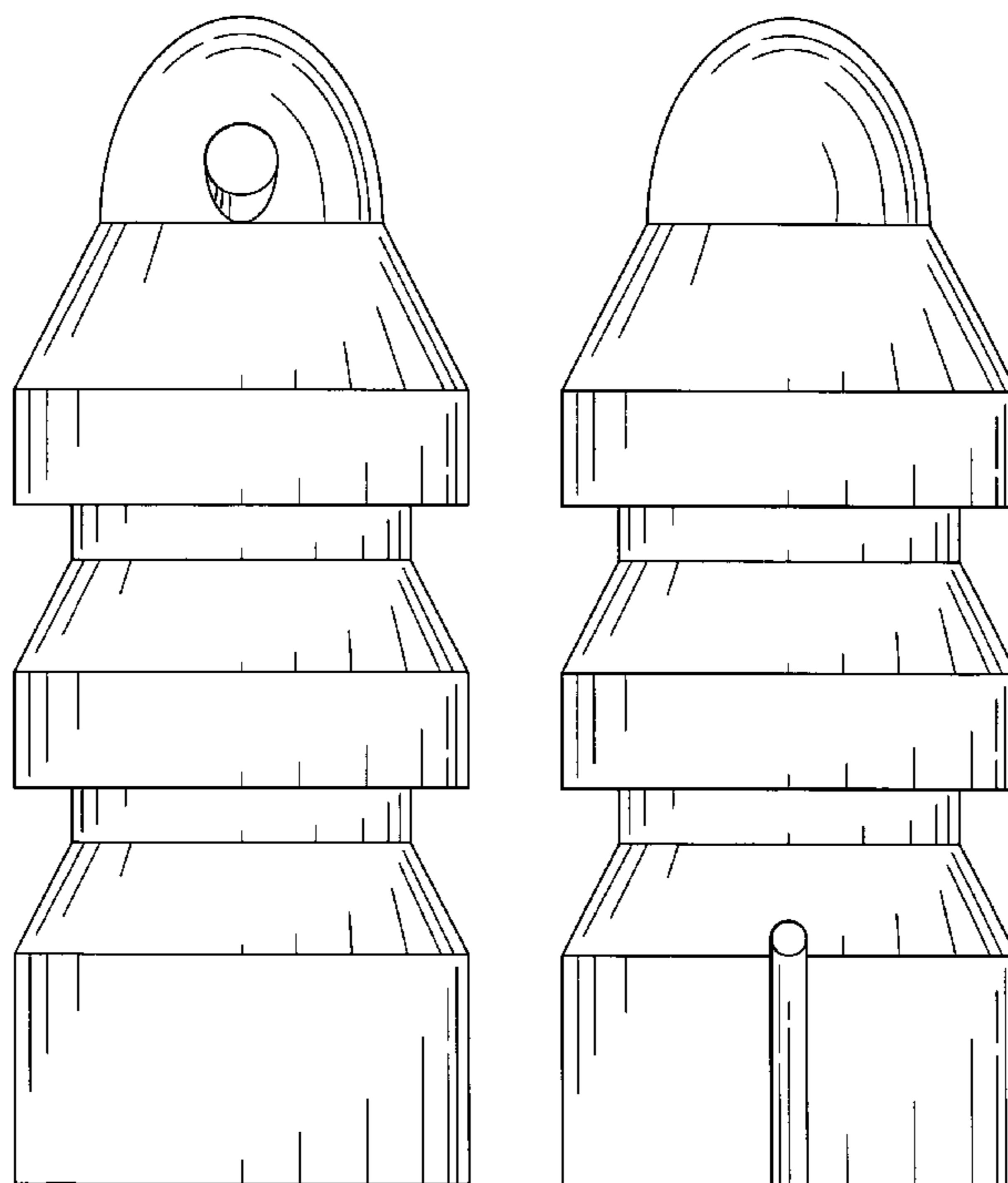
FIG. 3 is a top view of said surgical suture anchor.

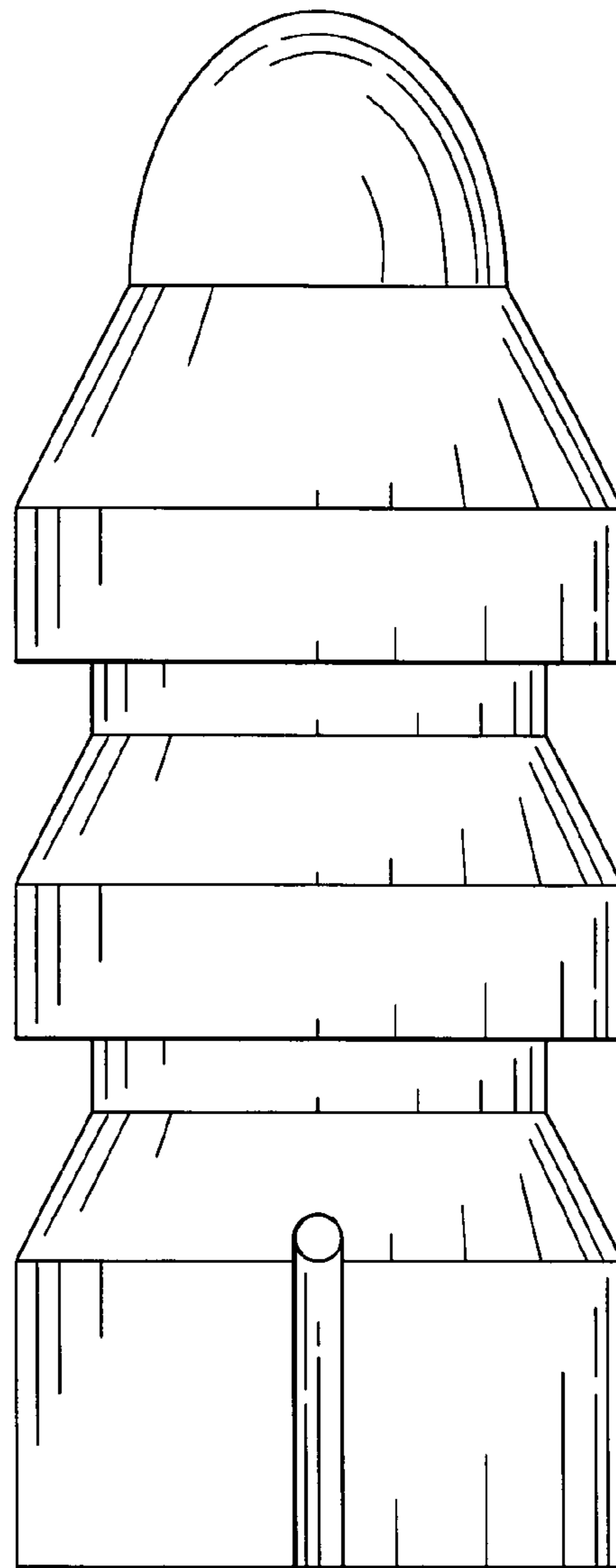
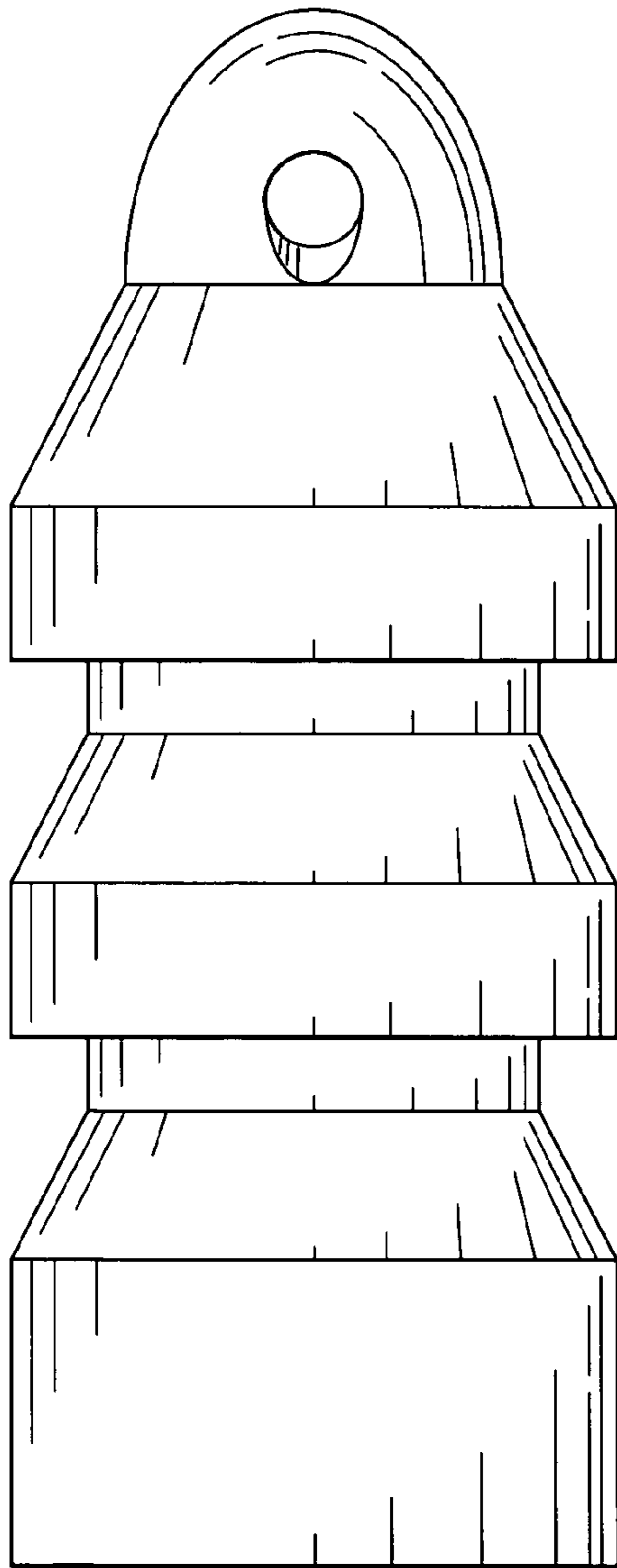
FIG. 4 is a bottom view of said surgical suture anchor

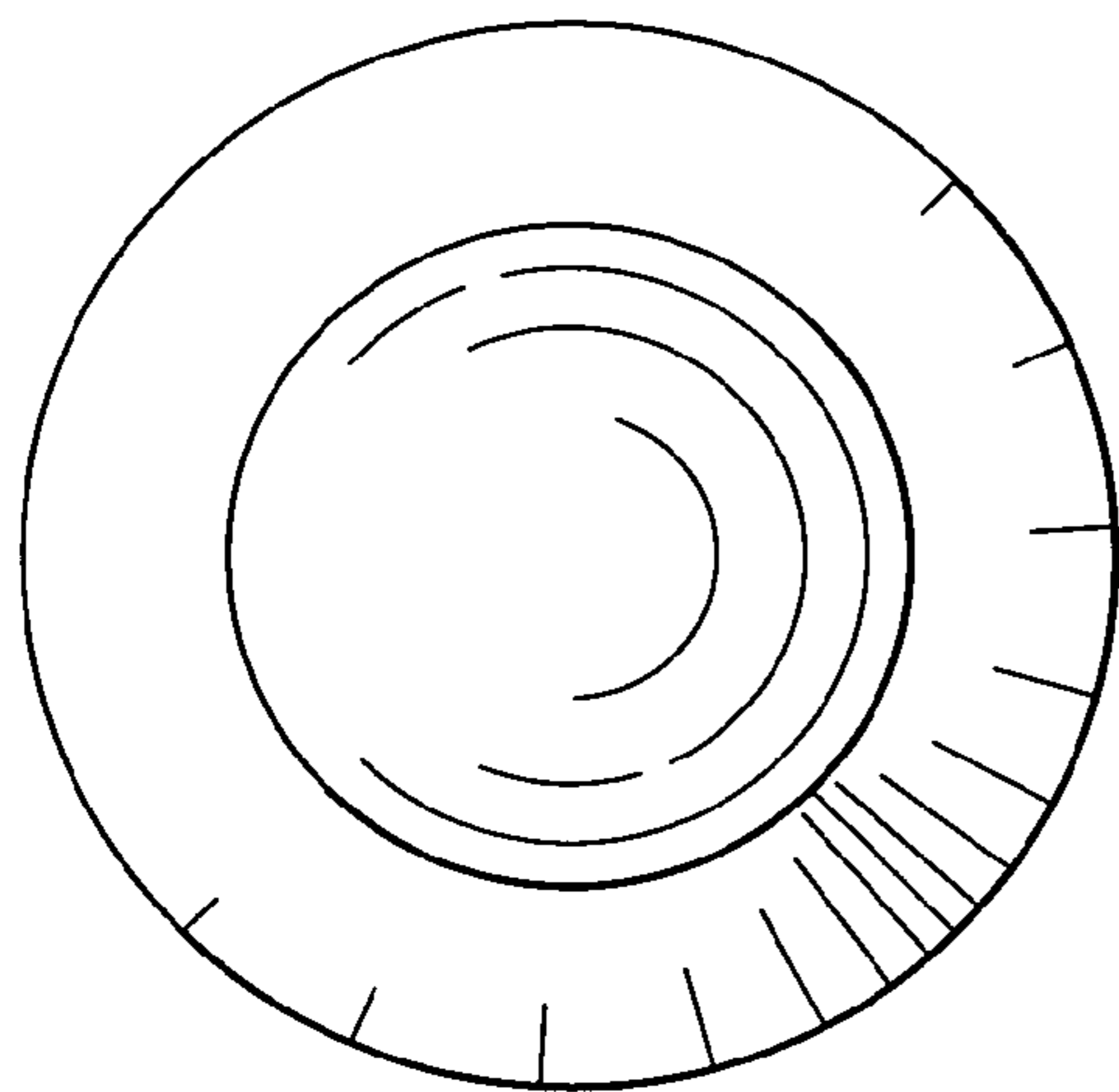

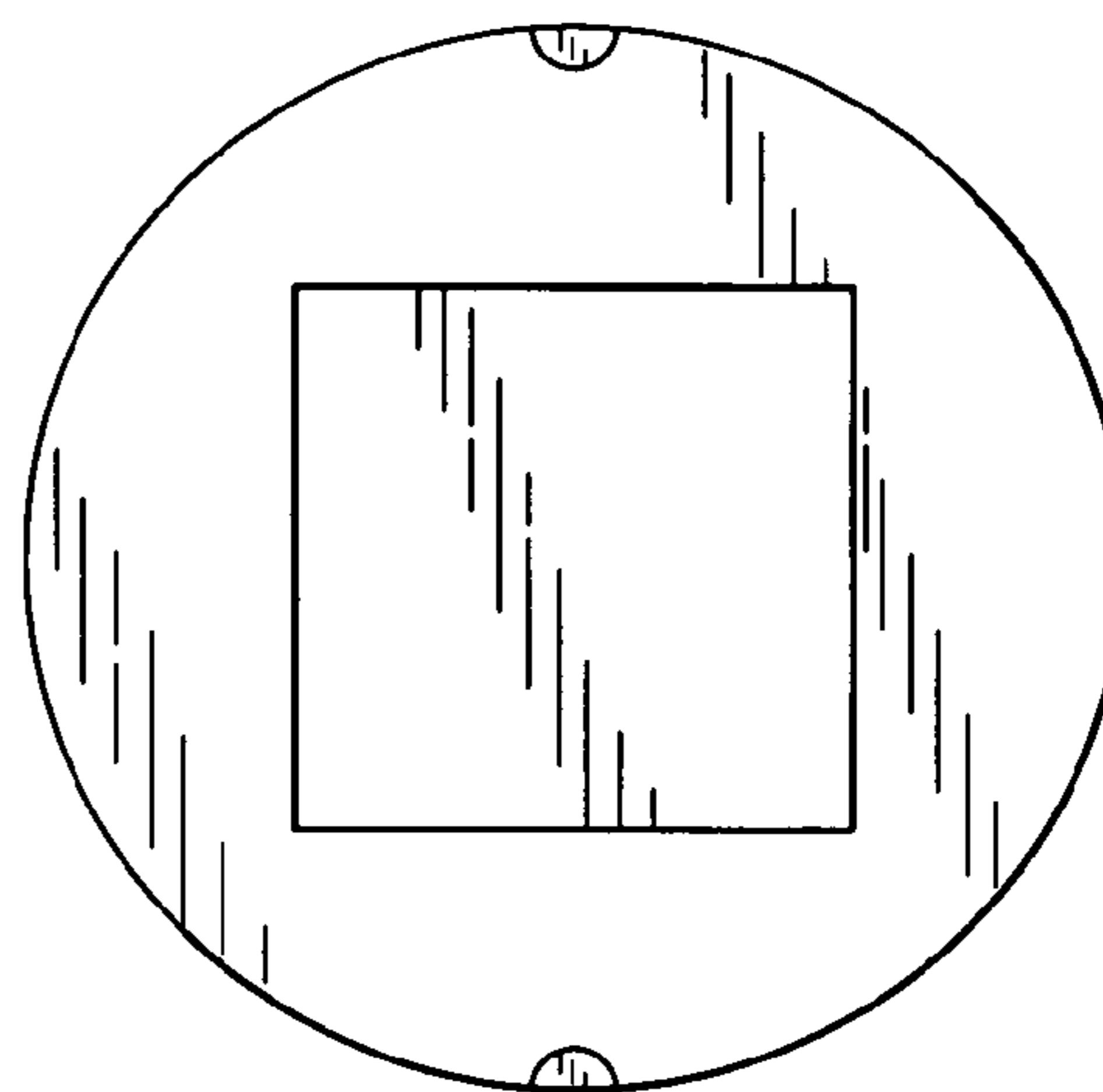

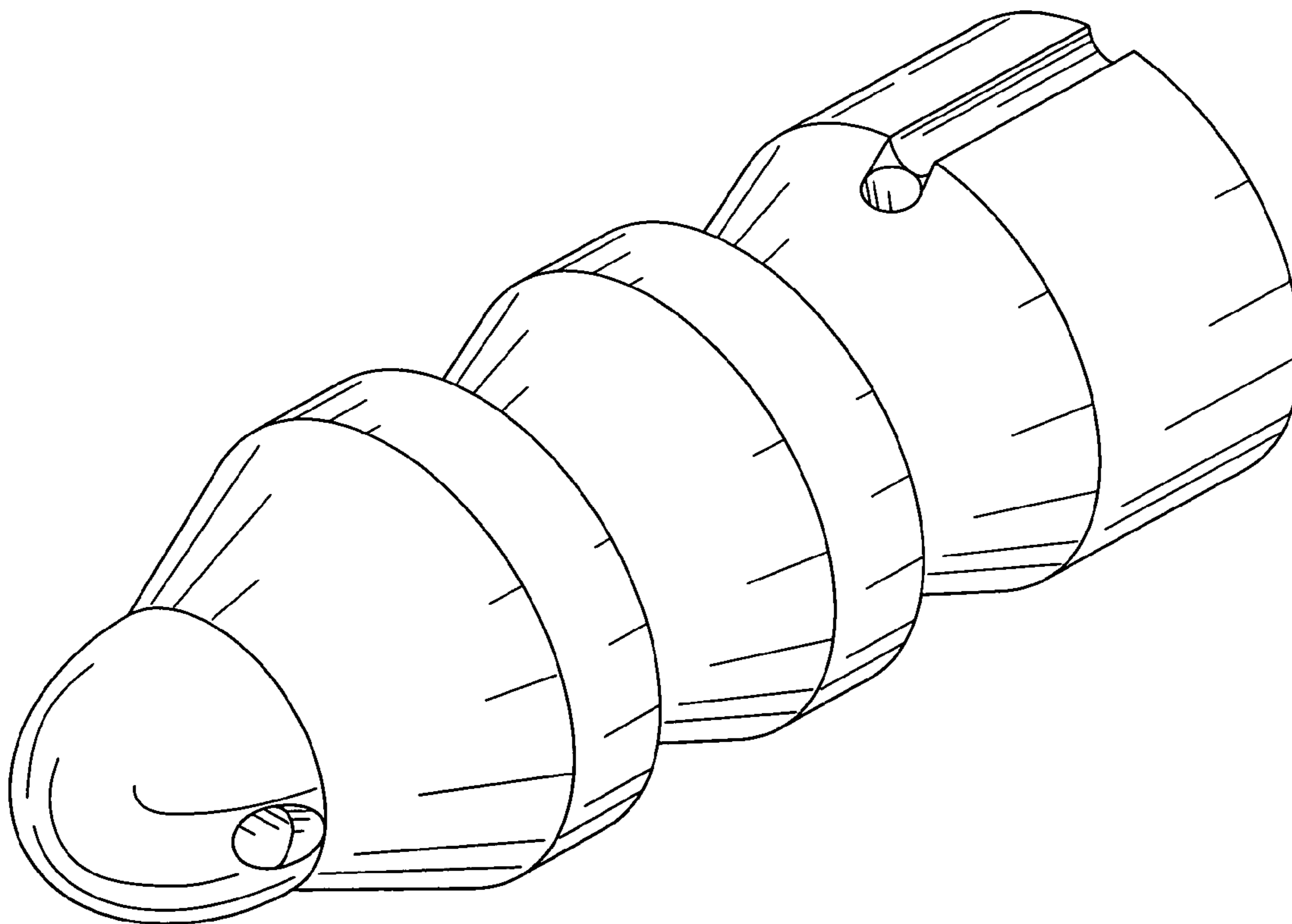
