(57) **CLAIM**

I claim, the ornamental design for a shoe, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a shoe, showing my new design;

FIG. 5 is a right elevation view thereof taken from the right of FIG. 3;

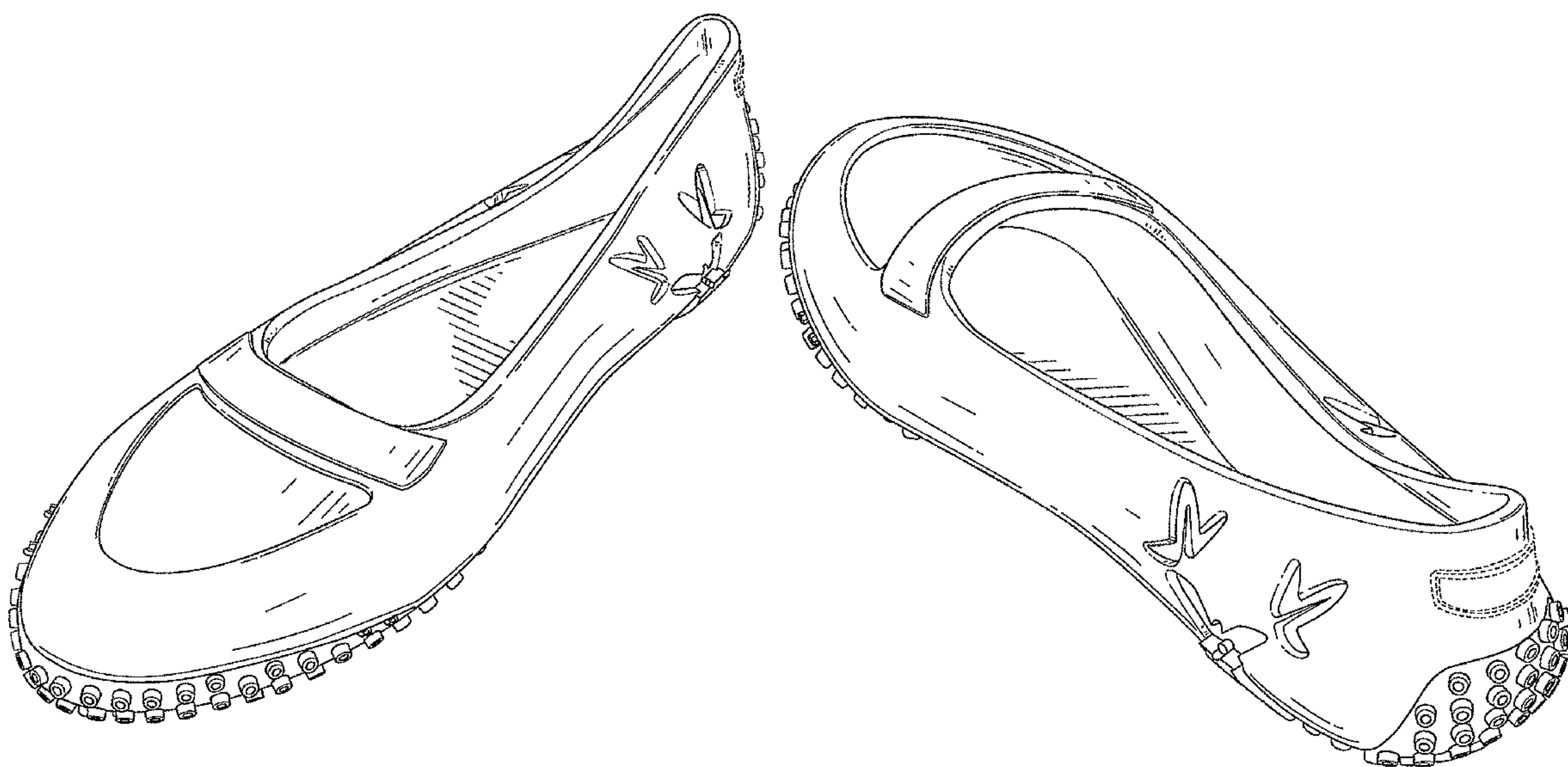
FIG. 6 is a left elevation view thereof taken from the left of FIG. 3; and

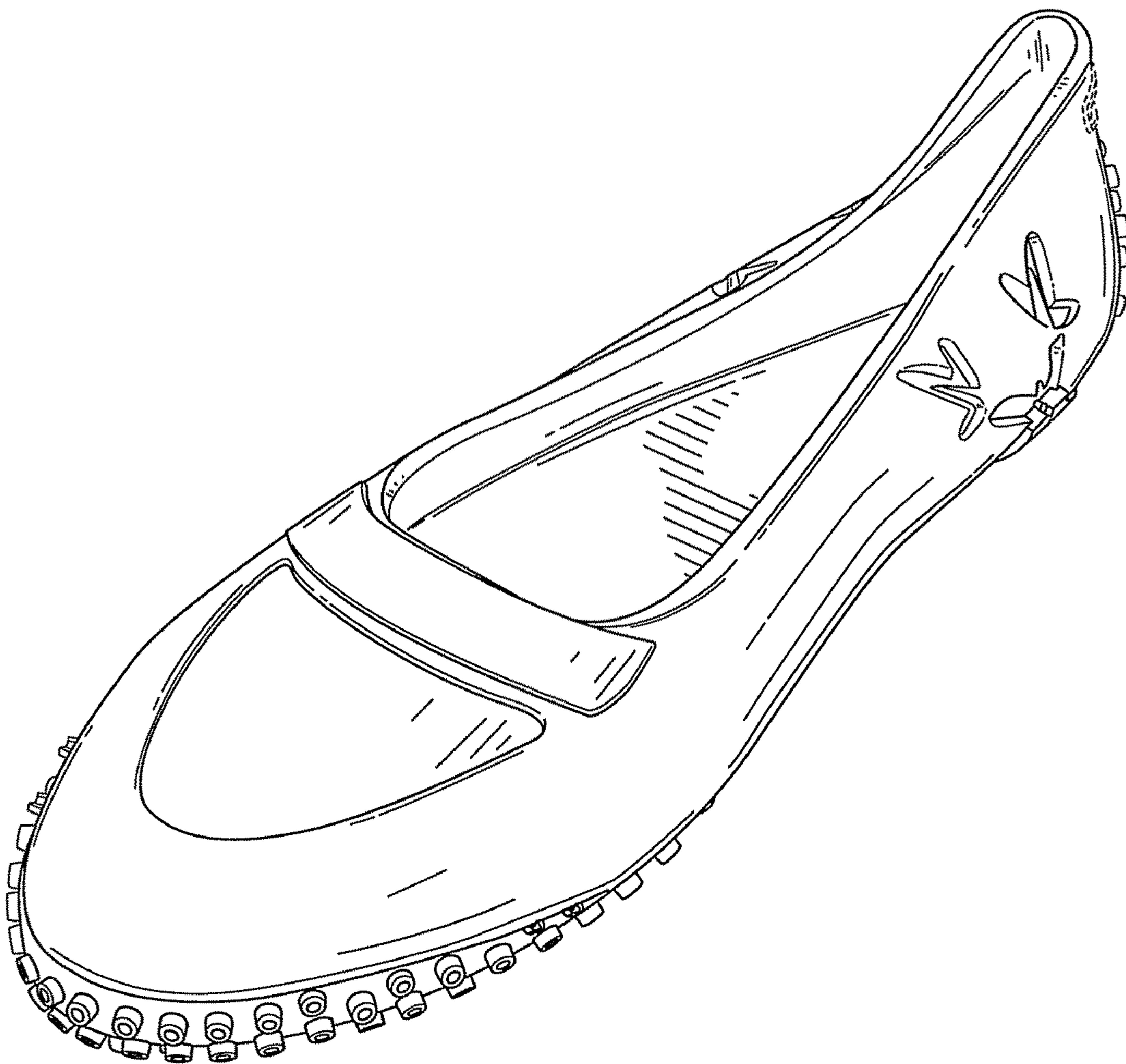
FIG. 7 is a top plan view thereof; and,

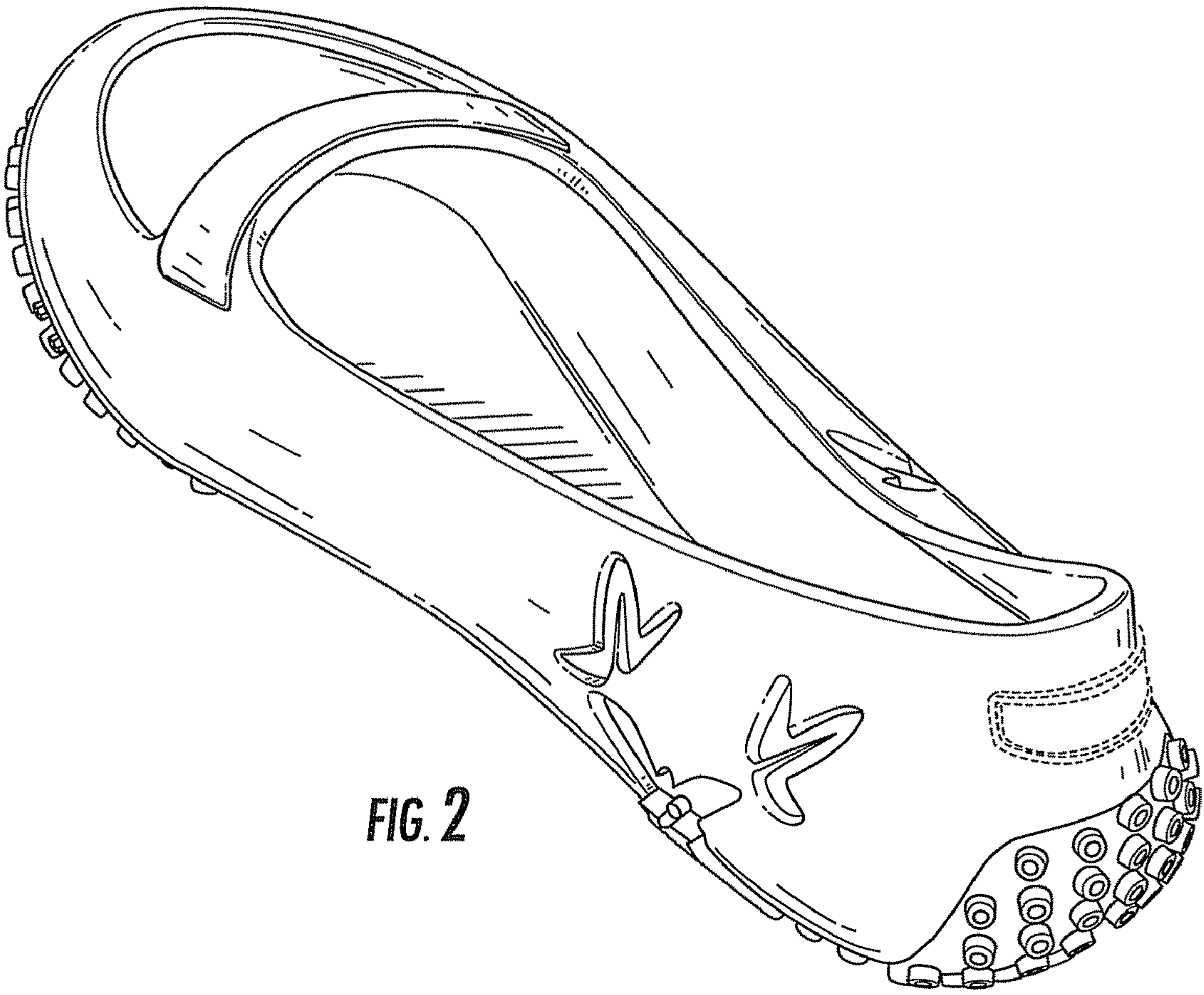
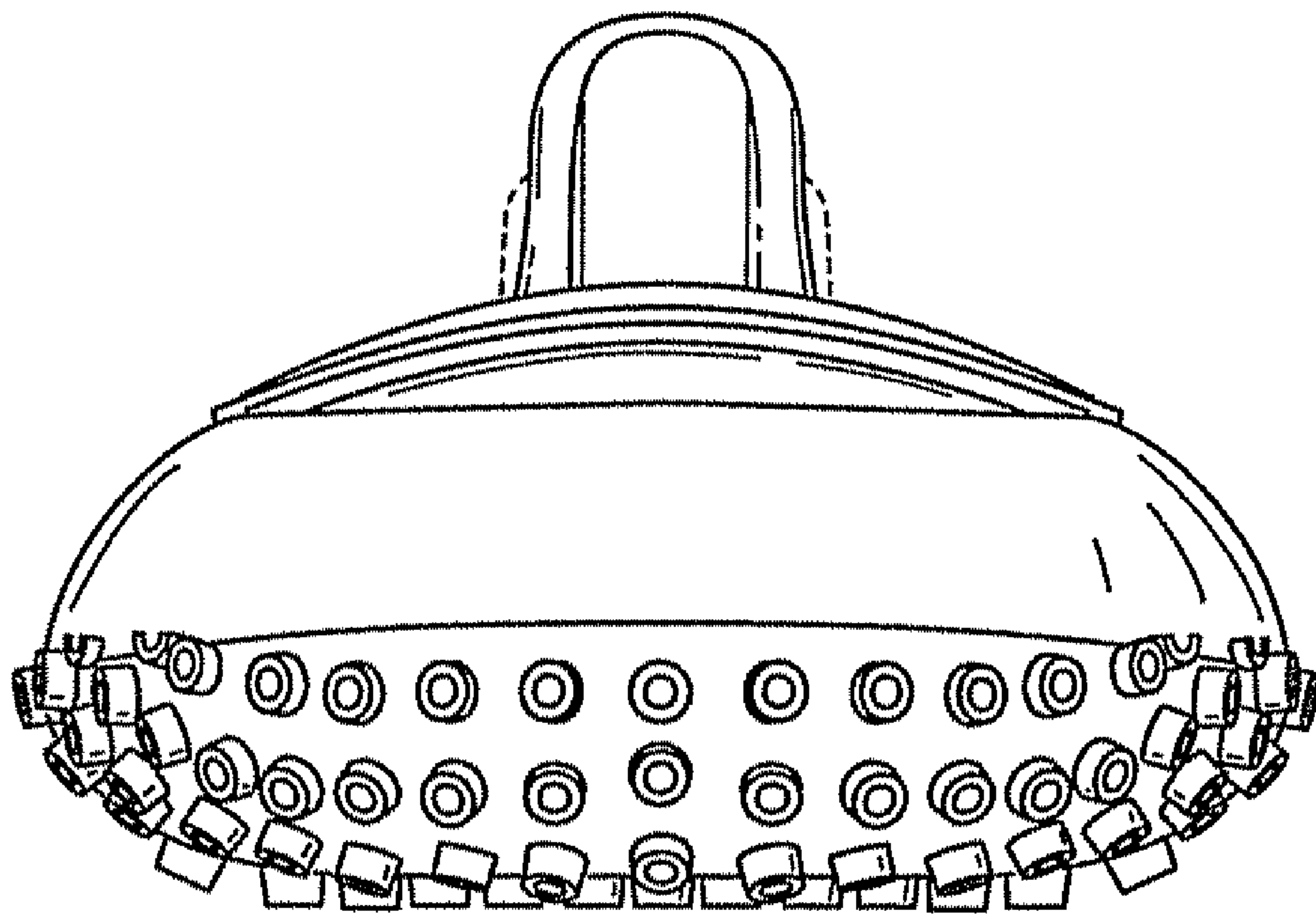
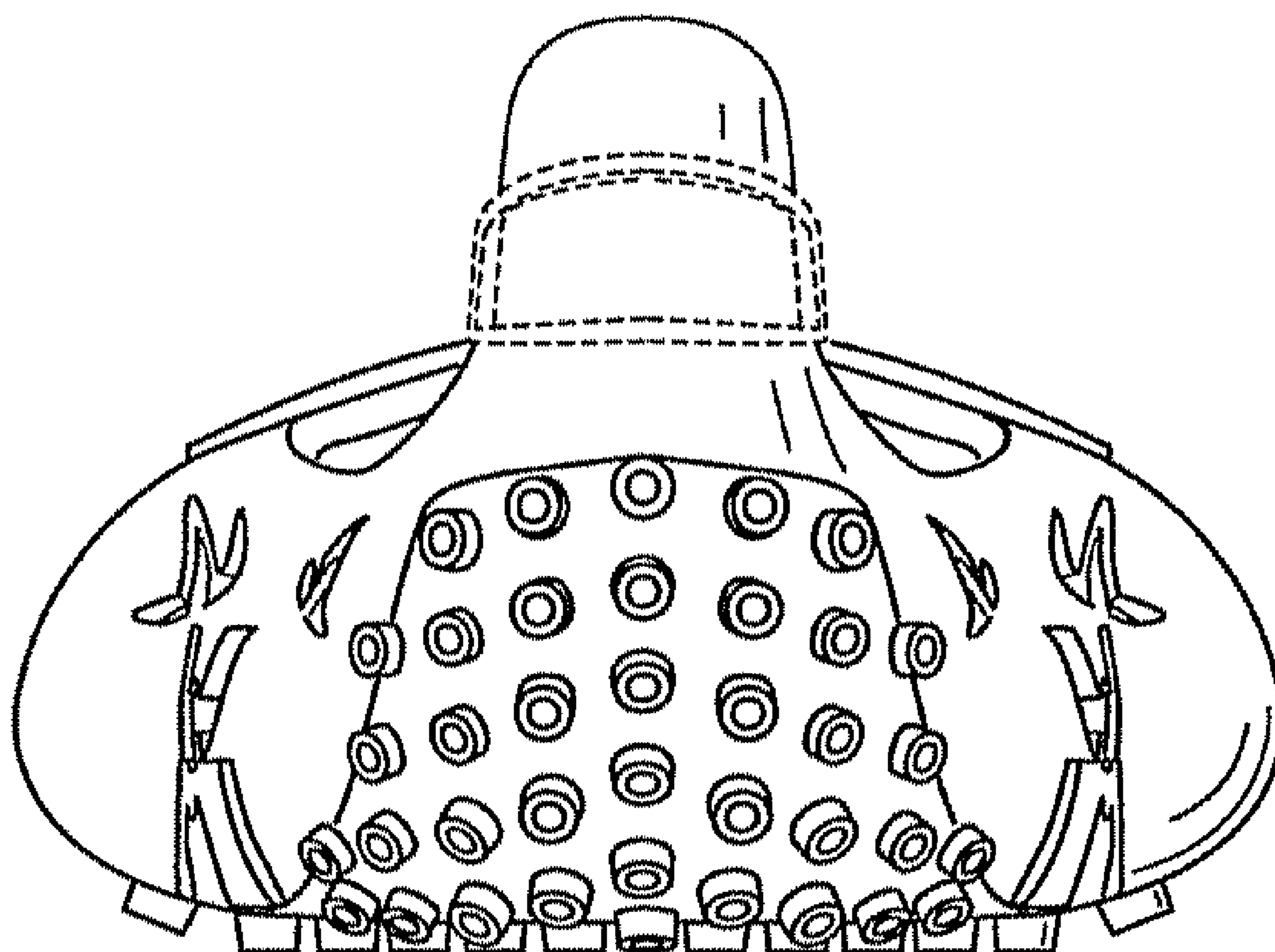

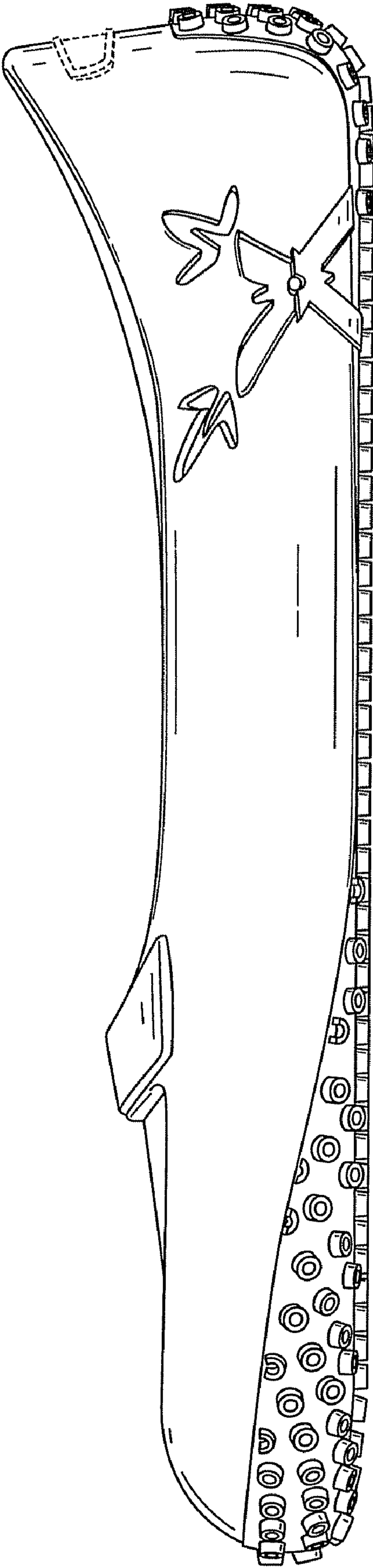

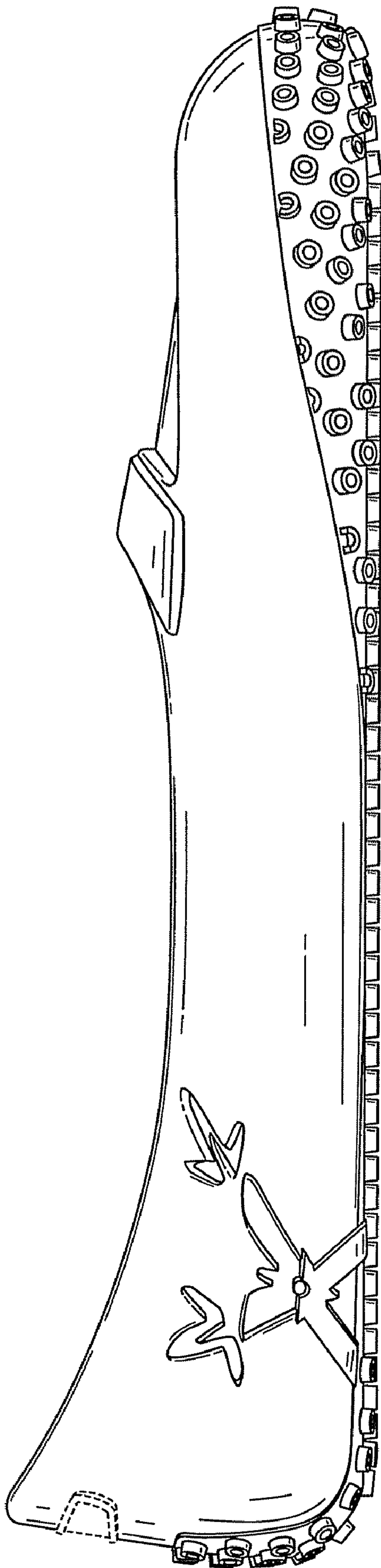
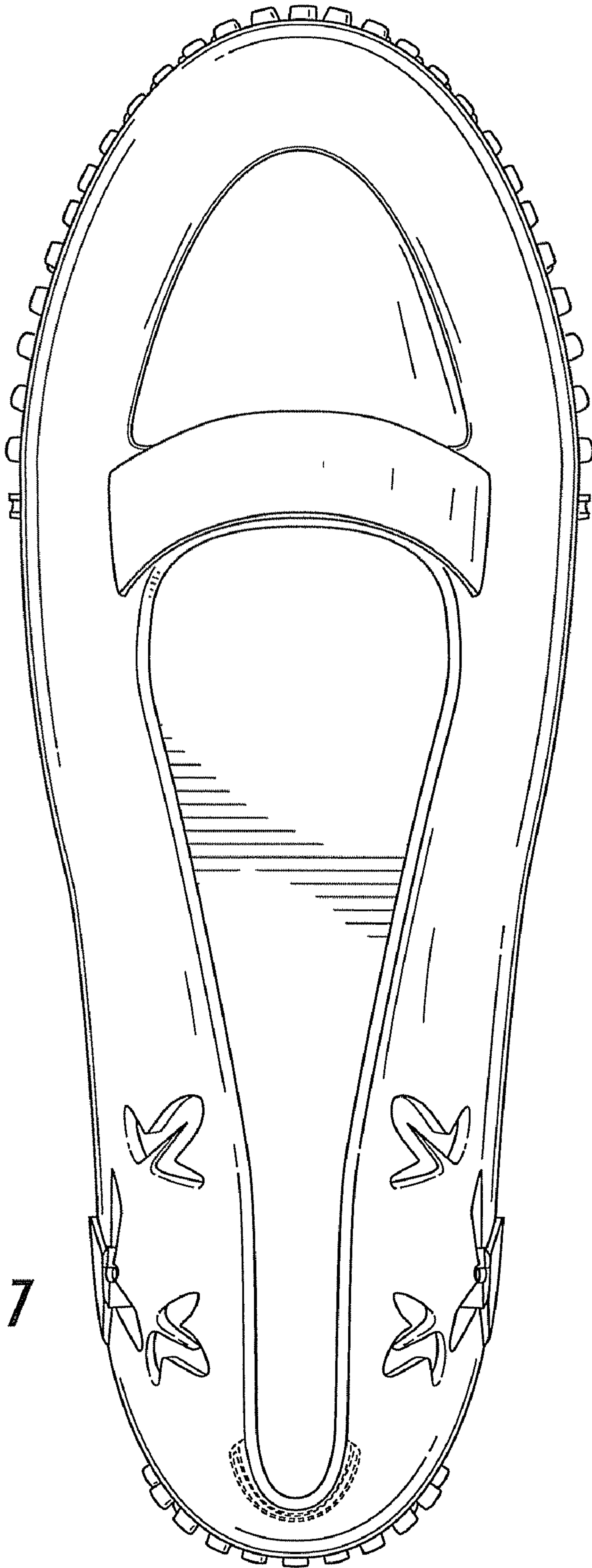
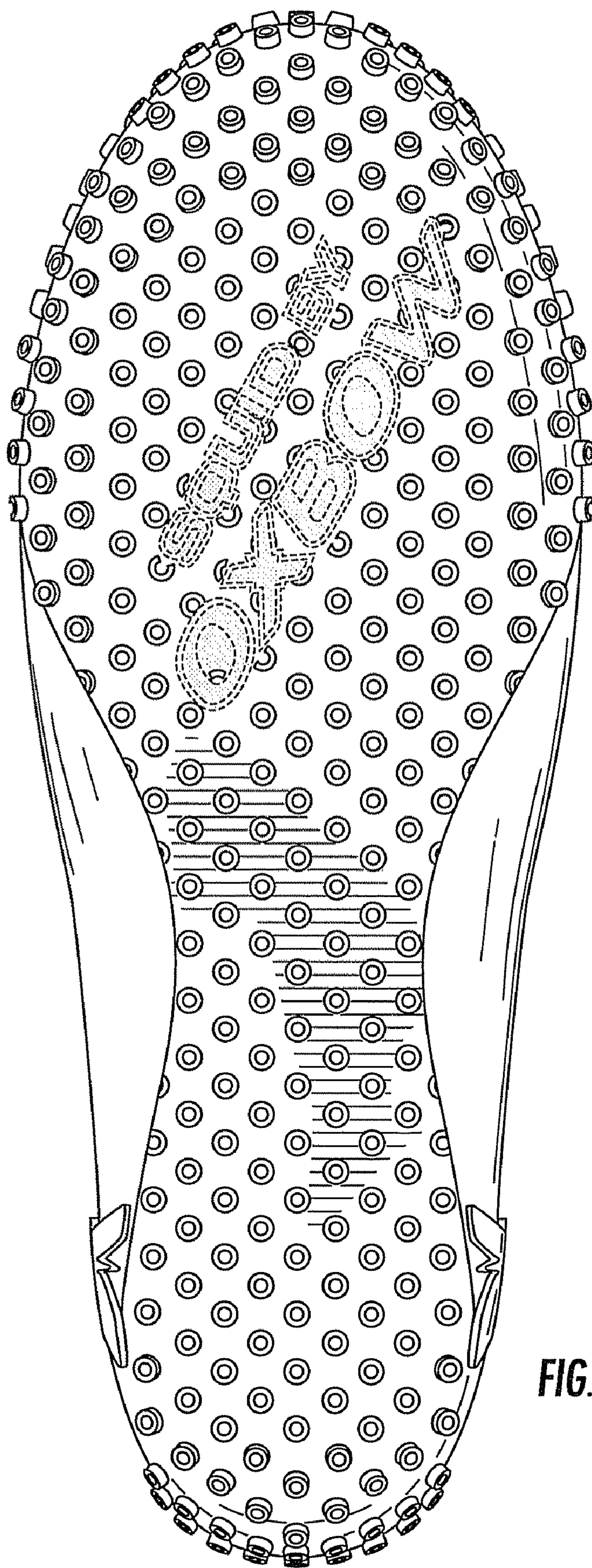
