DESCRIPTION

FIG. 1 is a front perspective view of a central hub for an optical disc box showing my new design;

FIG. 2 is a front view thereof;

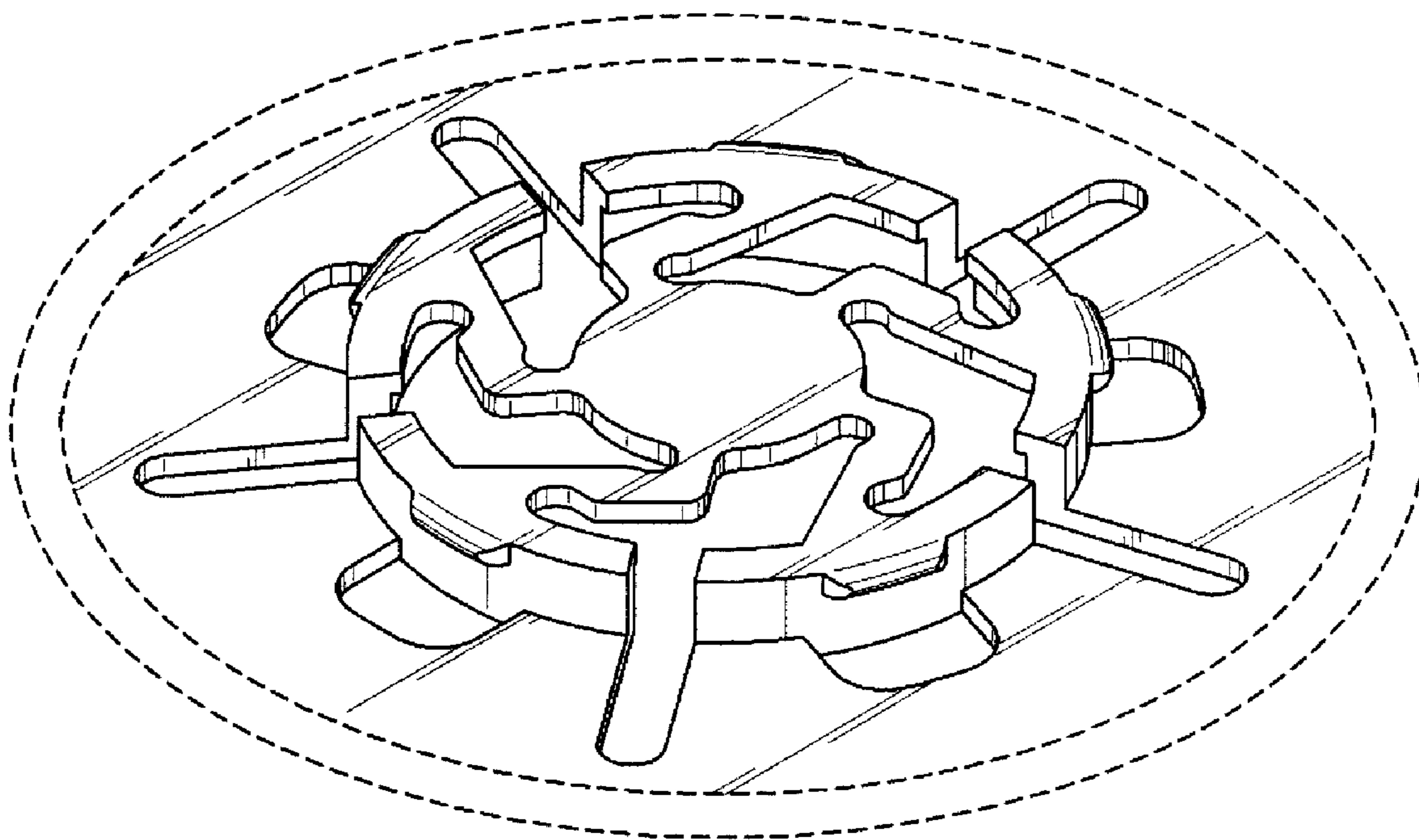
FIG. 3 is a rear view thereof;

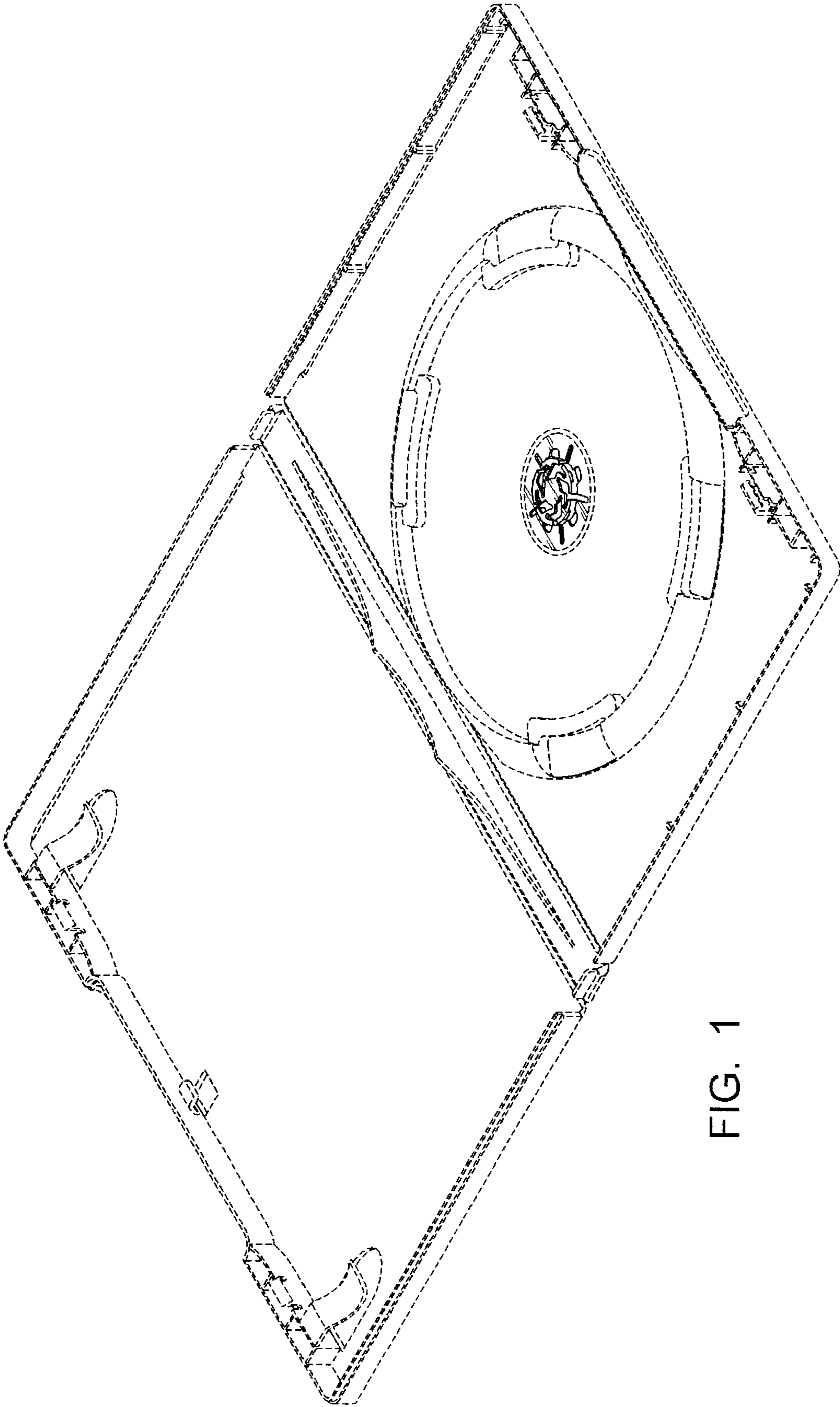

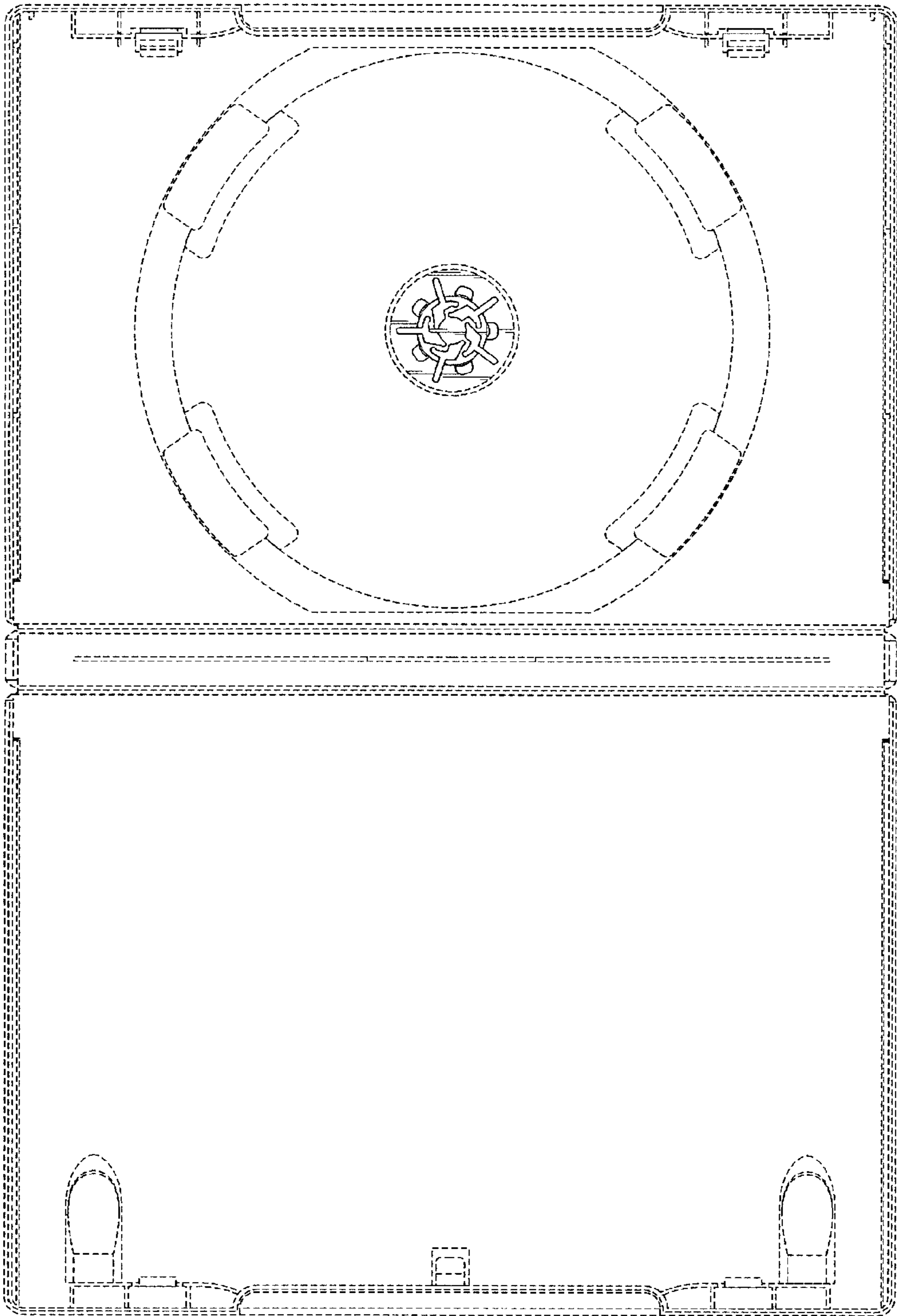

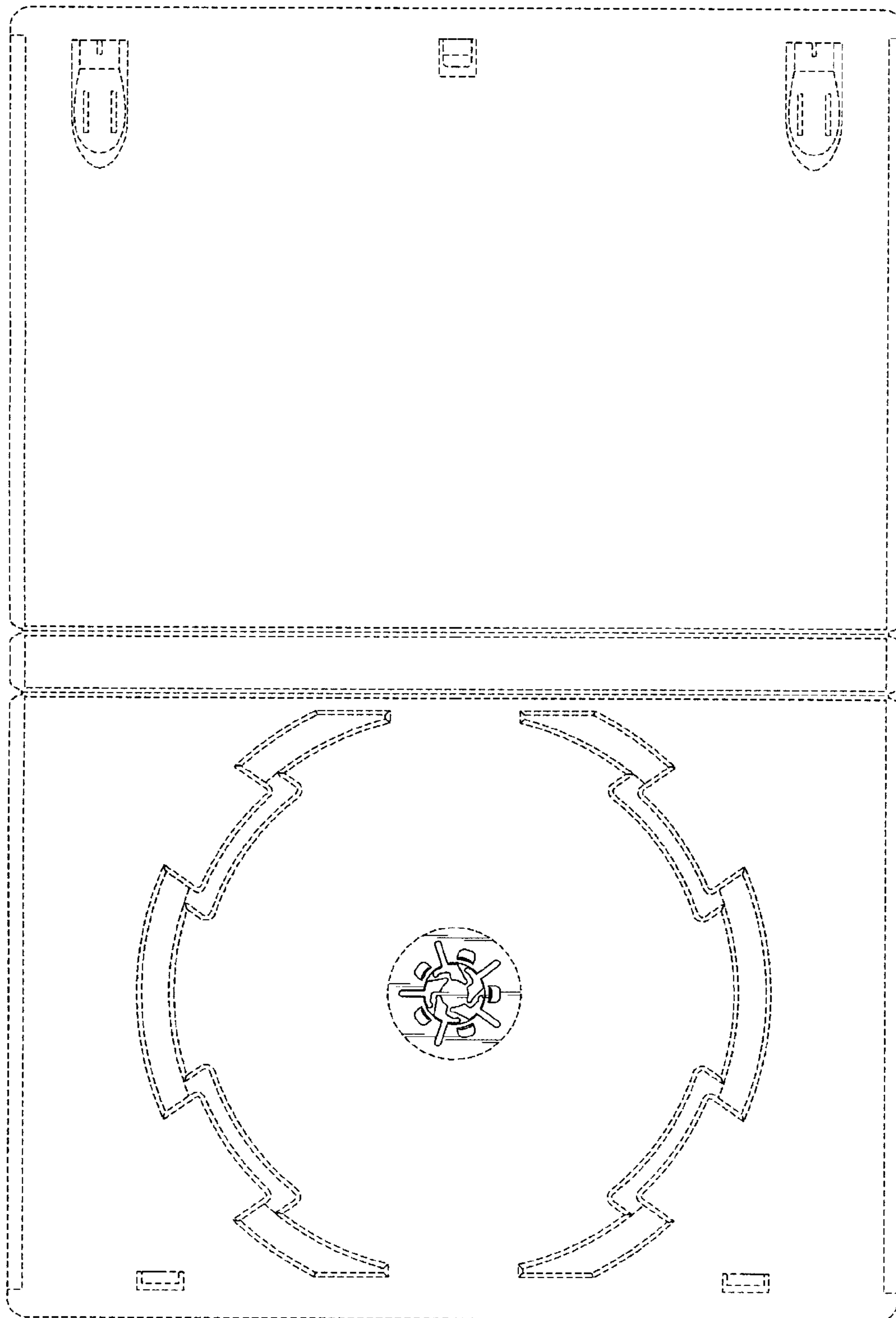

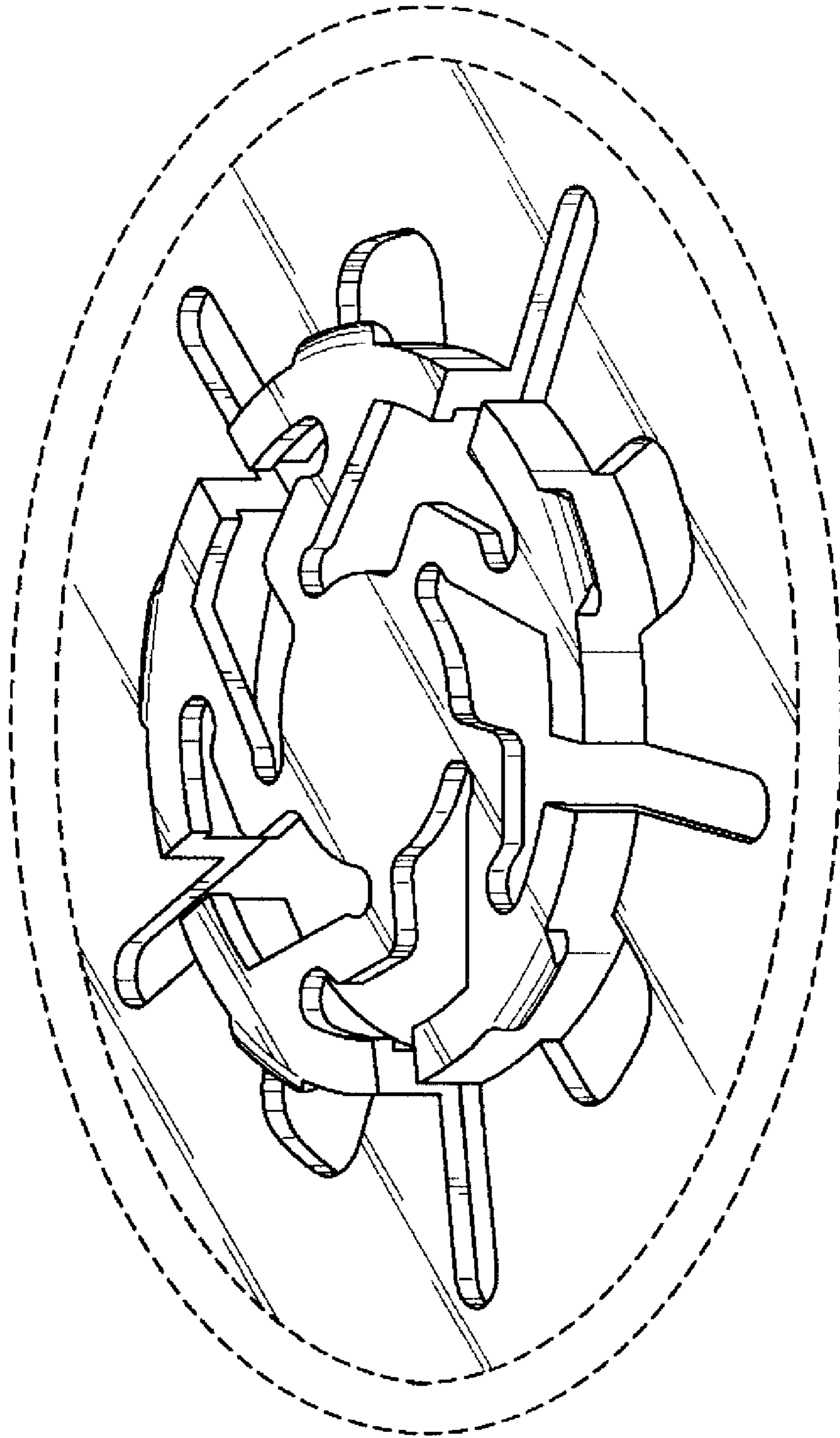

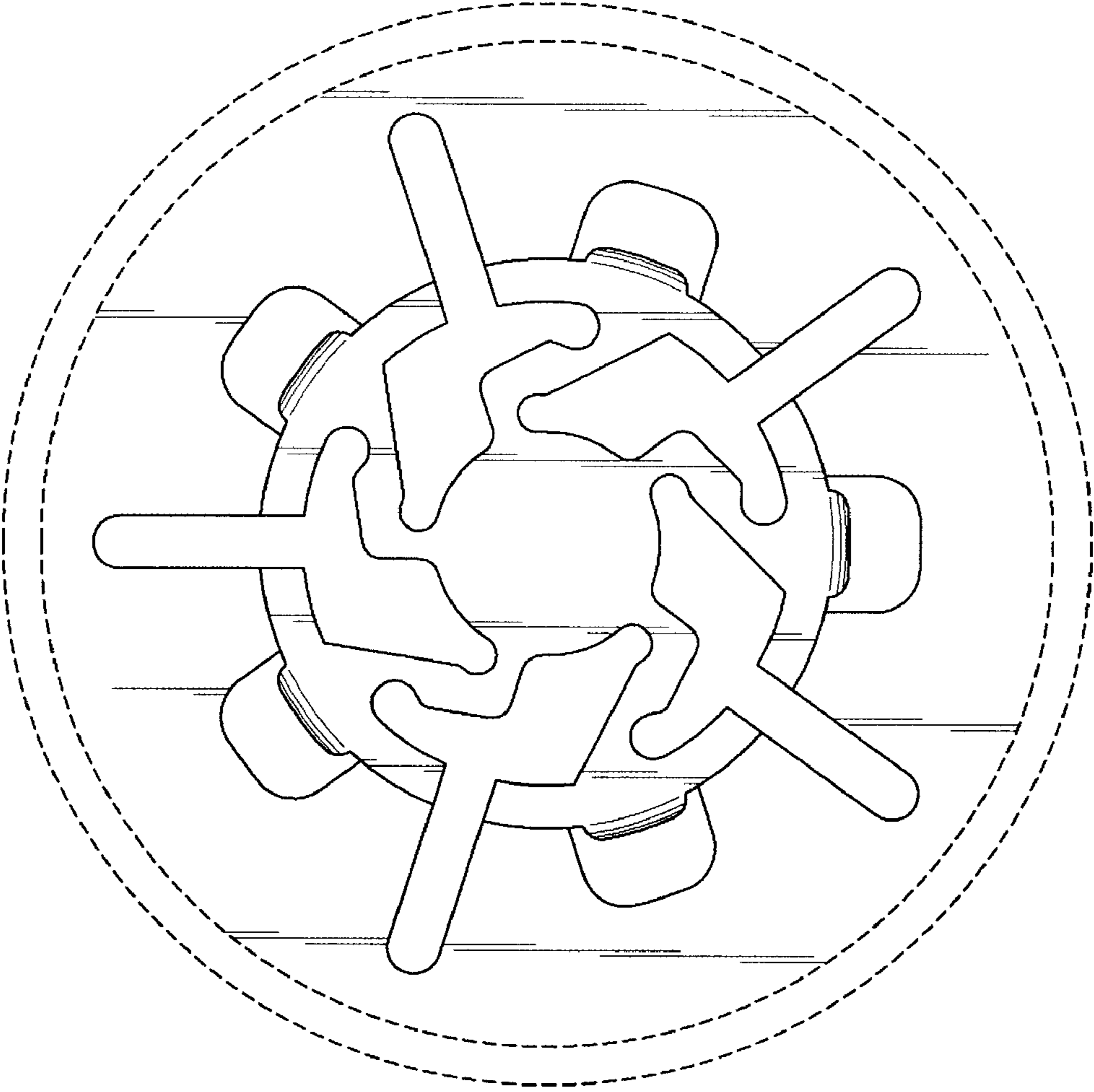
