(57) **CLAIM**

The ornamental design for a computer cabinet, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view showing the top, front and left side of my new design for a computer cabinet with the access panels in the closed position;

FIG. 2 is a front elevation of the computer cabinet of FIG. 1;

FIG. 3 is a top plan view of the computer cabinet of FIG. 1;

FIG. 4 is a left side elevation of the computer cabinet of FIG. 1;

FIG. 5 is a right side elevation of the computer cabinet of FIG. 1;

FIG. 6 is a perspective view showing the top, front, and left side of the computer cabinet of FIG. 1 with the access panels in the open position;

FIG. 7 is a front elevation of the computer cabinet of FIG. 6;

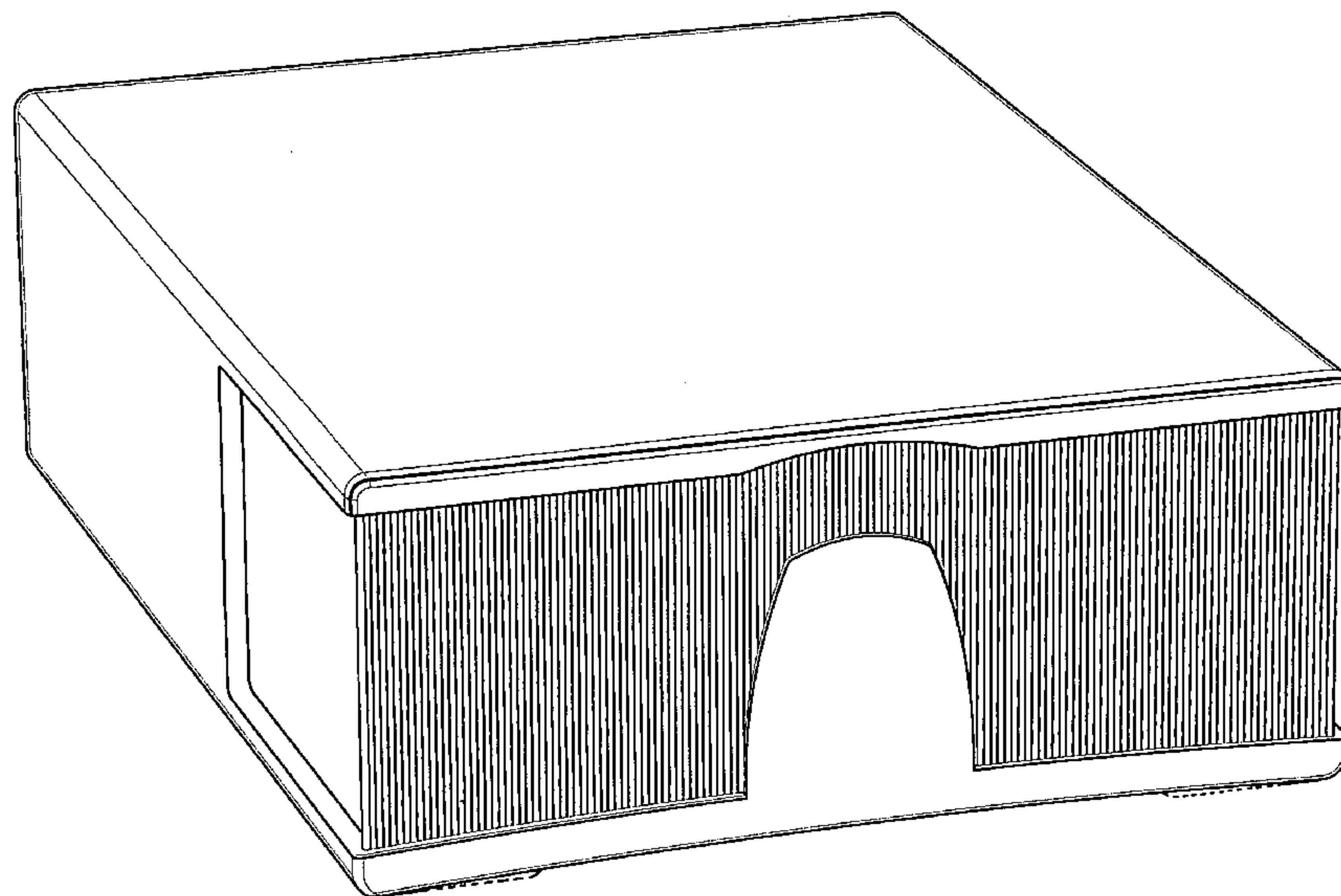
FIG. 8 is a top plan view of the computer cabinet of FIG. 6;

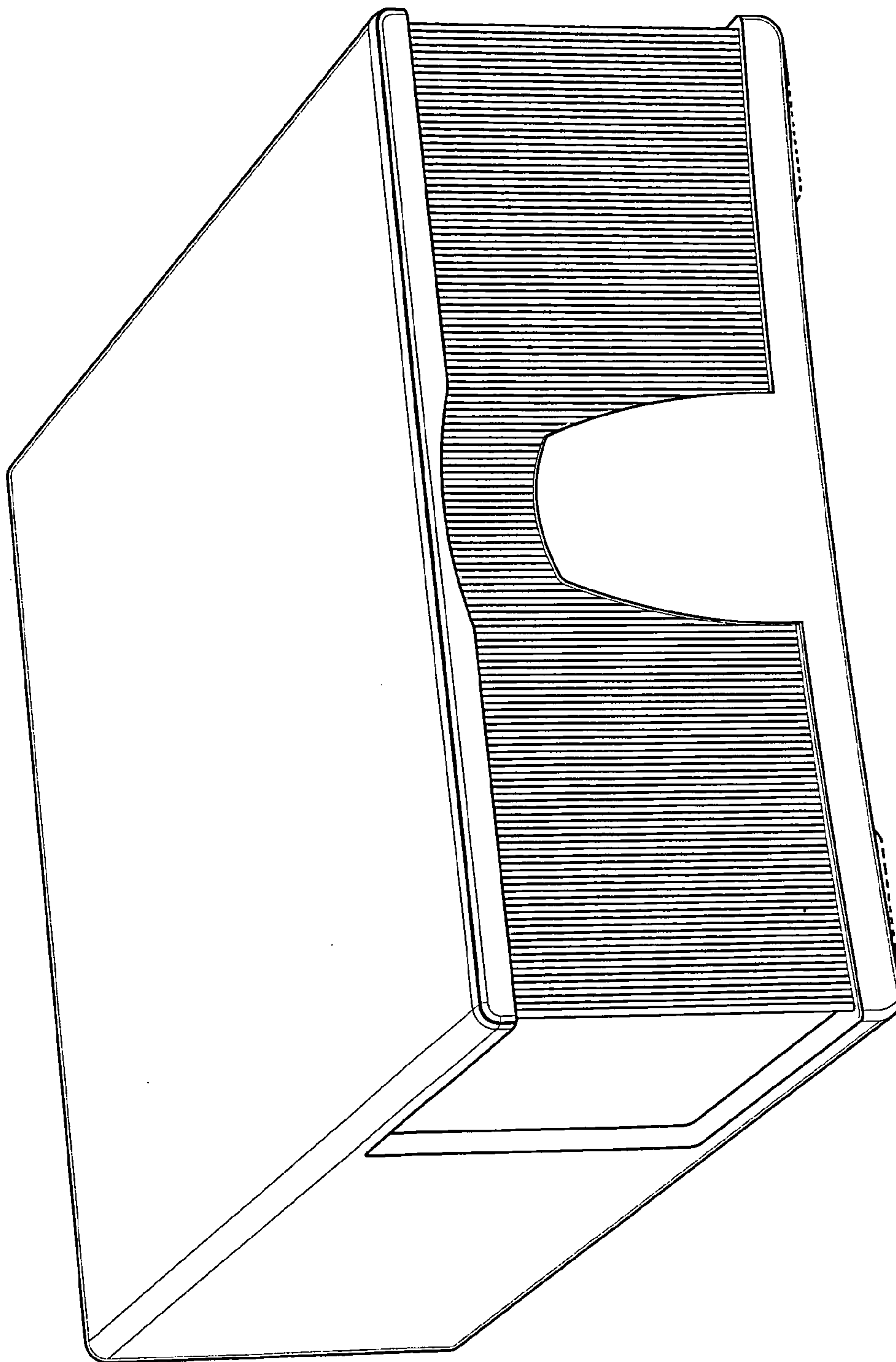

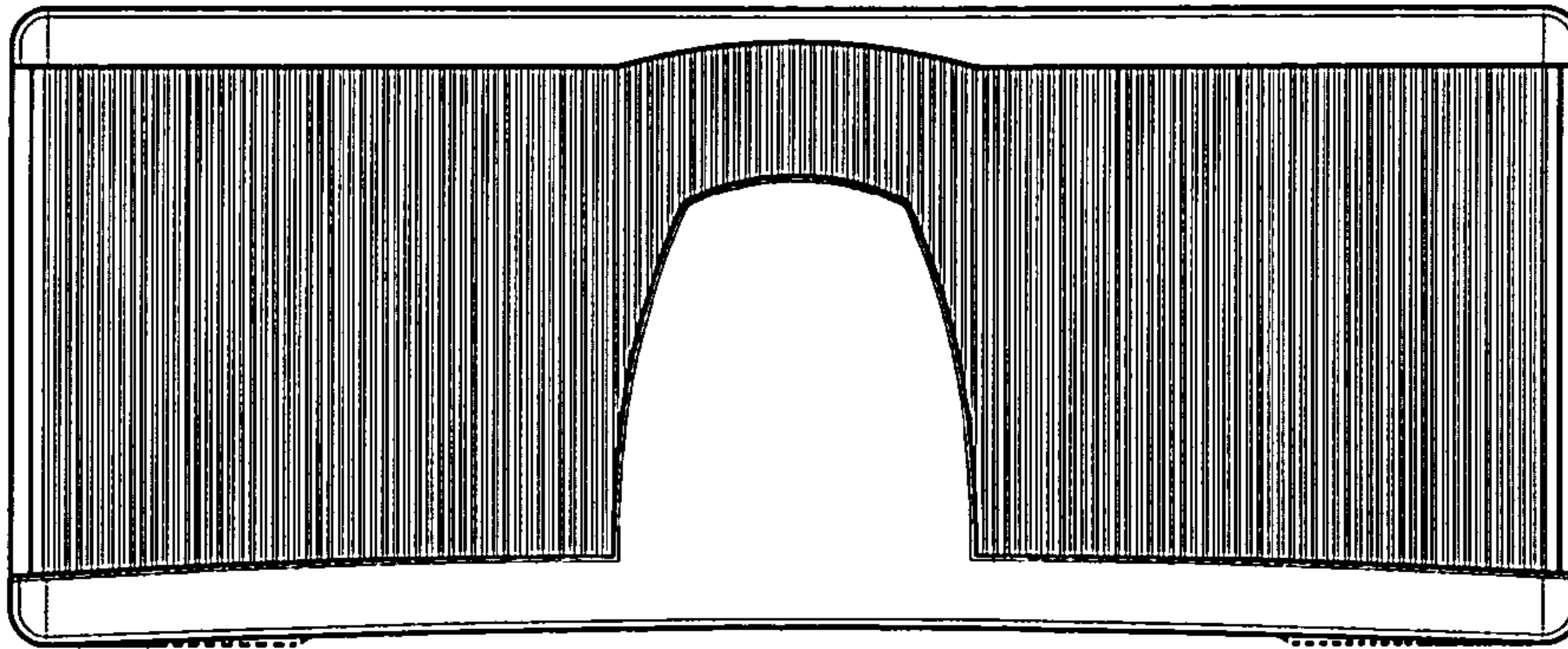

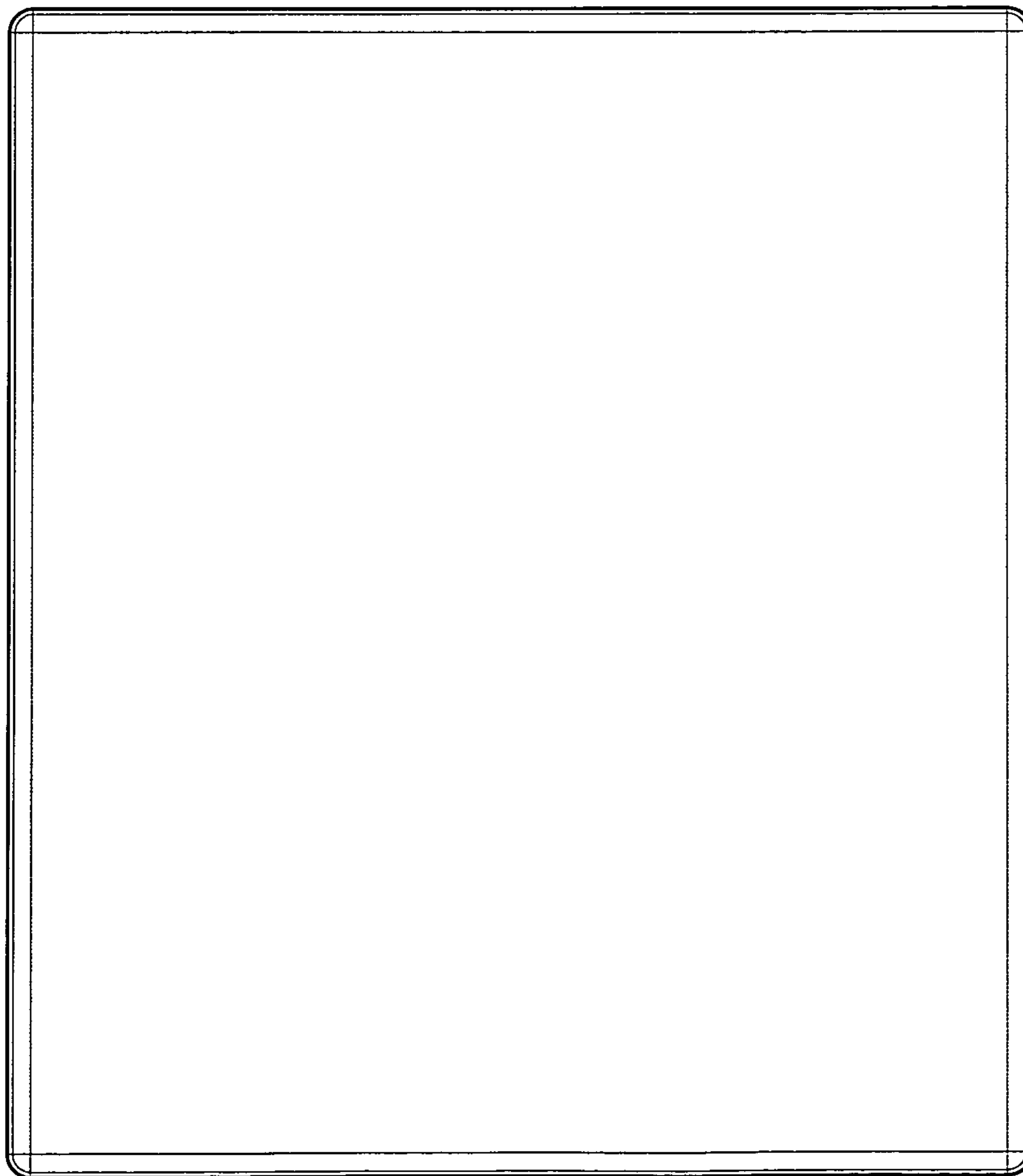

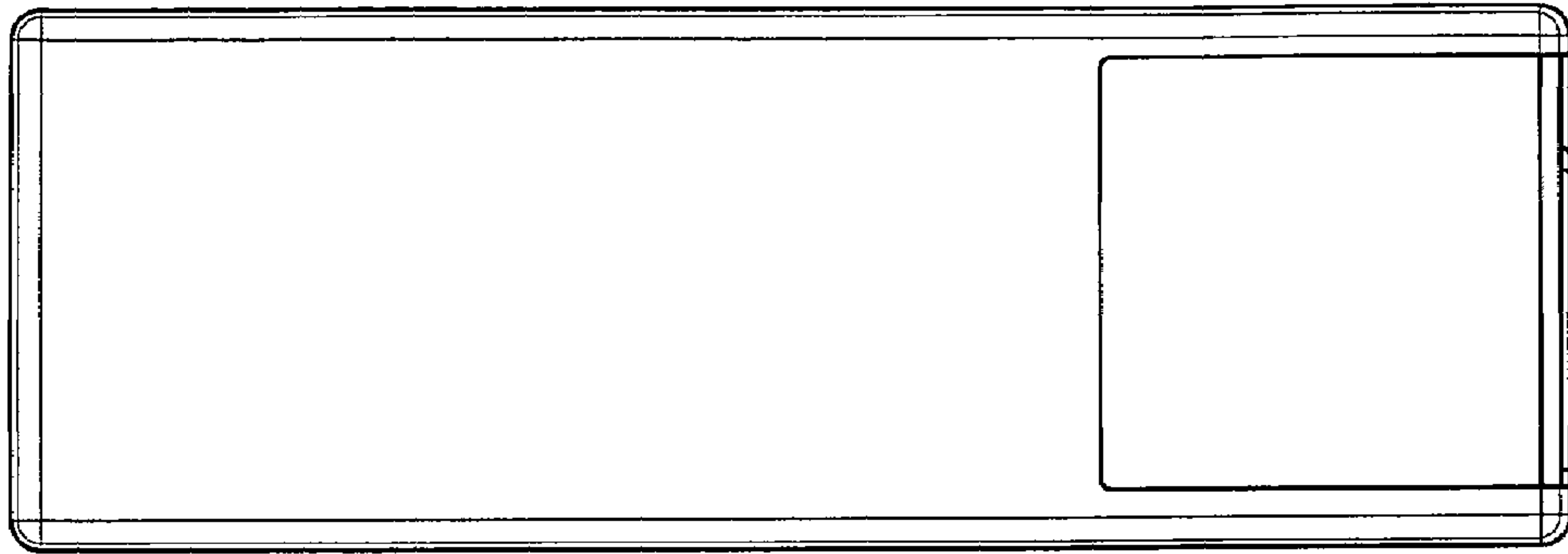

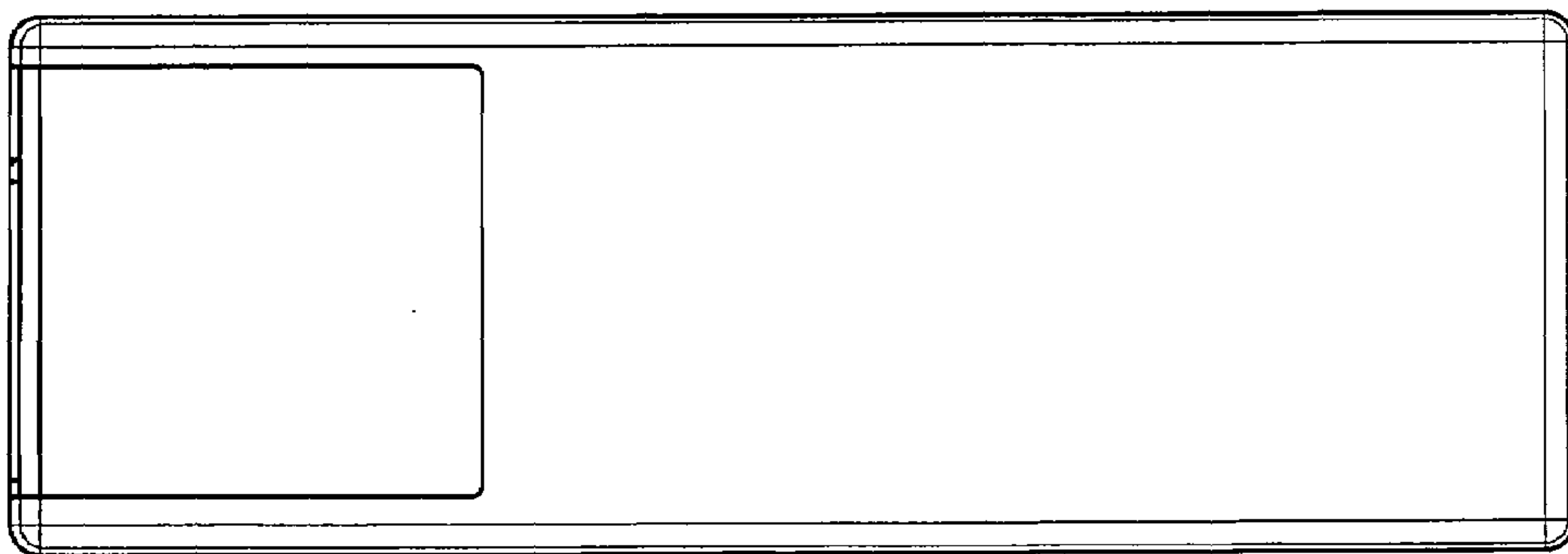

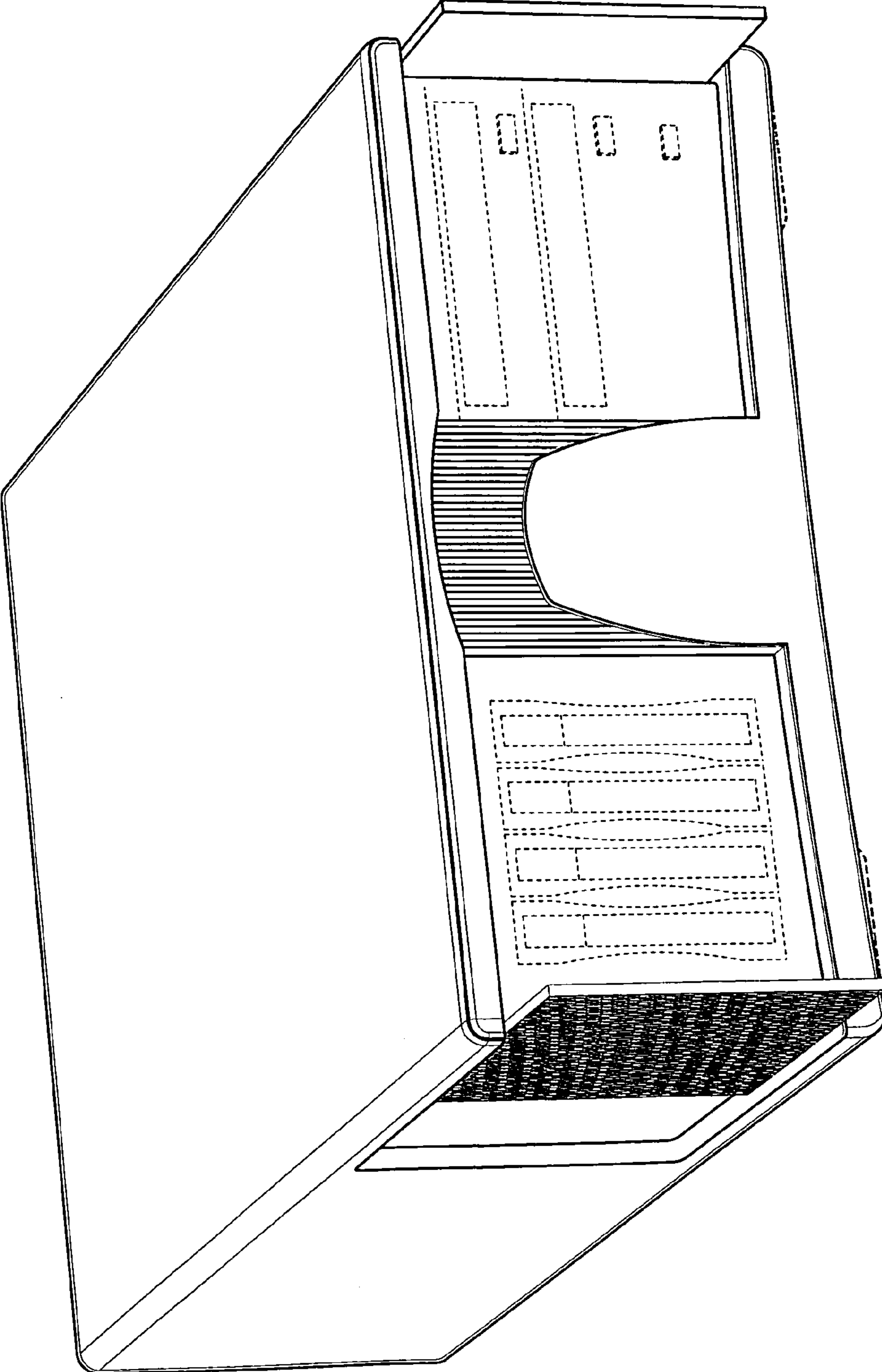

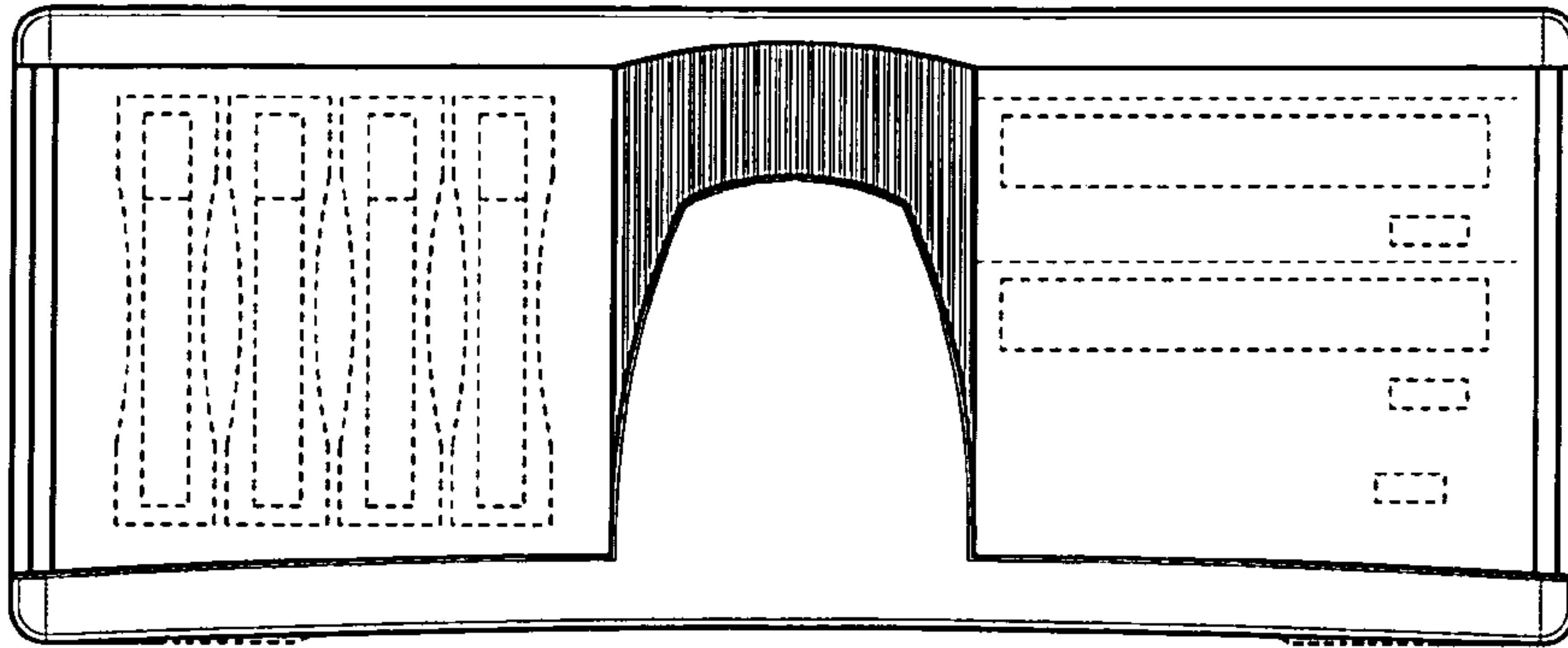

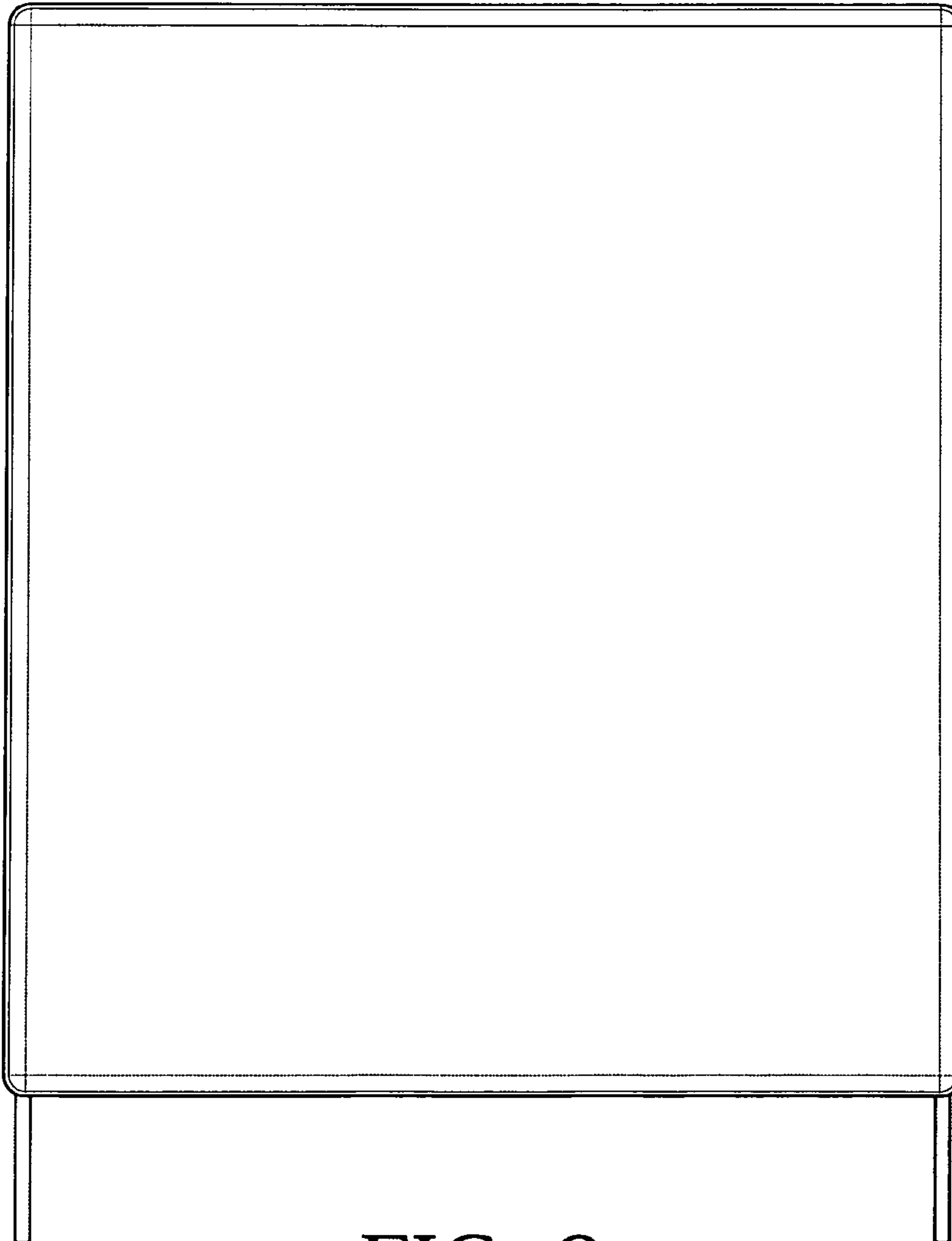

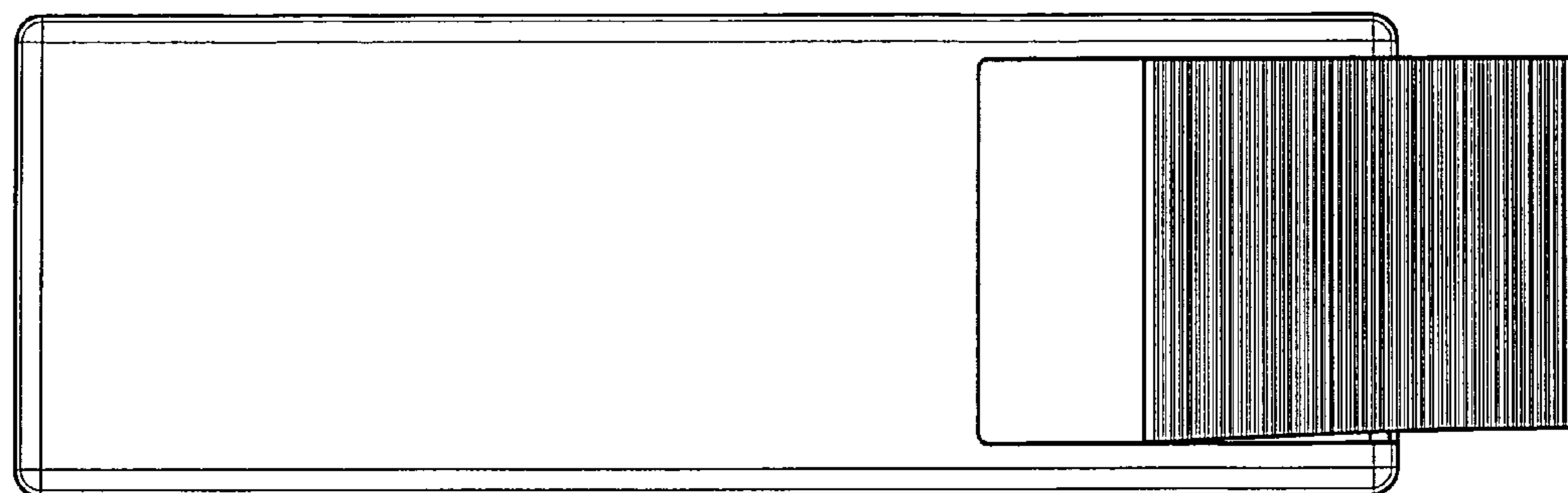

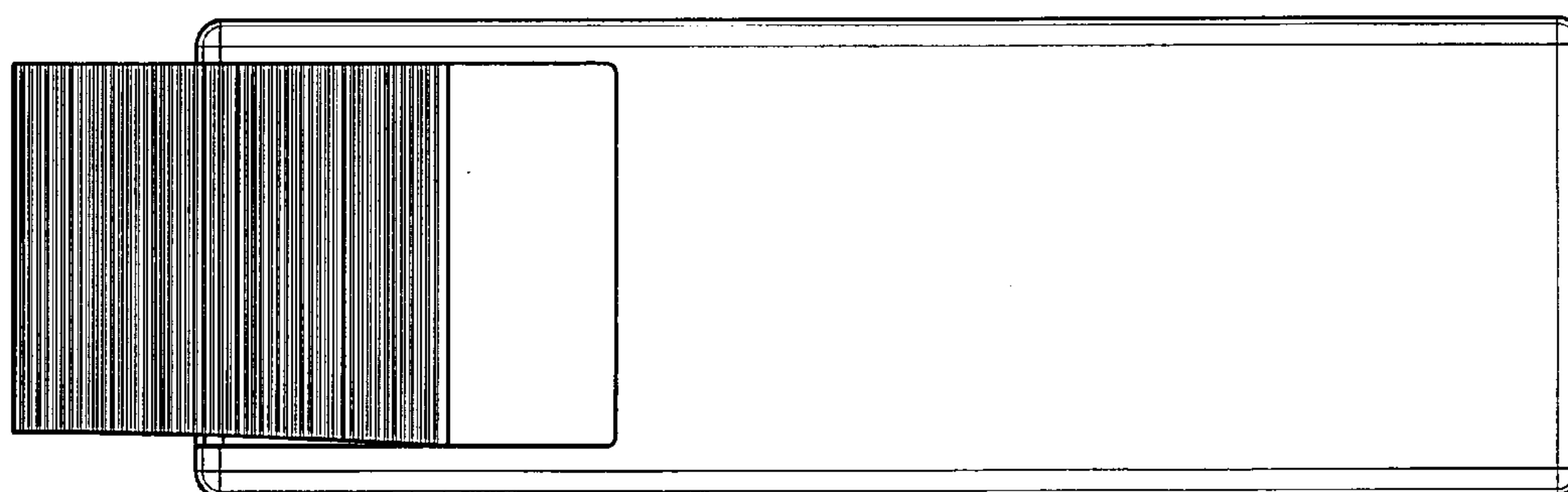
