The ornamental design for a control region for an appliance, as shown and described.

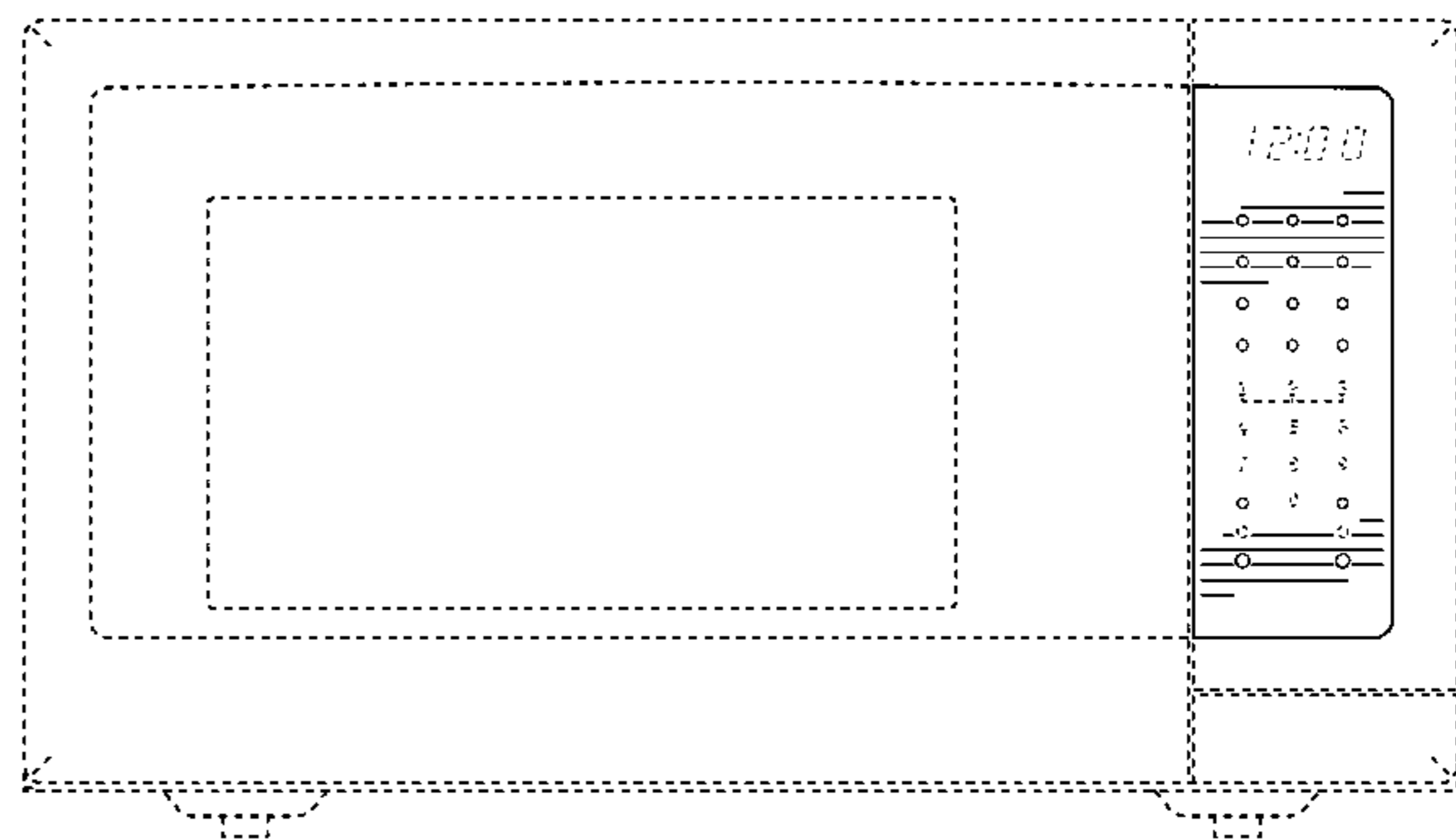
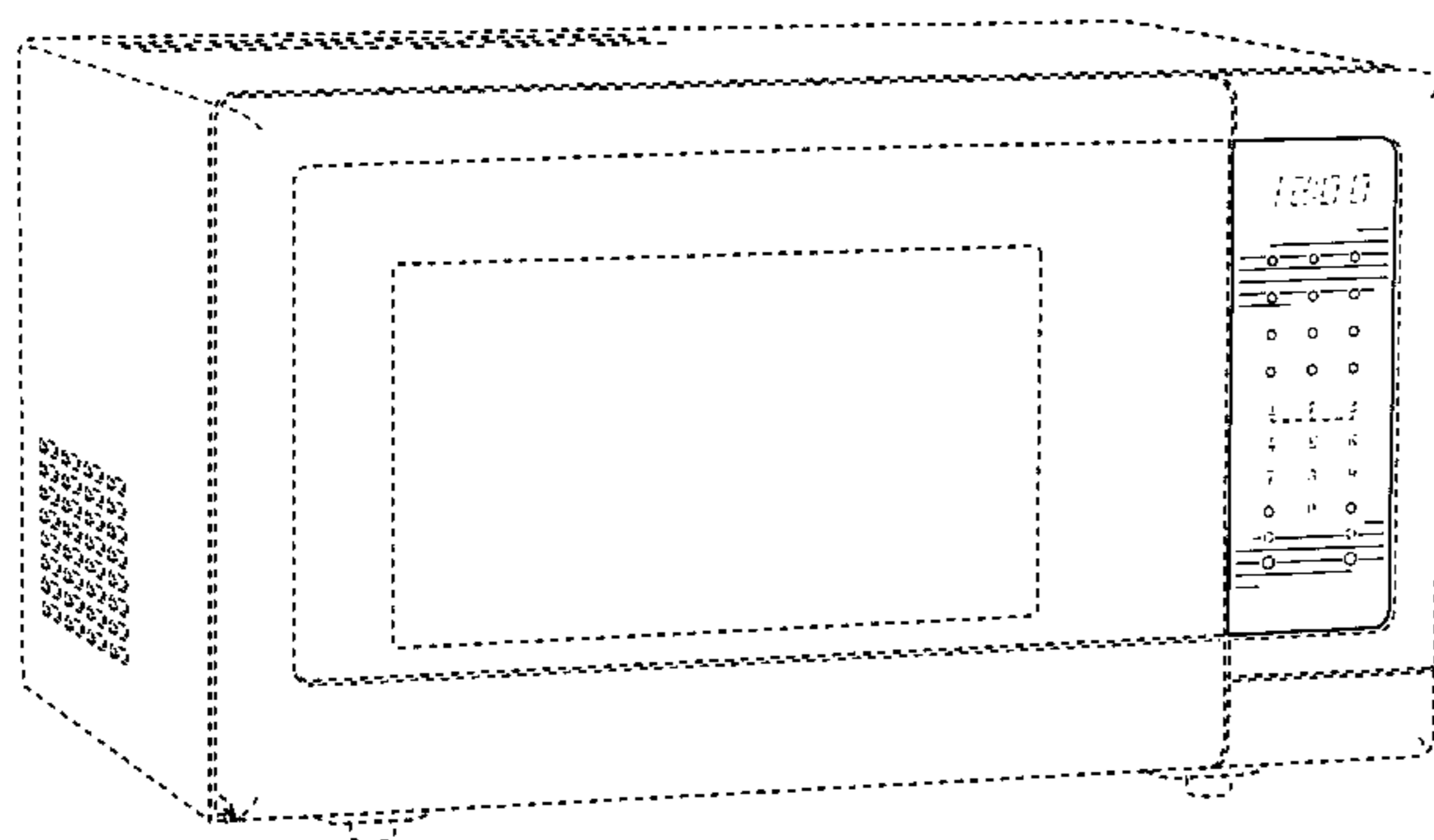
DESCRIPTION

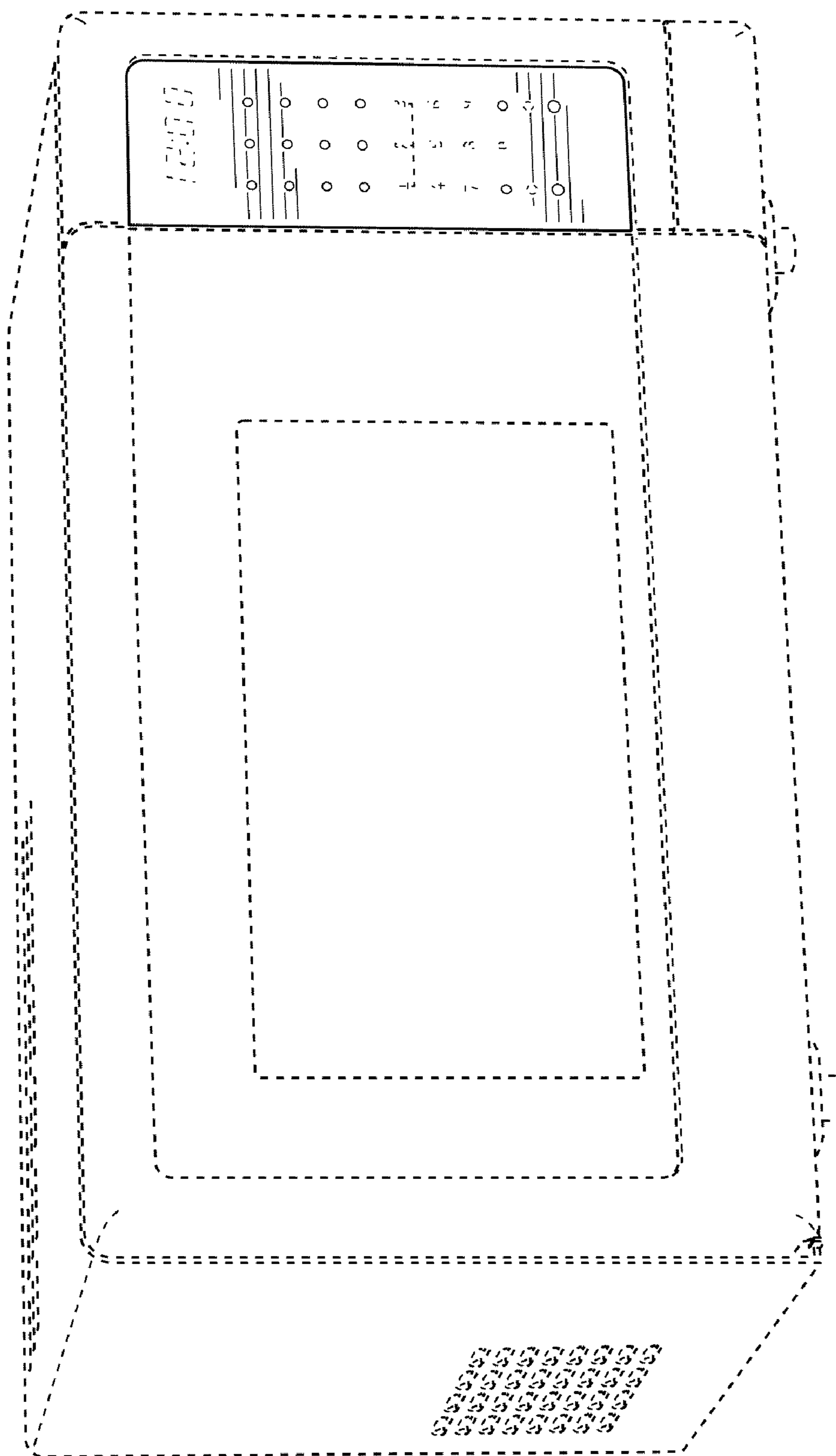

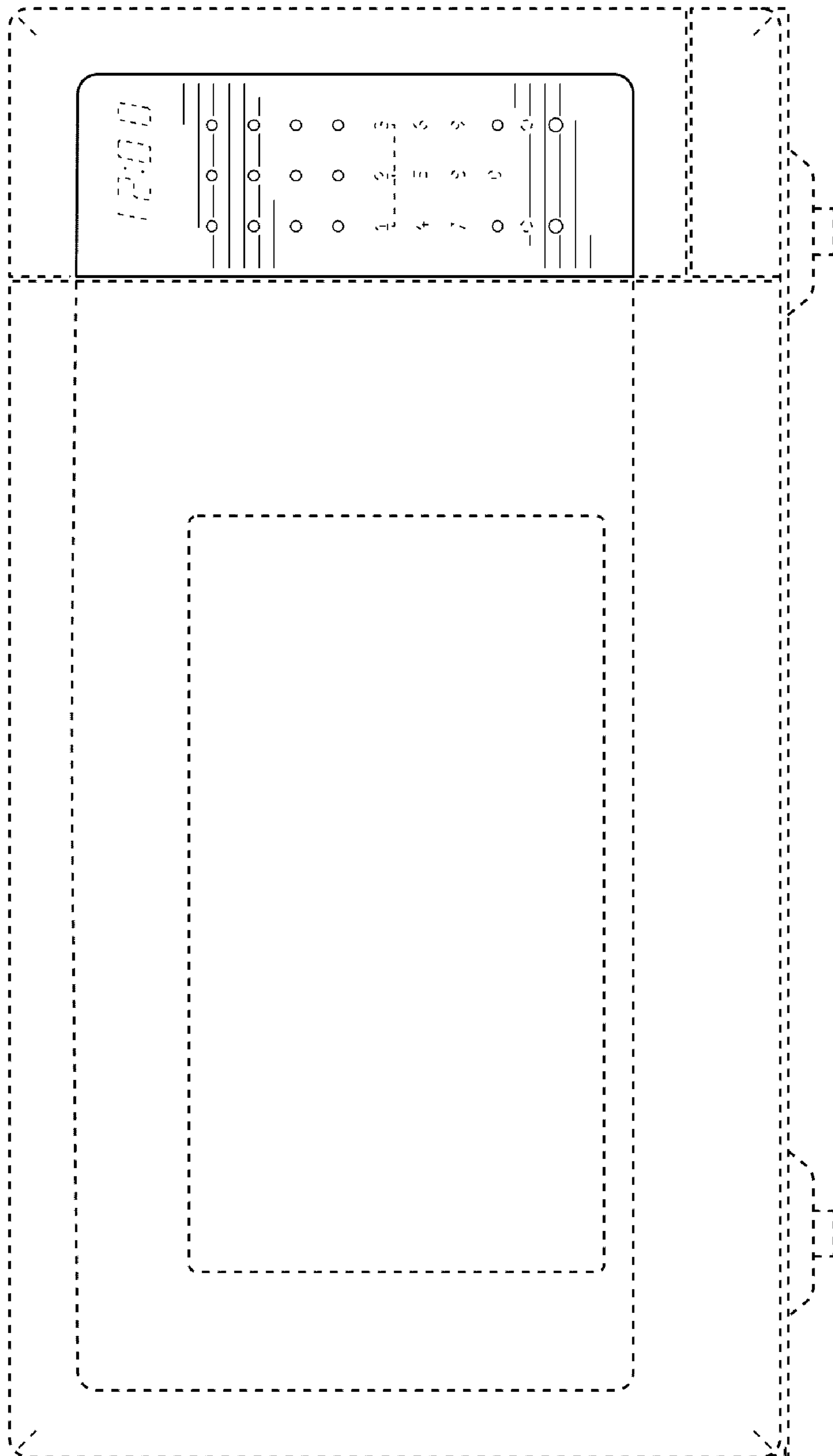
