The ornamental design for a cord lock, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a cord lock showing my new design;

FIG. 2 is a left side elevational view thereof;

FIG. 3 is a front elevational view, the opposite side being a mirror image thereof;

FIG. 4 is a right side elevational view thereof;

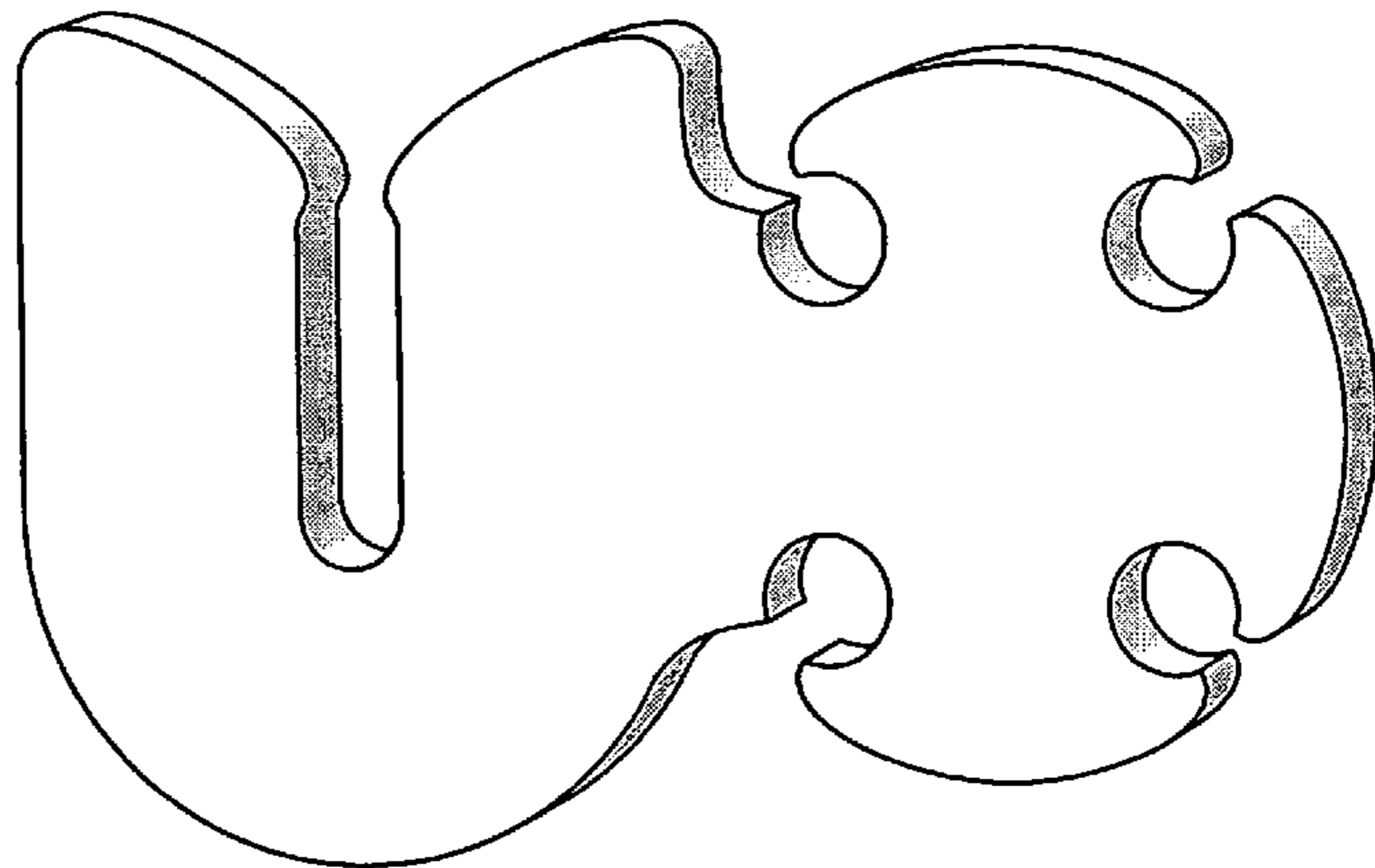
FIG. 5 is a bottom plan view thereof;

FIG. 6 is an environmental, perspective view thereof; and,

FIG. 7 is an environmental, top plan view thereof.

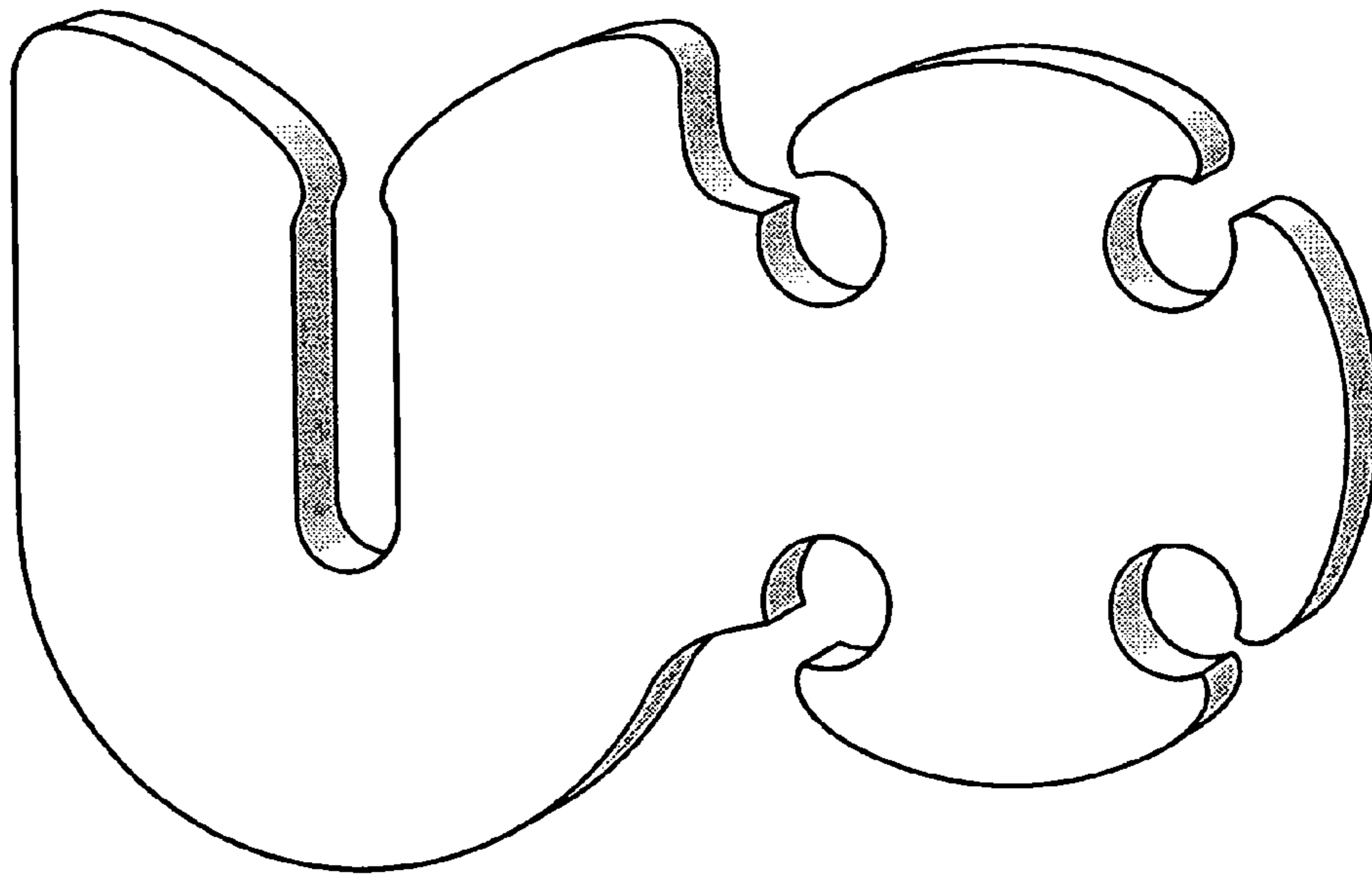

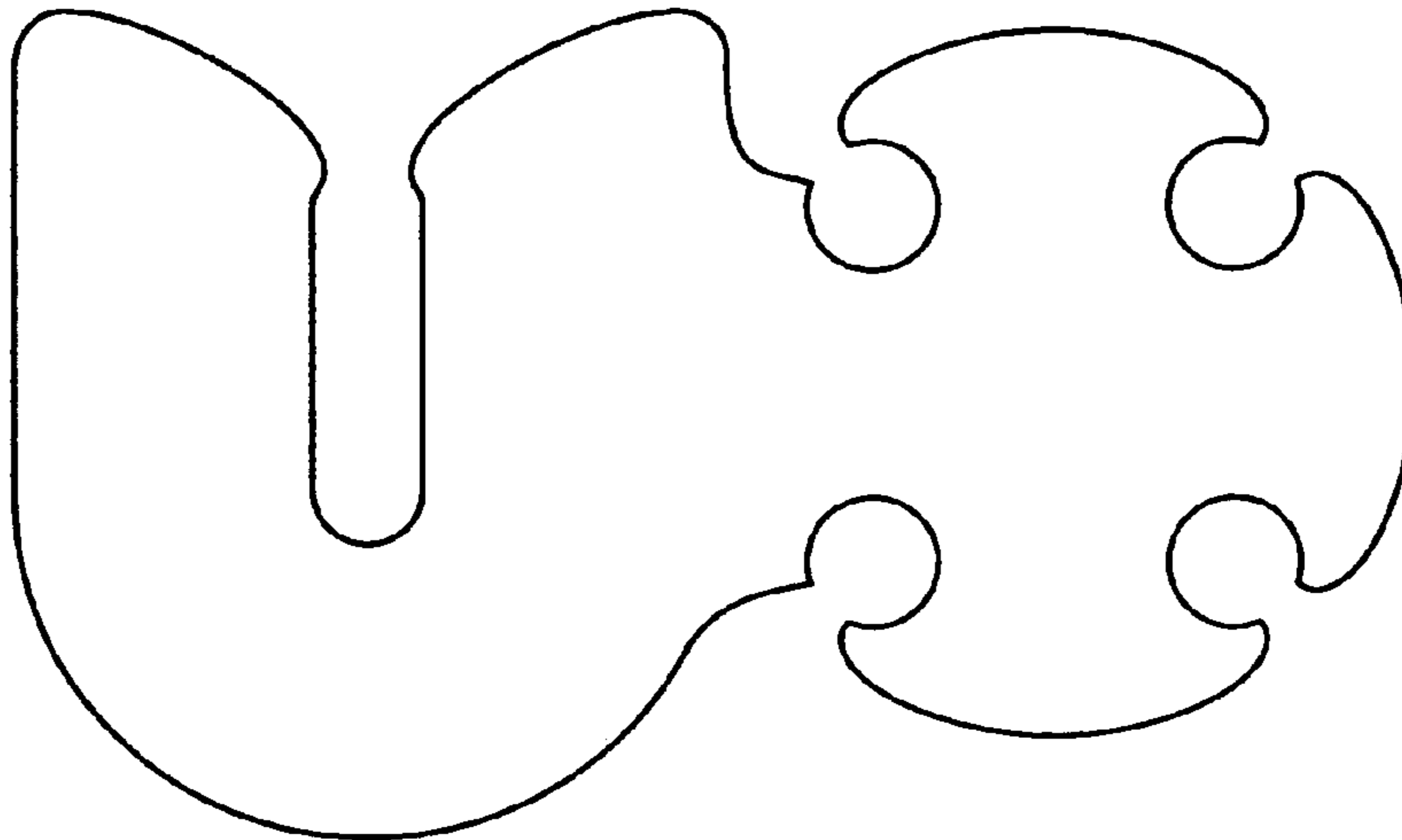

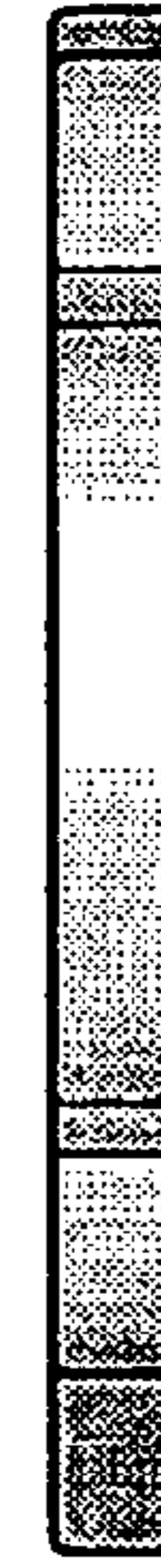

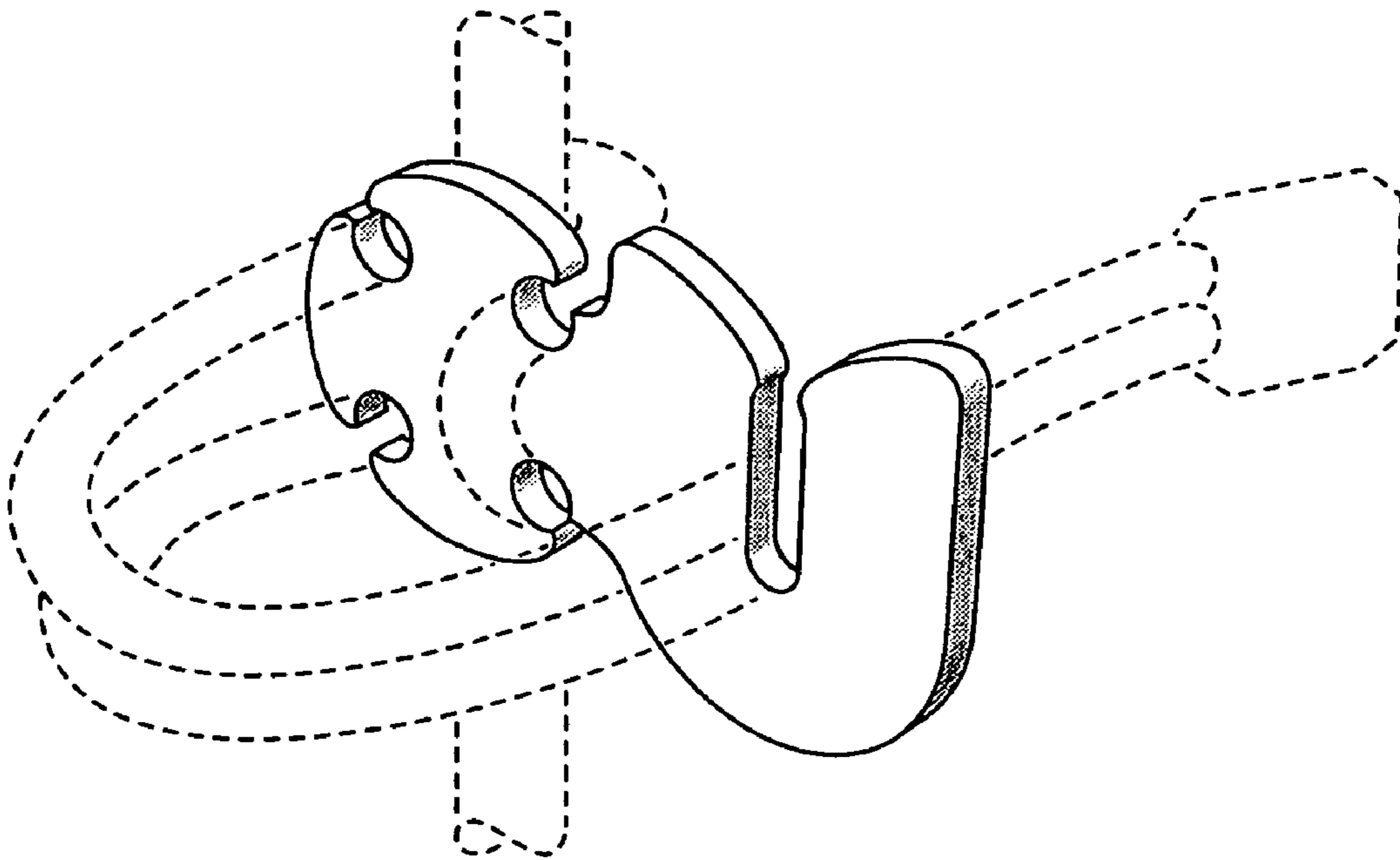
