(57) **CLAIM**

The ornamental design for a wristwatch case, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation of a wristwatch case showing my new design;

FIG. 2 is a rear elevation thereof;

FIG. 3 is a front elevation thereof showing a partially rotated watch case portion;

FIG. 4 is a front view thereof showing a fully rotated watch case portion;

FIG. 5 is a right side perspective view of FIG. 1;

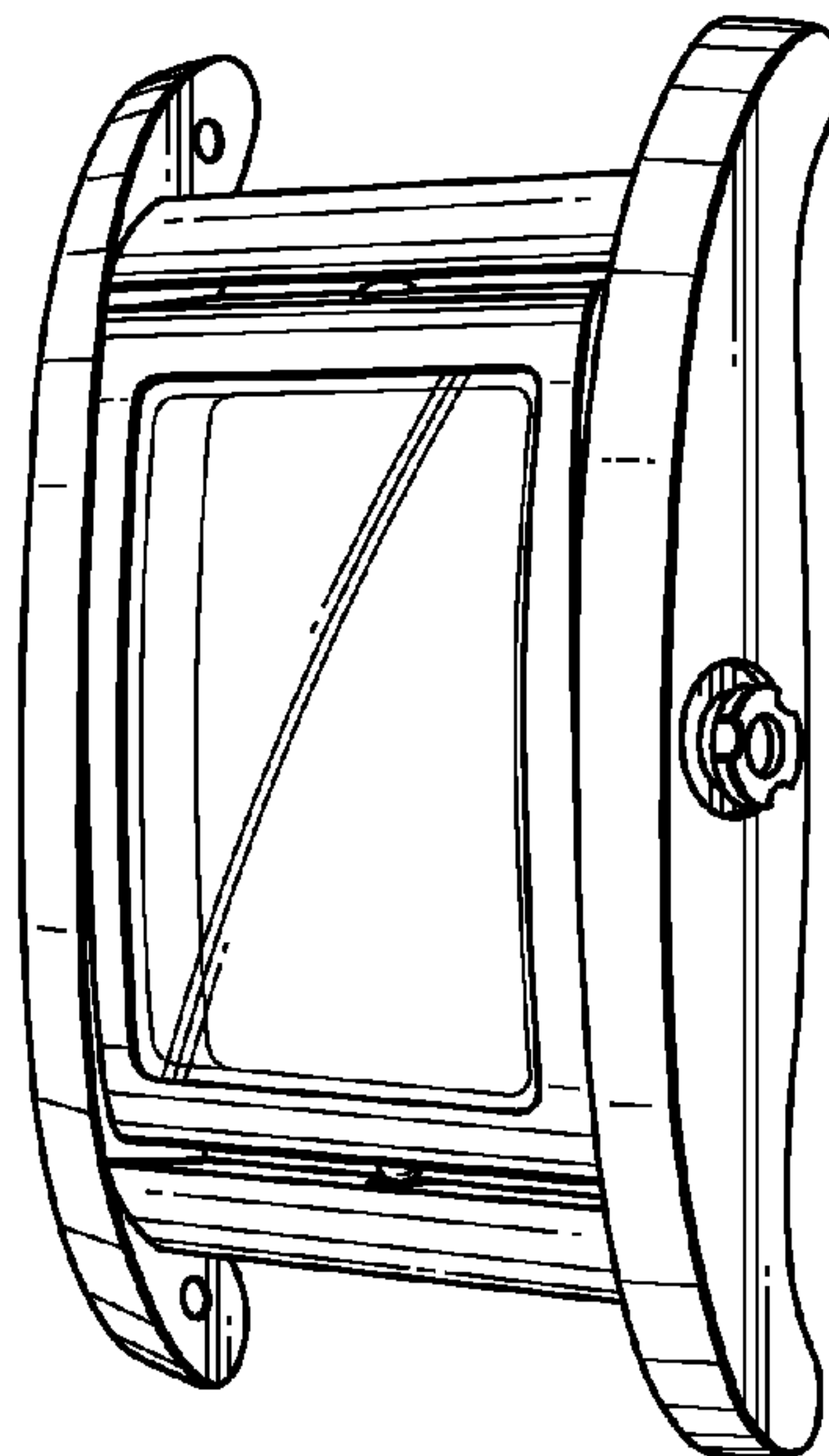
FIG. 6 is a right side view thereof;

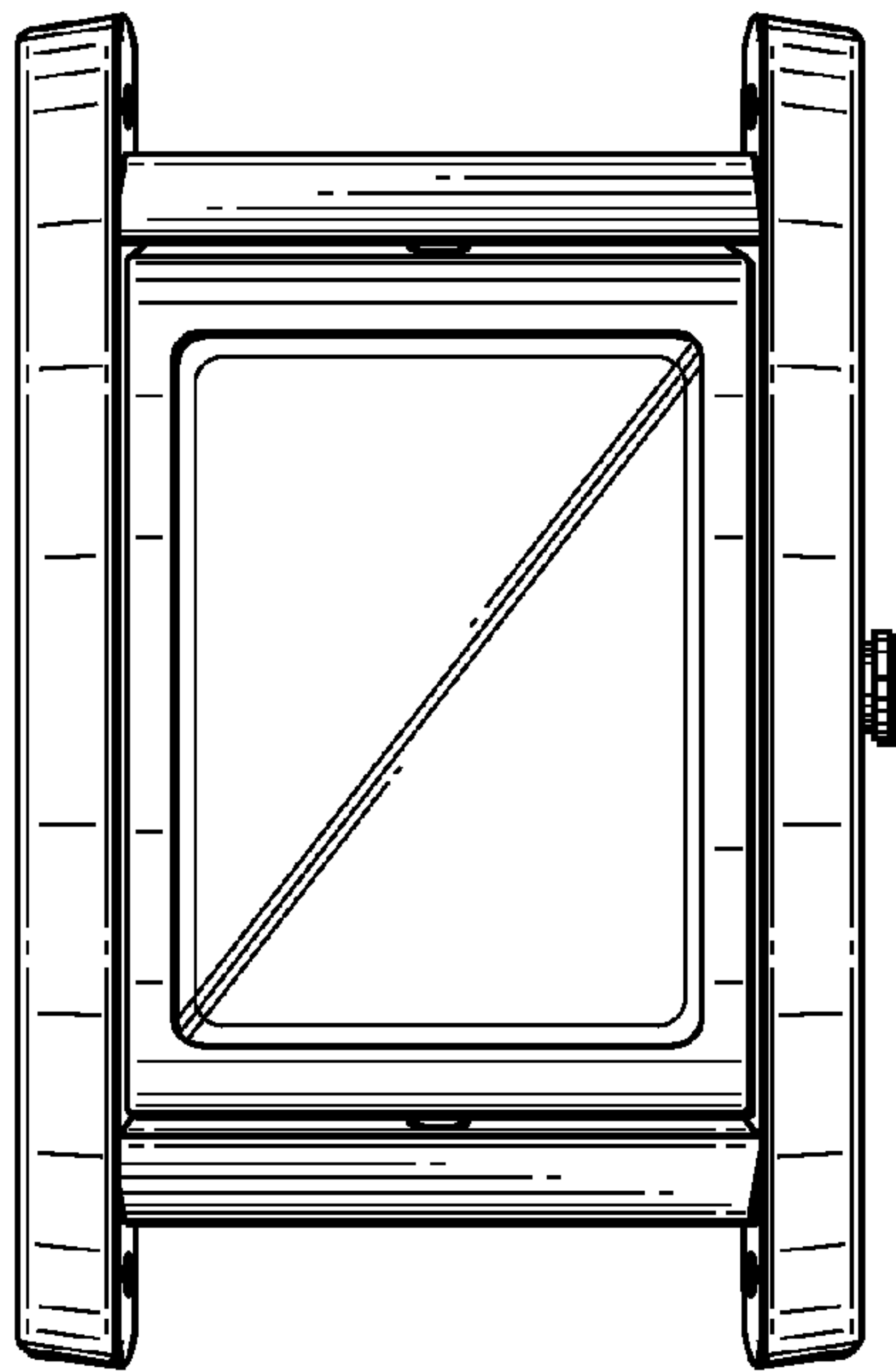

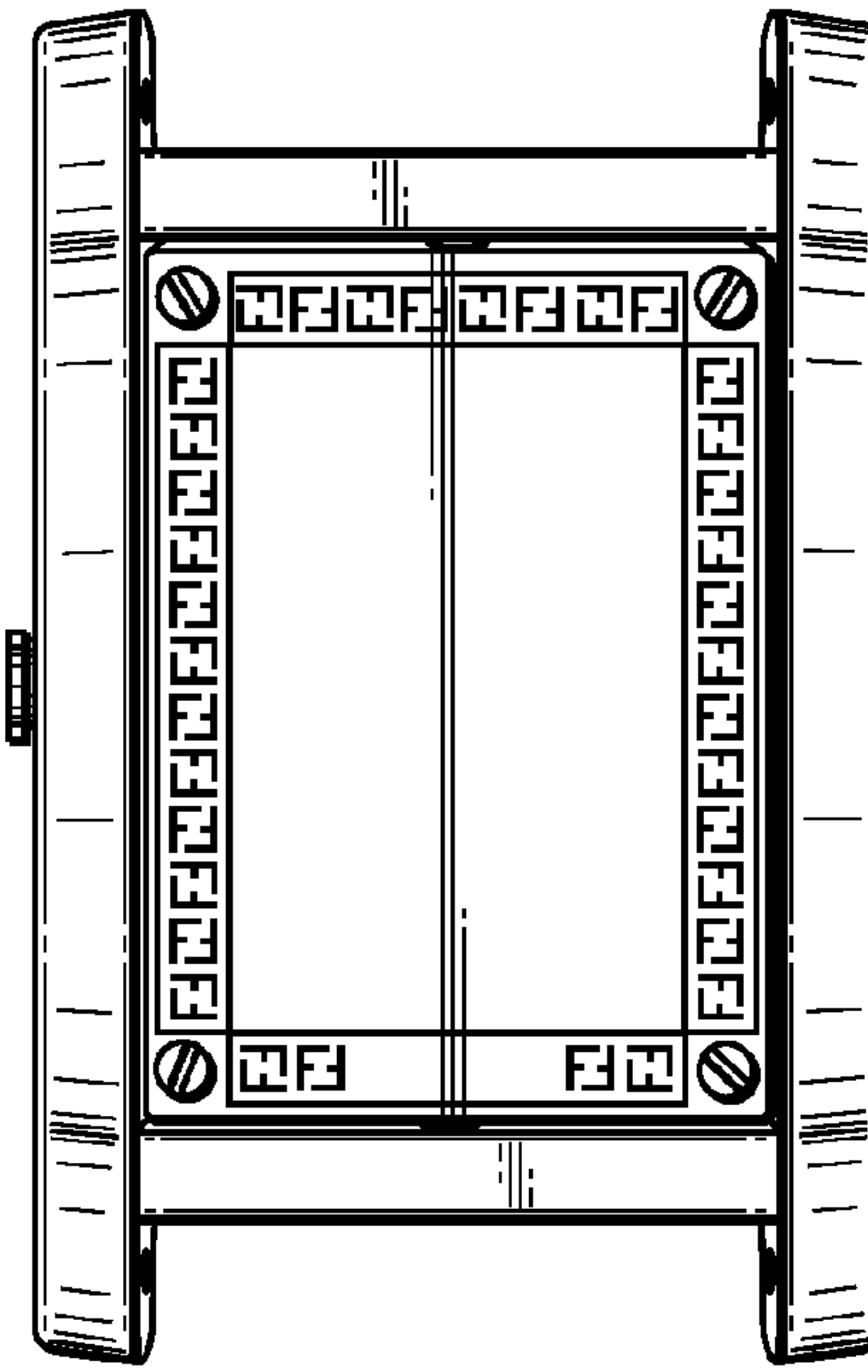

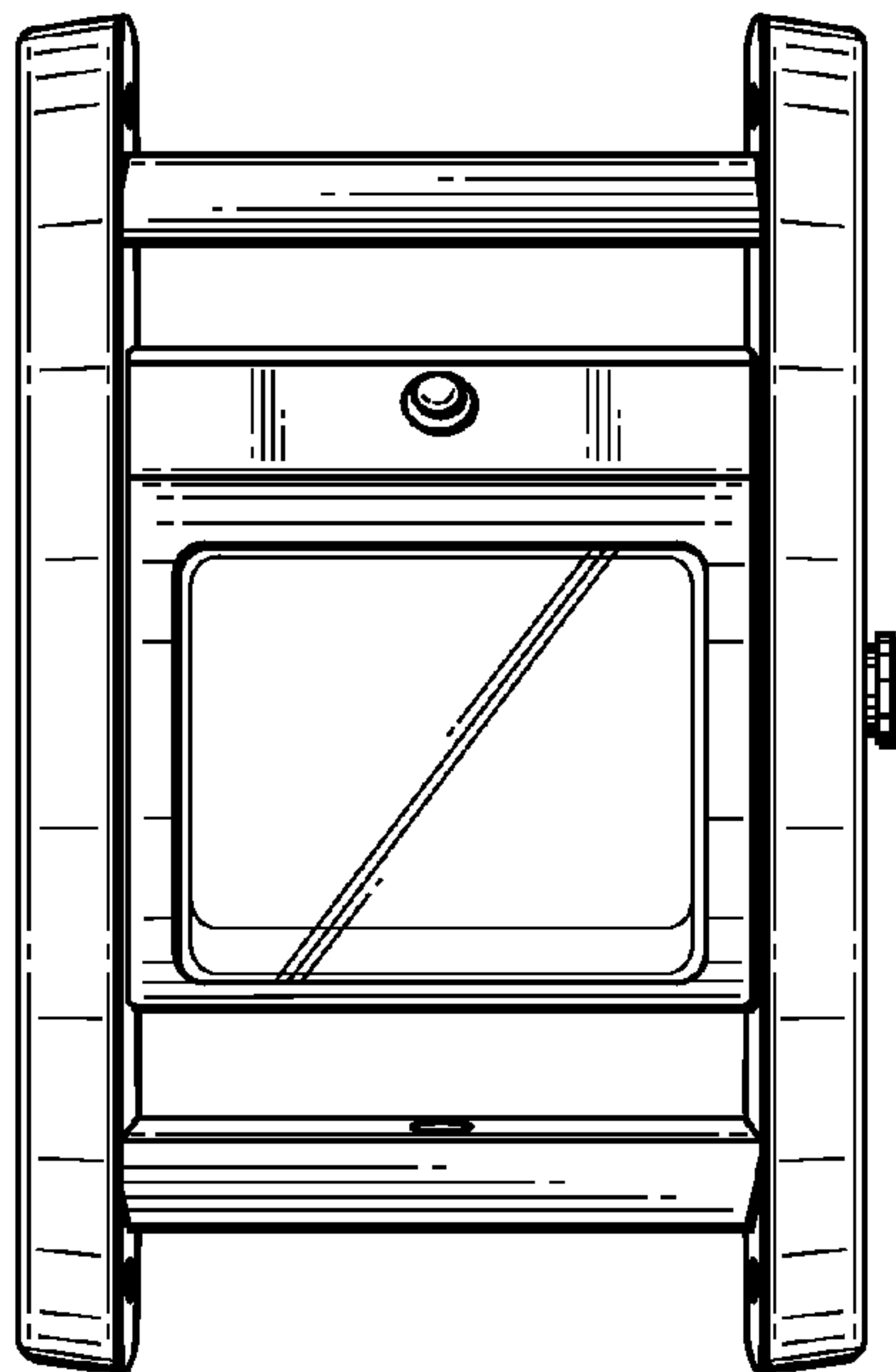

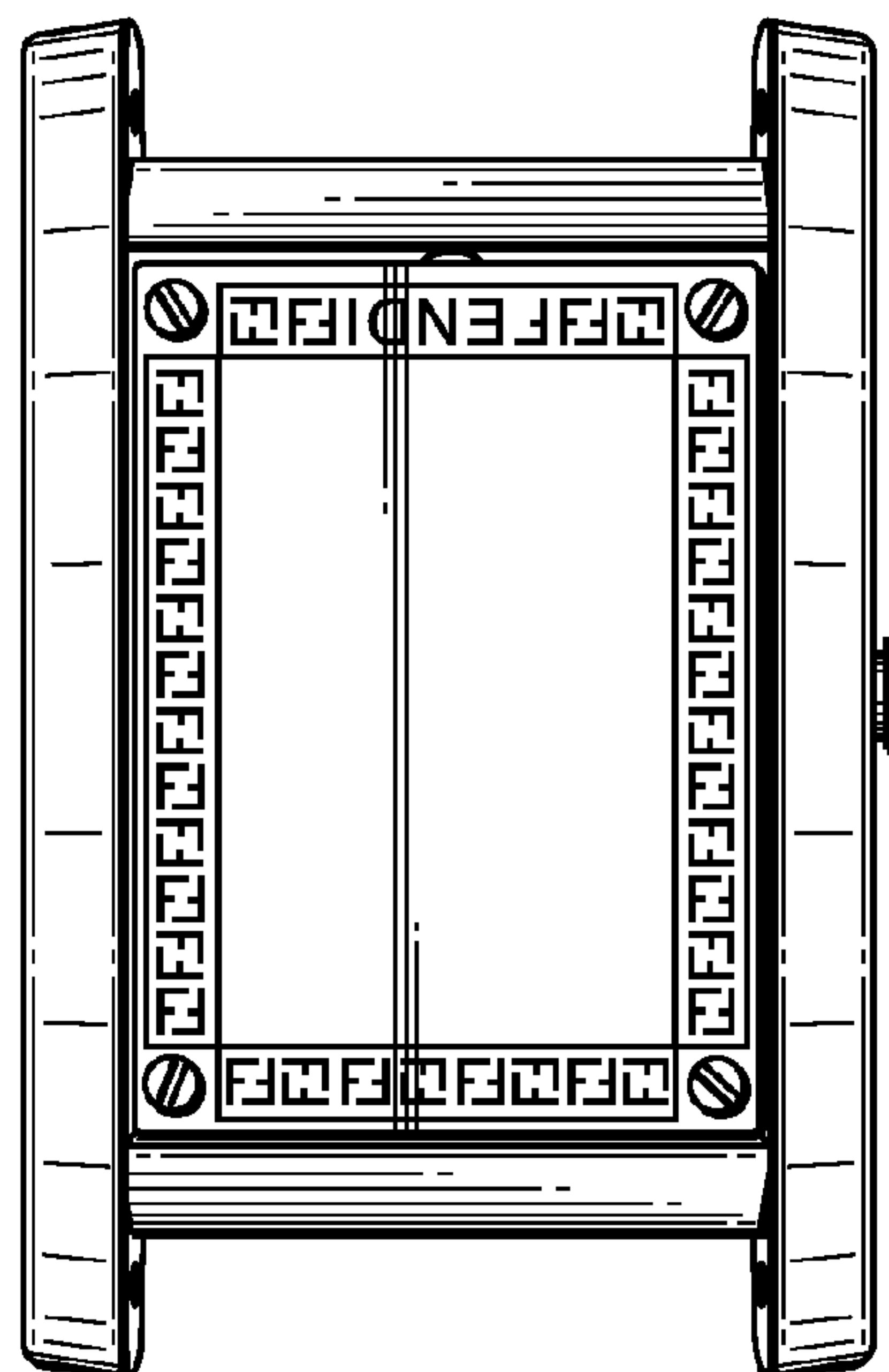

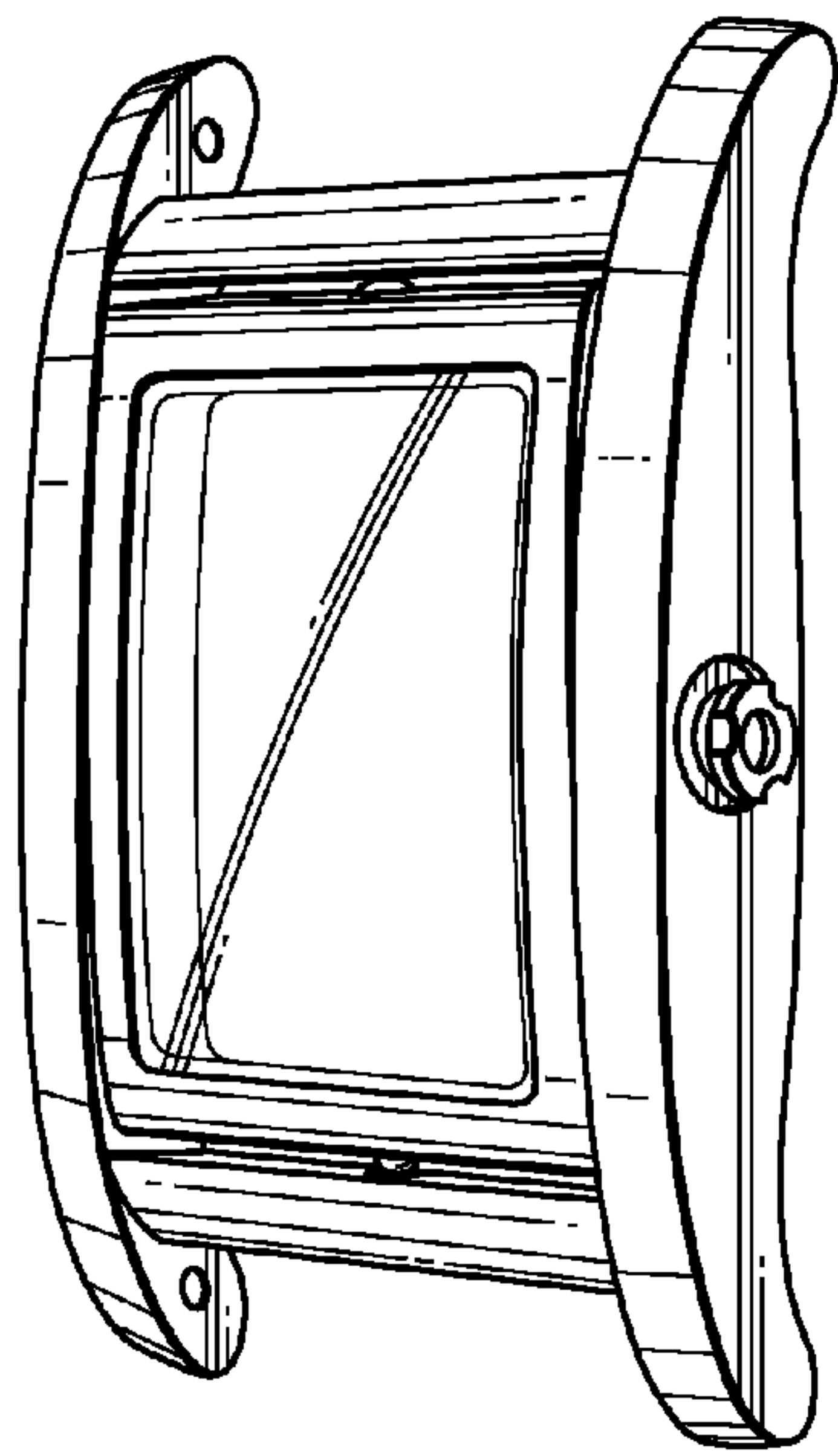

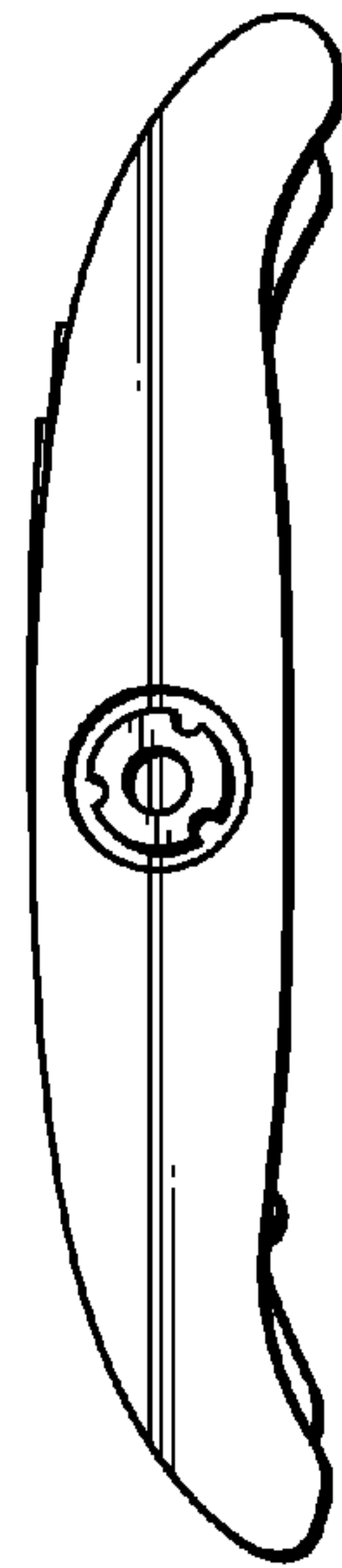

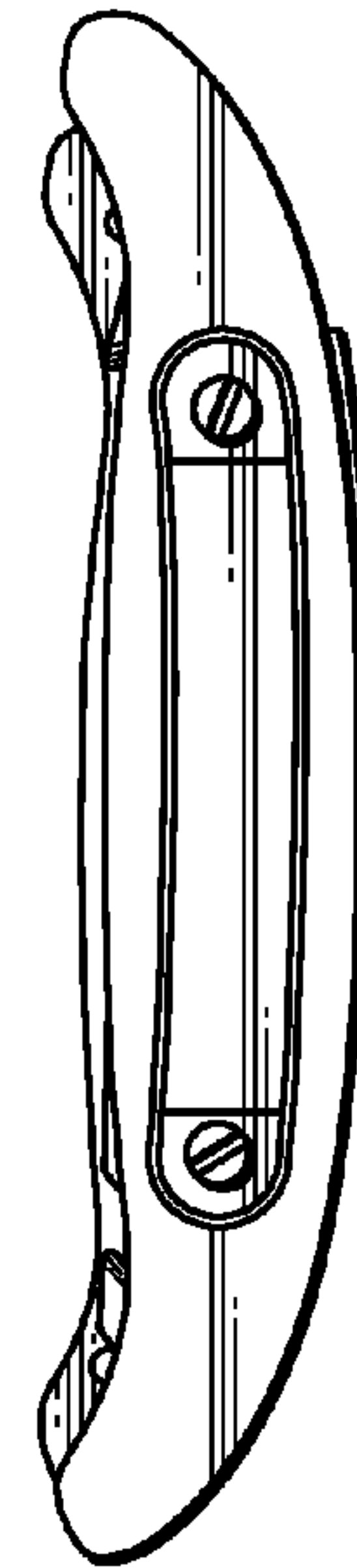

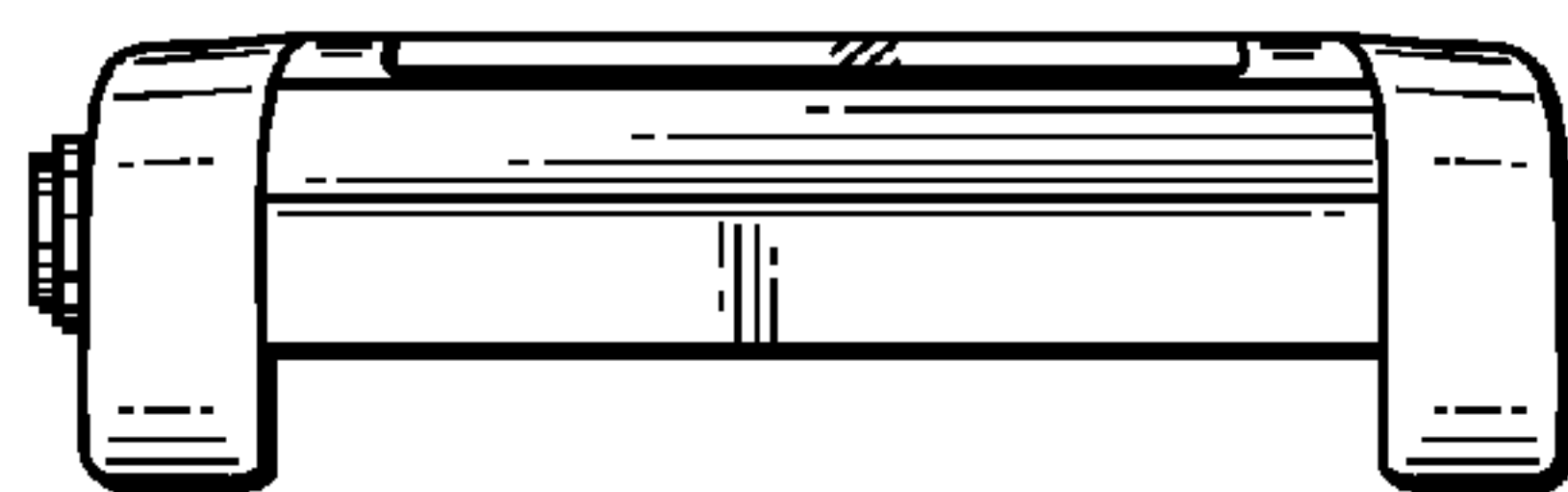

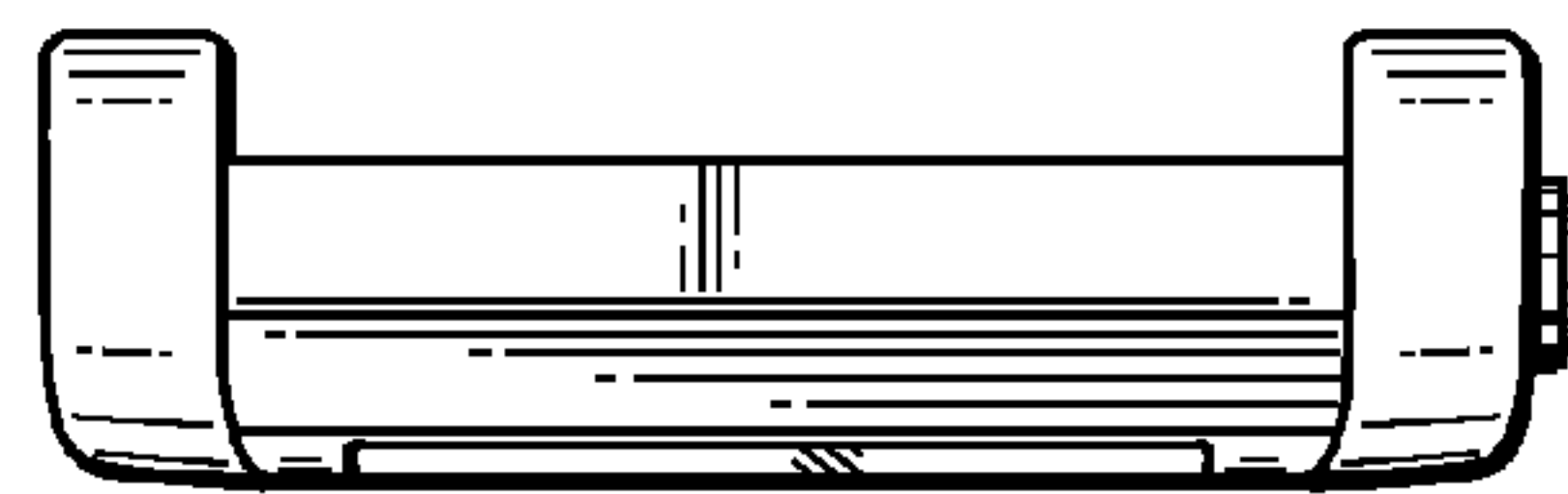
