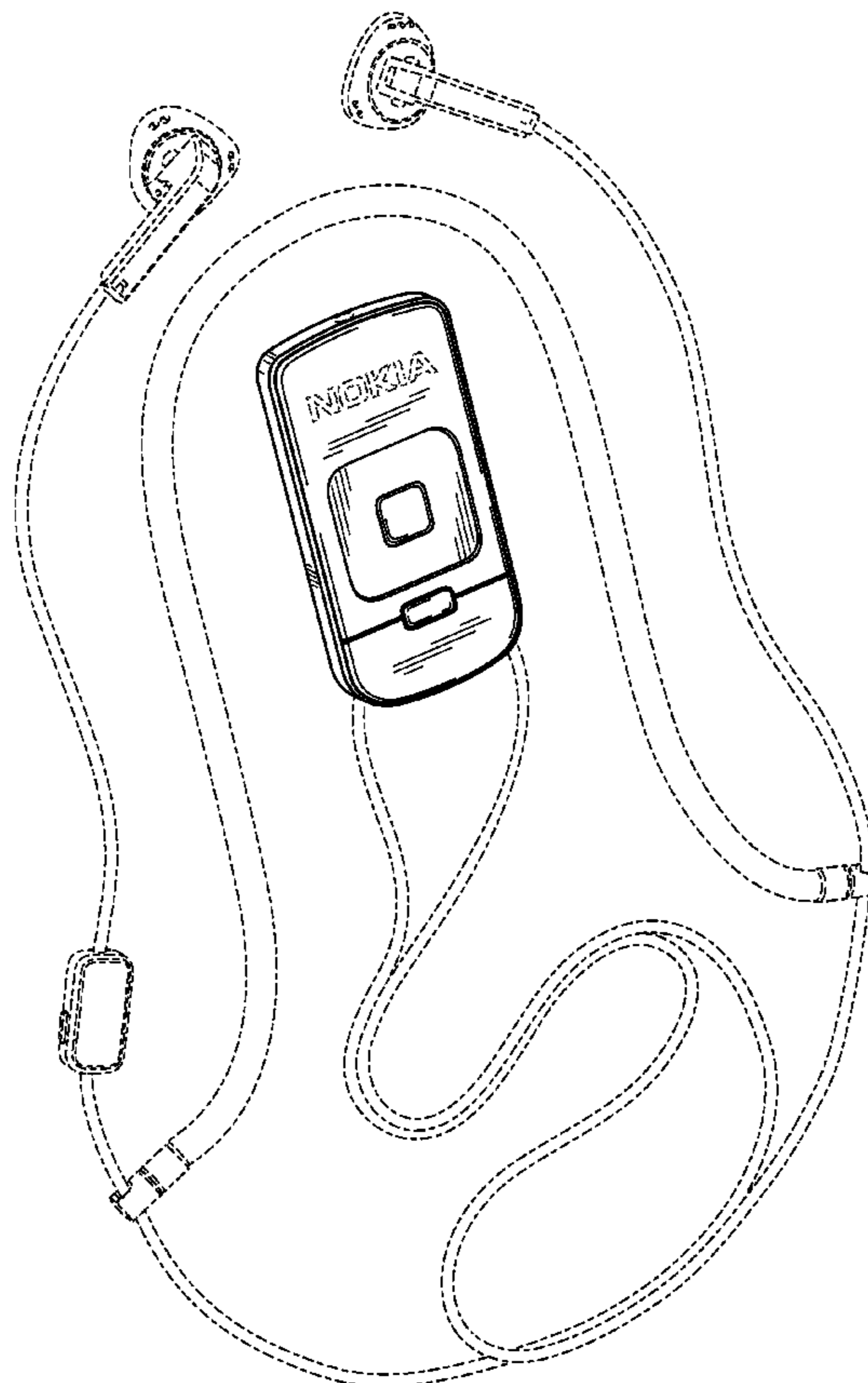
The ornamental design for a headset, as shown and described.

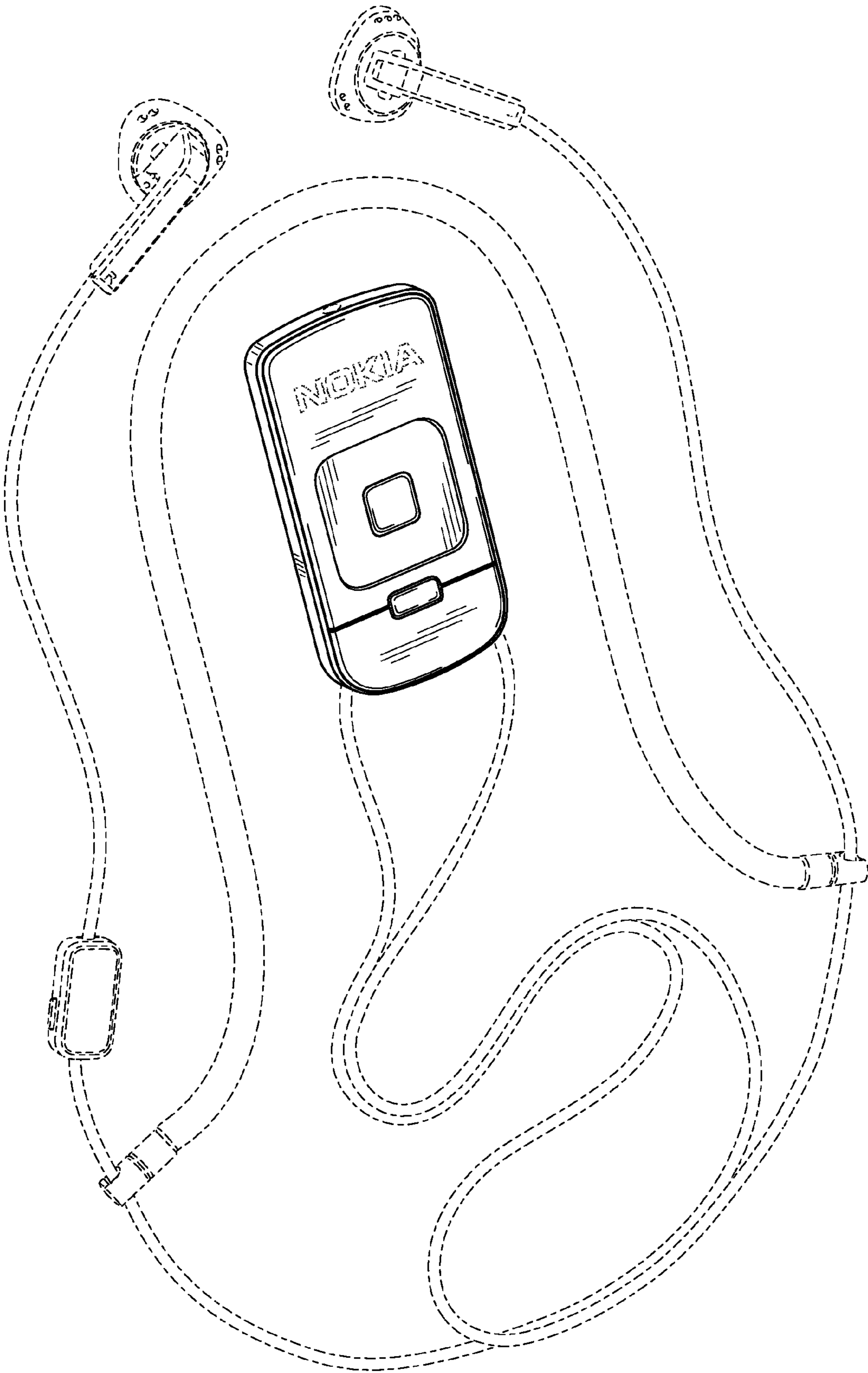
