FIG. 1 is a front view of a set of key buttons for a handset showing my new design in a broken line environment of a handset;

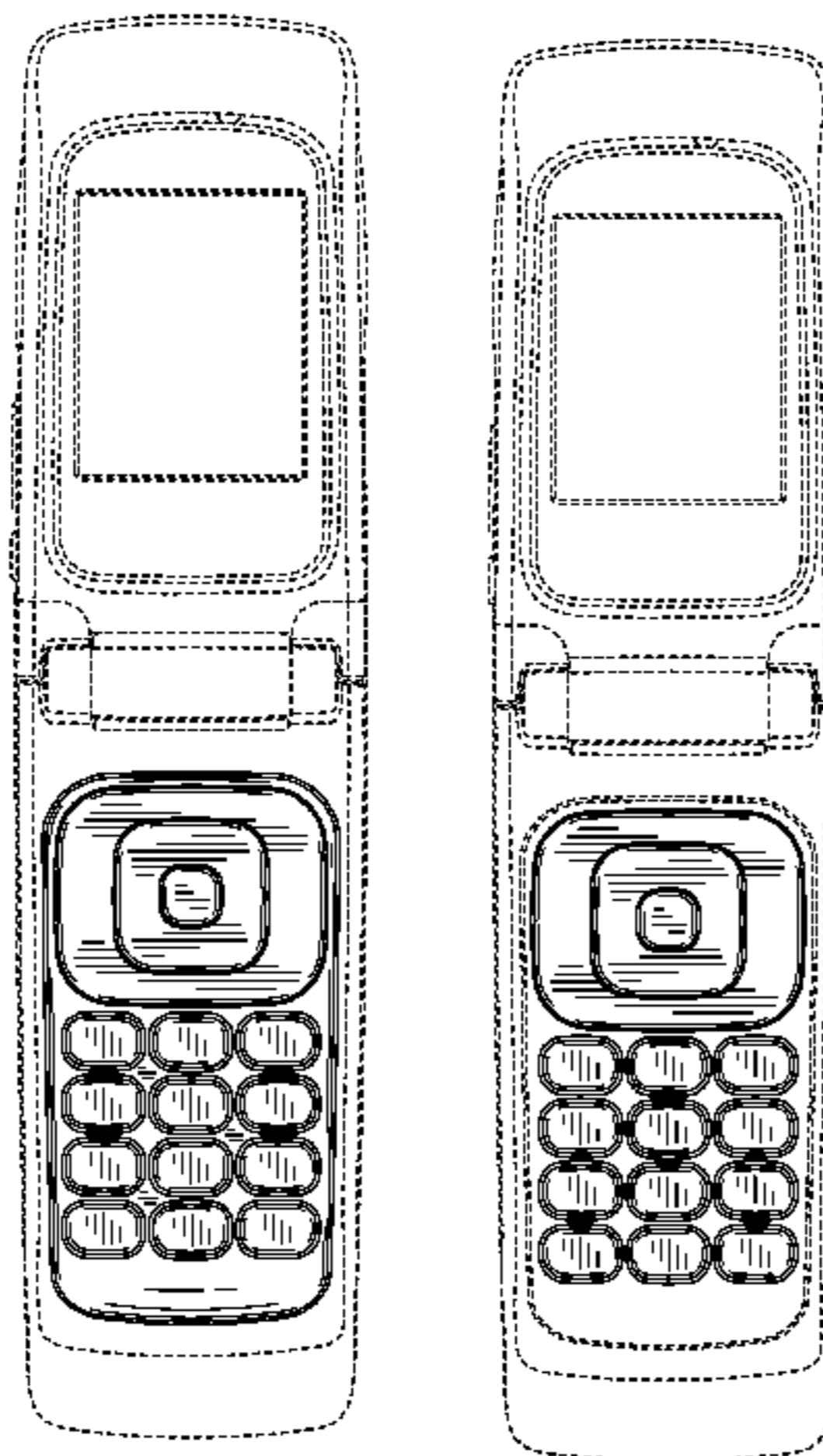
FIG. 2 is a perspective front view thereof;

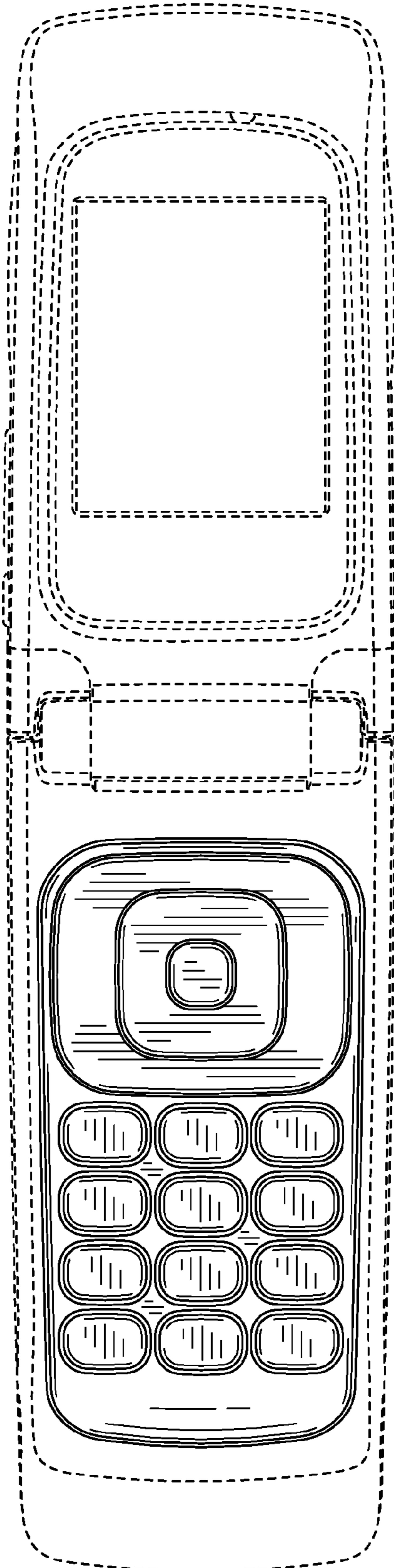

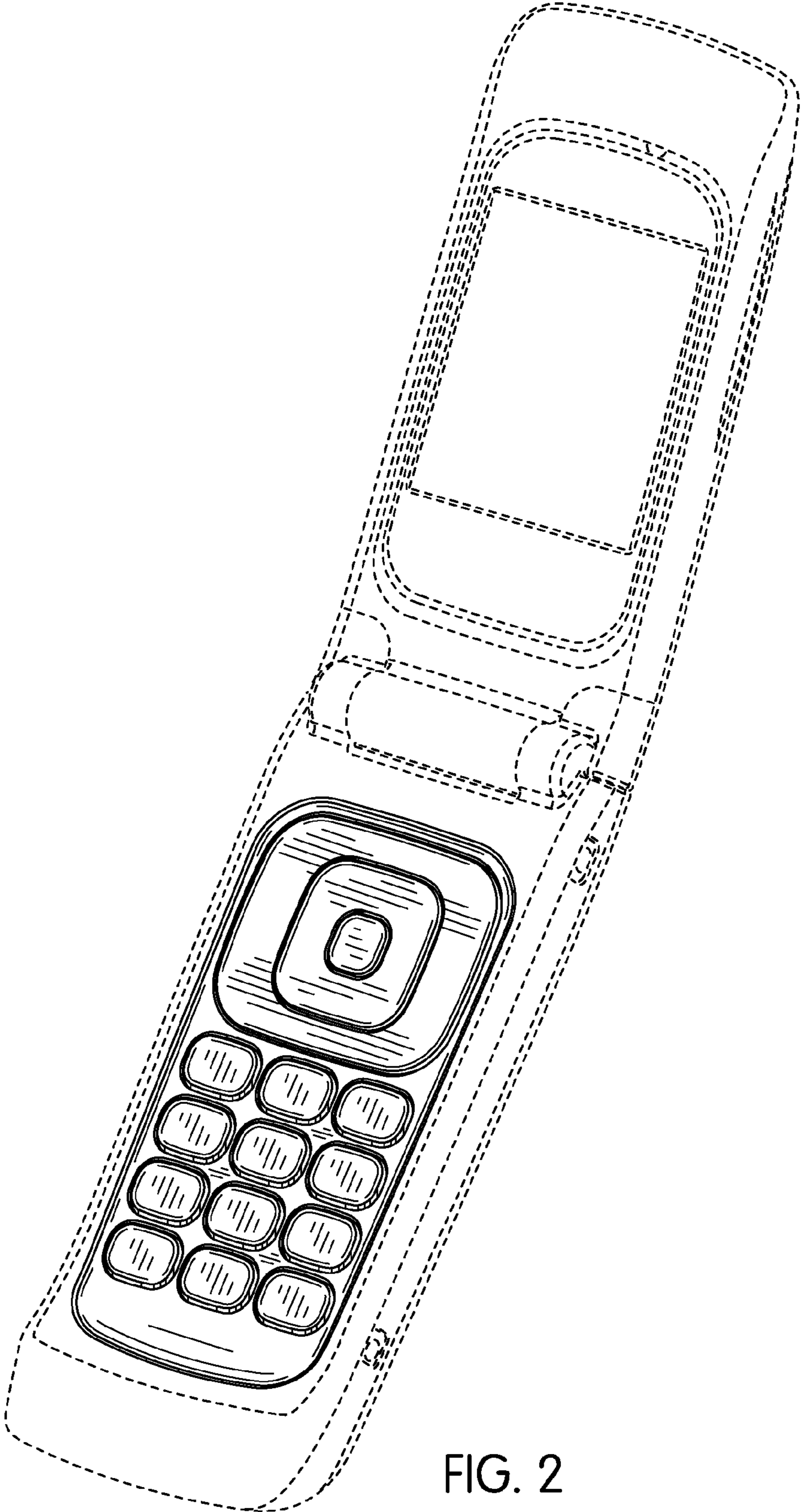

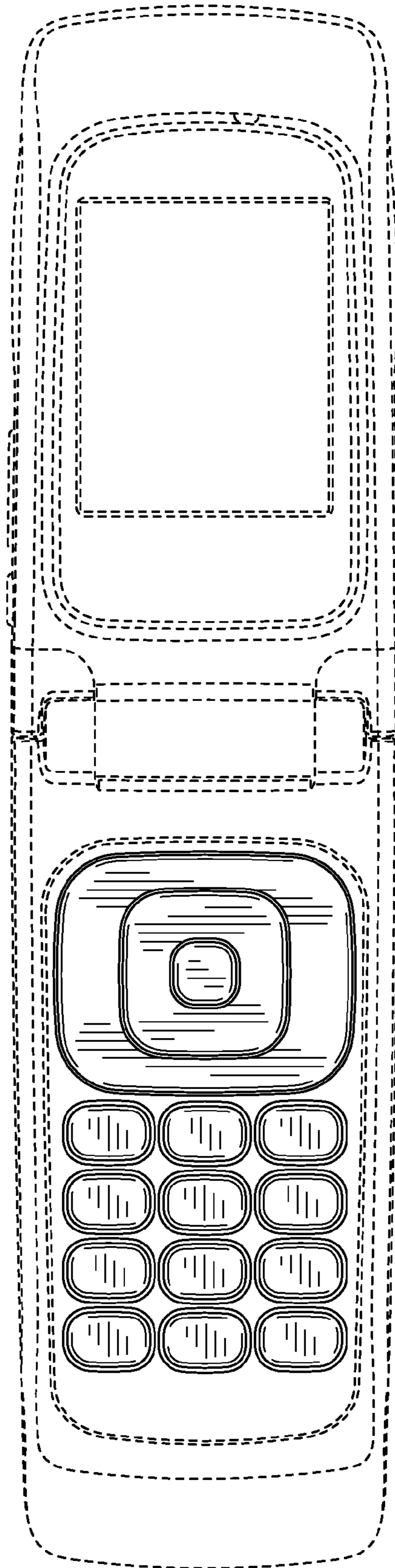

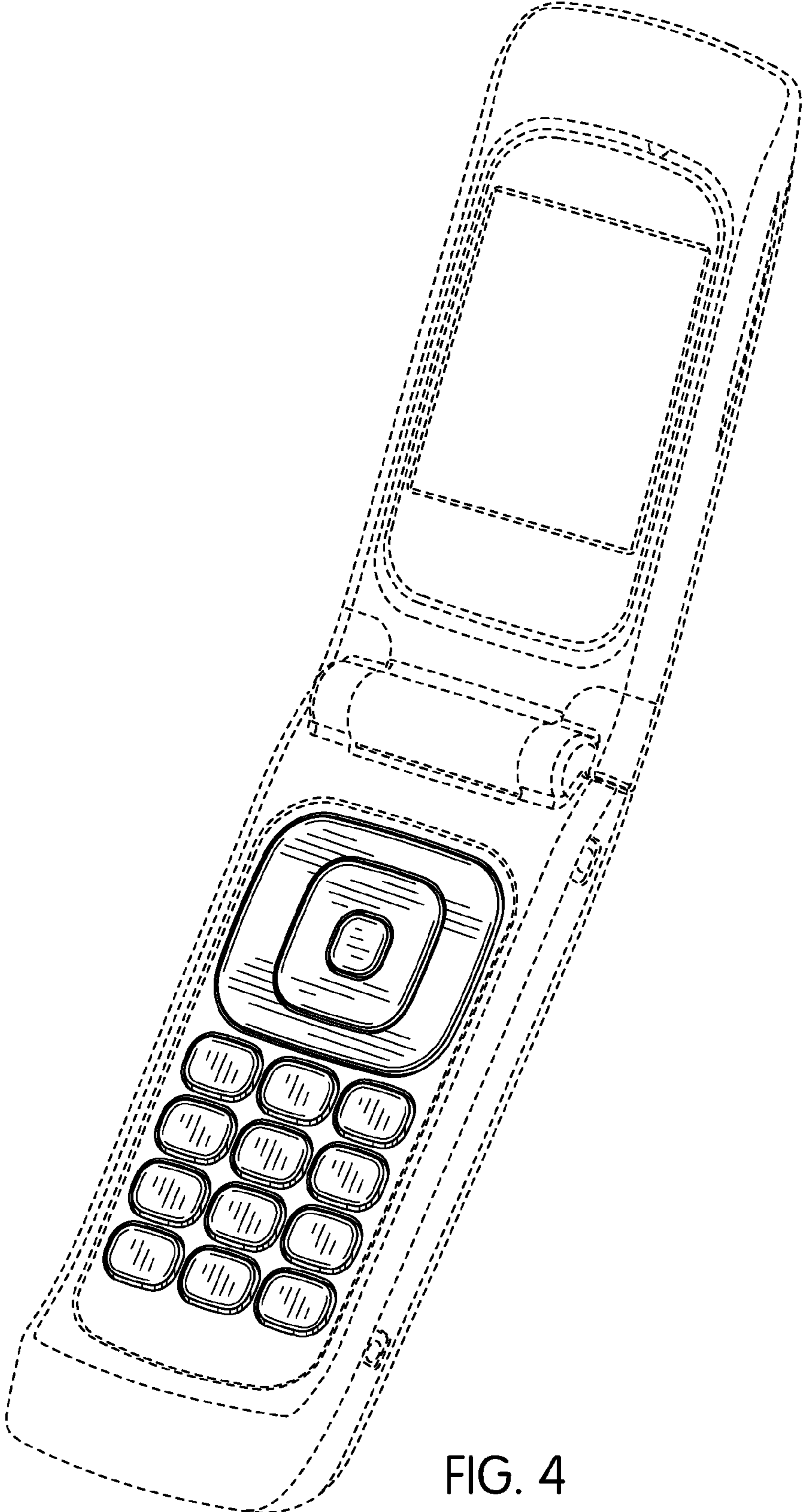
