The ornamental design for a stand for portable terminal, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, top and right perspective view of a stand for portable terminal showing our new design;

FIG. 2 is a rear, bottom and left perspective view thereof;

FIG. 3 is a front view thereof;

FIG. 4 is a rear view thereof;

FIG. 5 is a top plan view thereof;

FIG. 6 is a bottom plan view thereof;

FIG. 7 is a right side view thereof, a left side view being a mirror image thereof; and,

FIG. 8 is a front, top and right perspective view of a stand for portable terminal showing a state of use.

The broken line showing of a portable terminal is included for the purpose of illustrating environment and forms no part of the claimed design.

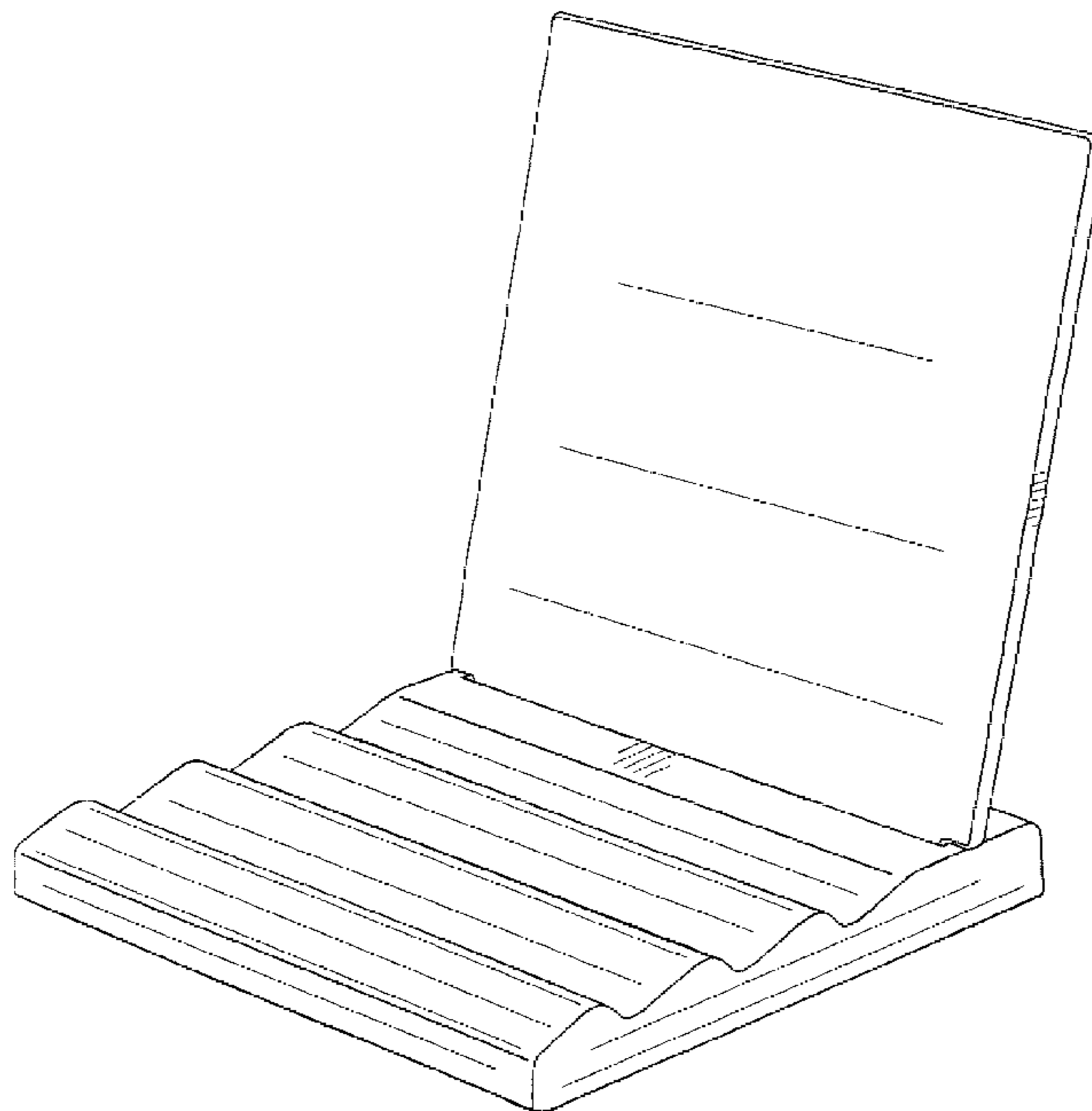

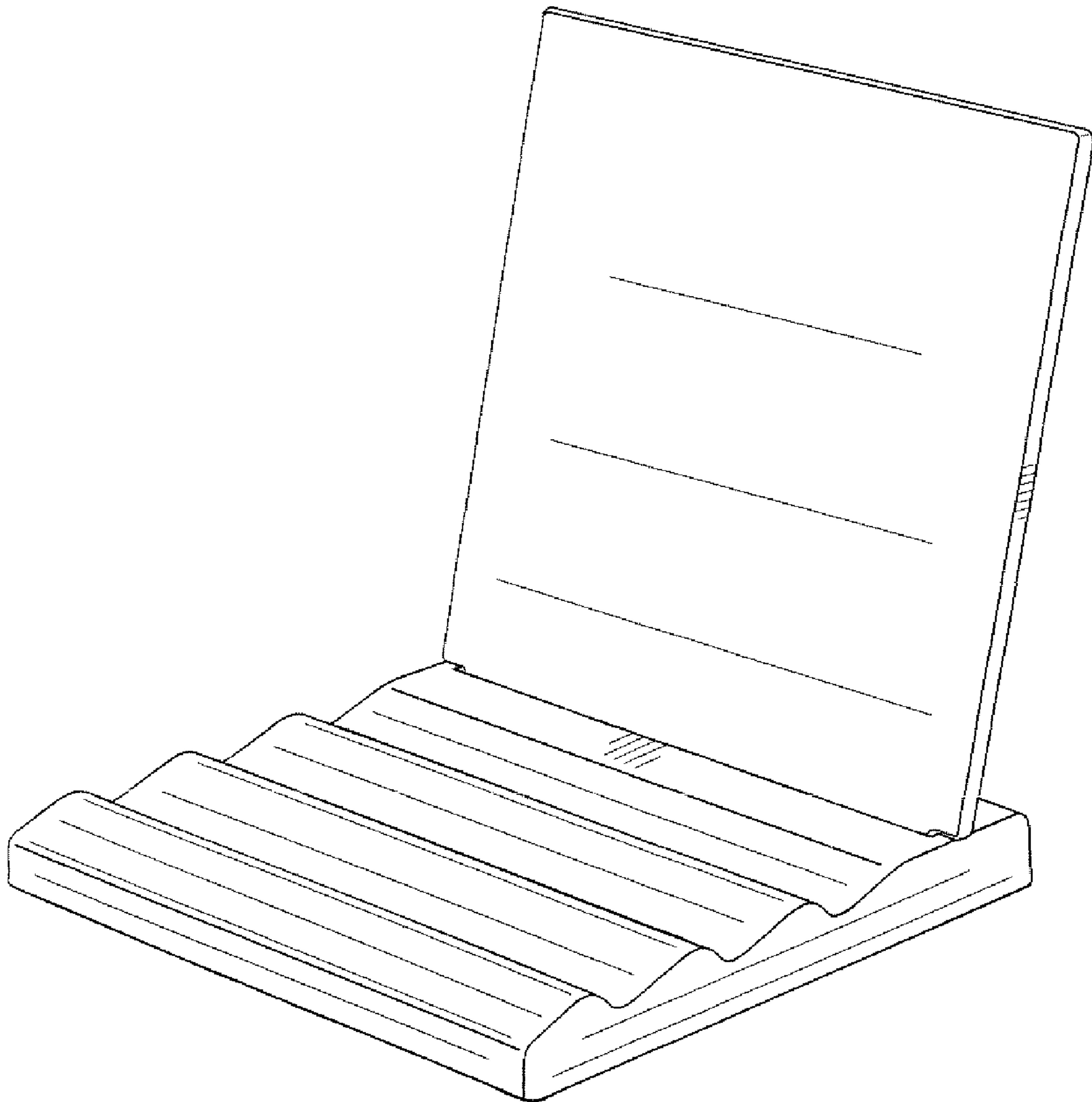

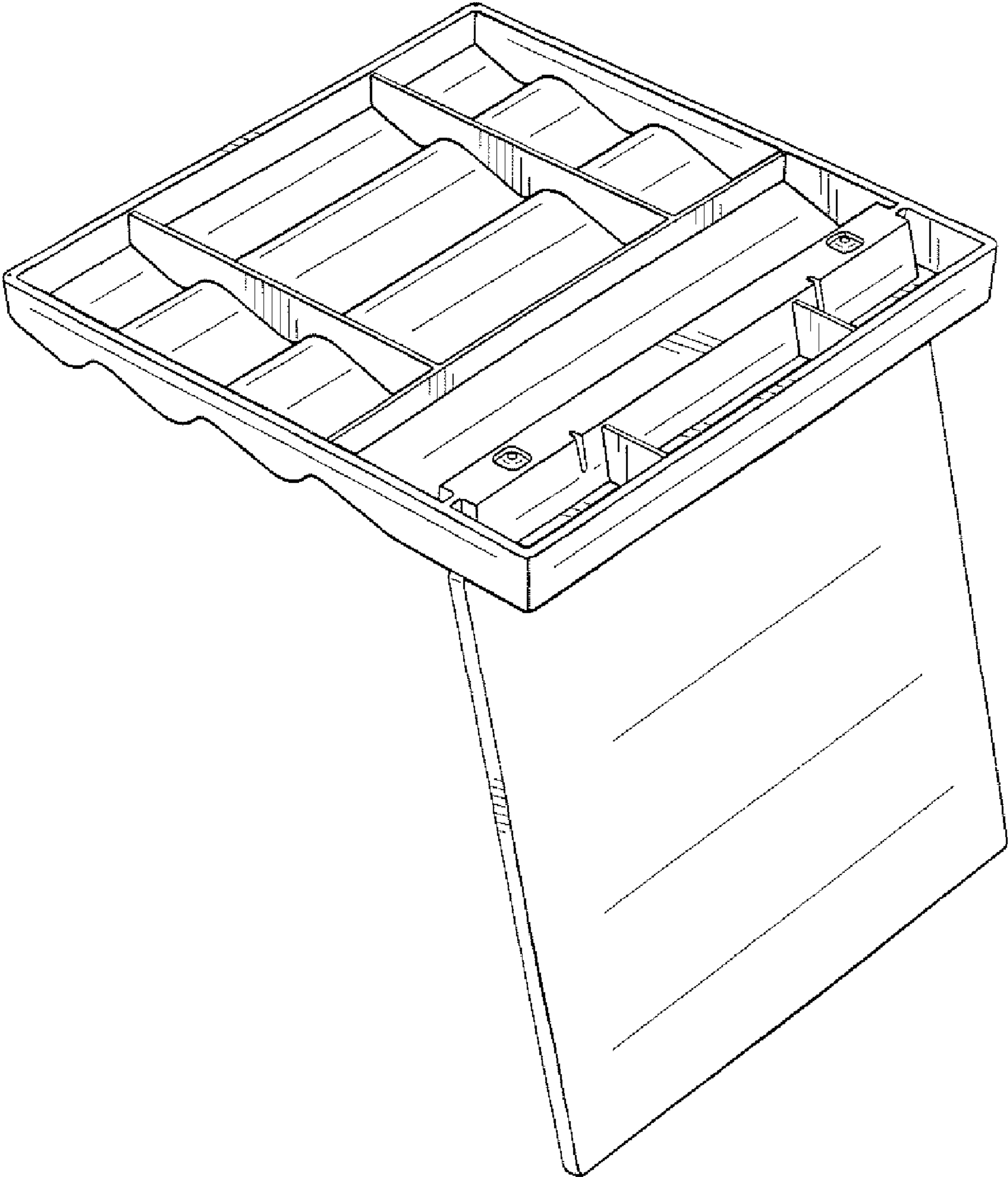

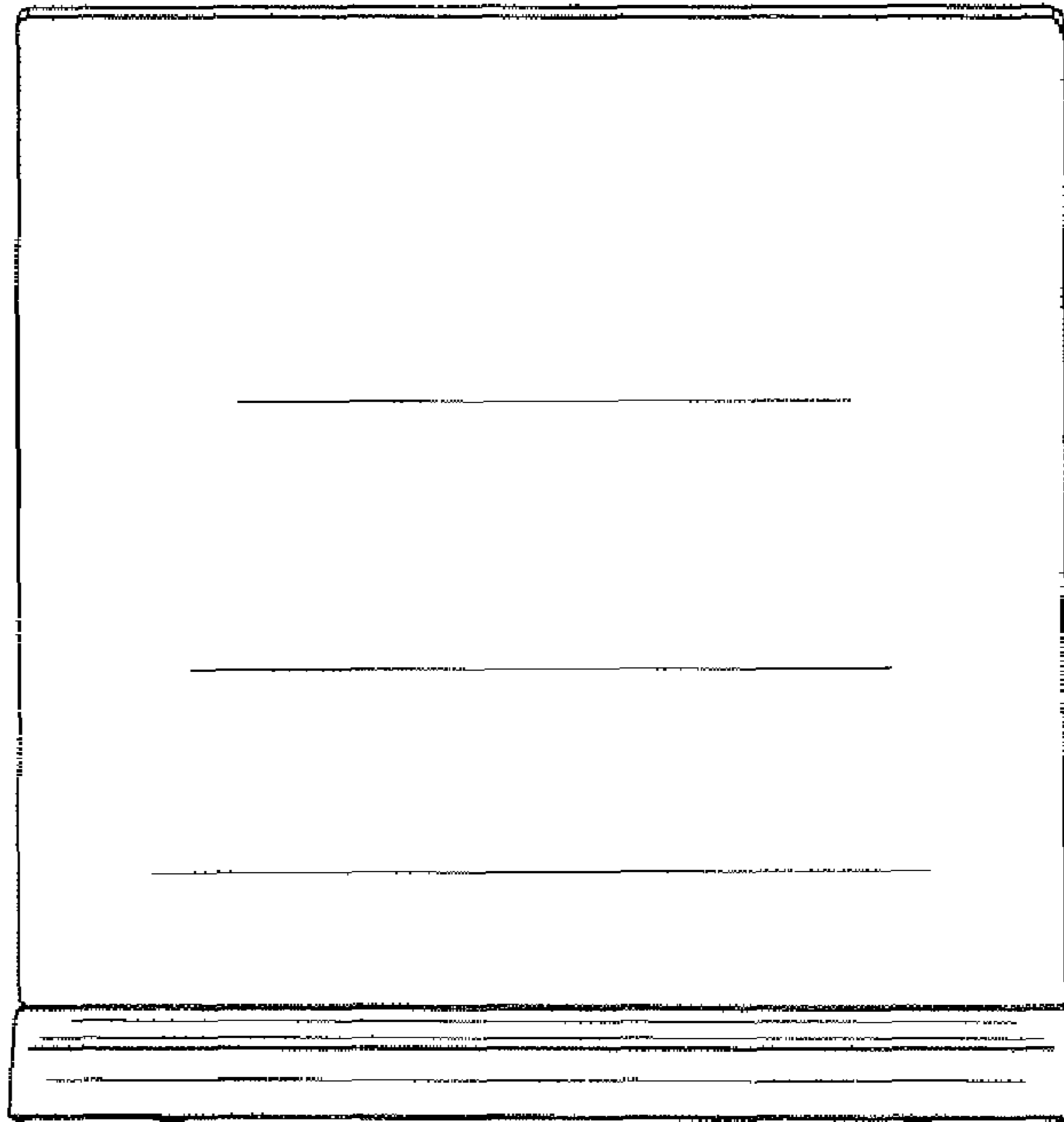

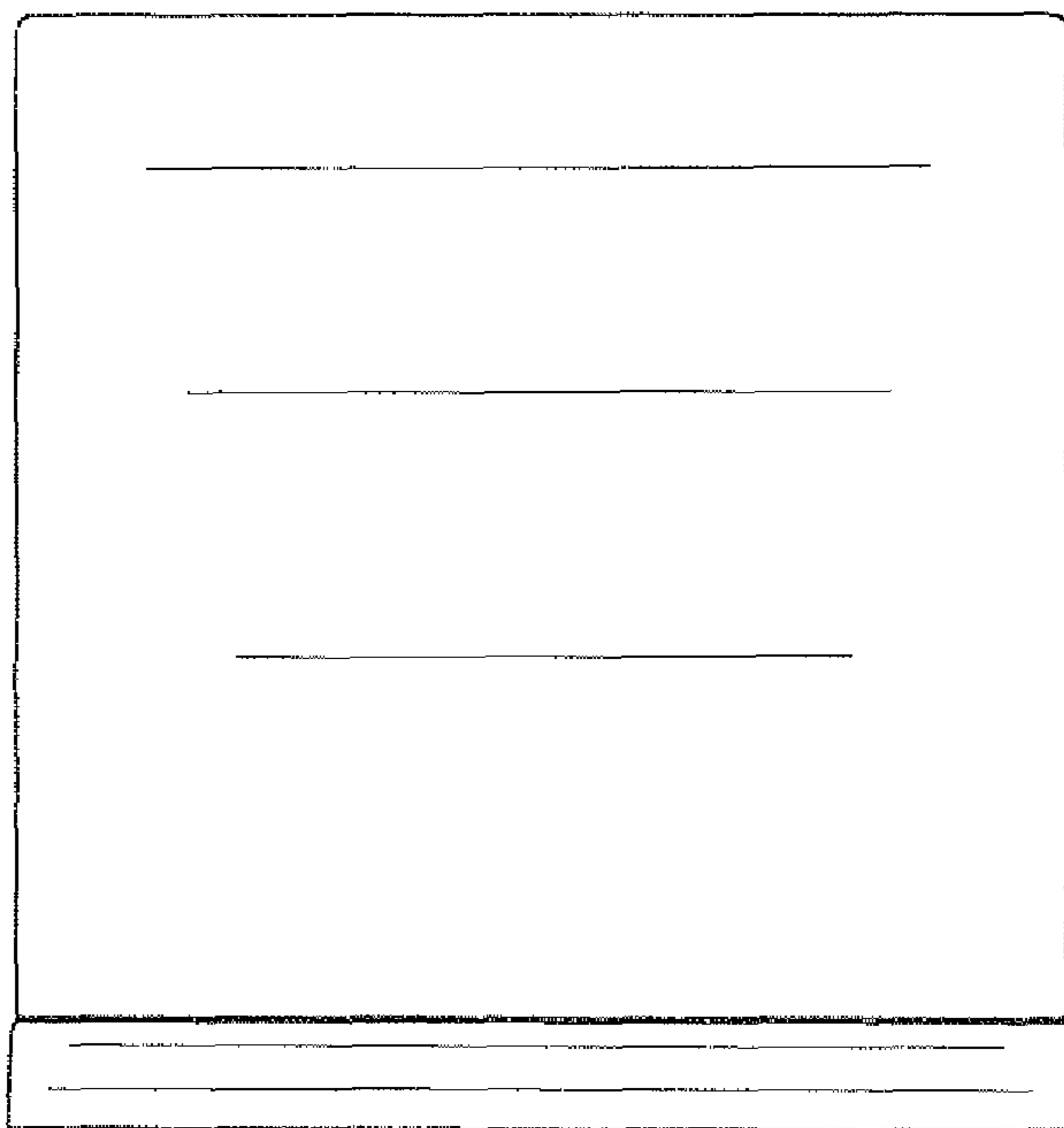

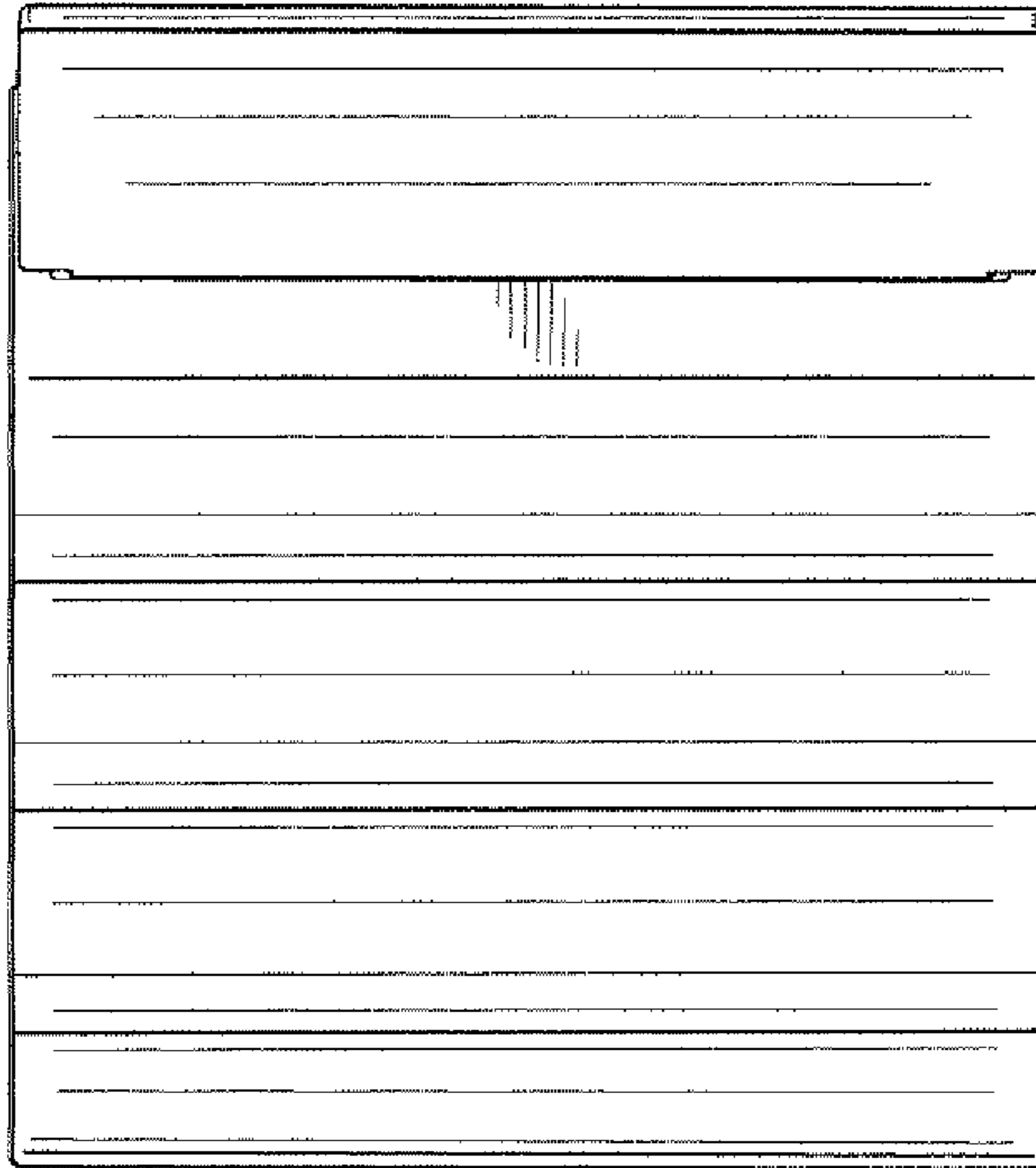

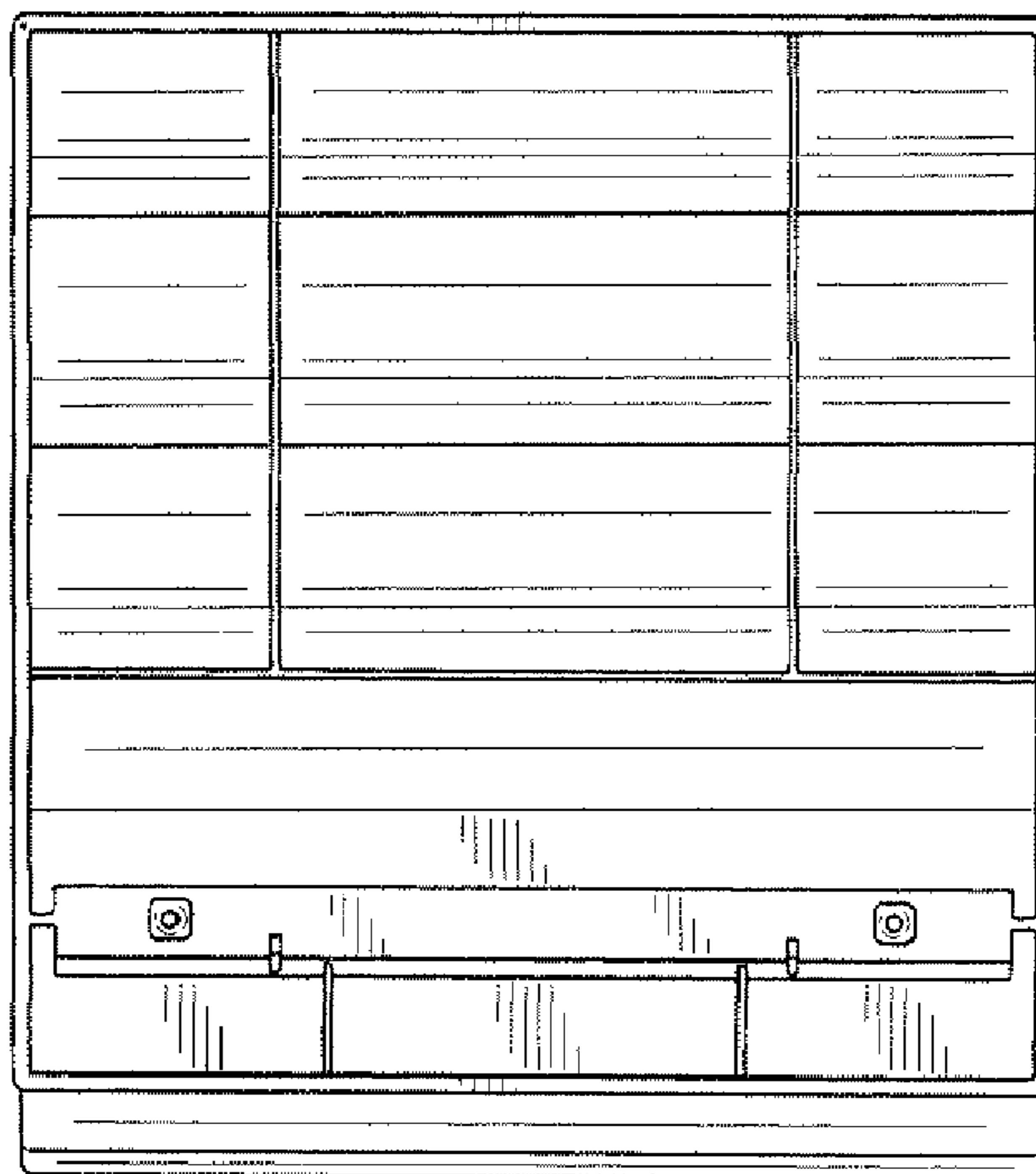

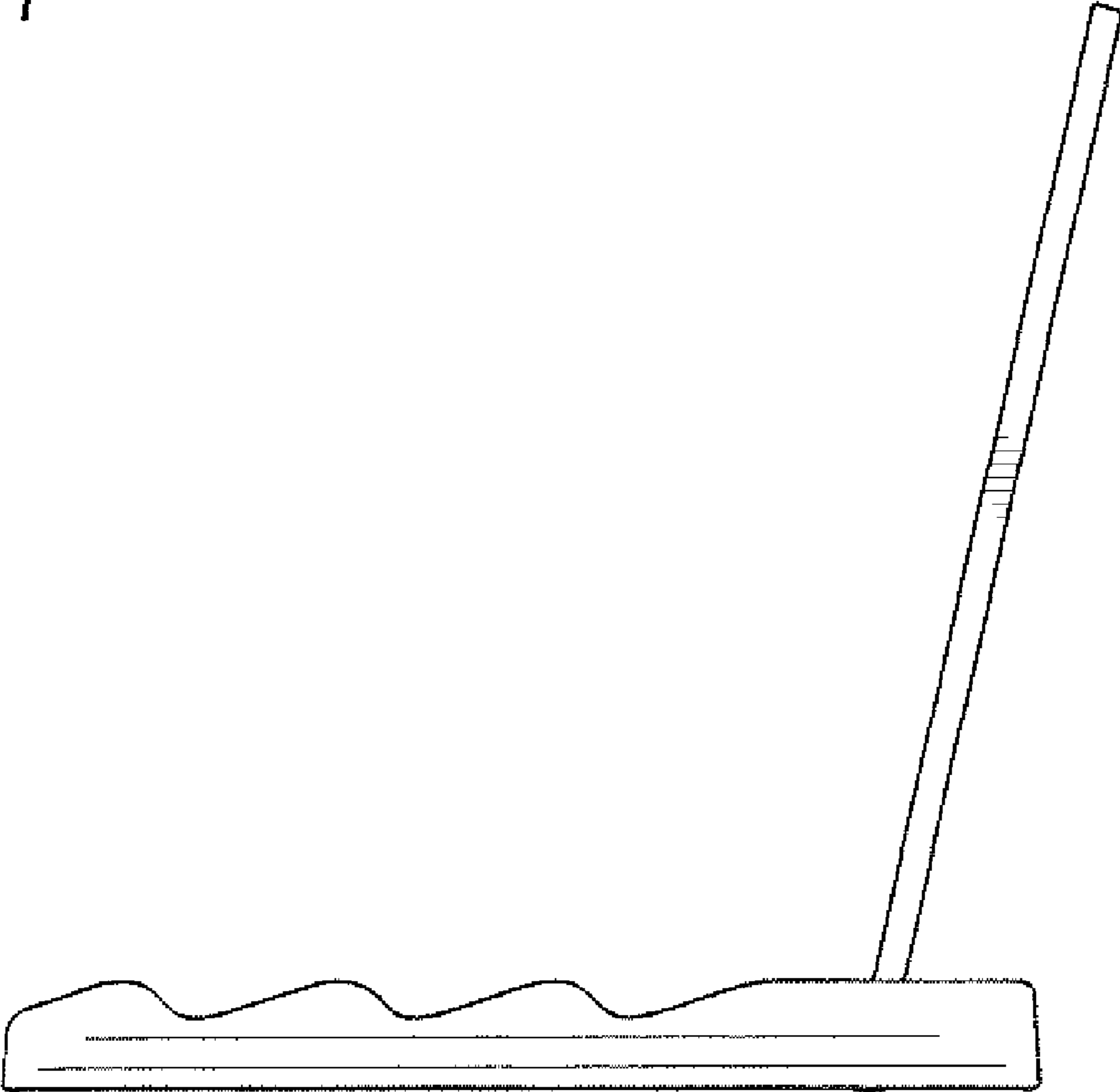
