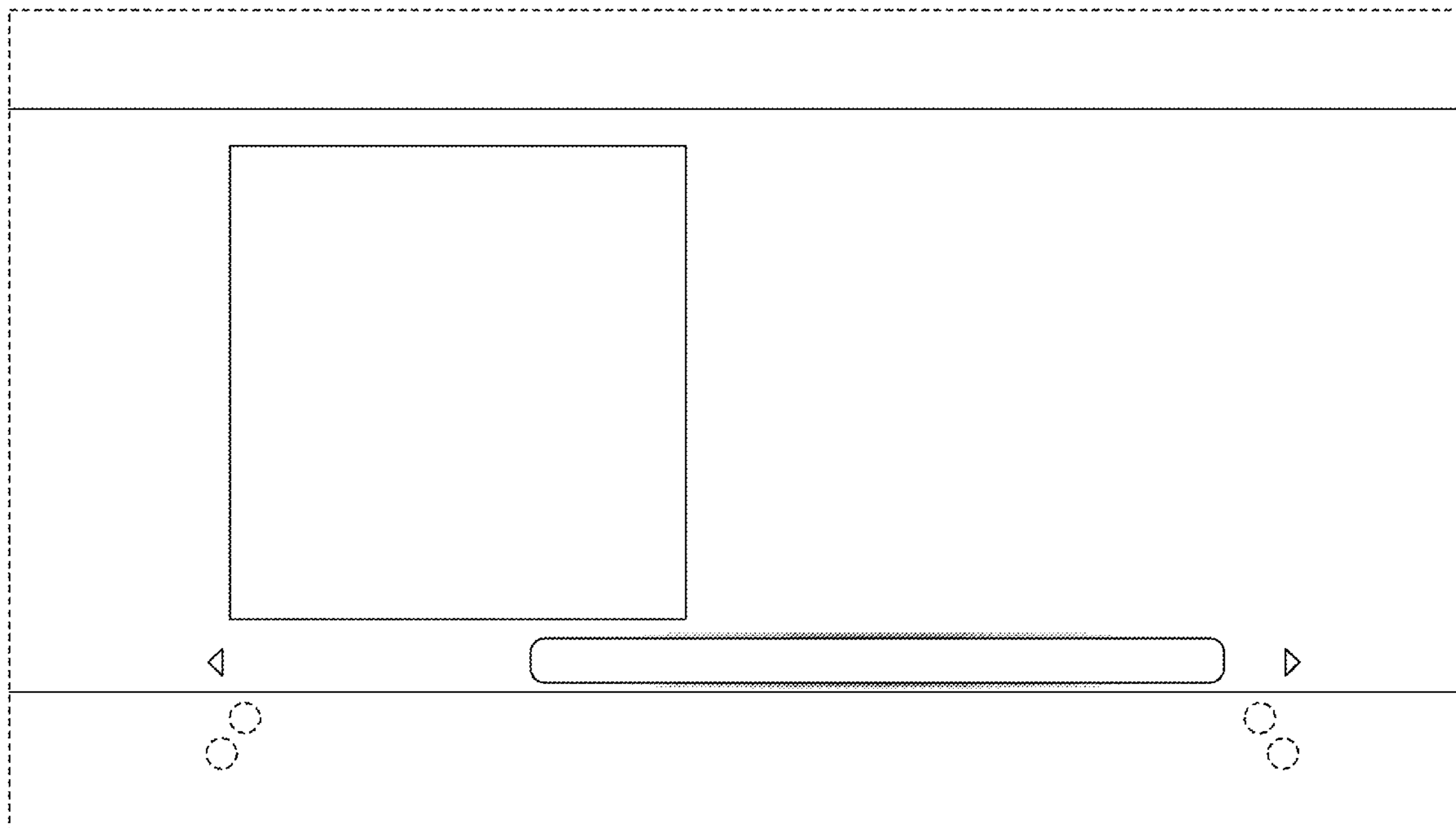
The ornamental design for a portion of a user interface for a display screen, as shown and described.

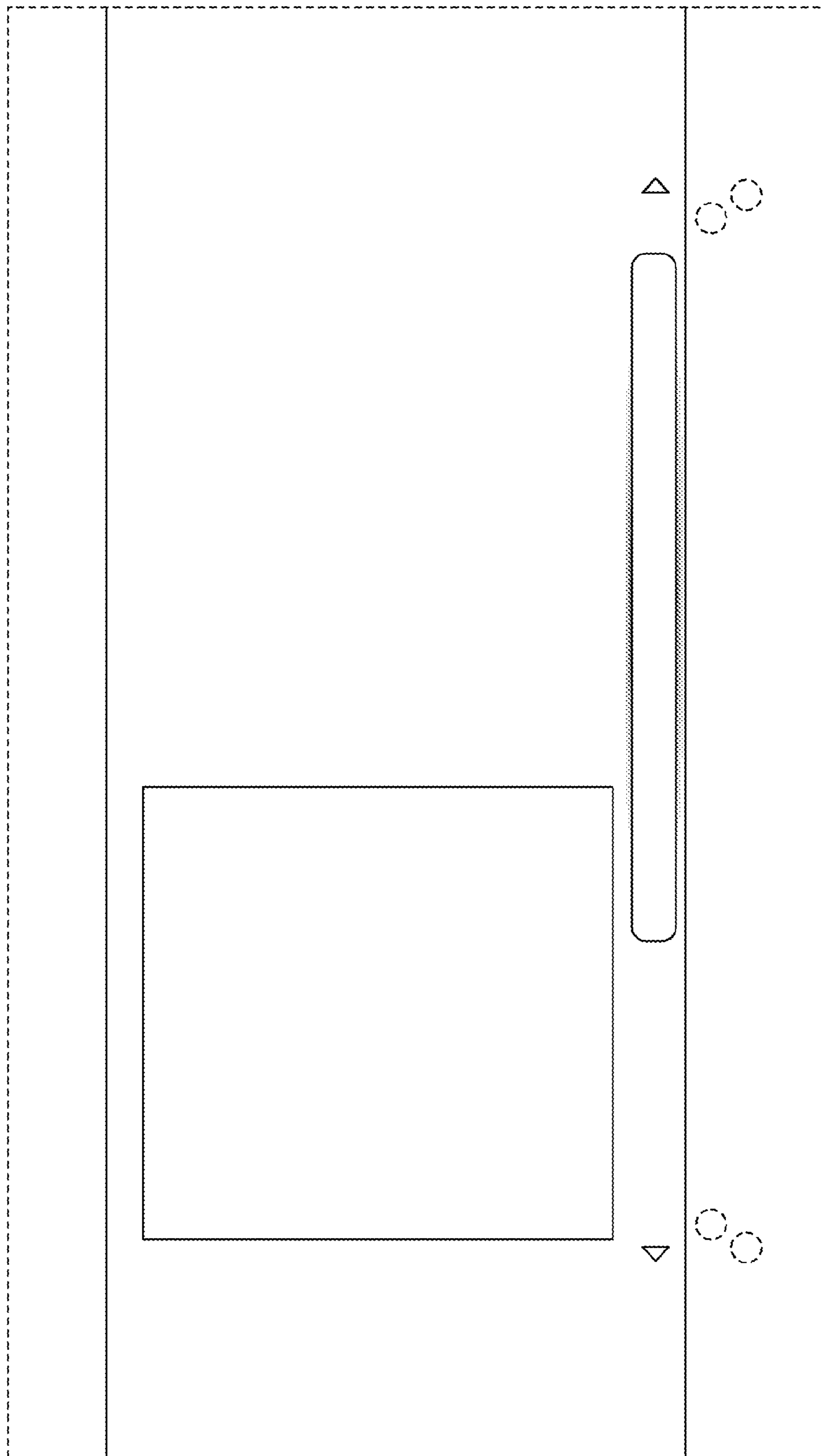
**DESCRIPTION**
