**DESCRIPTION**

FIG. 4 is a rear elevational view of the golf club head of FIG. 1;

FIG. 5 is a top view of the golf club head of FIG. 1;

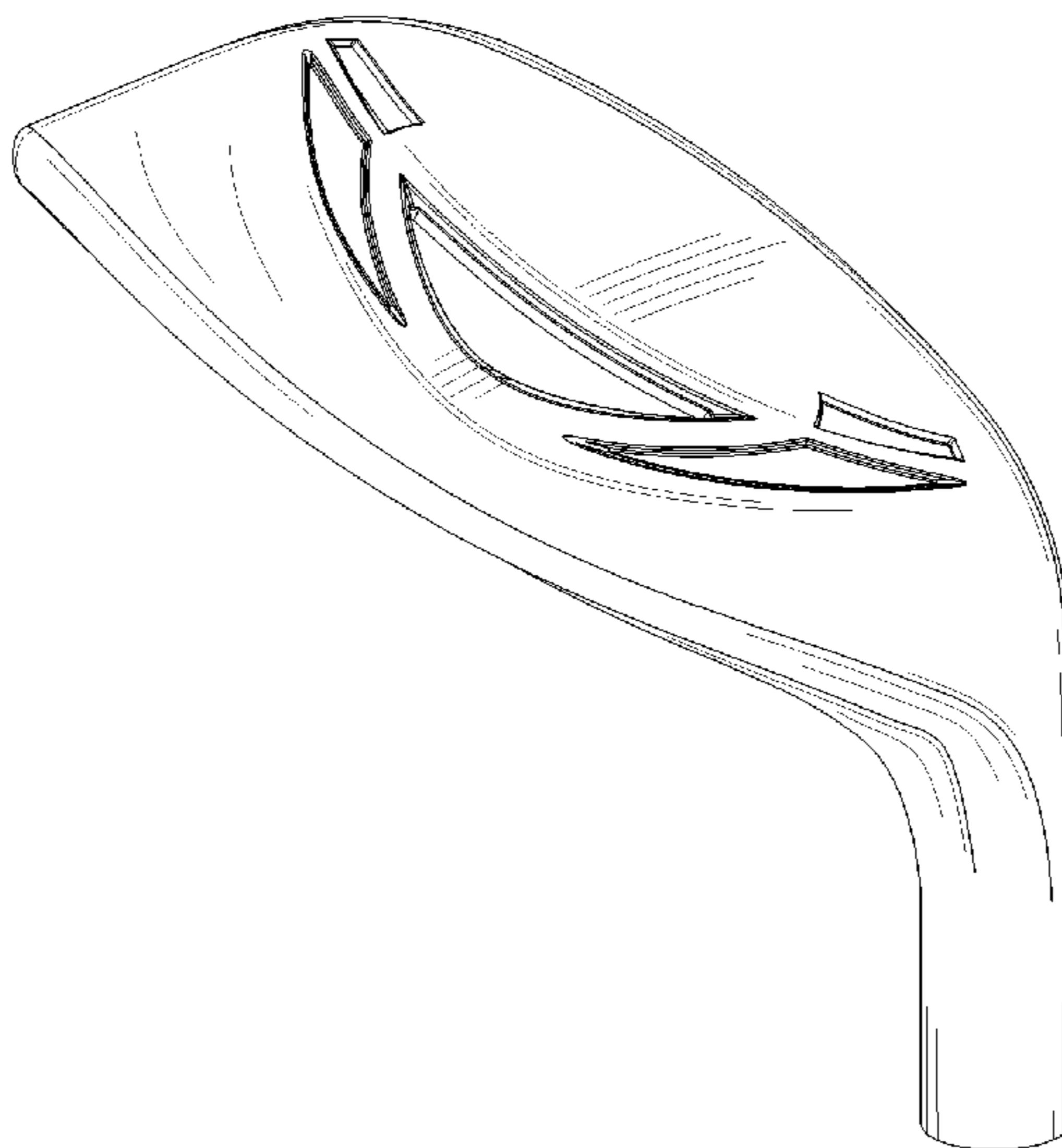
FIG. 6 is a bottom view of the golf club head of FIG. 1;

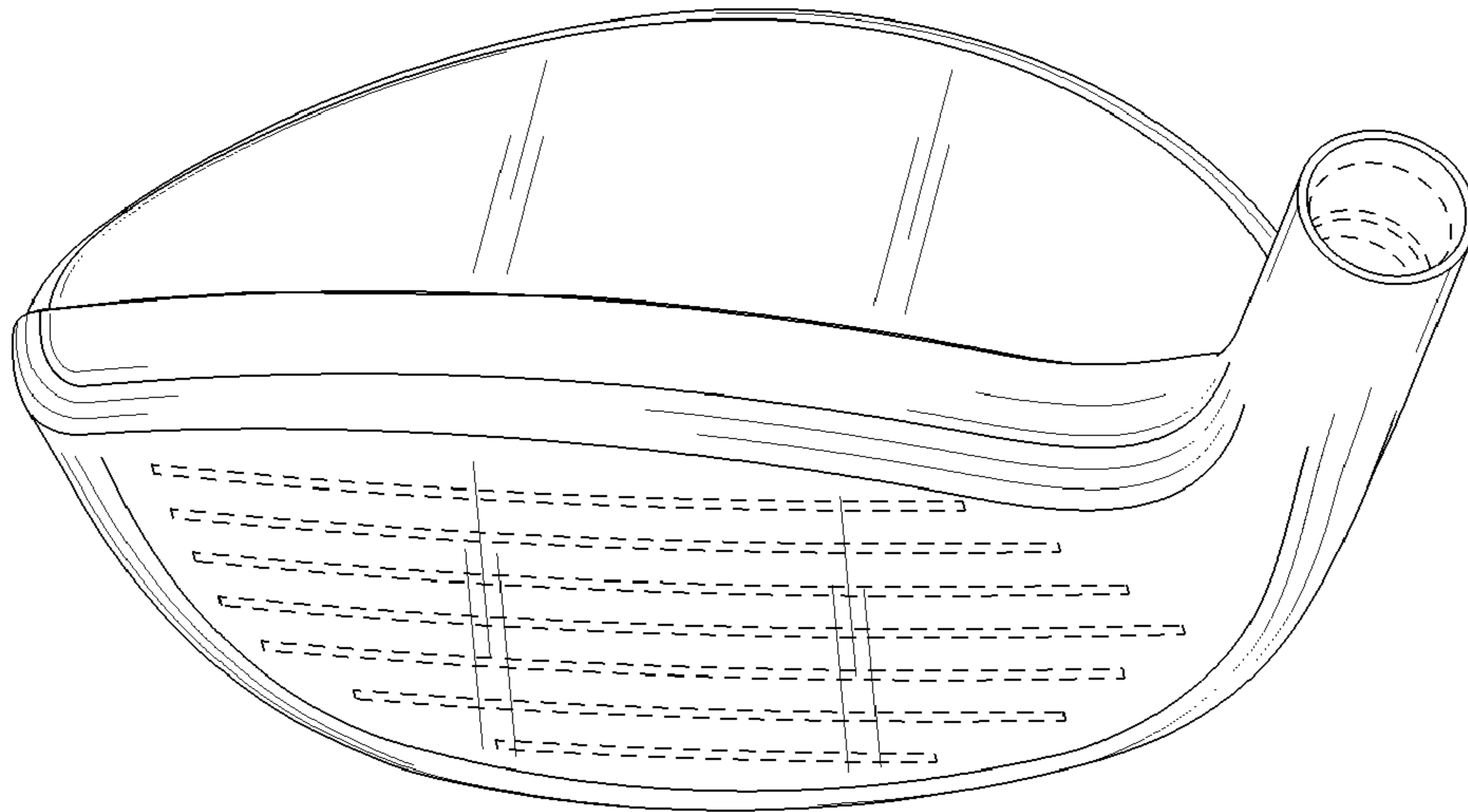

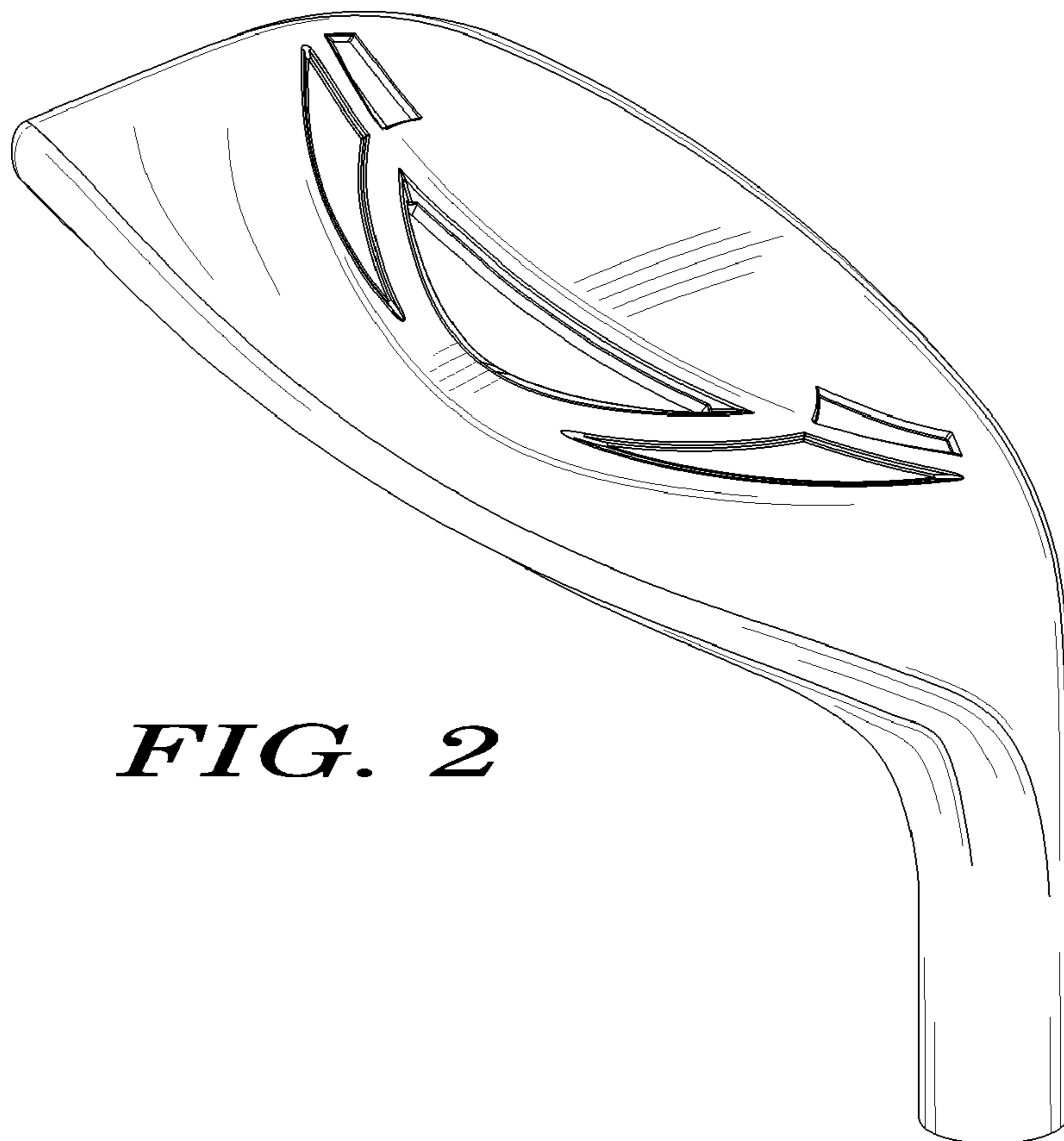

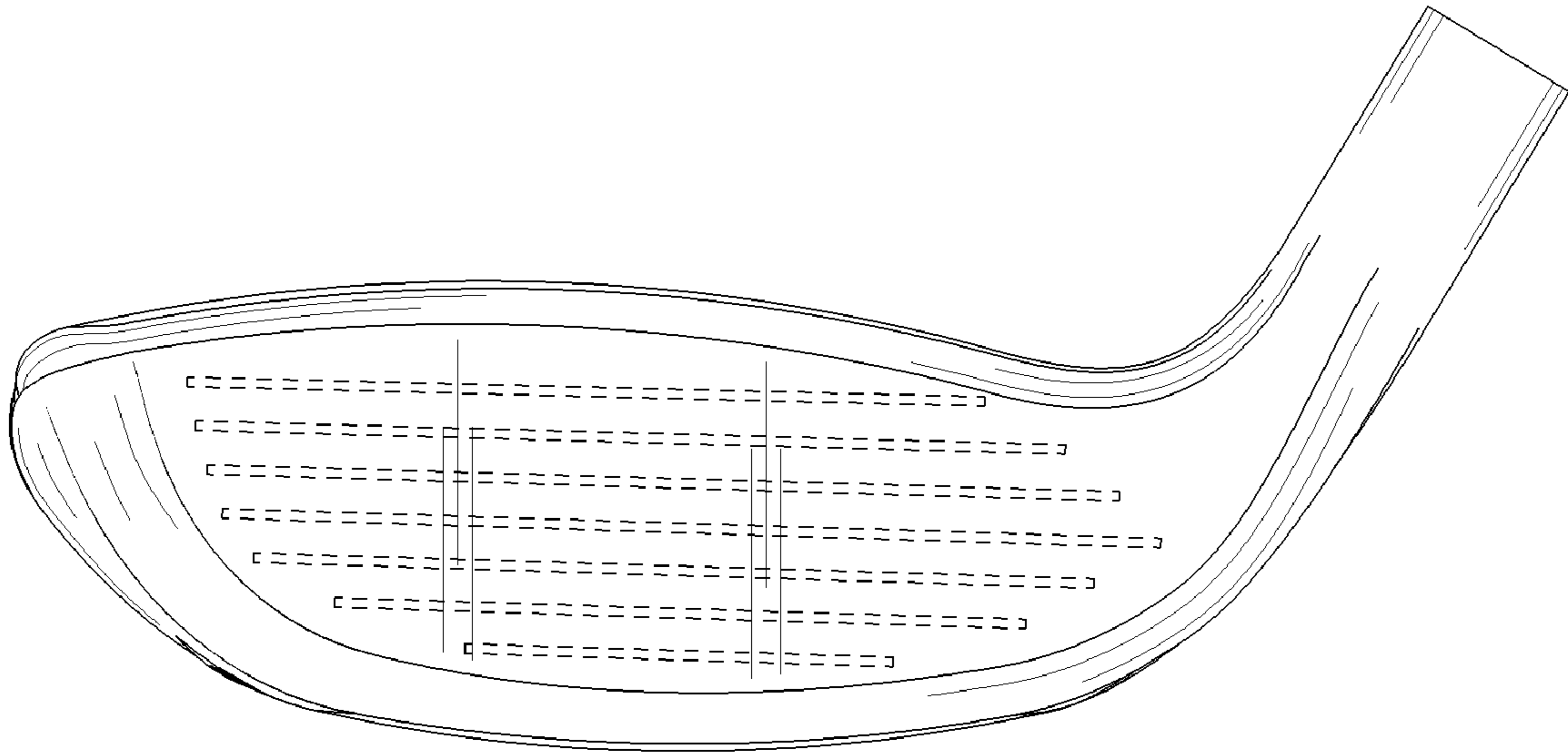

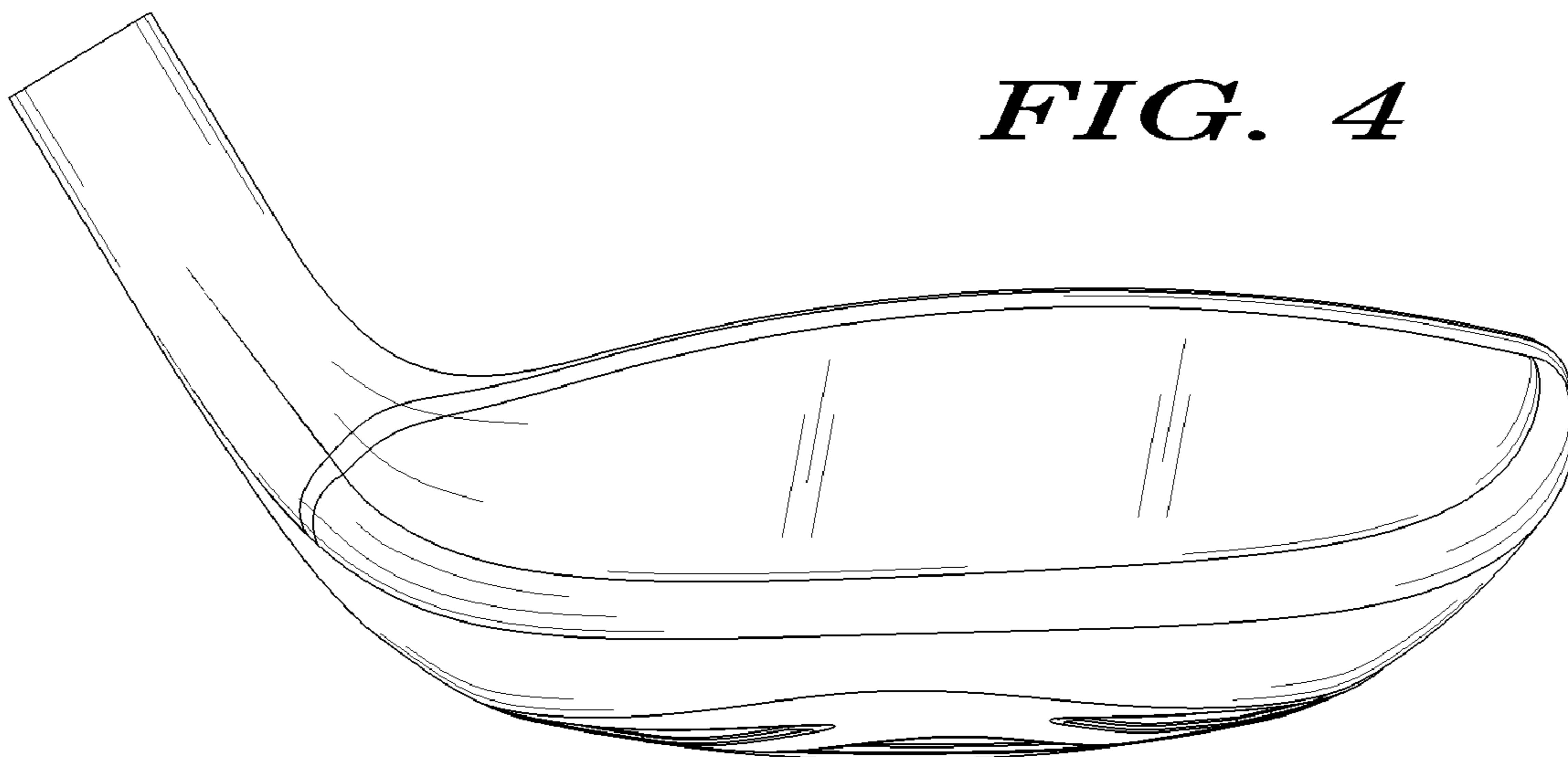

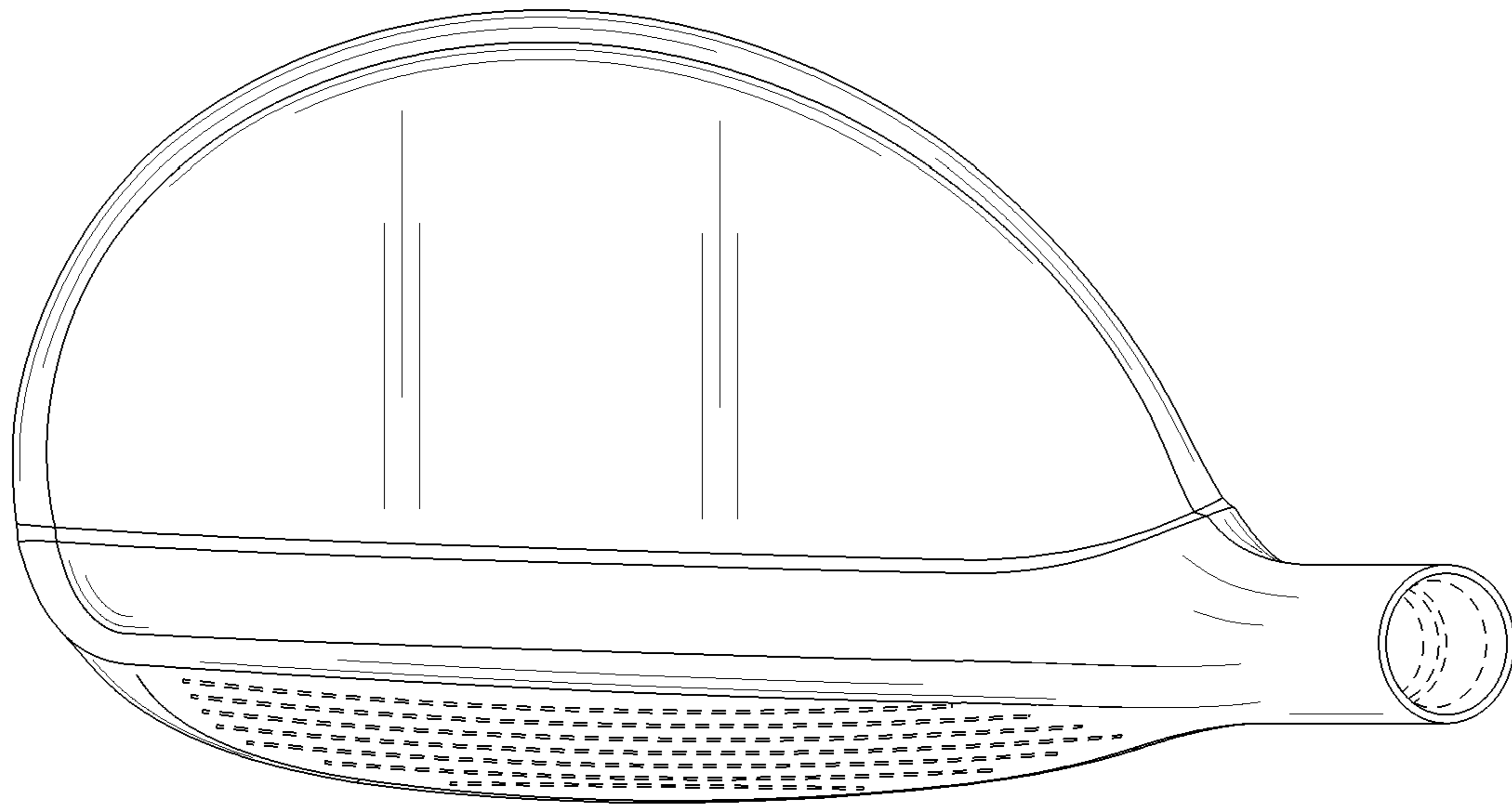

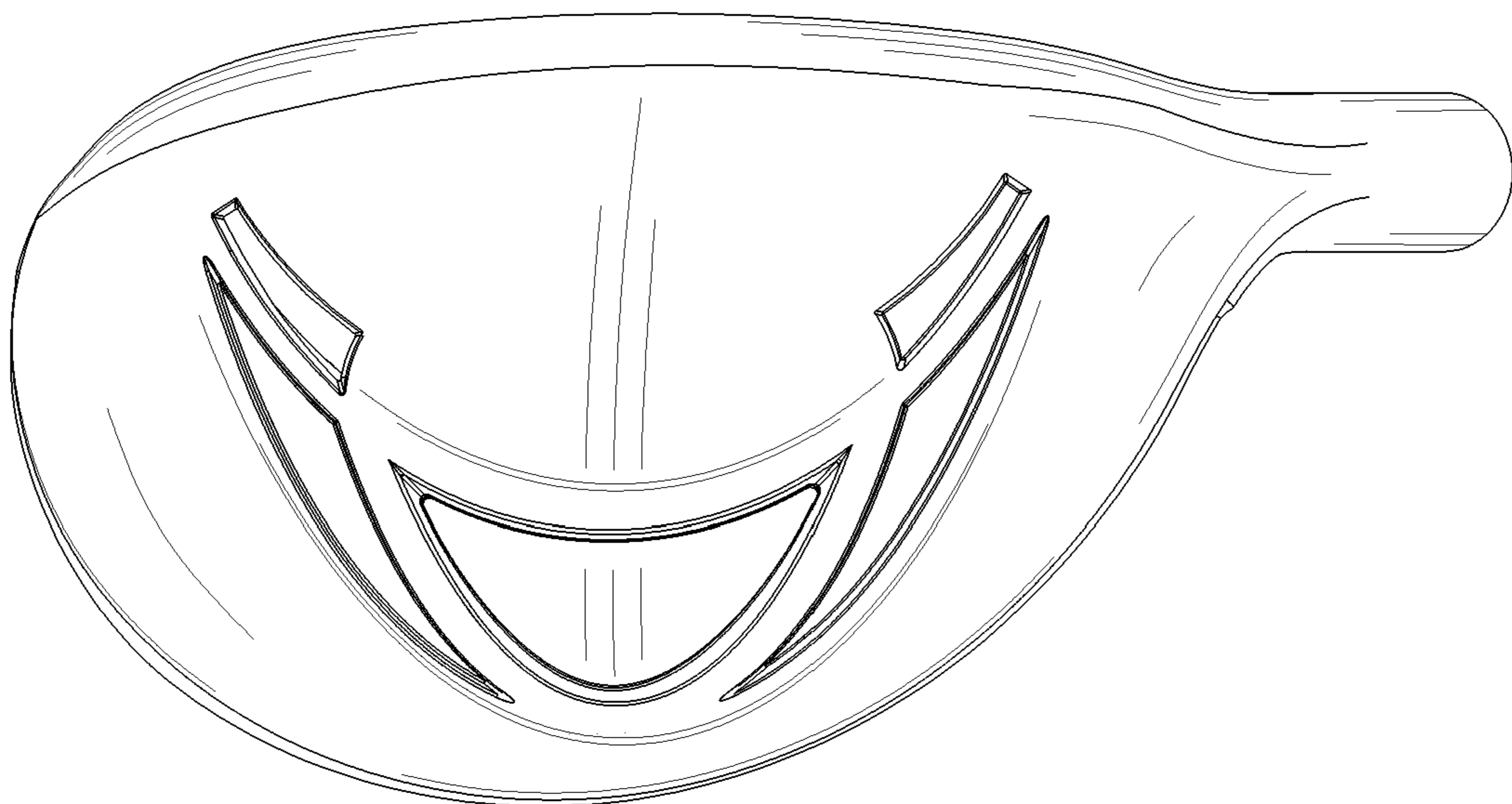


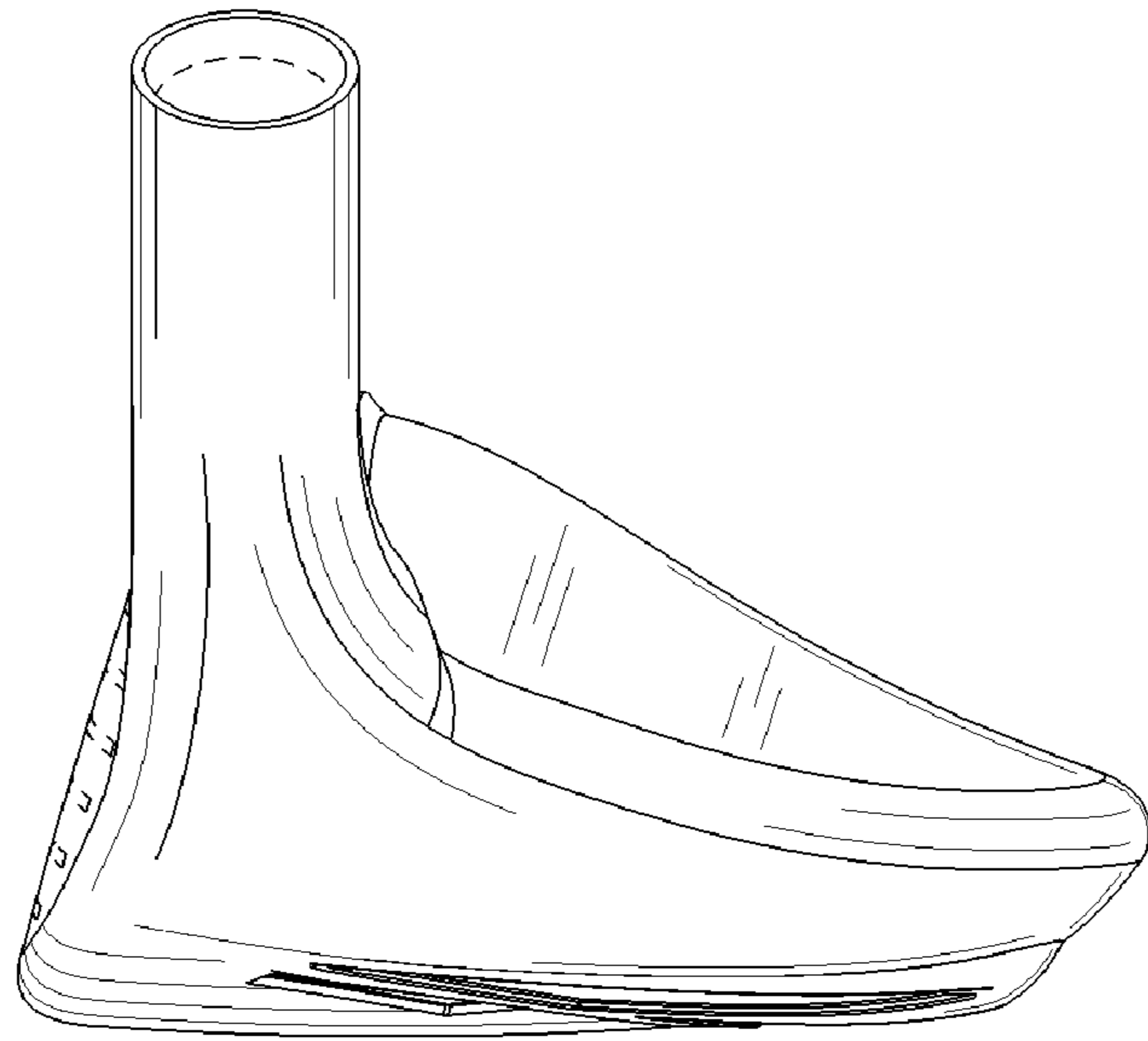

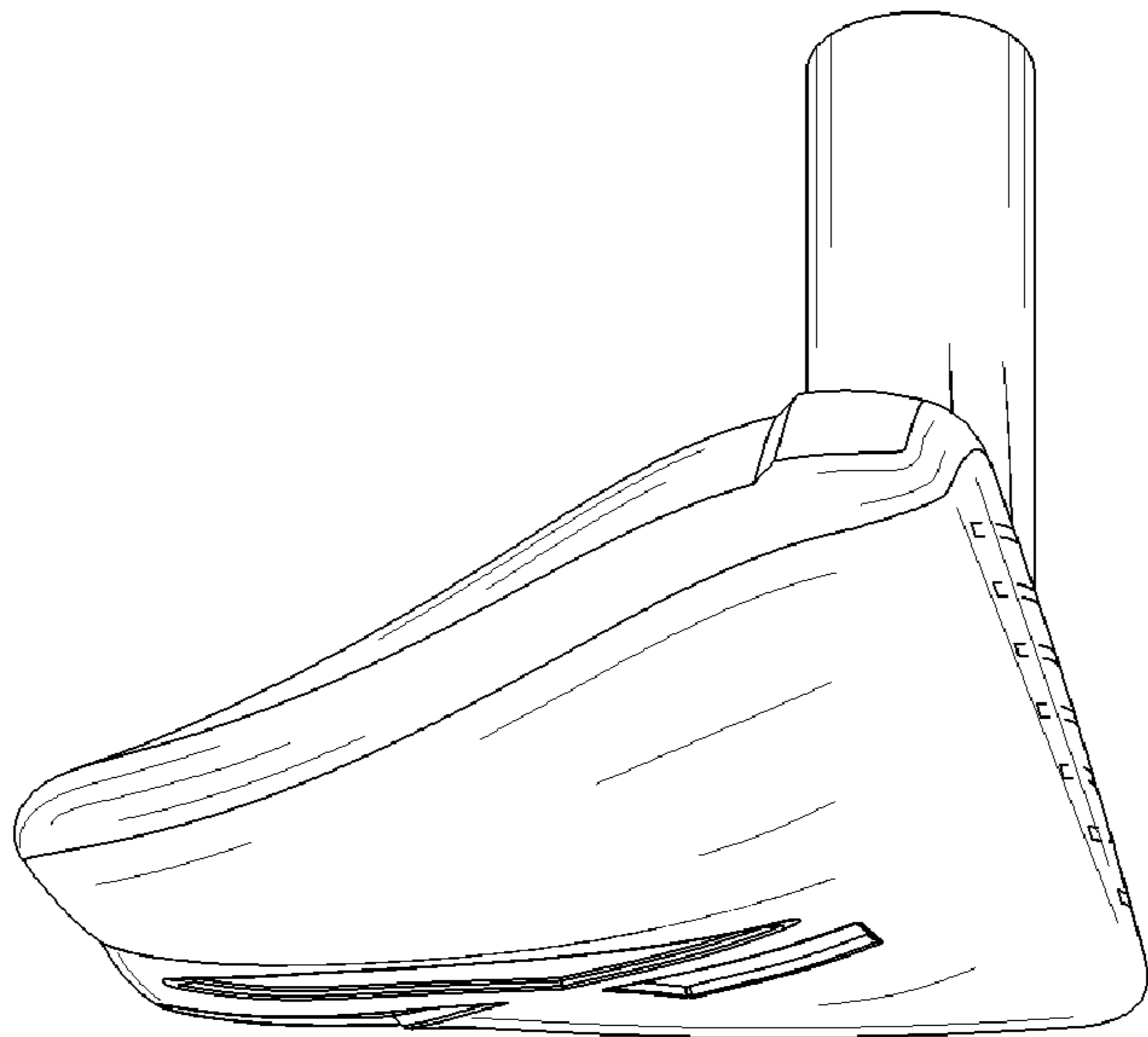
