FIG. 1 is a bottom perspective view of the invention with two runners;

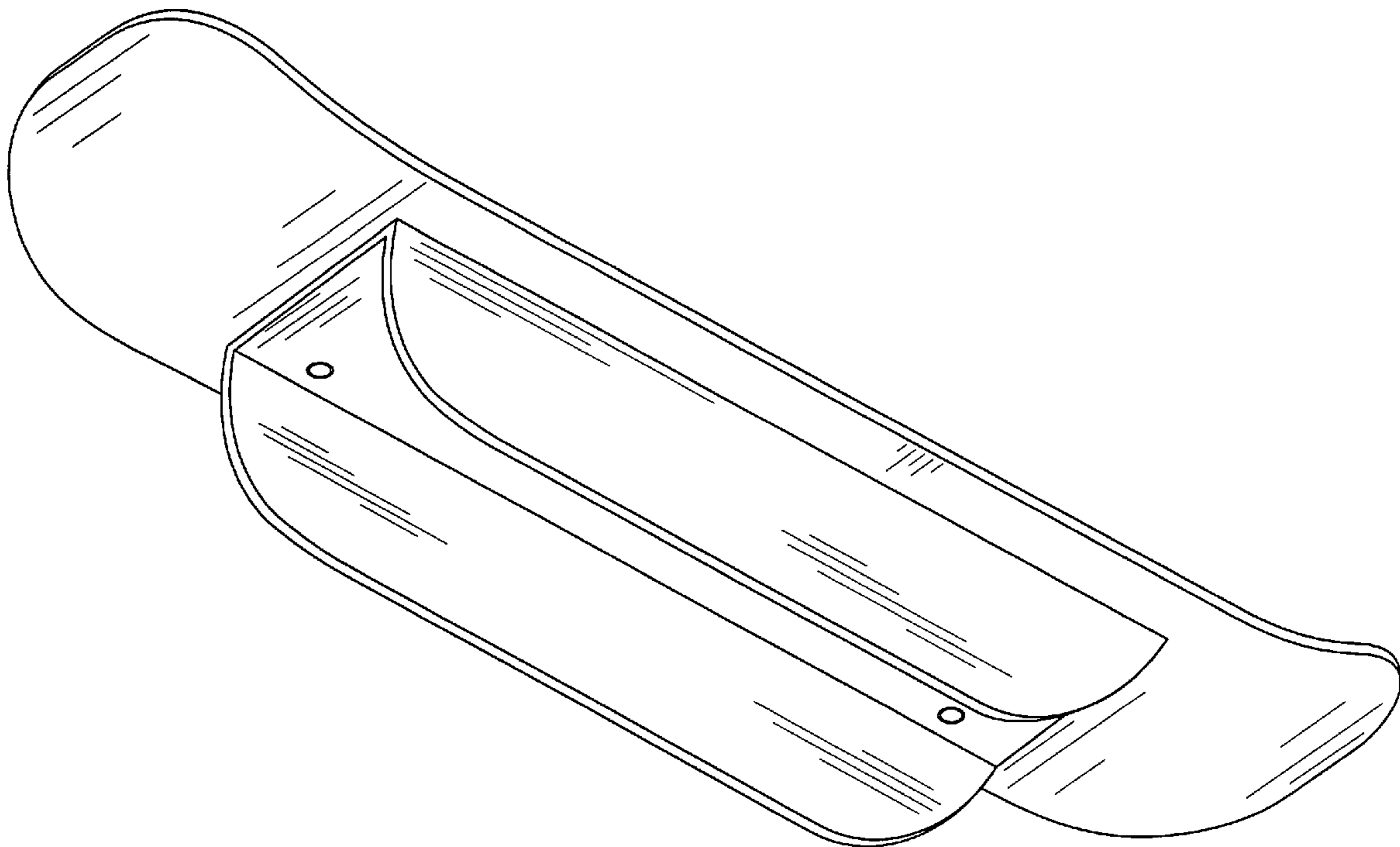
FIG. 2 is a right side view of the invention which is a mirror image of the left side view of the invention;

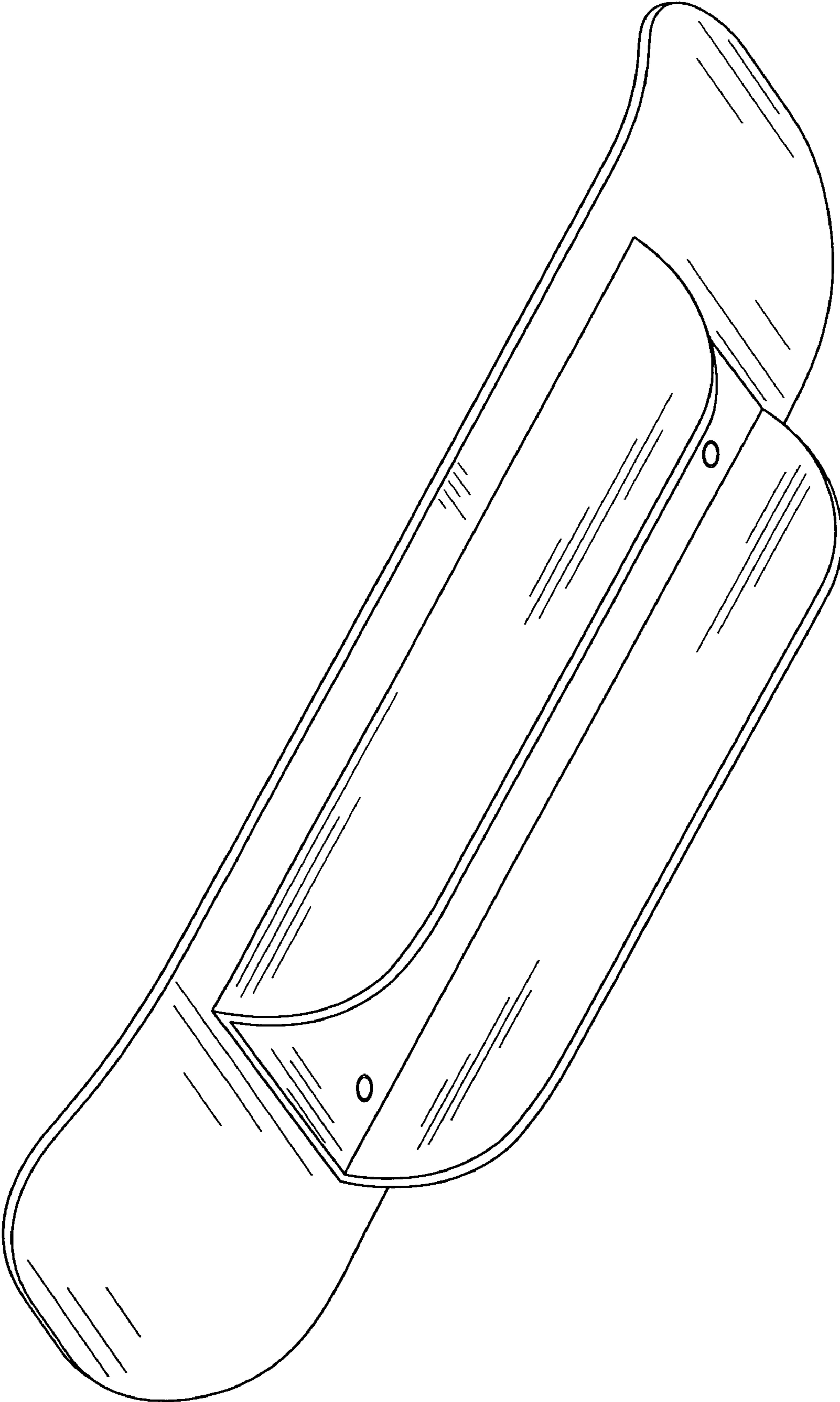

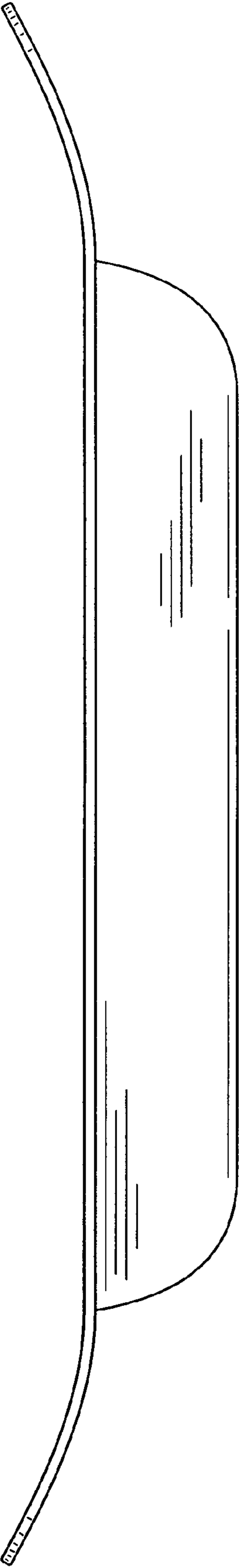

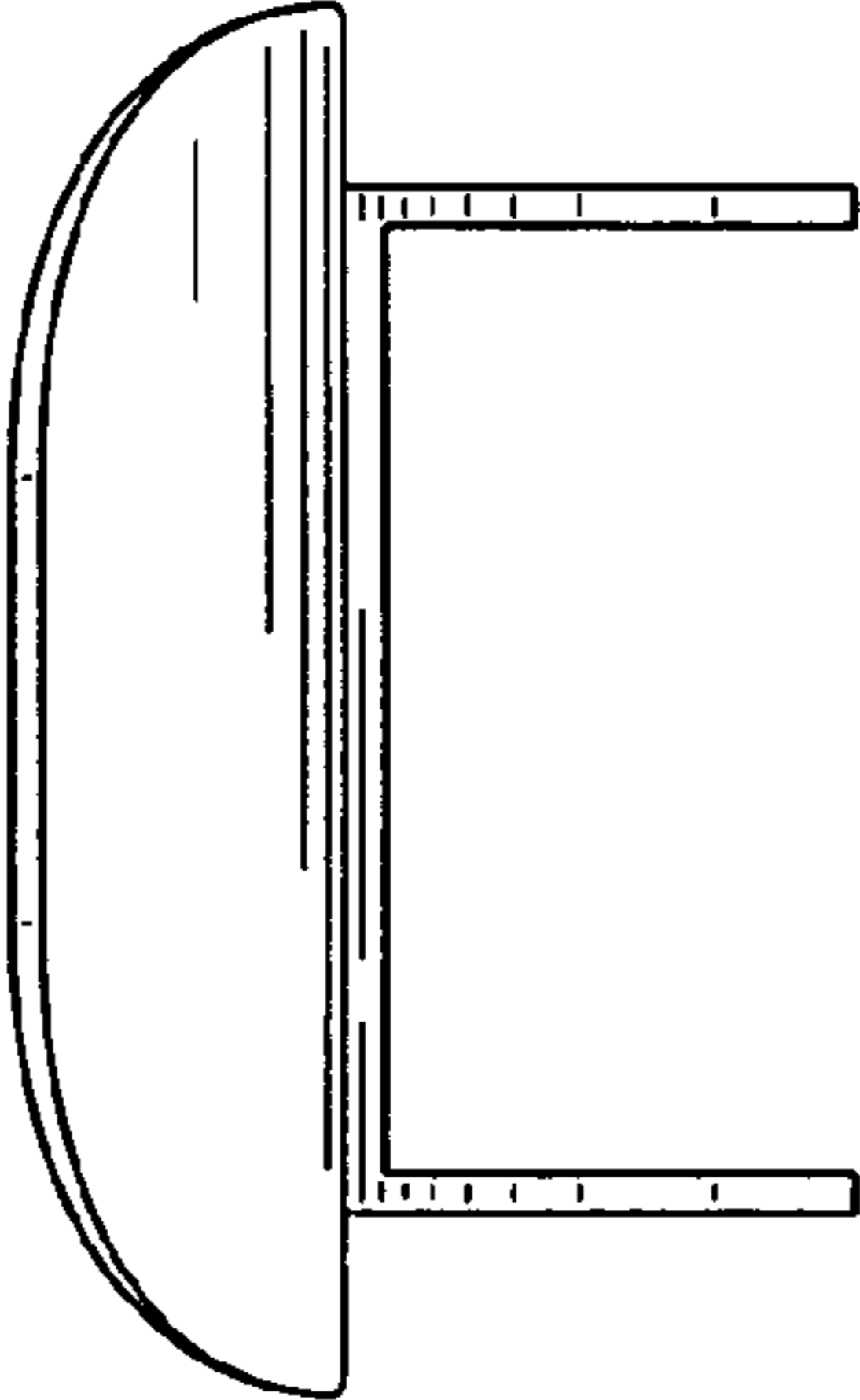

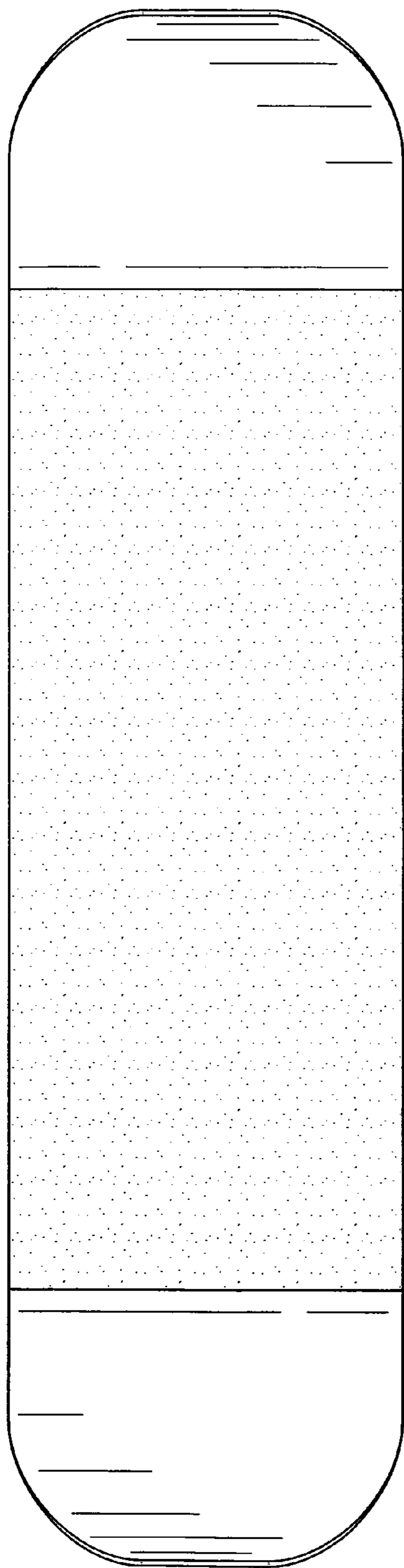

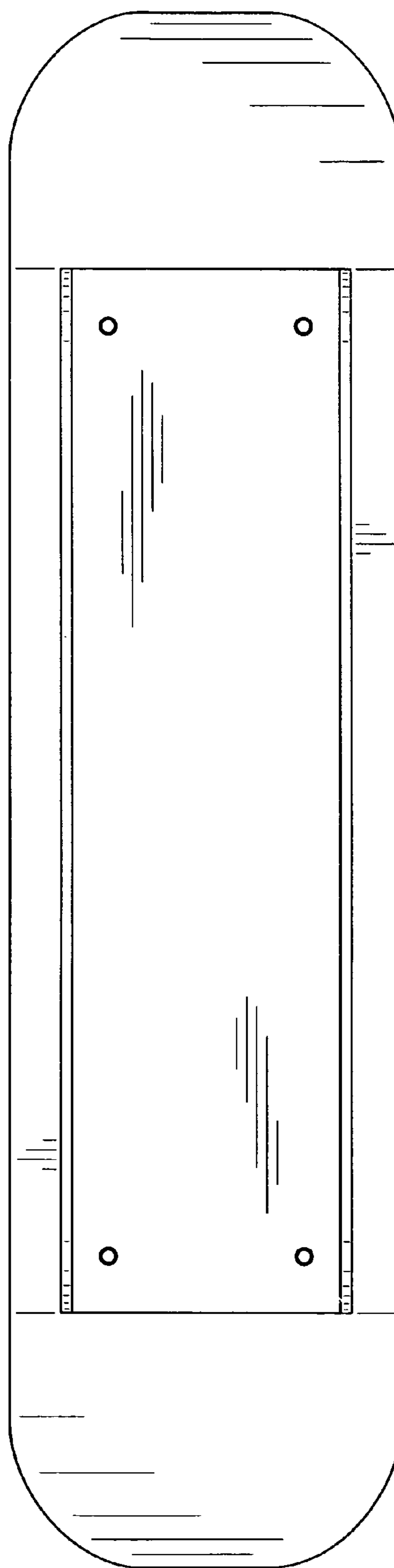
