FIG. 1 is a perspective view taken generally from the front of a hang tag air freshener showing my new design;

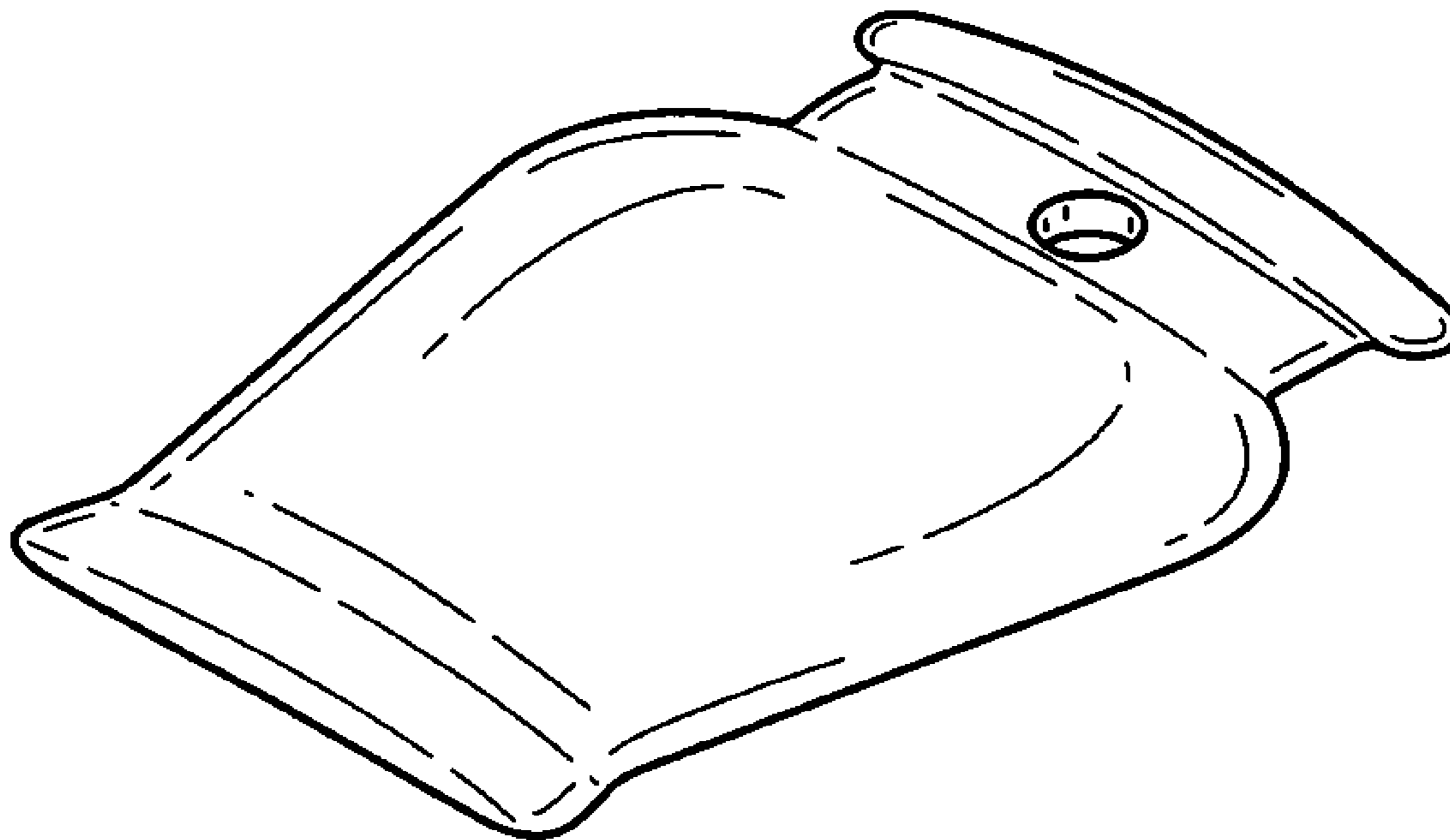
FIG. 2 is a front elevational view thereof with the opposite side being a mirror image thereof;

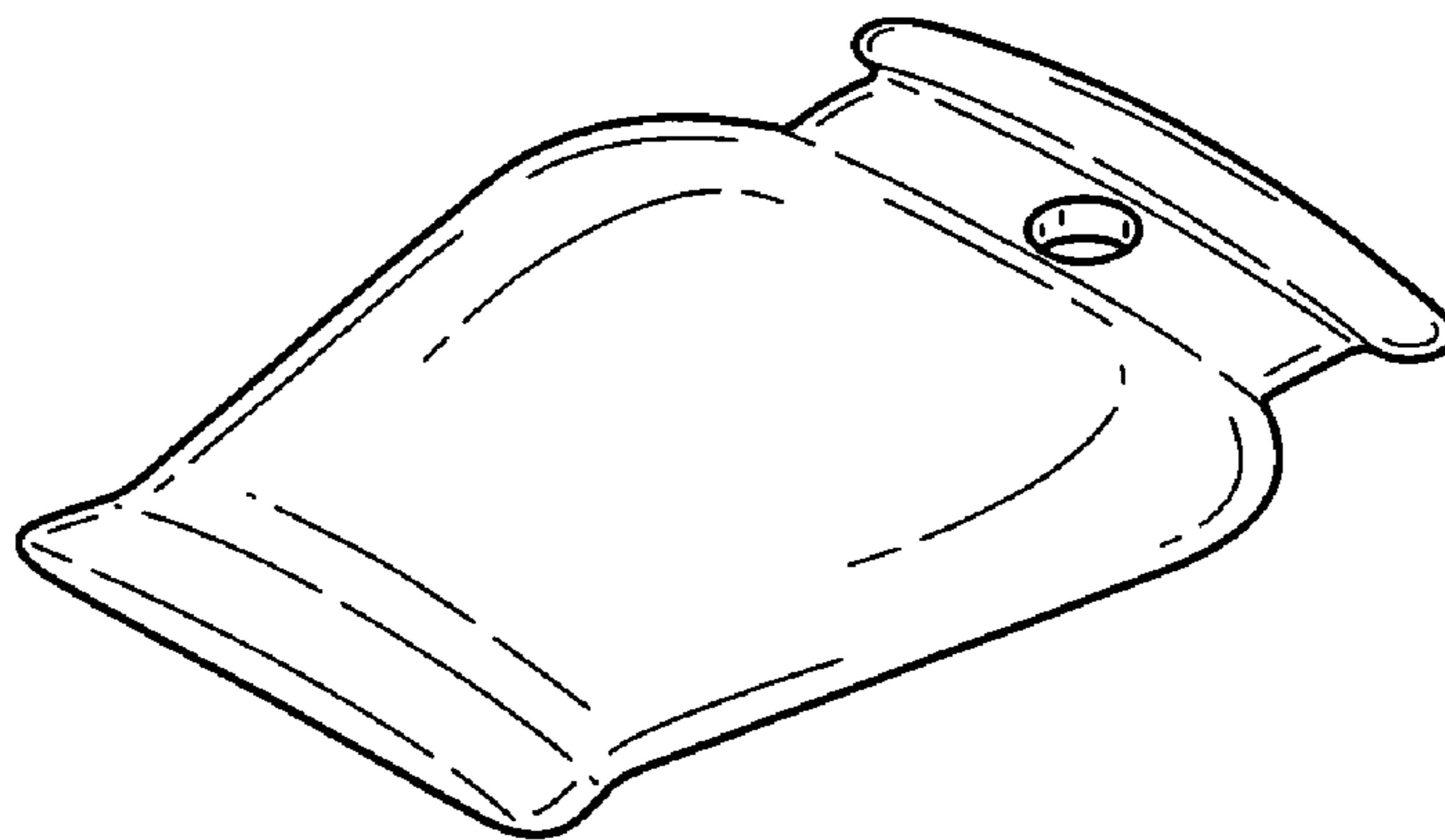

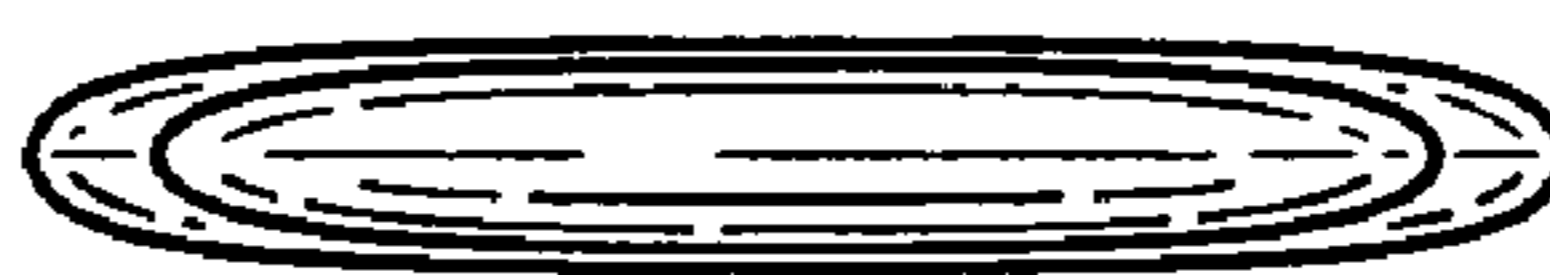

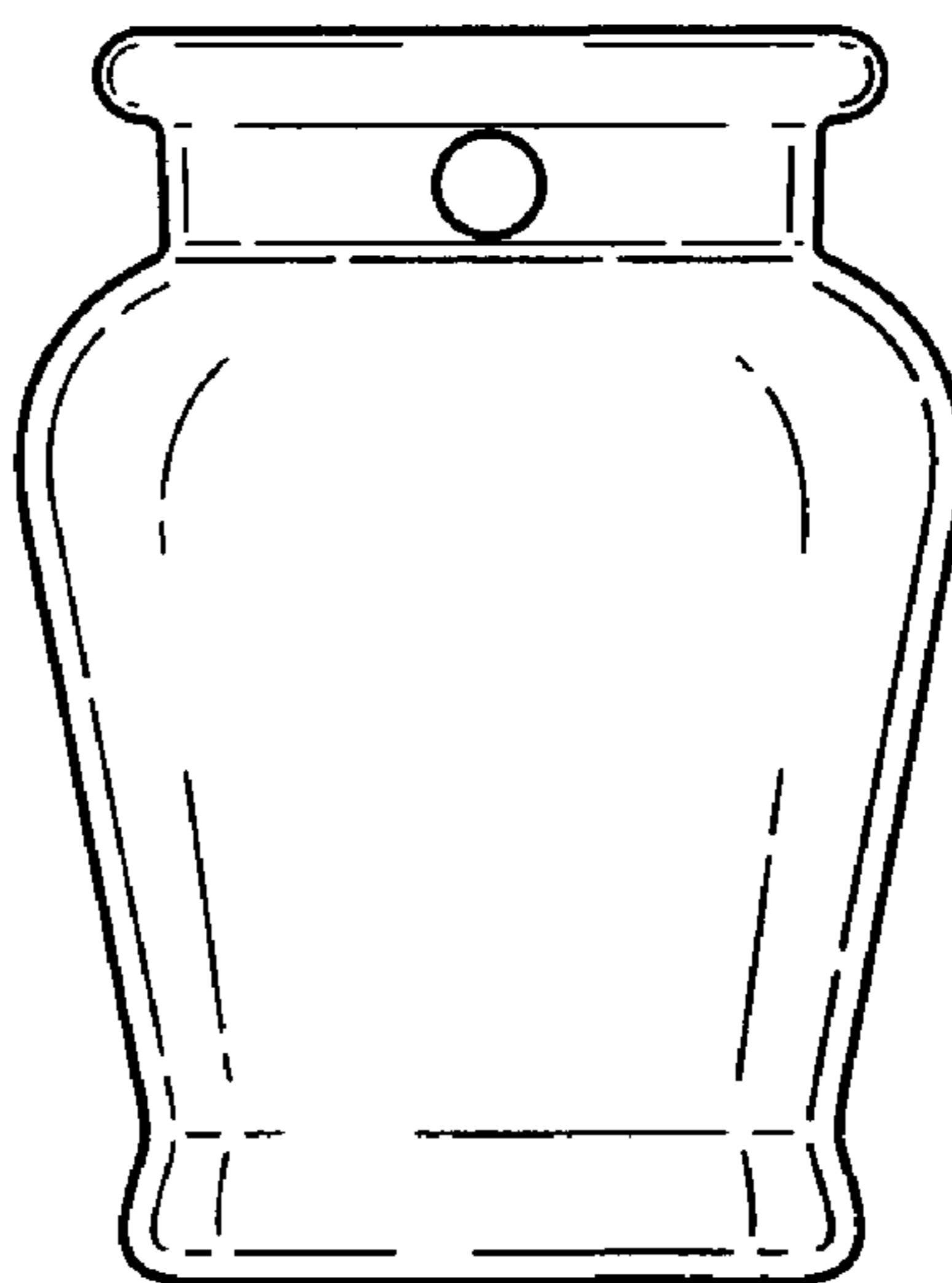

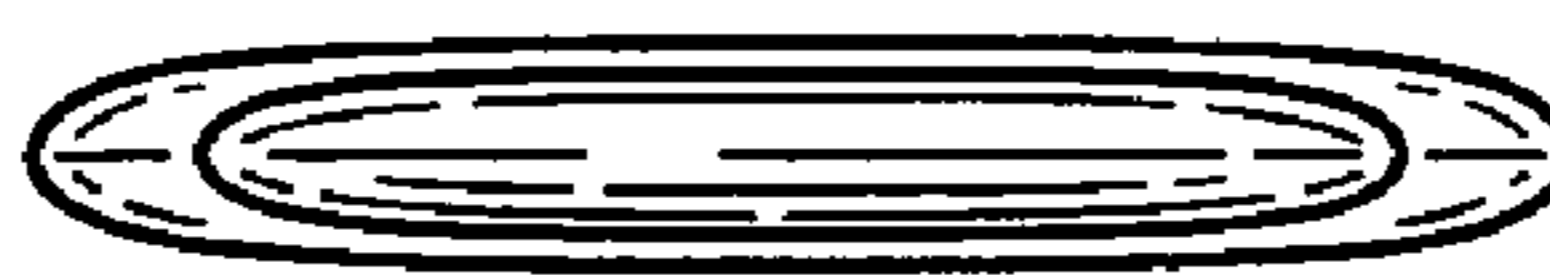
