FIG. 4 is a top view of the ultrasonic dental tip.

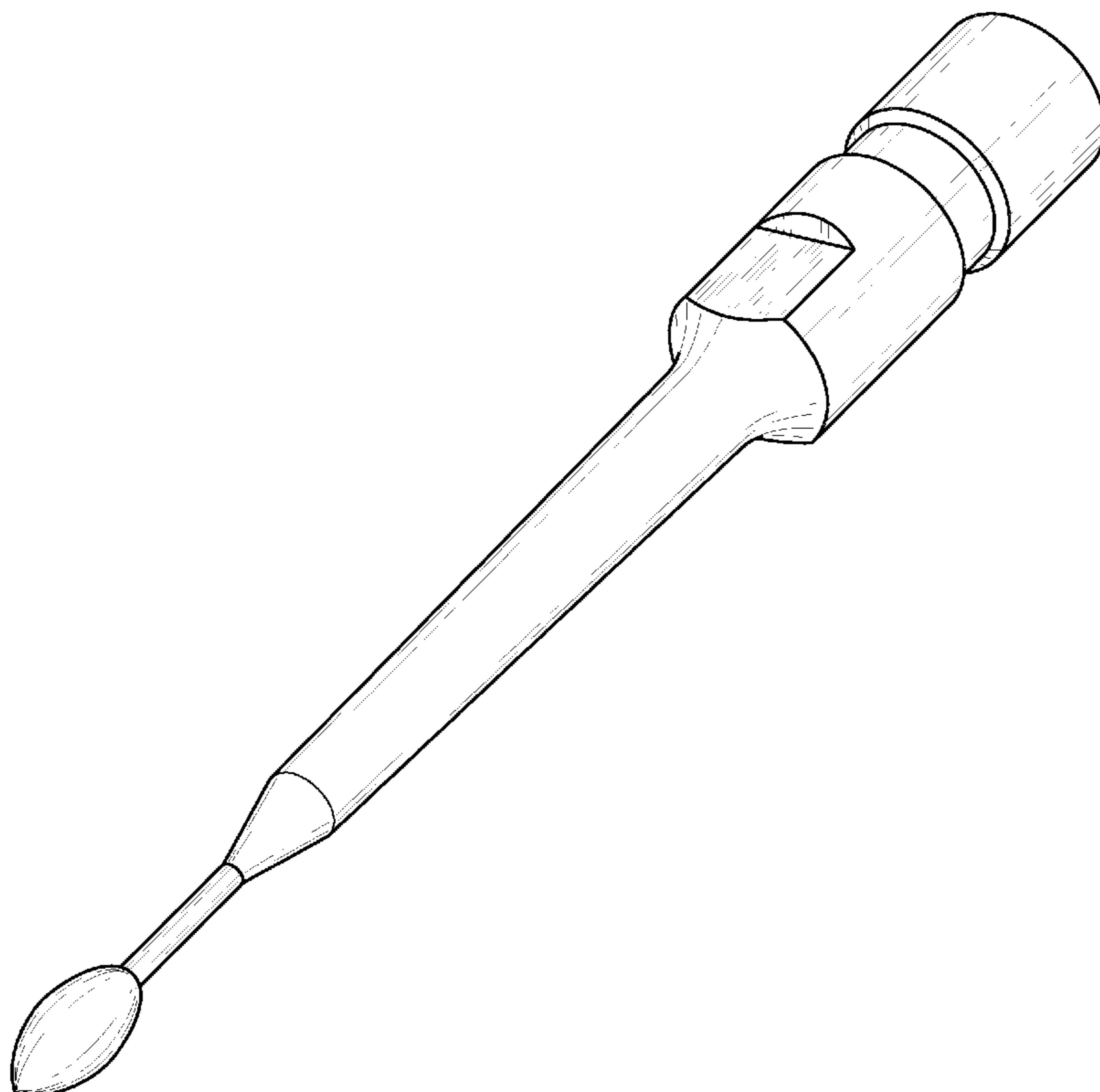
FIG. 5 is a bottom view of the ultrasonic dental tip.

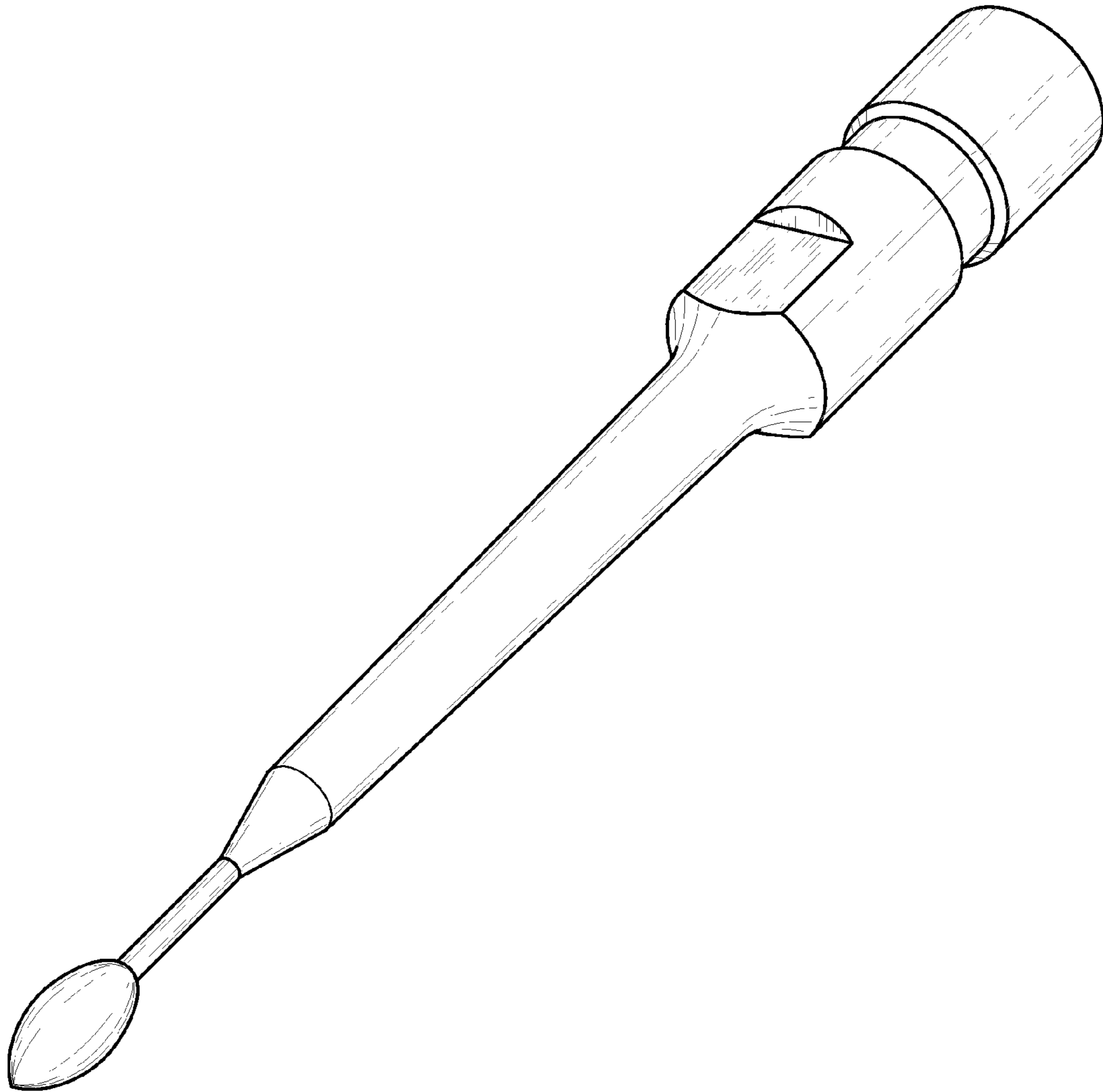
FIG. 6 is a front view of the ultrasonic dental tip; and,

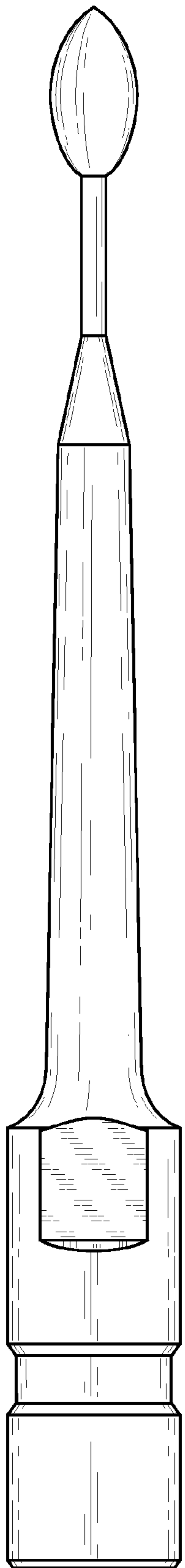

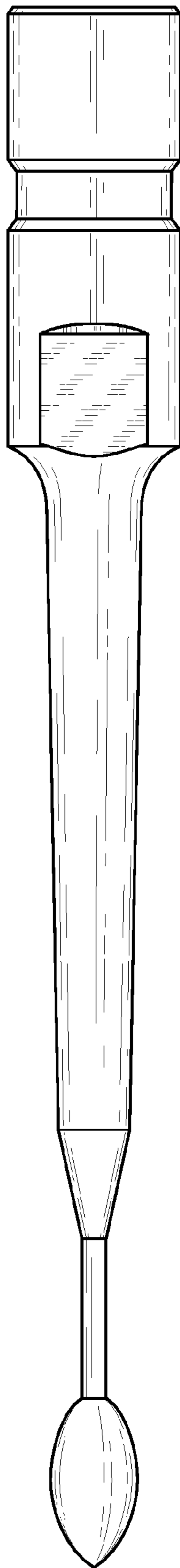

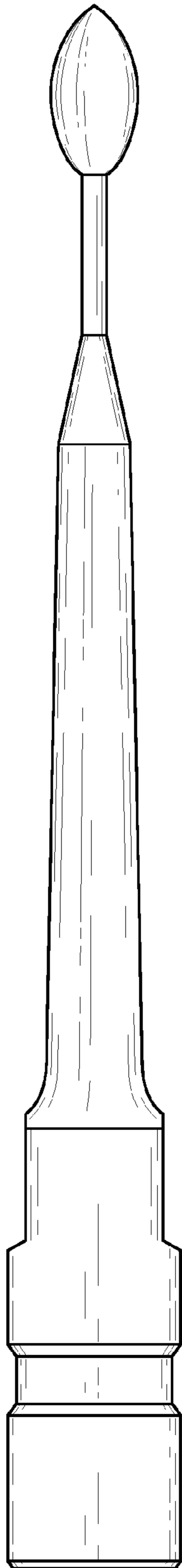

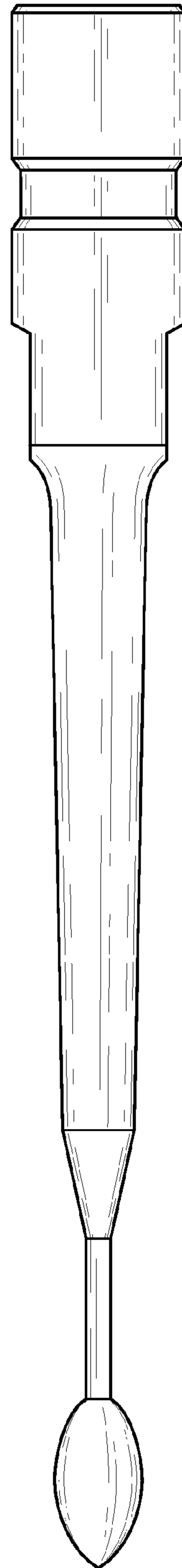
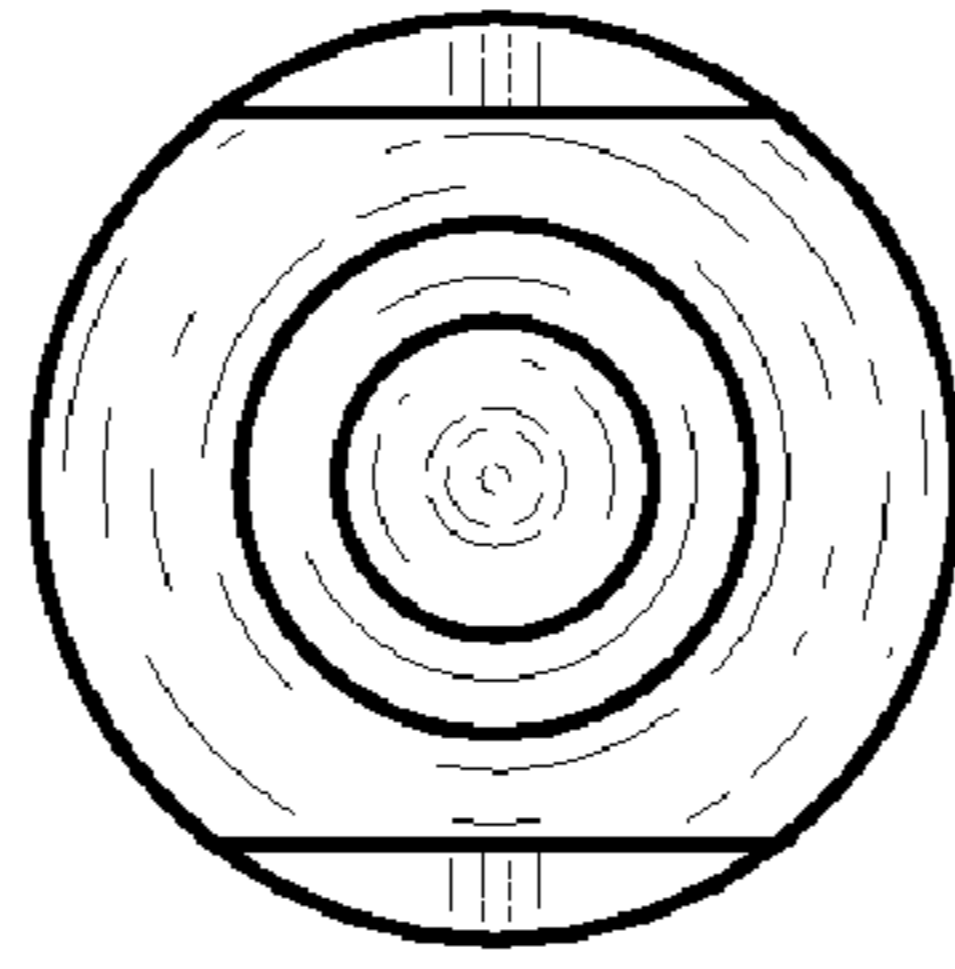
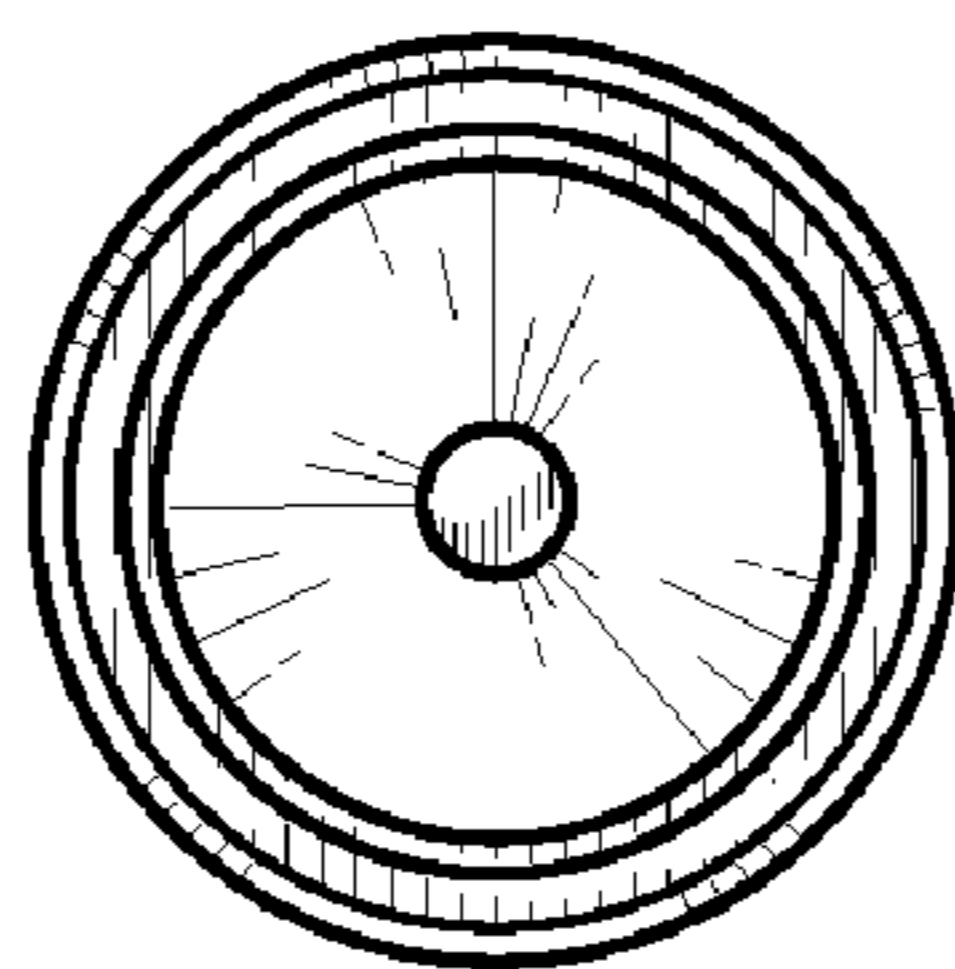
