FIG. 4 is a side view of the floor stripper;

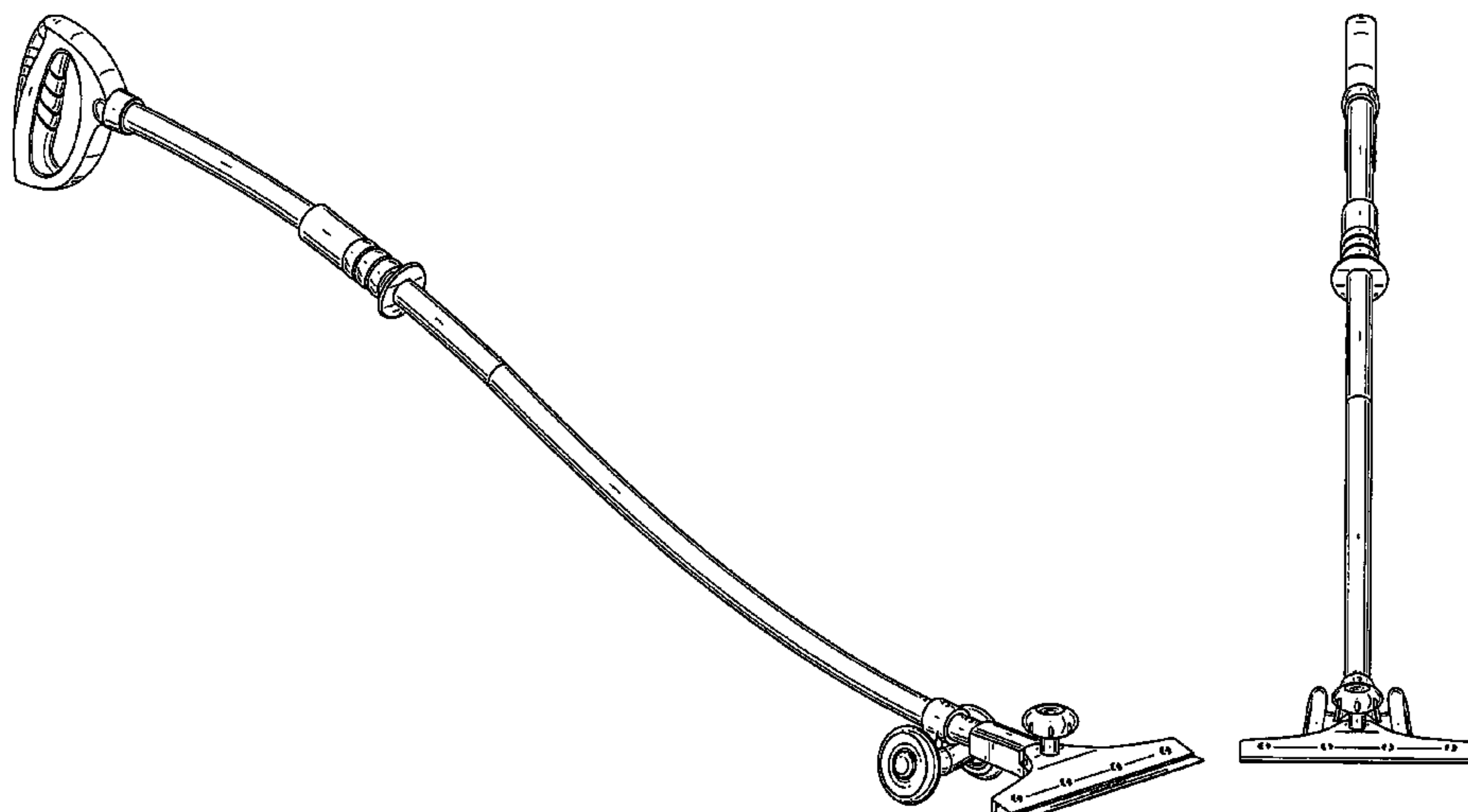
FIG. 5 is another side view of the floor stripper;

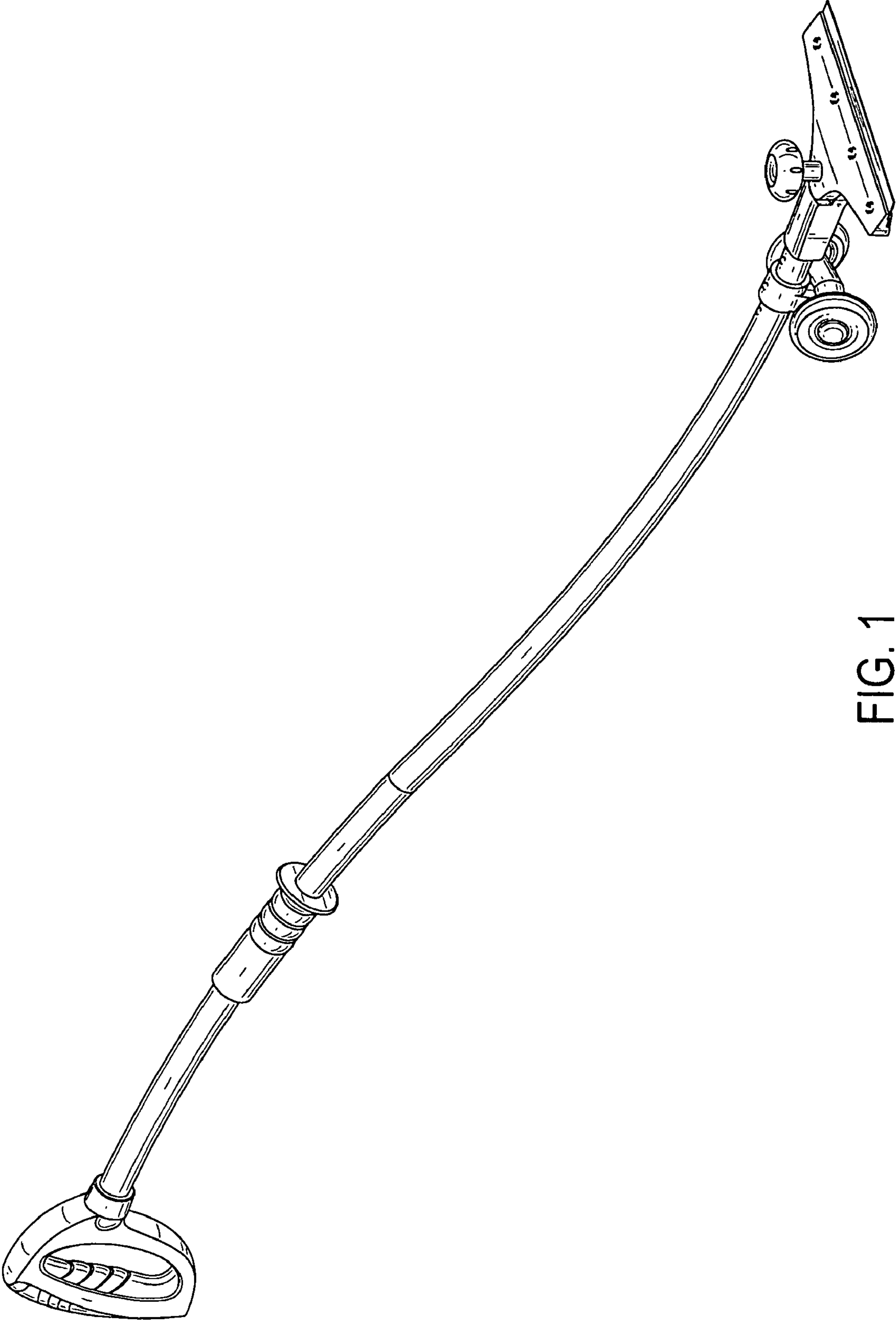

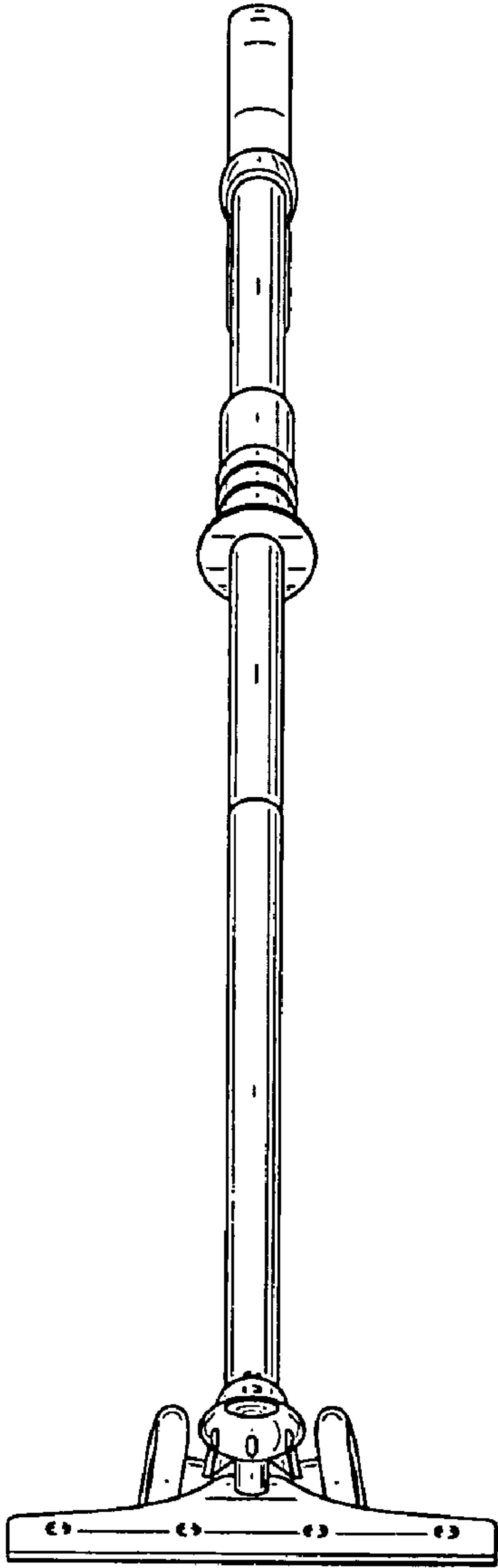

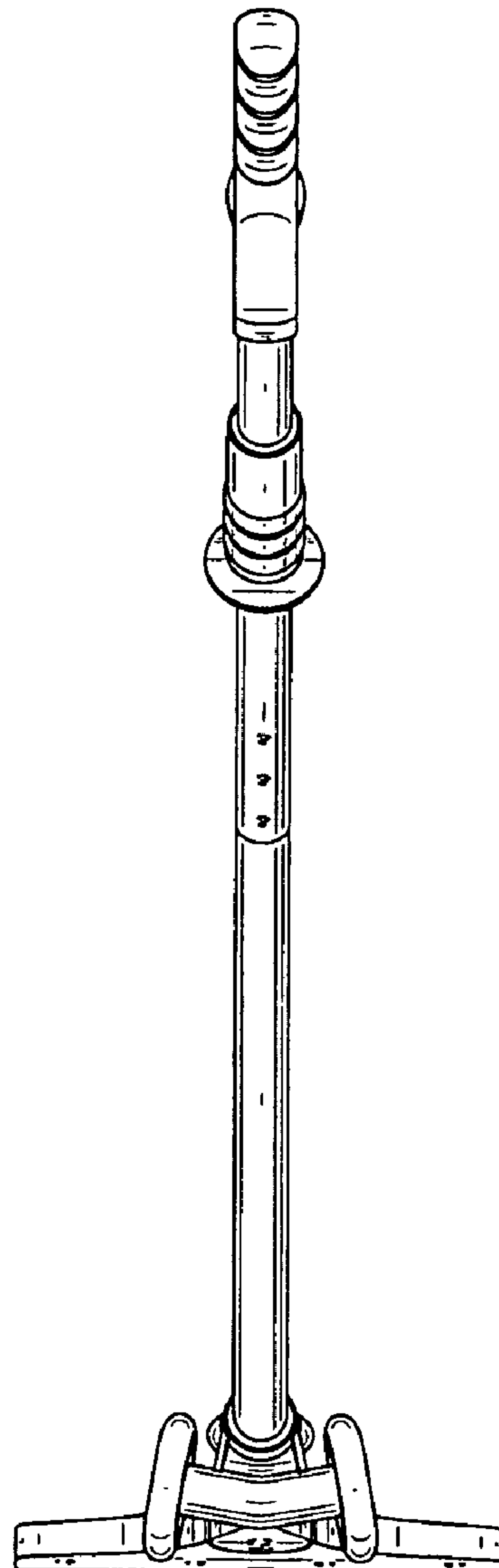

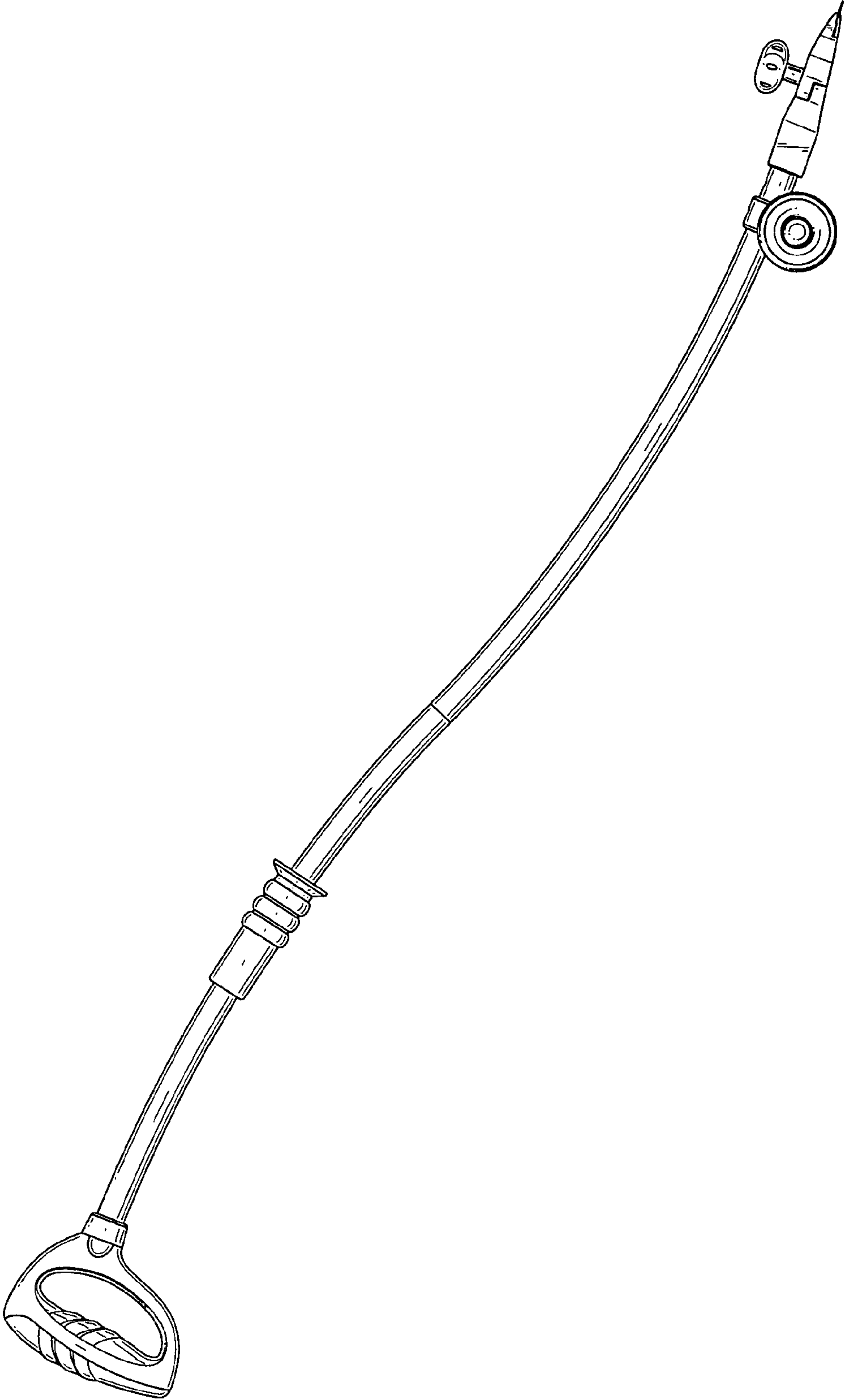

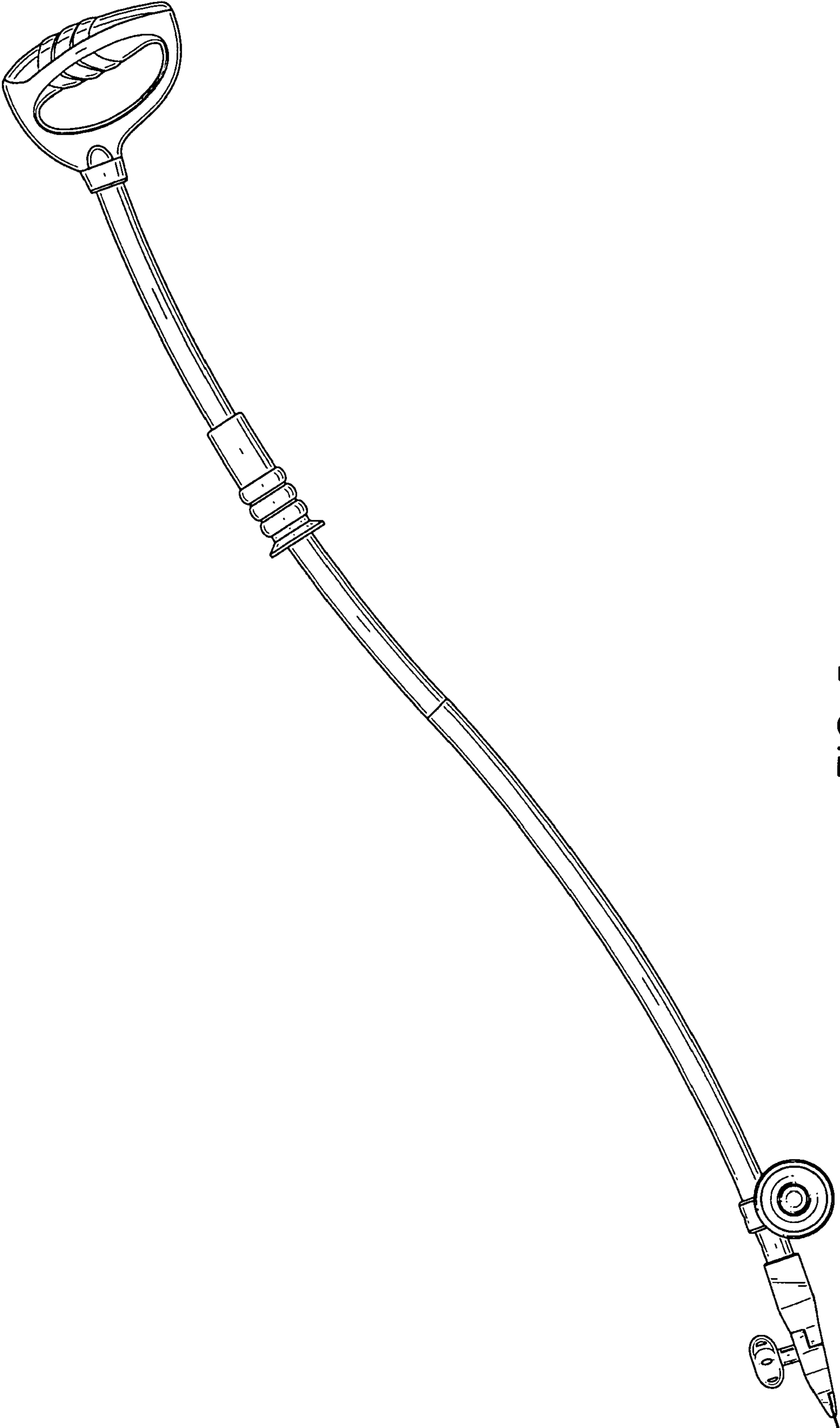

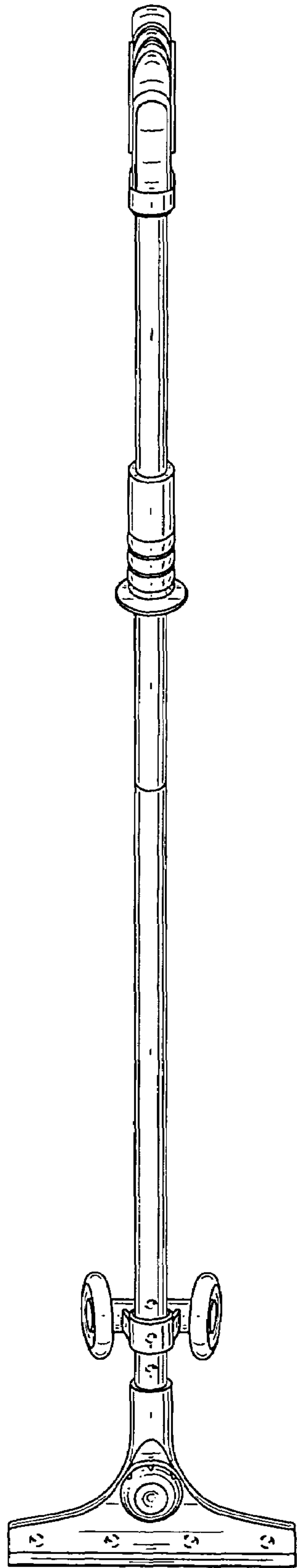

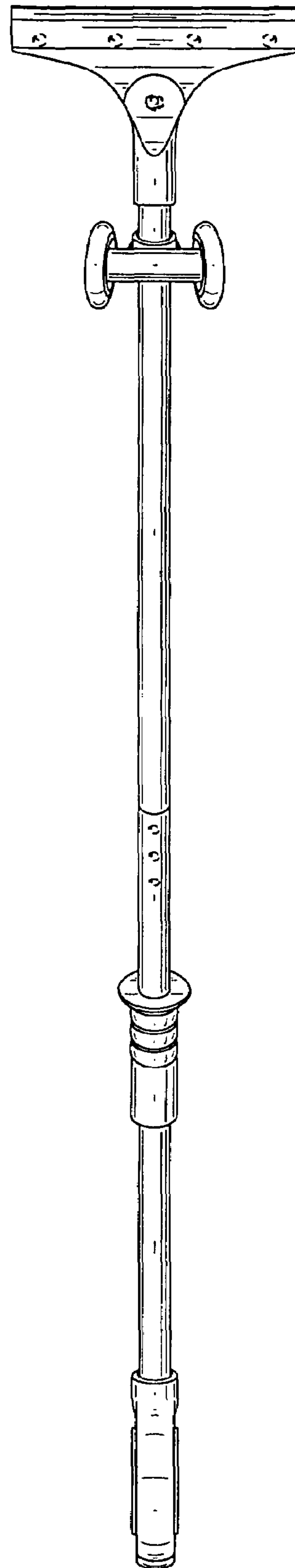
