(57) **CLAIM**

We claim the ornamental design for footwear, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an article of footwear, showing our new design; and,

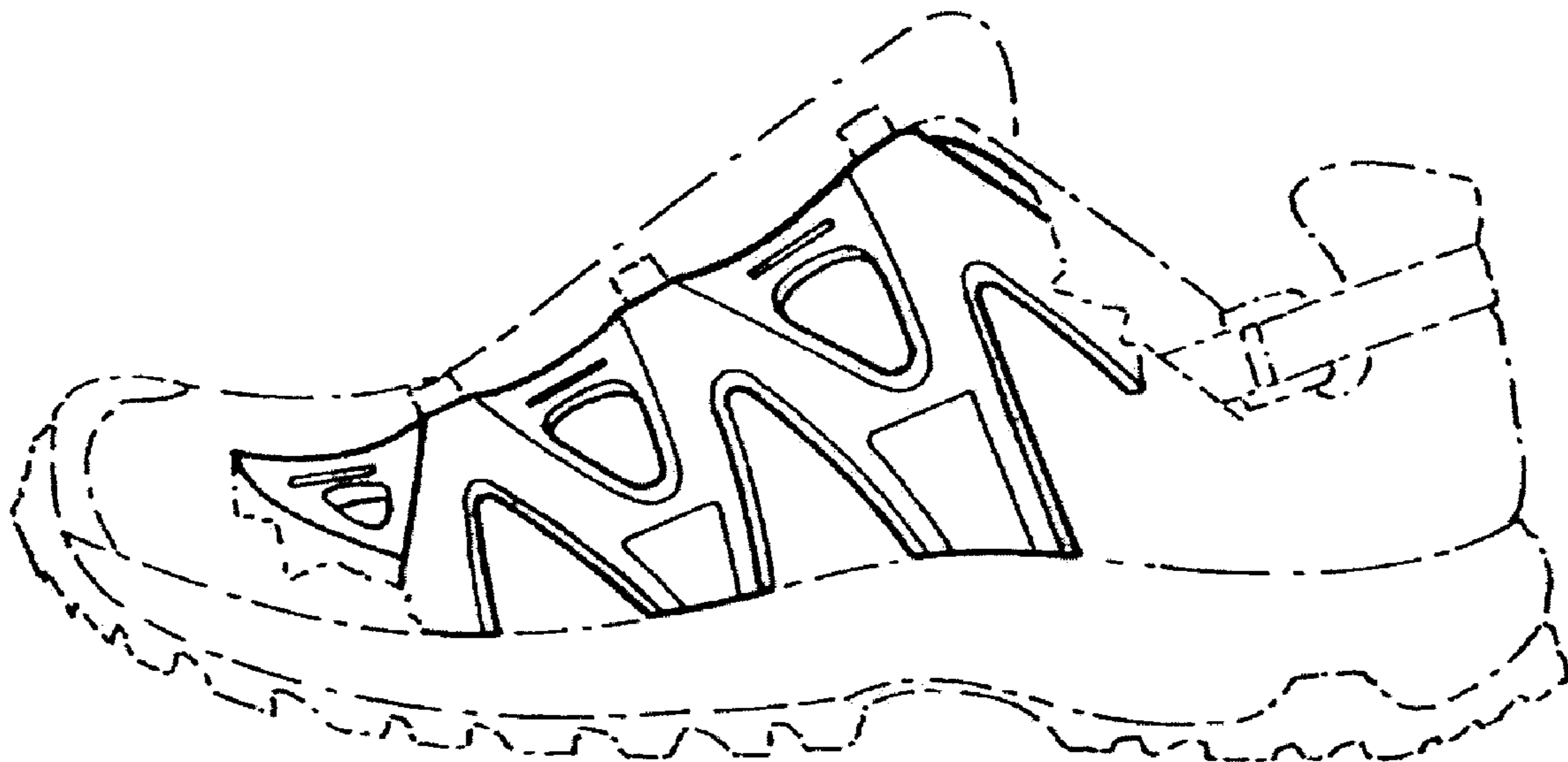
FIG. 2 is a side view thereof.

The two jagged broken lines in each of the drawing figures, each such line extending between two solid lines, represent unclaimed boundaries of the design.

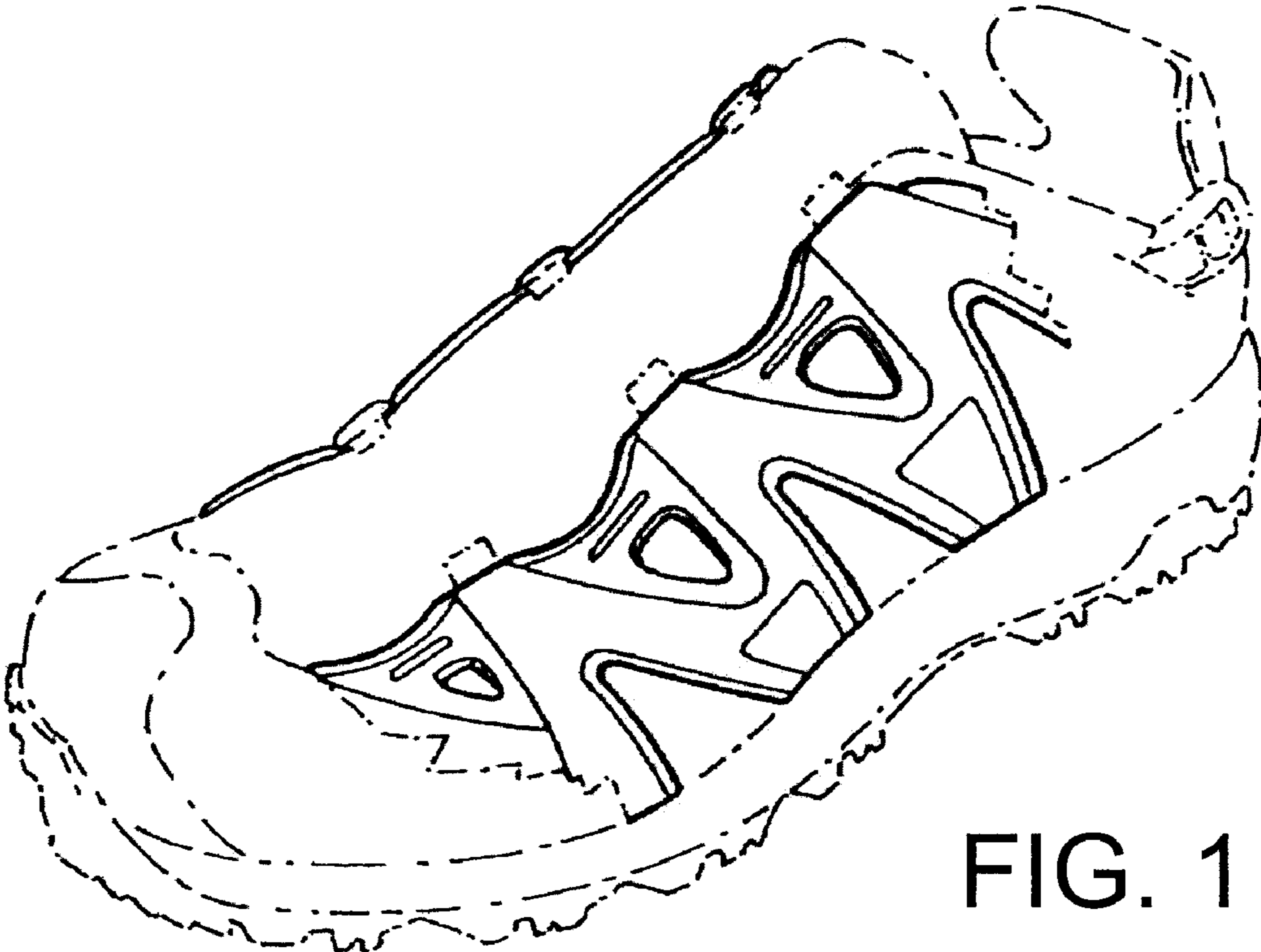

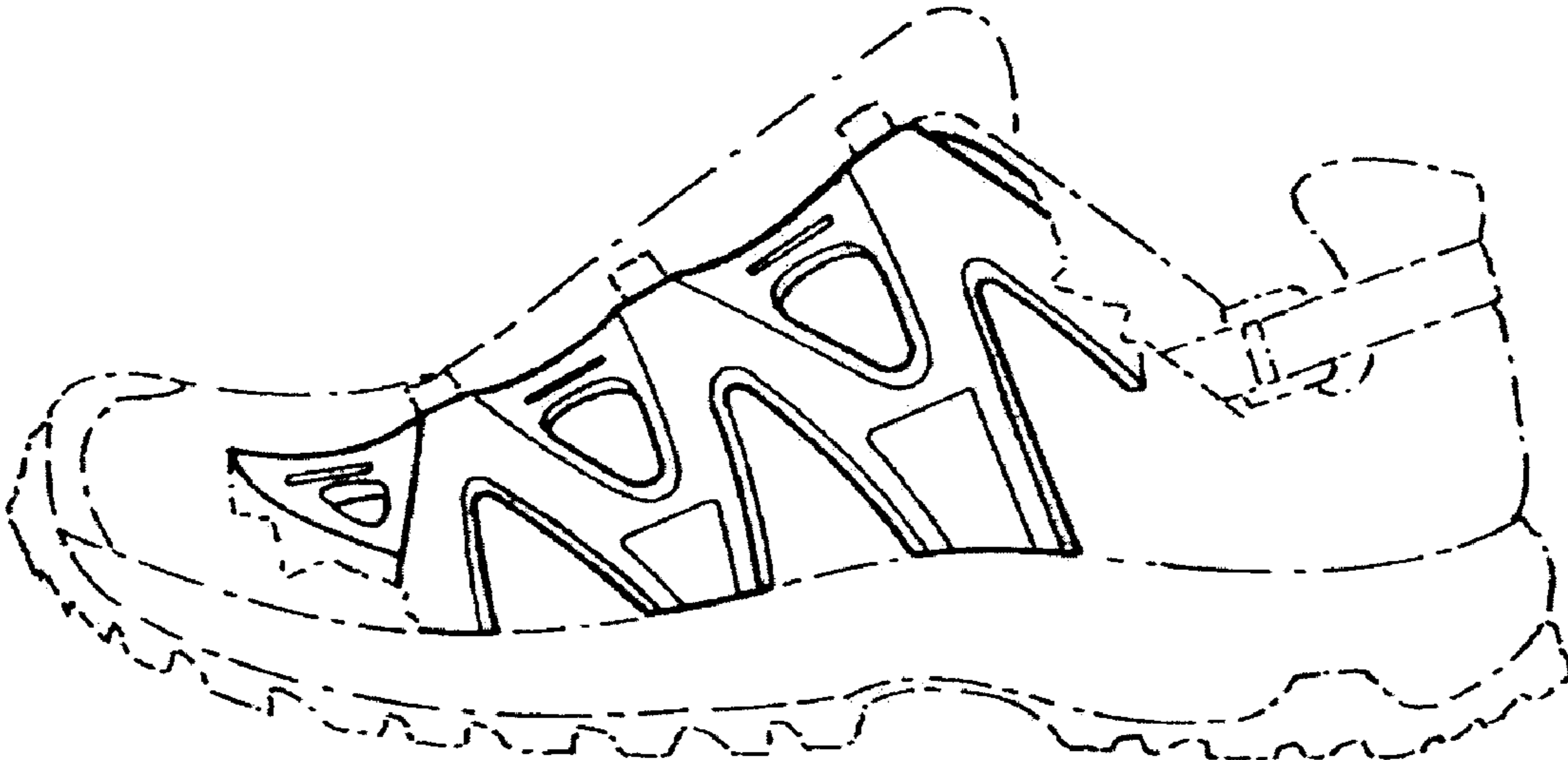
