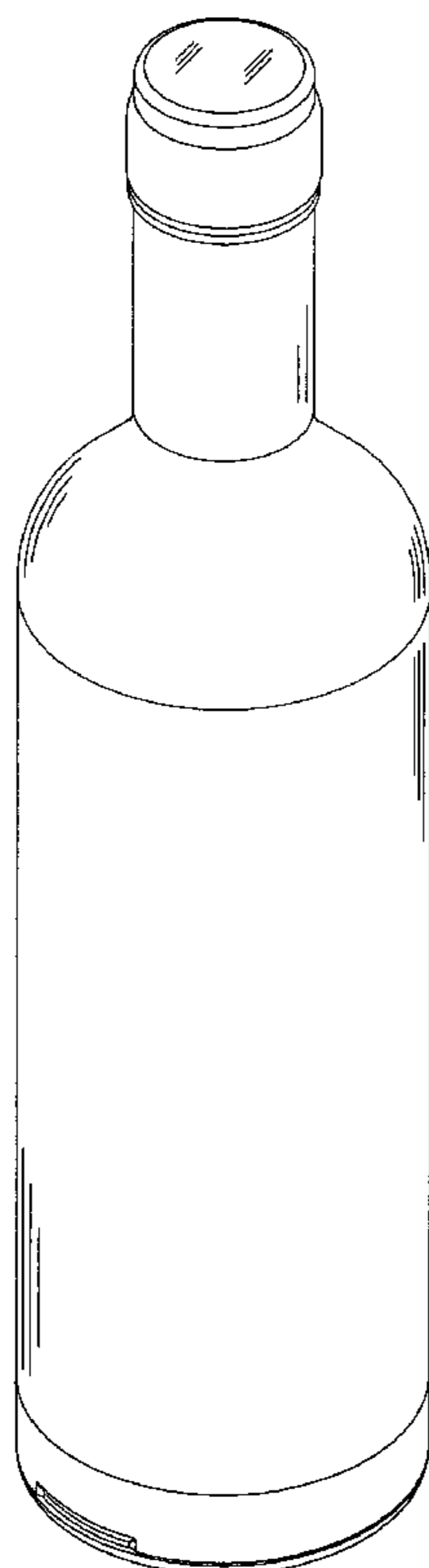
FIG. 8 is another perspective view thereof showing the case being detached from the umbrella;

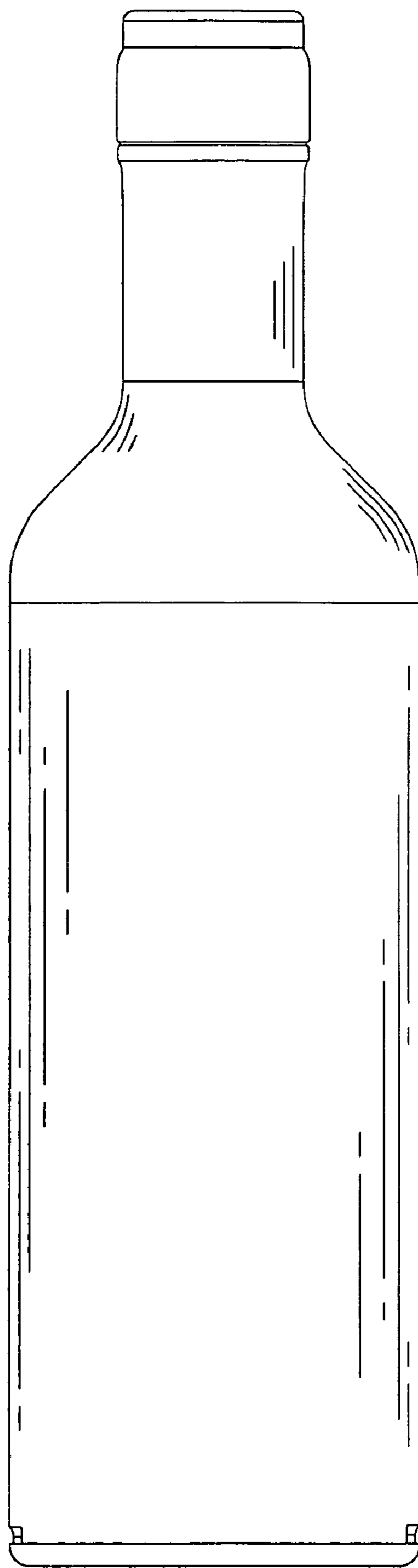

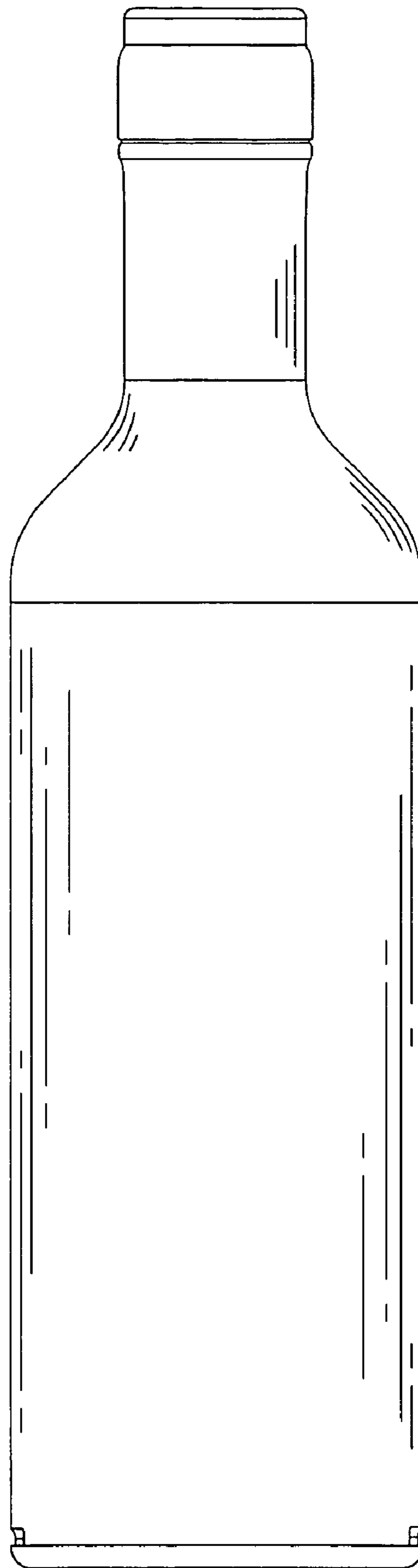

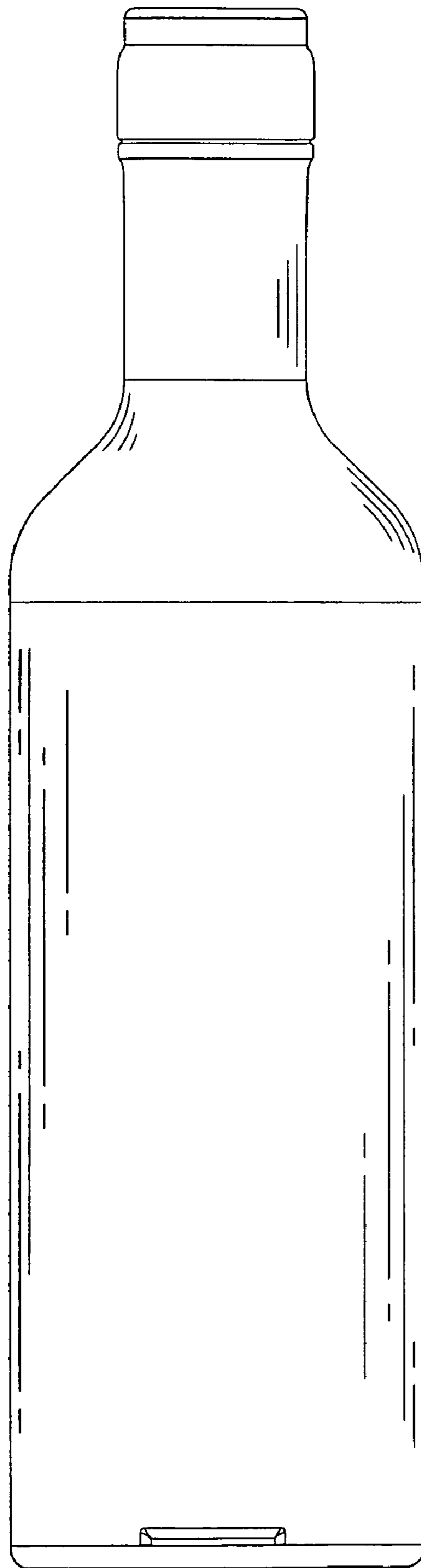

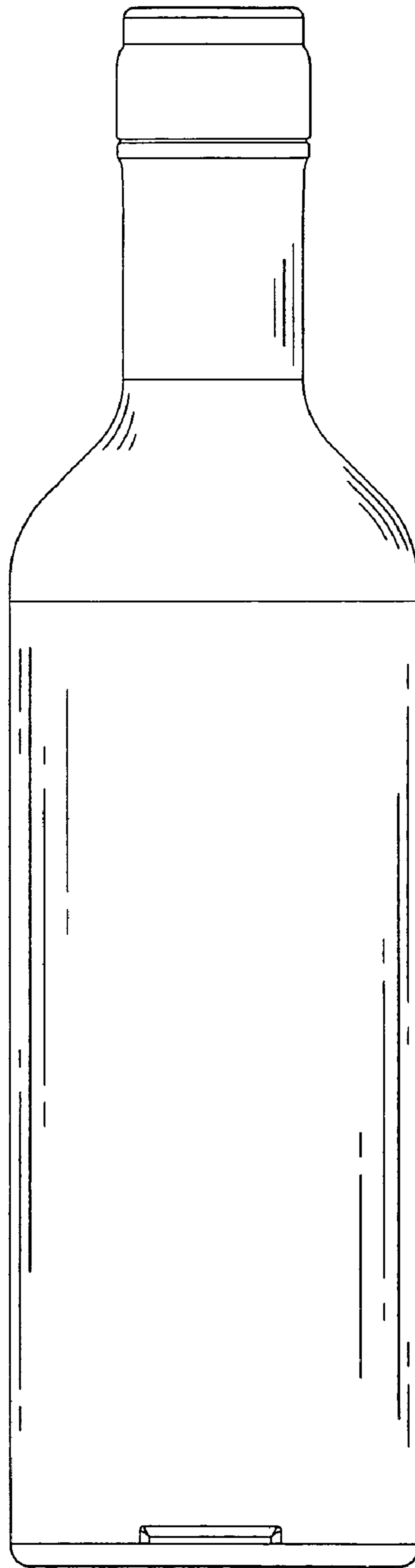

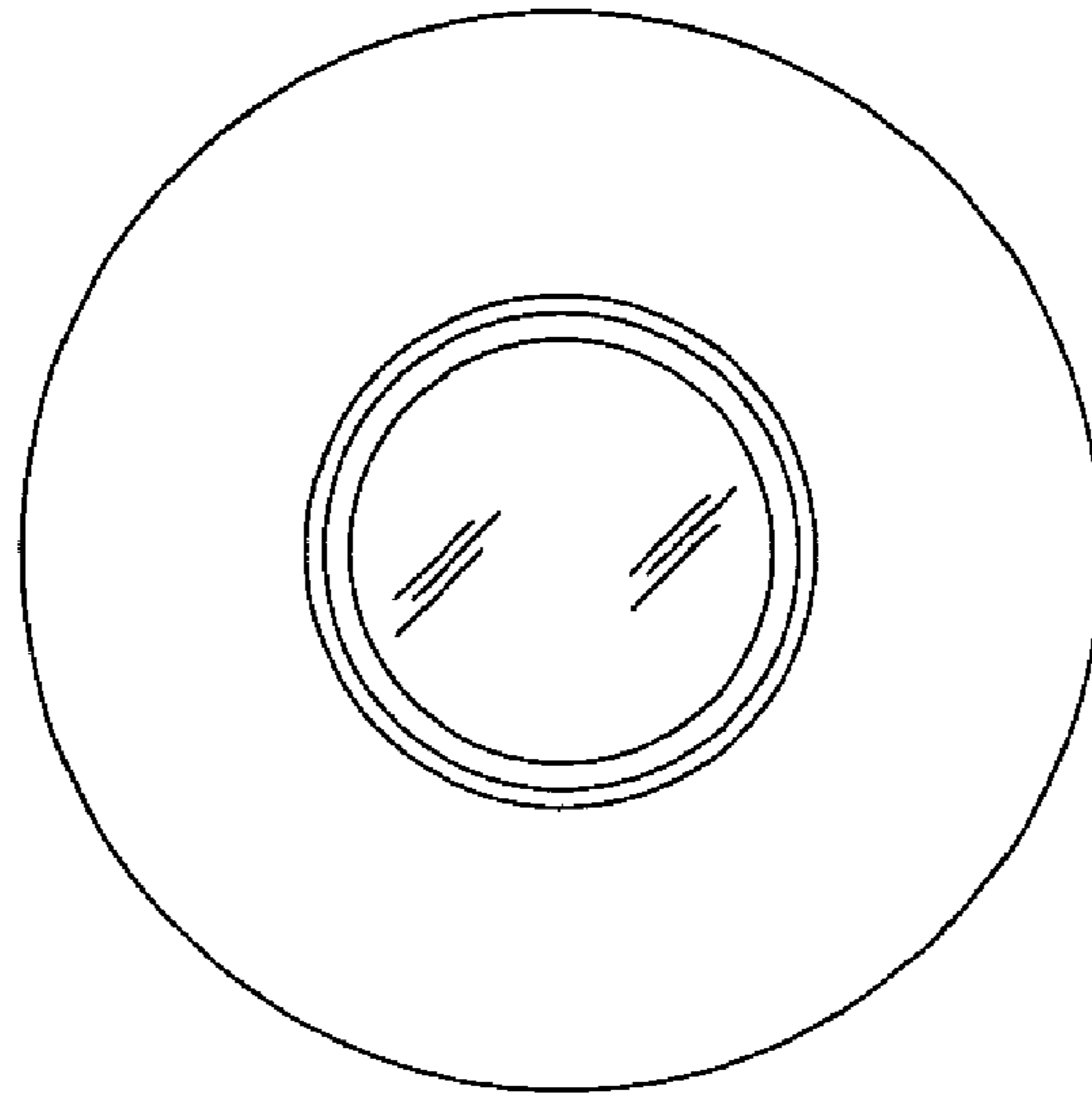

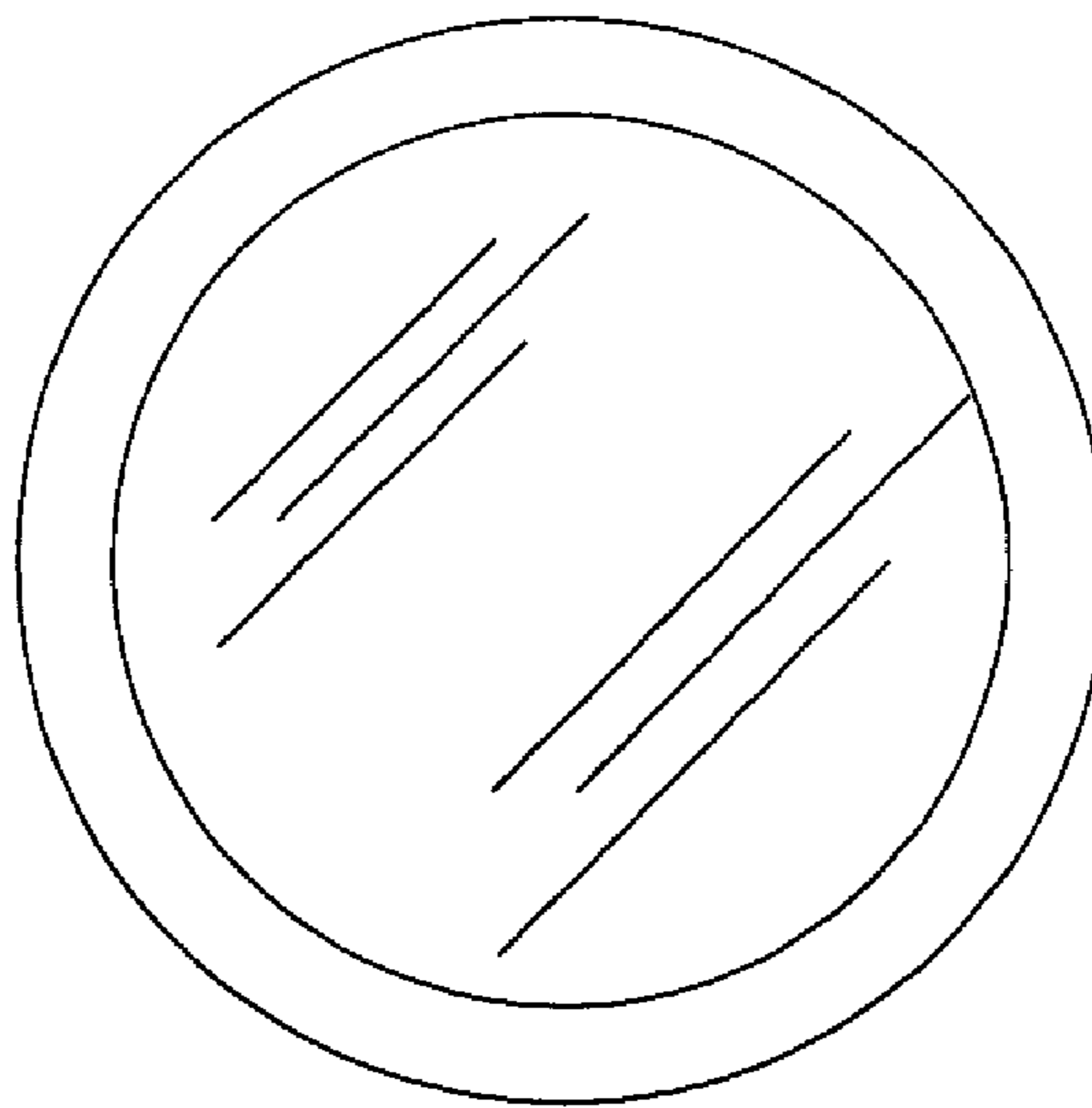

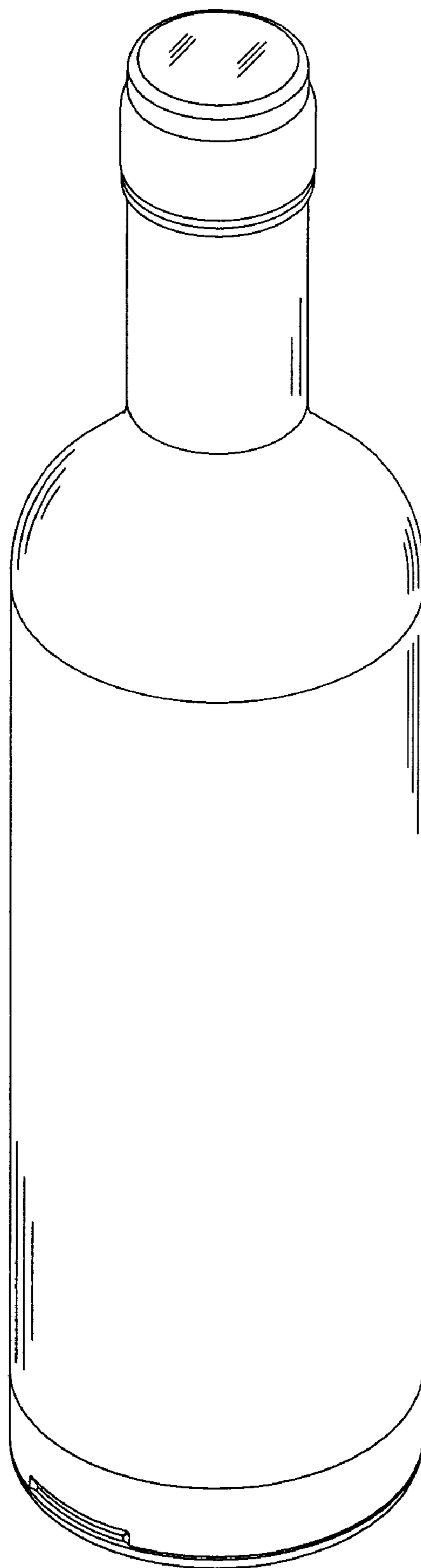

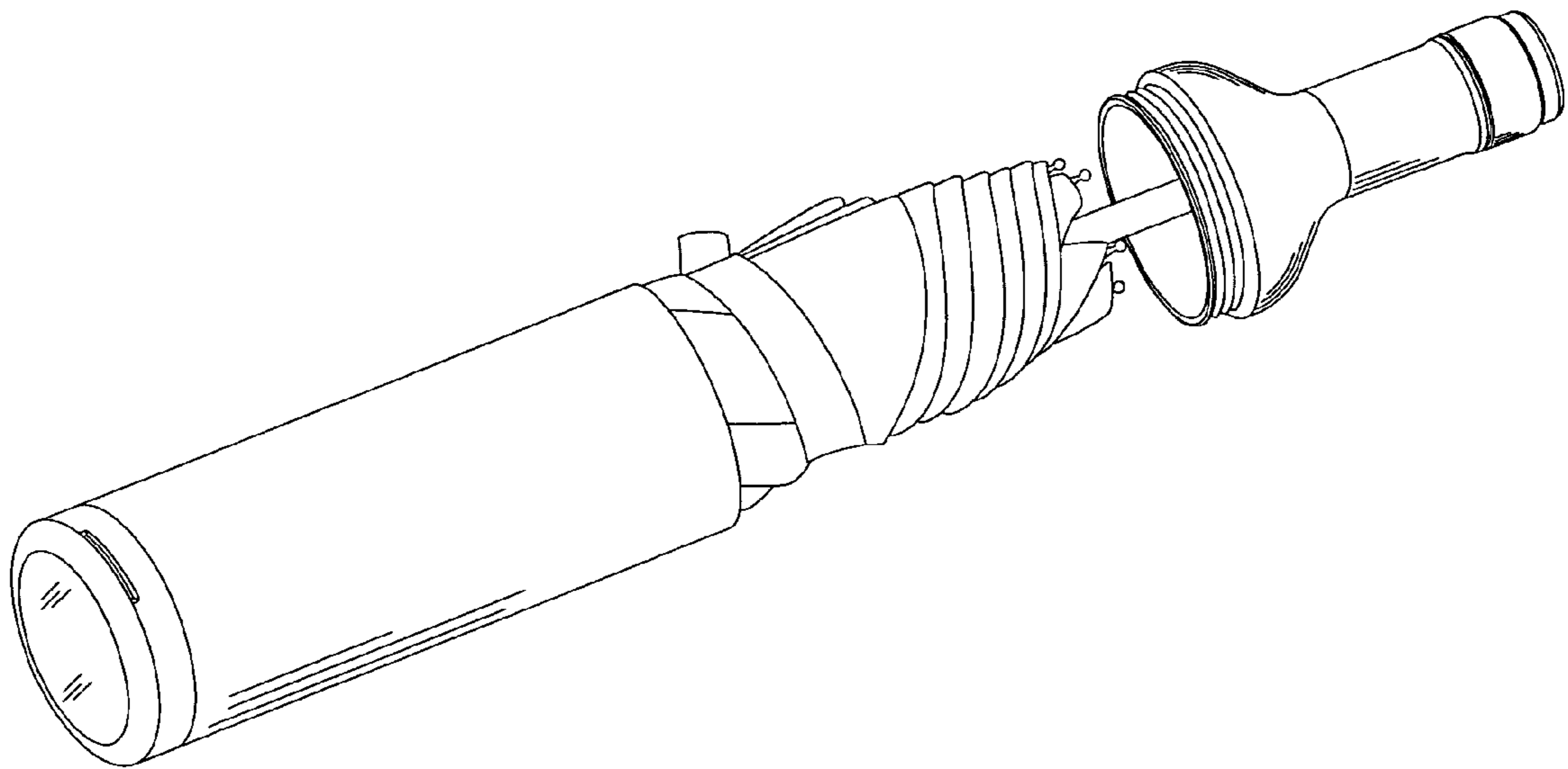

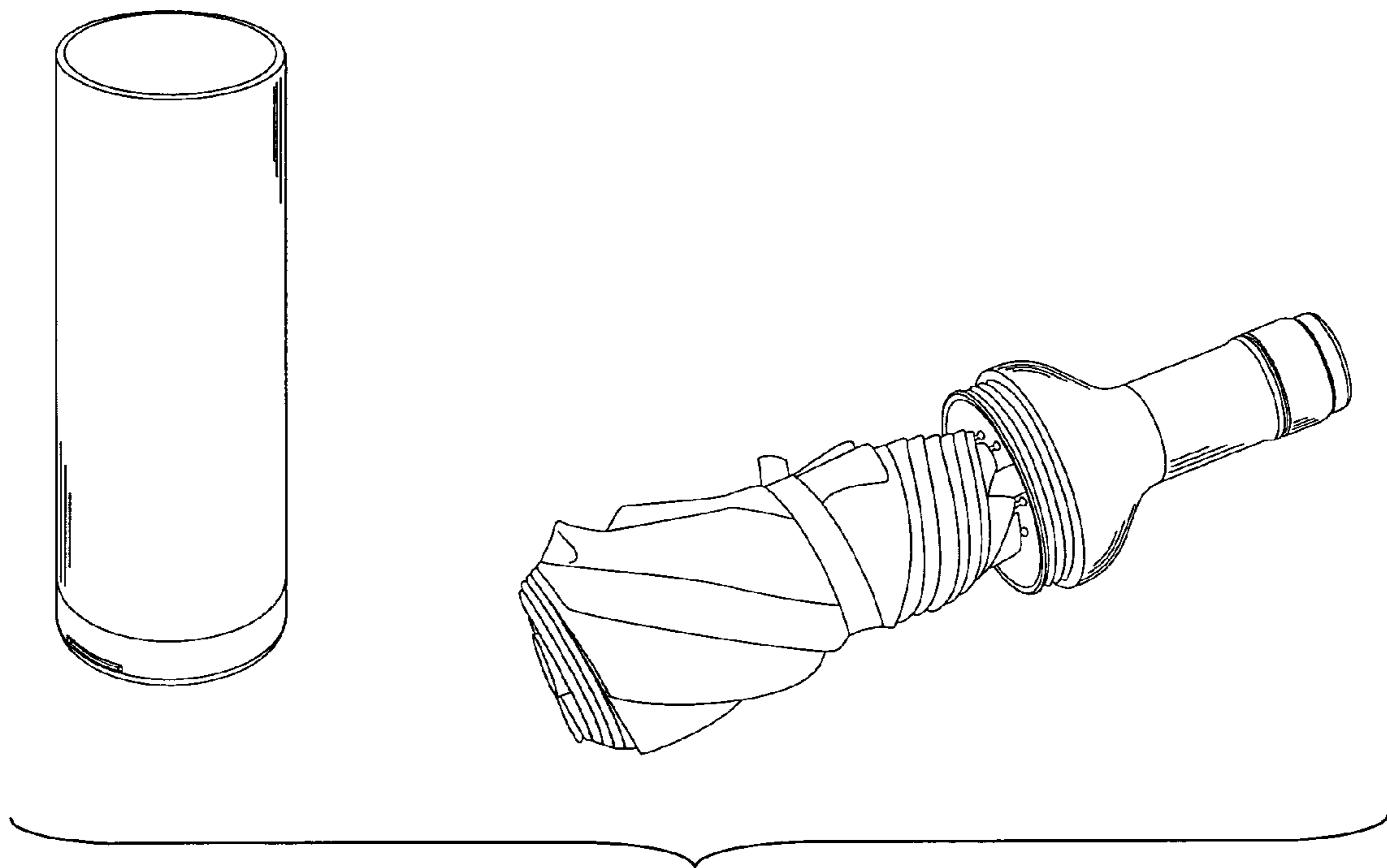

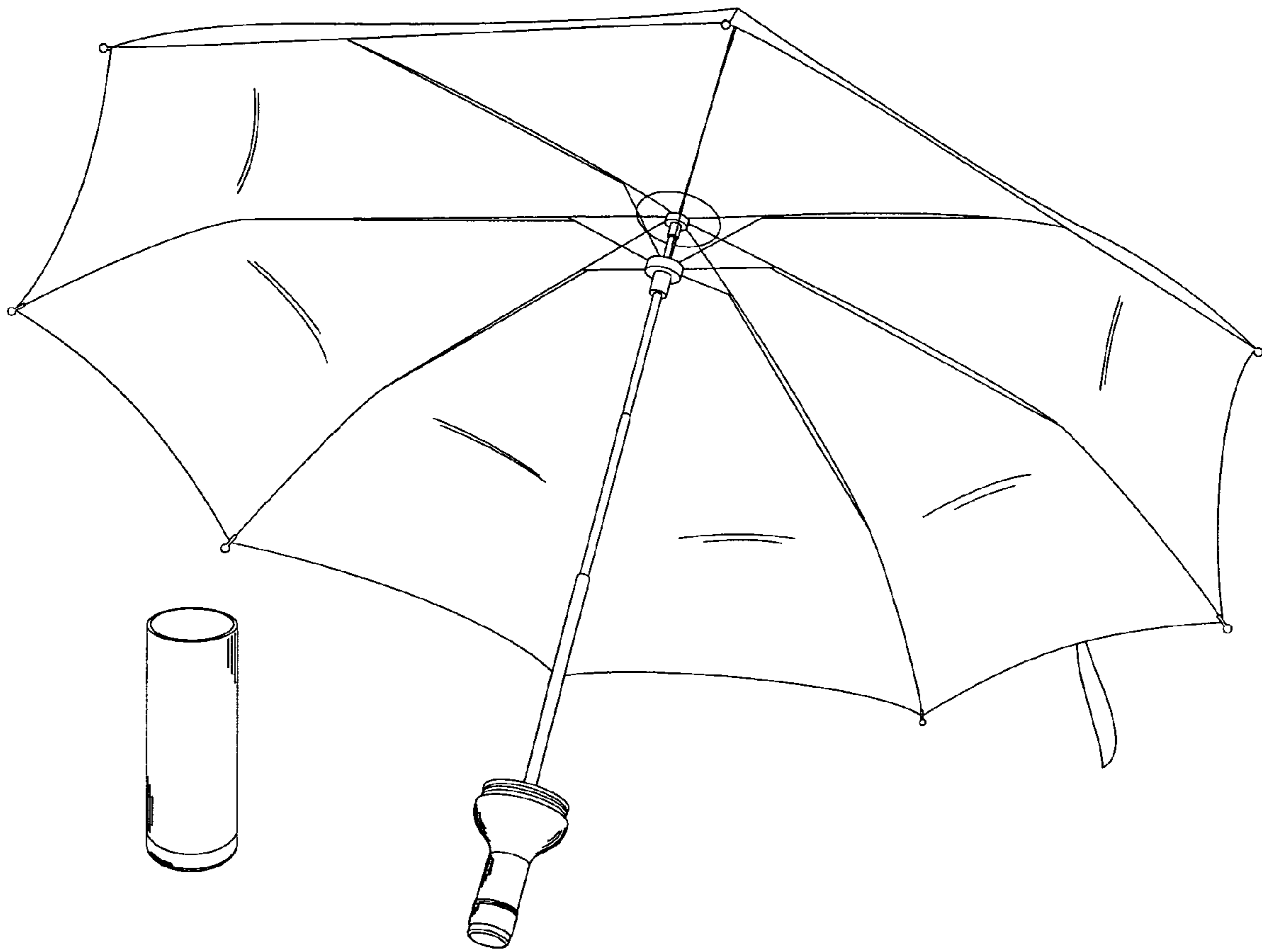
