(57) **CLAIM**

The ornamental design for a collapsible bag, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a collapsible bag showing my new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a left side elevational view thereof;

FIG. 5 is a right side elevational view thereof;

FIG. 6 is a top plan view thereof;

FIG. 7 is a bottom view thereof;

FIG. 8 is a rear view thereof partially collapsed;

FIG. 9 is a front view thereof partially collapsed;

FIG. 10 is a left side view thereof partially collapsed;

FIG. 11 is a right side view thereof partially collapsed;

FIG. 12 is a bottom view thereof partially collapsed;

FIG. 13 is a top view thereof partially collapsed;

FIG. 14 is a perspective view thereof partially collapsed with the handles shown in another position;

FIG. 15 is a front elevational view thereof fully collapsed;

FIG. 16 is a rear elevational view thereof fully collapsed;

FIG. 17 is a left side elevational view thereof fully collapsed;

FIG. 18 is a right side elevational view thereof fully collapsed;

FIG. 19 is a top plan view thereof fully collapsed;

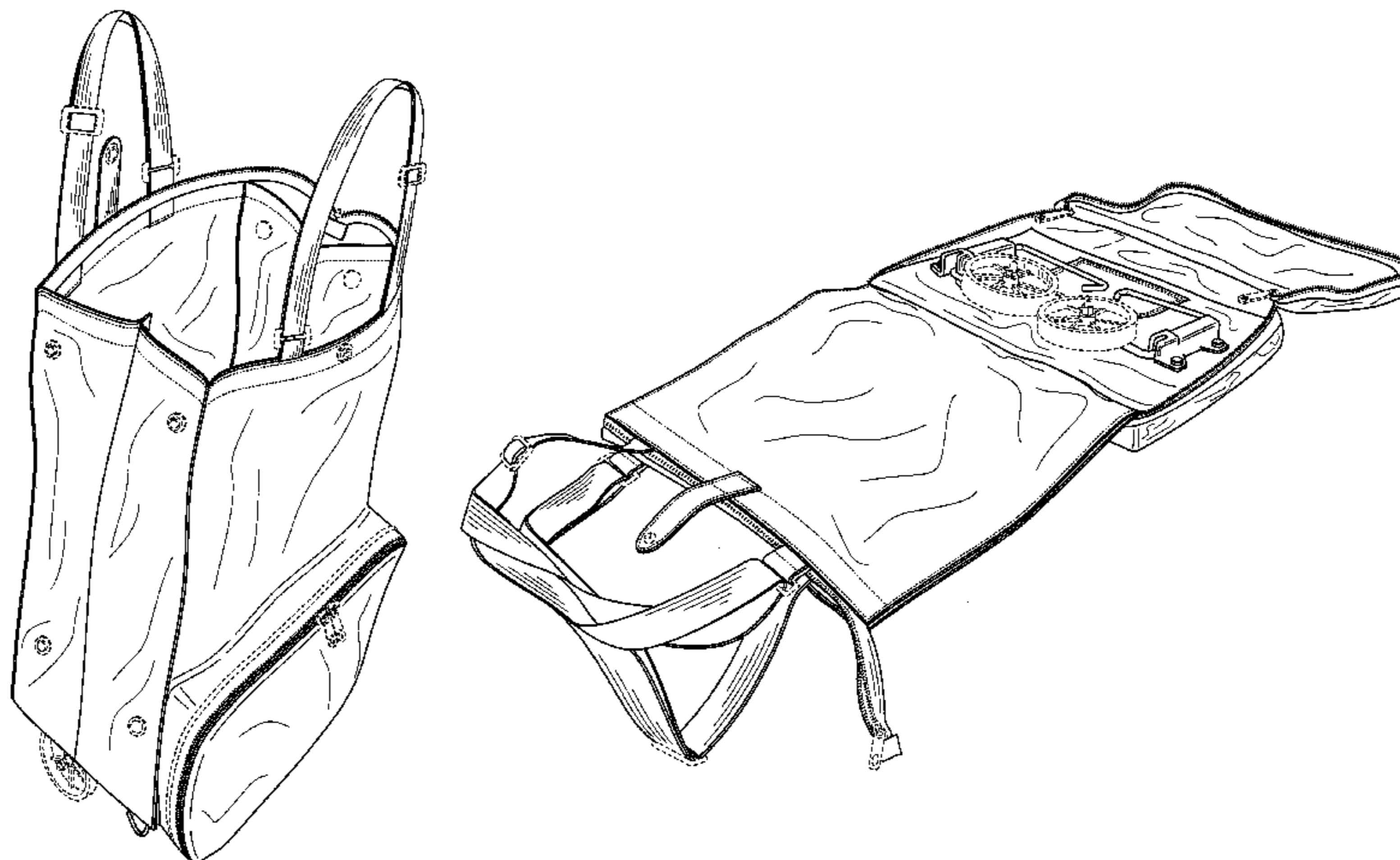
FIG. 20 is a bottom view thereof fully collapsed; and,

FIG. 21 is a perspective view thereof fully collapsed.

The broken line showing of wheels, zipper pulls, handle clips, snaps and other details shown in FIGS. 1-21 is included for the purpose of showing environmental portions of the collapsible bag and forms no part of the claimed design.

The short, light weight dashed lines represent conventional stitching.

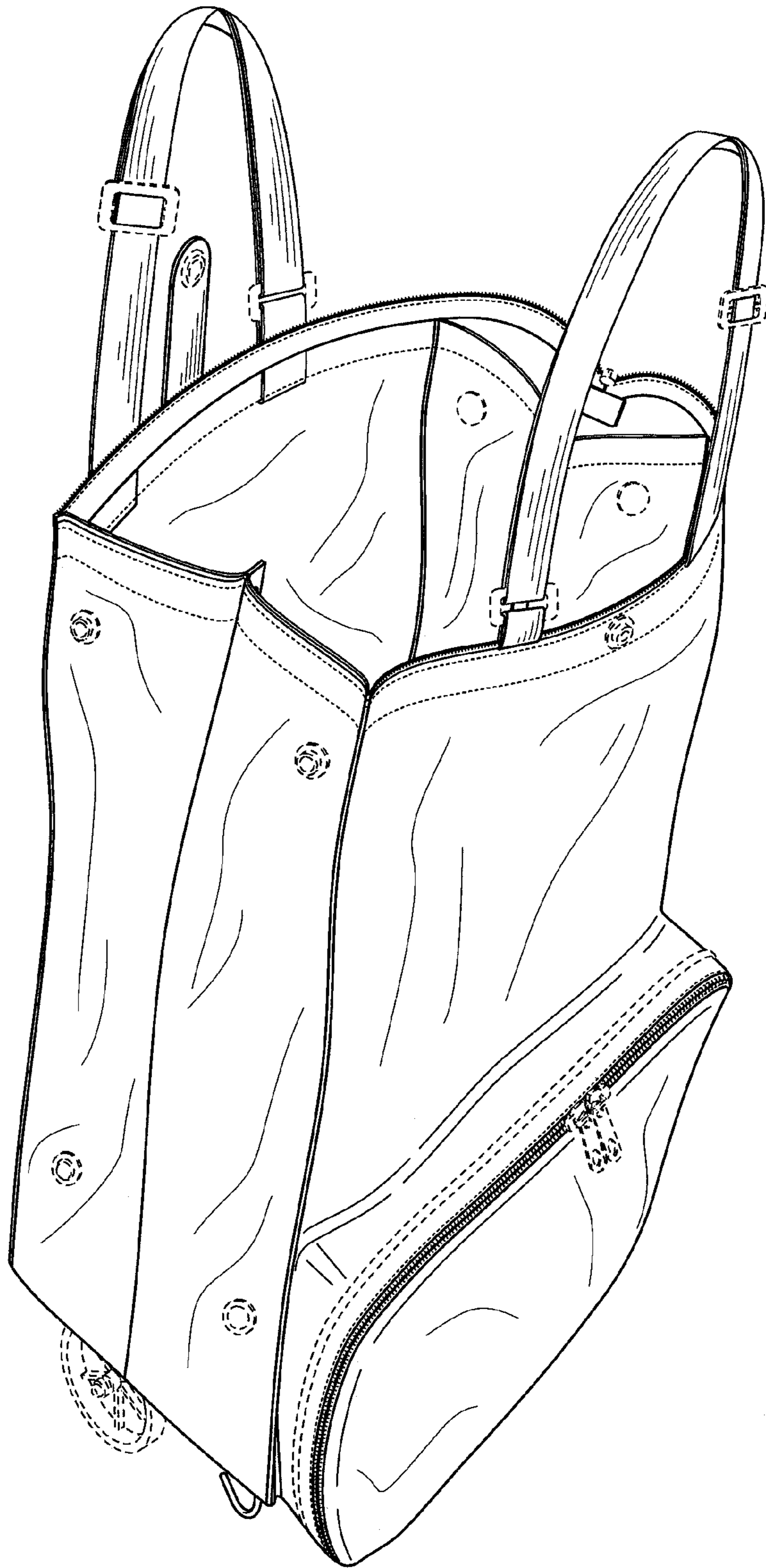

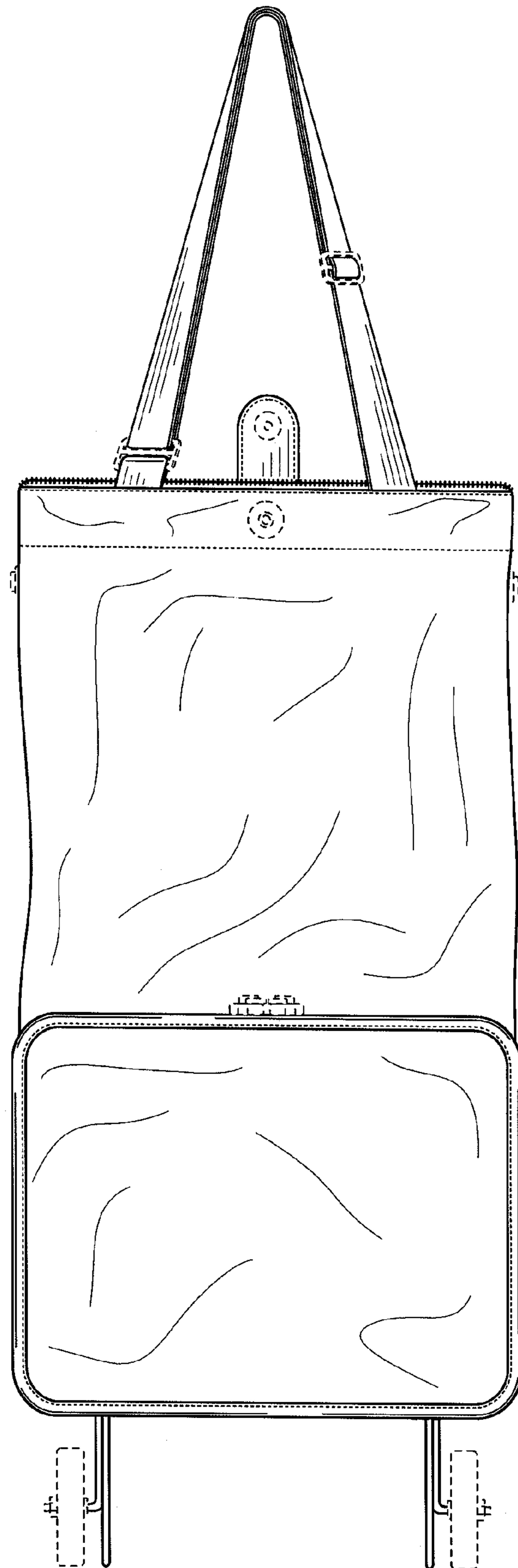

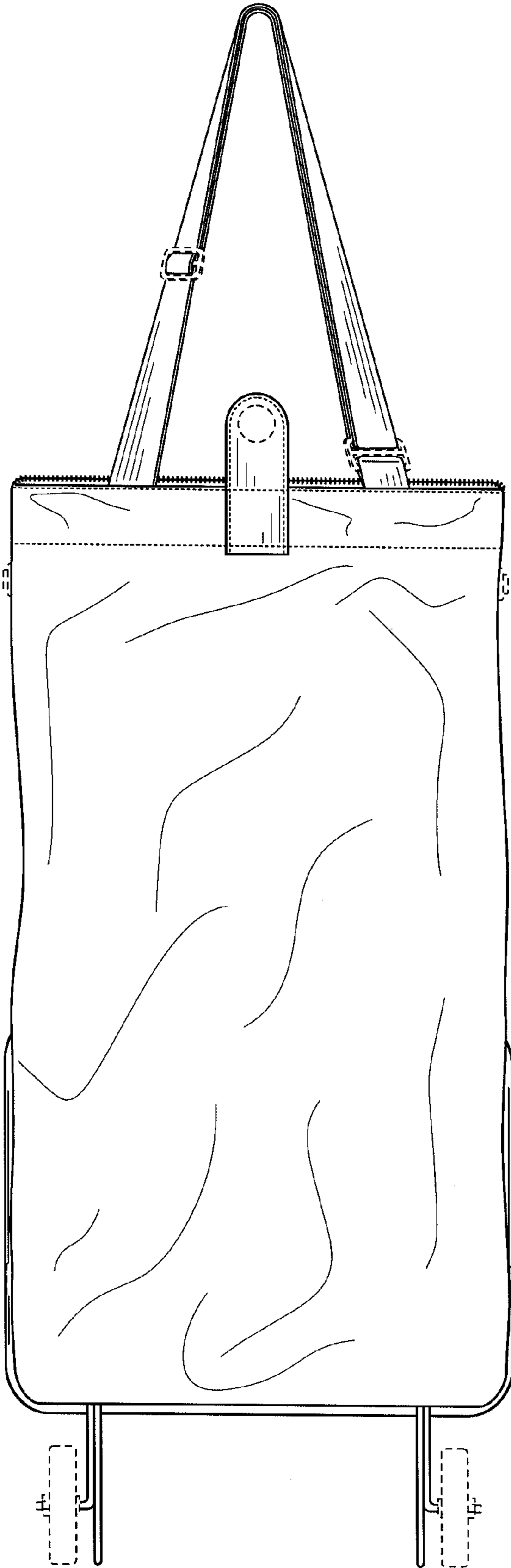

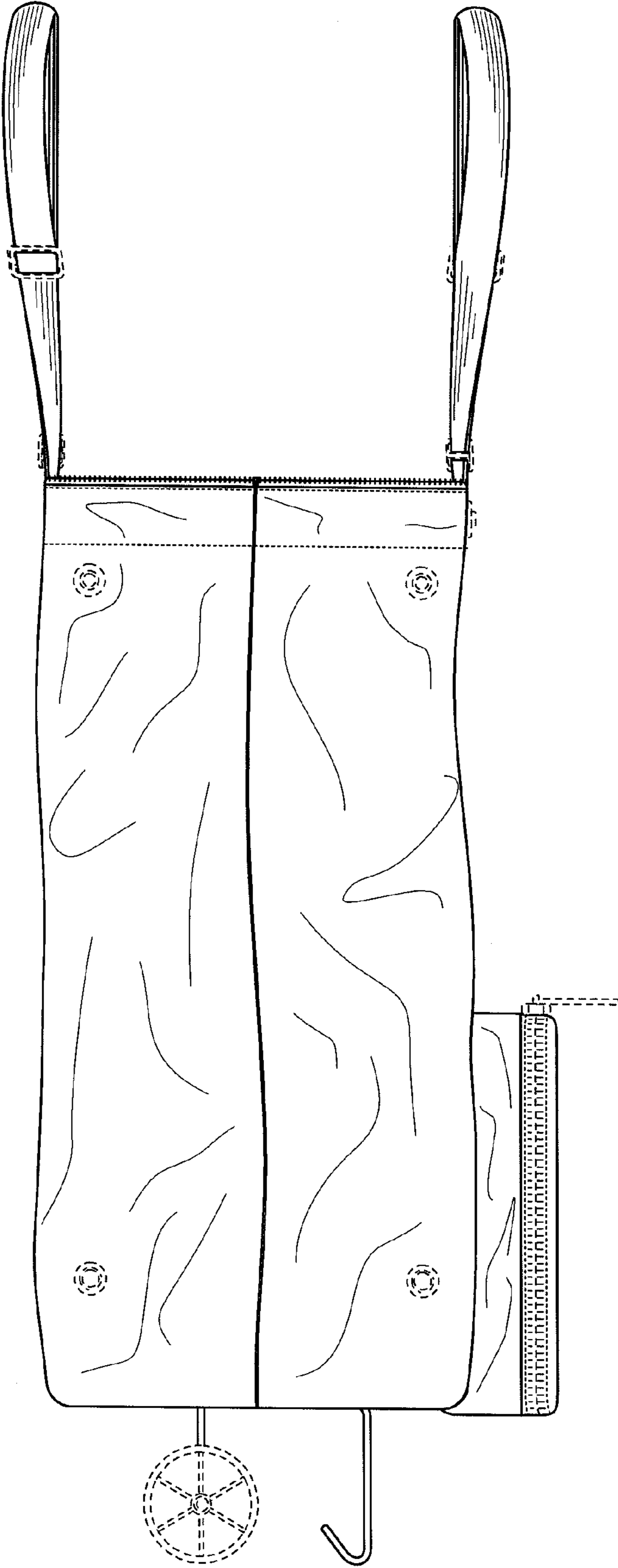

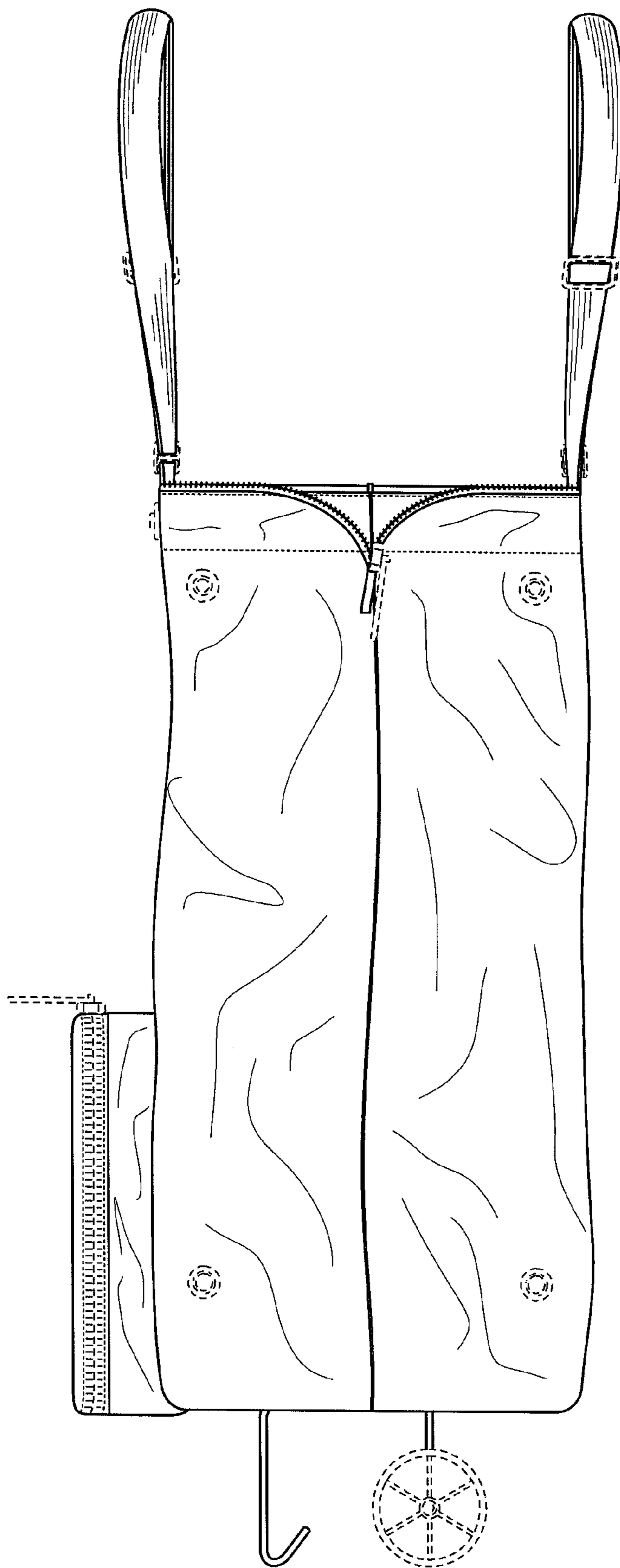

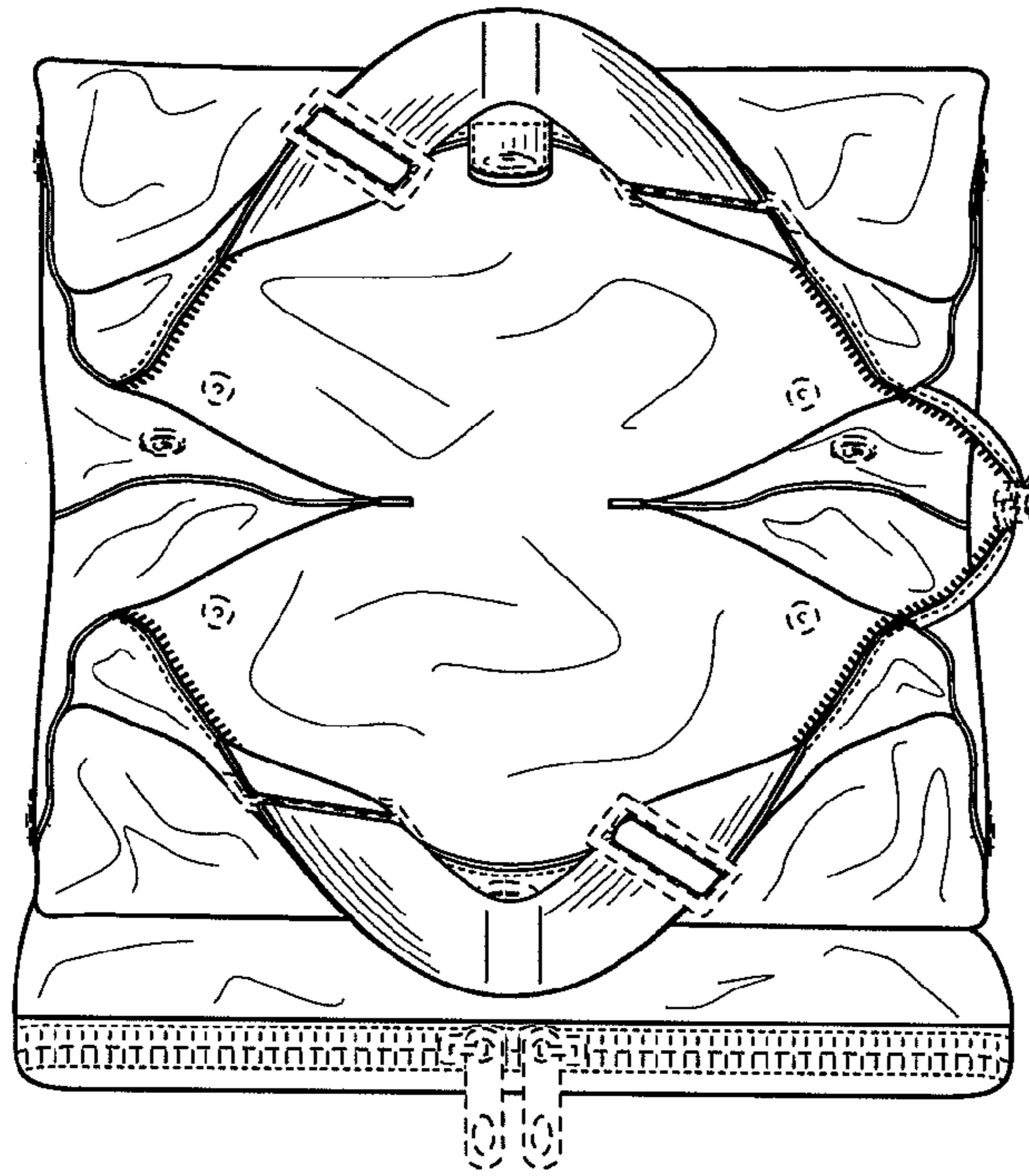

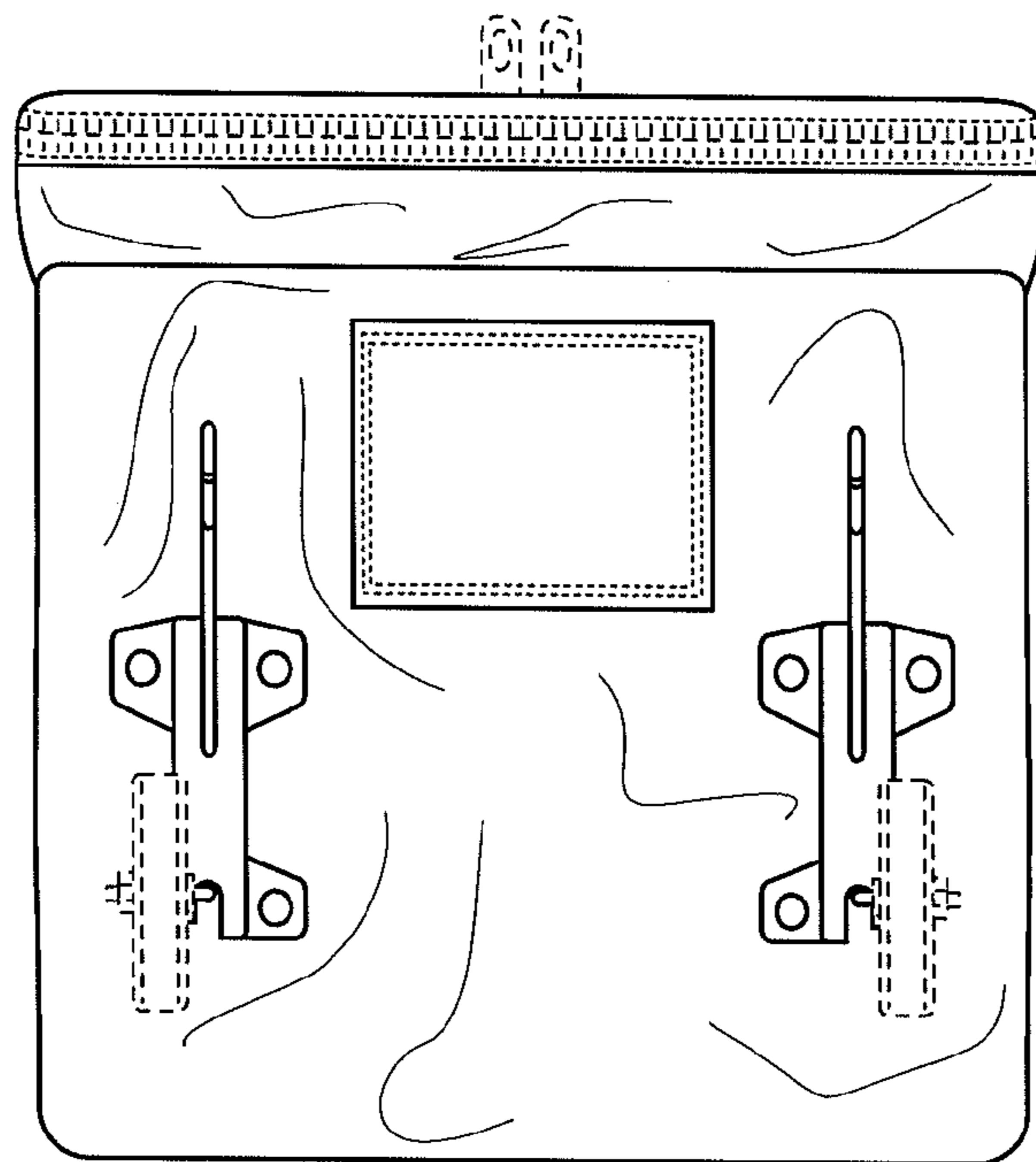

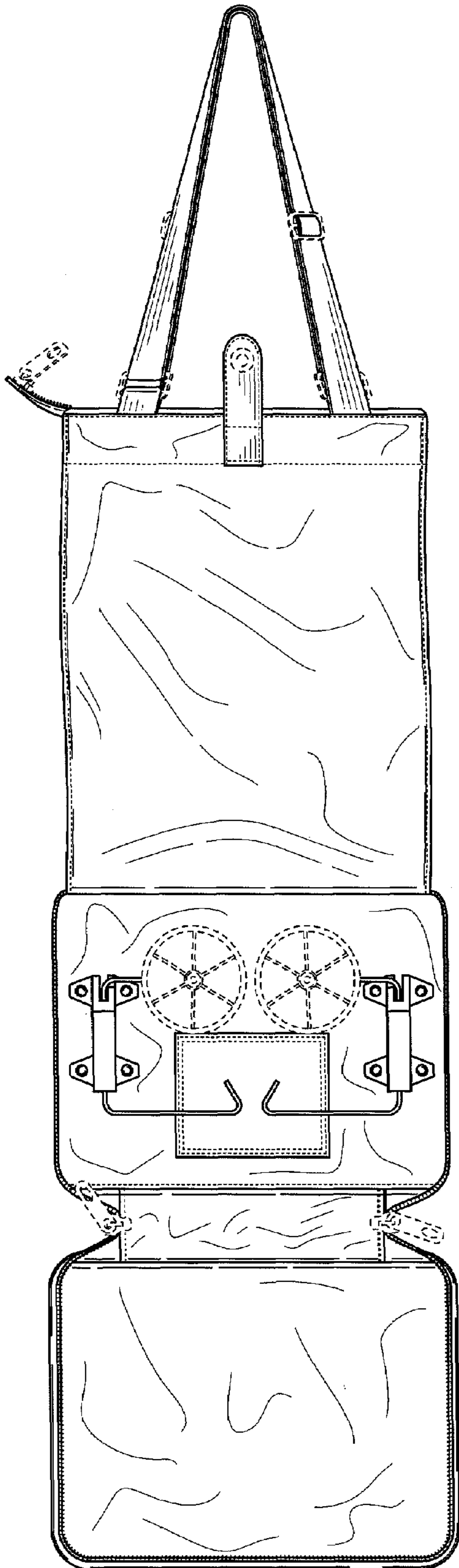

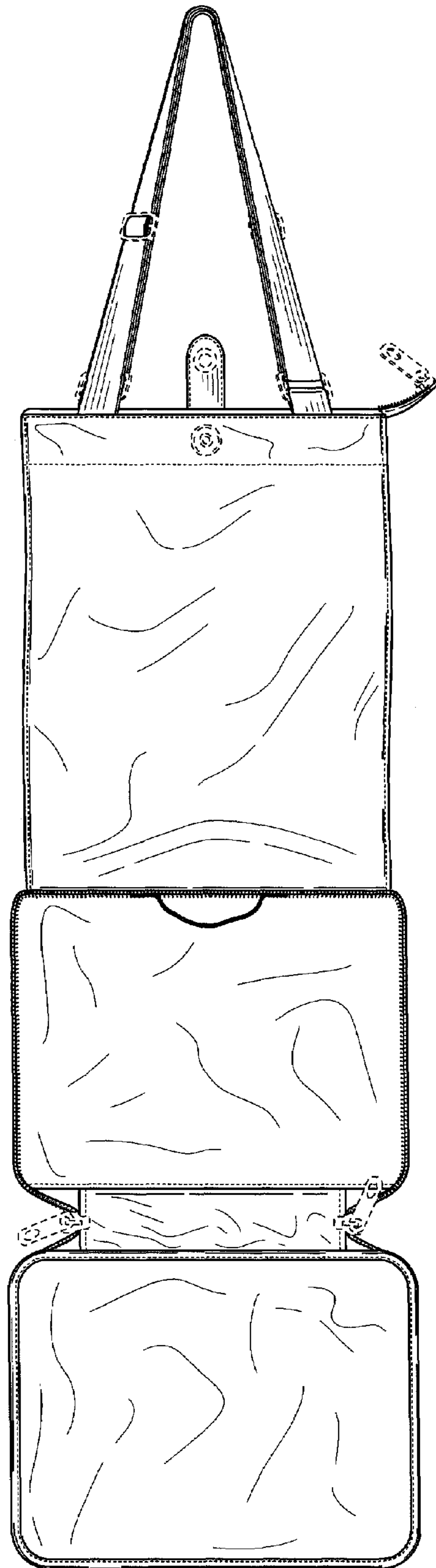

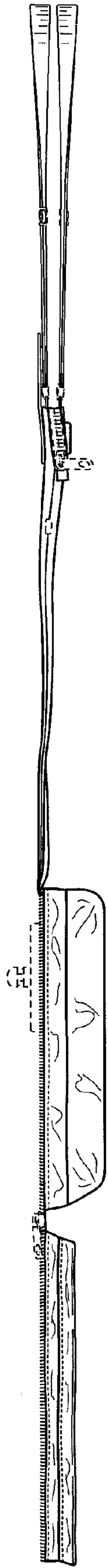

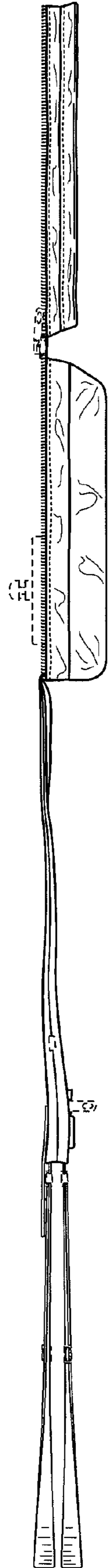

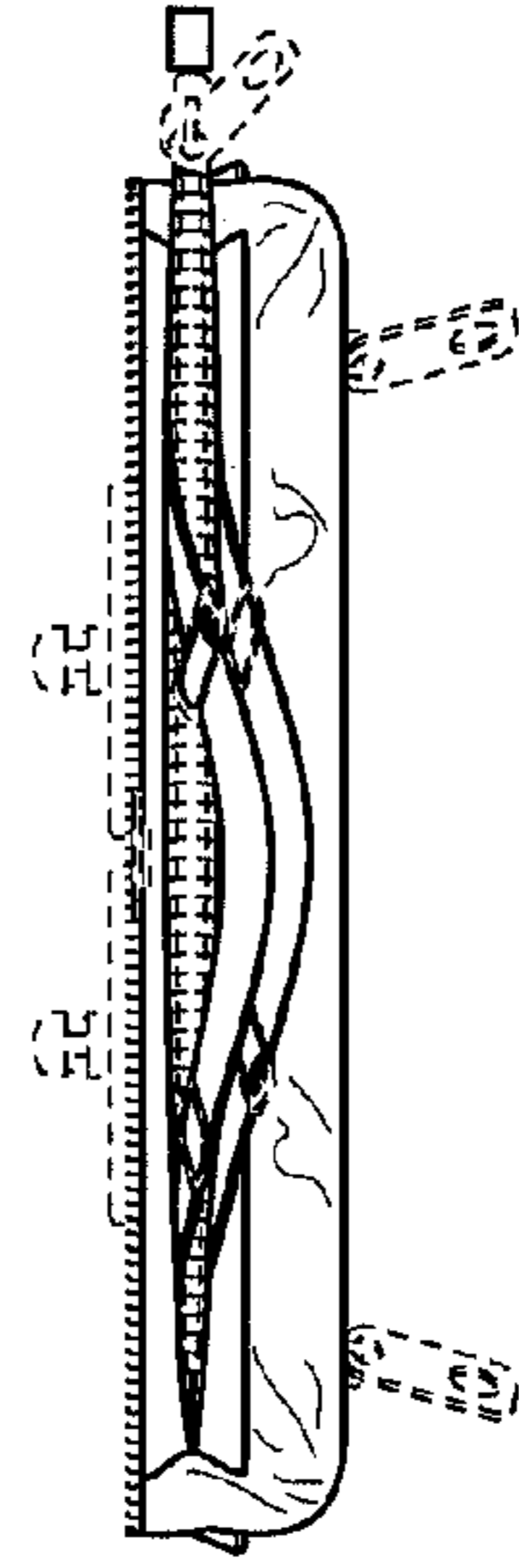

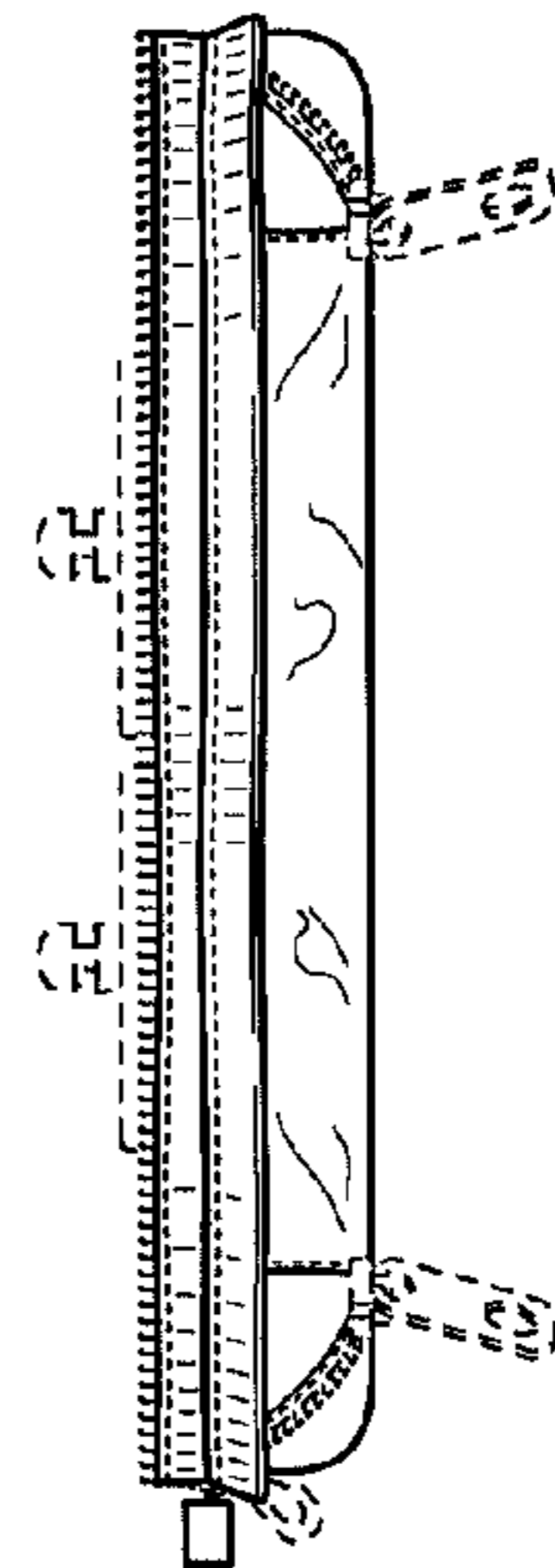

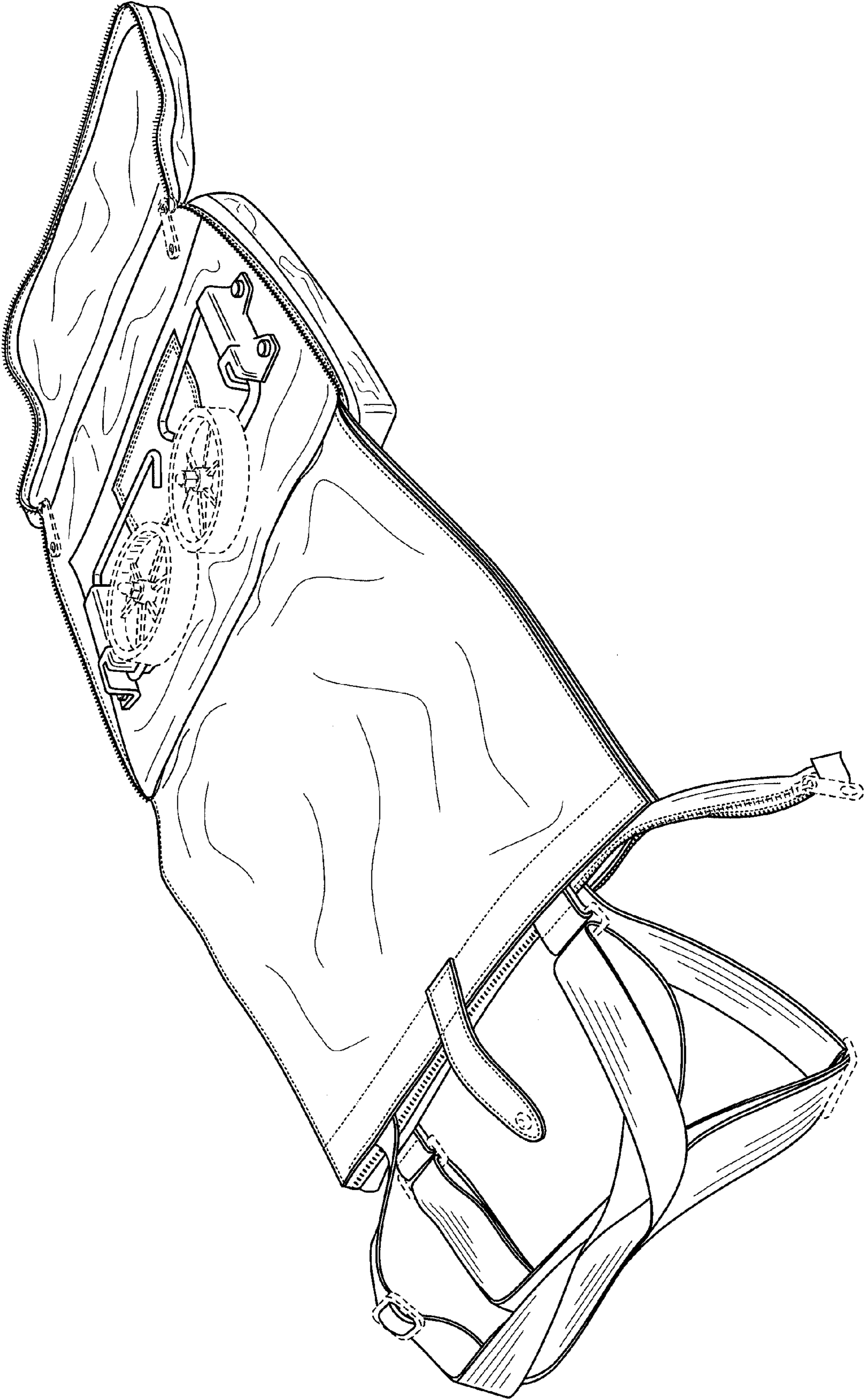

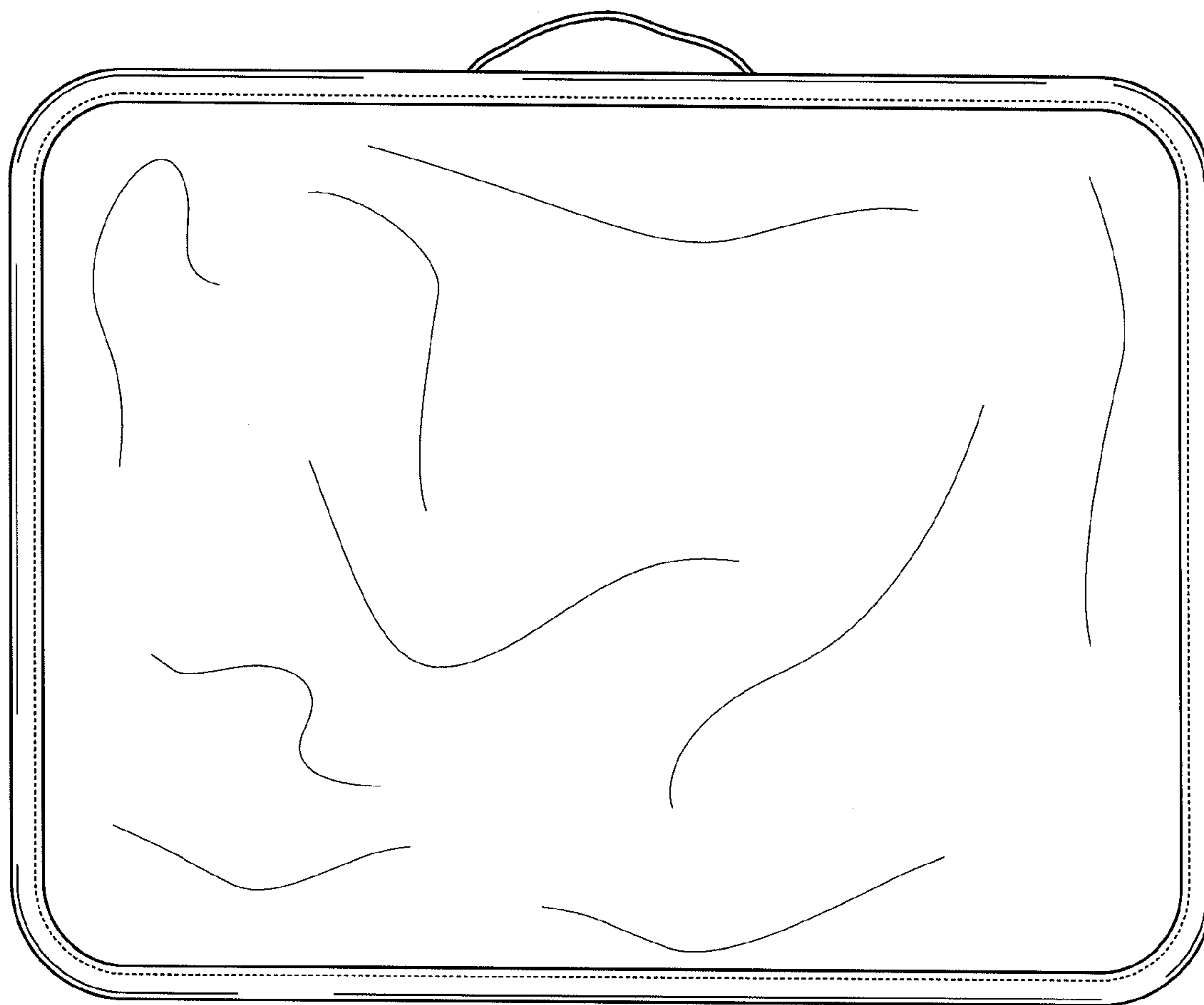

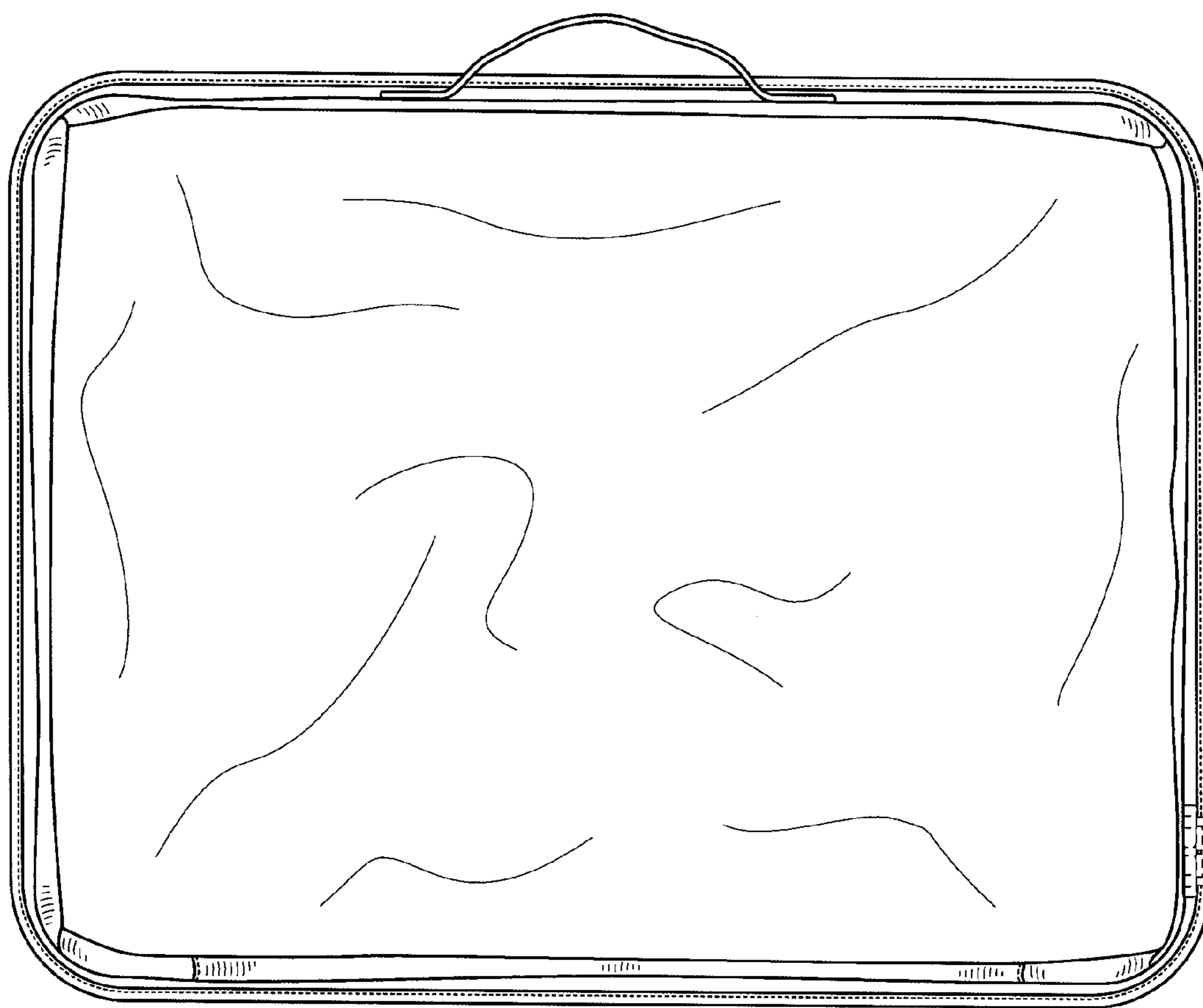

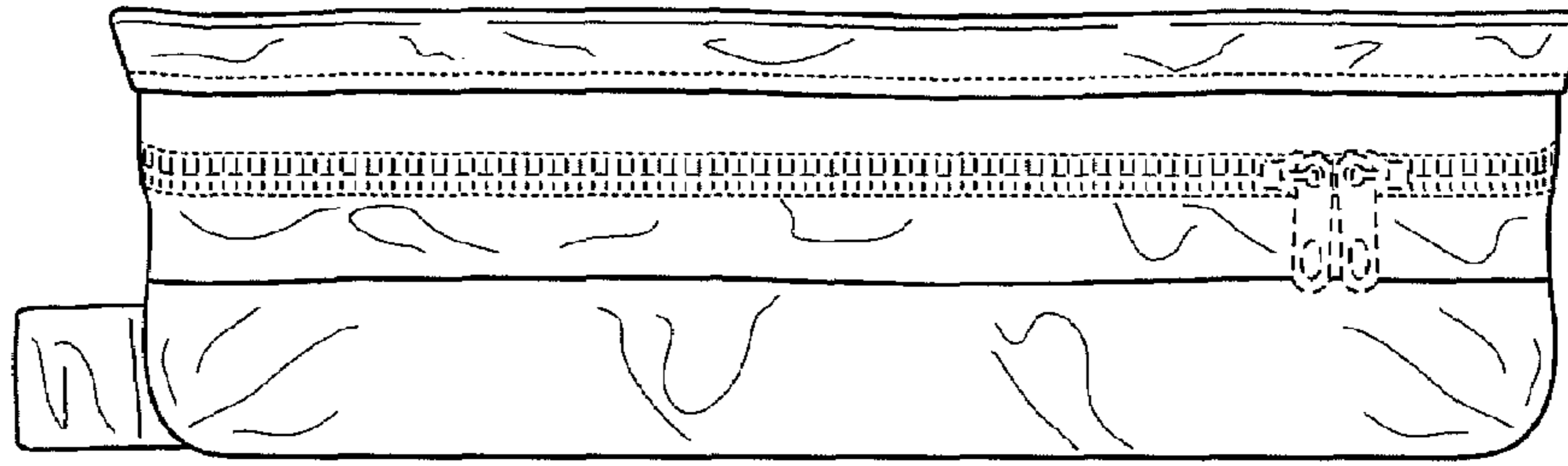

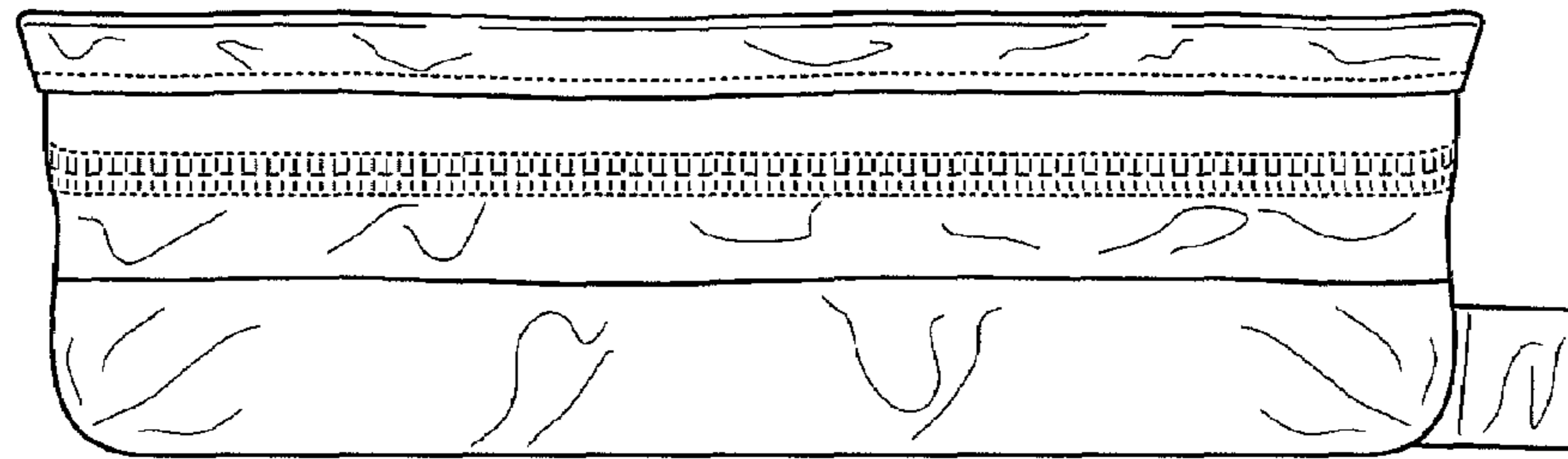

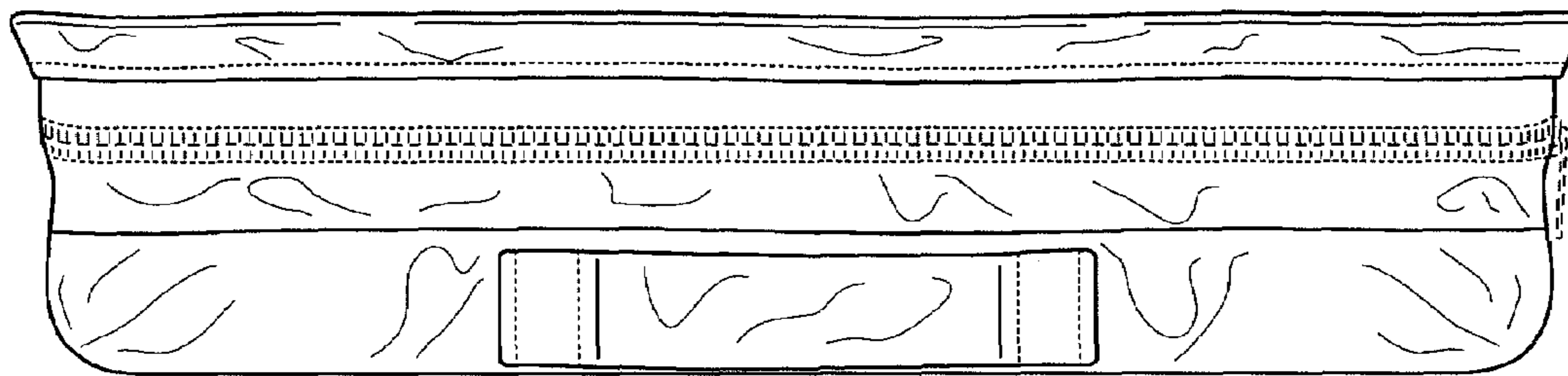

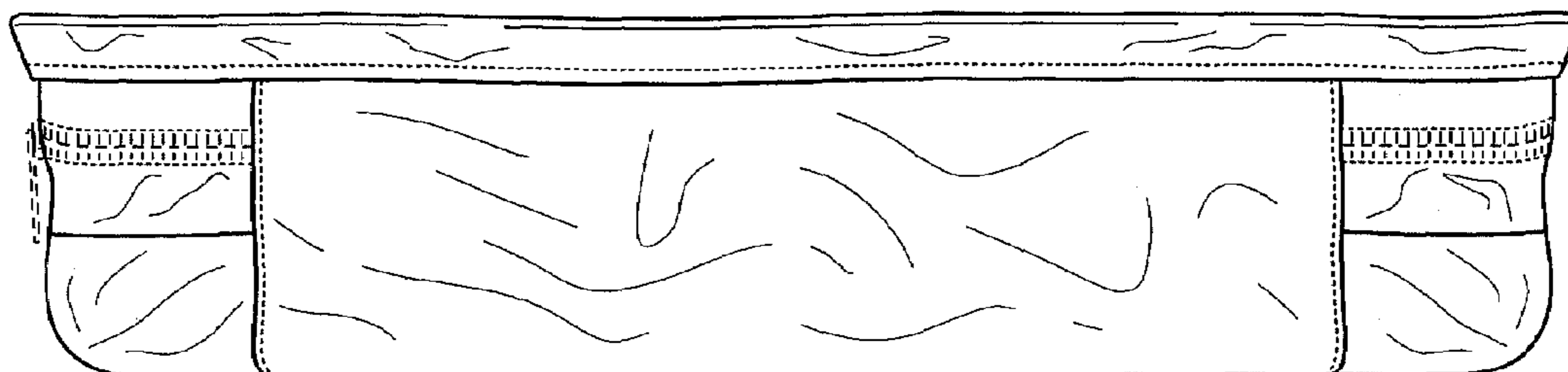

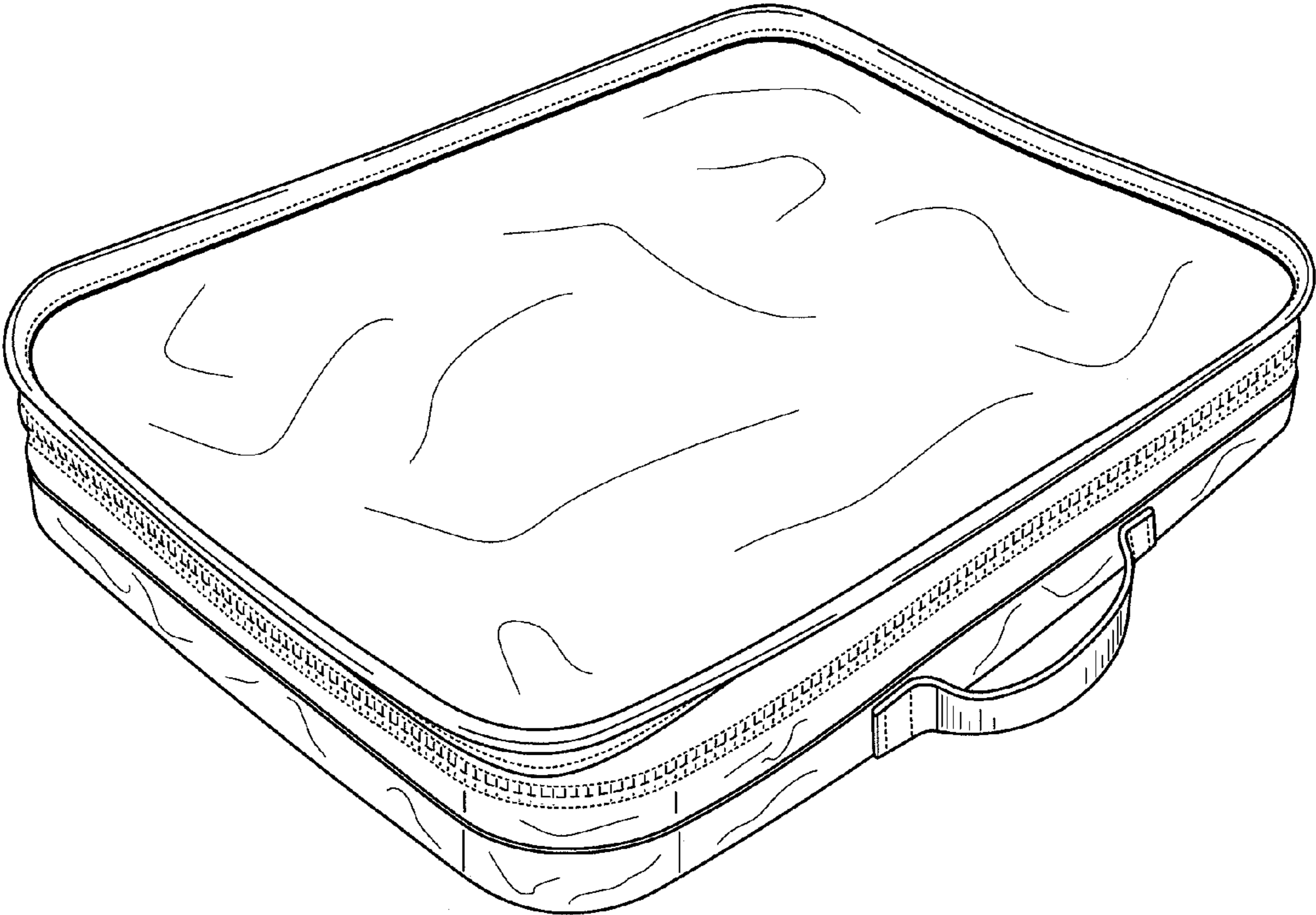
