(57) **CLAIM**

The ornamental design for a toothbrush with base, as shown and described.

DESCRIPTION

FIG. 1 is an exploded front elevation view of a toothbrush with base embodying my new design.

FIG. 2 is a rear elevation view thereof.

FIG. 3 is a left side elevation view thereof.

FIG. 4 is a right side elevation view thereof.

FIG. 5 is a top plan view thereof.

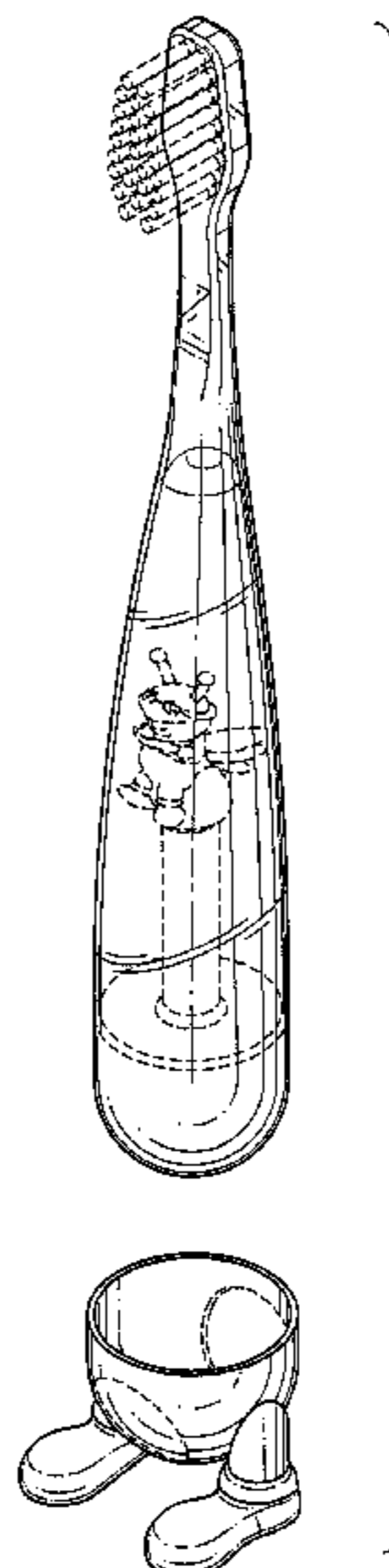
FIG. 6 is a bottom plan view thereof.

FIG. 7 is a top, front, and left side perspective thereof; and,

FIG. 8 is a top, rear, and right side perspective thereof.

The broken lines shown on the base represent boundaries of the claim while the broken lines showing bristles, an internal base, a support post, and a cartoon animal sculpture illustrate portions of the toothbrush which along with the aforementioned boundaries form no part of the claimed design.

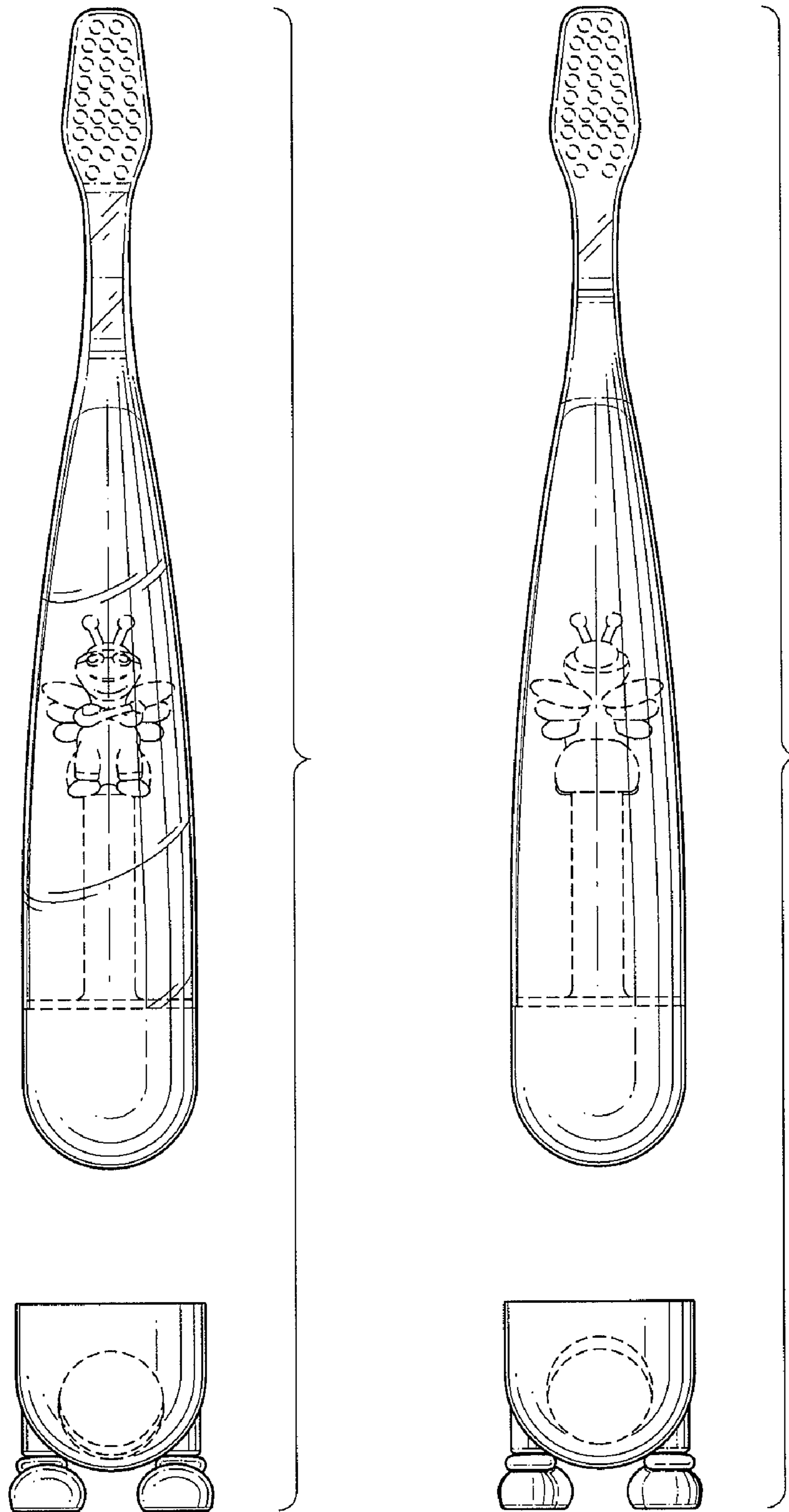

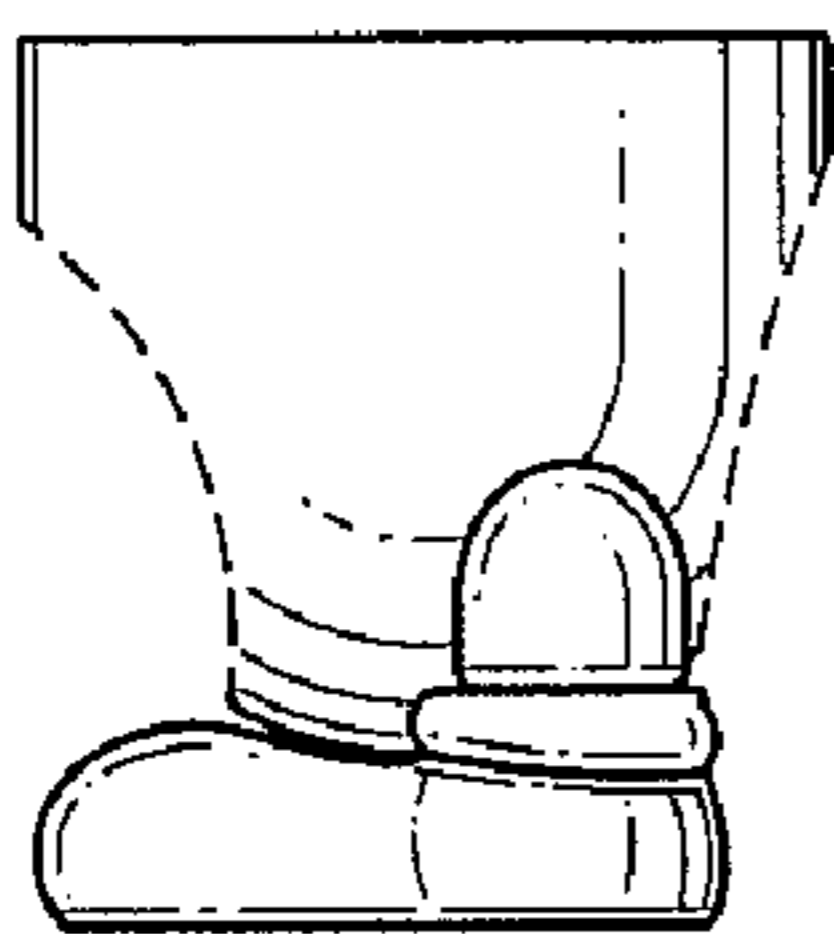
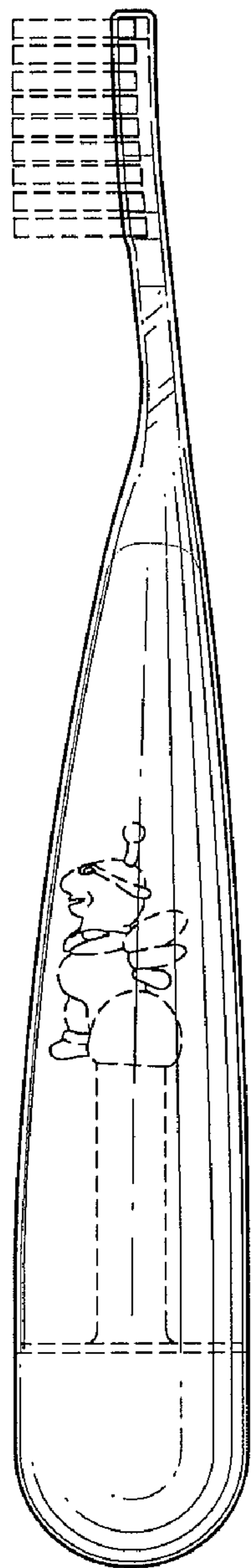

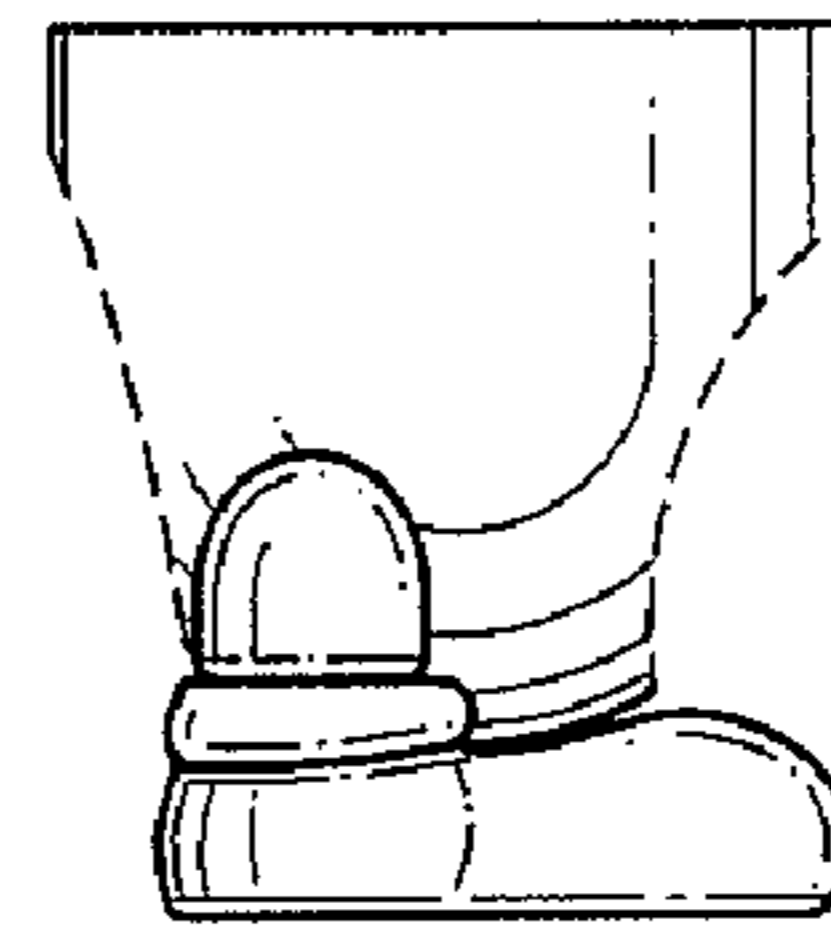
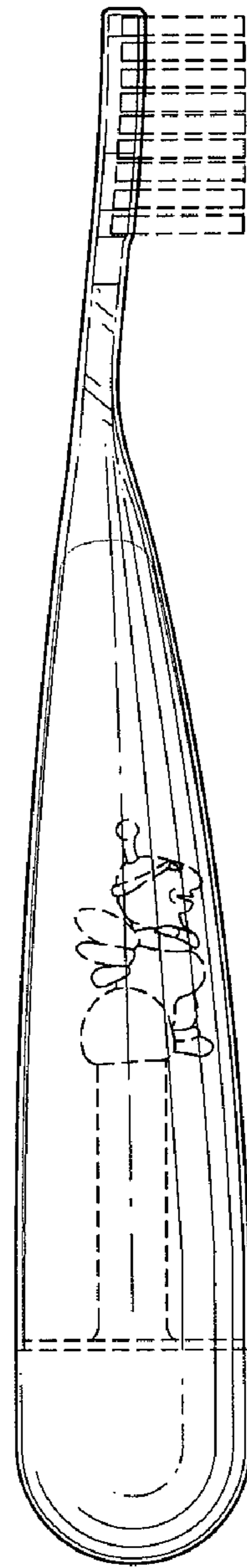

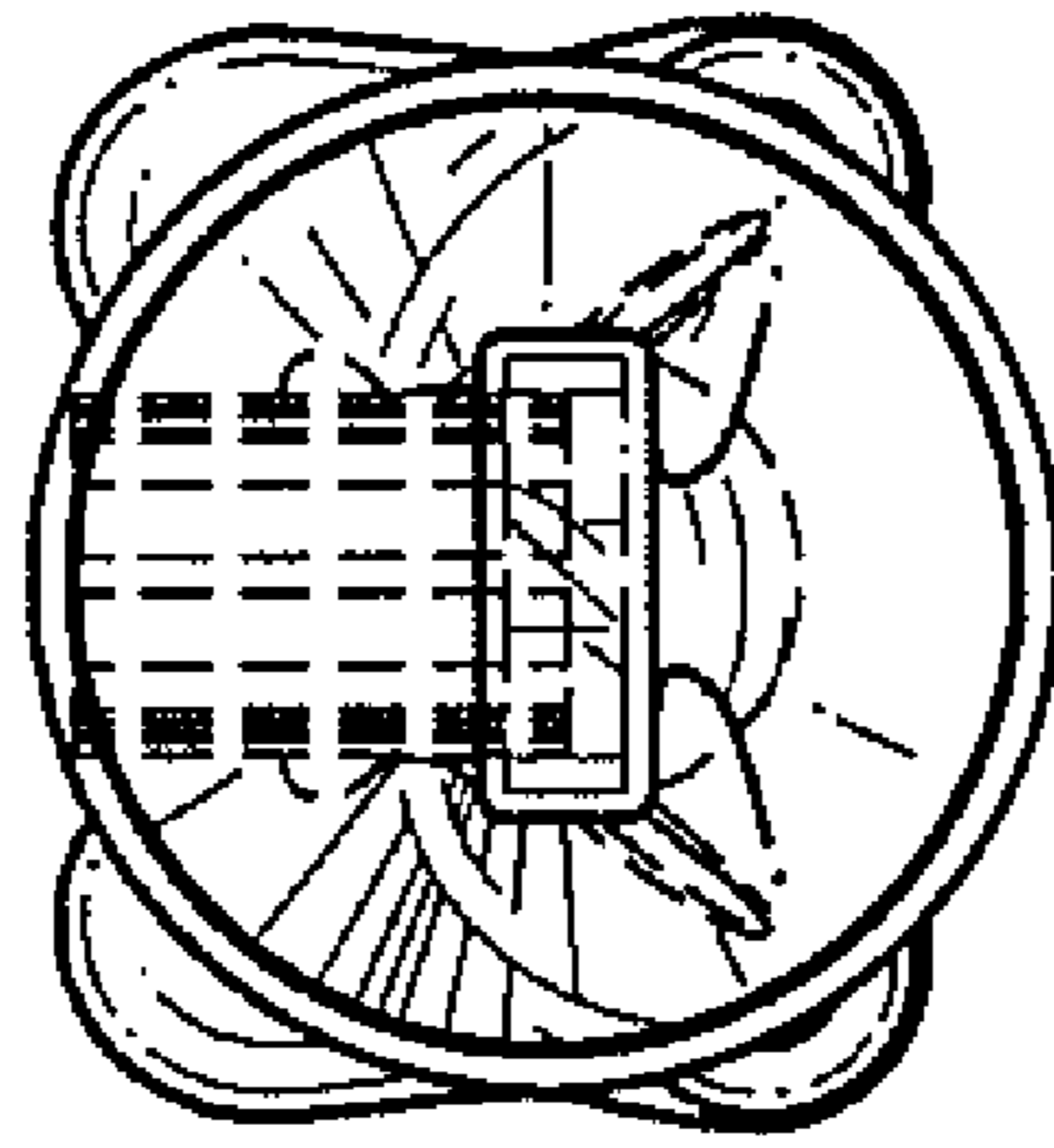

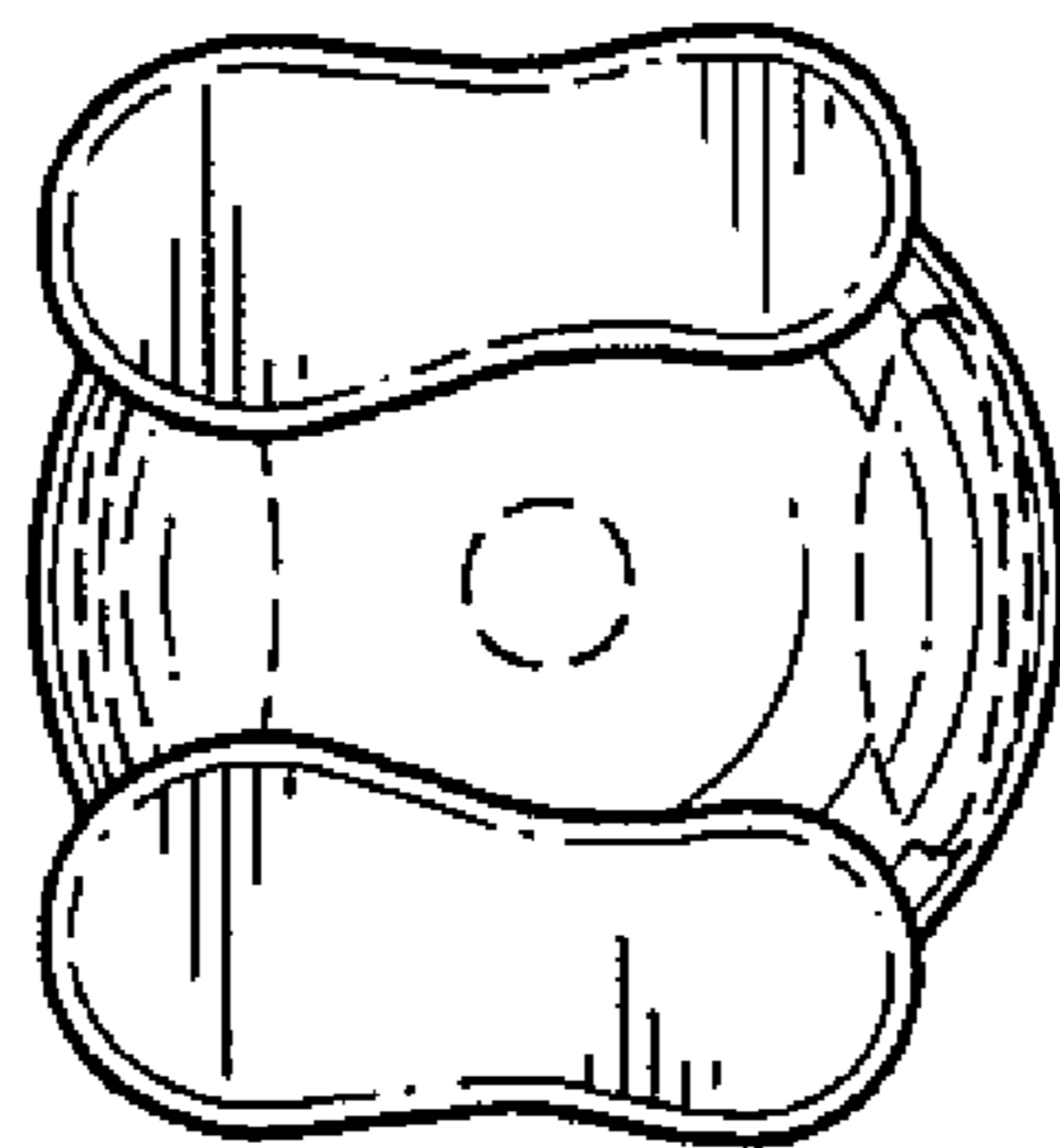

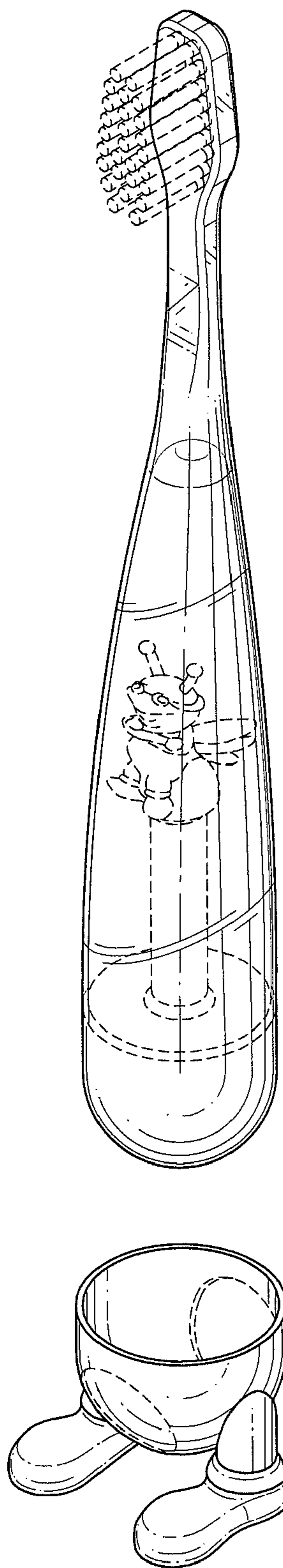

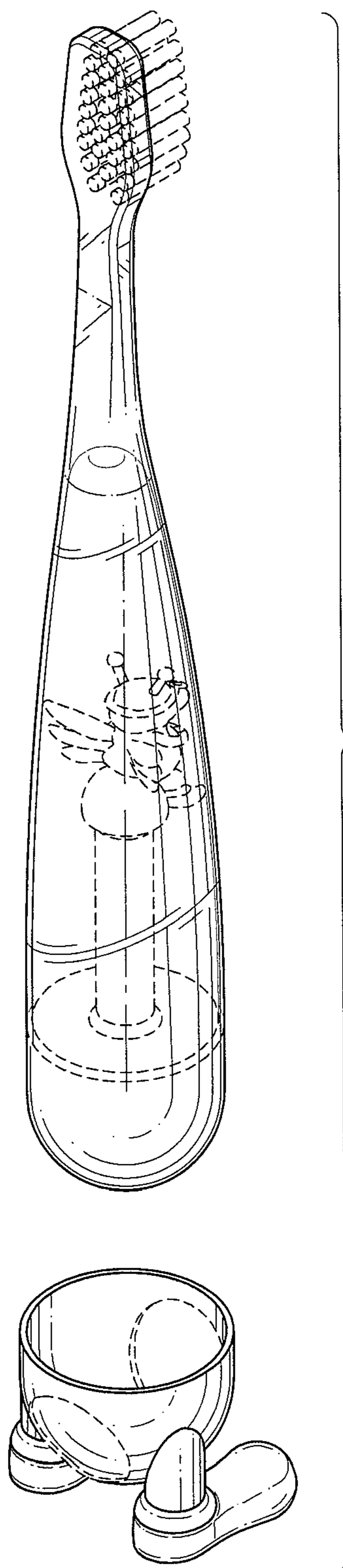
