FIG. 1 is a perspective view of a dispenser showing my new design;

FIG. 2 is a front elevation view thereof;

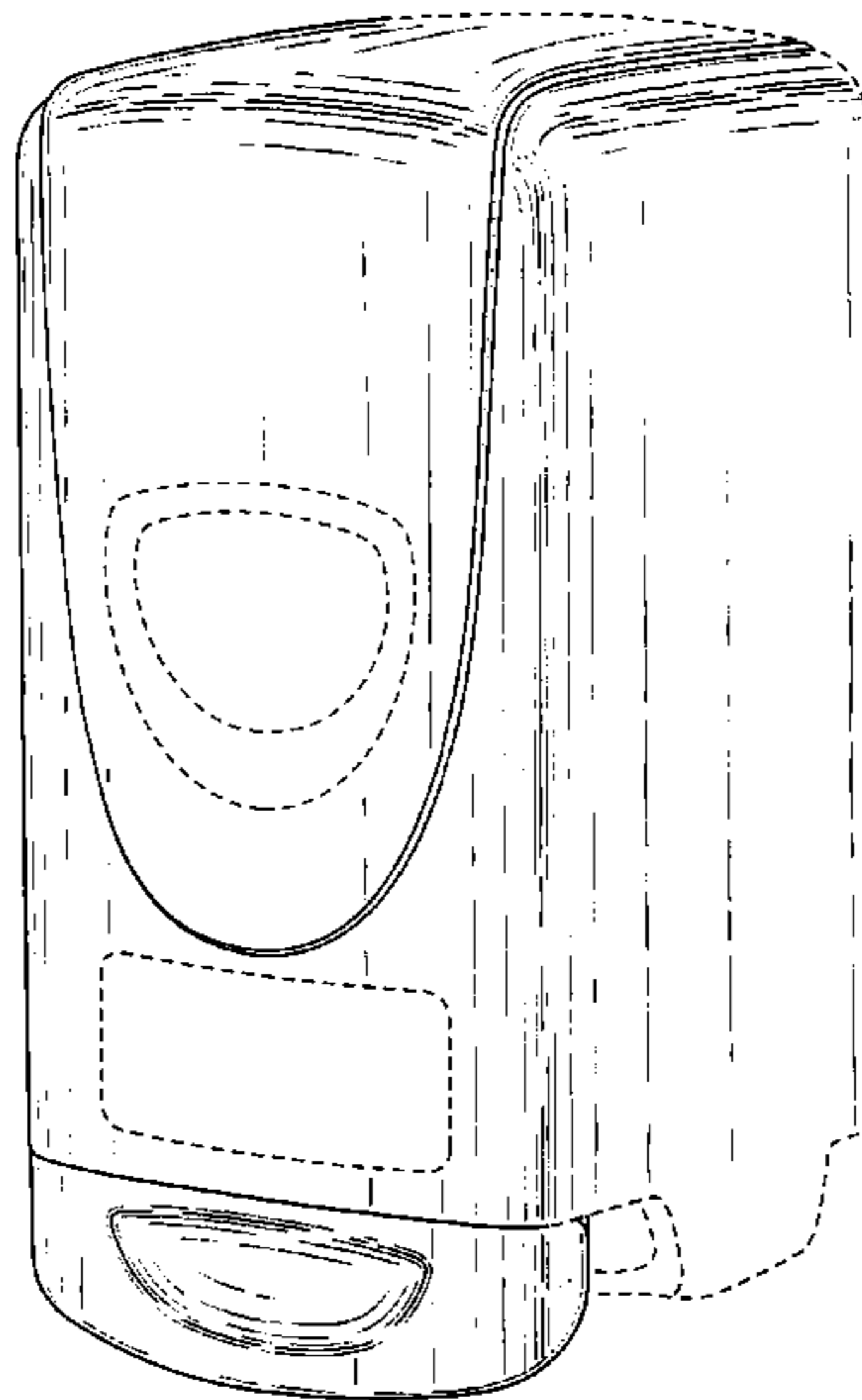
FIG. 3 is a left side elevation view thereof, the right side elevation being a mirror image of that shown;

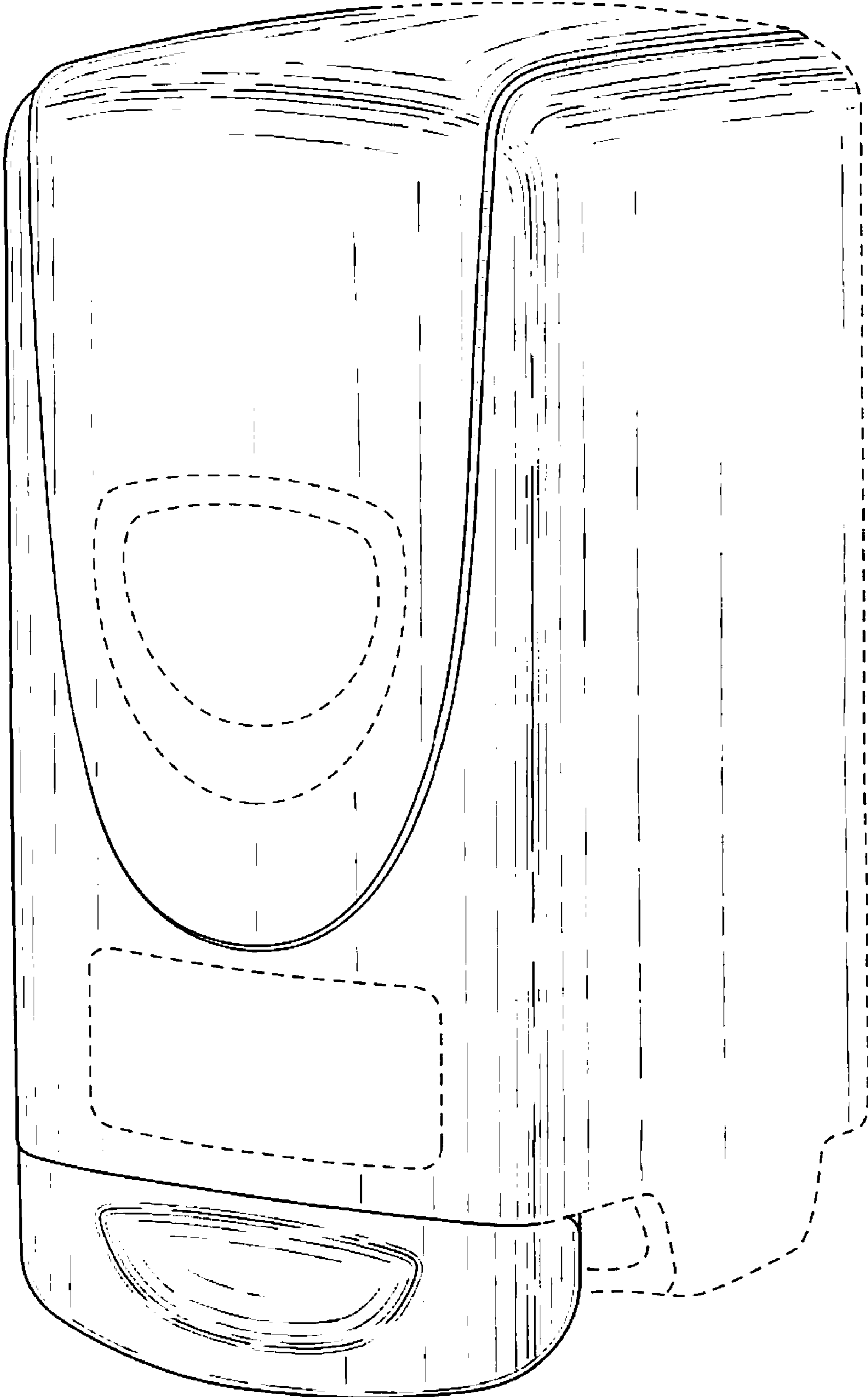

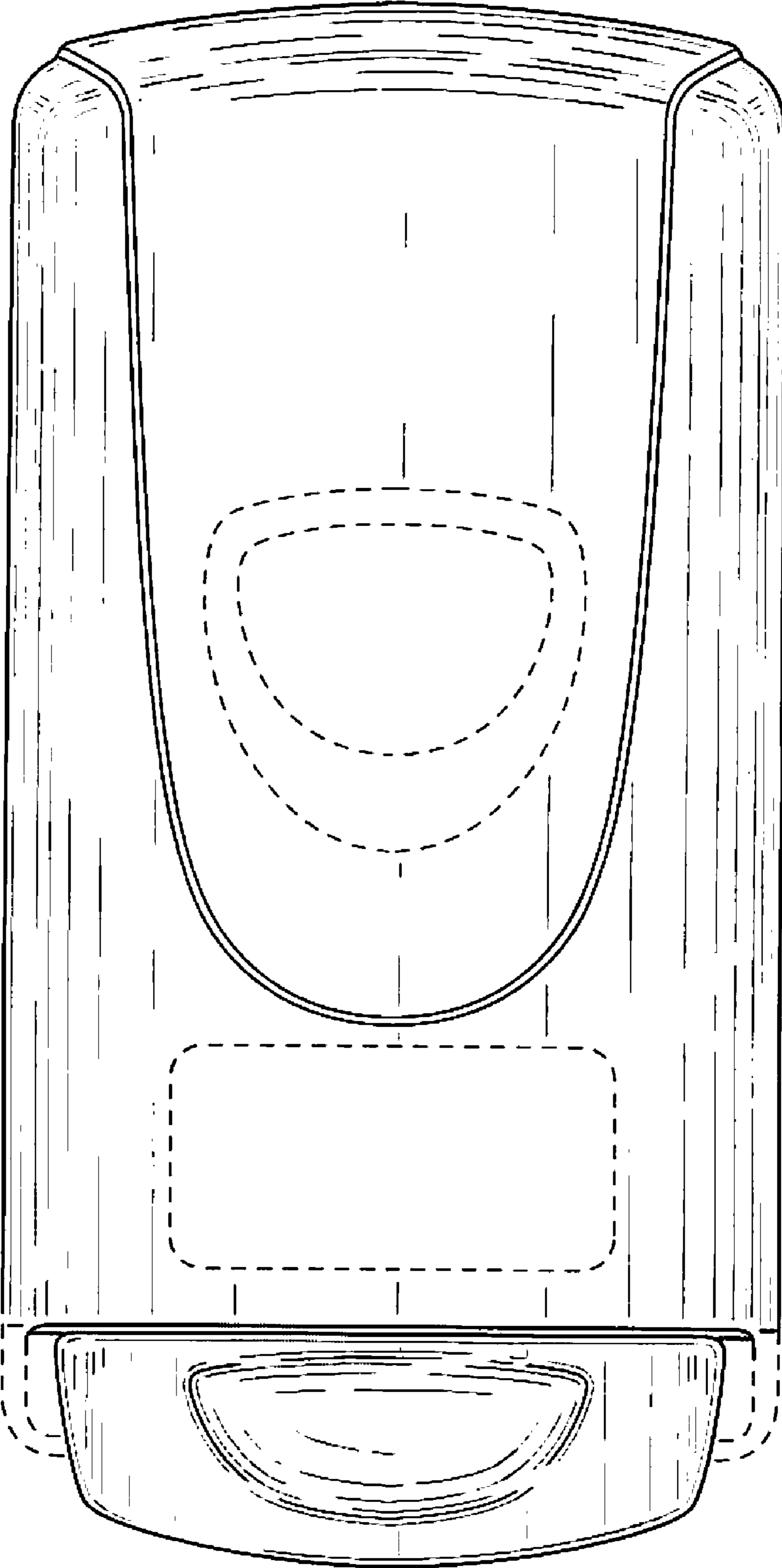

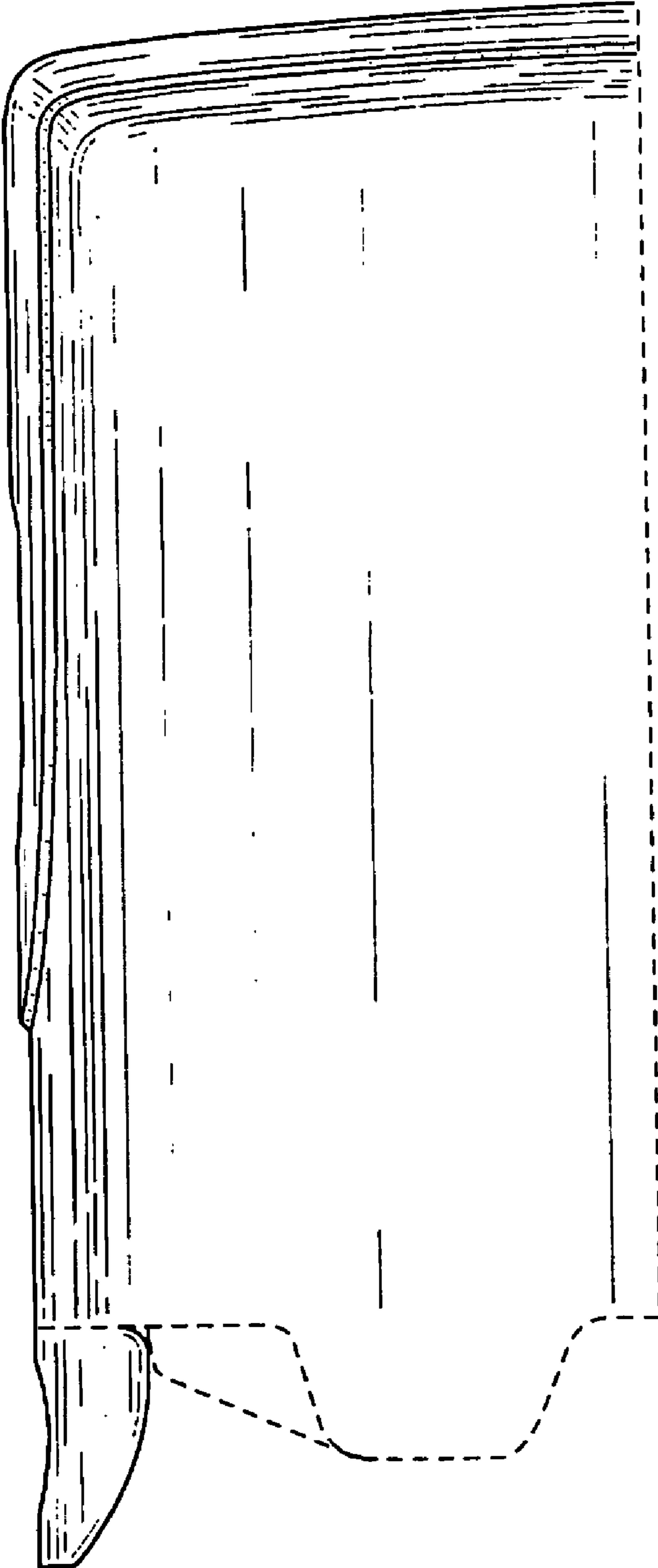

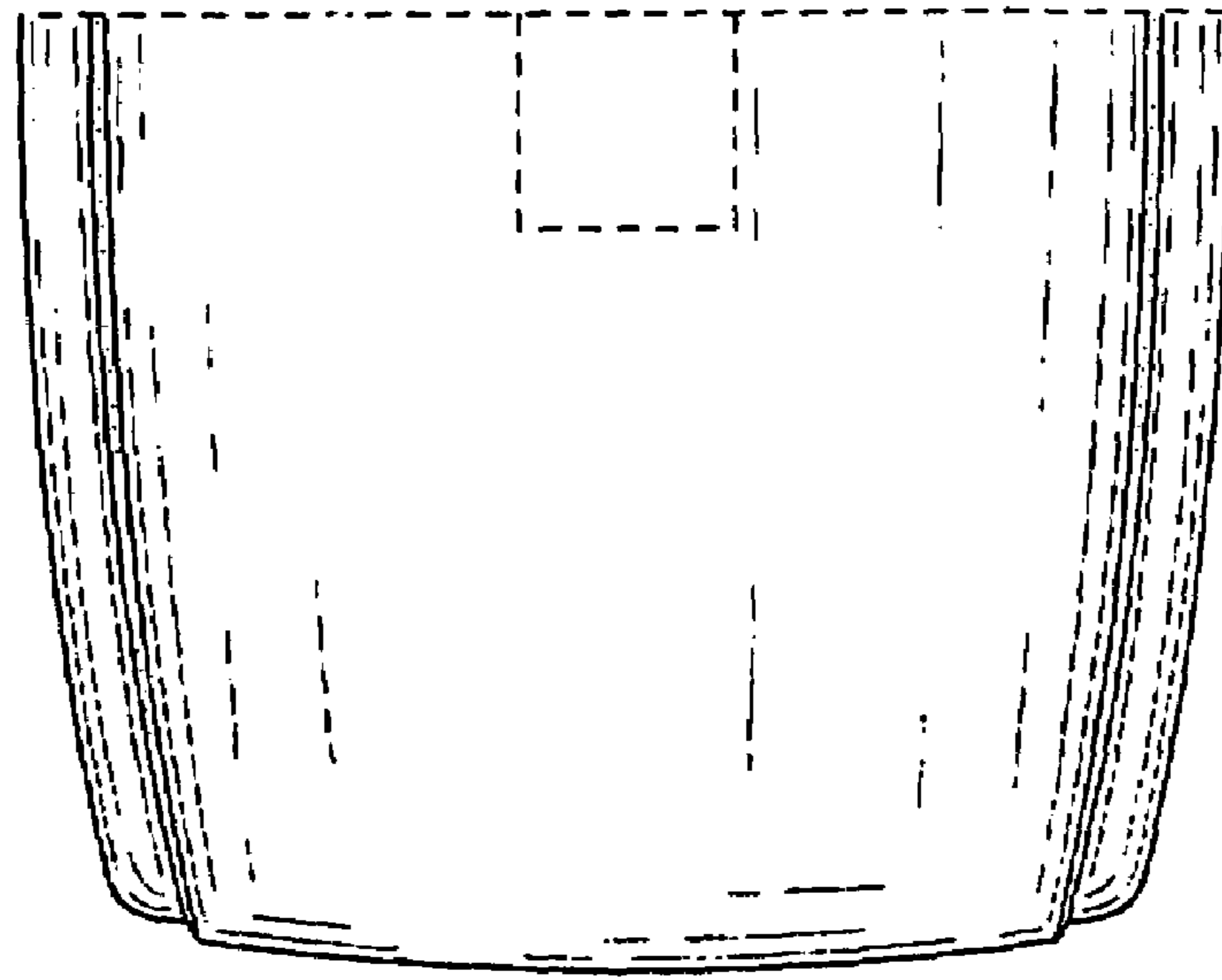

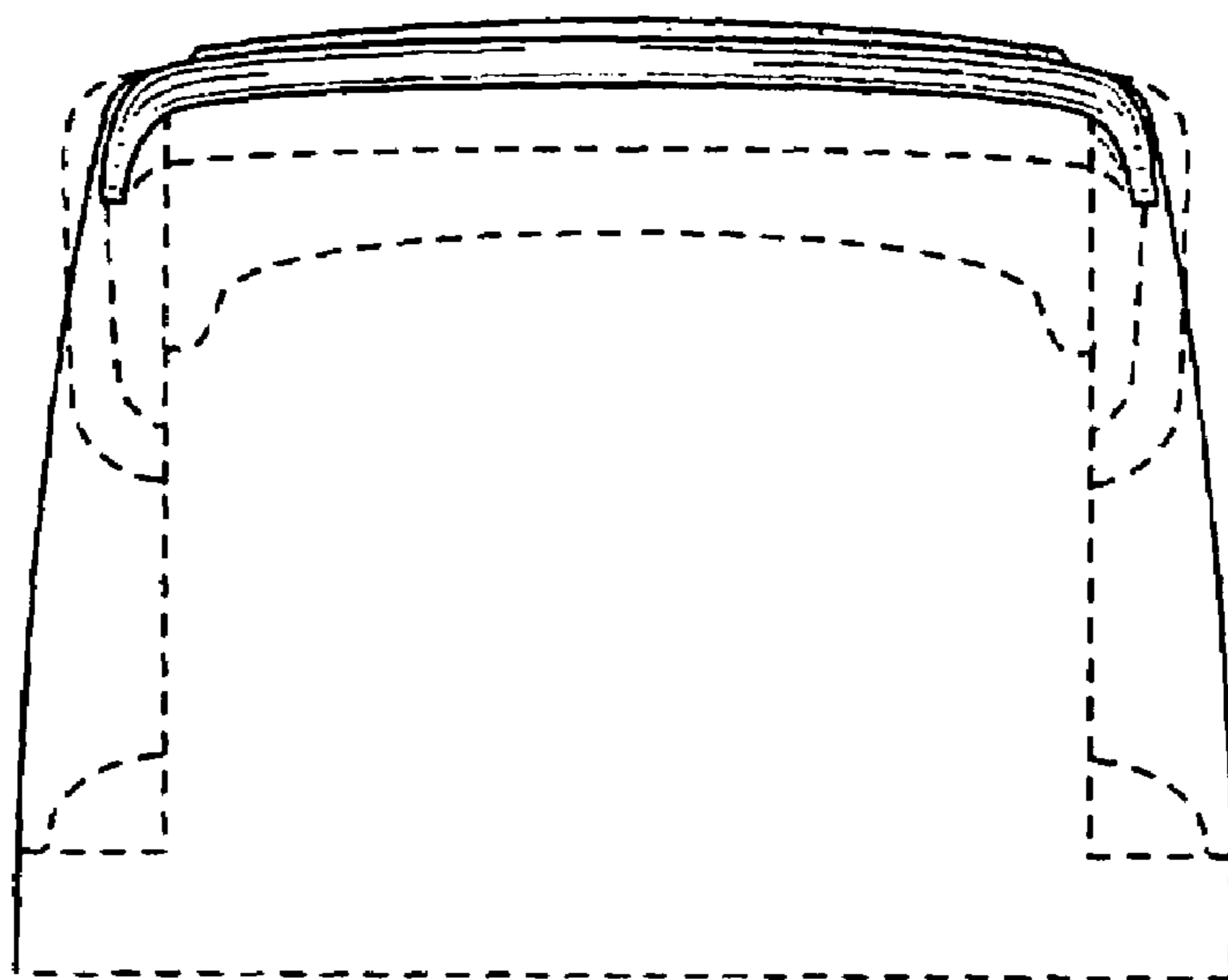
