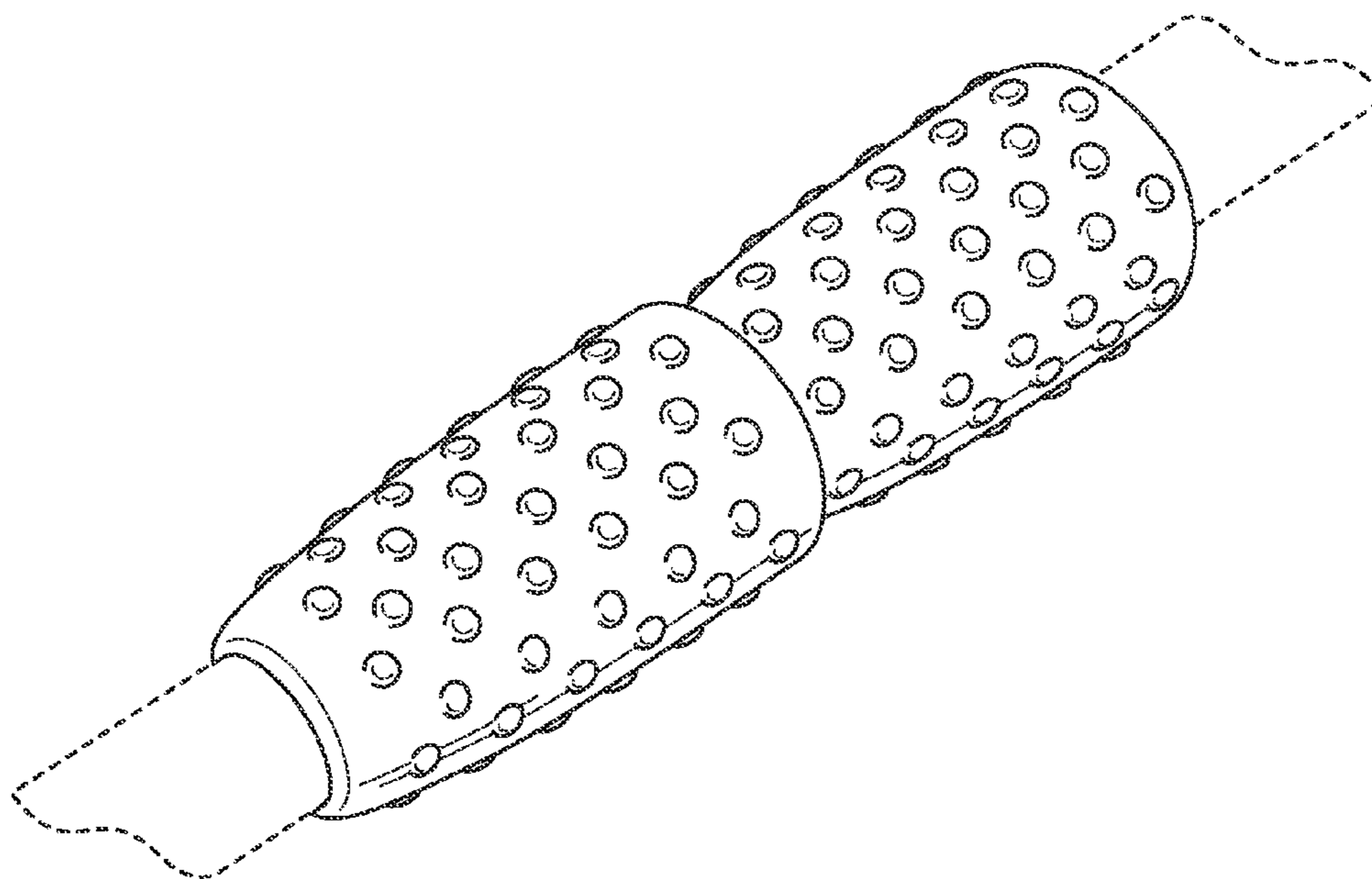
The ornamental design for a portion of a handle, as shown and described.

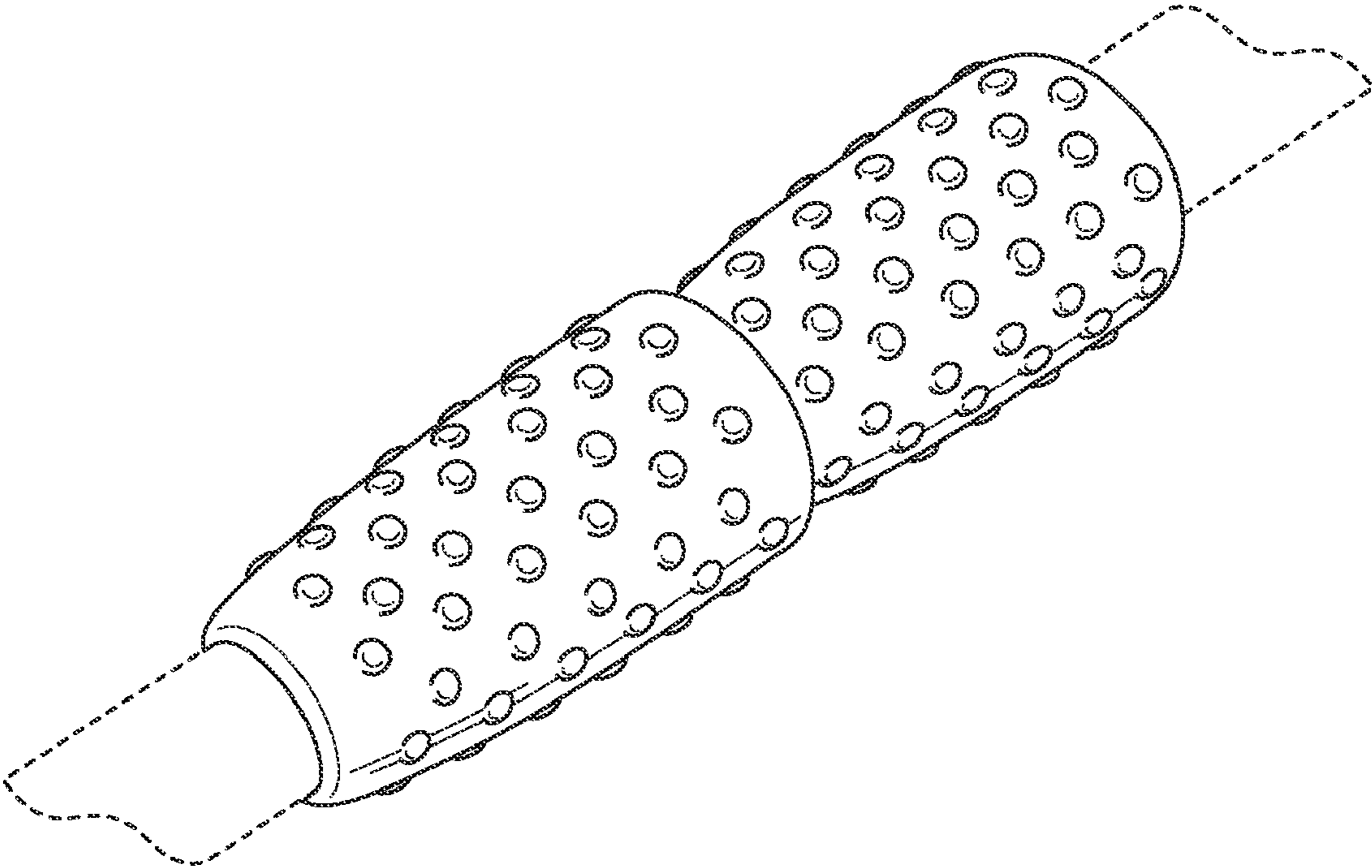

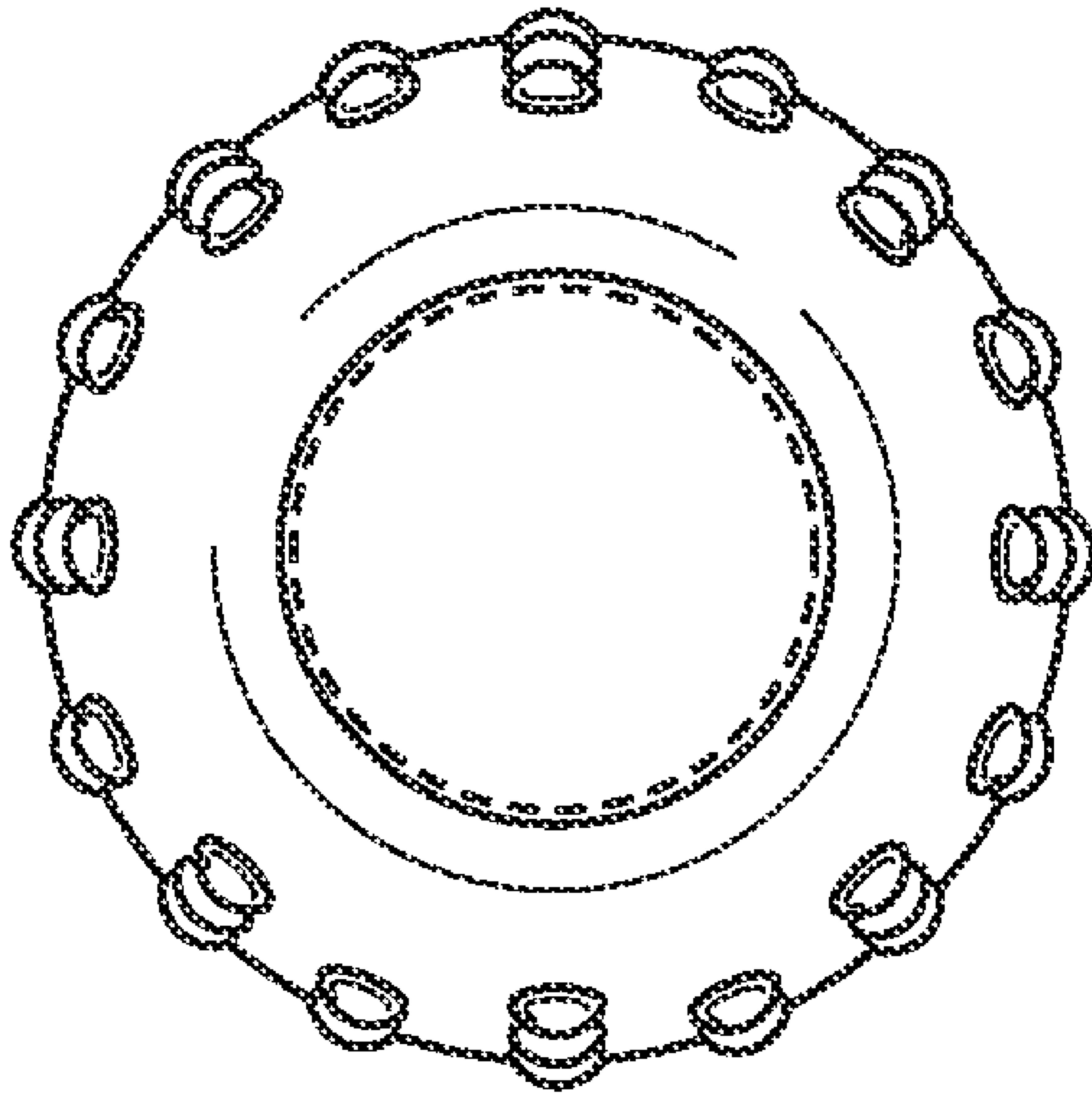

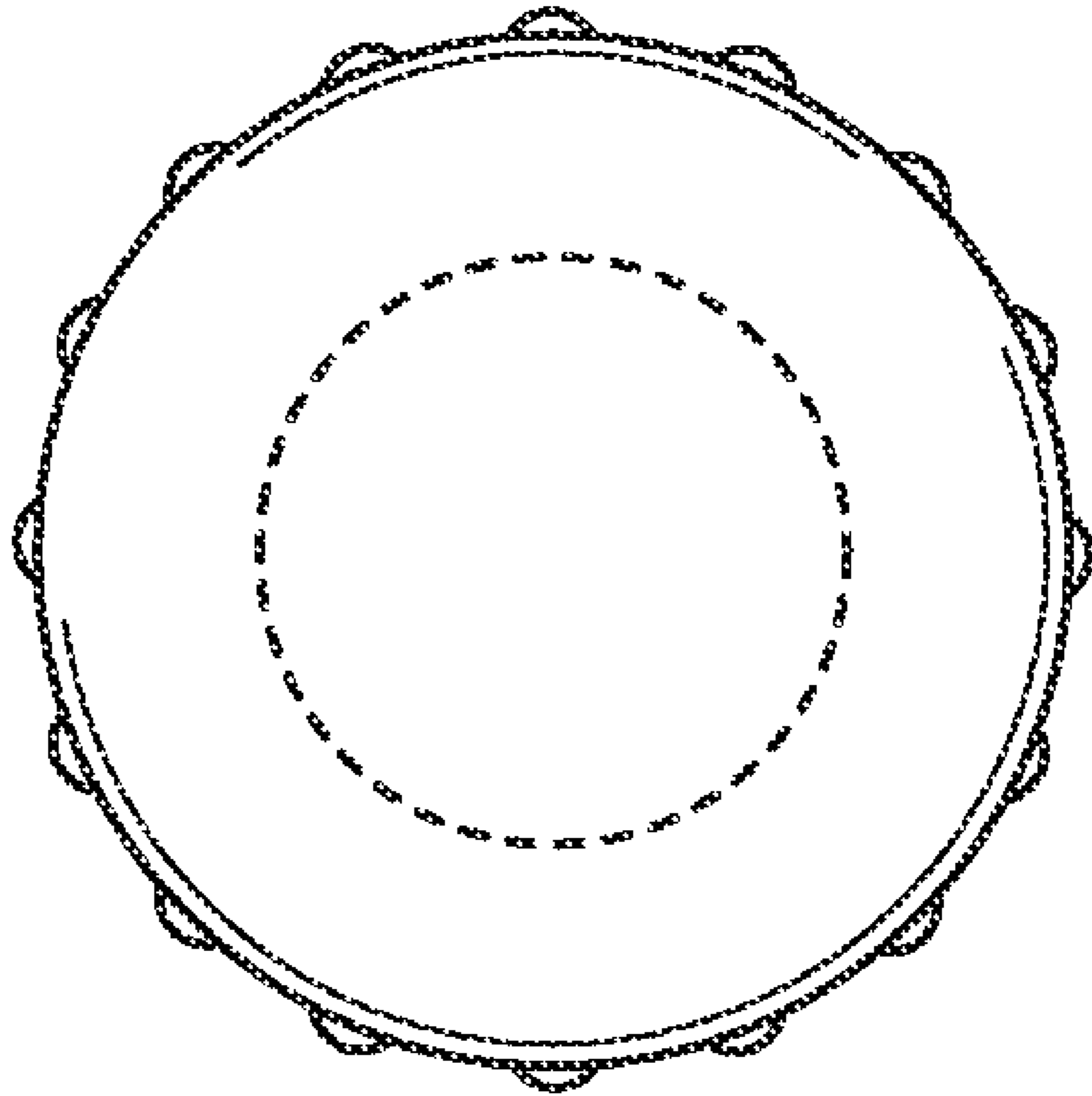

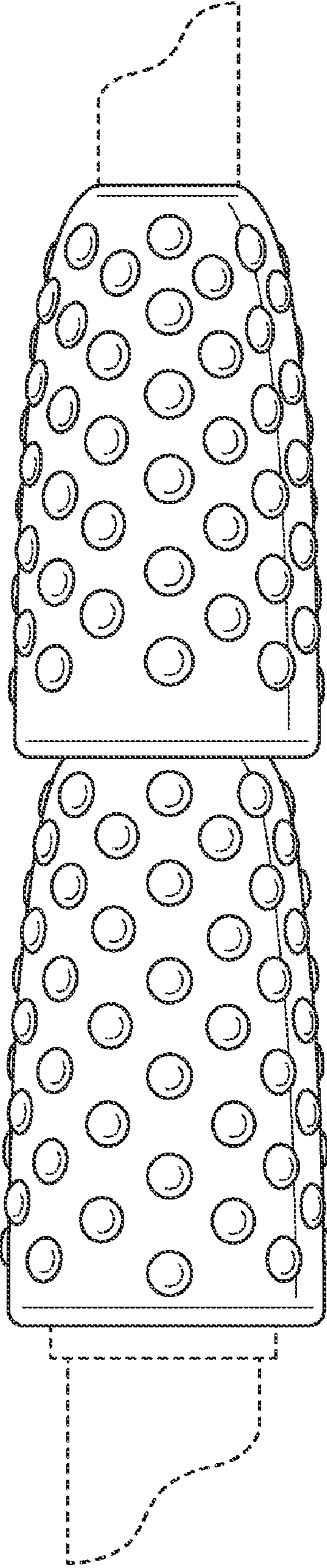

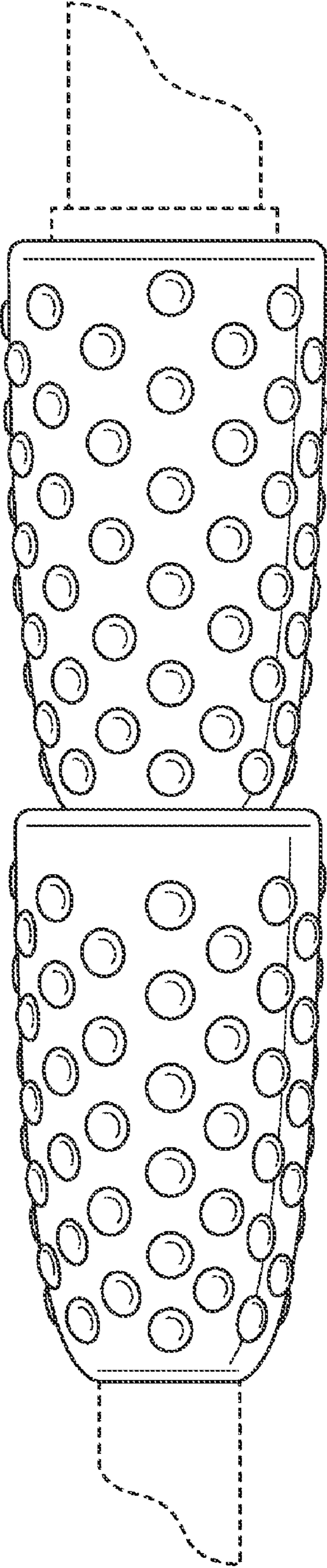

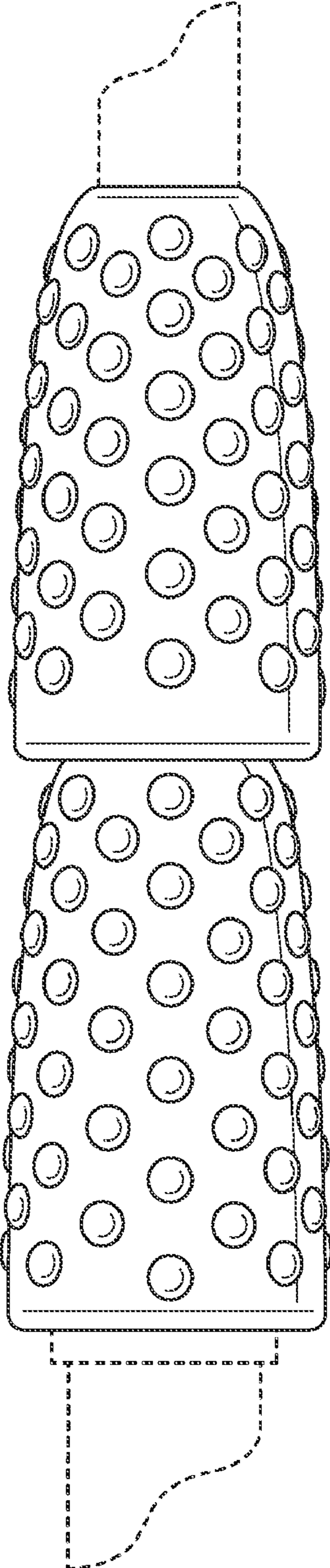

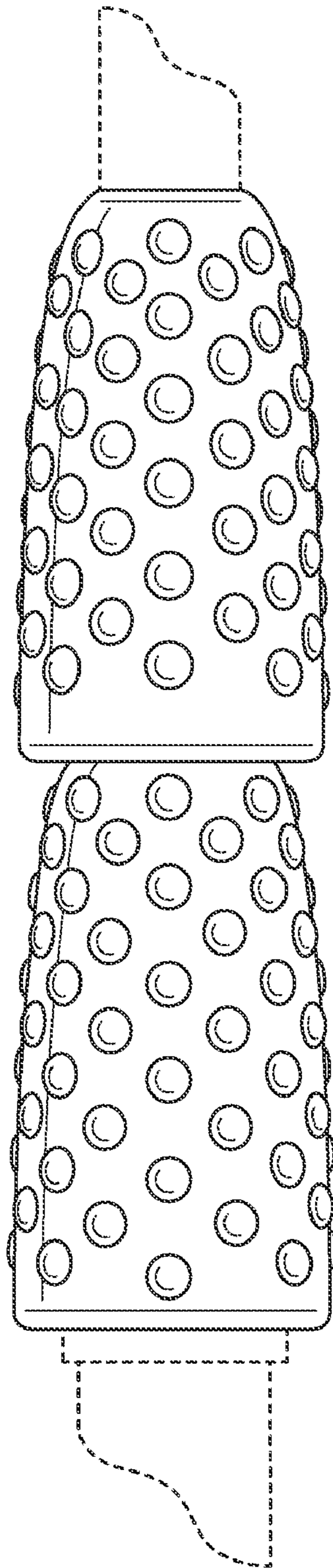
