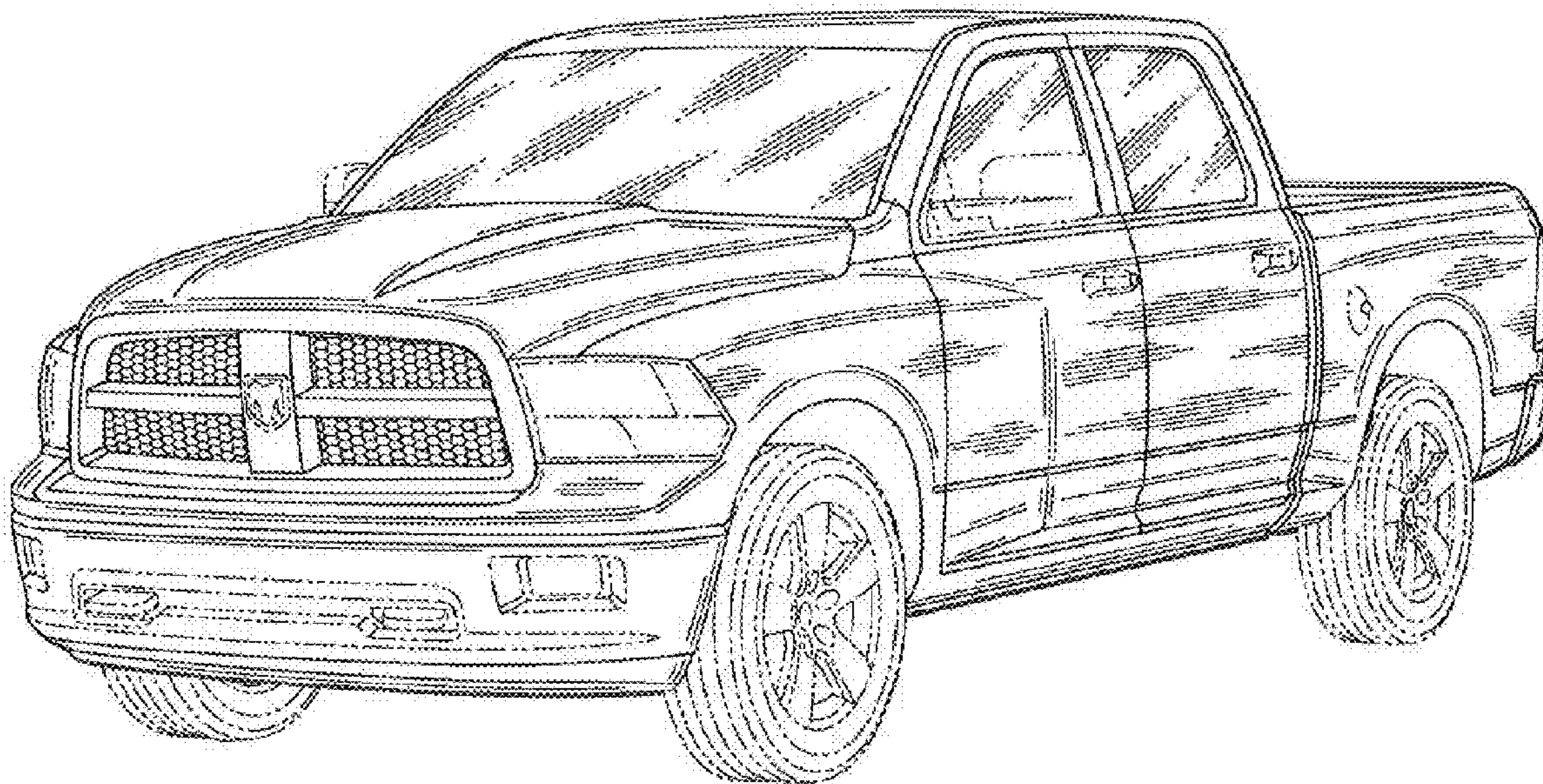
FIG. 7 is a side view of FIG. 6;

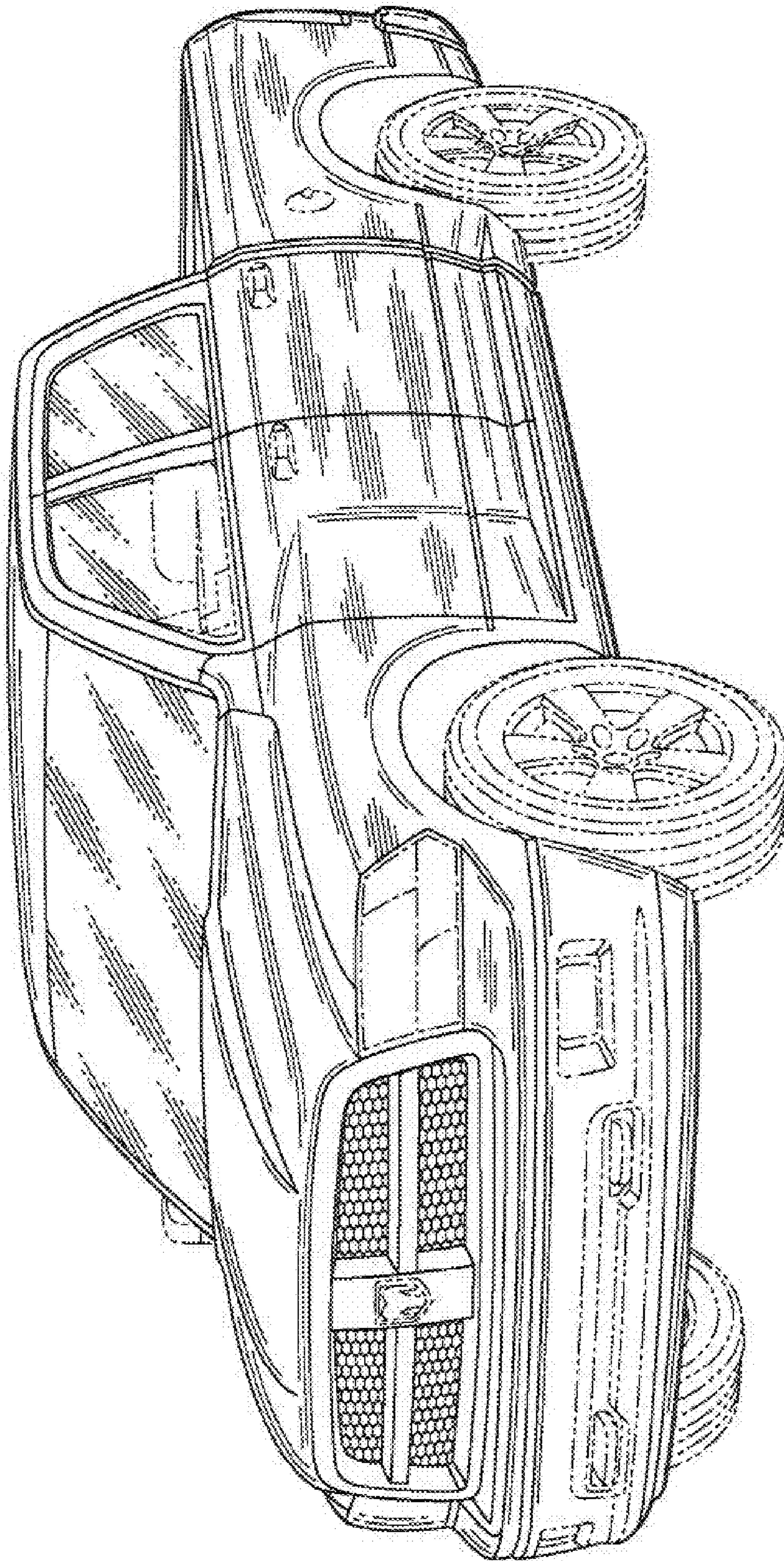

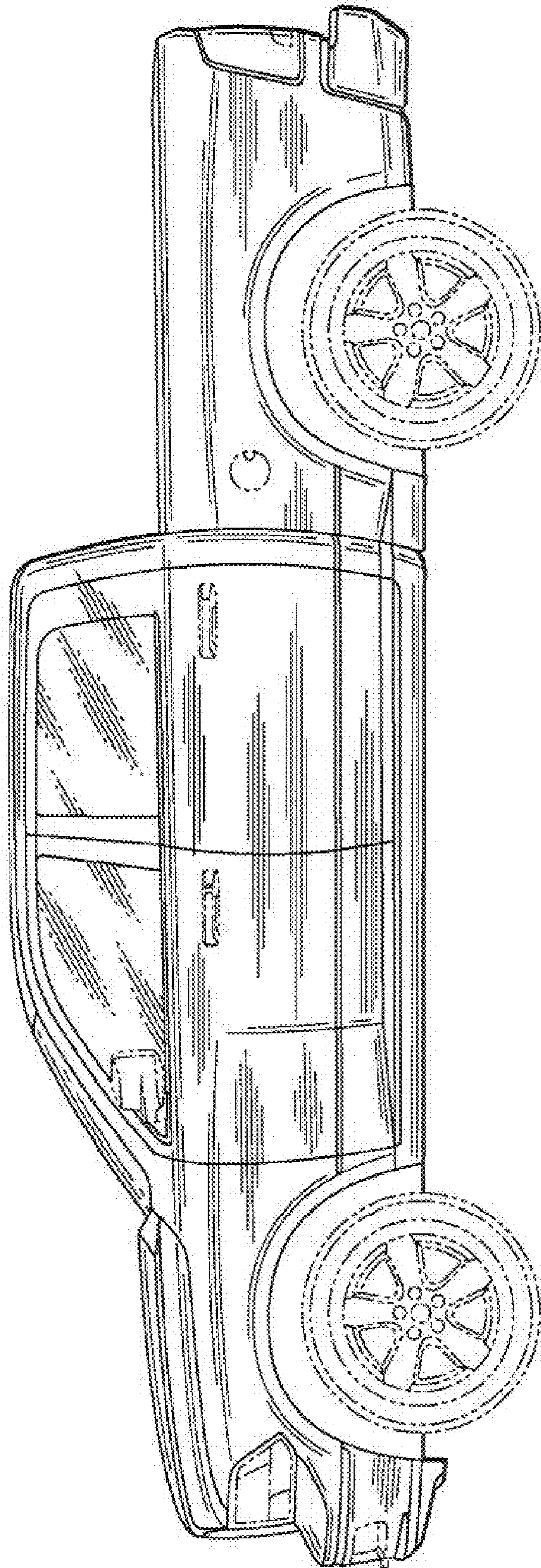

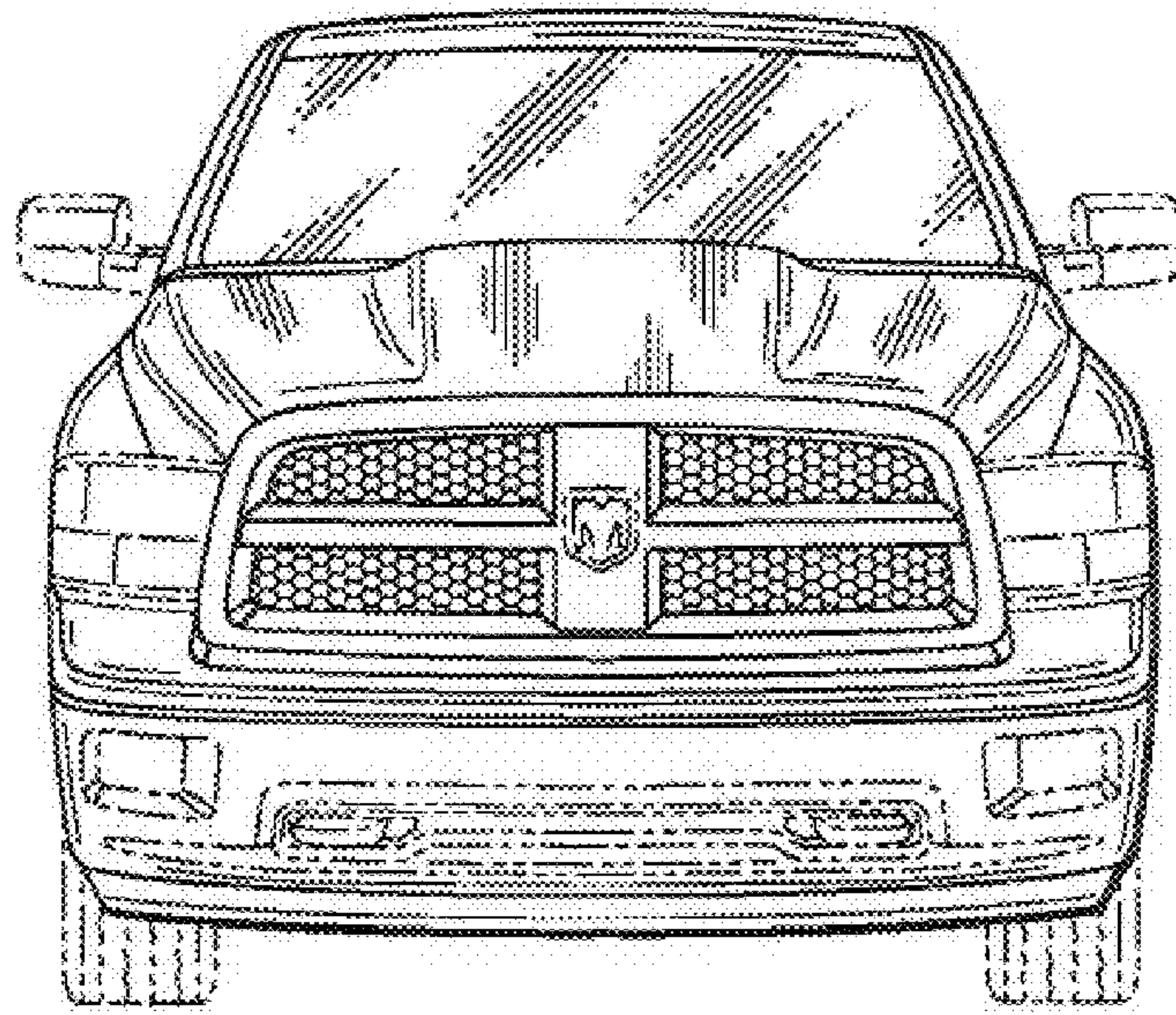

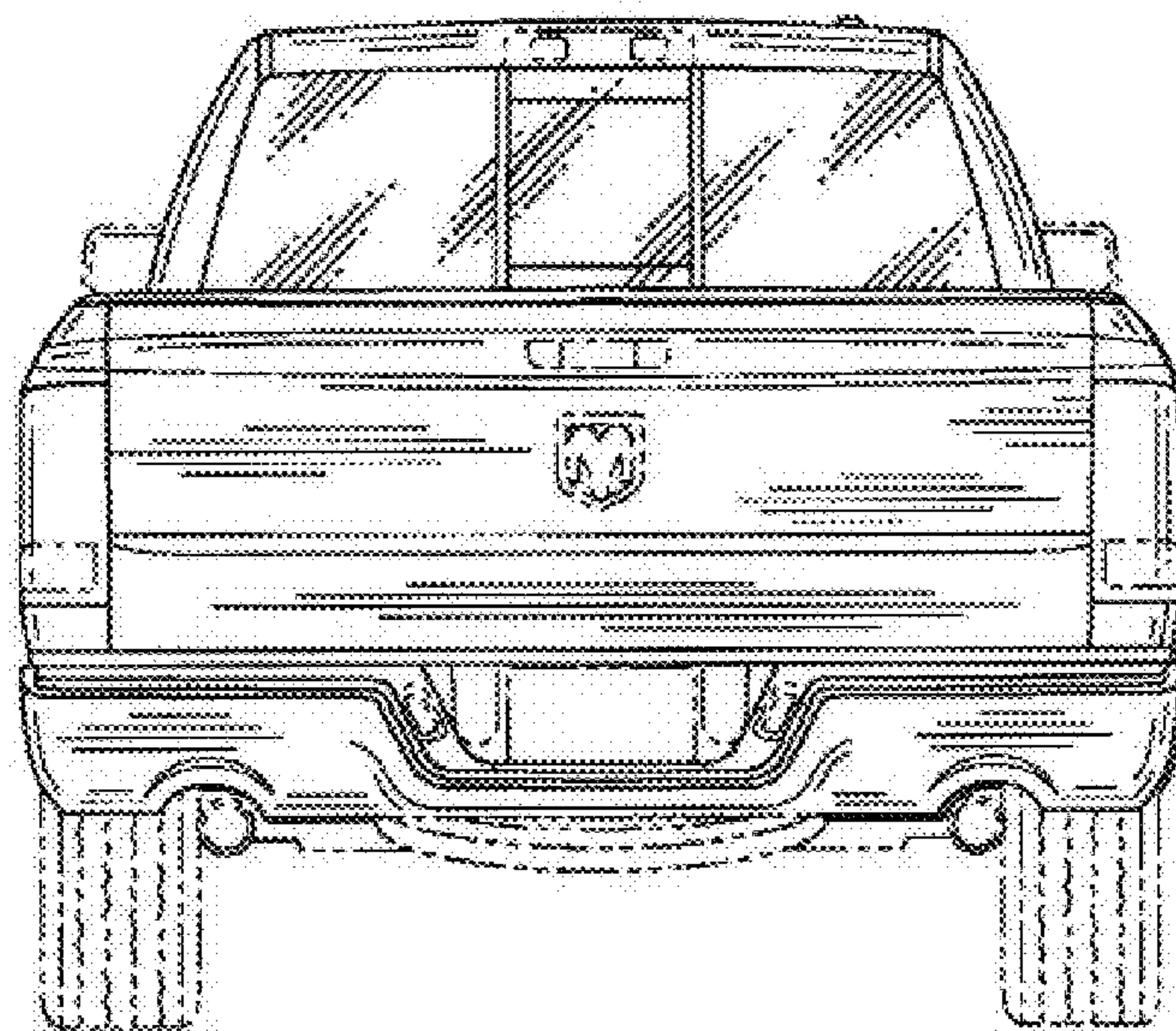

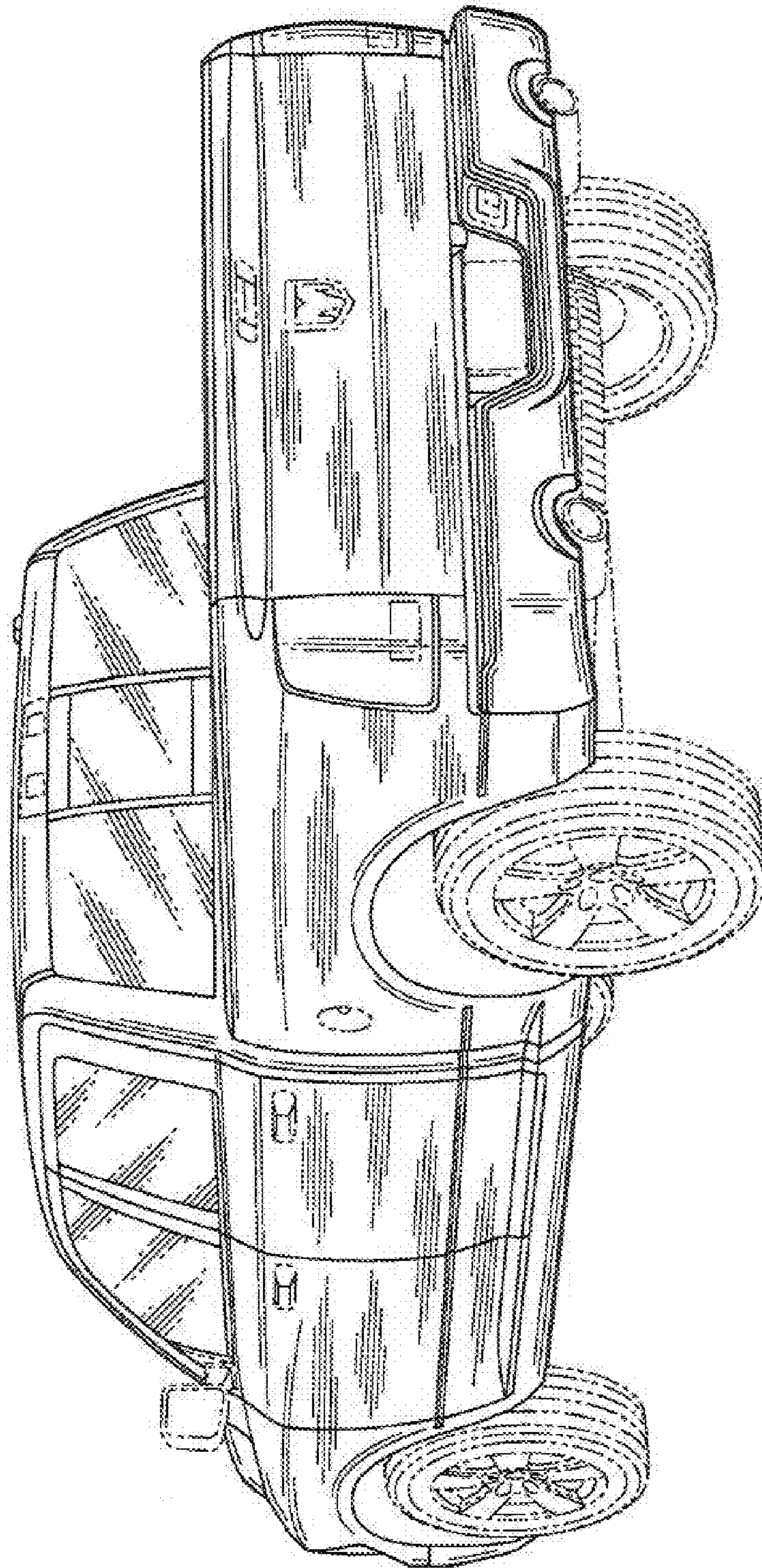

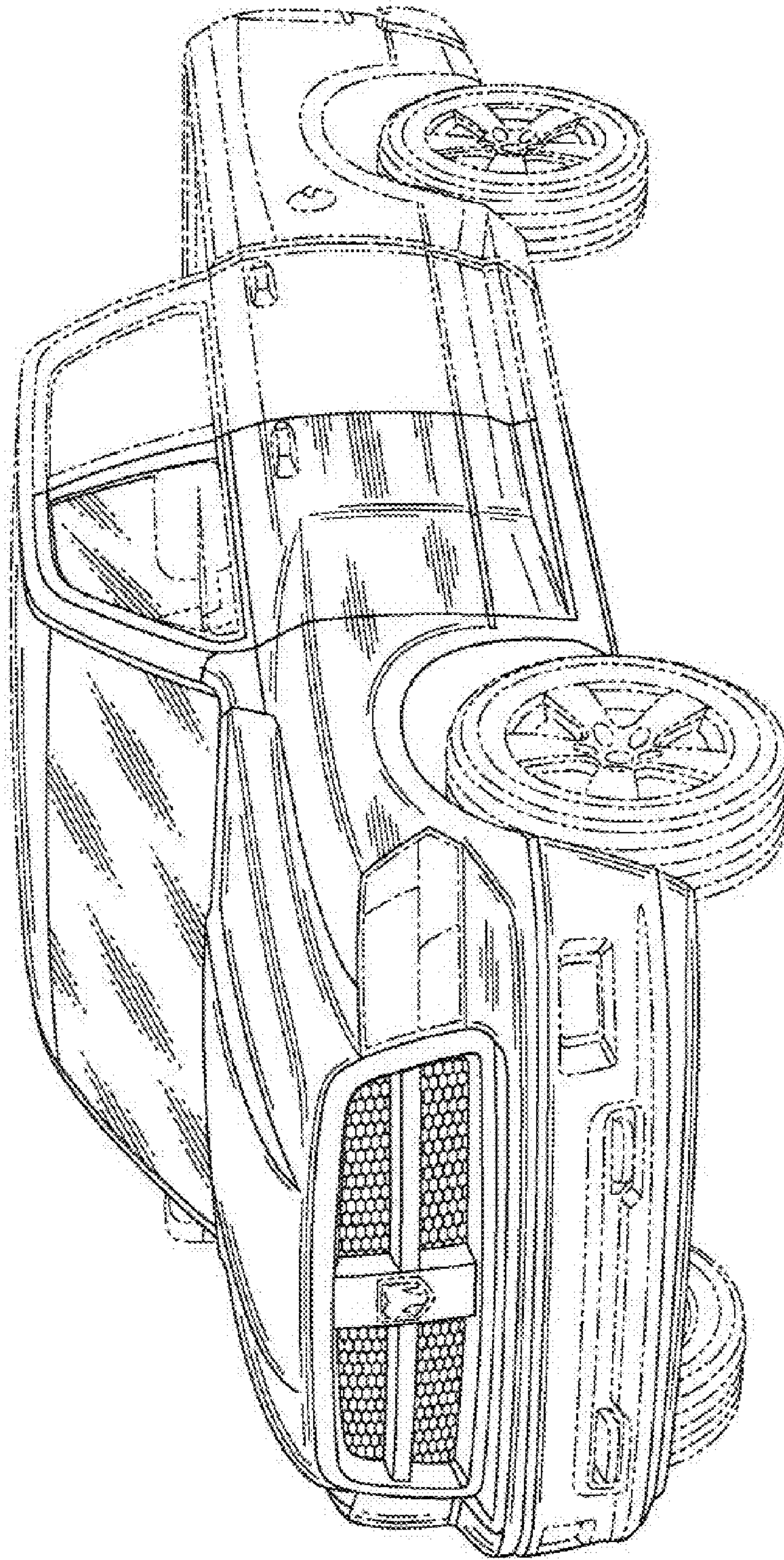

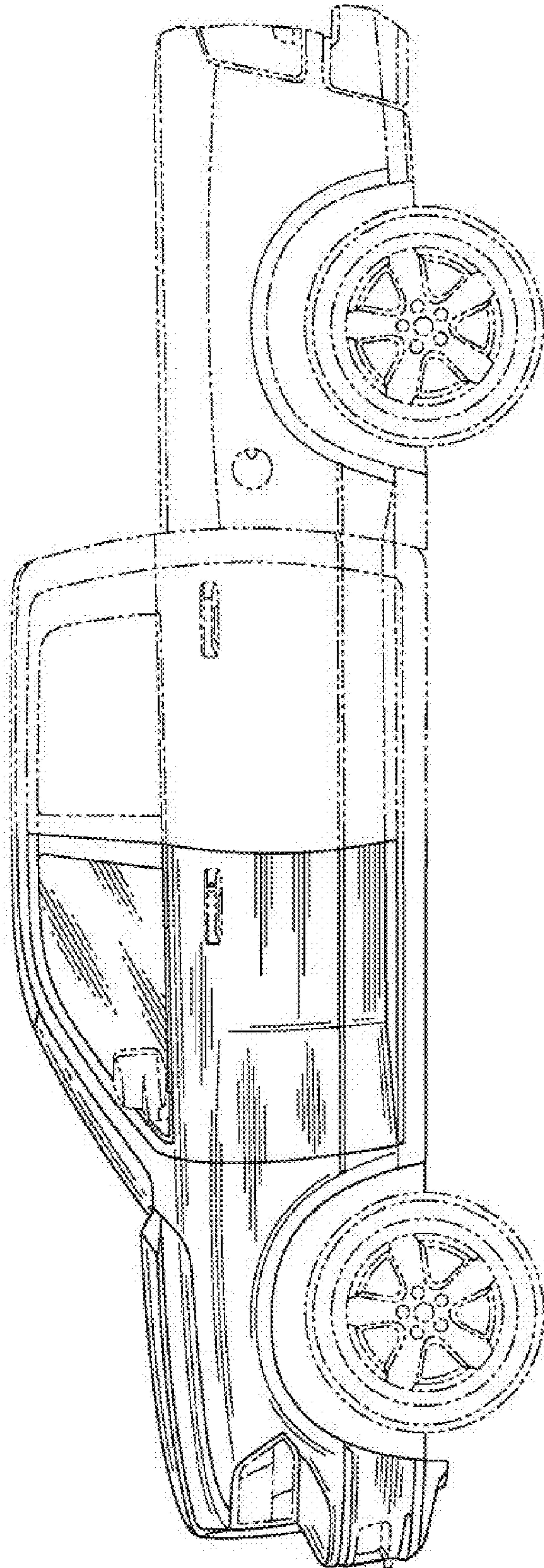

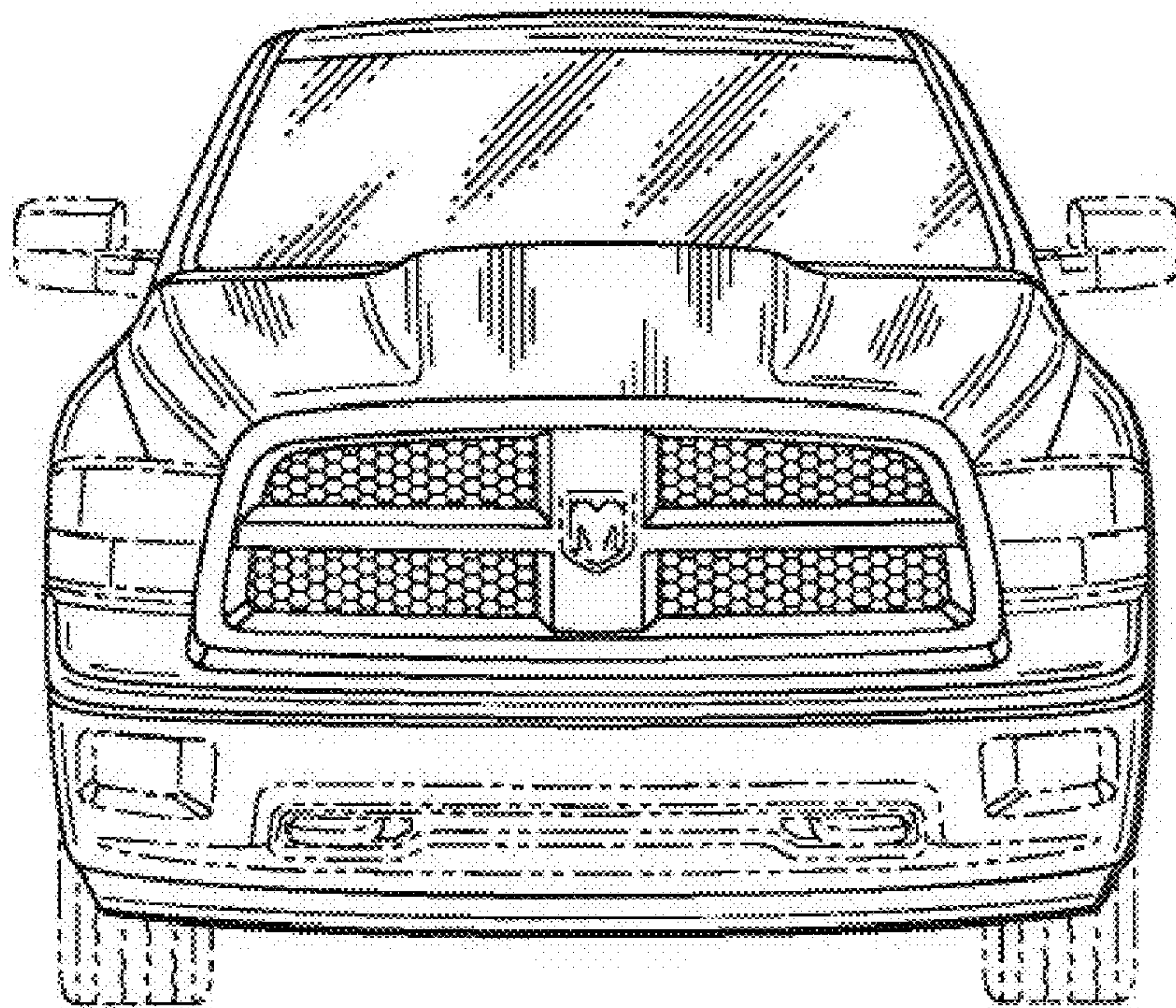

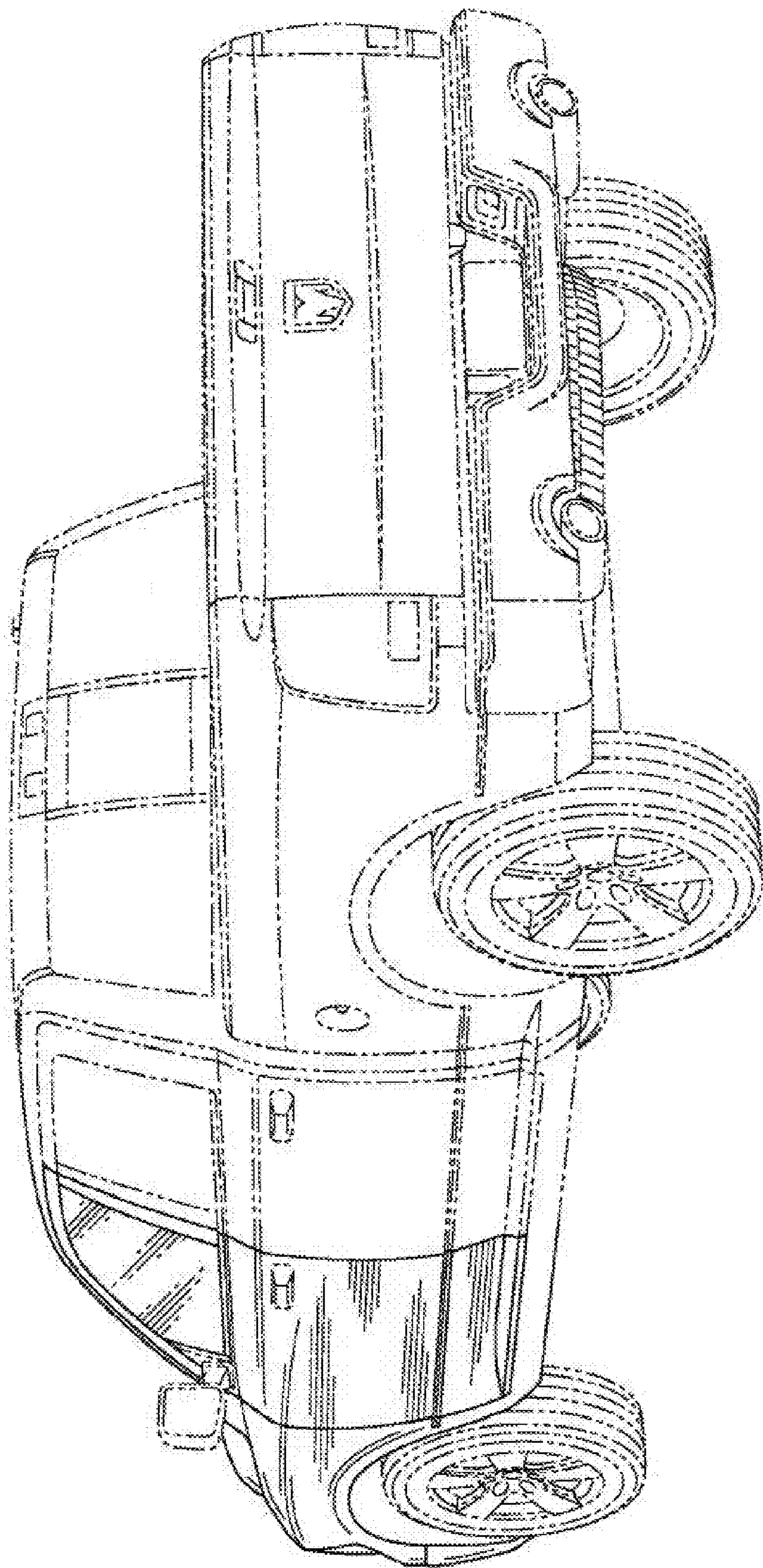
