FIG. 1 is a perspective view of a bucket organizer and storage means for pick-up trucks showing my new design;

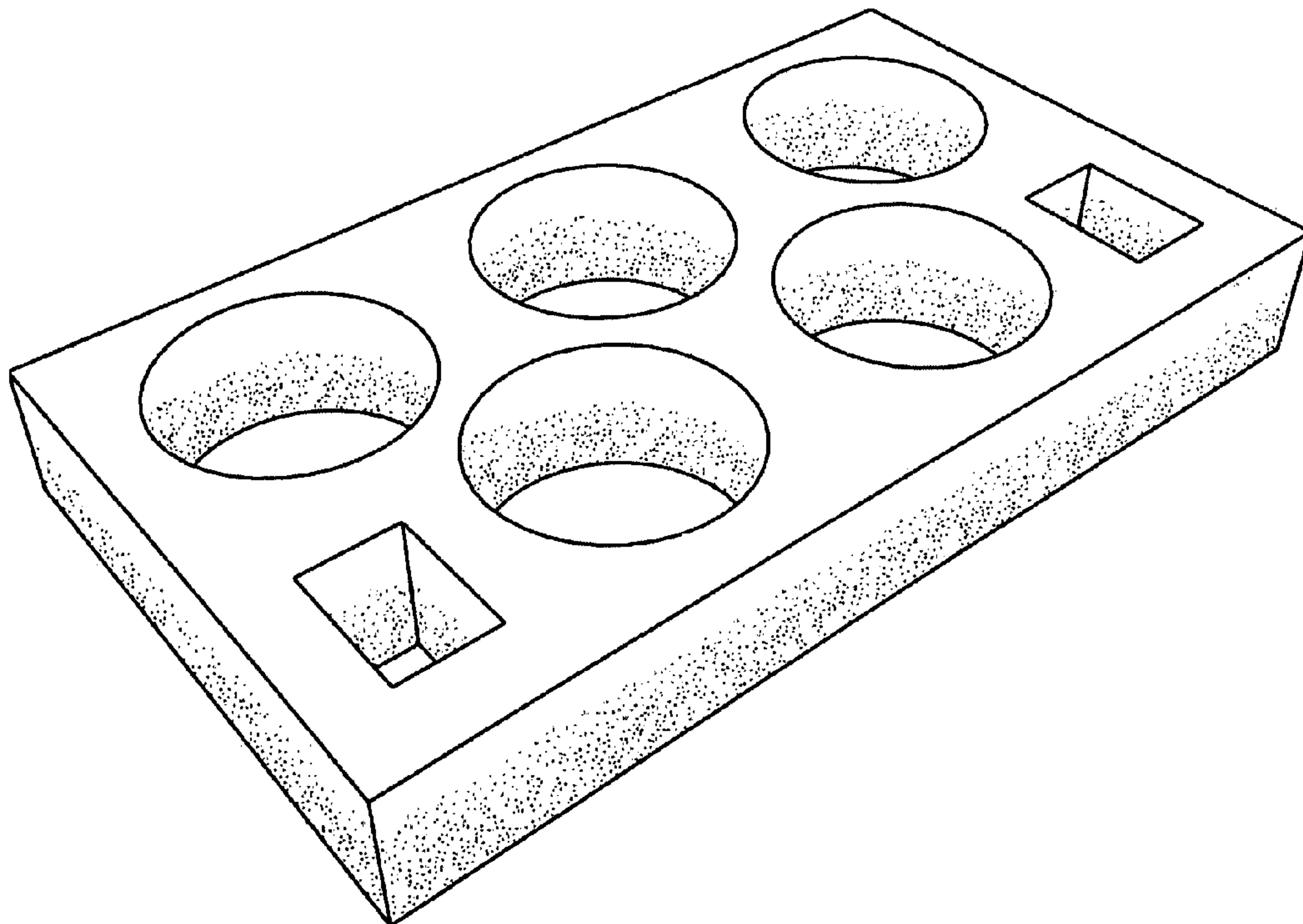
FIG. 2 is a front view thereof;

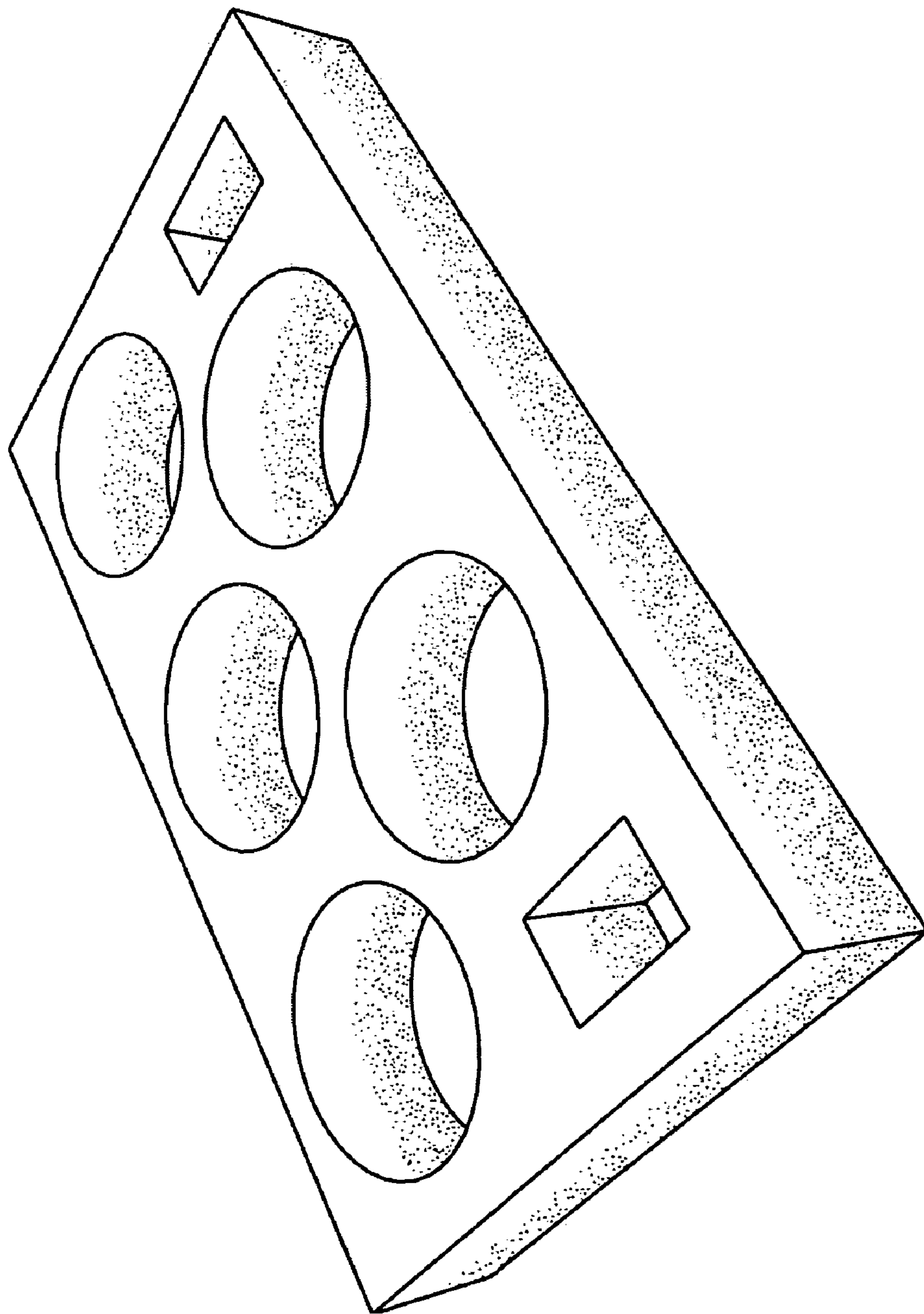

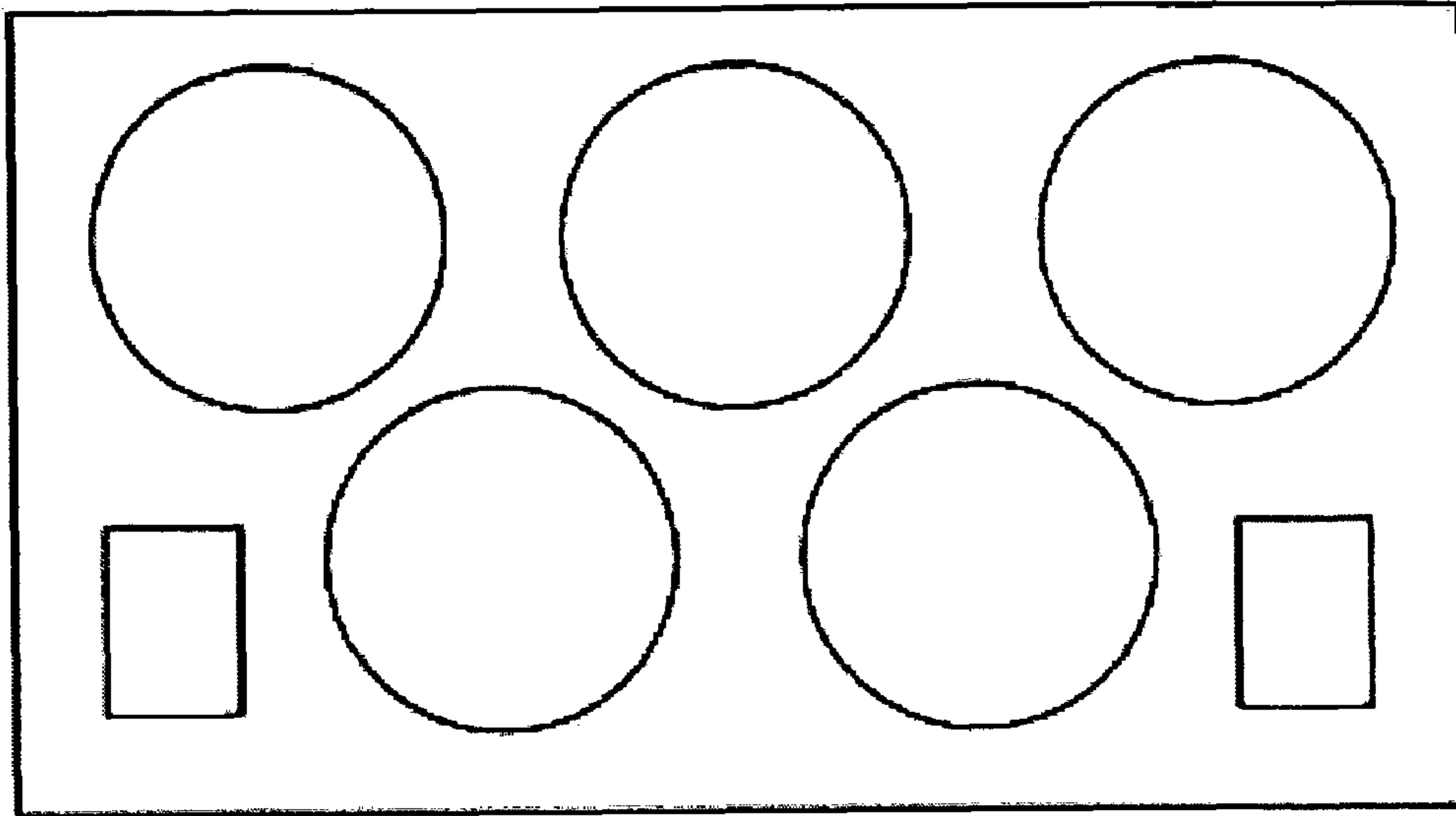

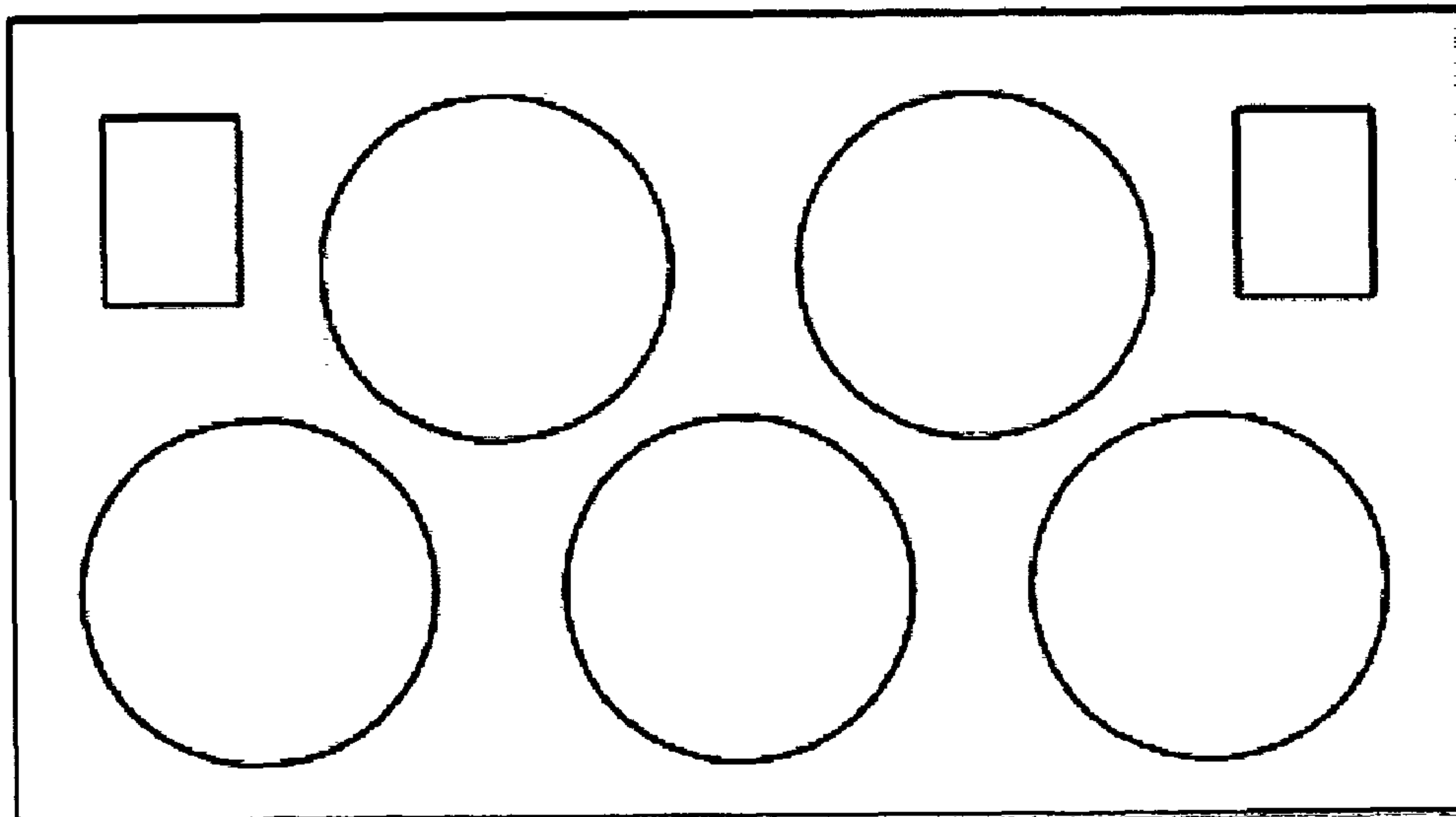
