The ornamental design for an electrical socket, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a new and ornamental design for an electrical socket;

FIG. 2 is a side elevation view thereof; the other side being a mirror image;

FIG. 3 is a front-elevation view thereof;

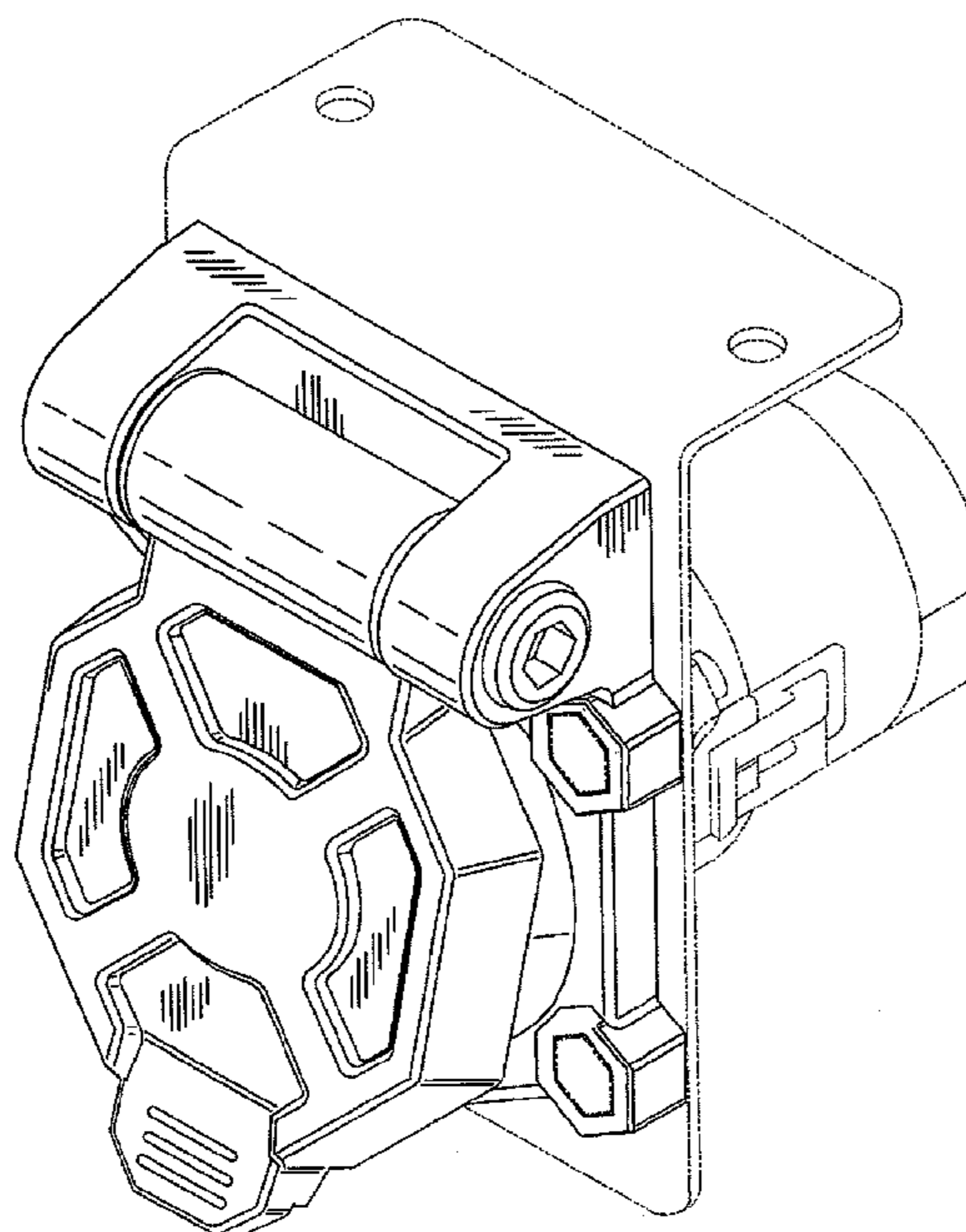
FIG. 4 is a rear elevation view thereof;

FIG. 5 is a top plan view thereof; and,

FIG. 6 is a bottom plan view thereof.

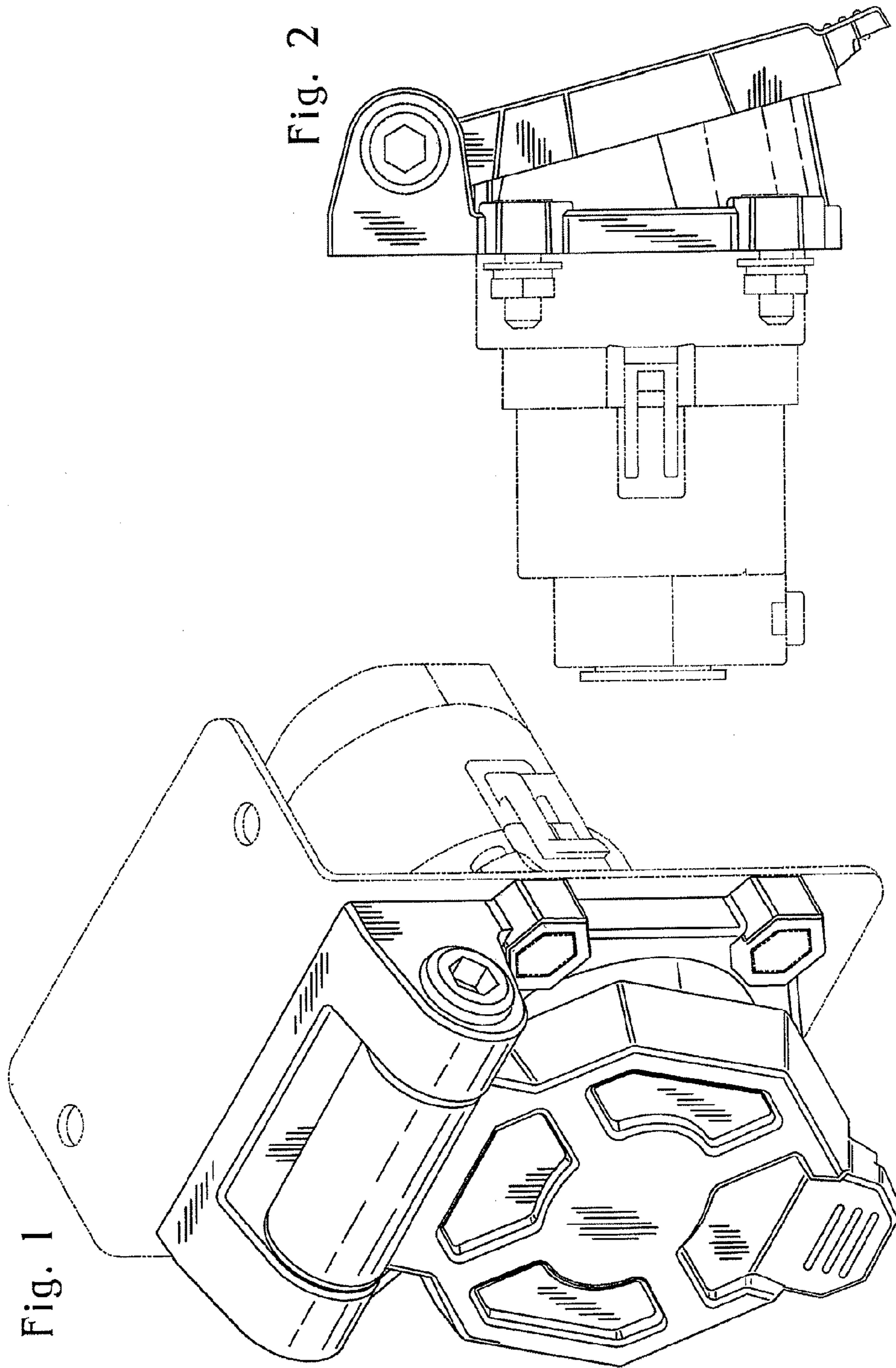

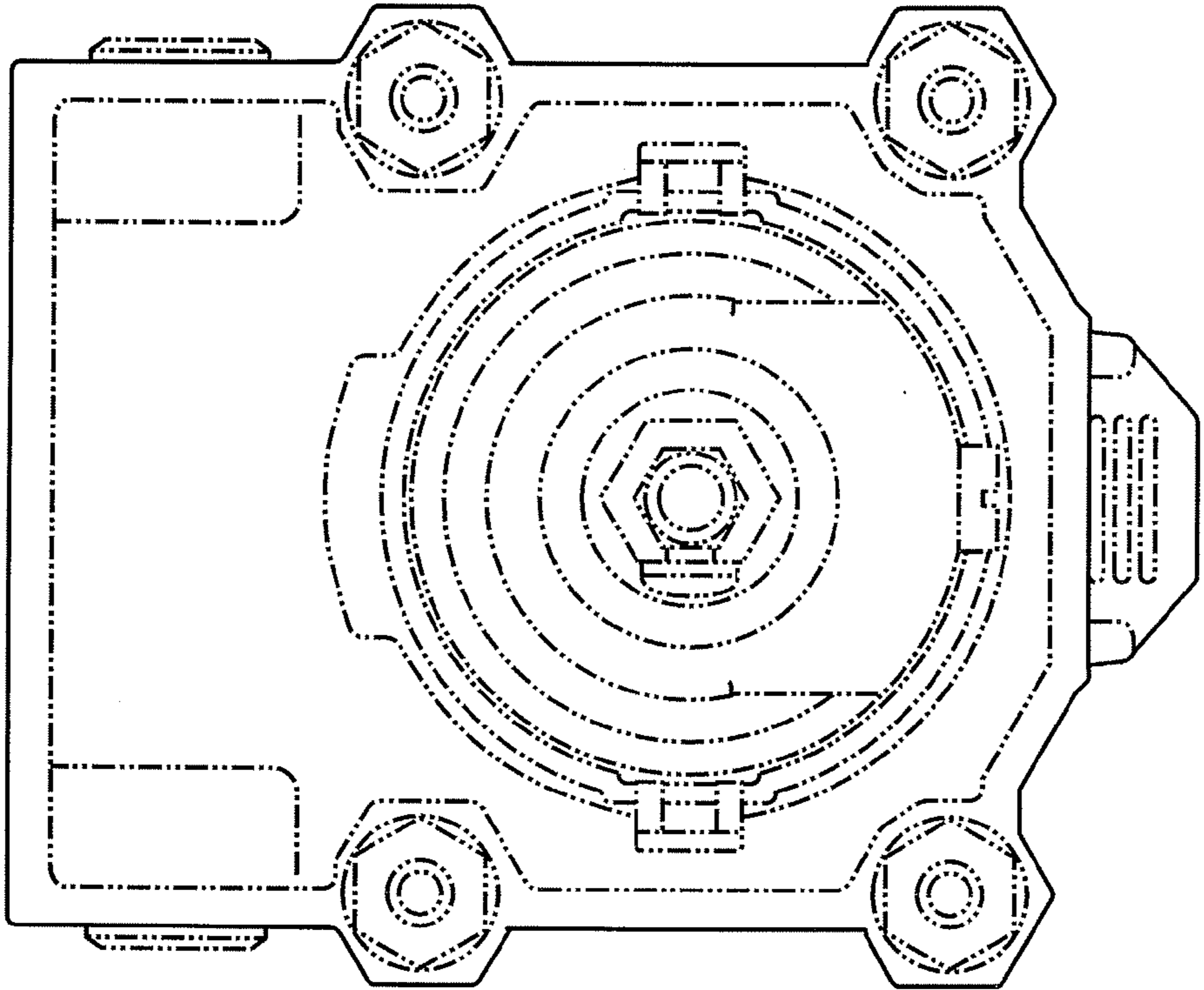

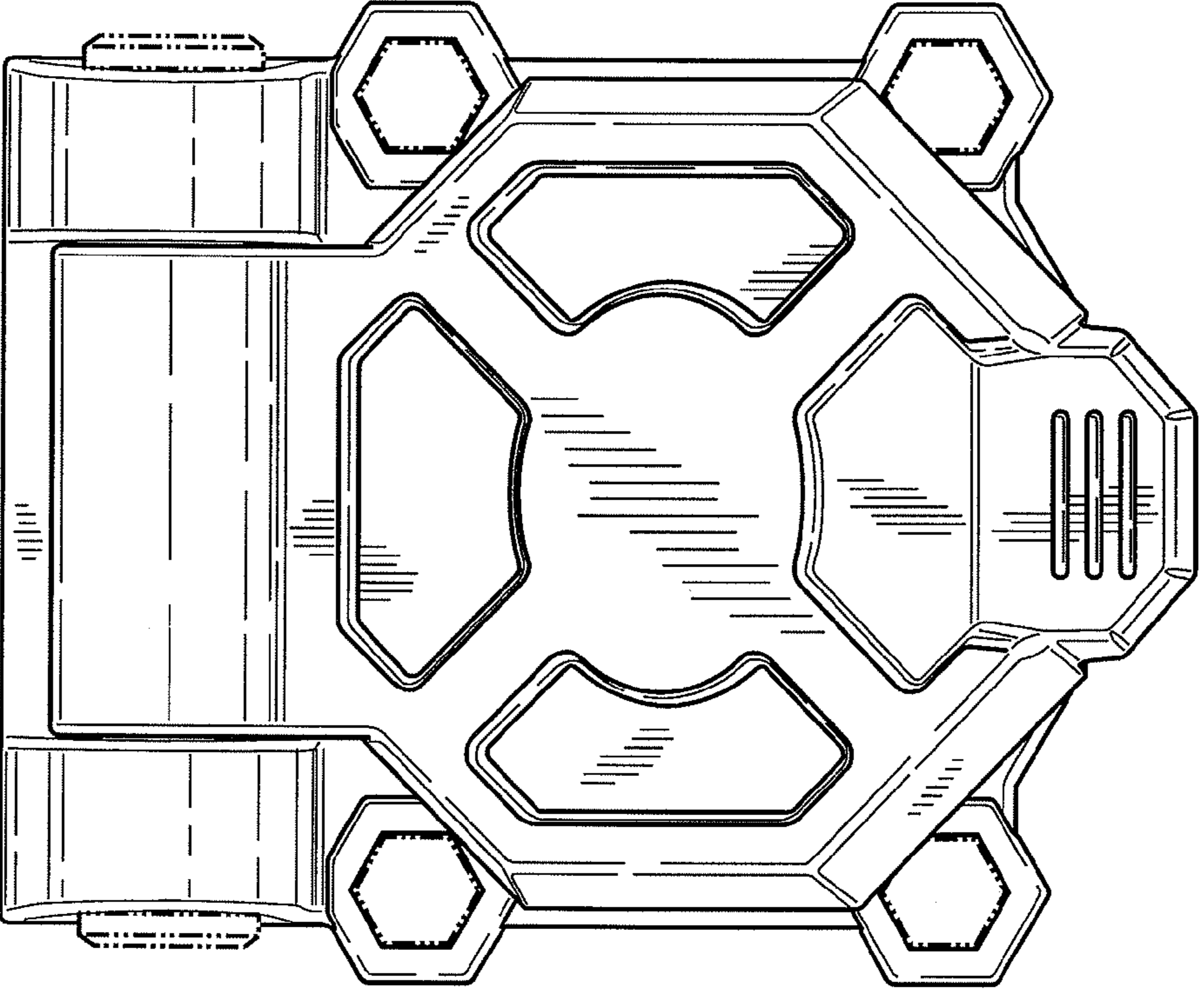

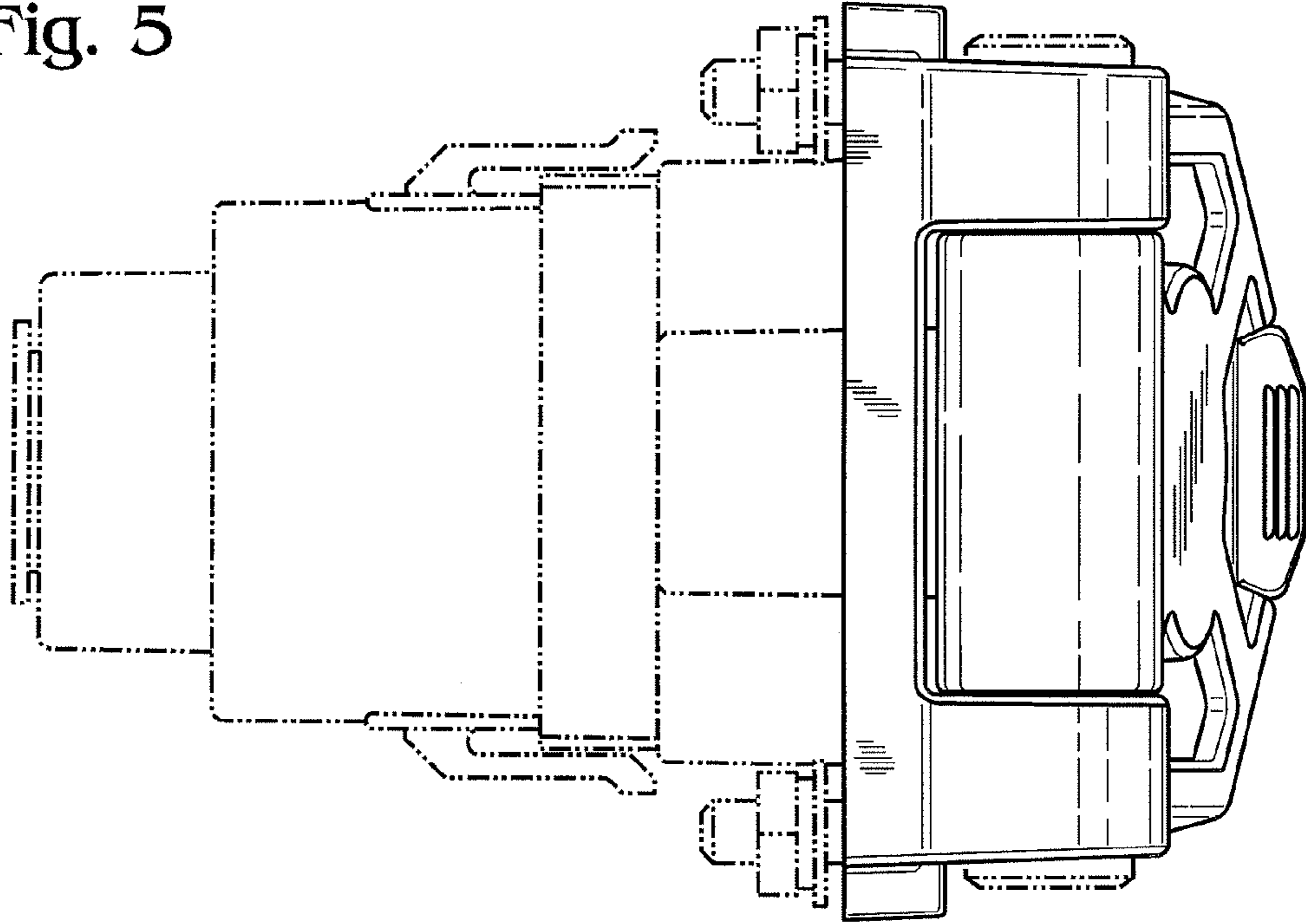
