FIG. 11 is a rear perspective view of a handset in an open, in-use position thereof.

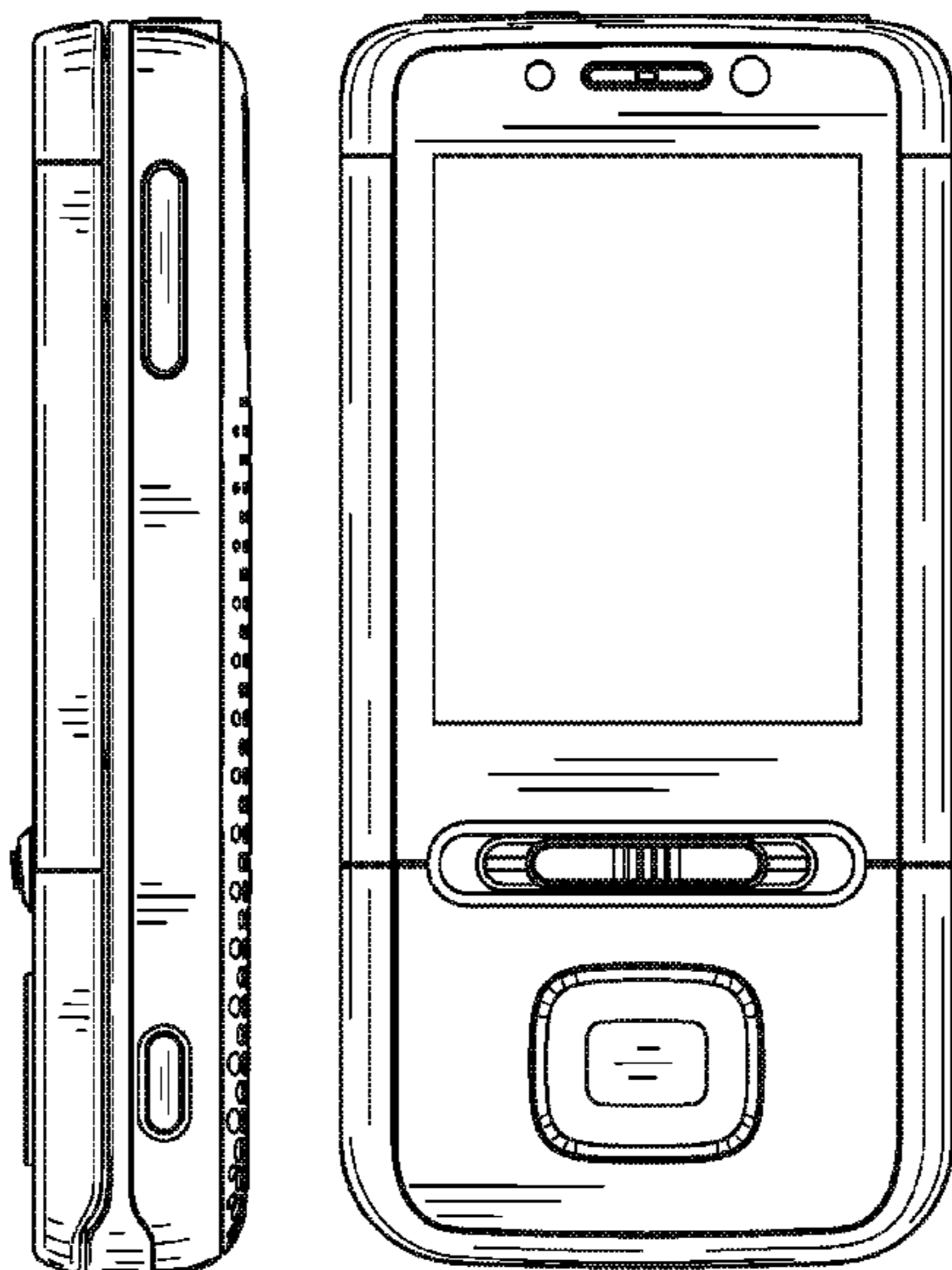

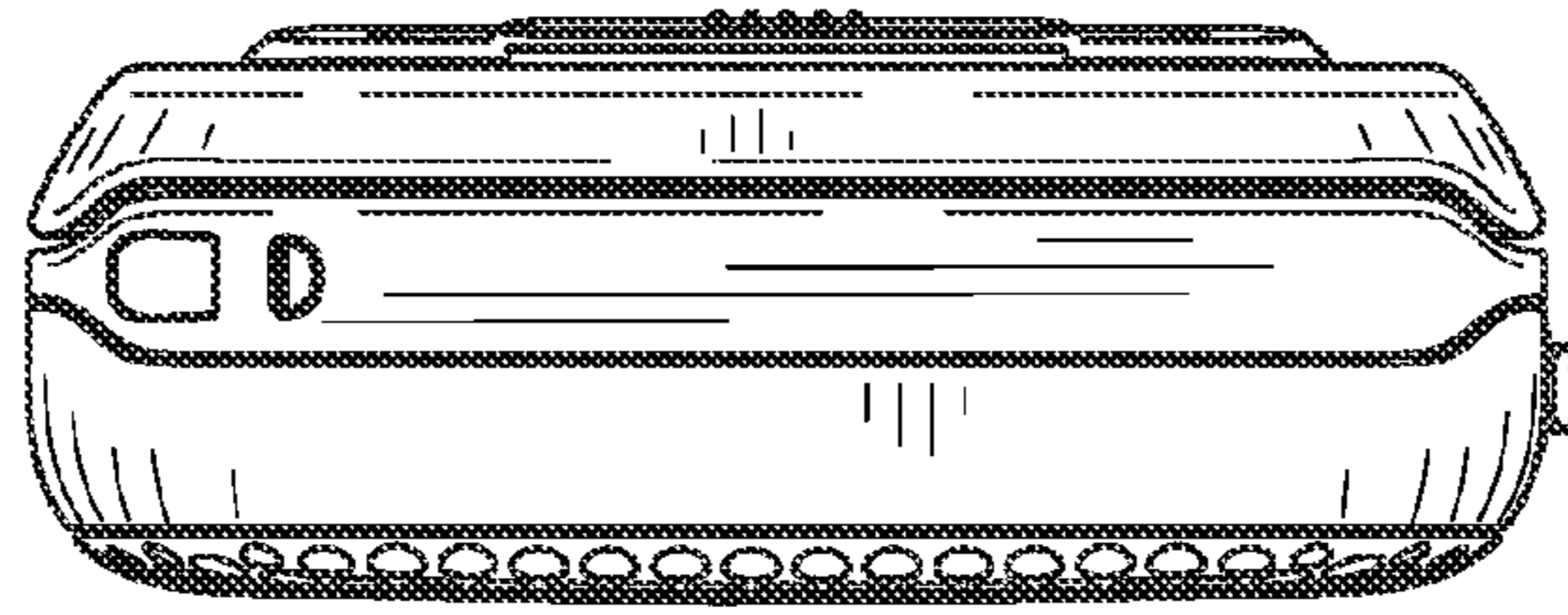

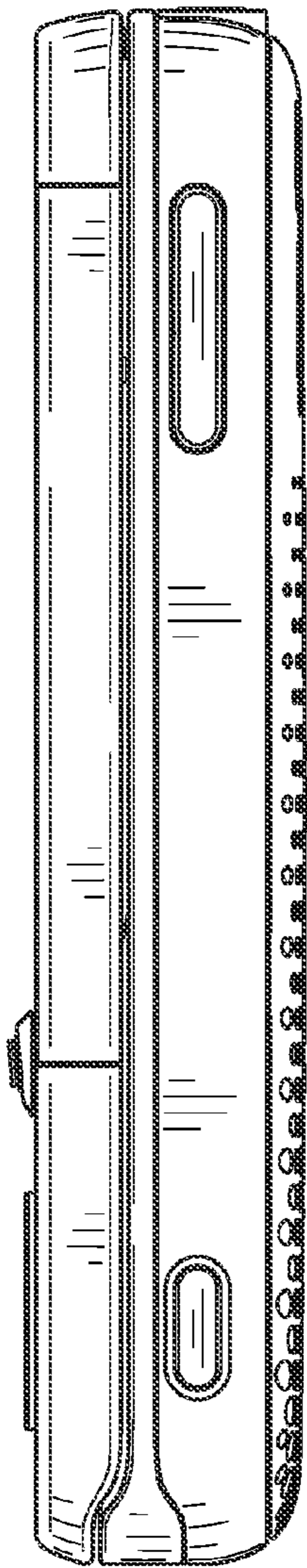

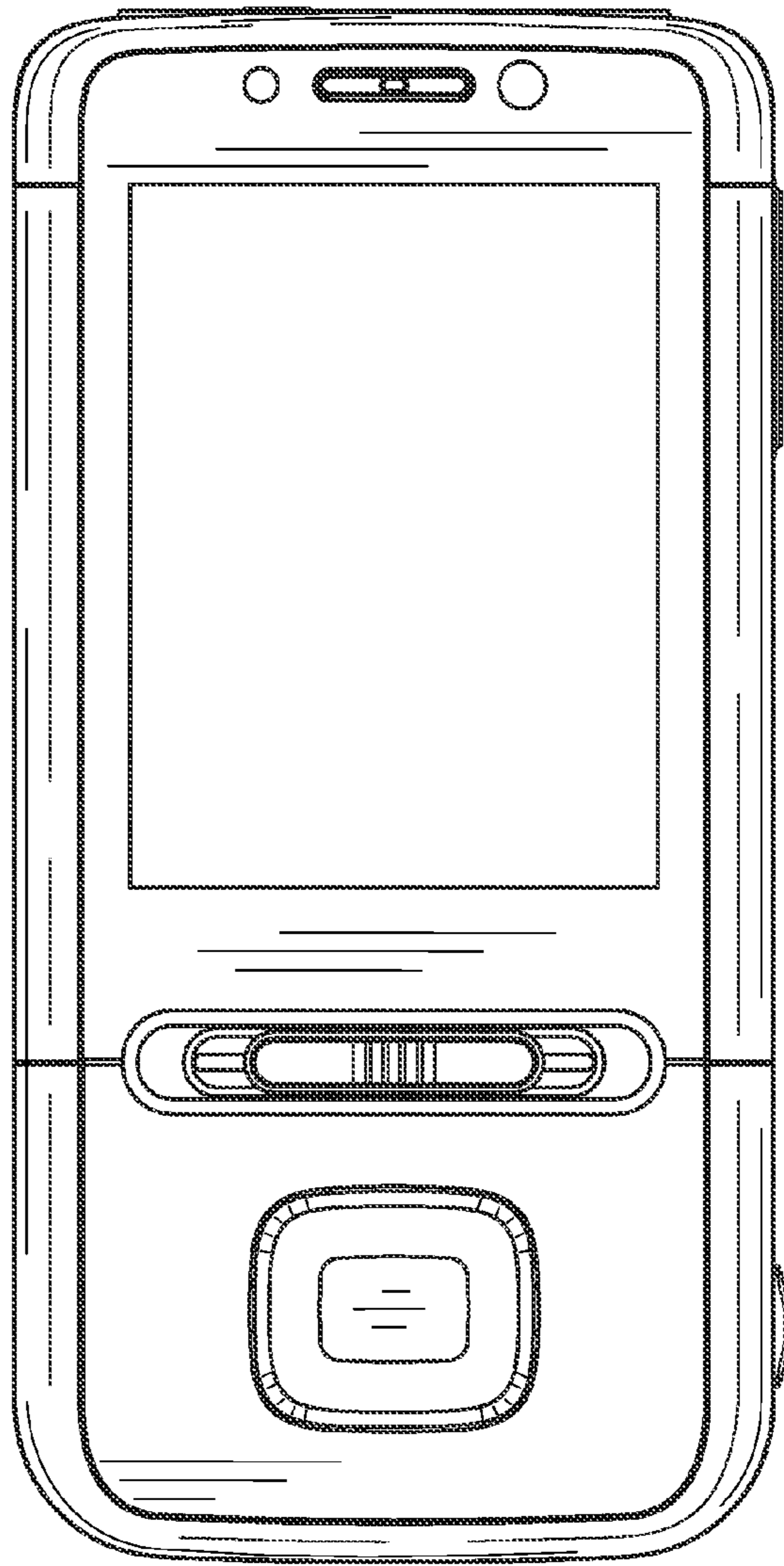

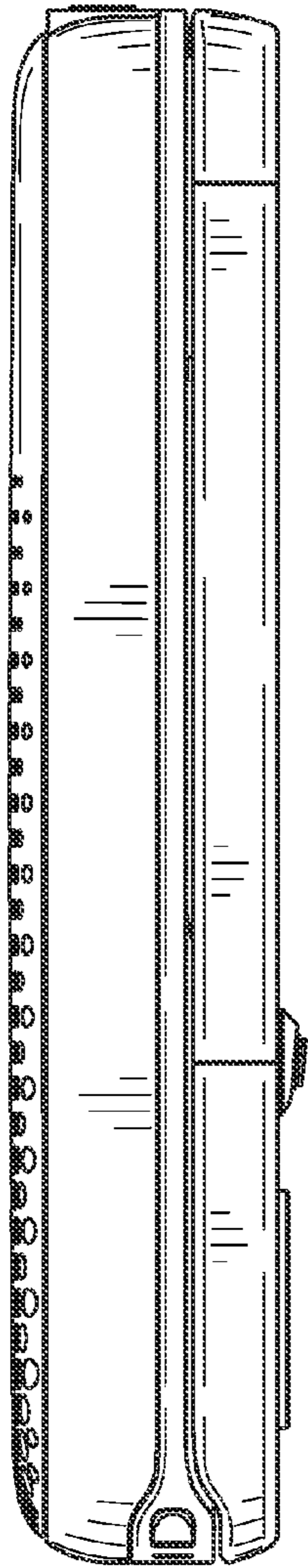

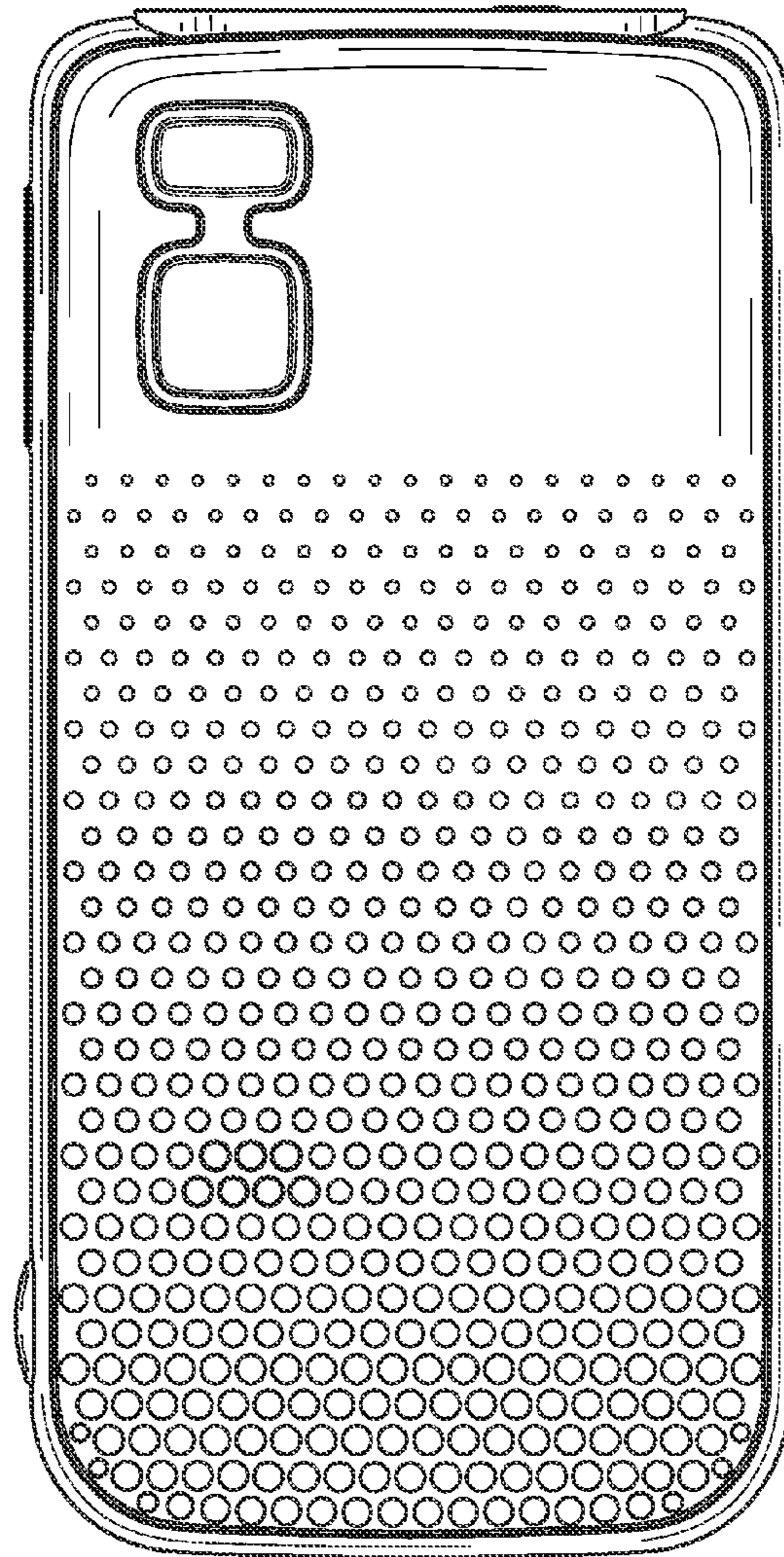

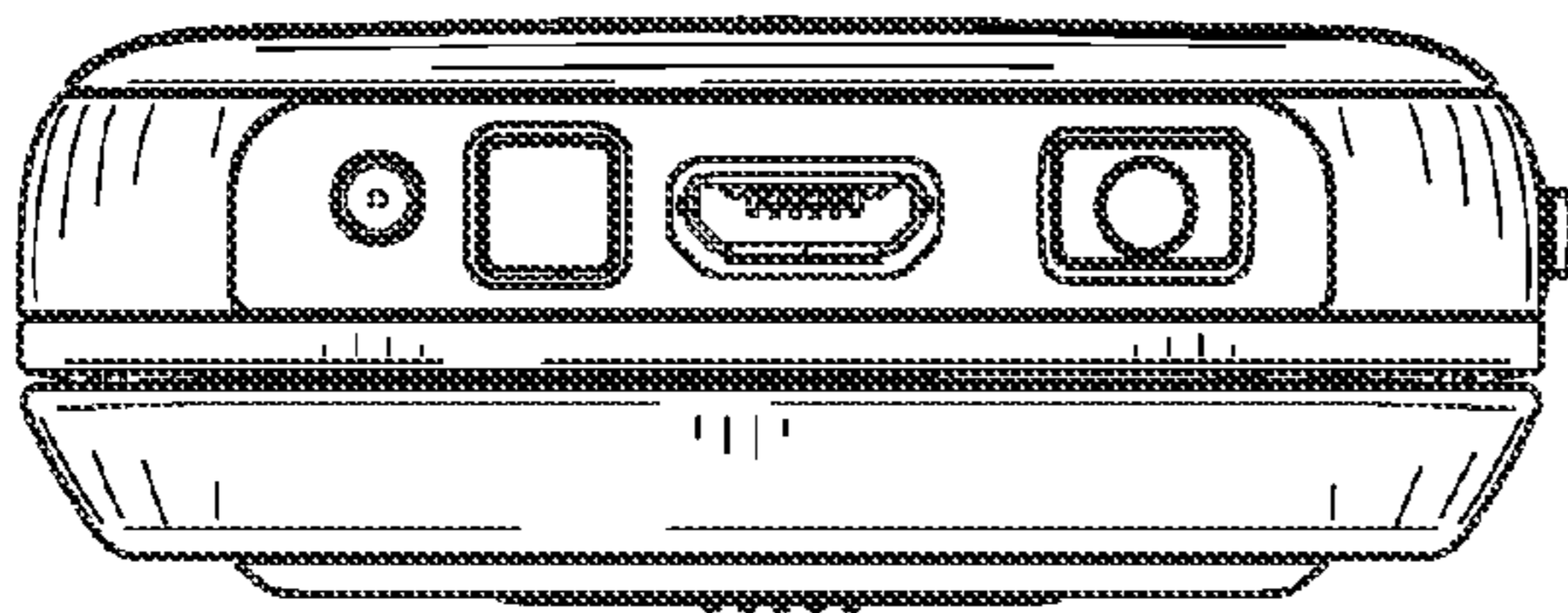

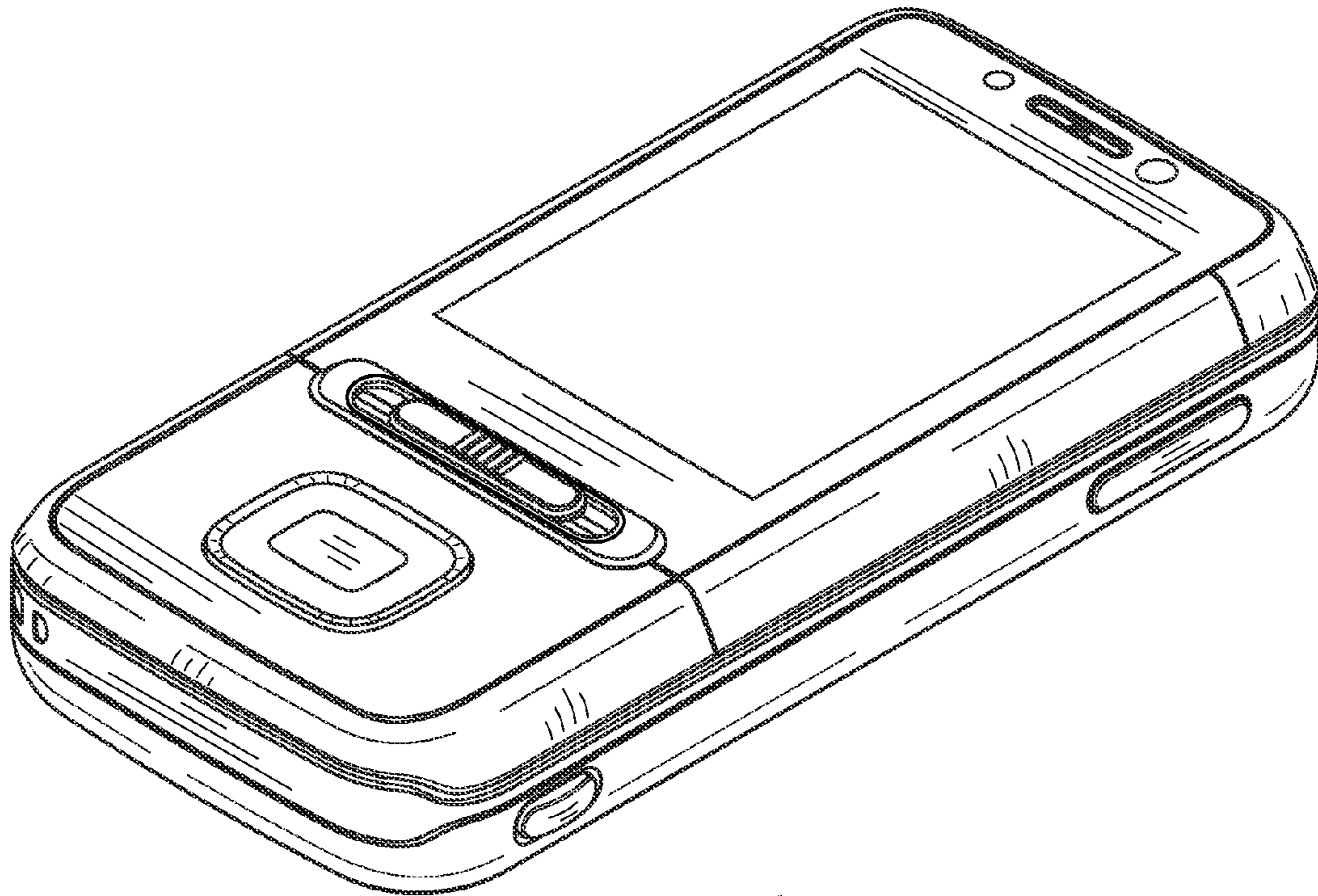

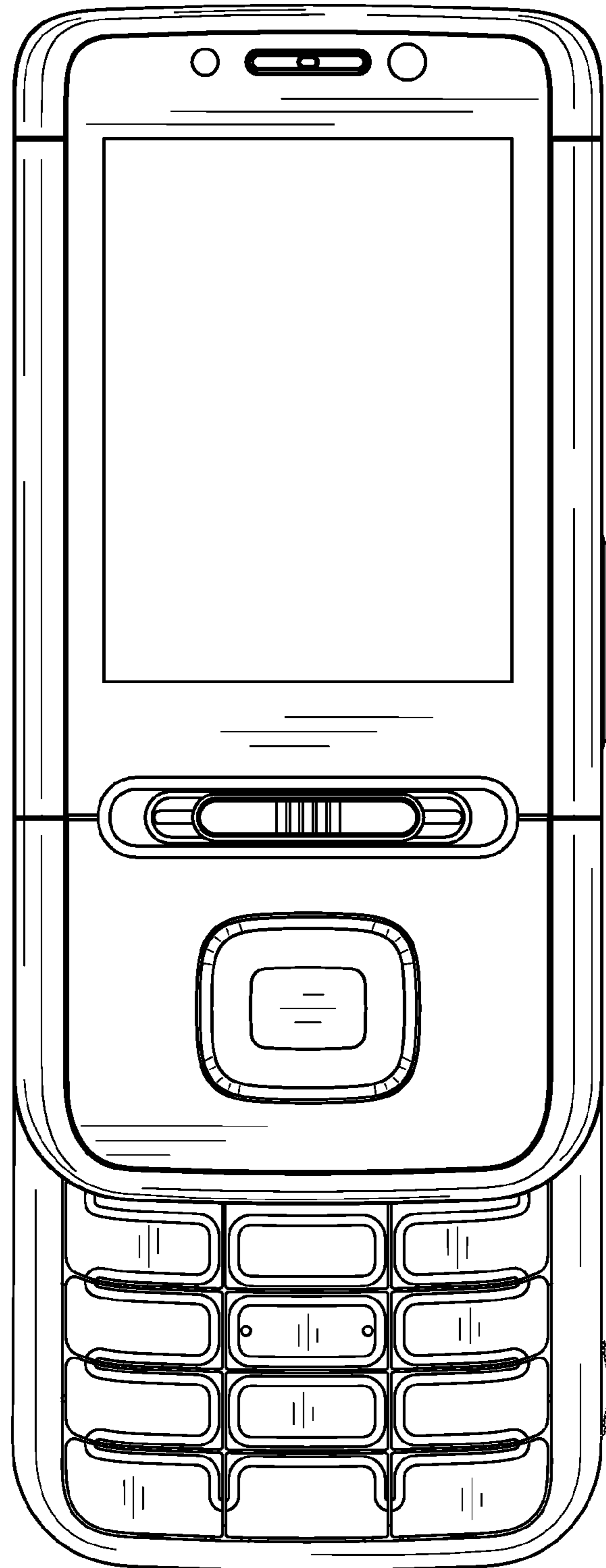

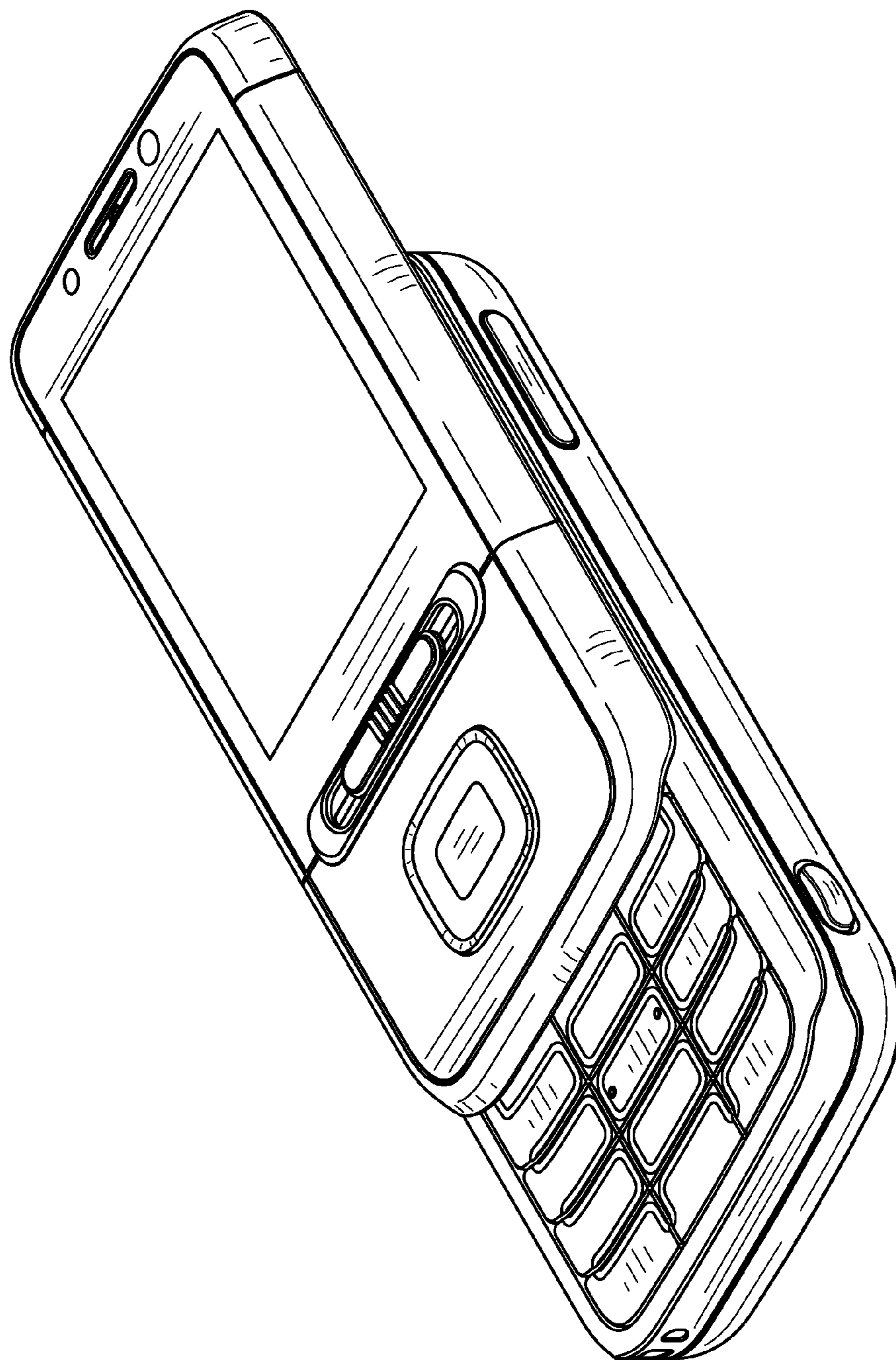
