FIG. 8 is a front perspective view of a second embodiment of the new ornamental design illustrating a flared tubular member, the cross-section of the tubular member transitioning from circular to oval;

FIG. 9 is a front-end view thereof, illustrating the circular-to-oval transitioning cross-section of the tubular member;

FIG. 10 is a rear-end view thereof;

FIG. 11 is a left-side view thereof;

FIG. 12 is a right-side view thereof;

FIG. 13 is a top view thereof; and,

FIG. 14 is a bottom view thereof.

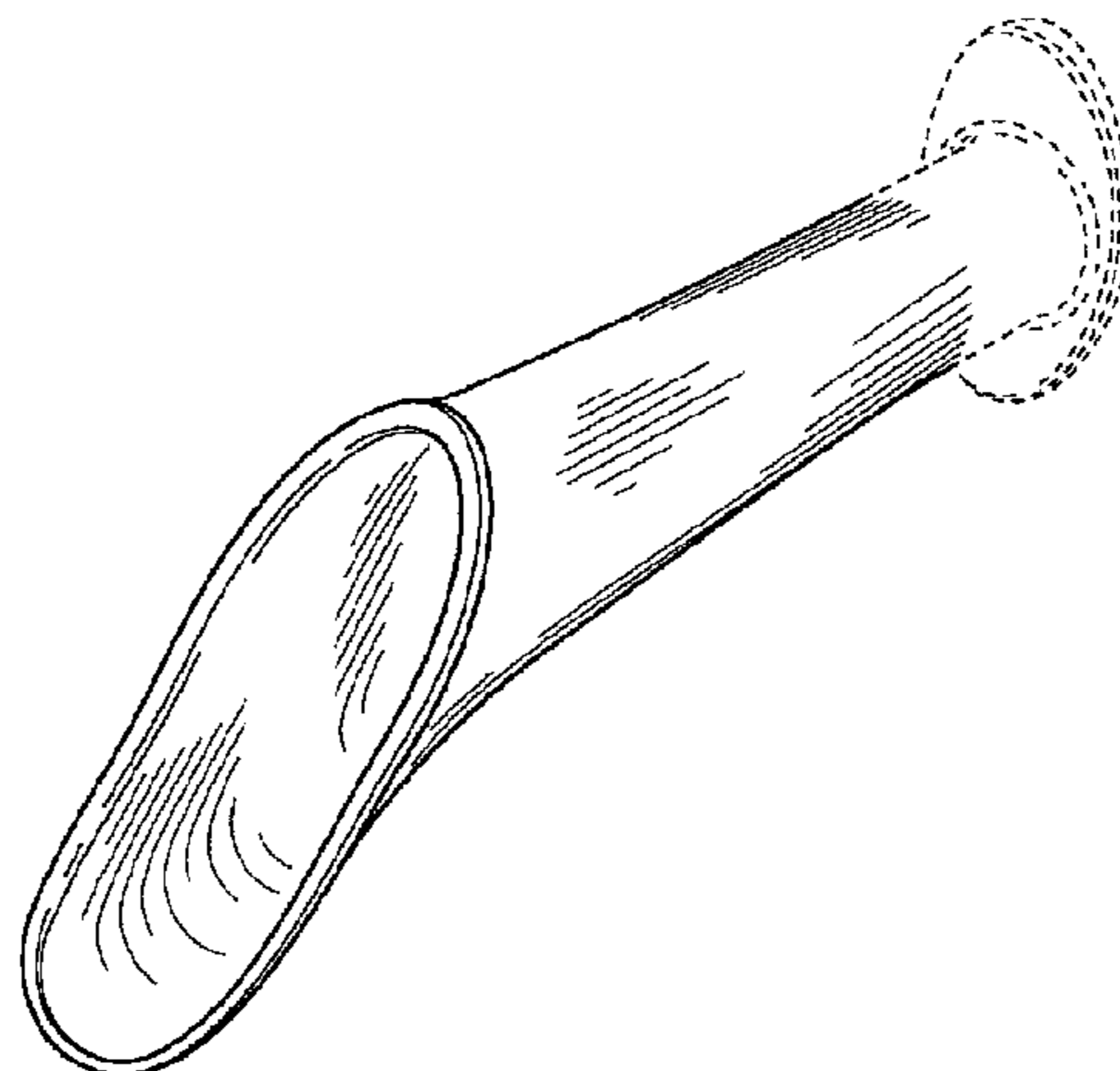

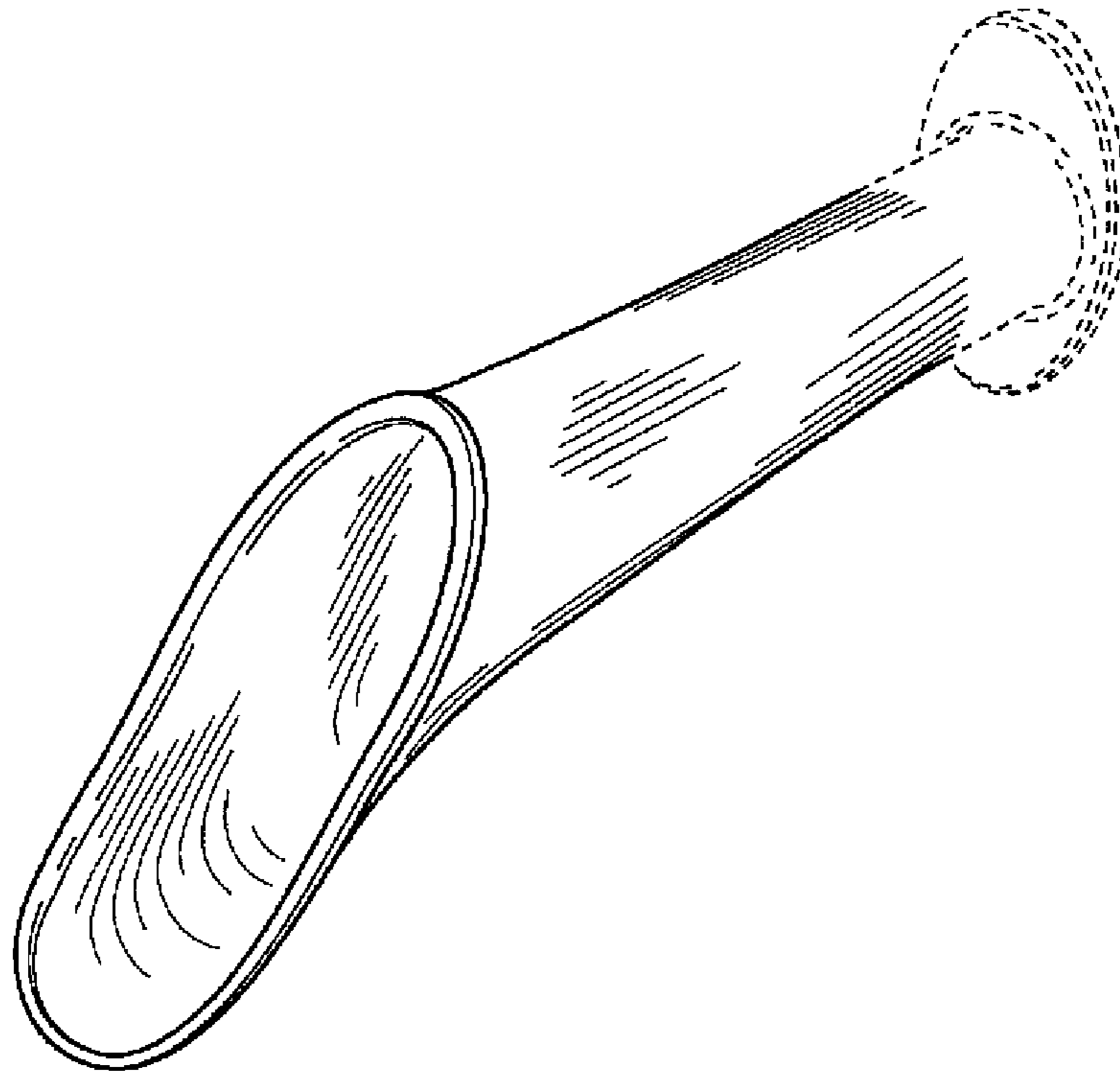

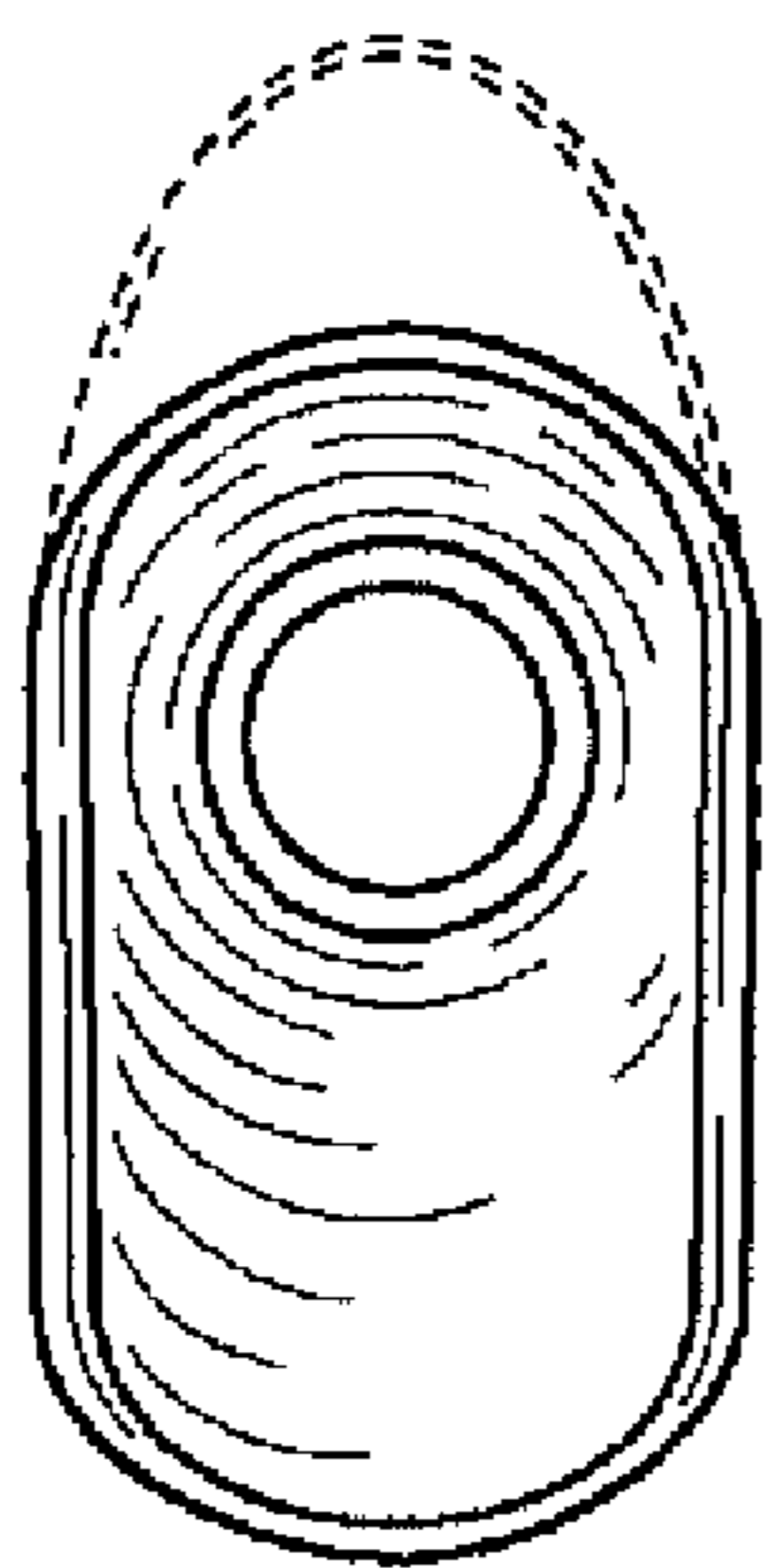

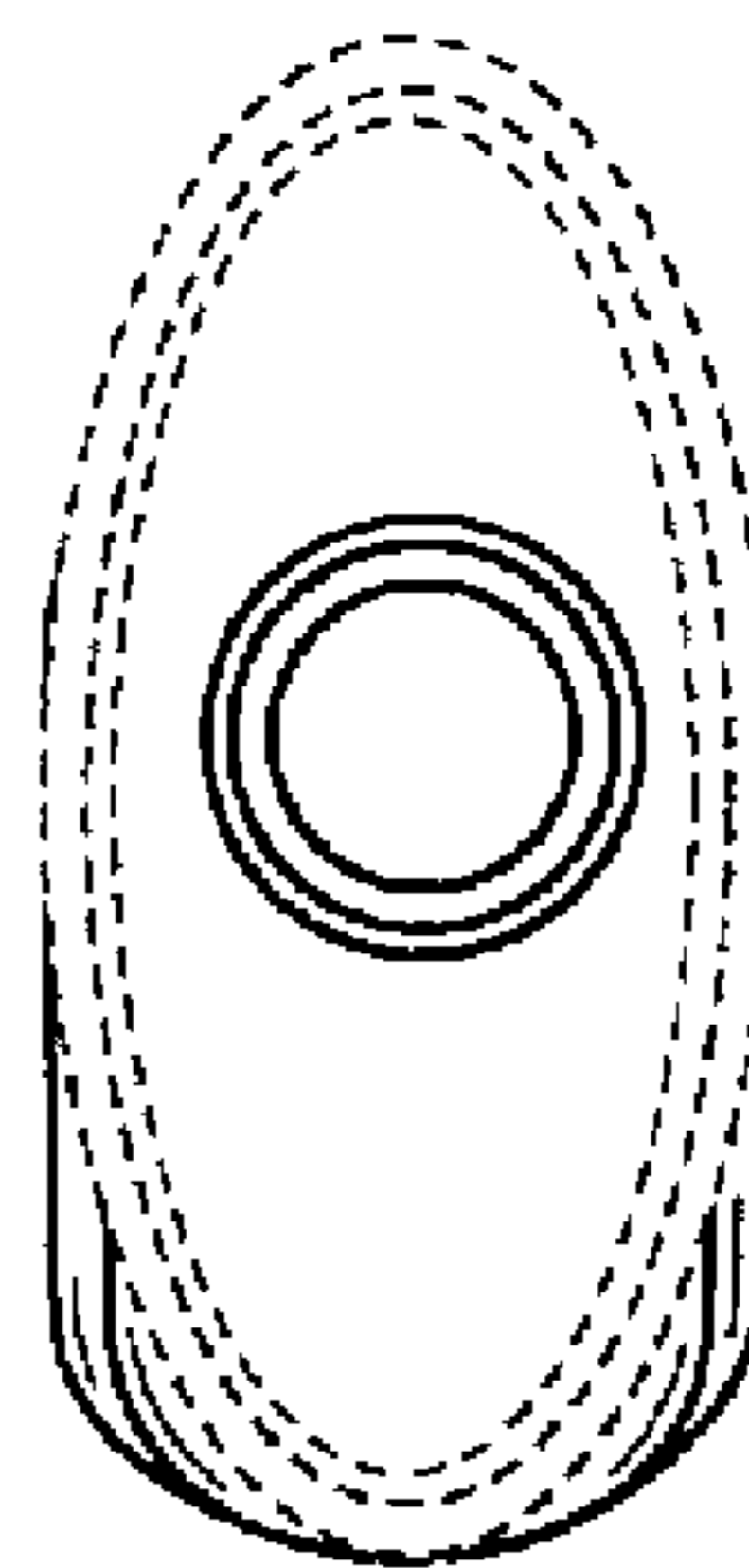

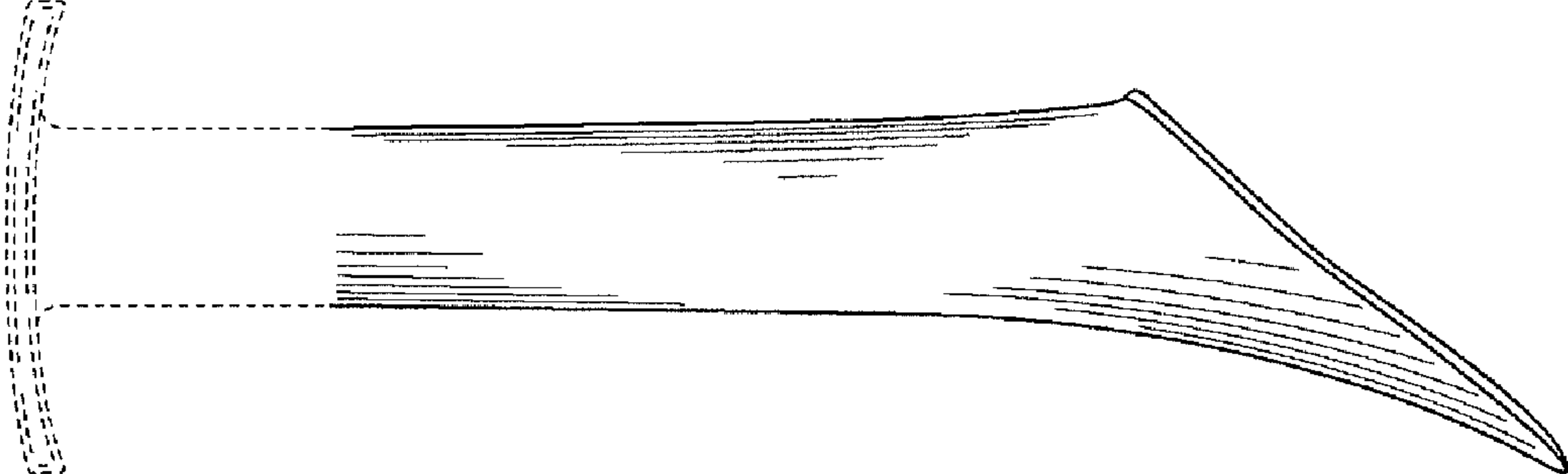

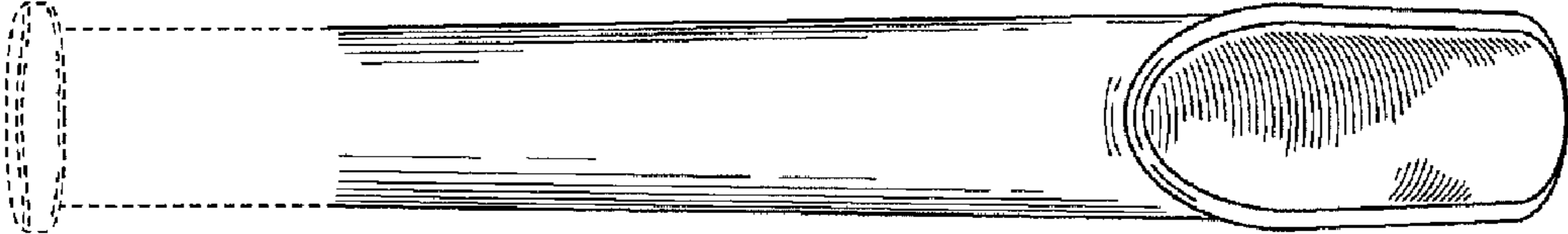

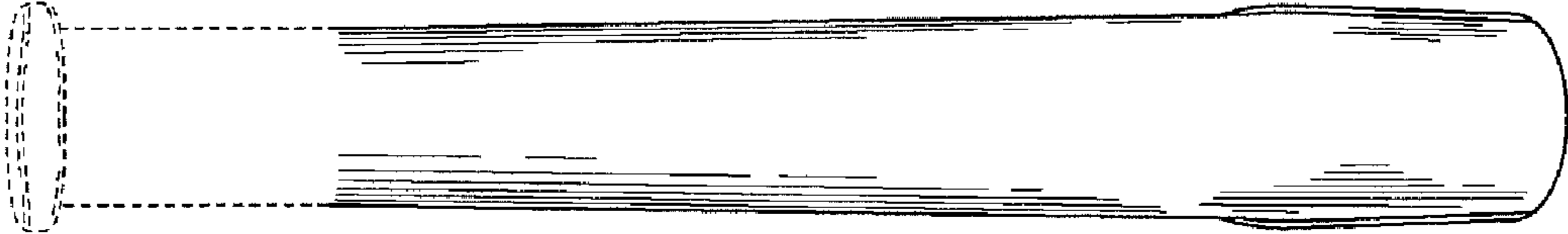

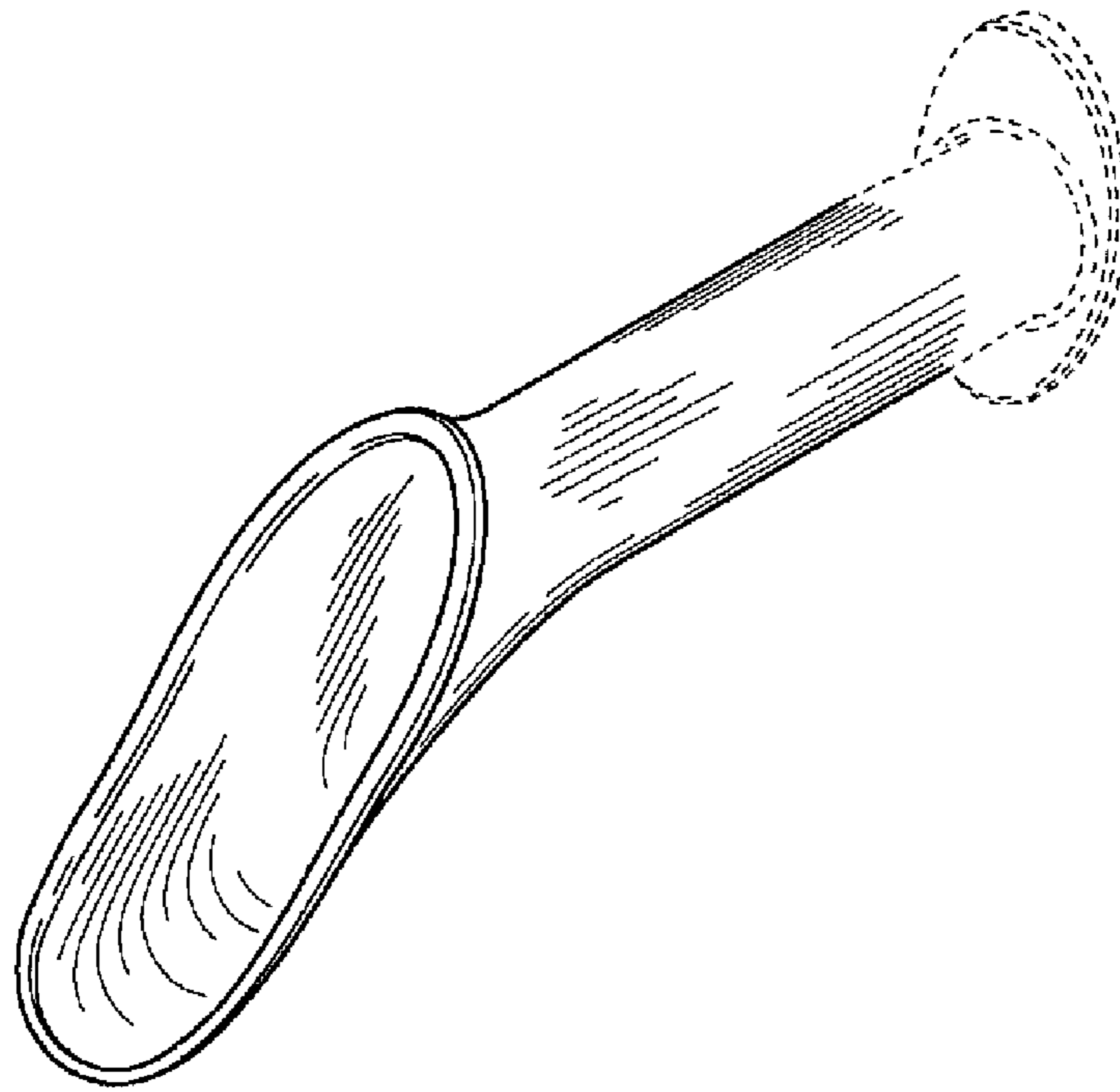

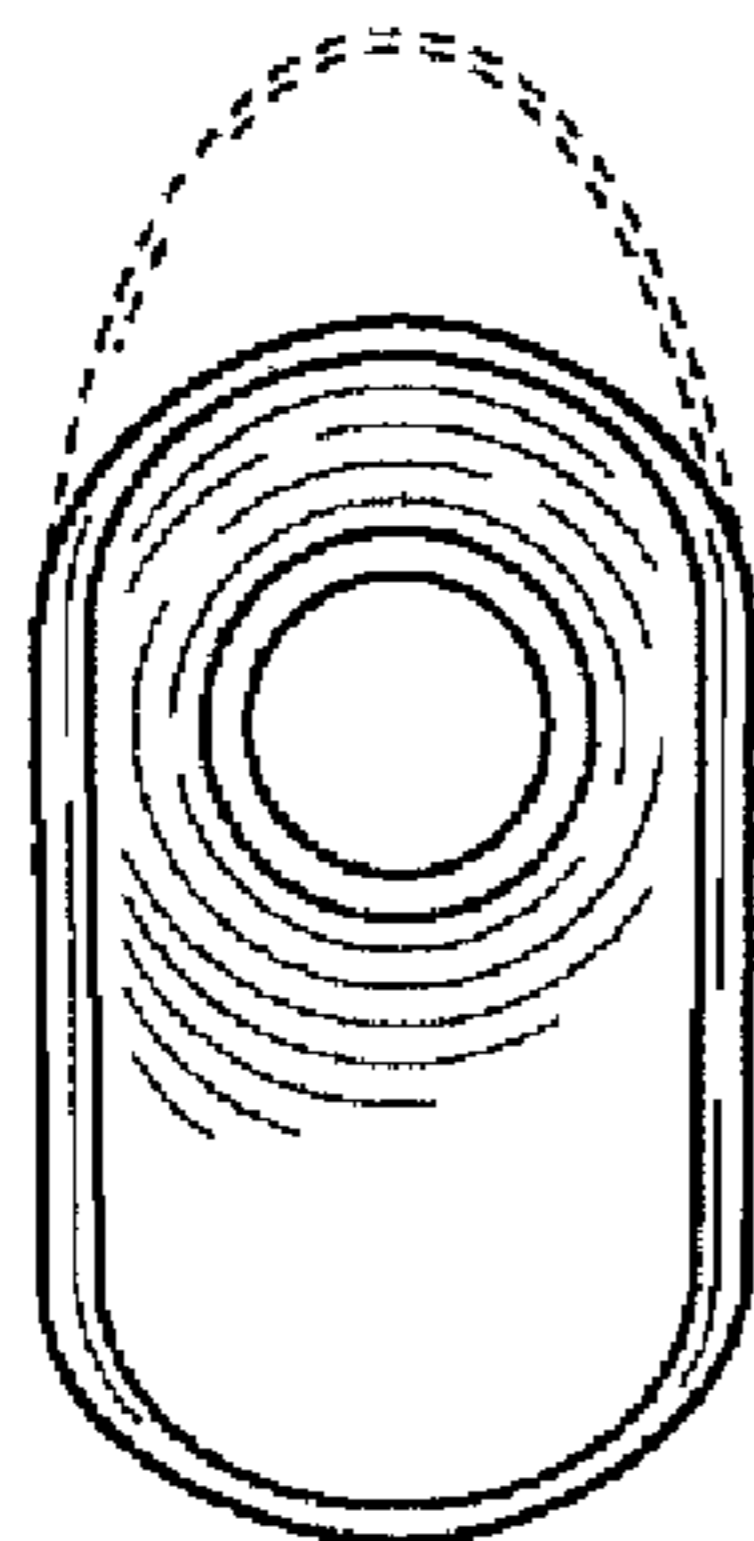

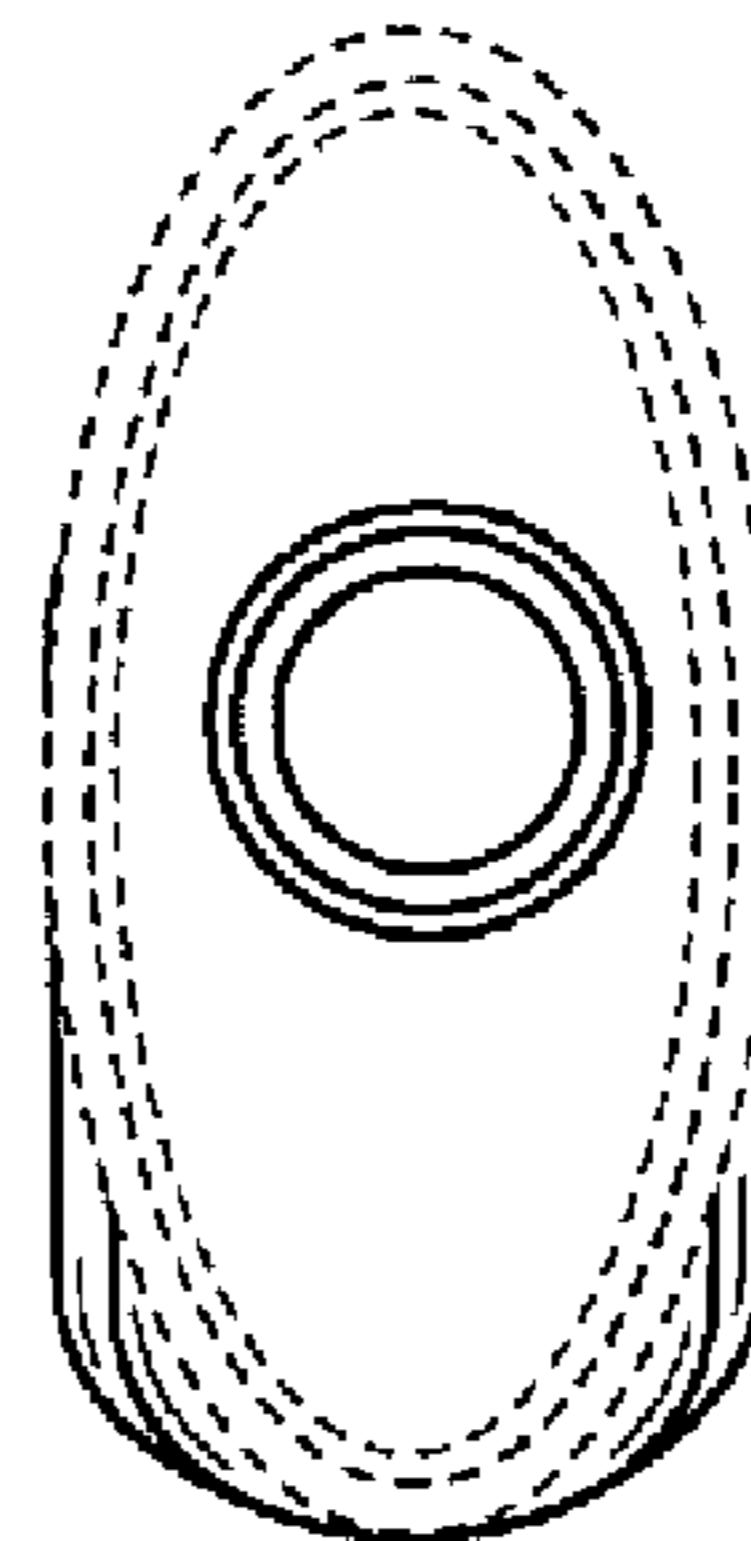

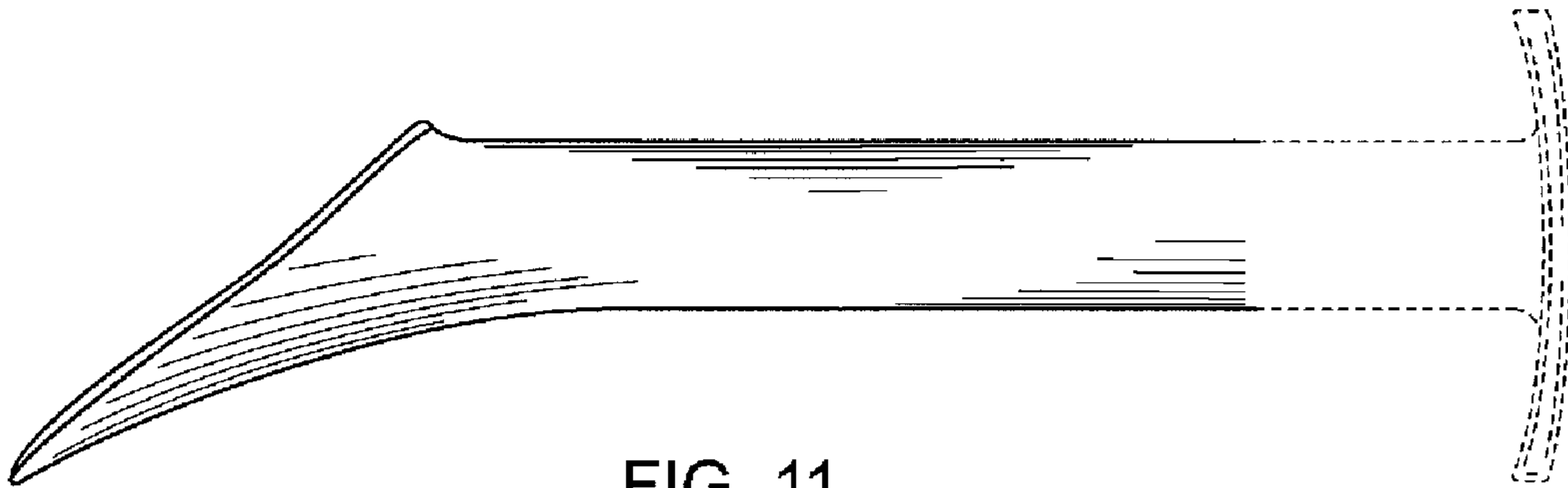

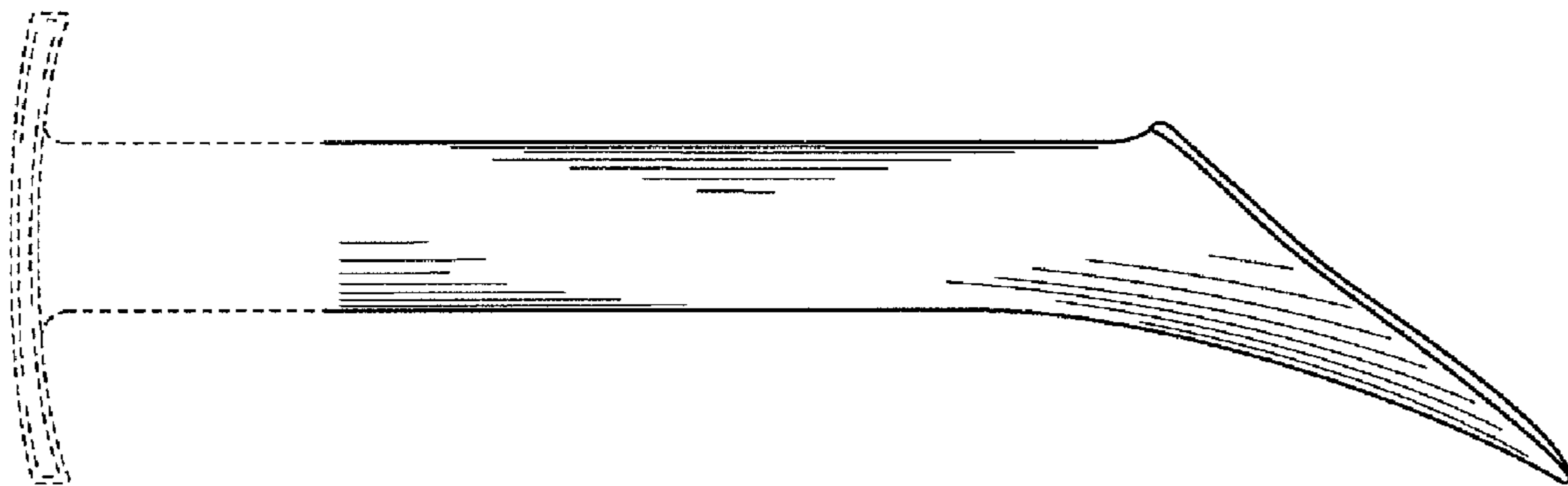

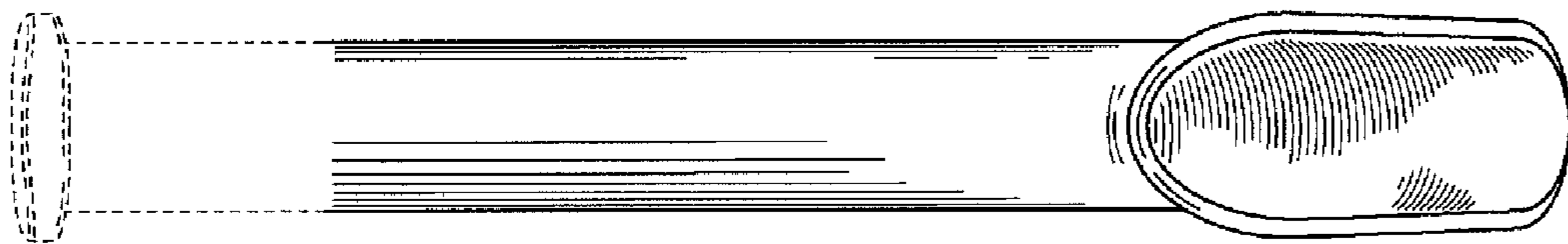

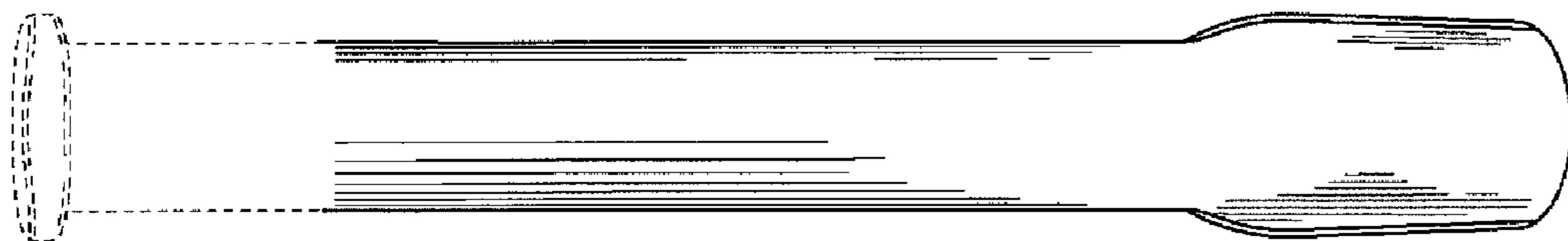
