DESCRIPTION

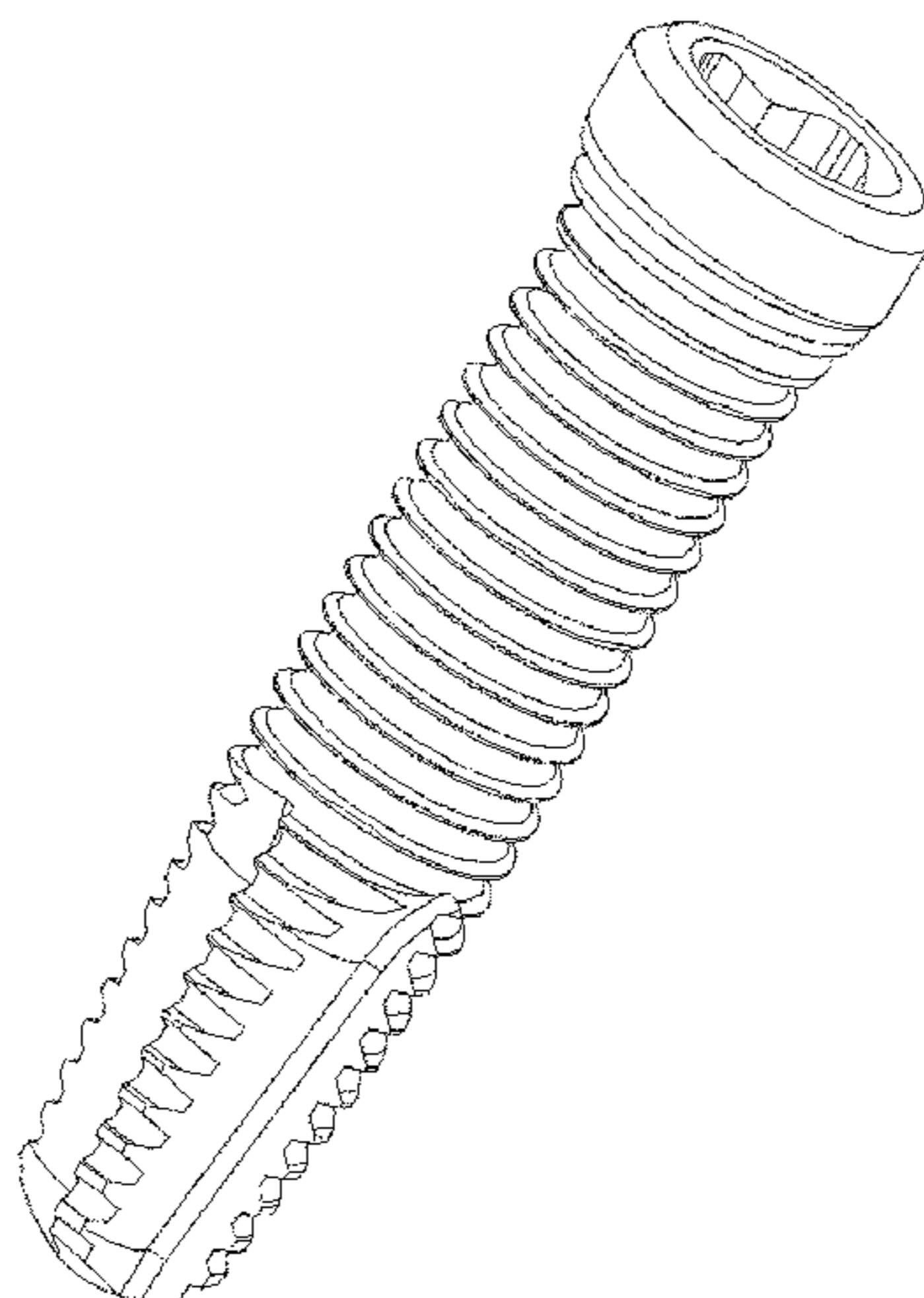
FIG. 1 is a perspective view of a dental implant showing my new design;

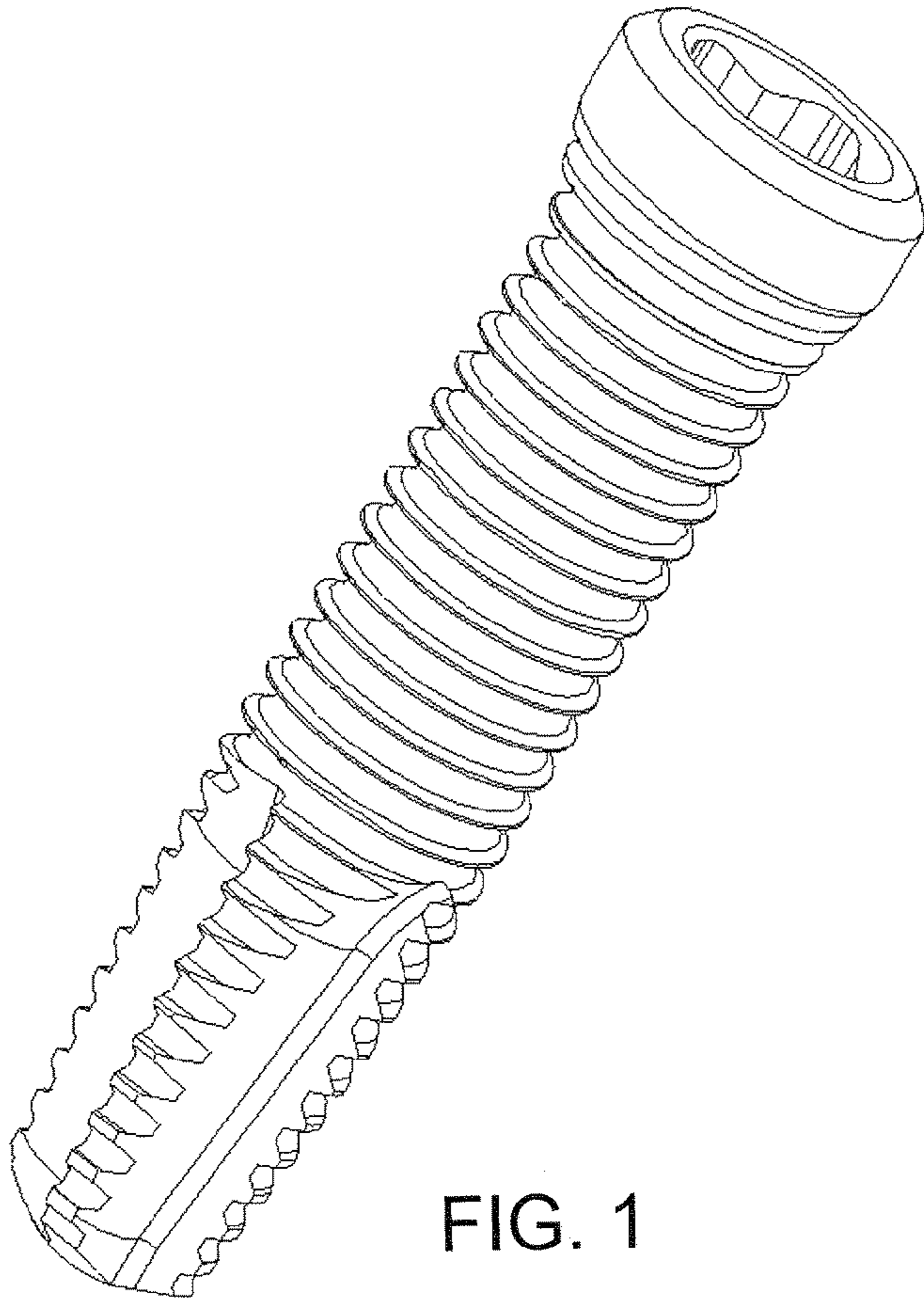

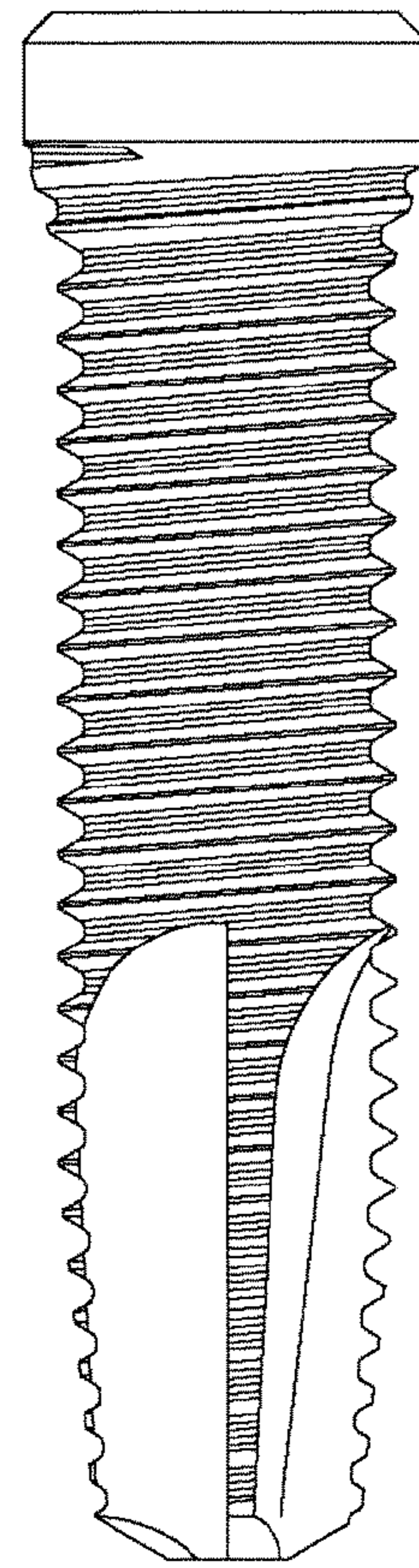

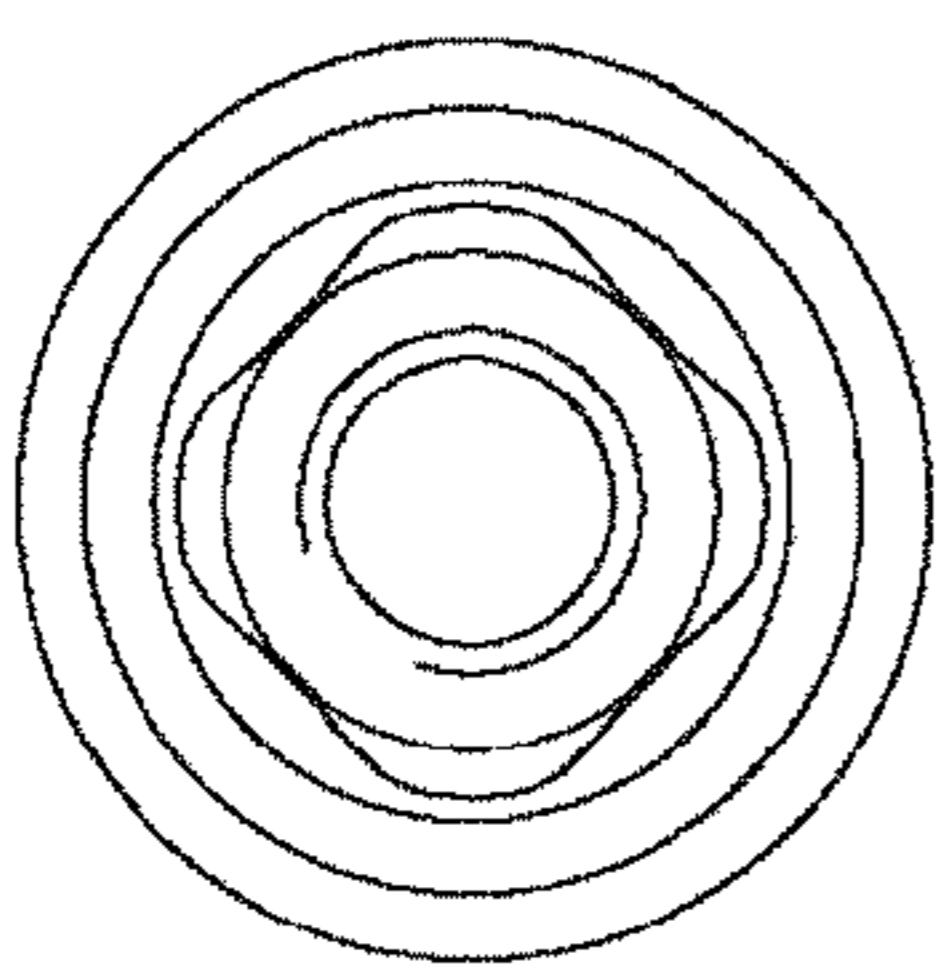

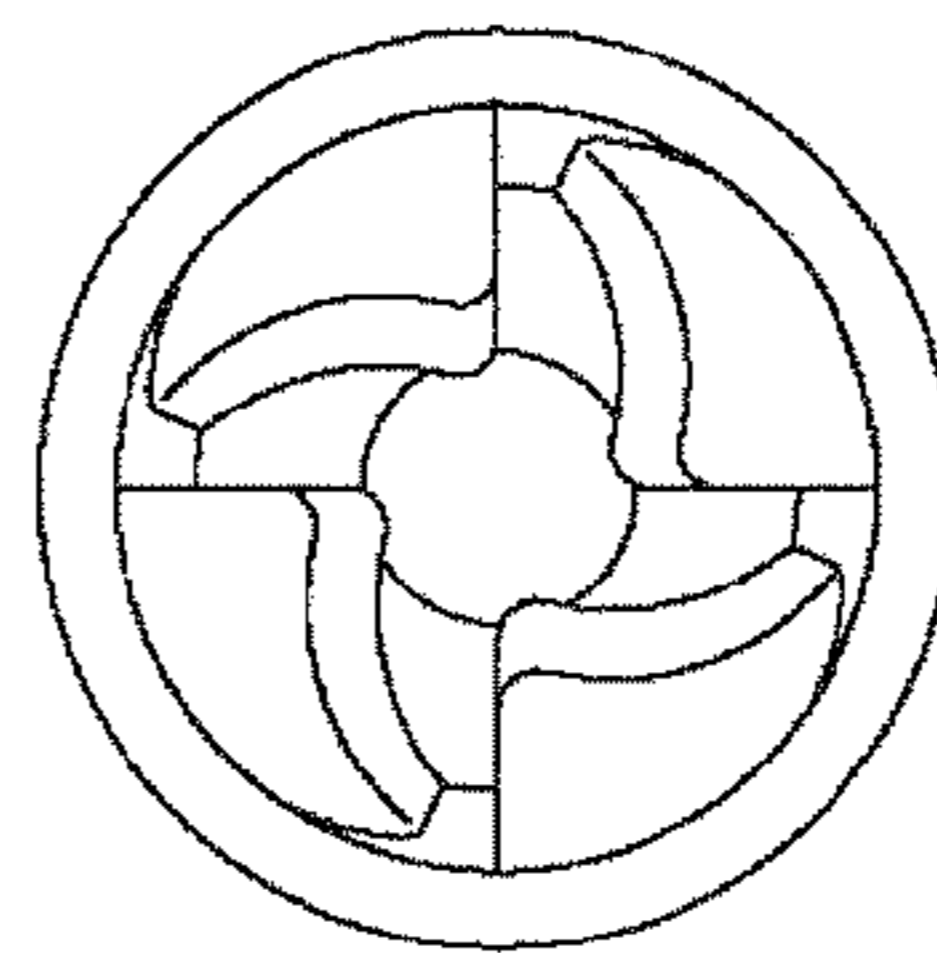
