FIG. 4 is a bottom plan view thereof;

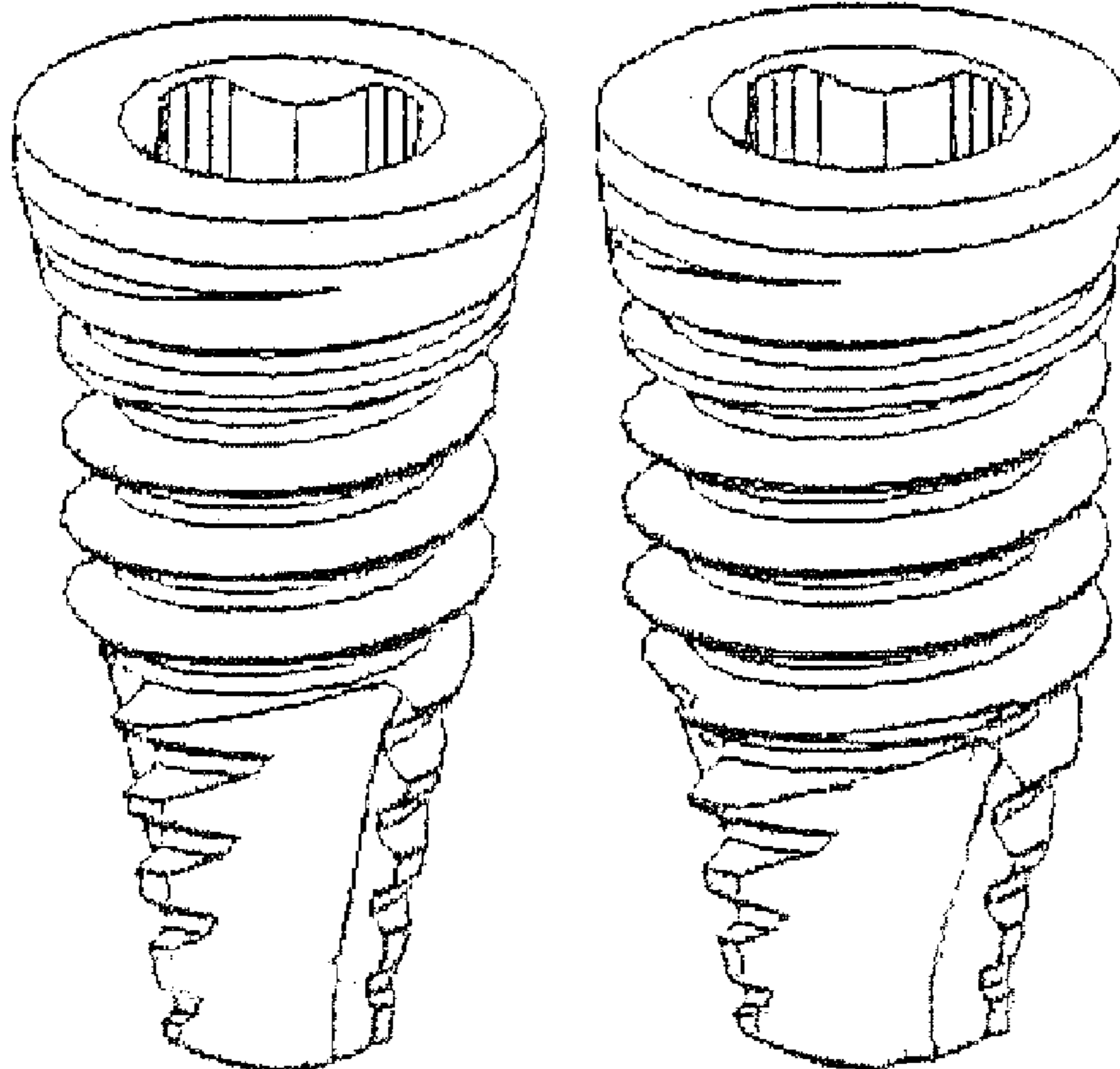
FIG. 5 is a perspective view of a modified embodiment of the design shown in FIGS. 1 through 4;

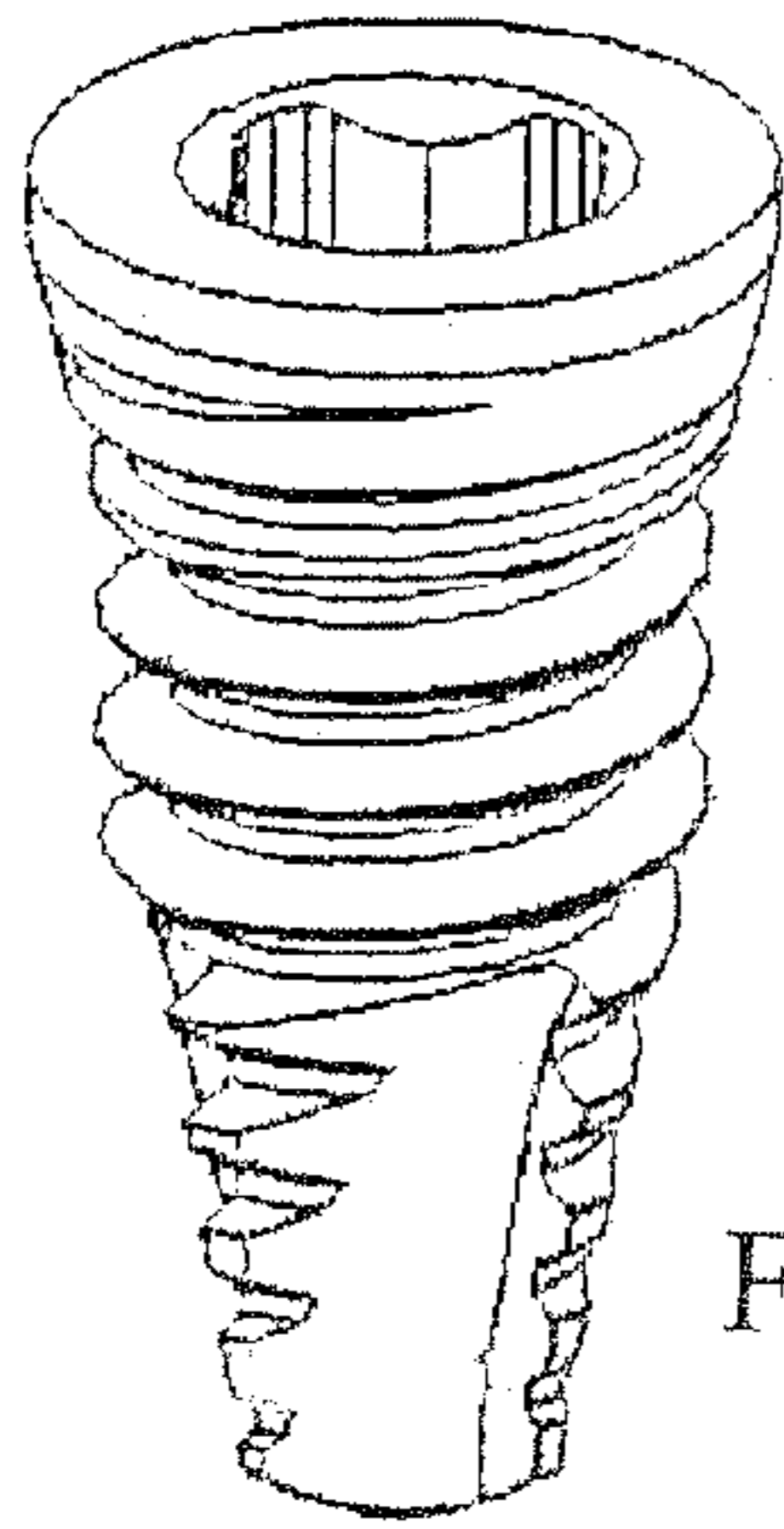

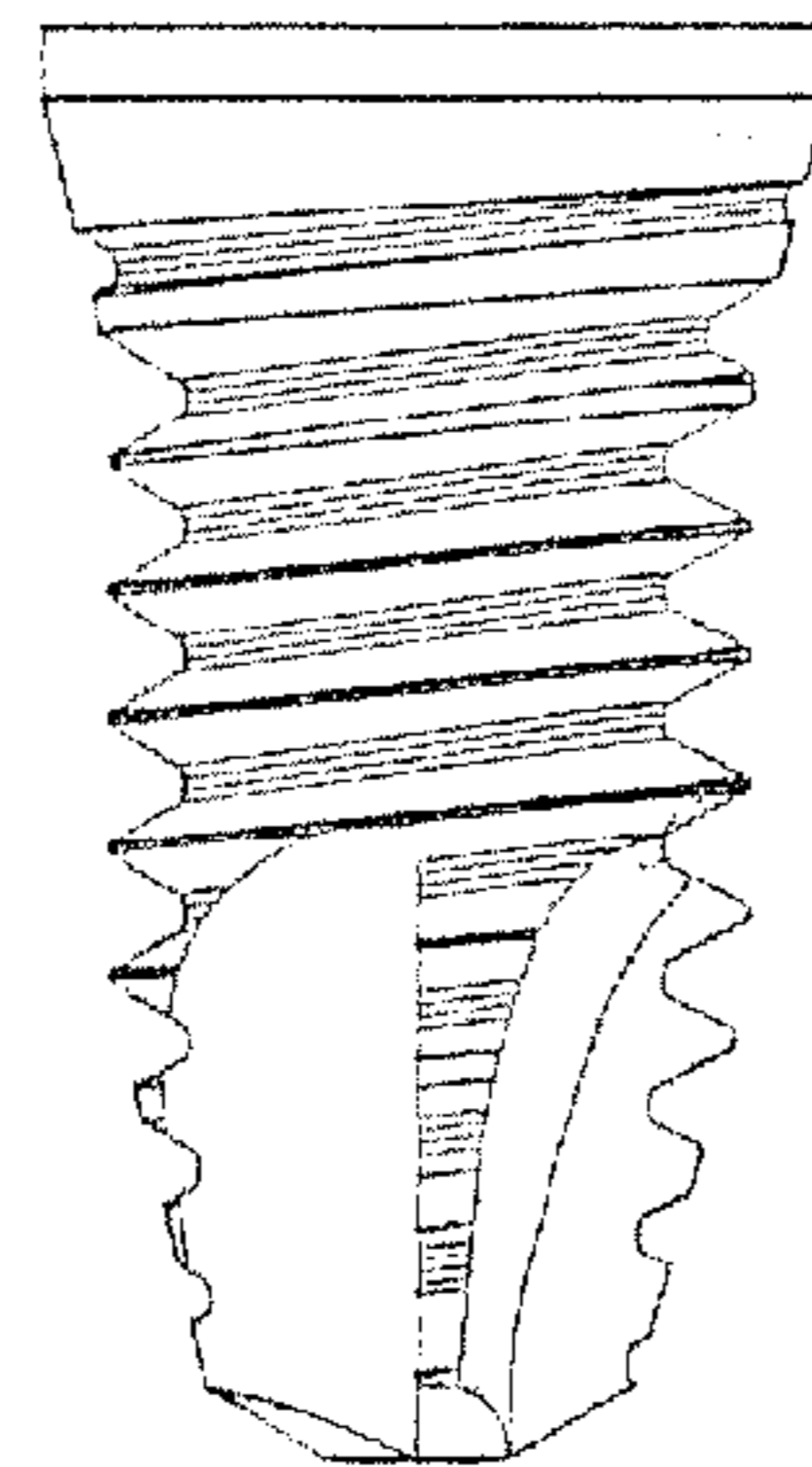

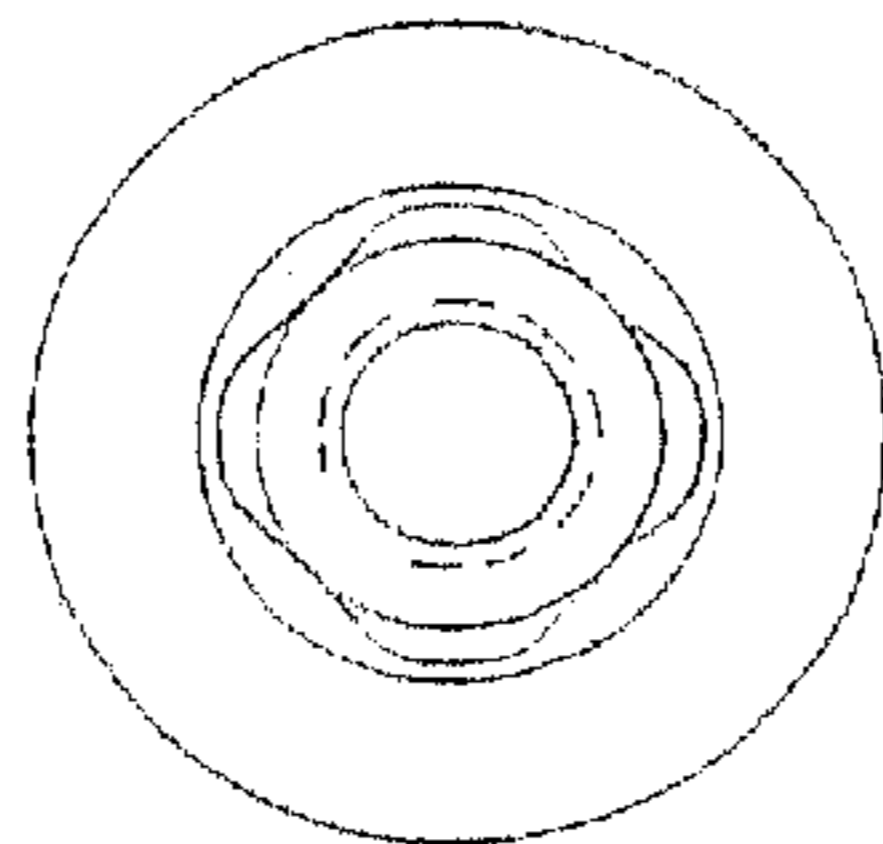

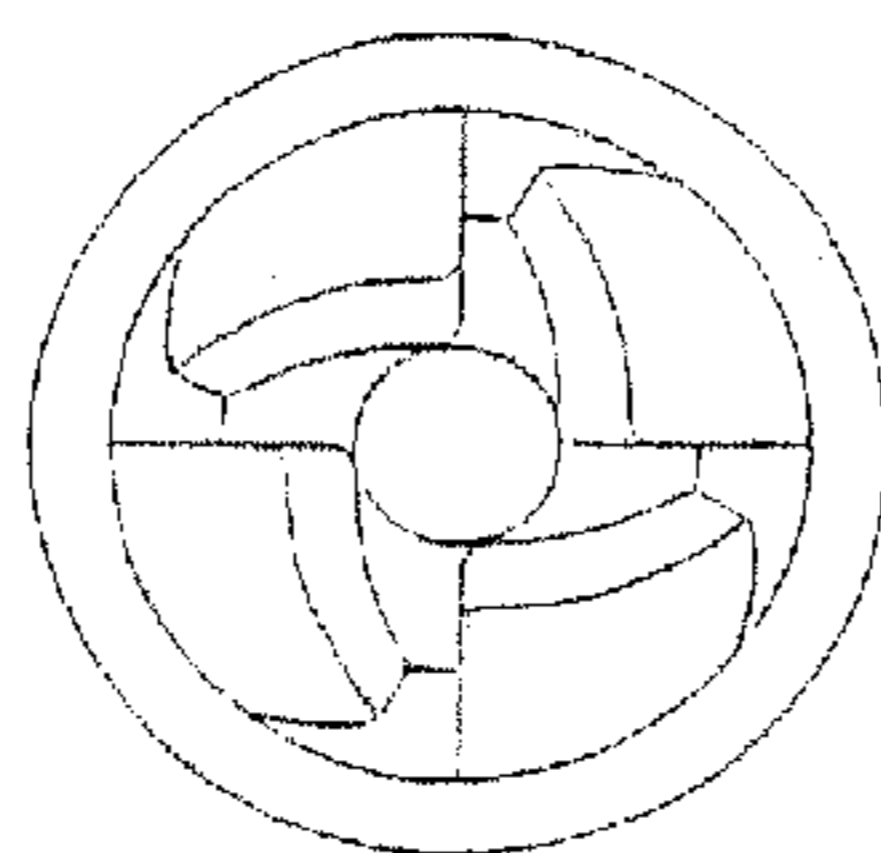

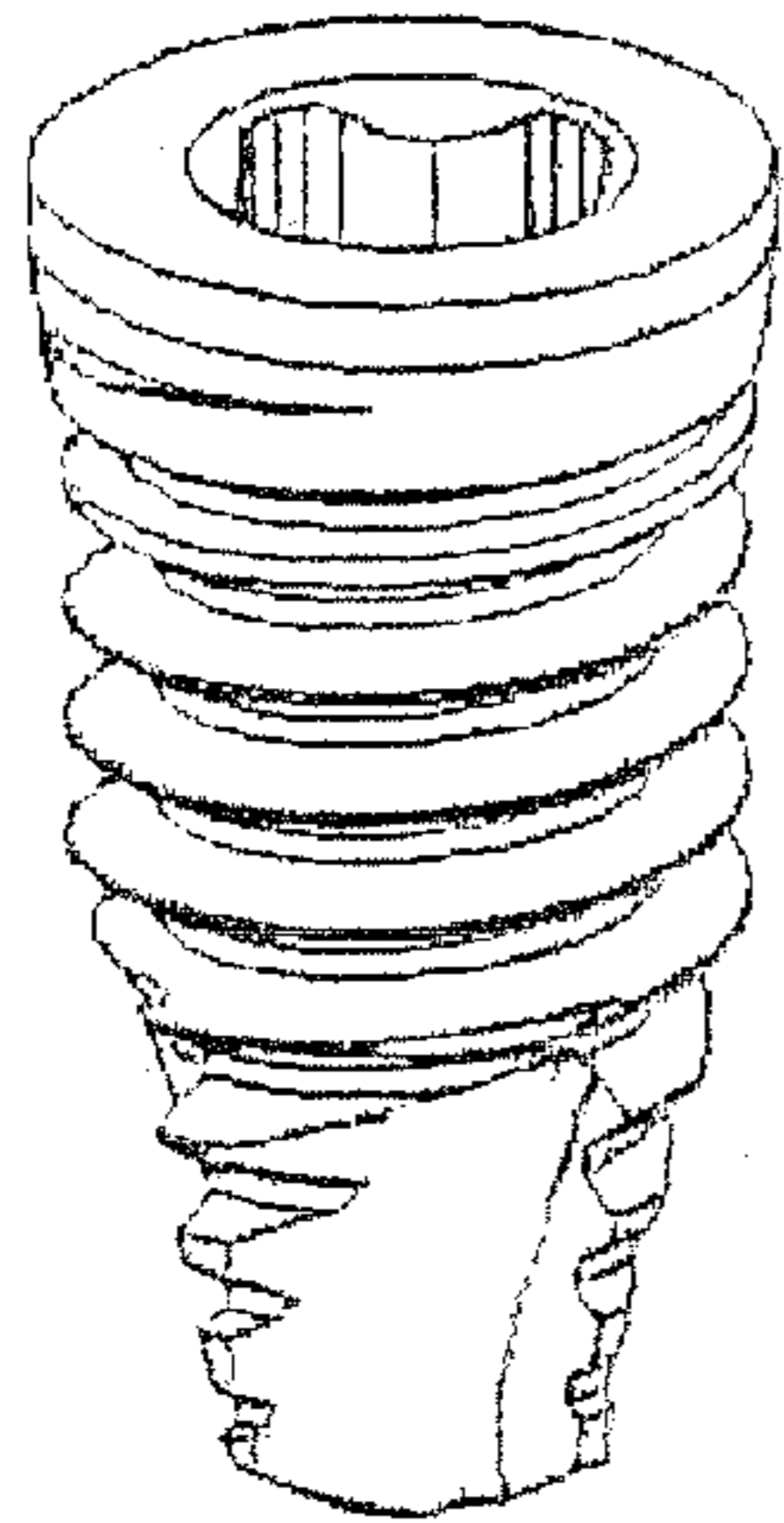

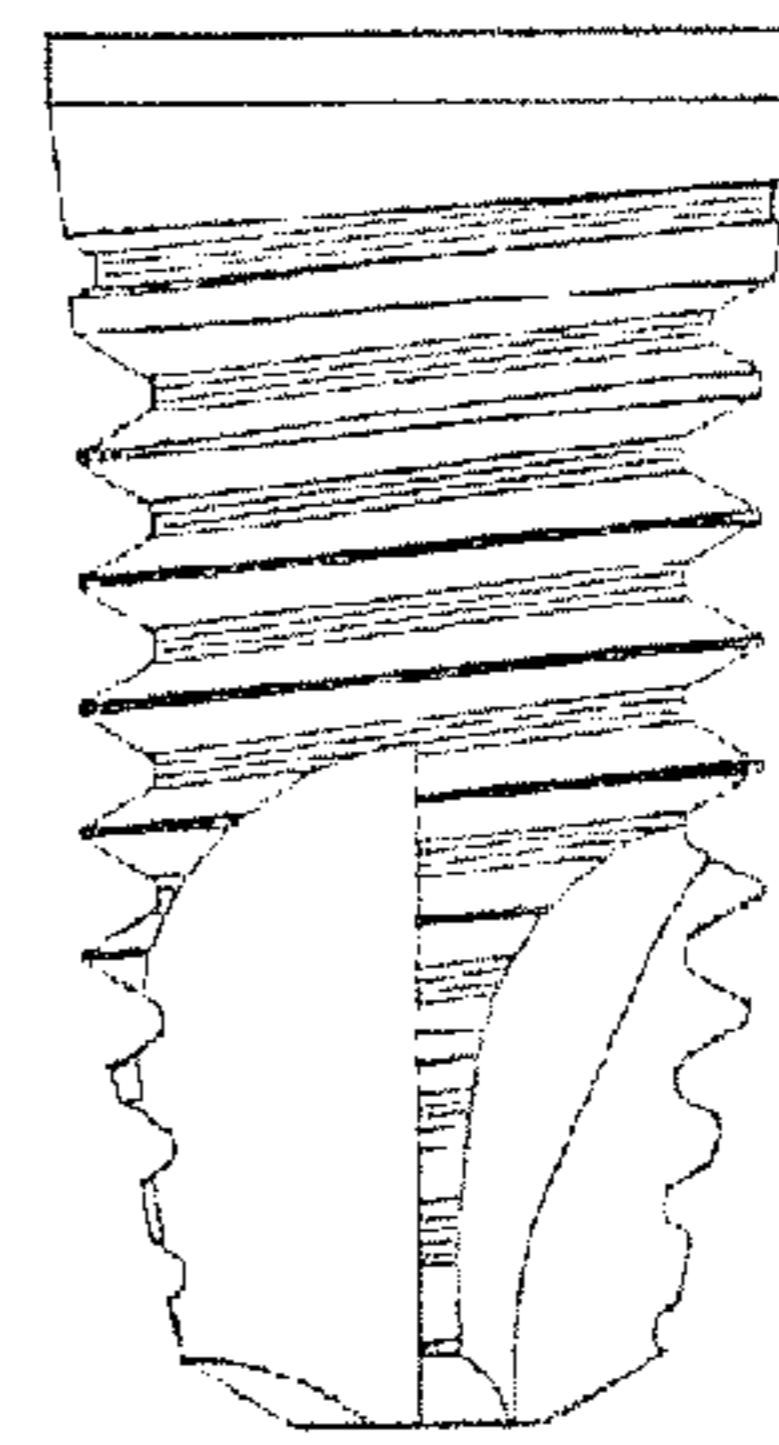

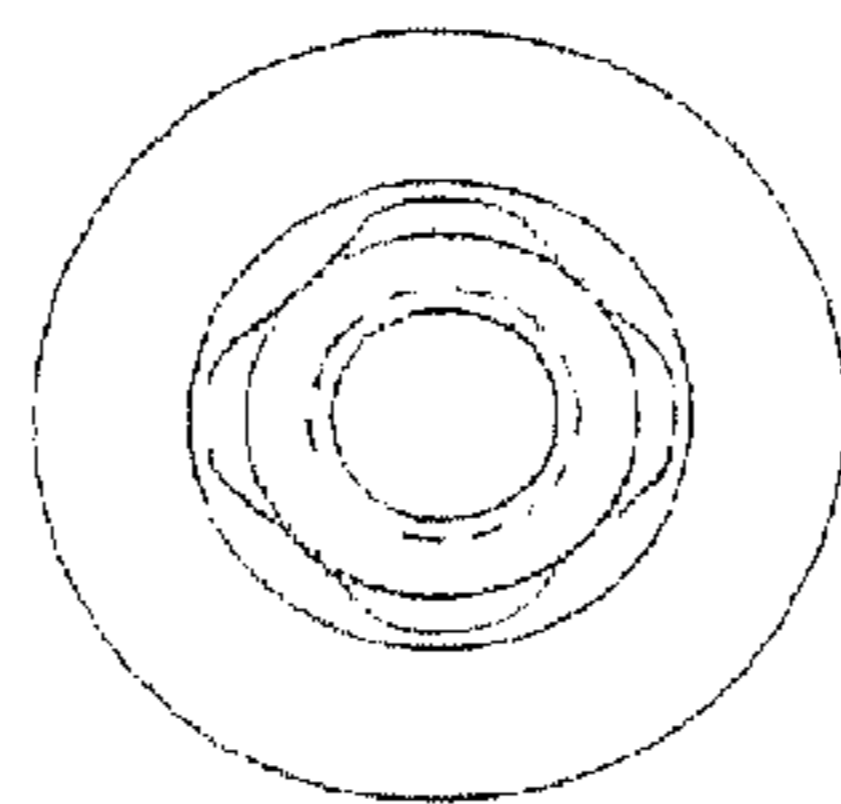

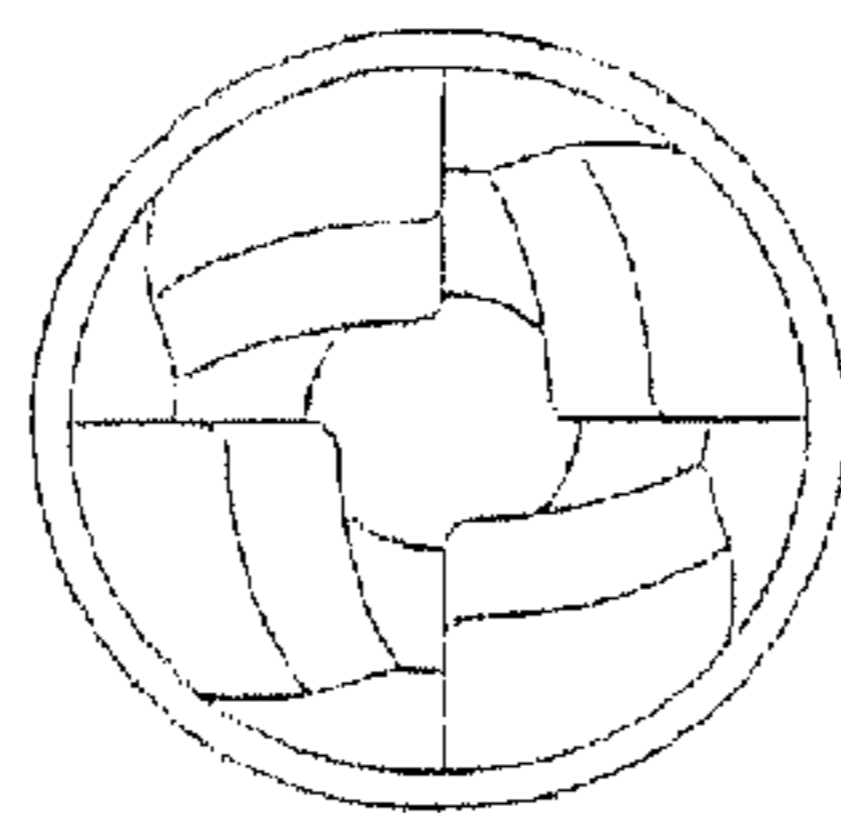
