FIG. 15 is a perspective view of a sushi roll with design, with my new character “O” design thereon;

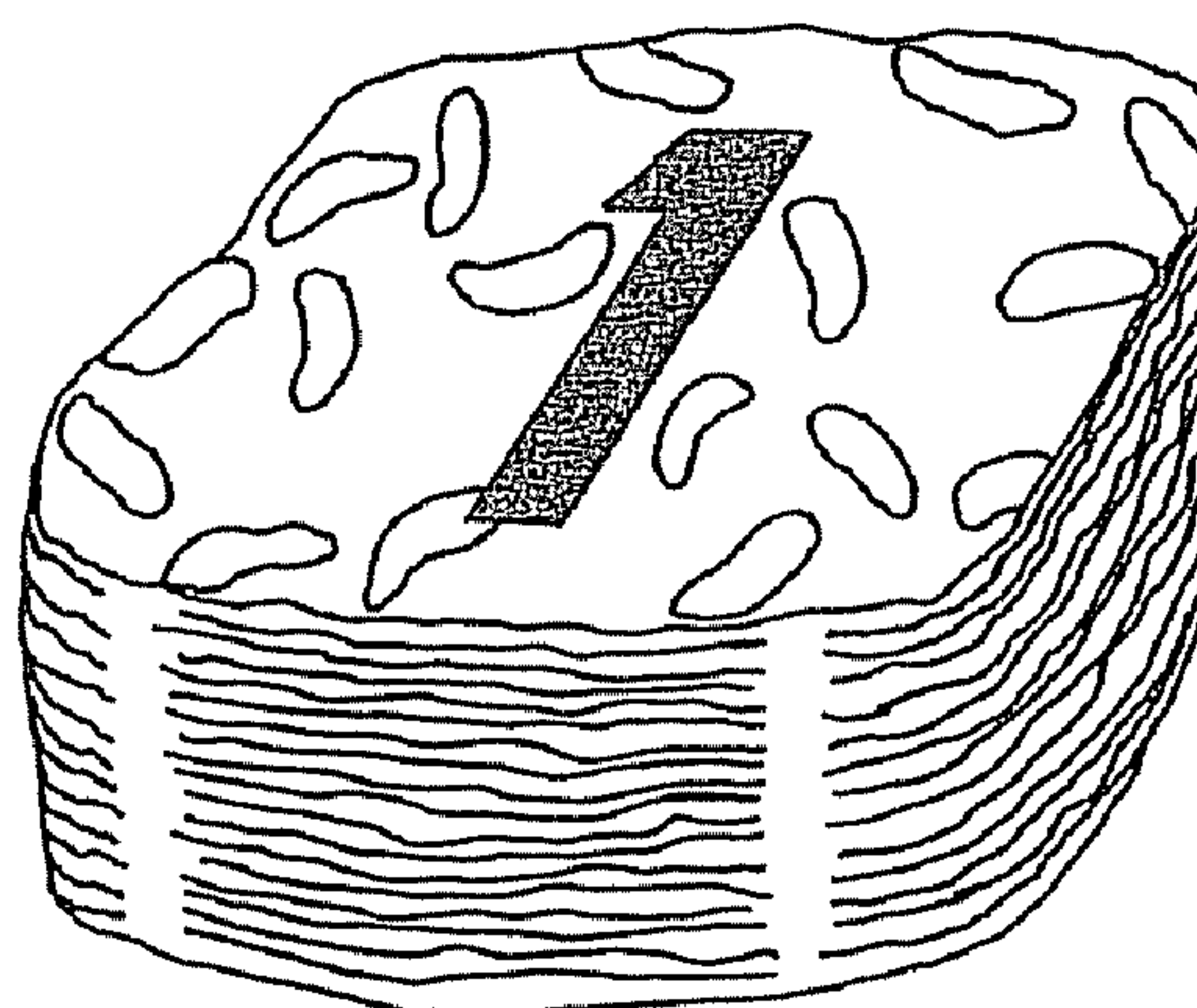
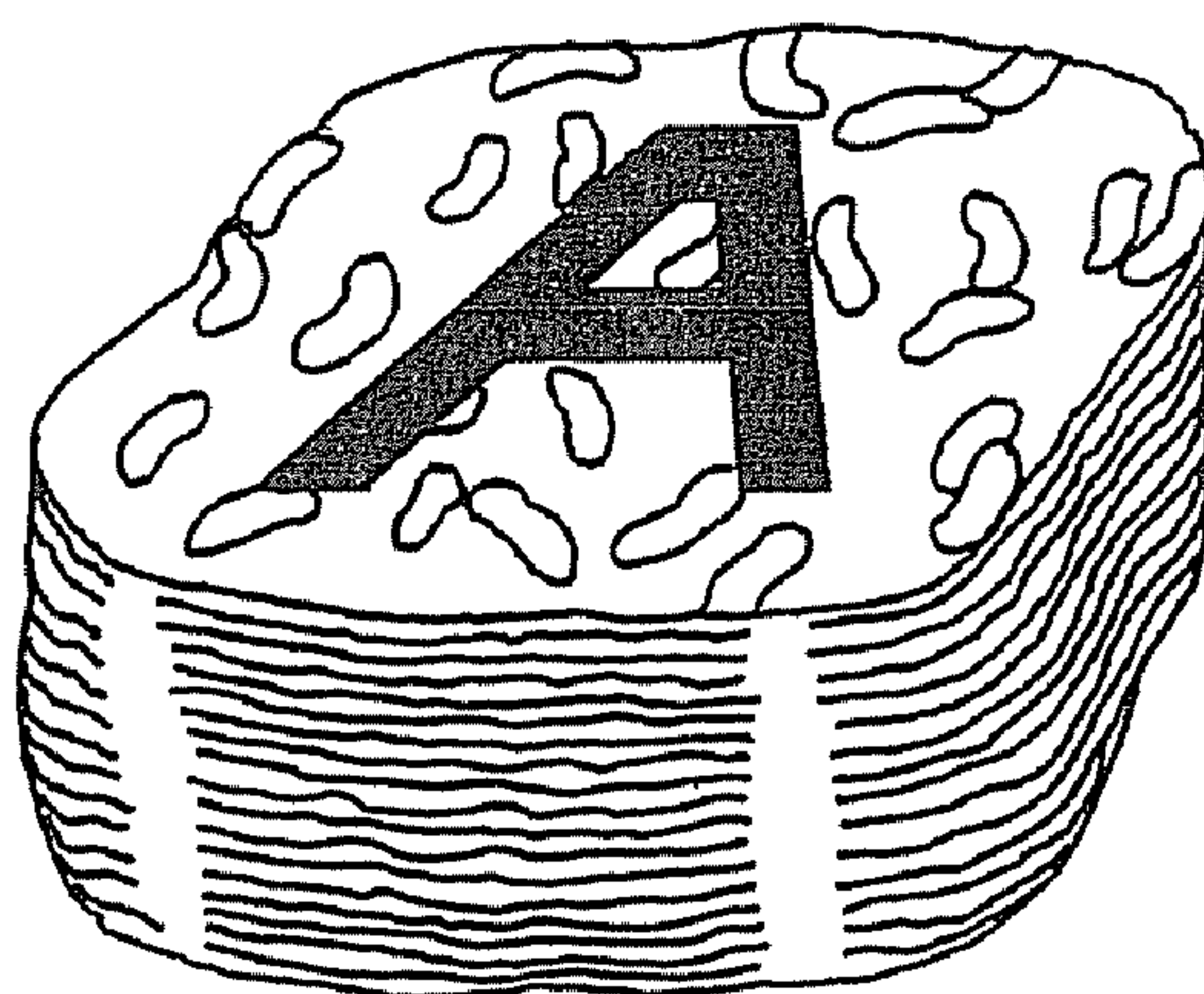


FIG. 16 is a perspective view of a sushi roll with design, with my new character “P” design thereon;

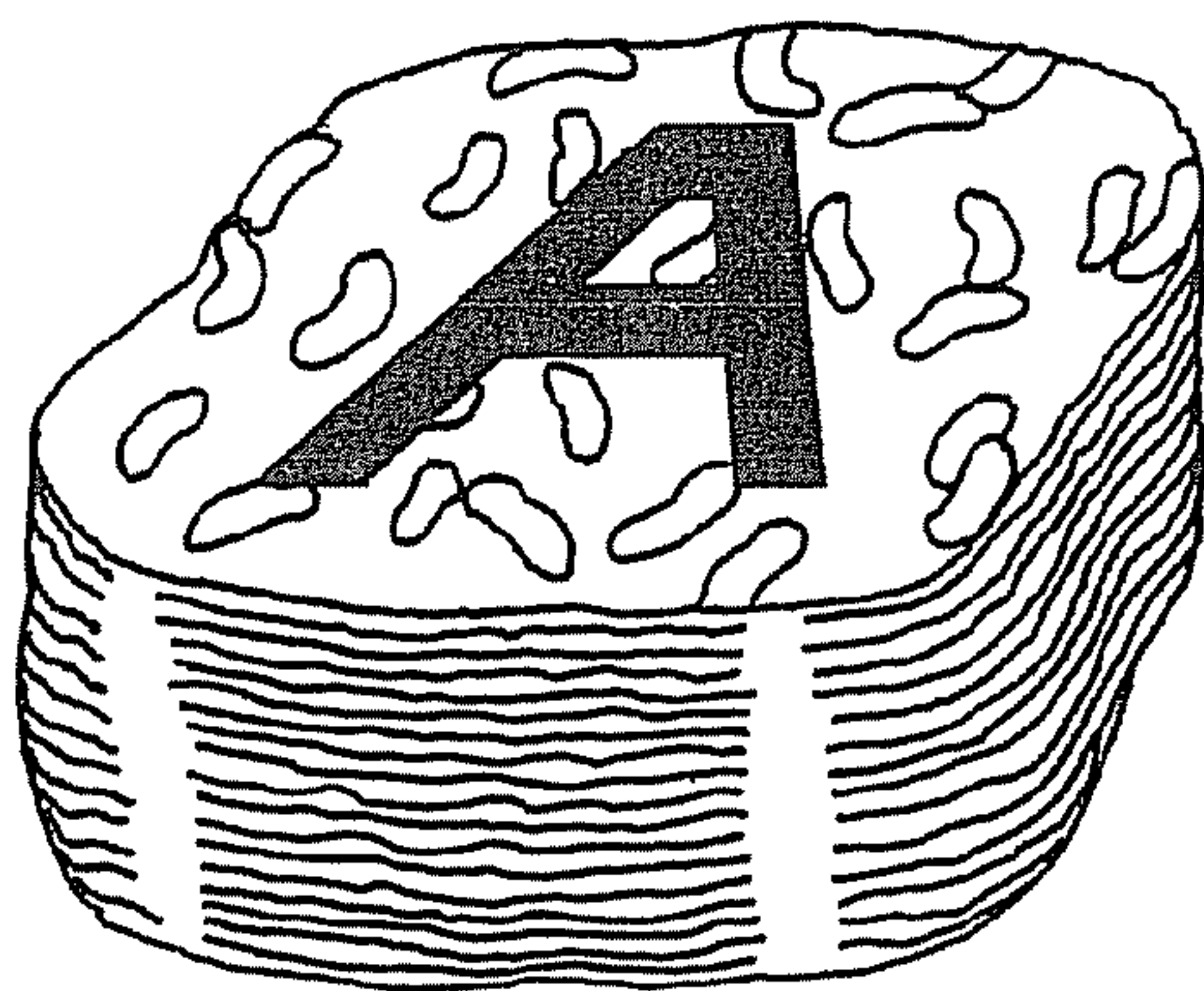

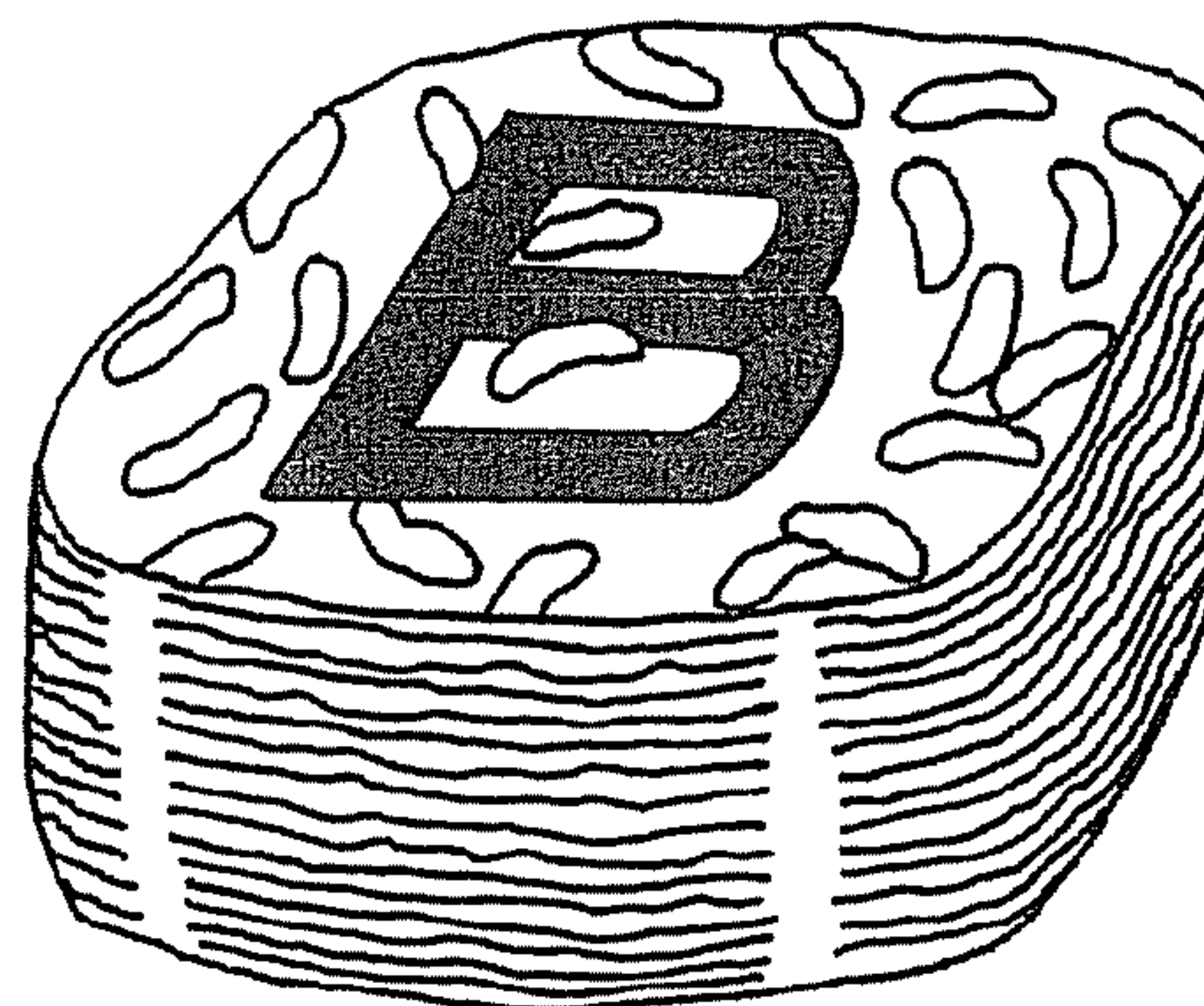

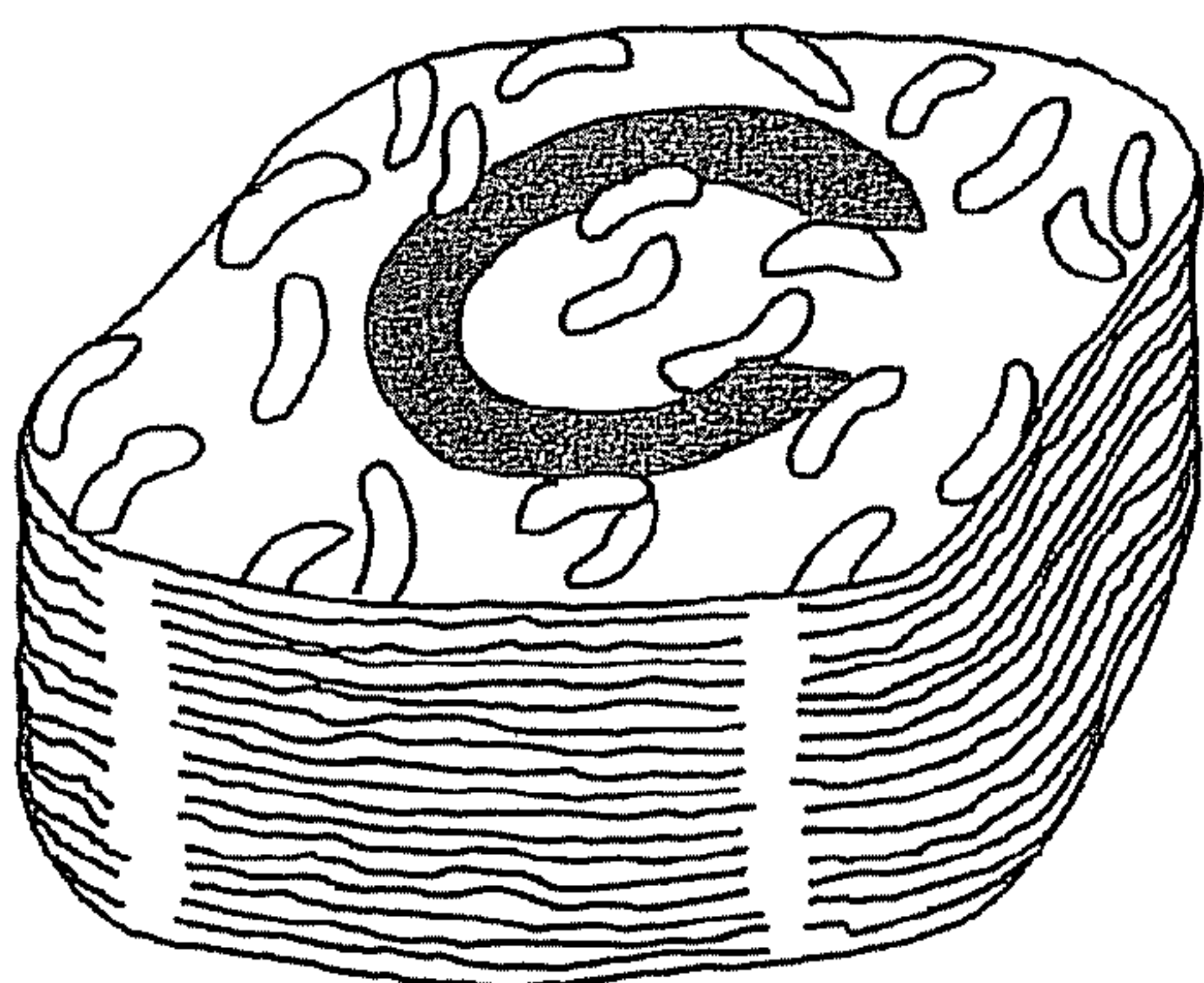

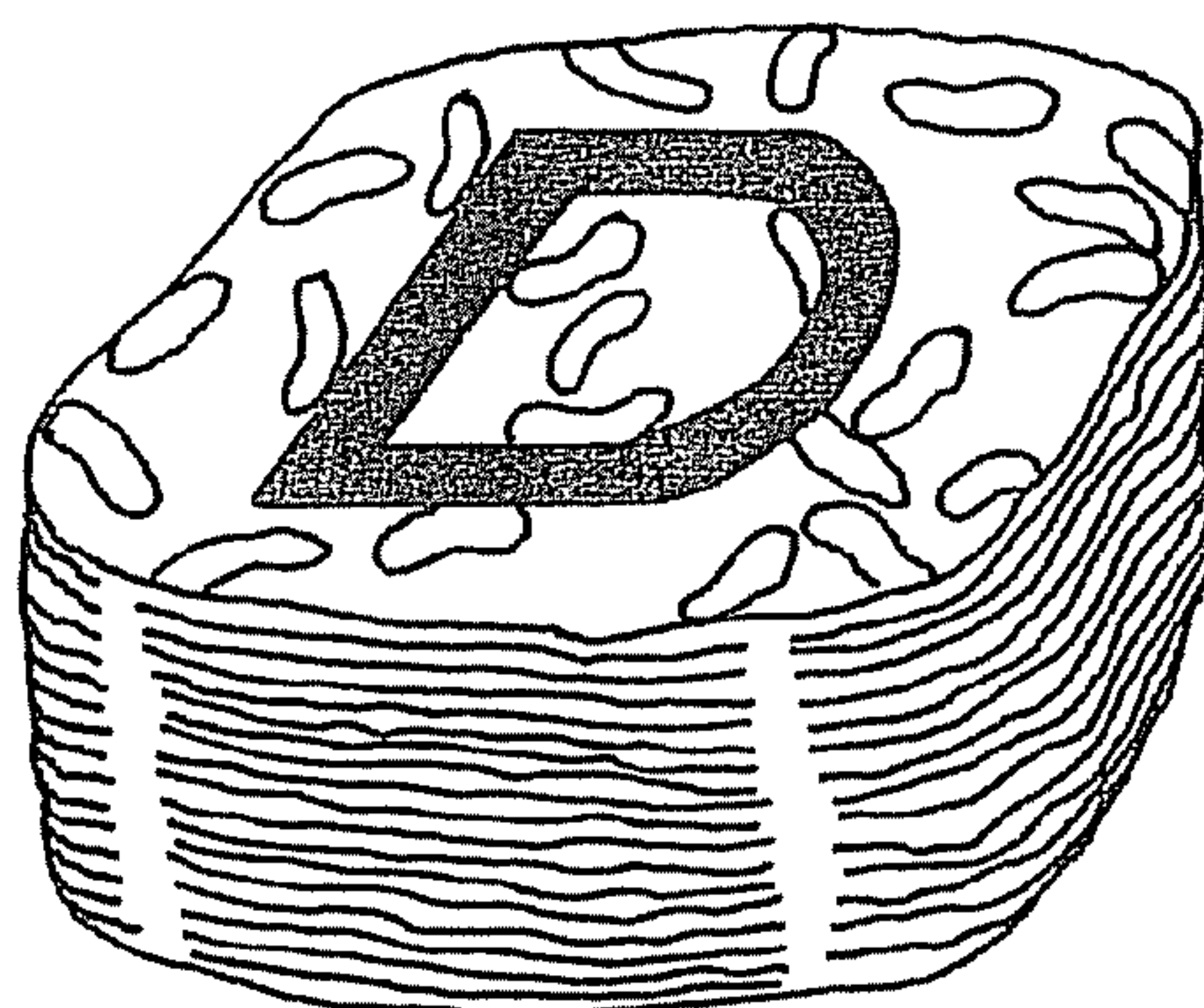

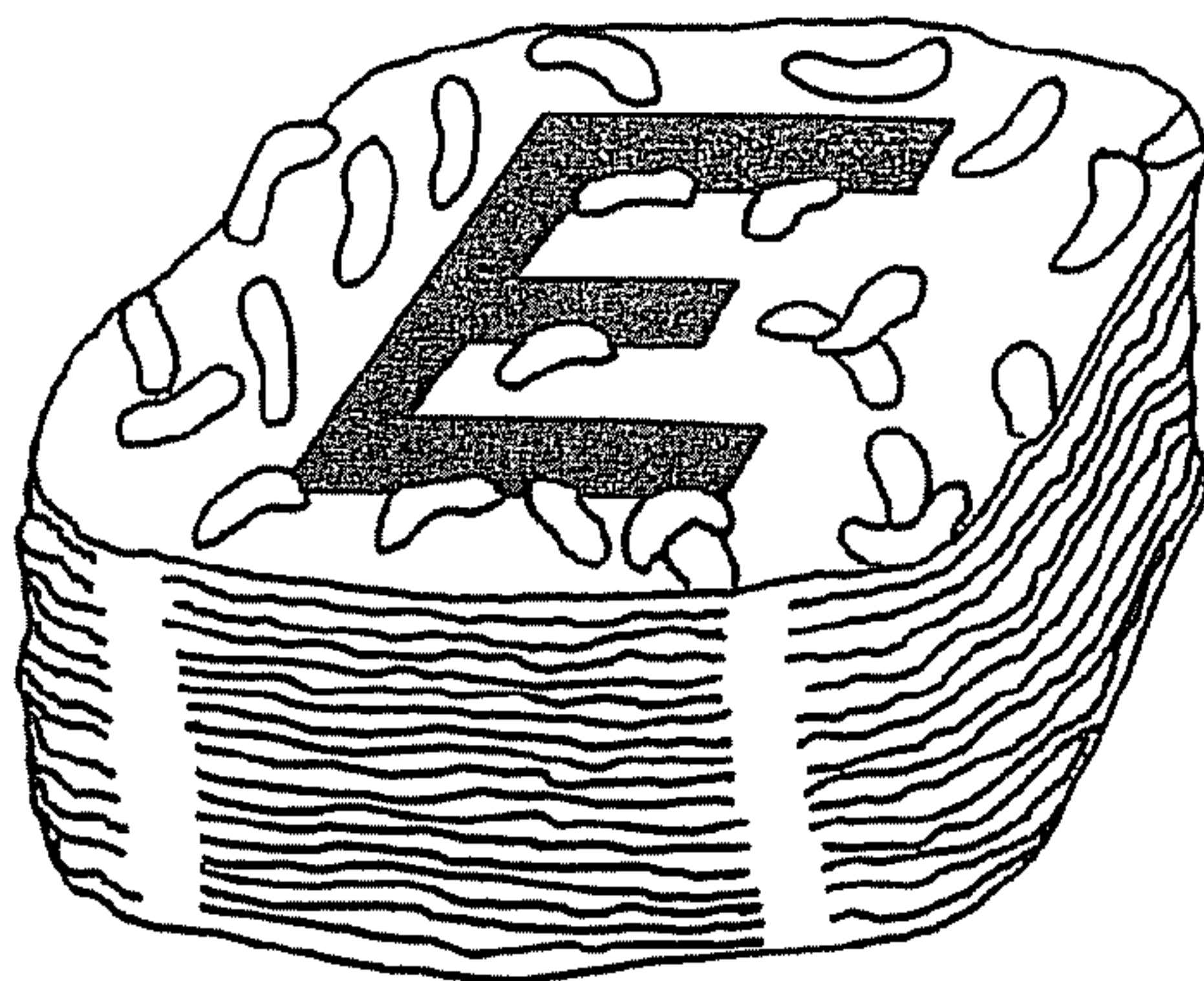

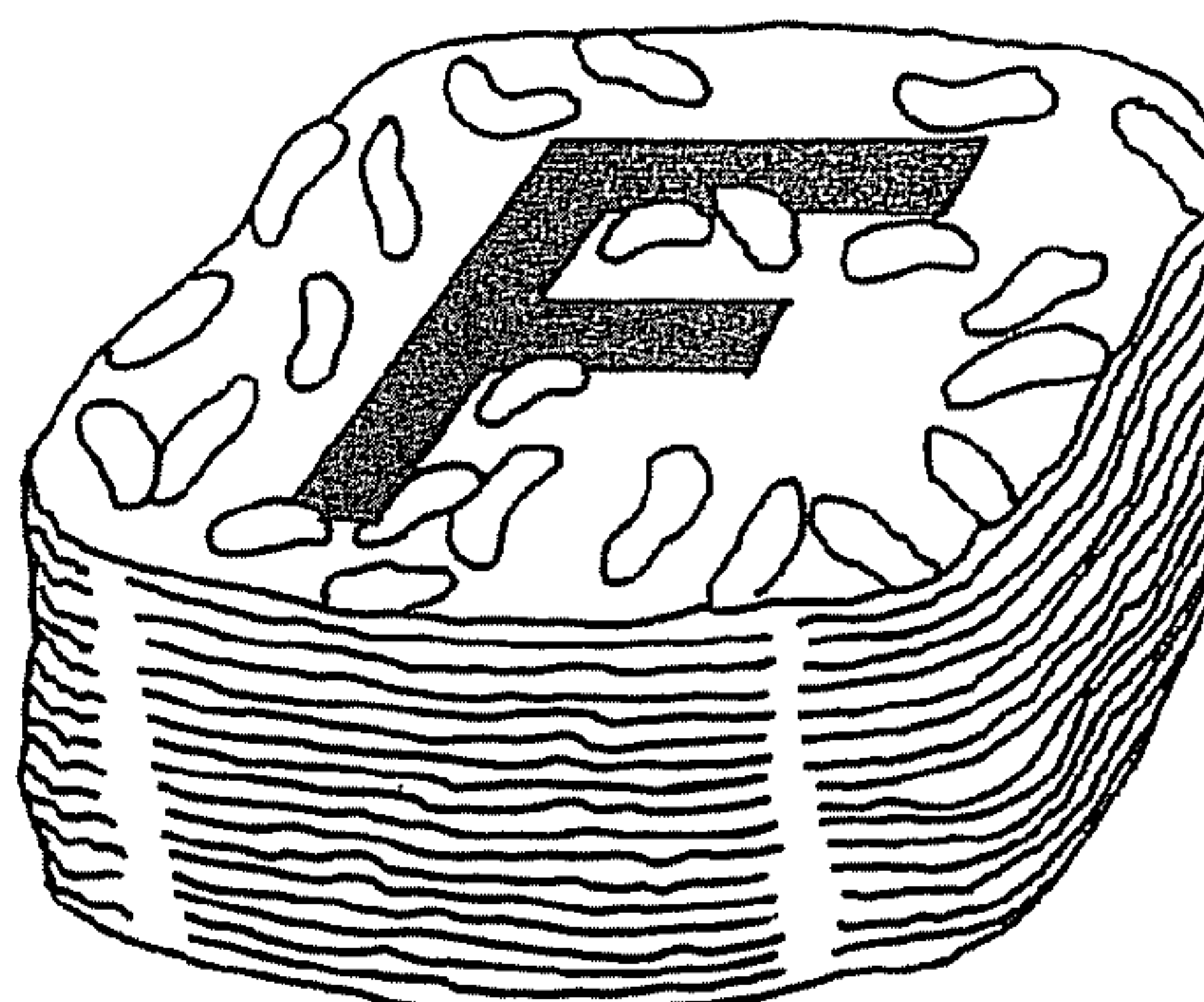

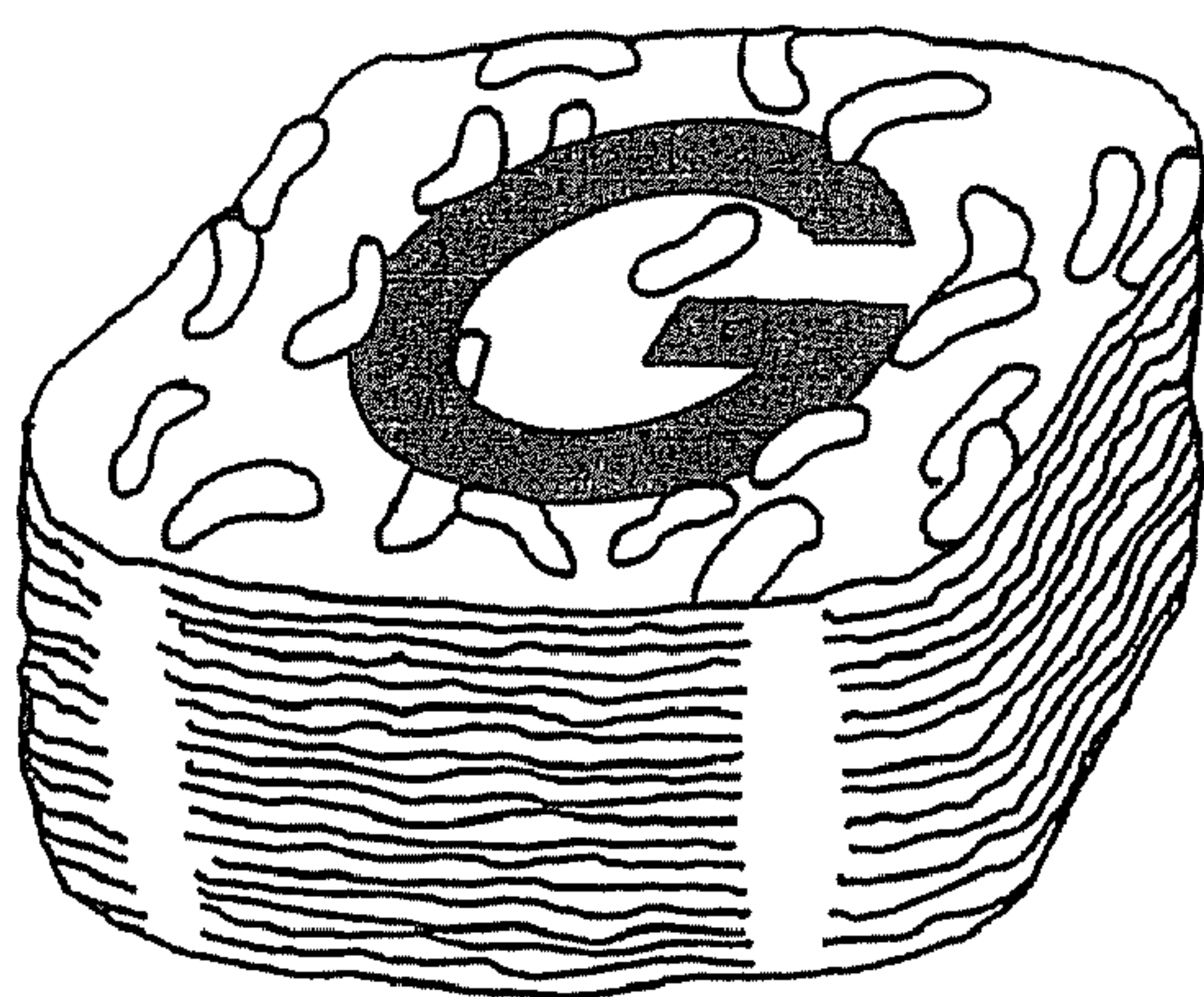

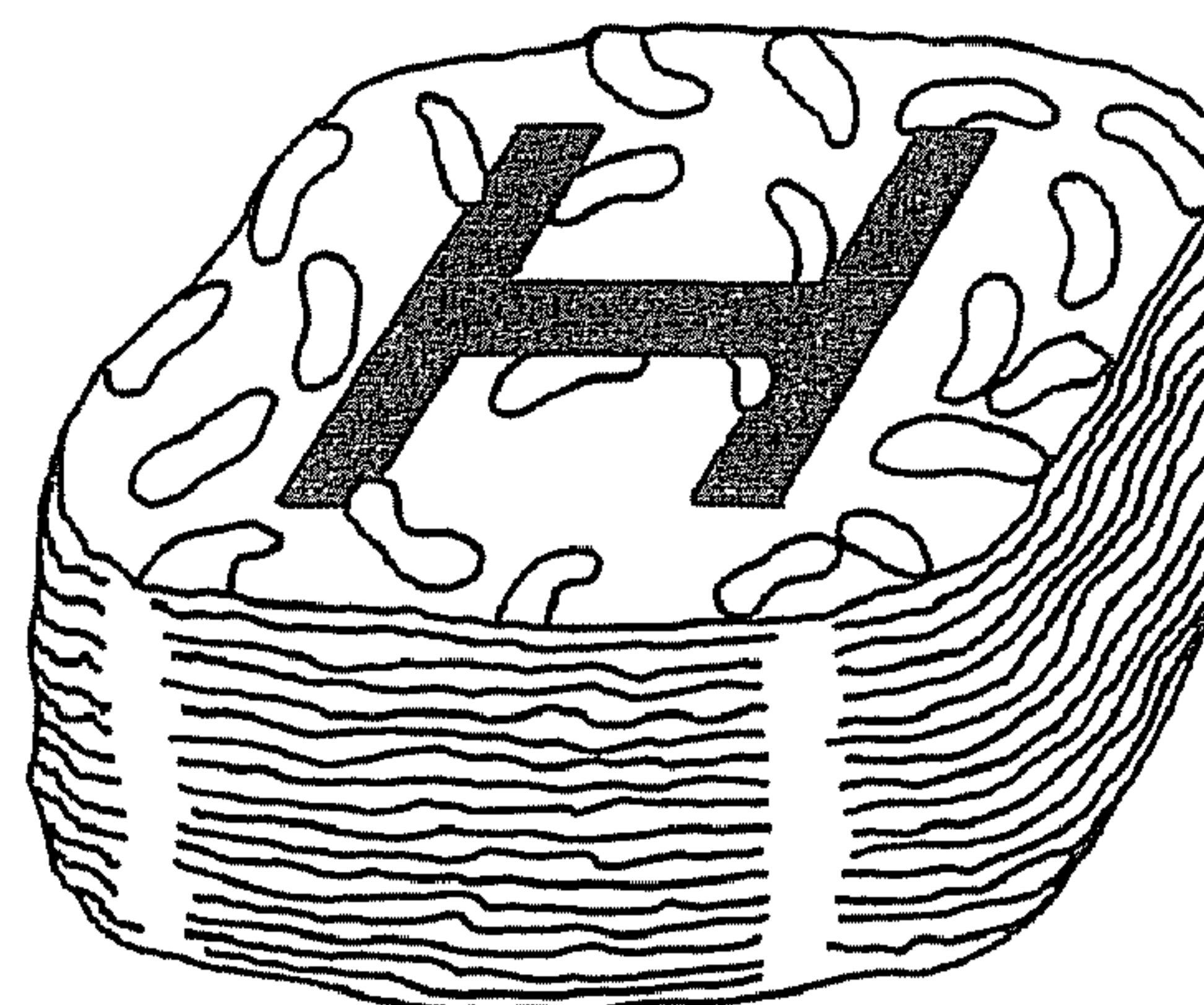

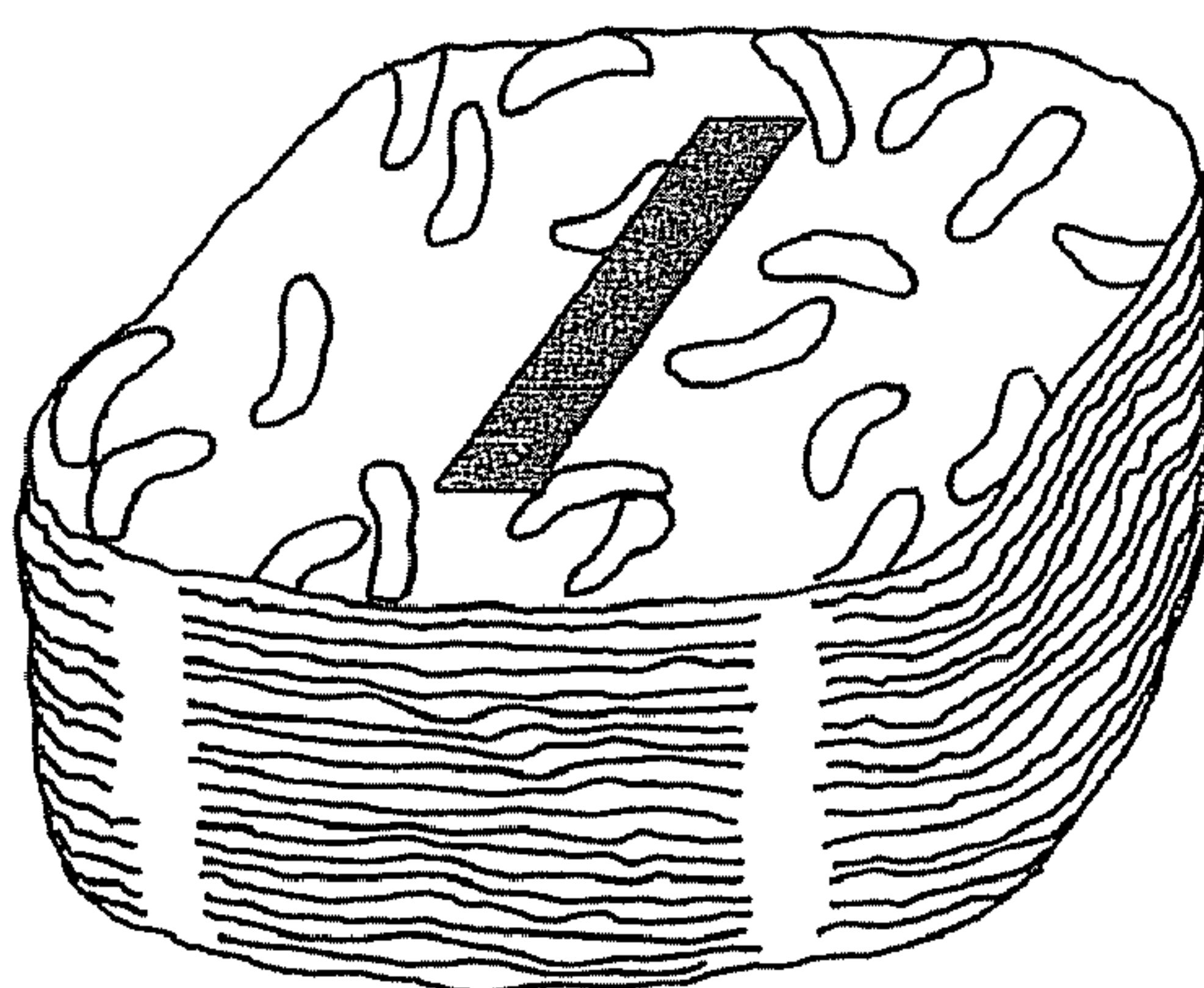

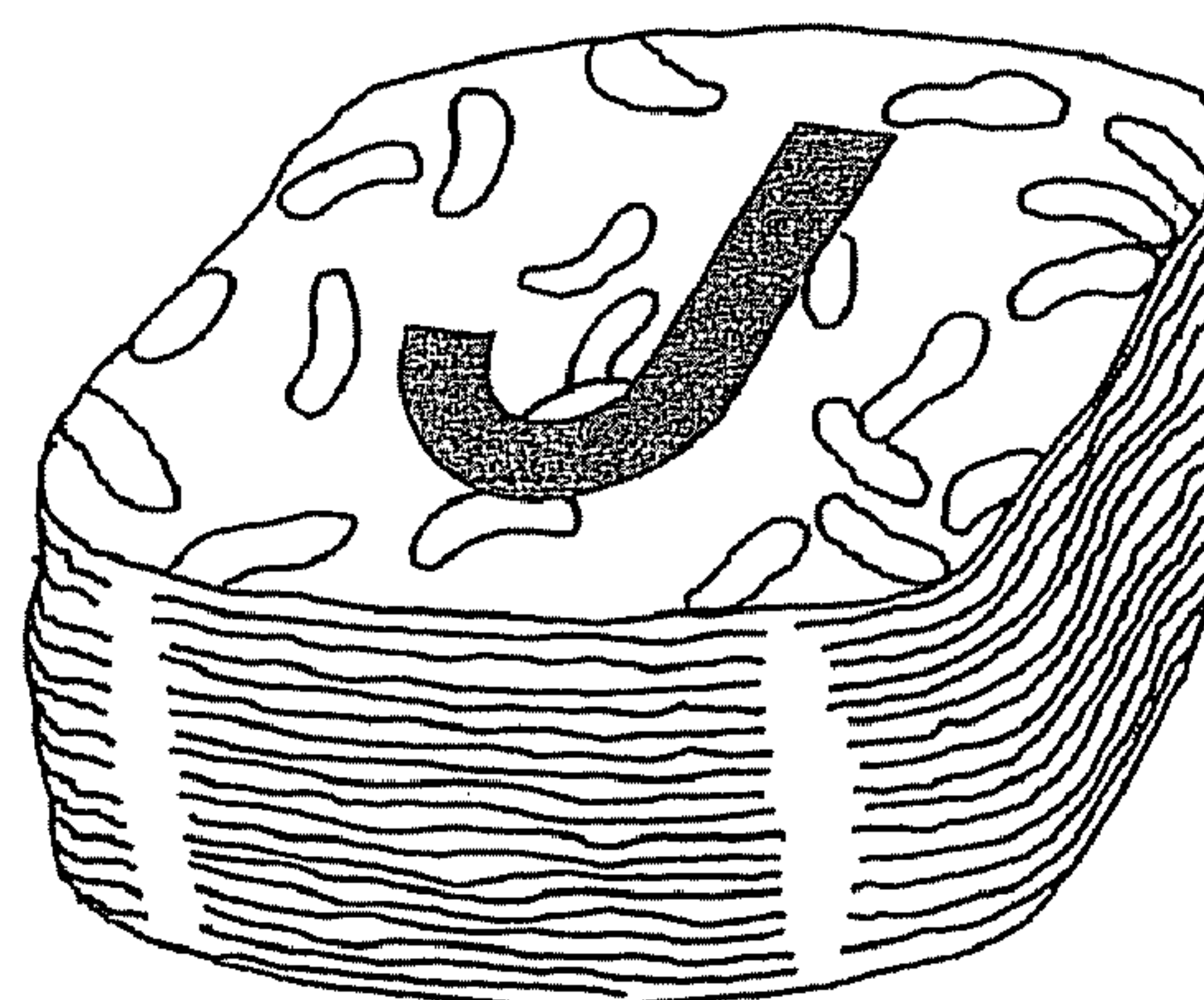

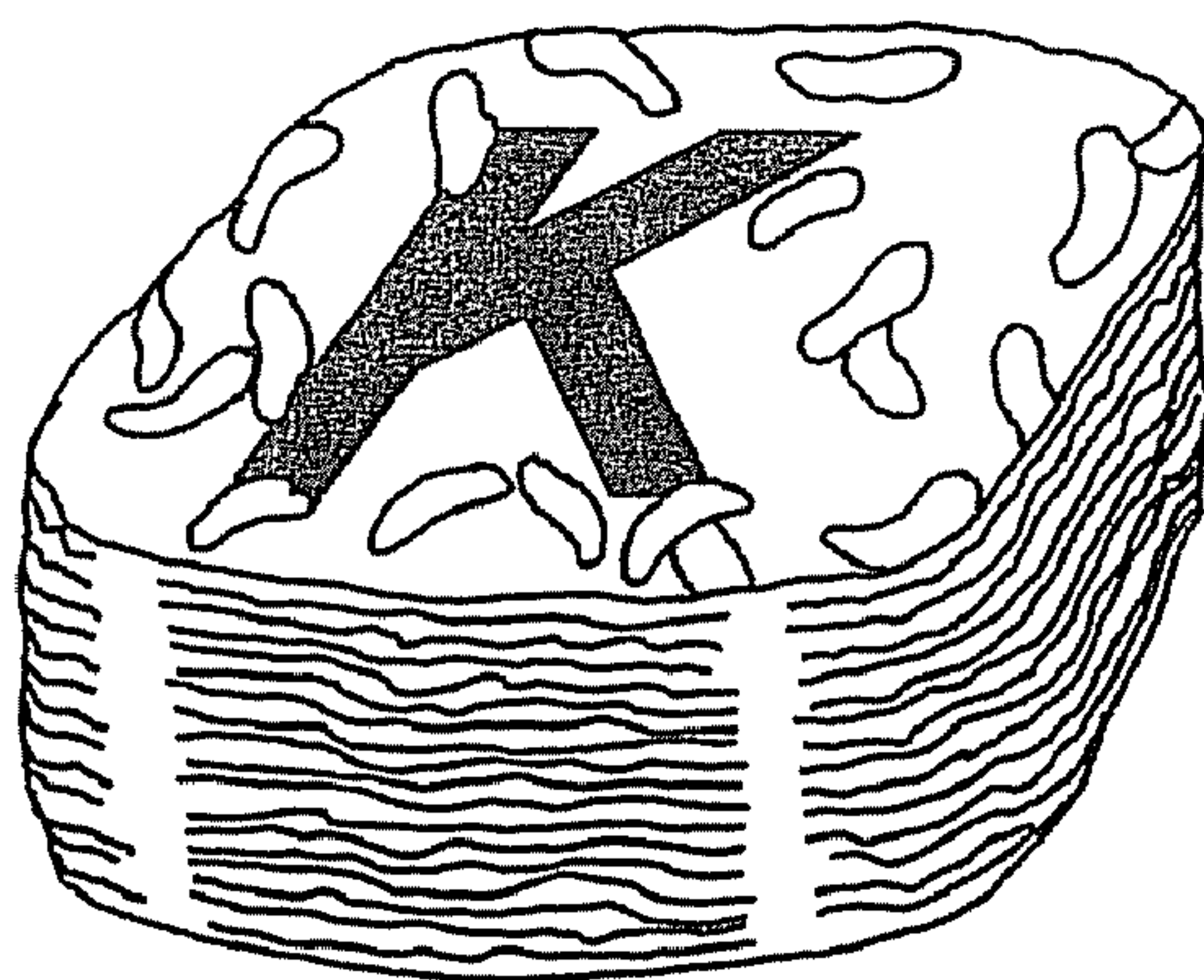

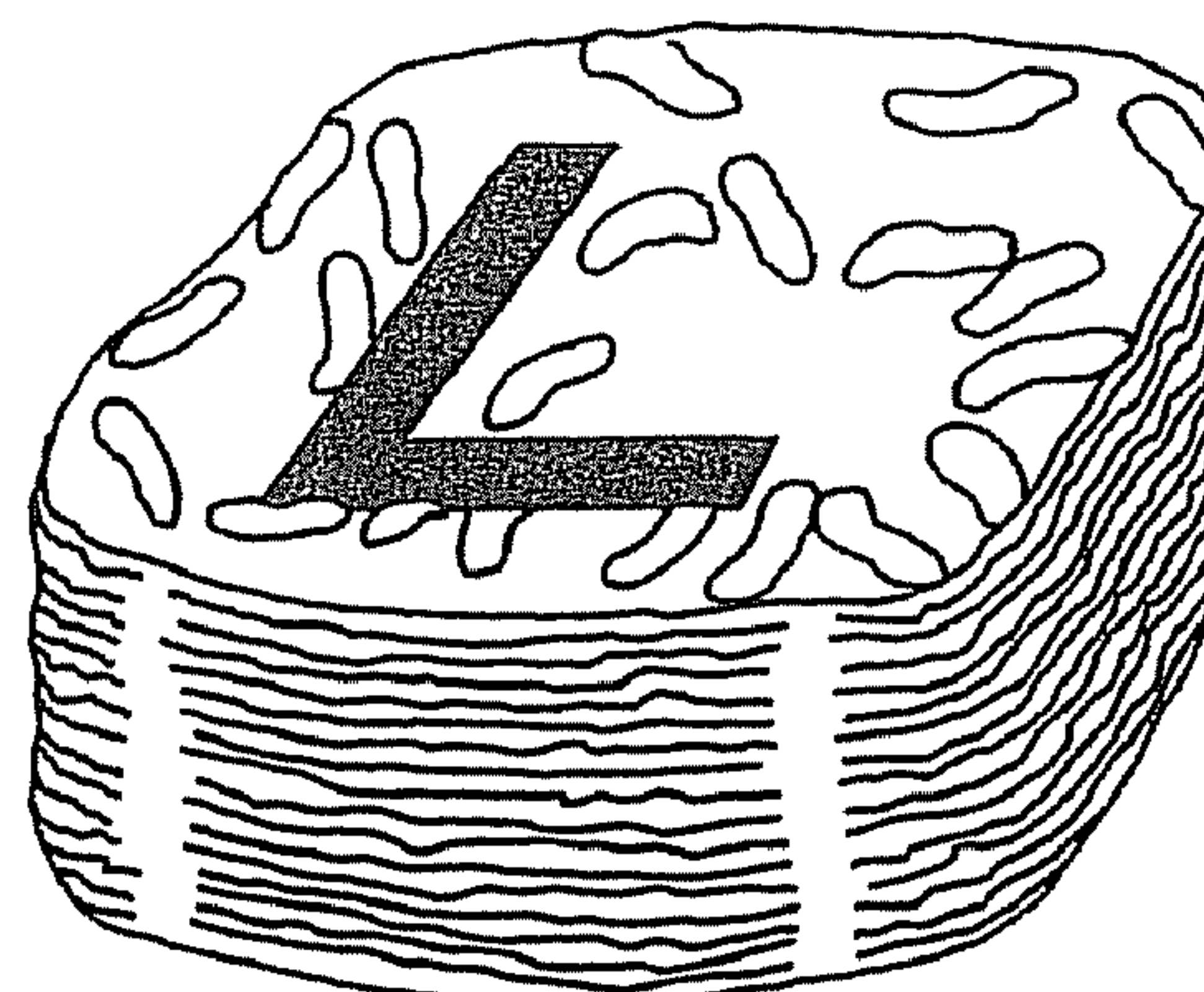

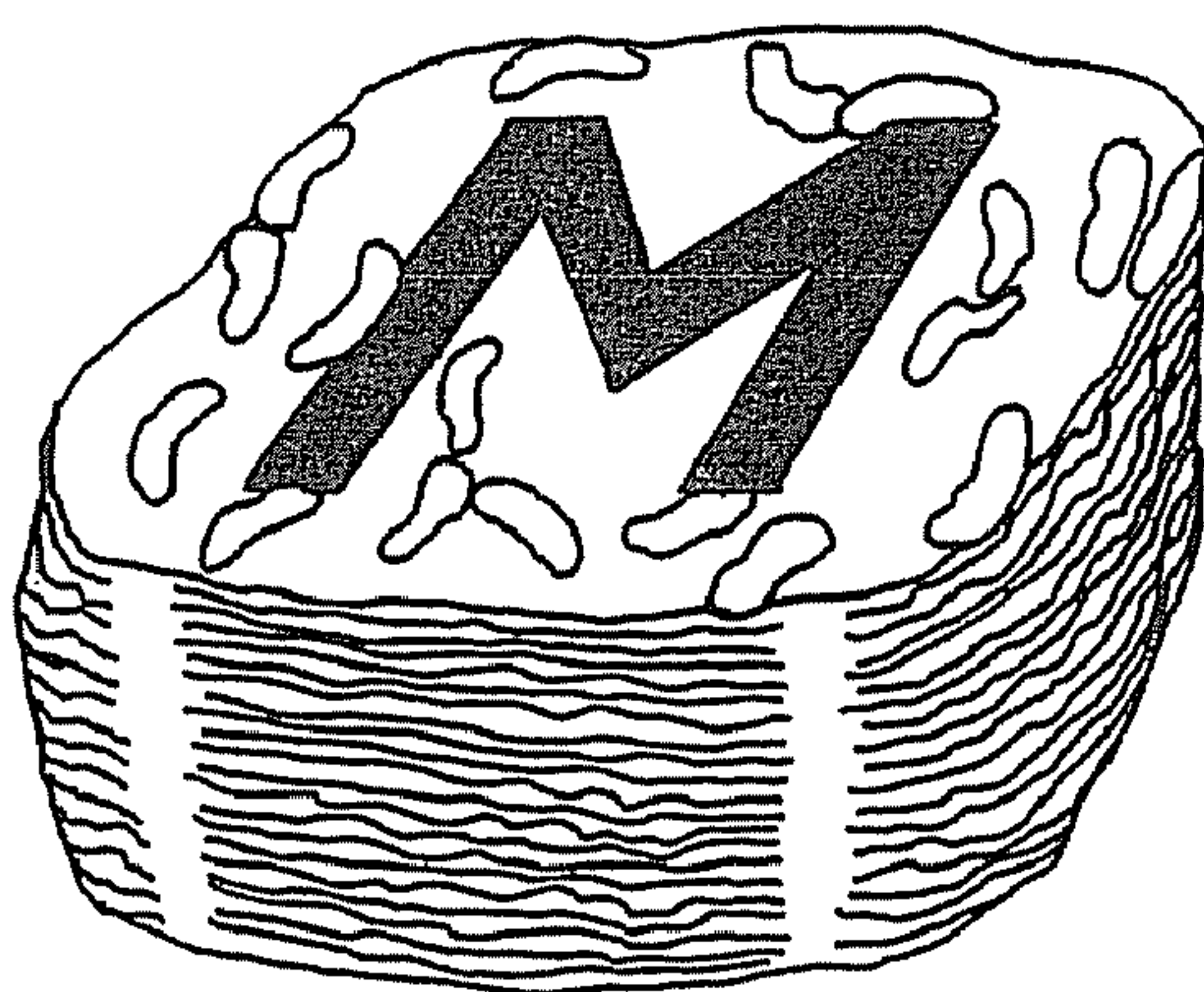

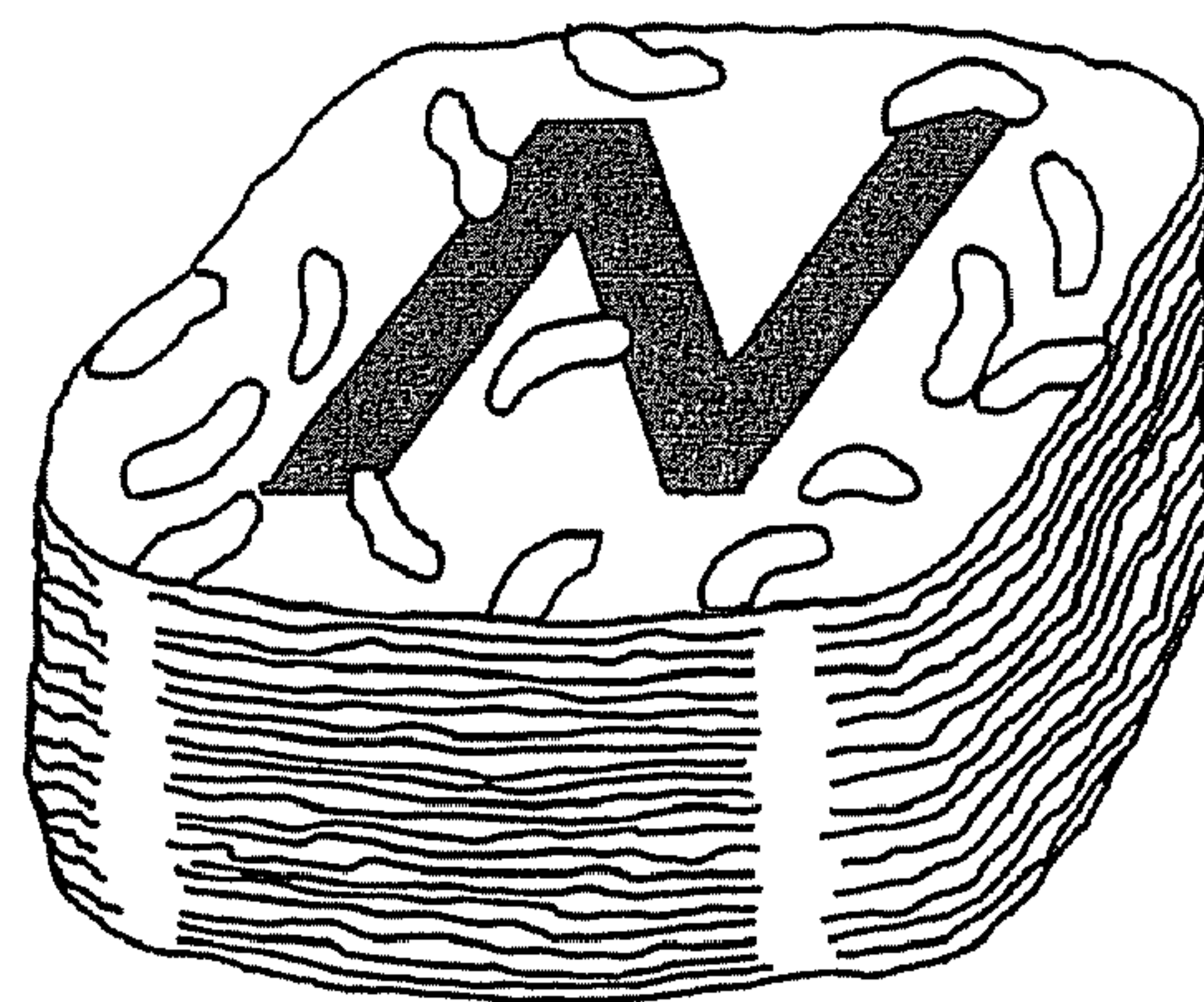

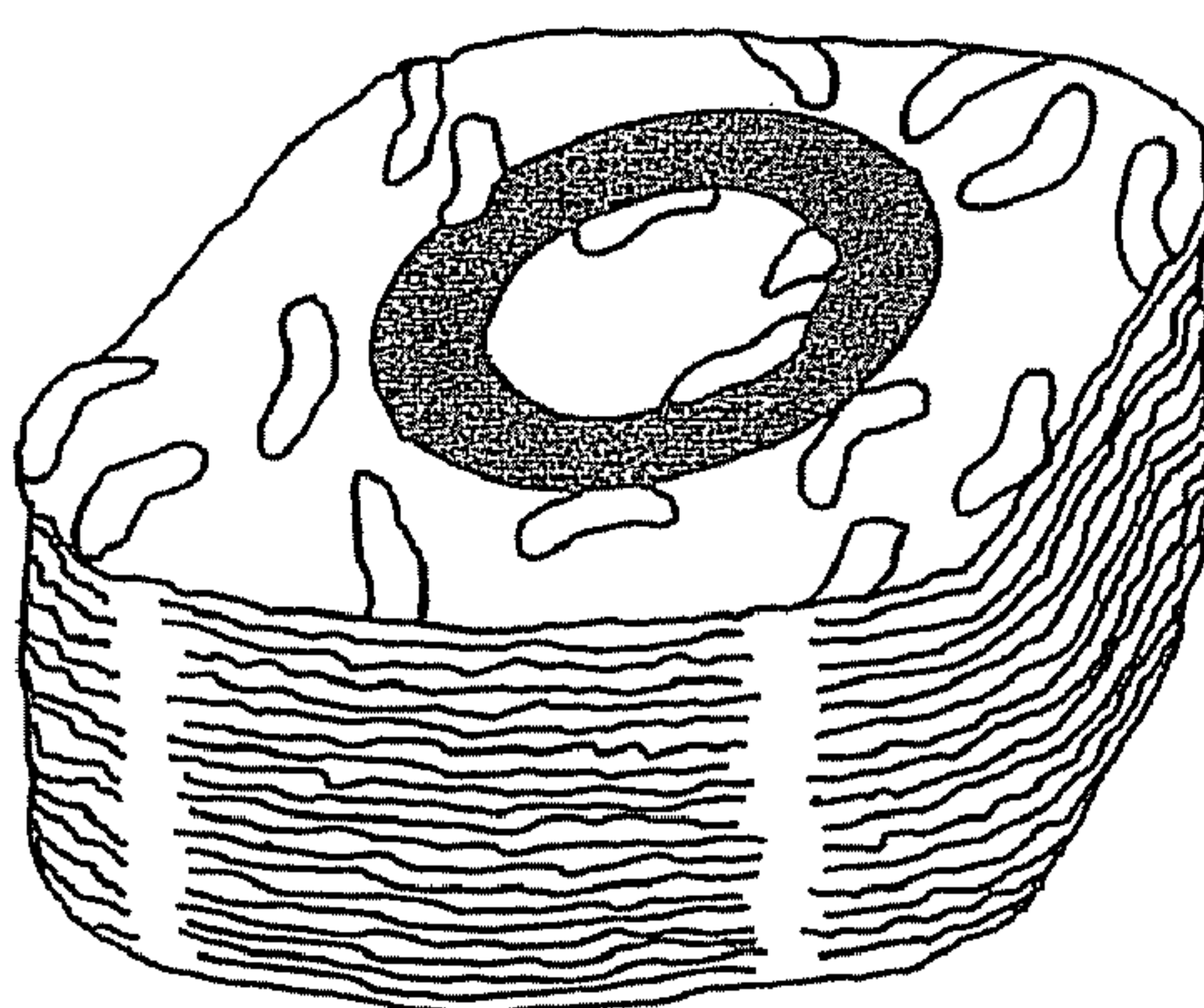

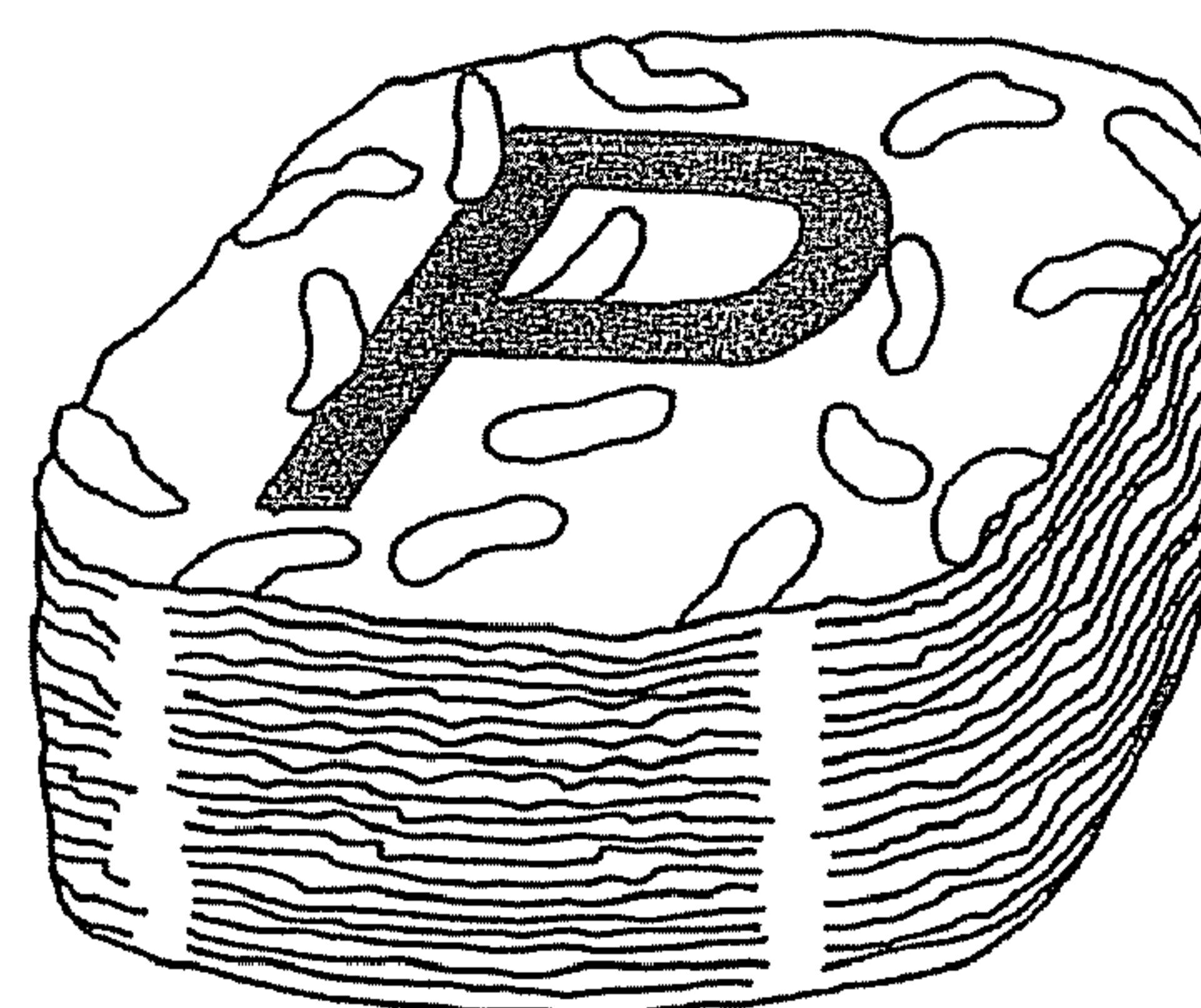

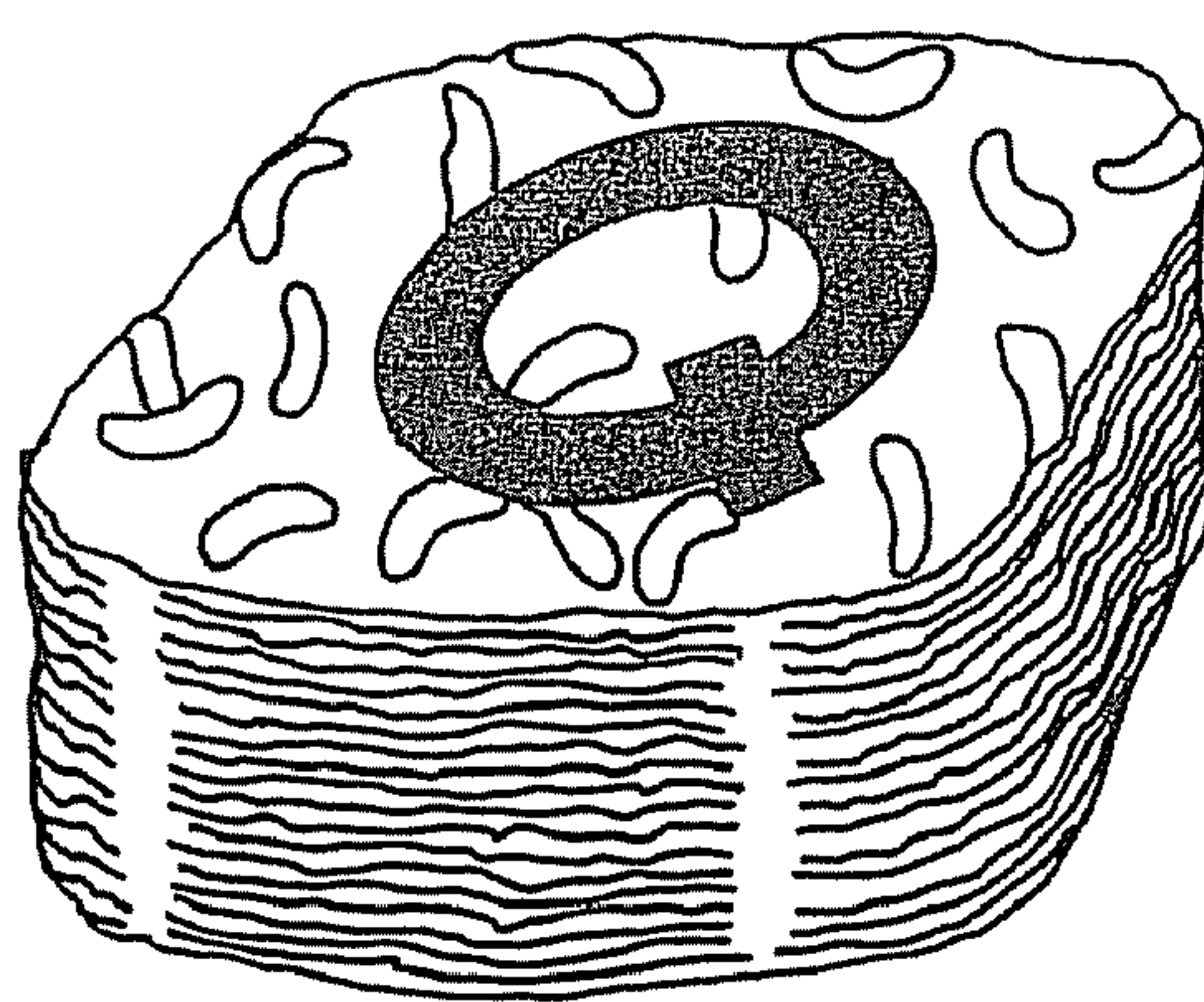

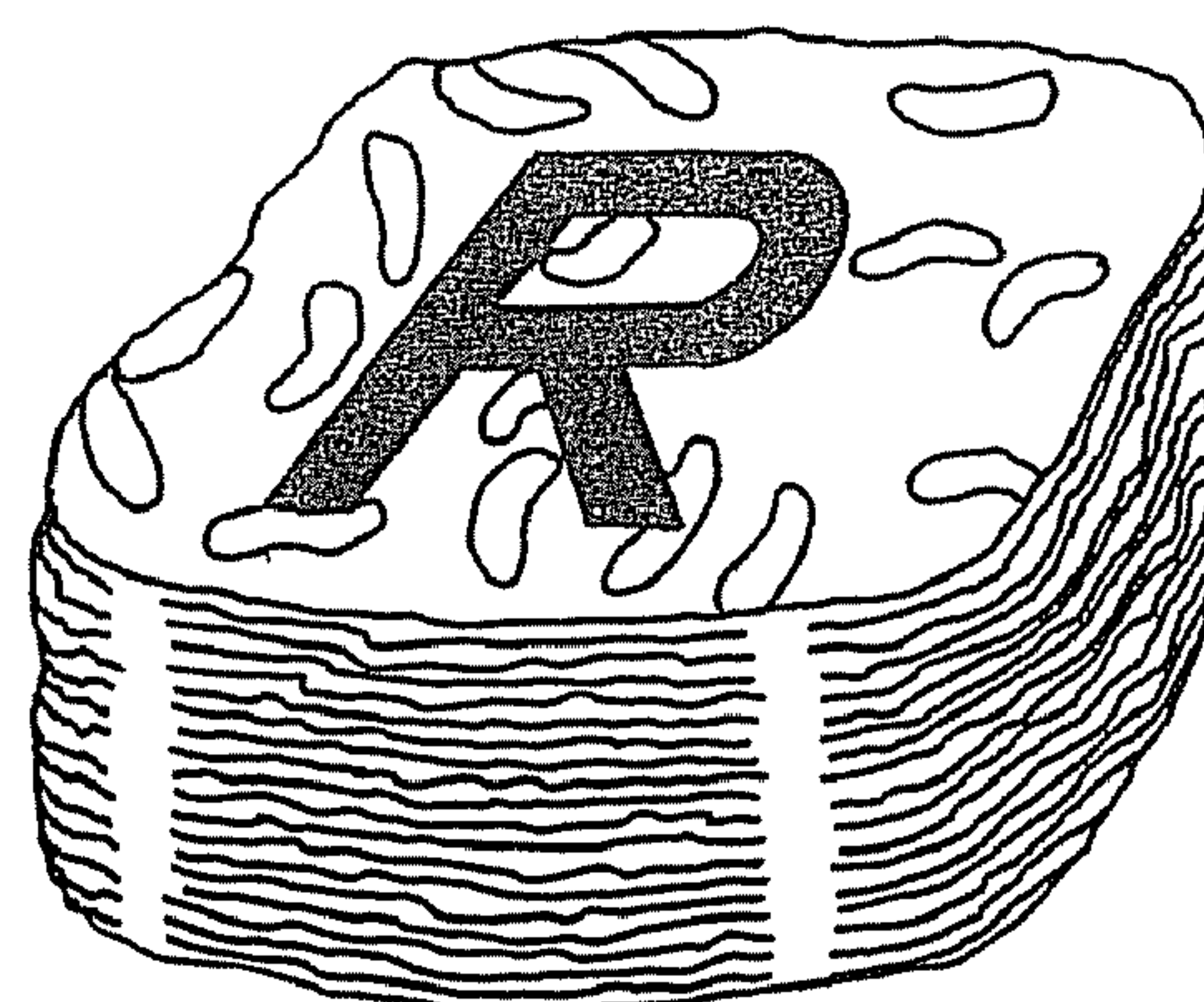

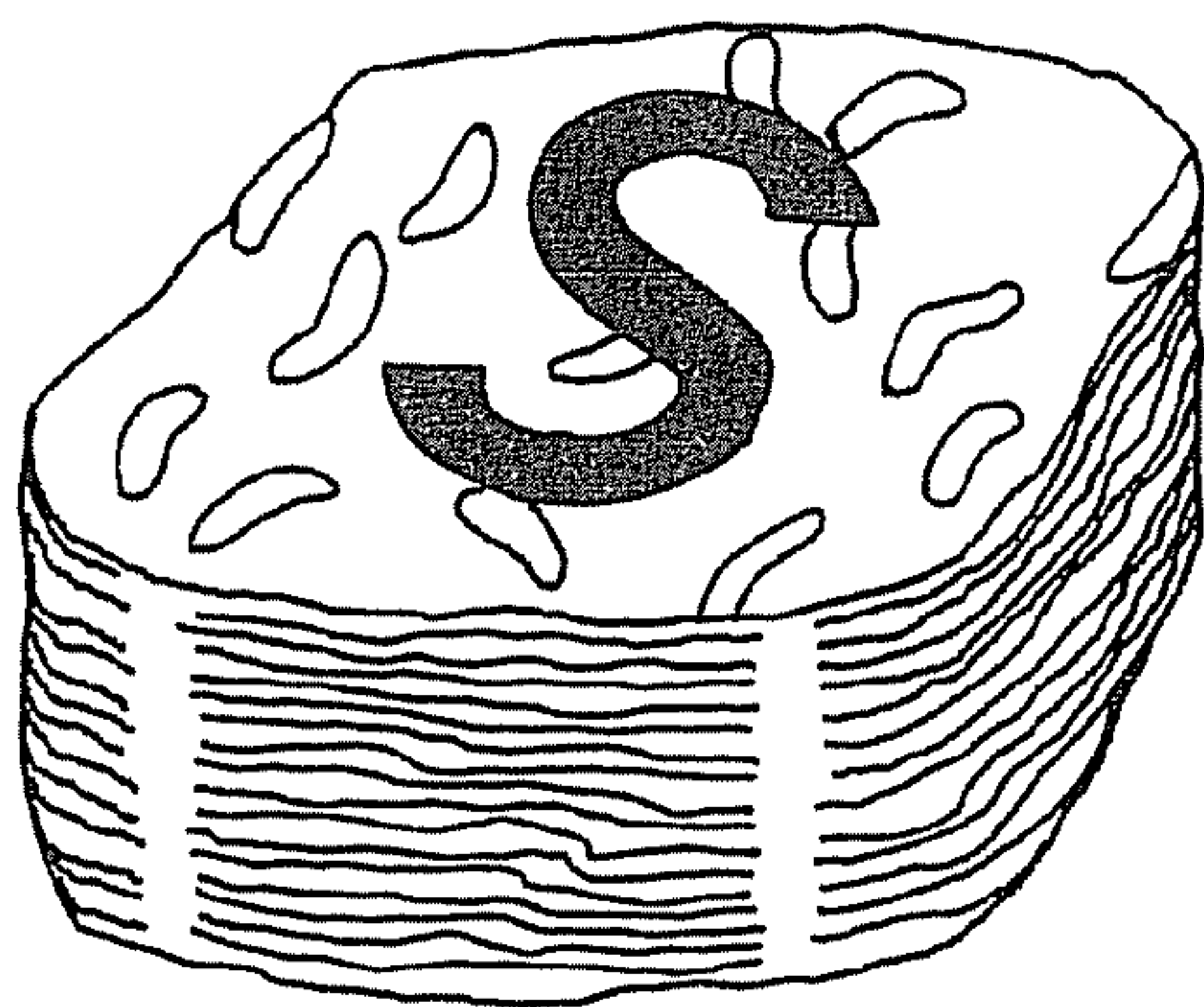

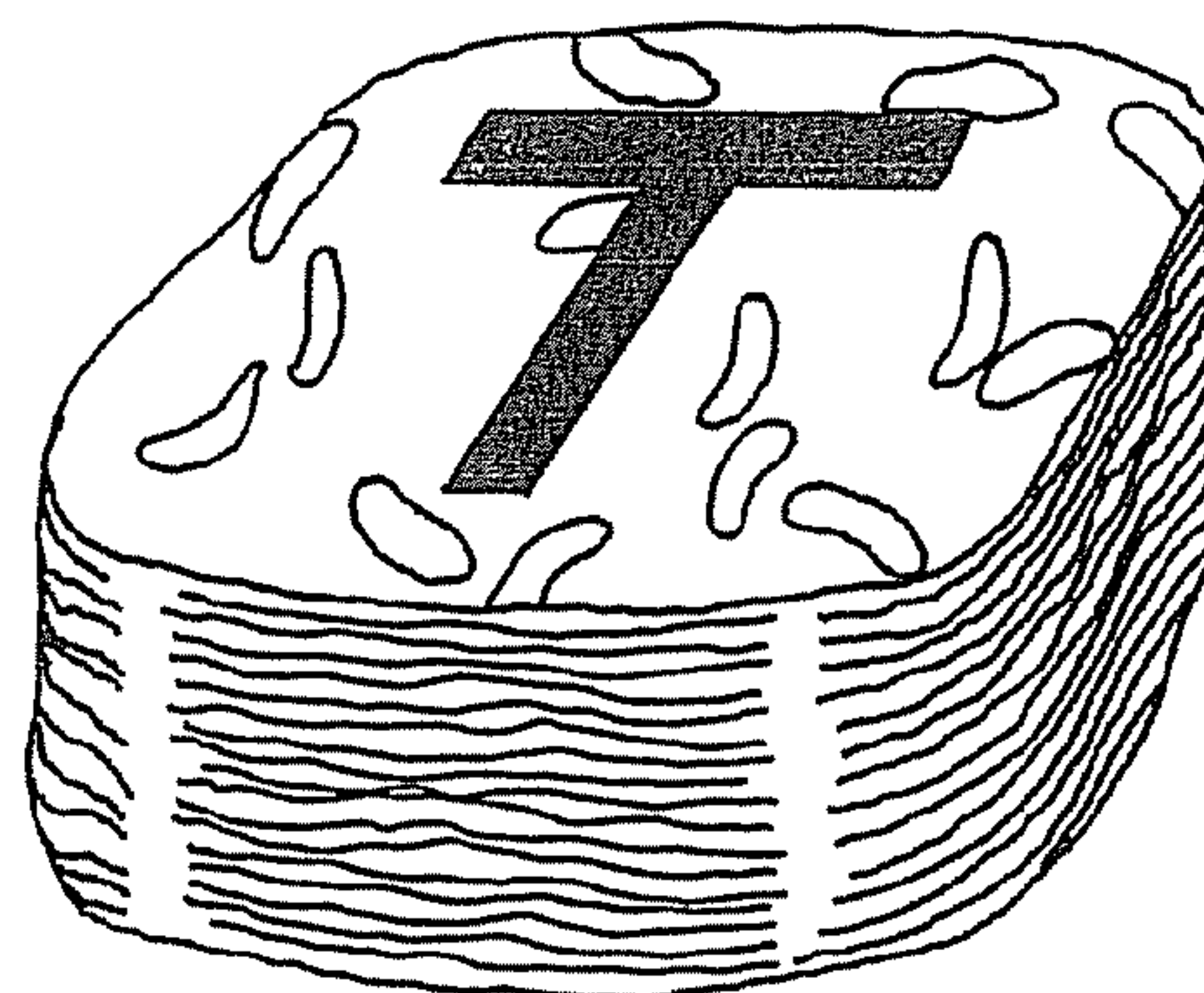

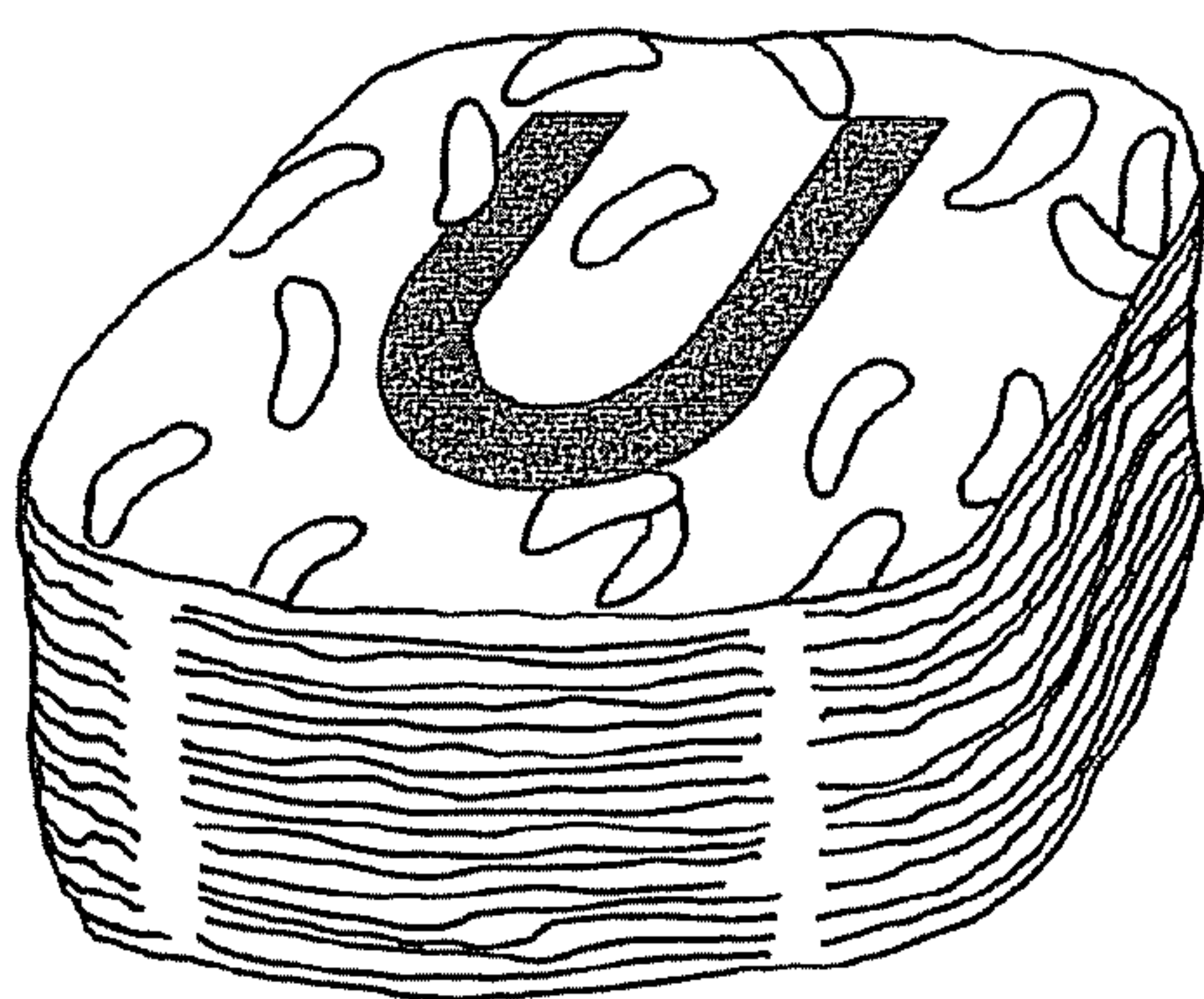

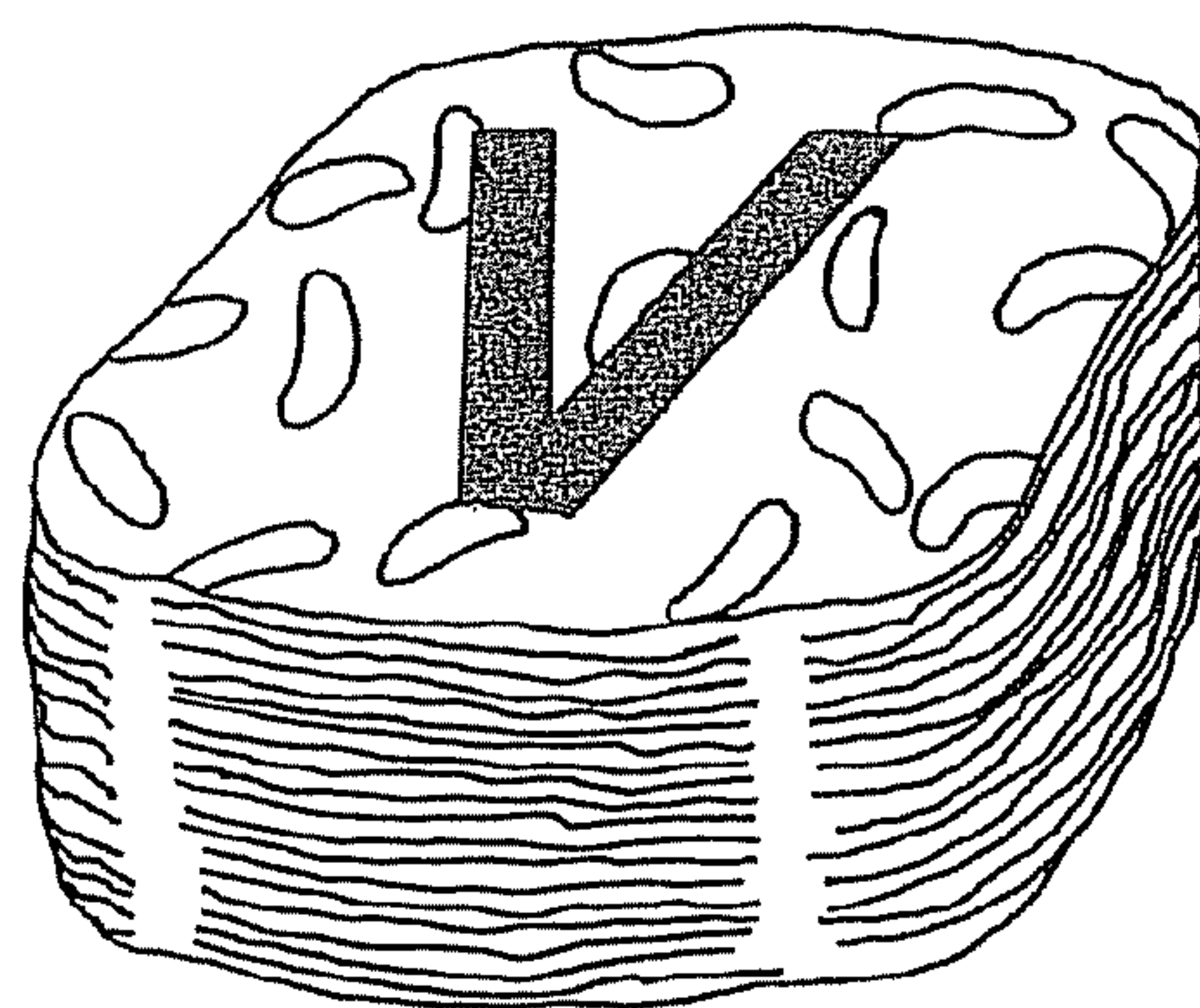

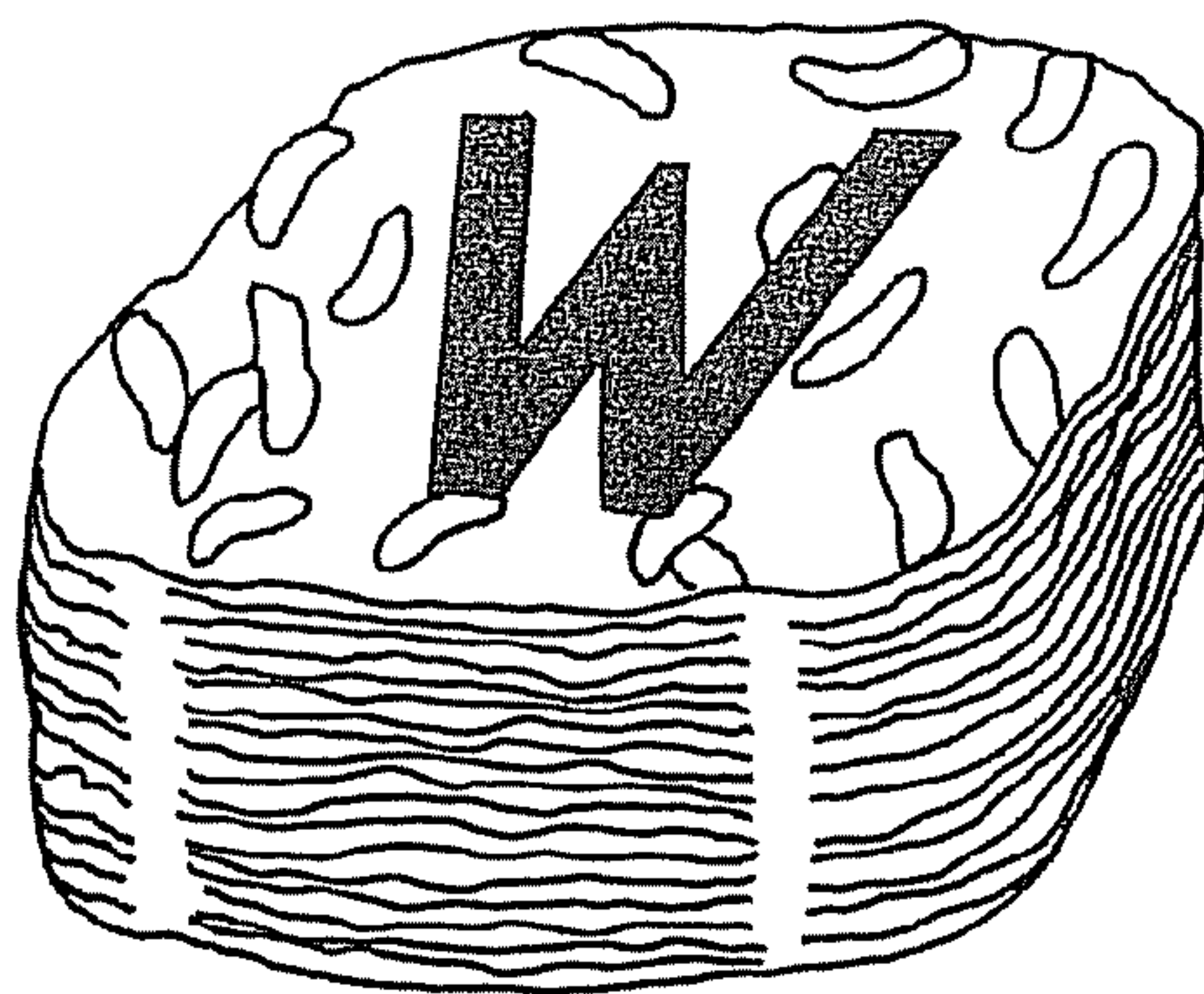

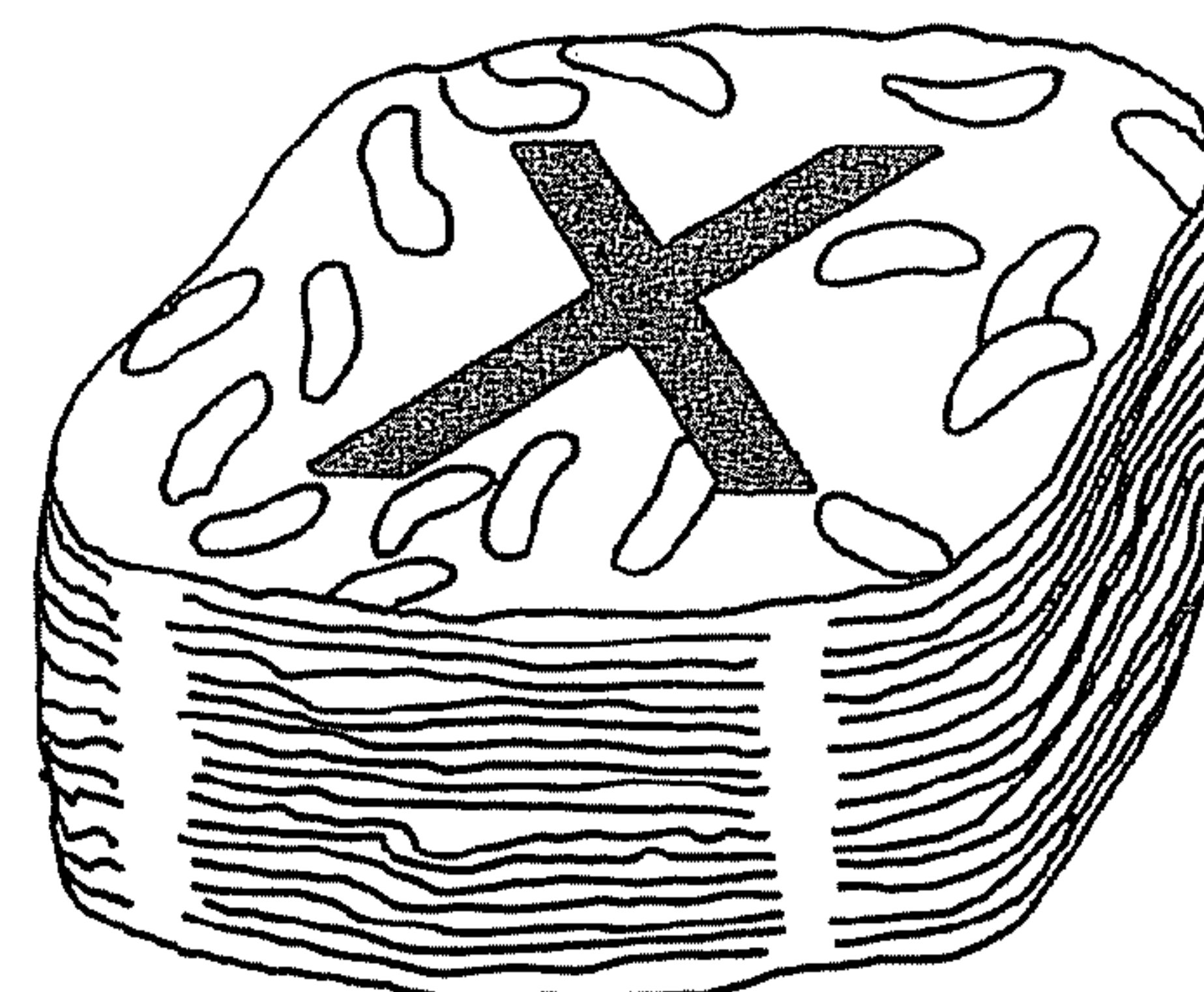

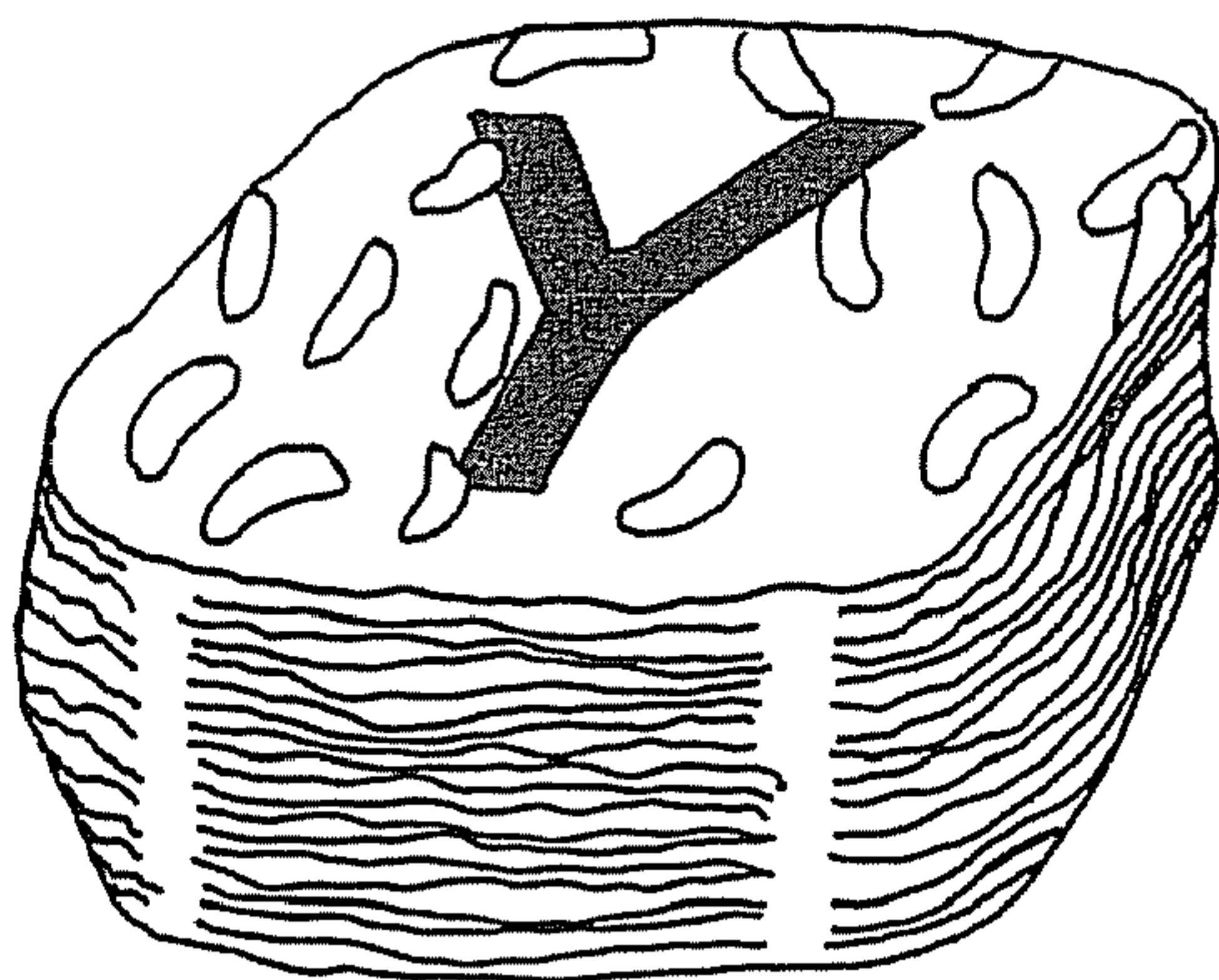

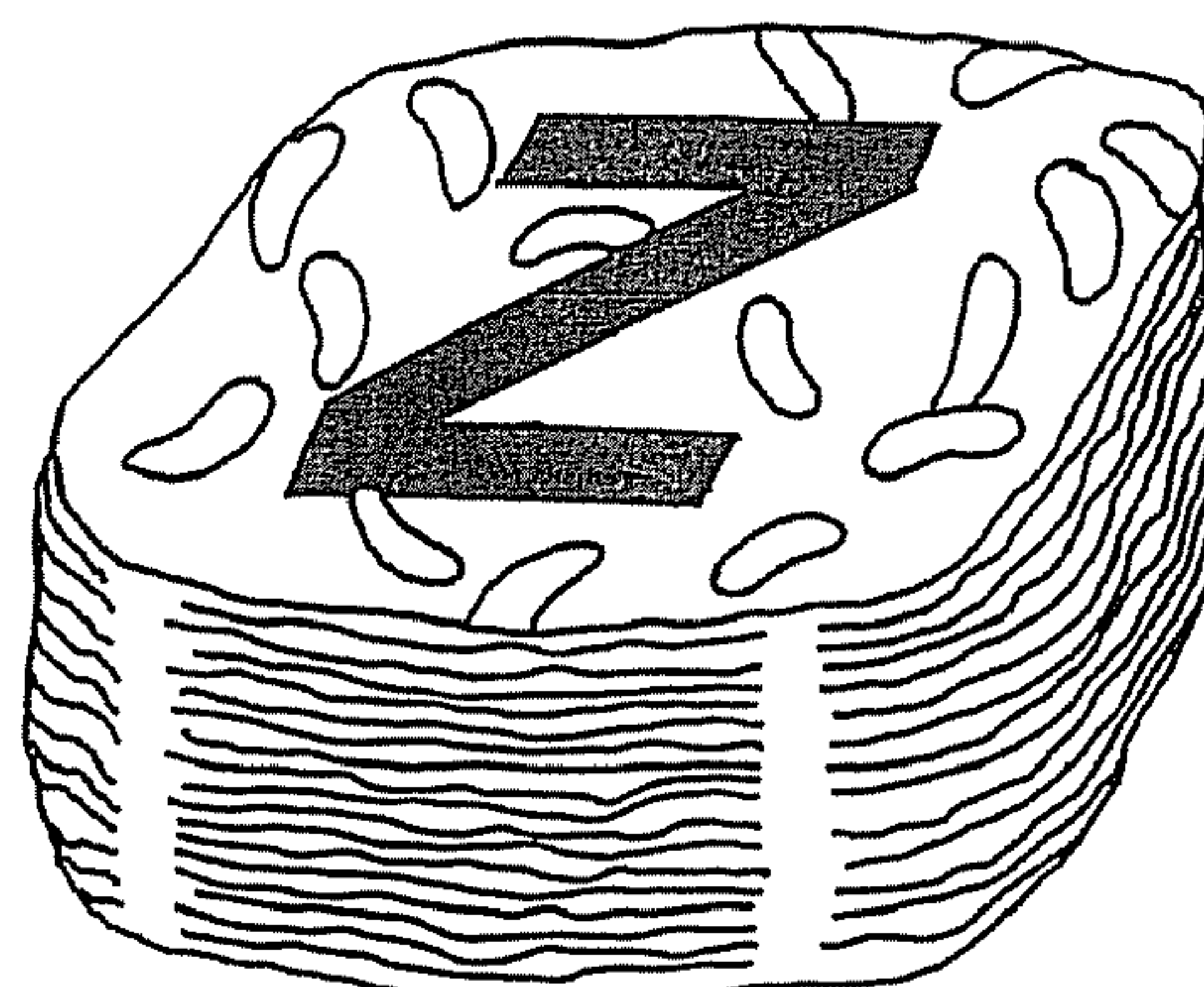

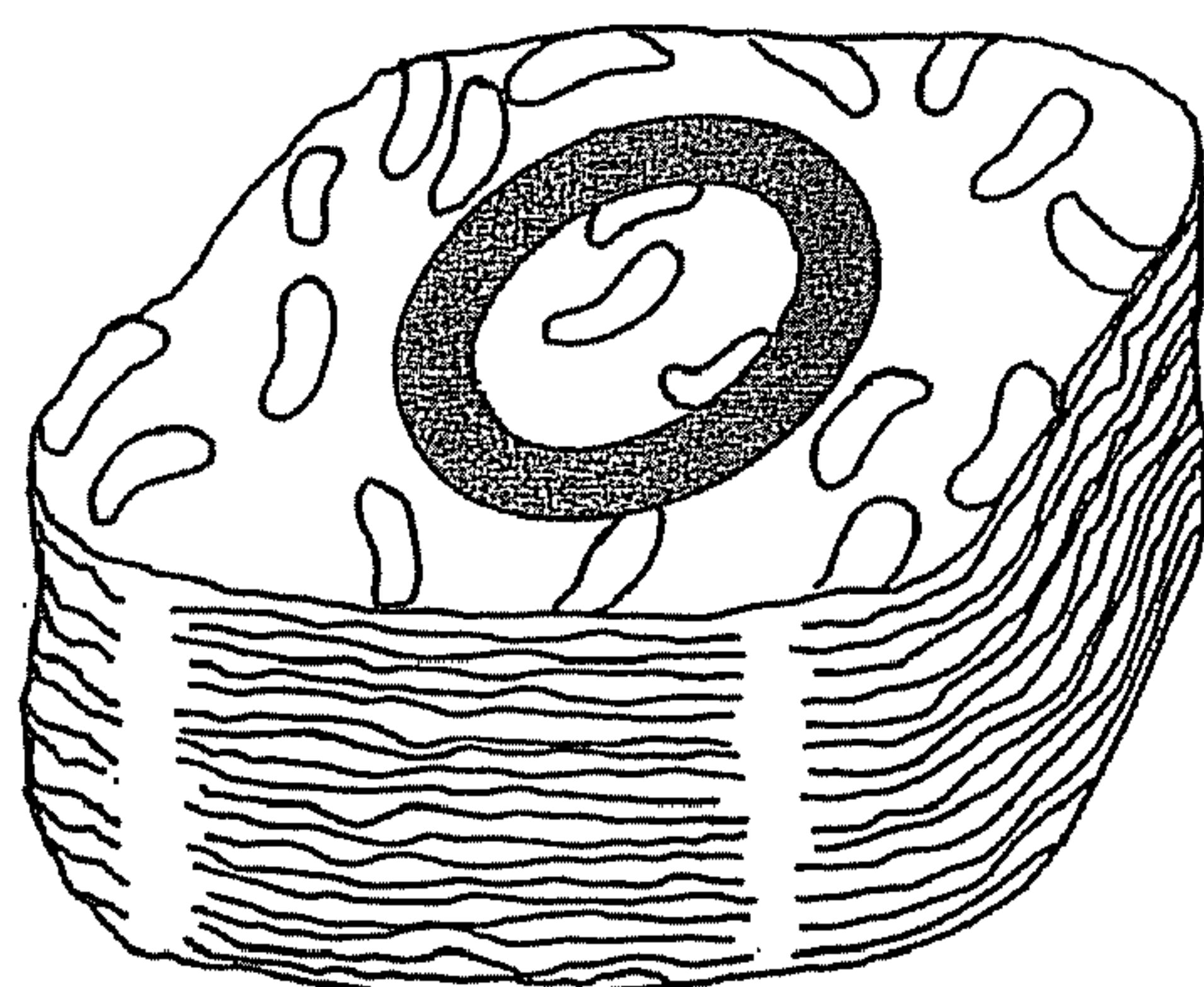

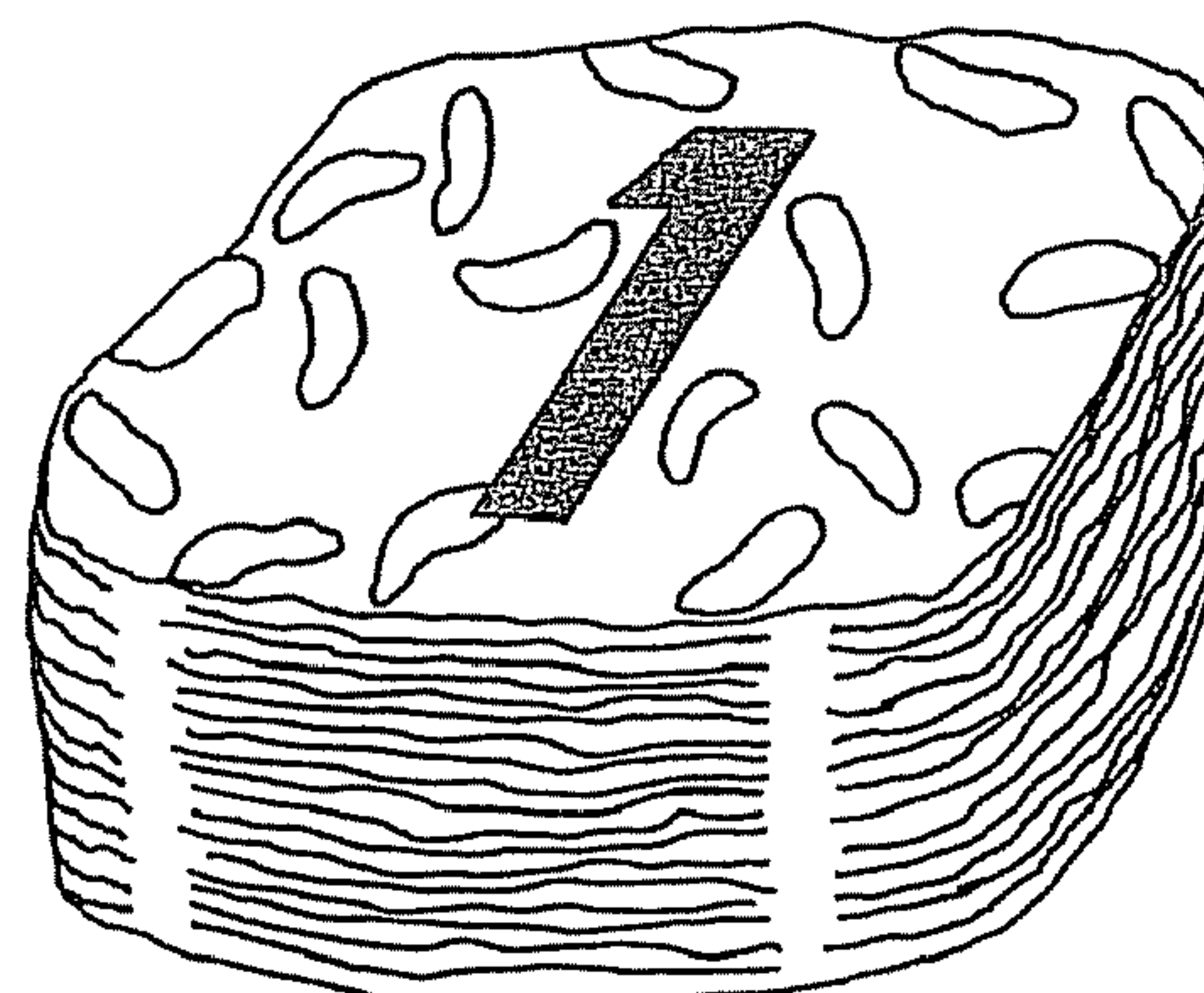

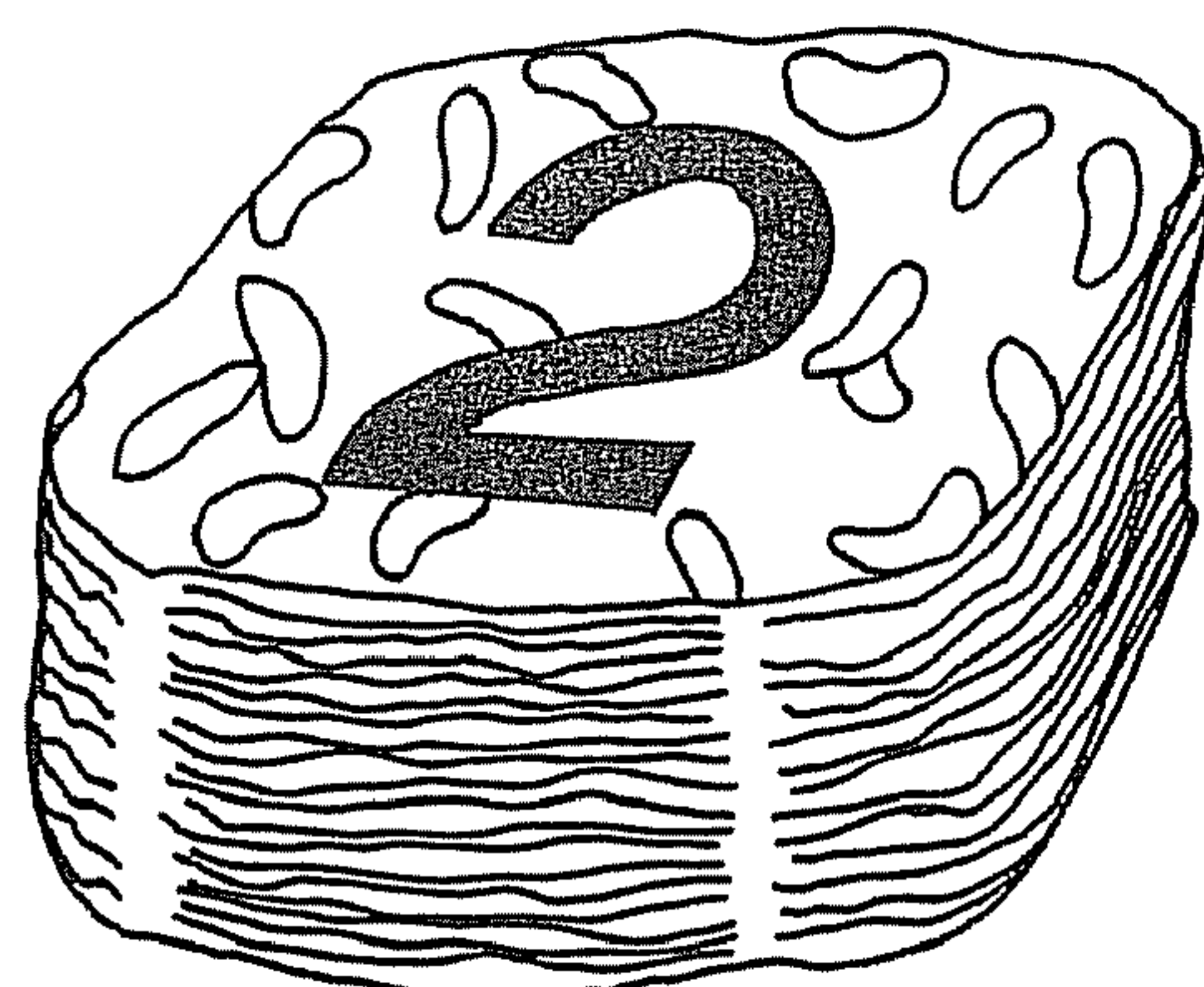

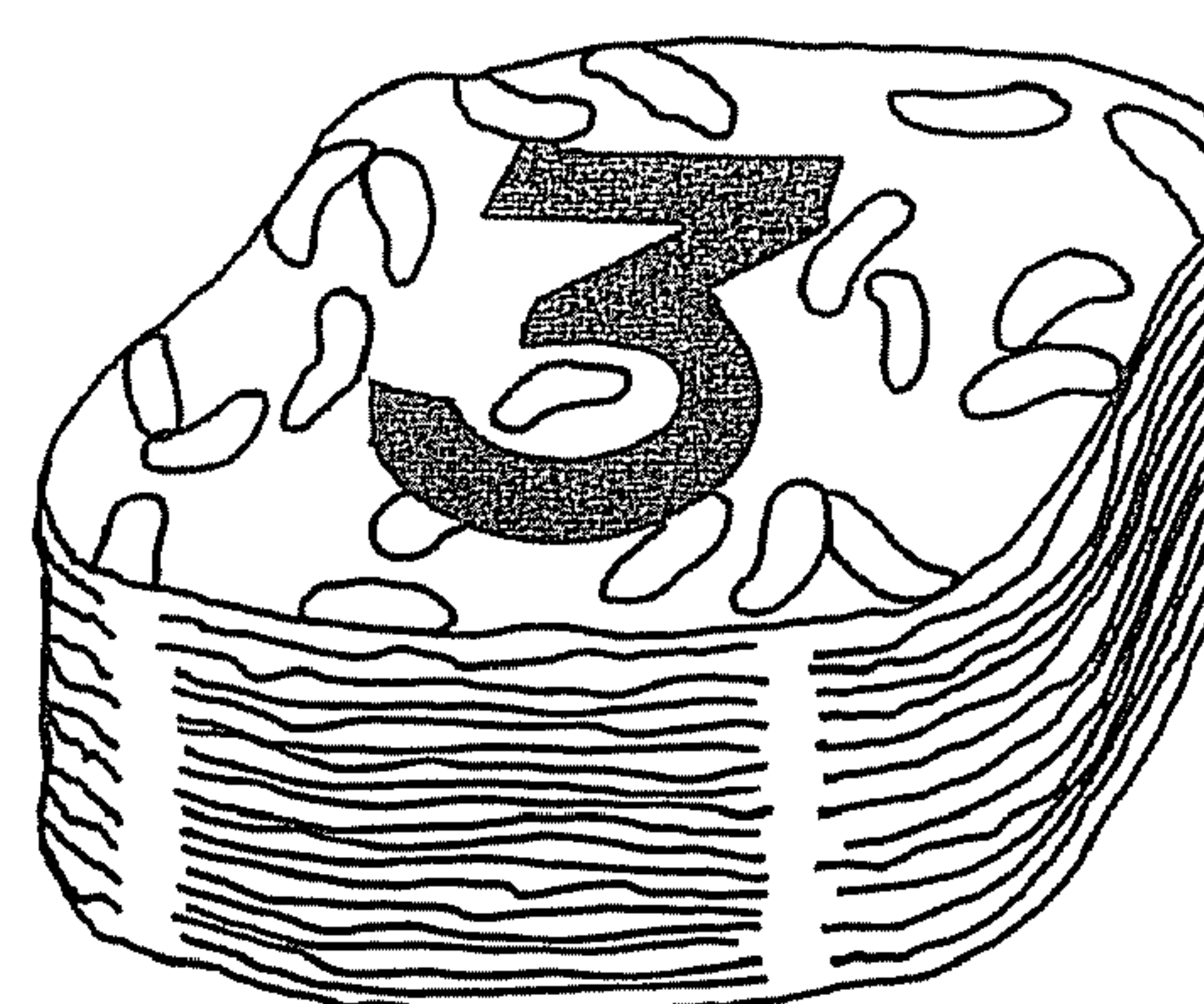

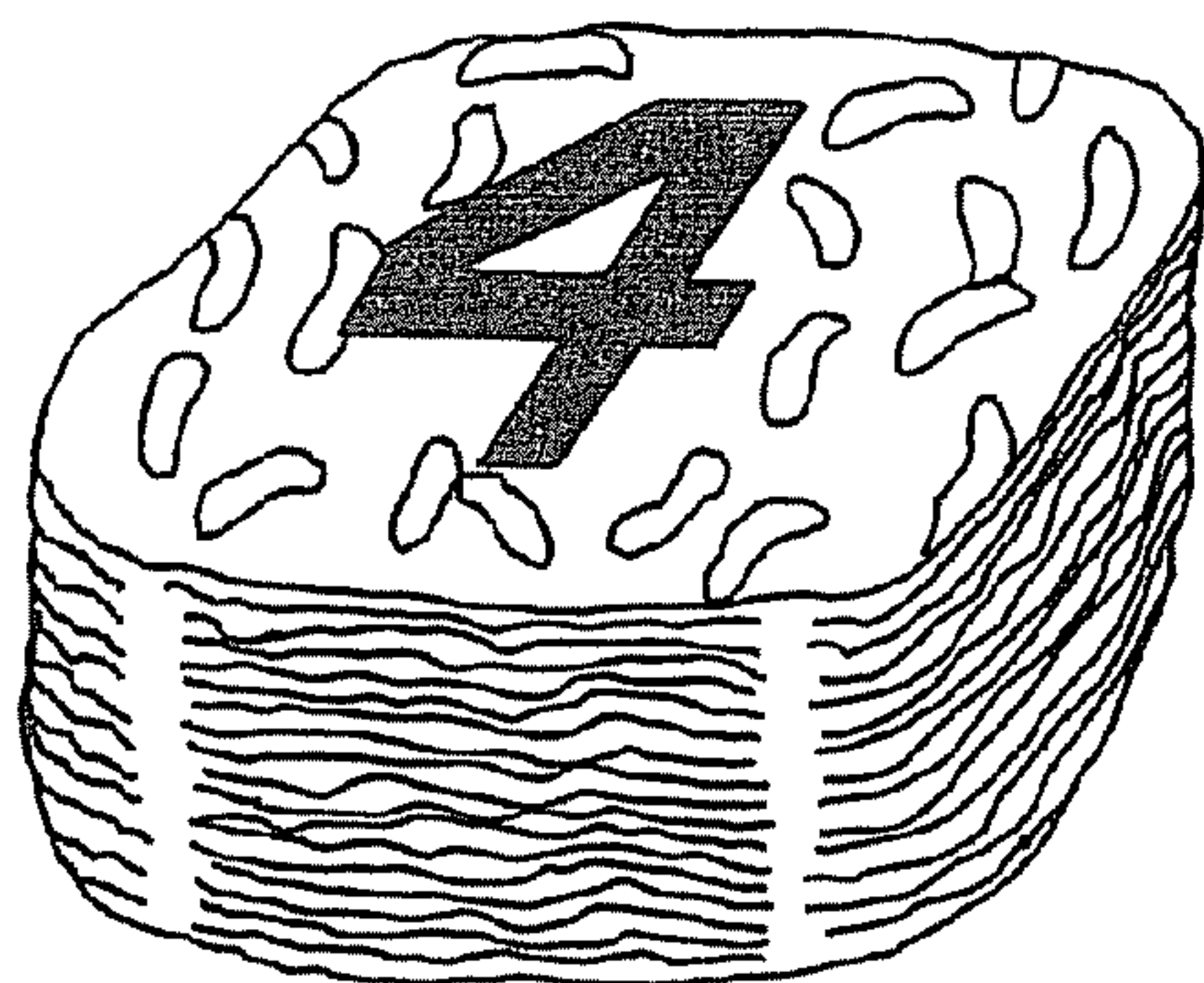

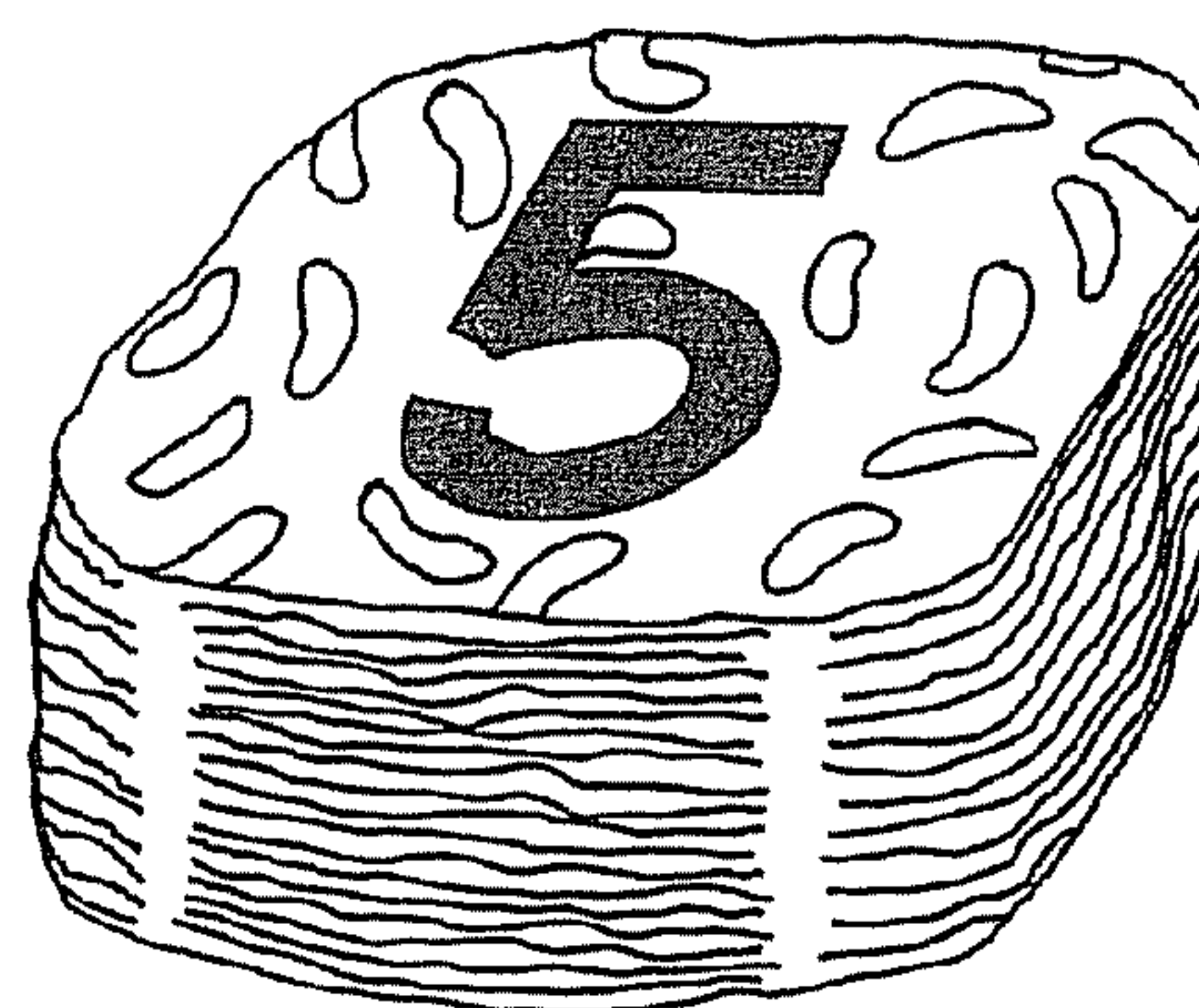

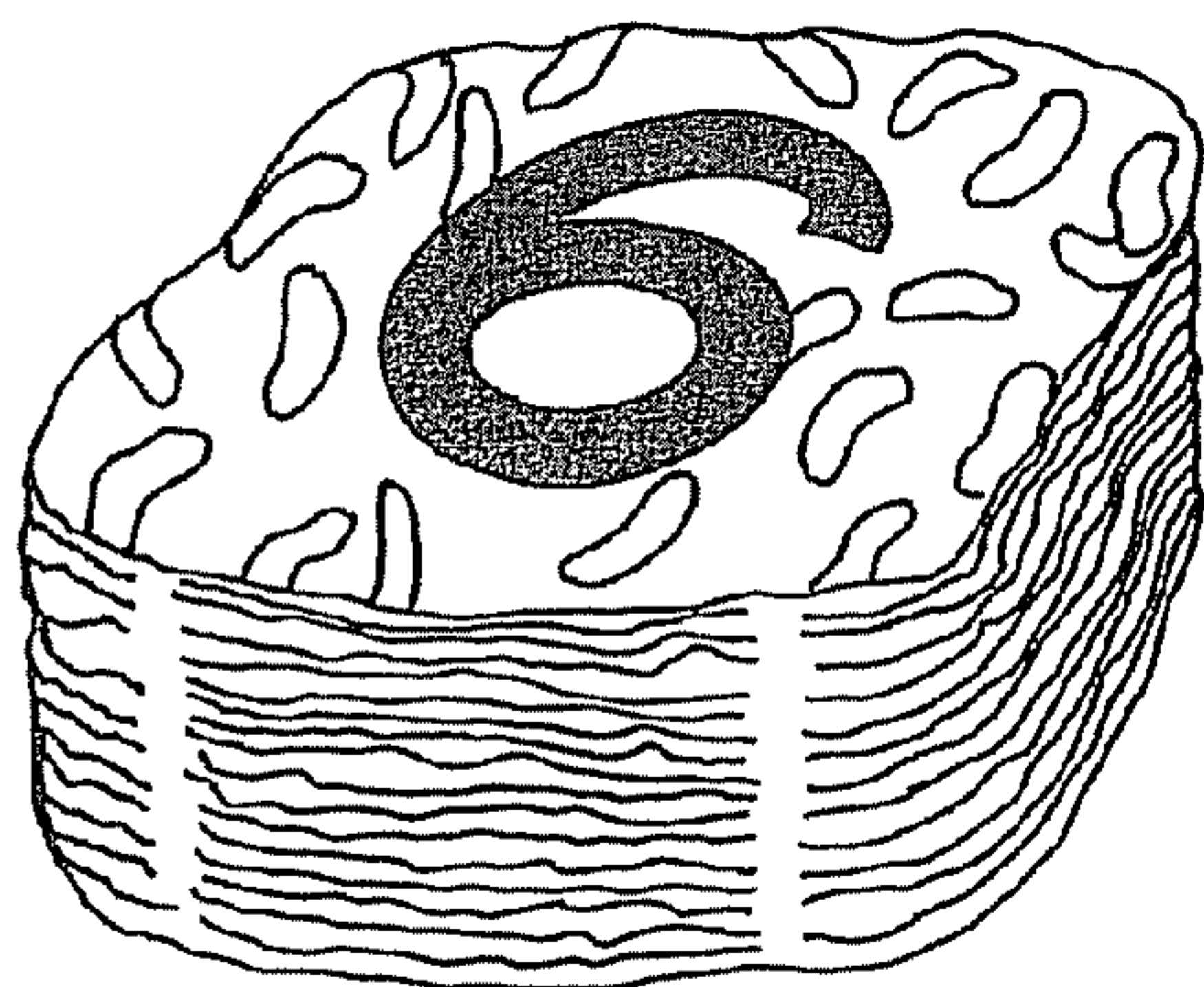

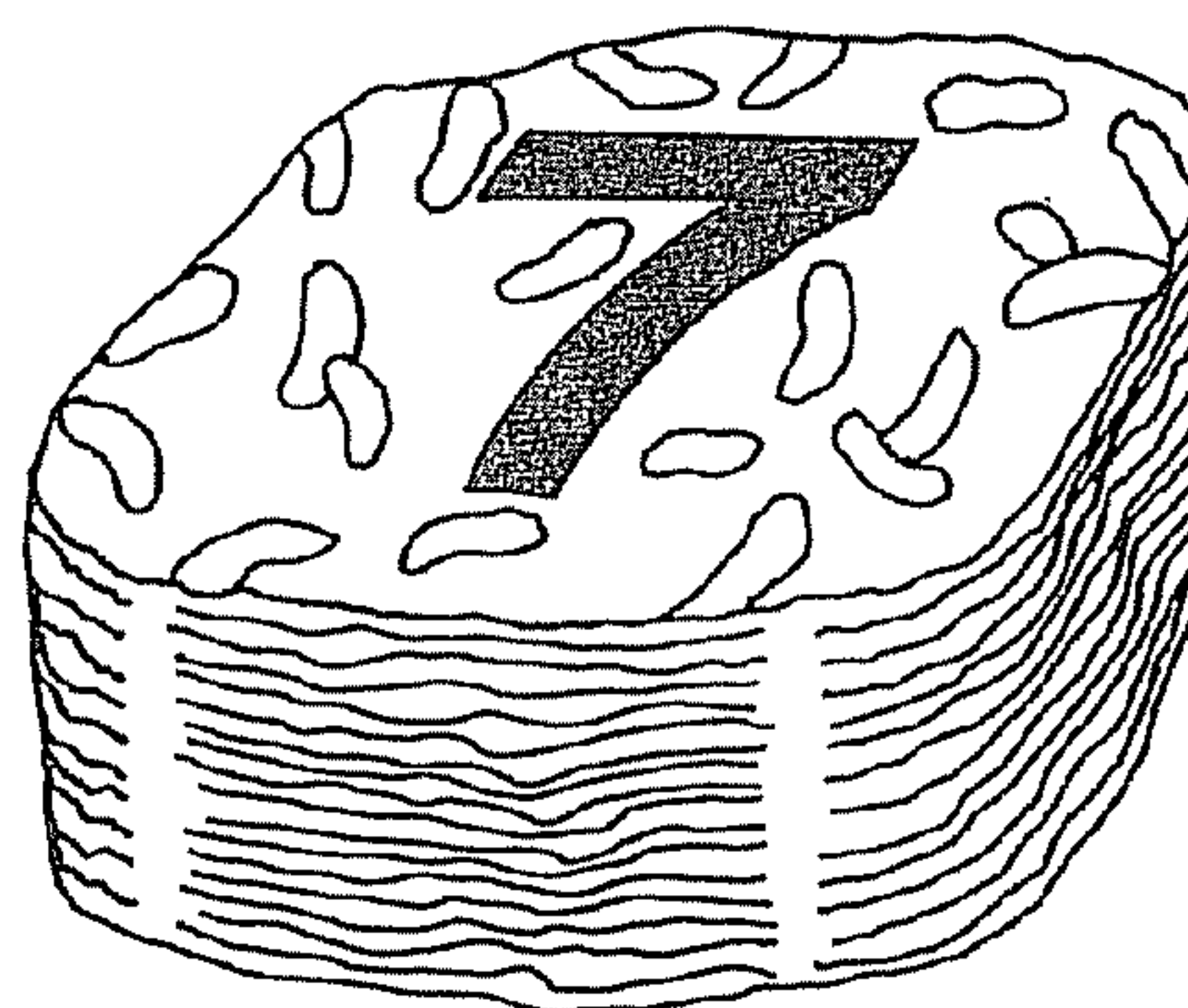

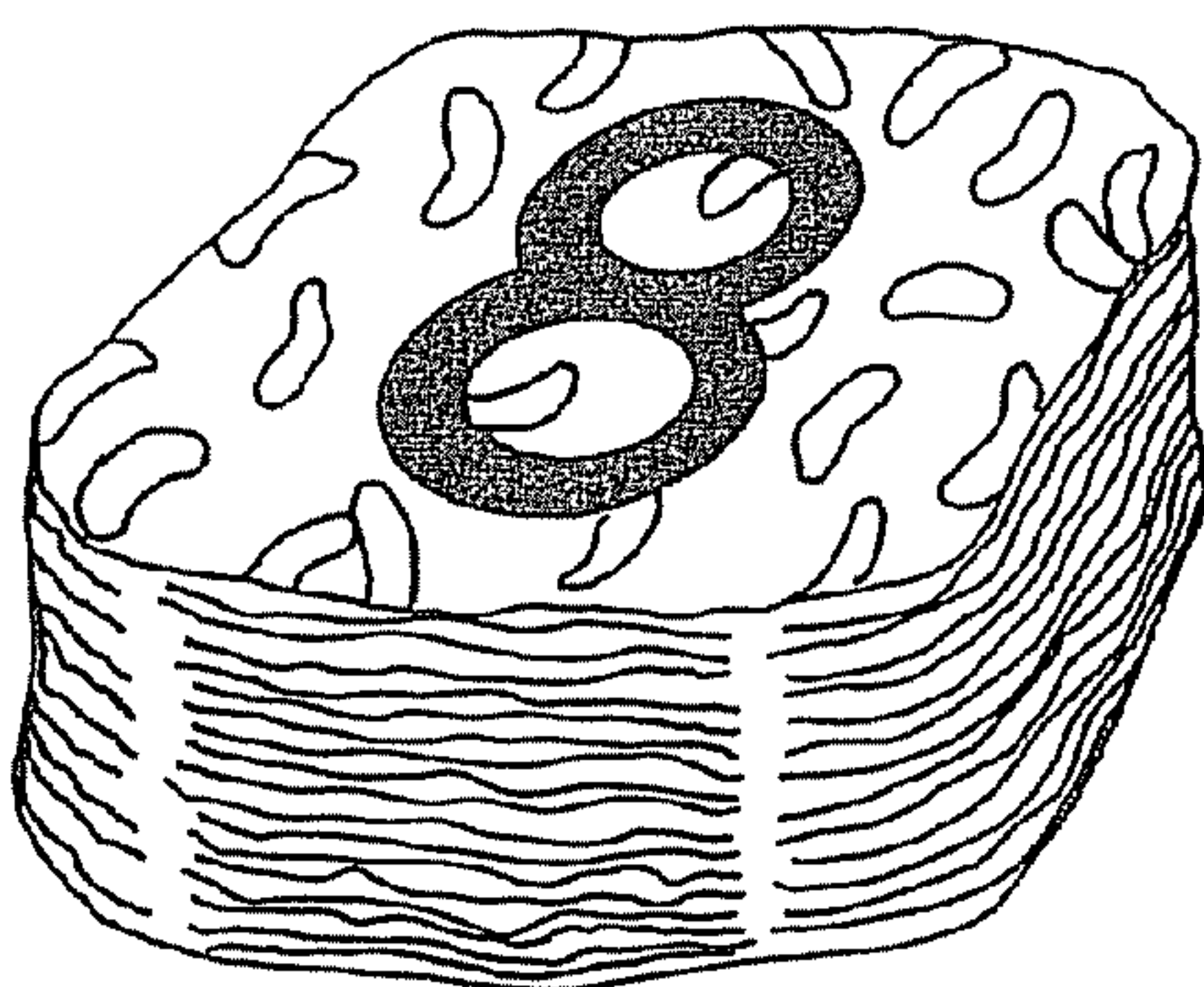

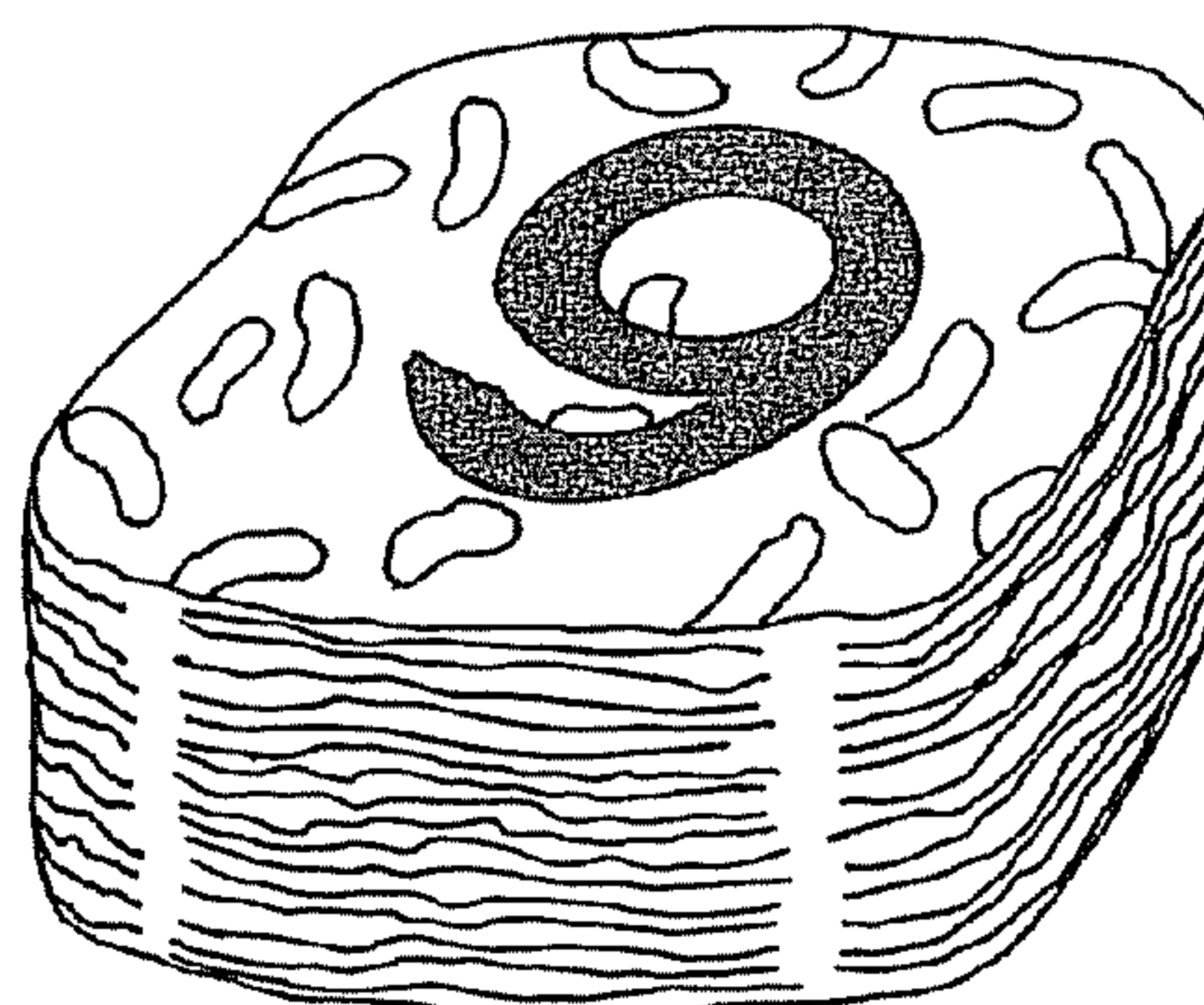

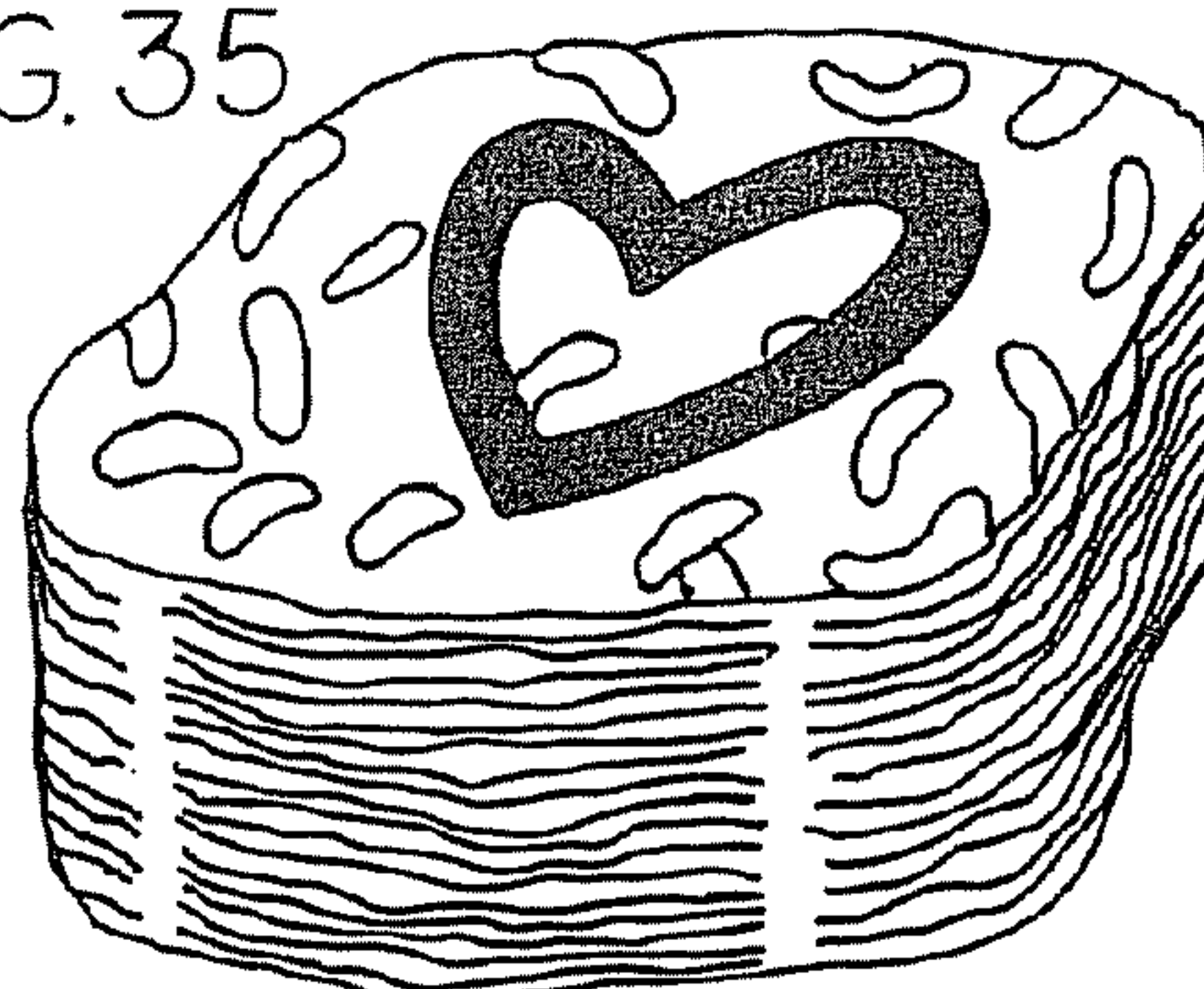
