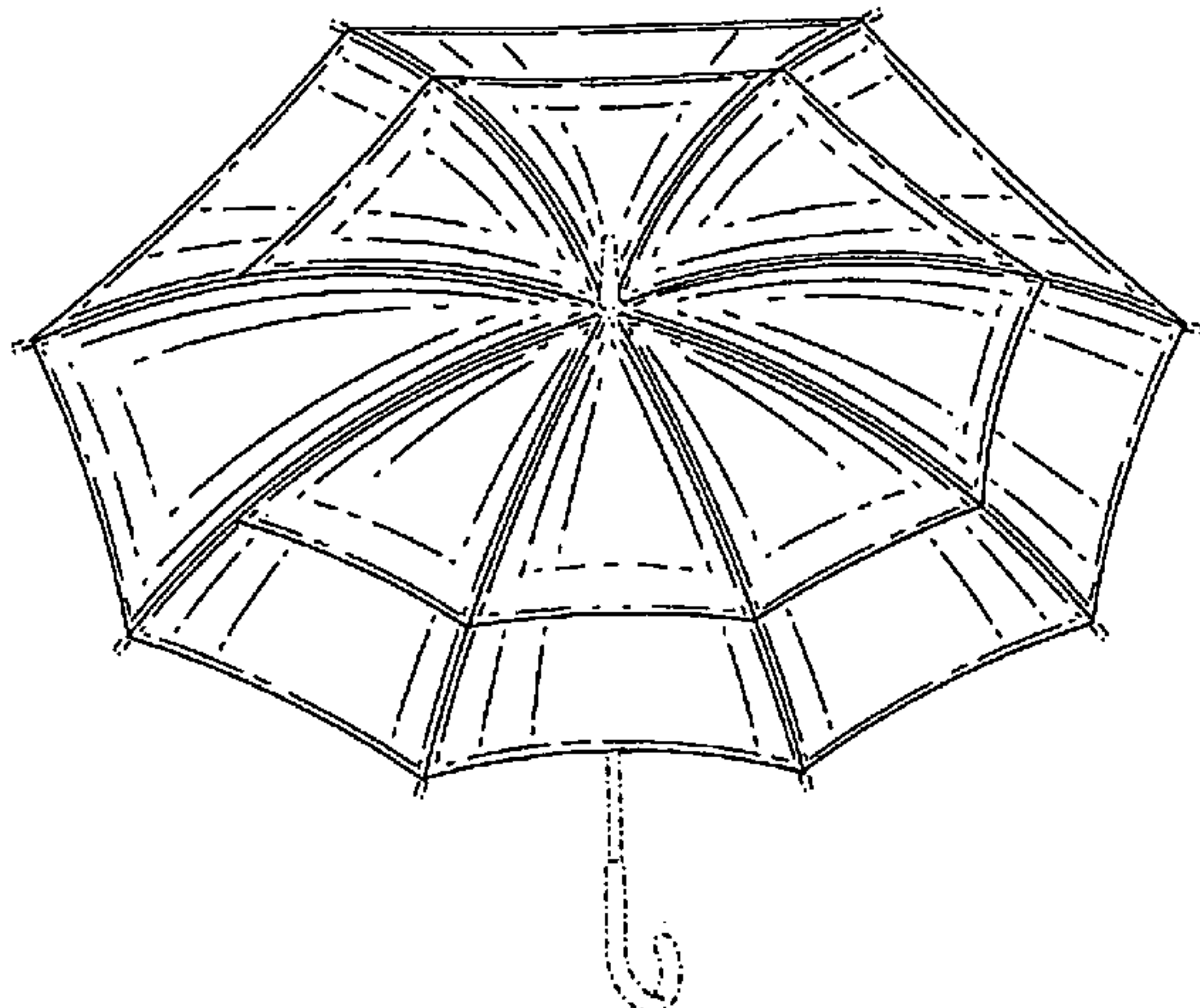

The ornamental design for an umbrella canopy, as shown and described.



DESCRIPTION

FIG. 1 is a top view of an embodiment of an umbrella canopy comprising seven contiguous double canopy panels and one single canopy panel showing our new design;

FIG. 2 is a bottom view thereof;

FIG. 3 is a top view of an ornamental design of an embodiment of an umbrella canopy comprising six contiguous double canopy panels and two contiguous single canopy panels showing my new design;

FIG. 4 is a bottom view thereof;

FIG. 5 is a top view of an ornamental design of an embodiment of an umbrella canopy comprising five contiguous double canopy panels and three contiguous single canopy panels showing my new design;

FIG. 6 is a bottom view thereof;

FIG. 7 is a top view of an ornamental design of an embodiment of an umbrella canopy comprising four contiguous double canopy panels and four contiguous single canopy panels showing my new design;

FIG. 8 is a bottom view thereof;

FIG. 9 is a top view of an ornamental design of an embodiment of an umbrella canopy comprising three contiguous double canopy panels and five contiguous single canopy panels showing my new design;

FIG. 10 is a bottom view thereof;

FIG. 11 is a top view of an ornamental design of an embodiment of an umbrella canopy comprising two contiguous double canopy panels and six contiguous single canopy panels showing my new design;

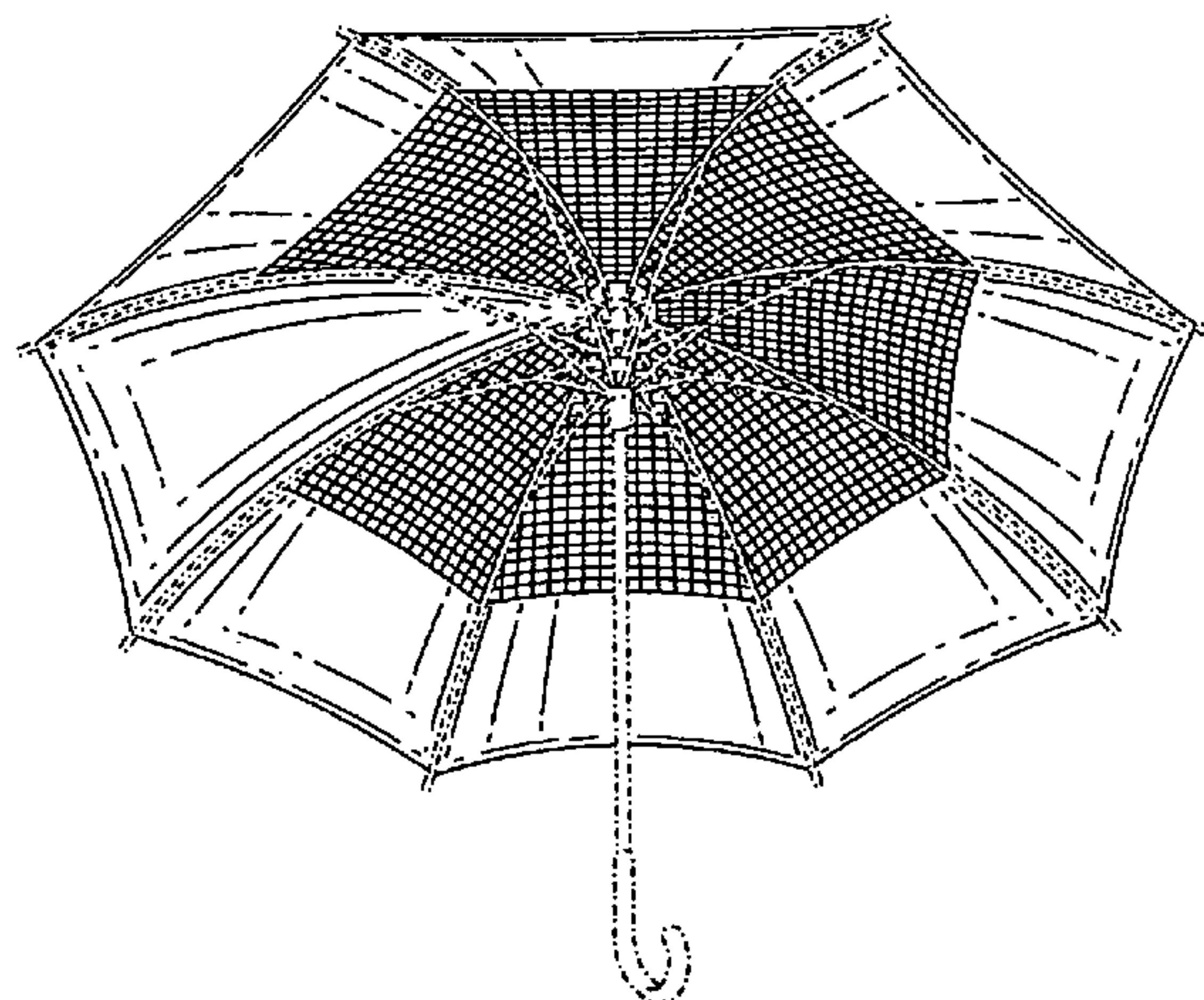
FIG. 12 is a bottom view thereof;

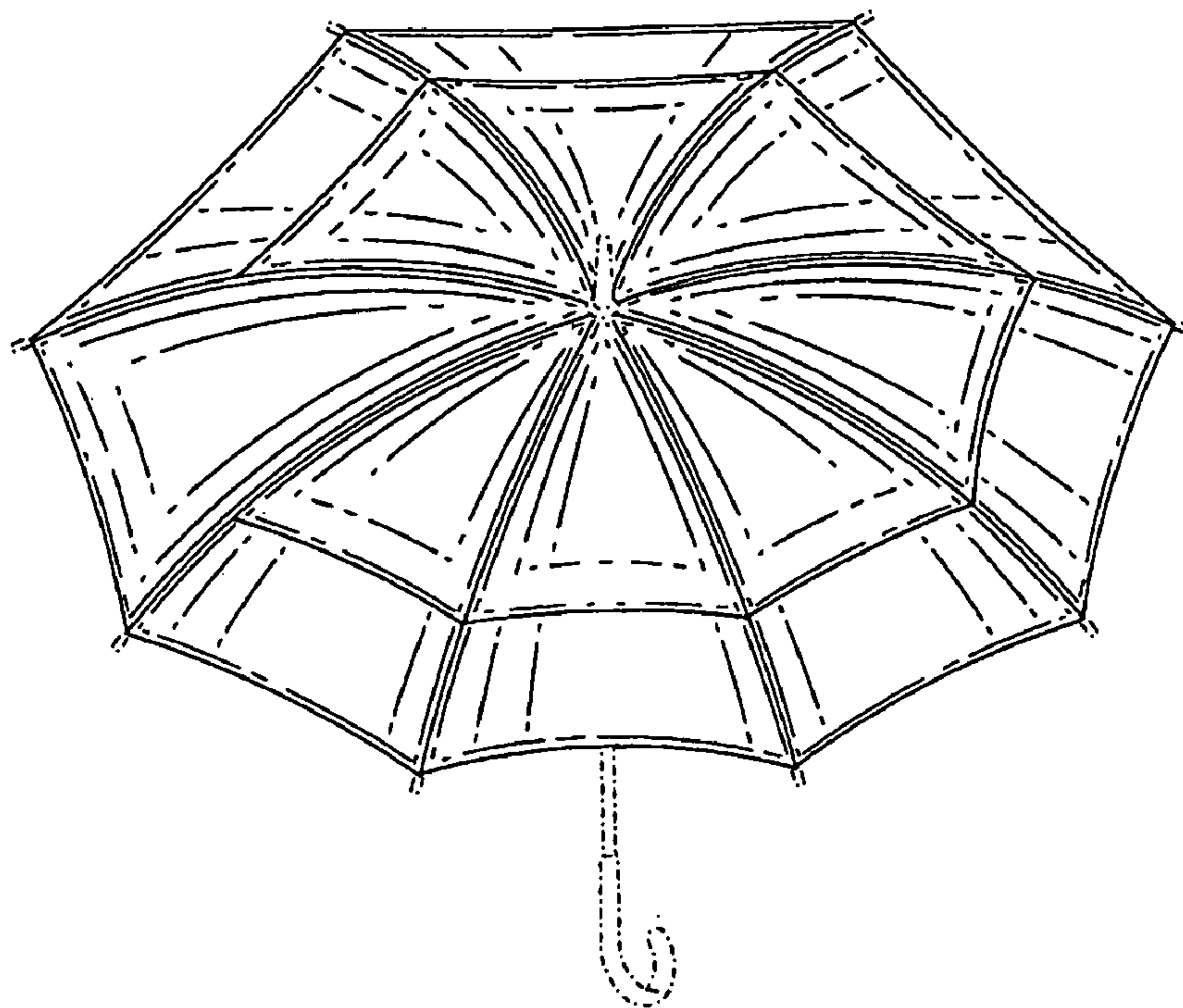

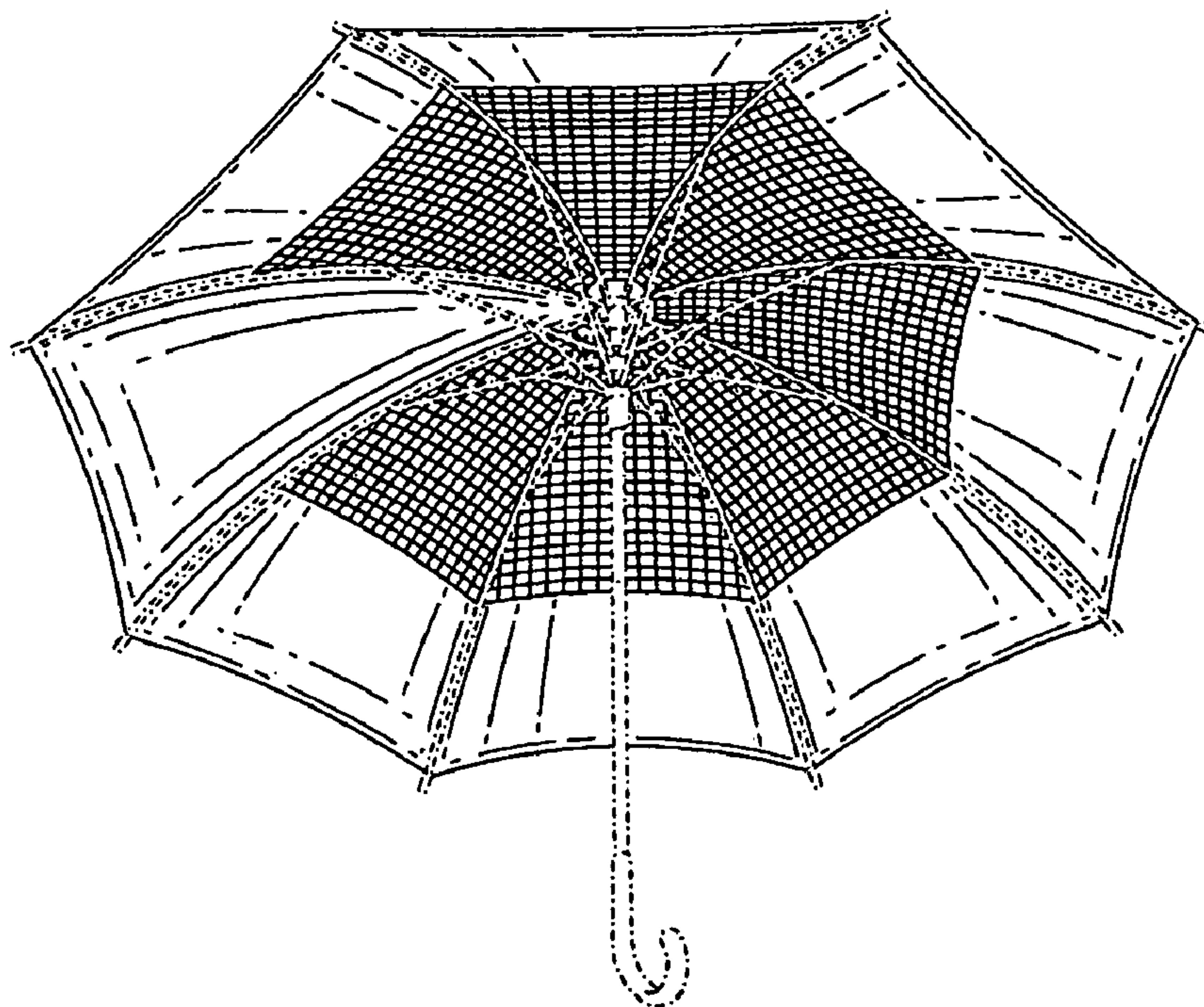

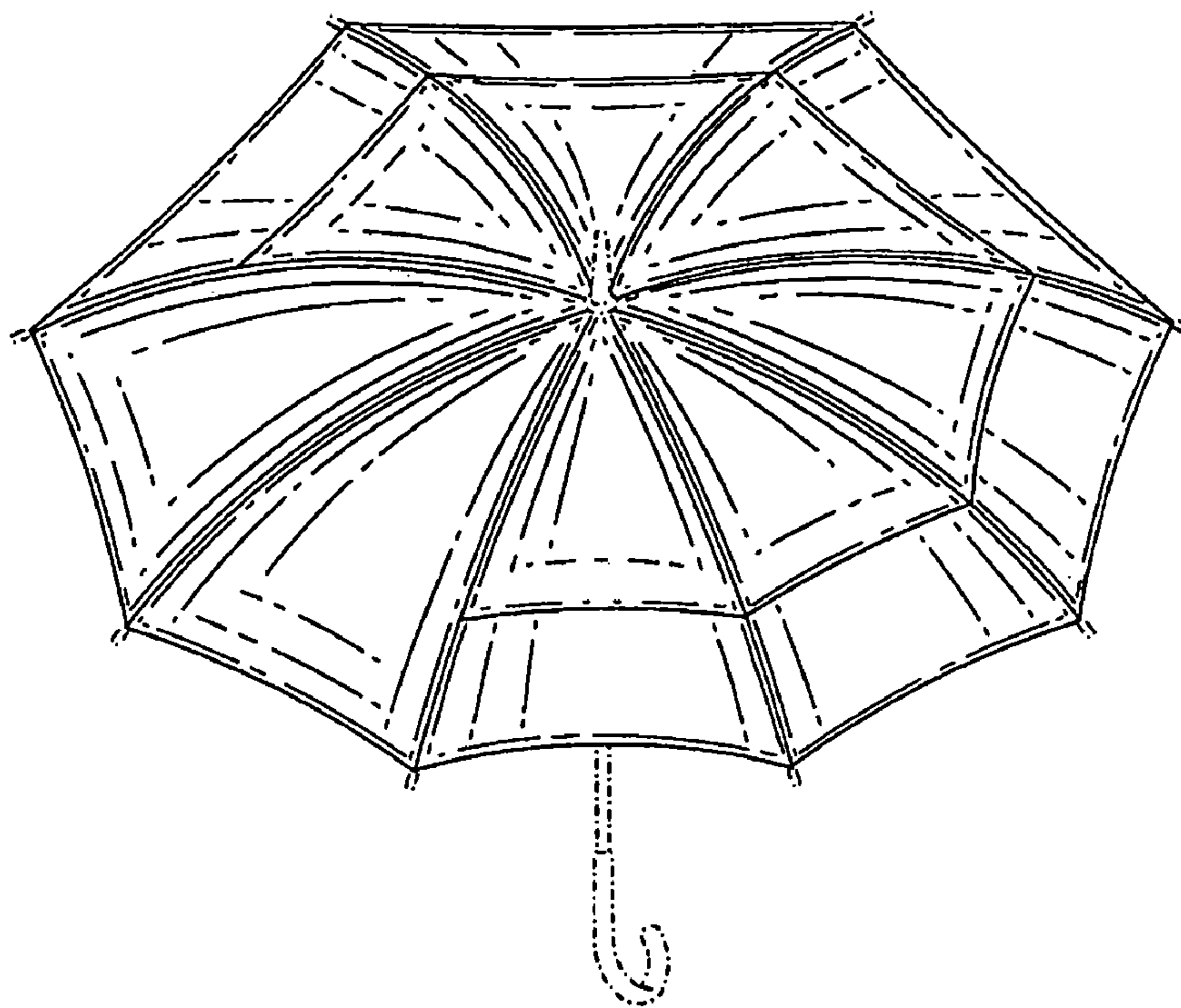

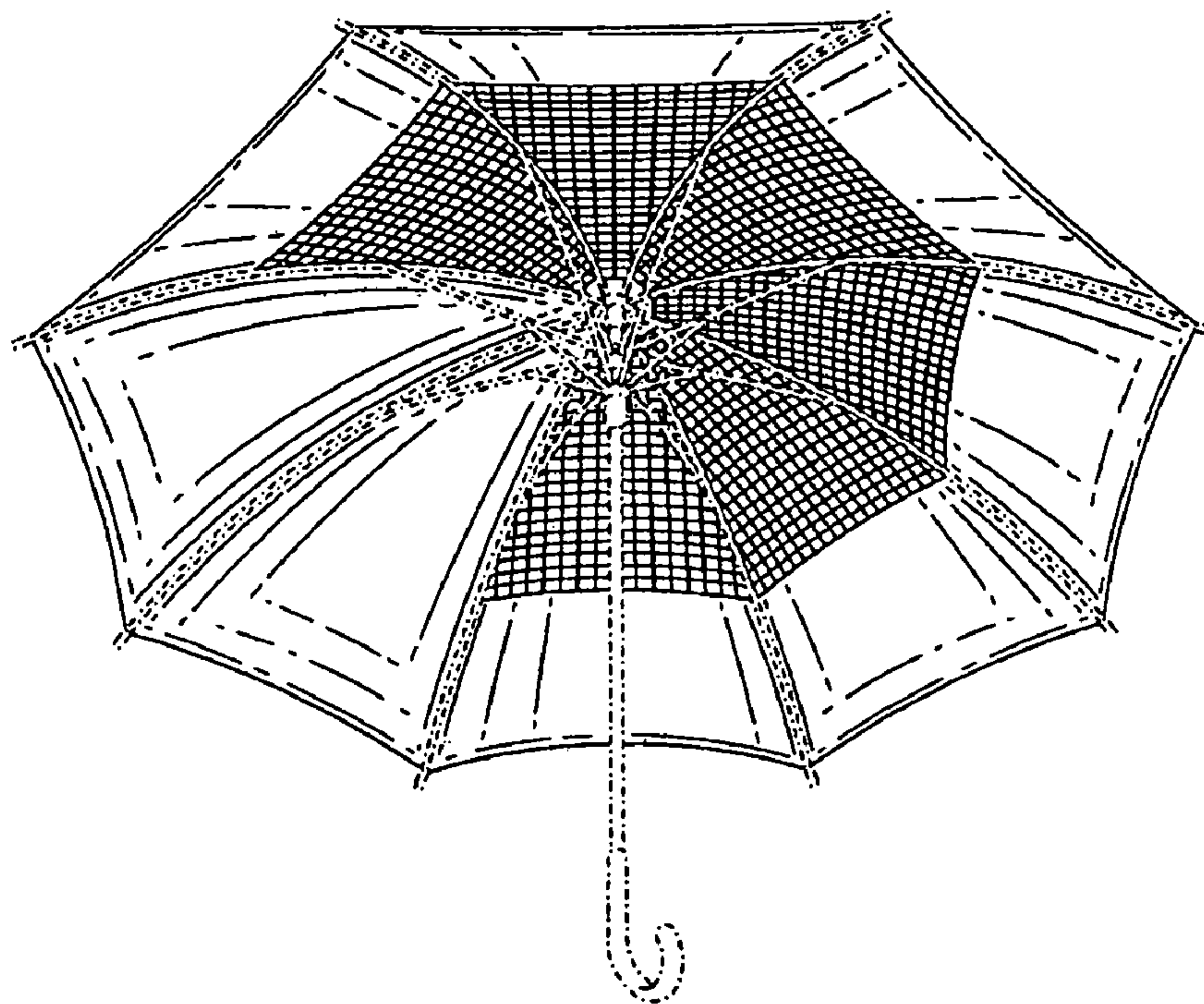

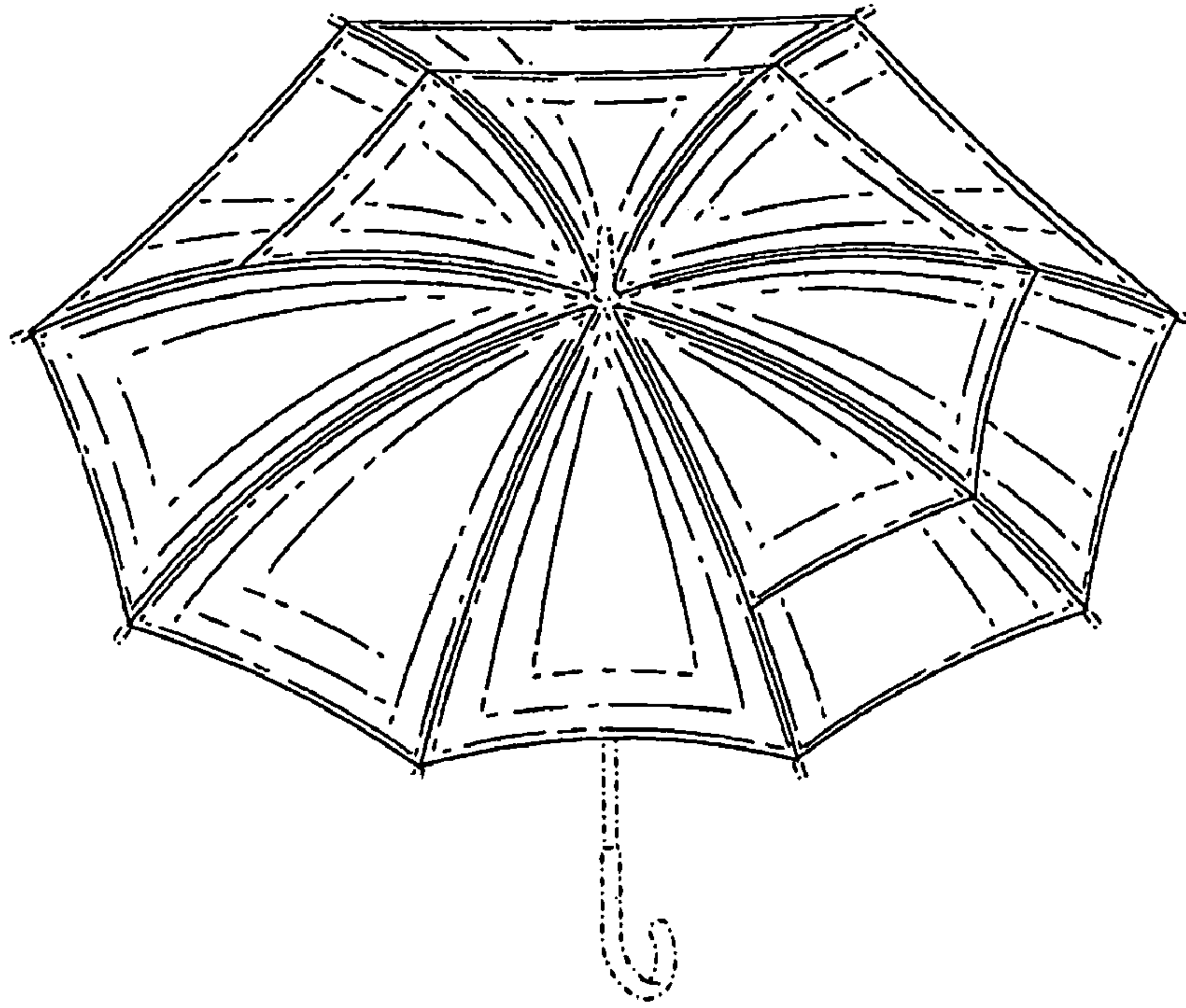

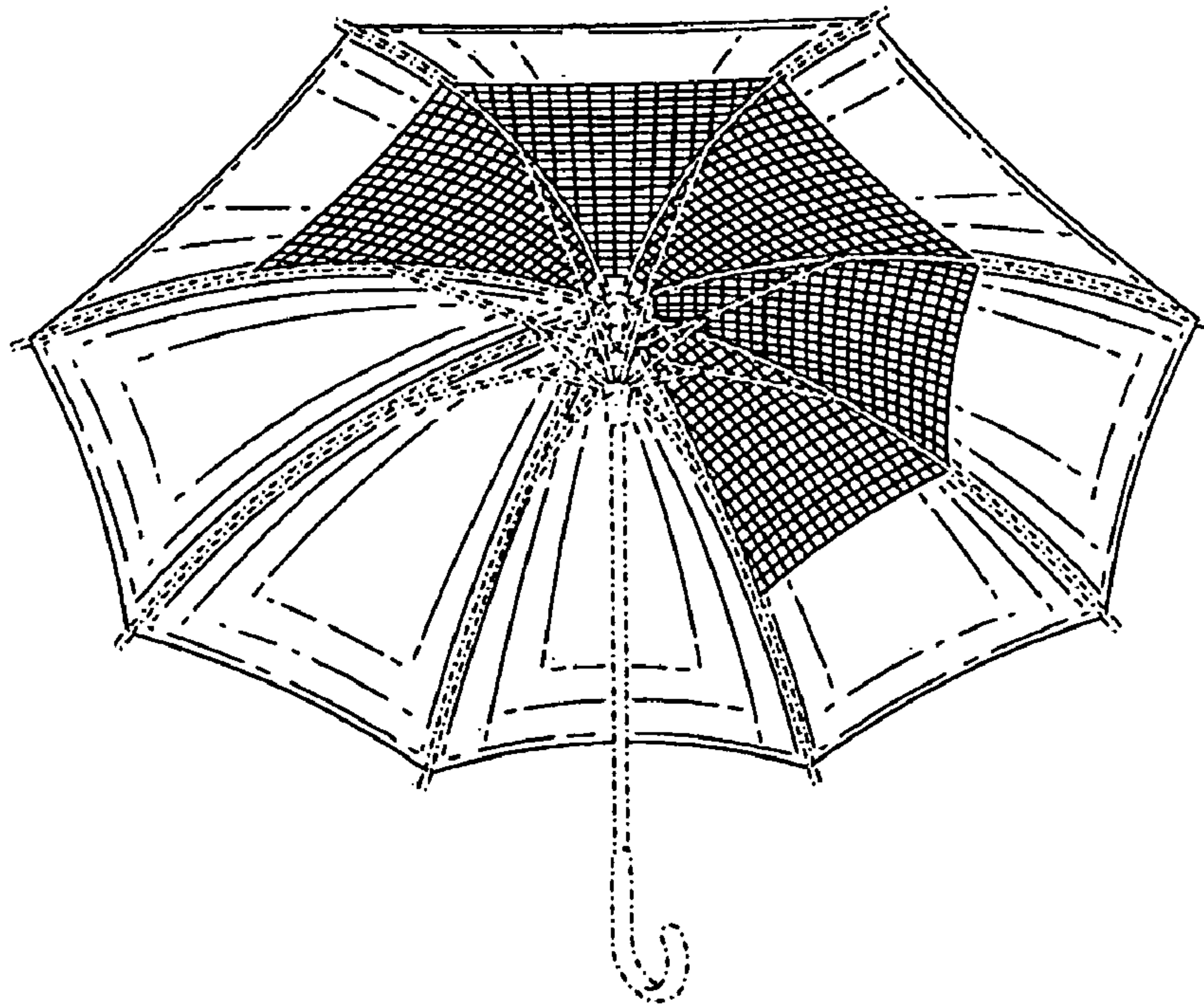

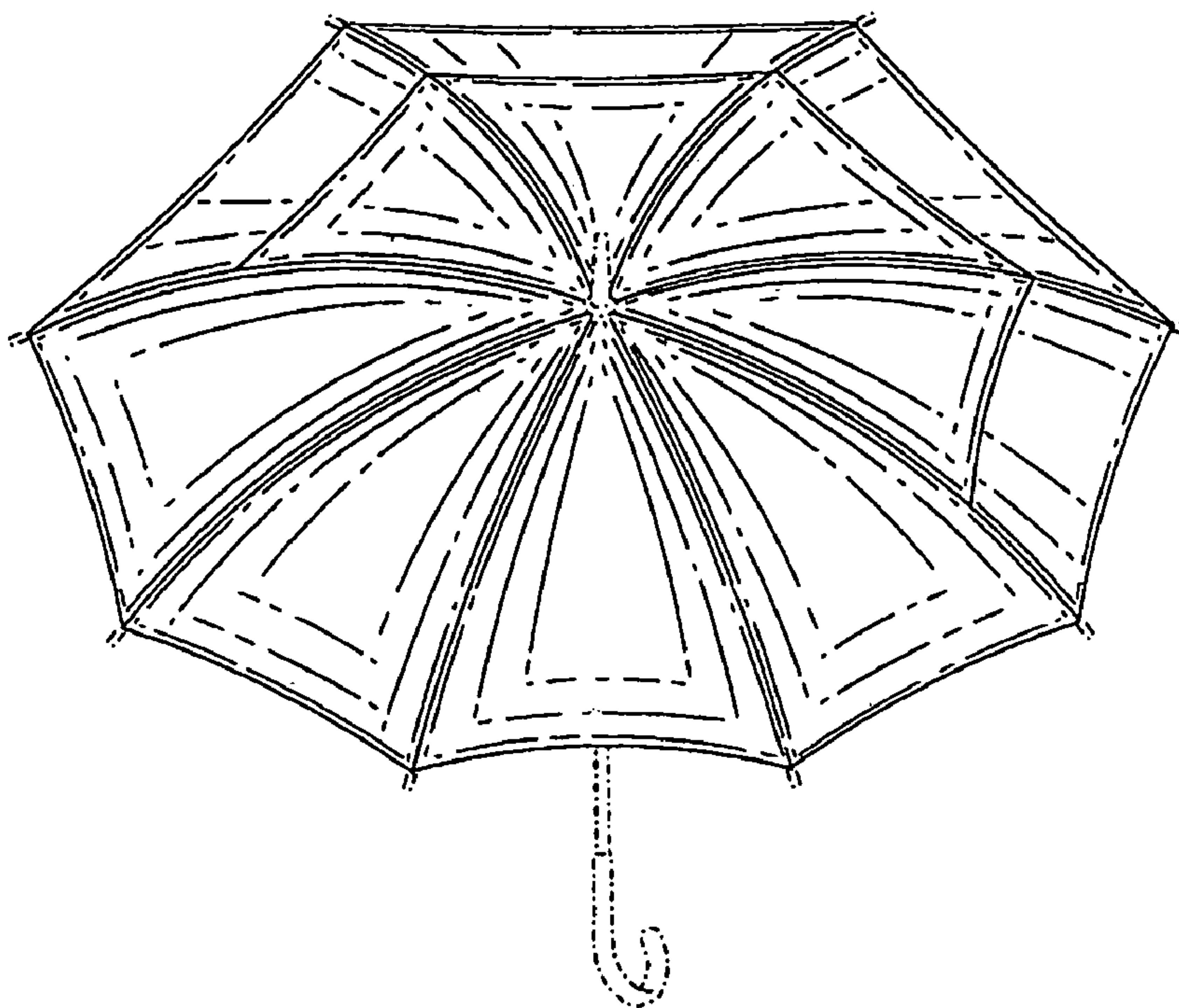

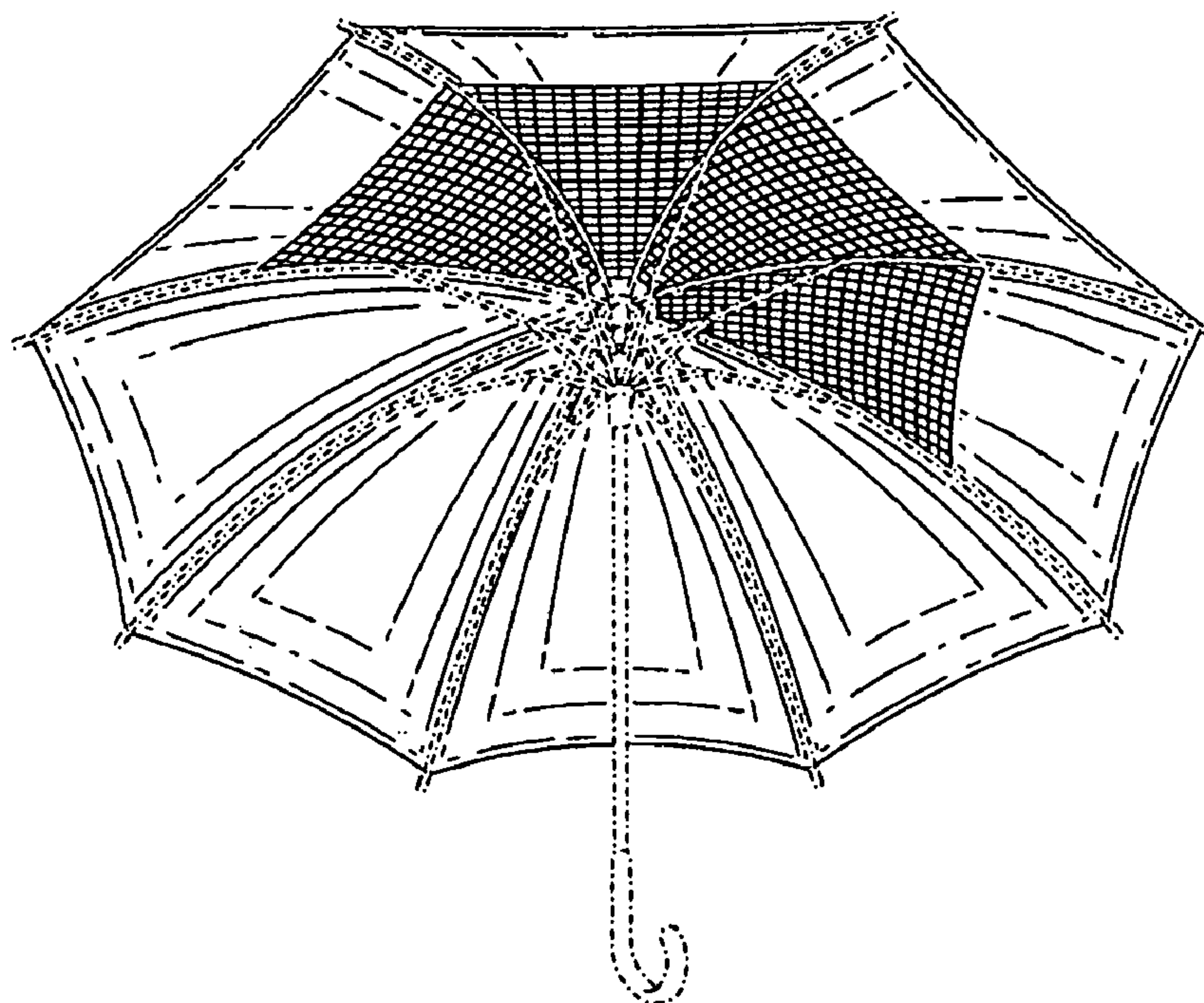

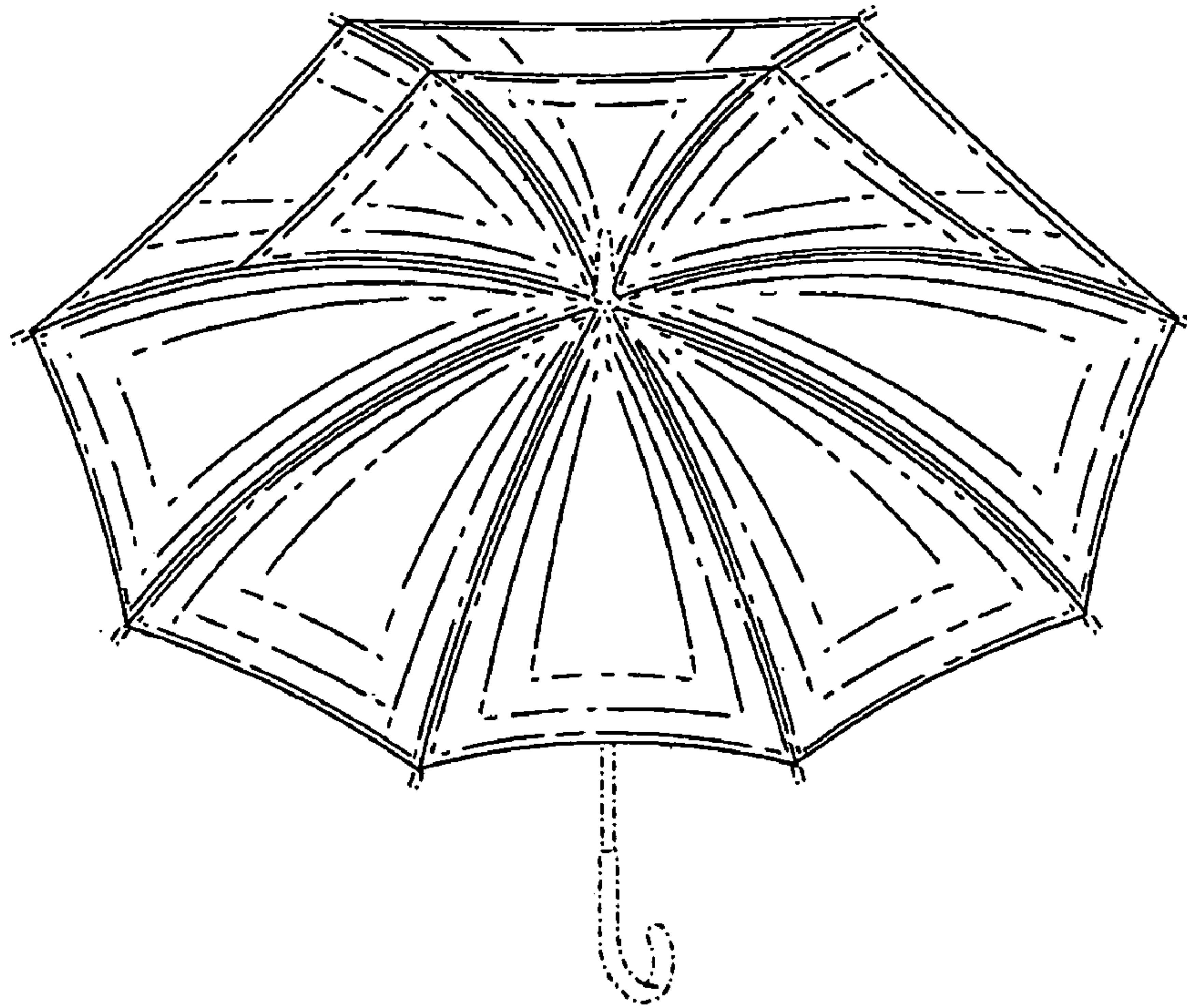

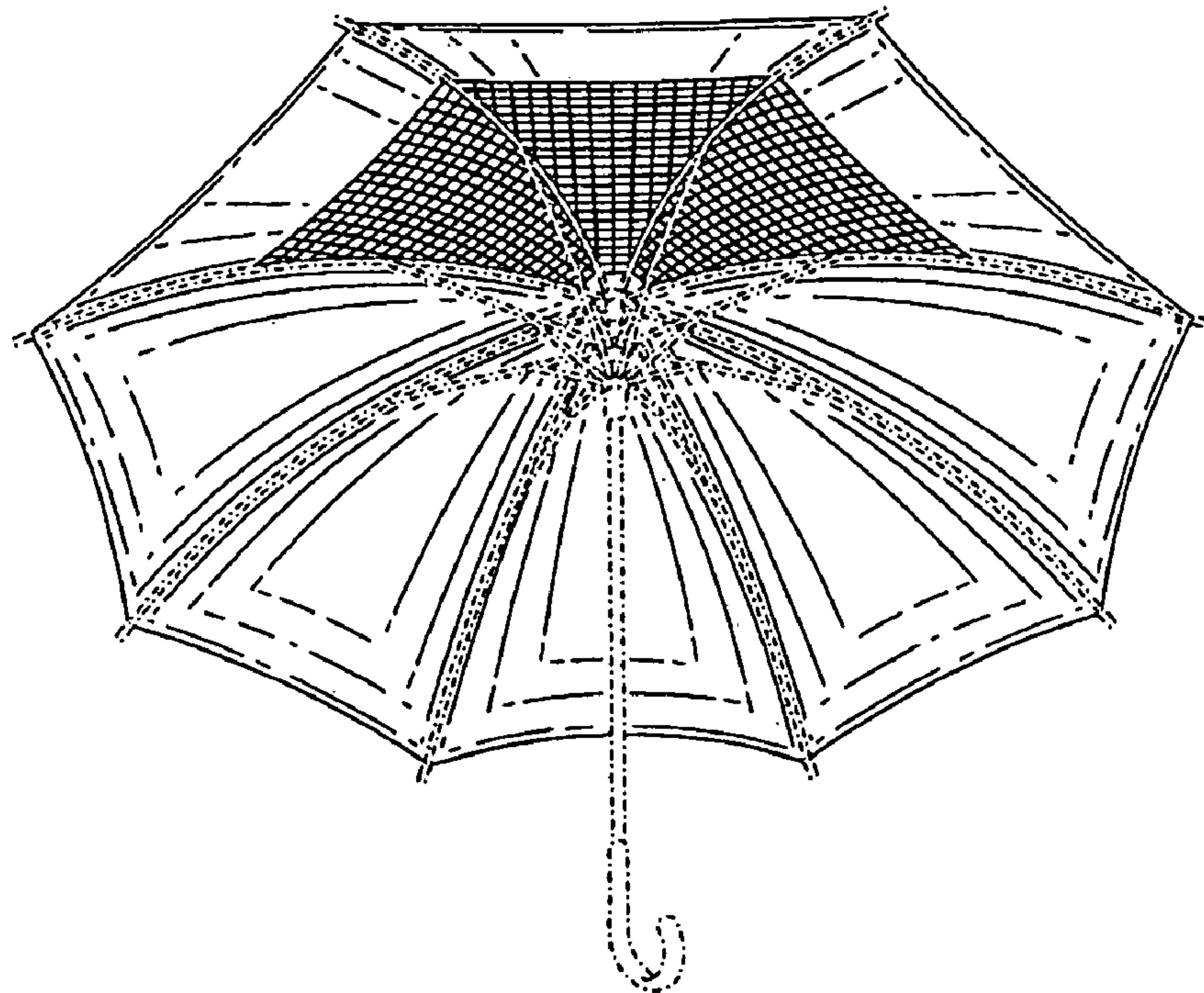

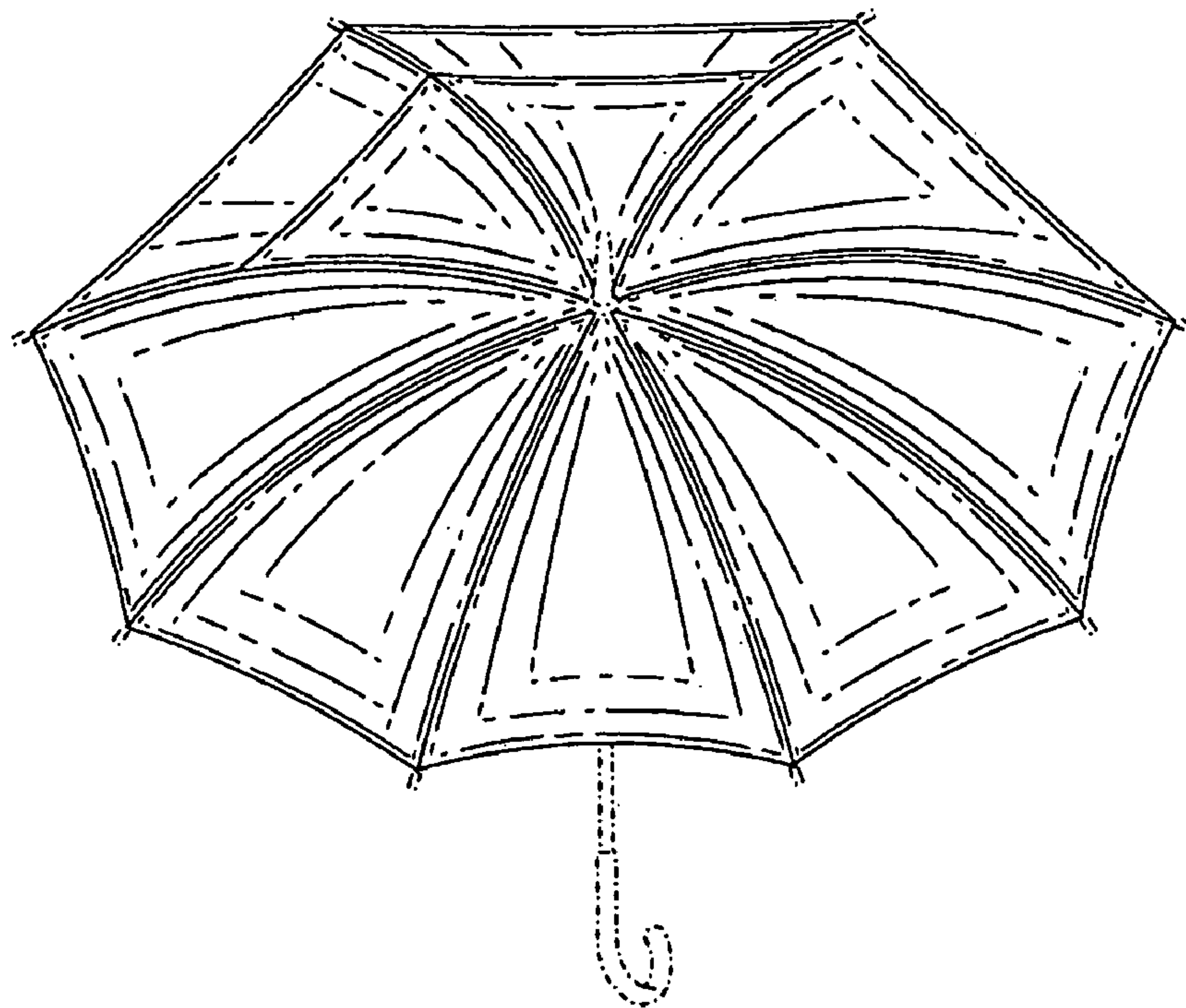

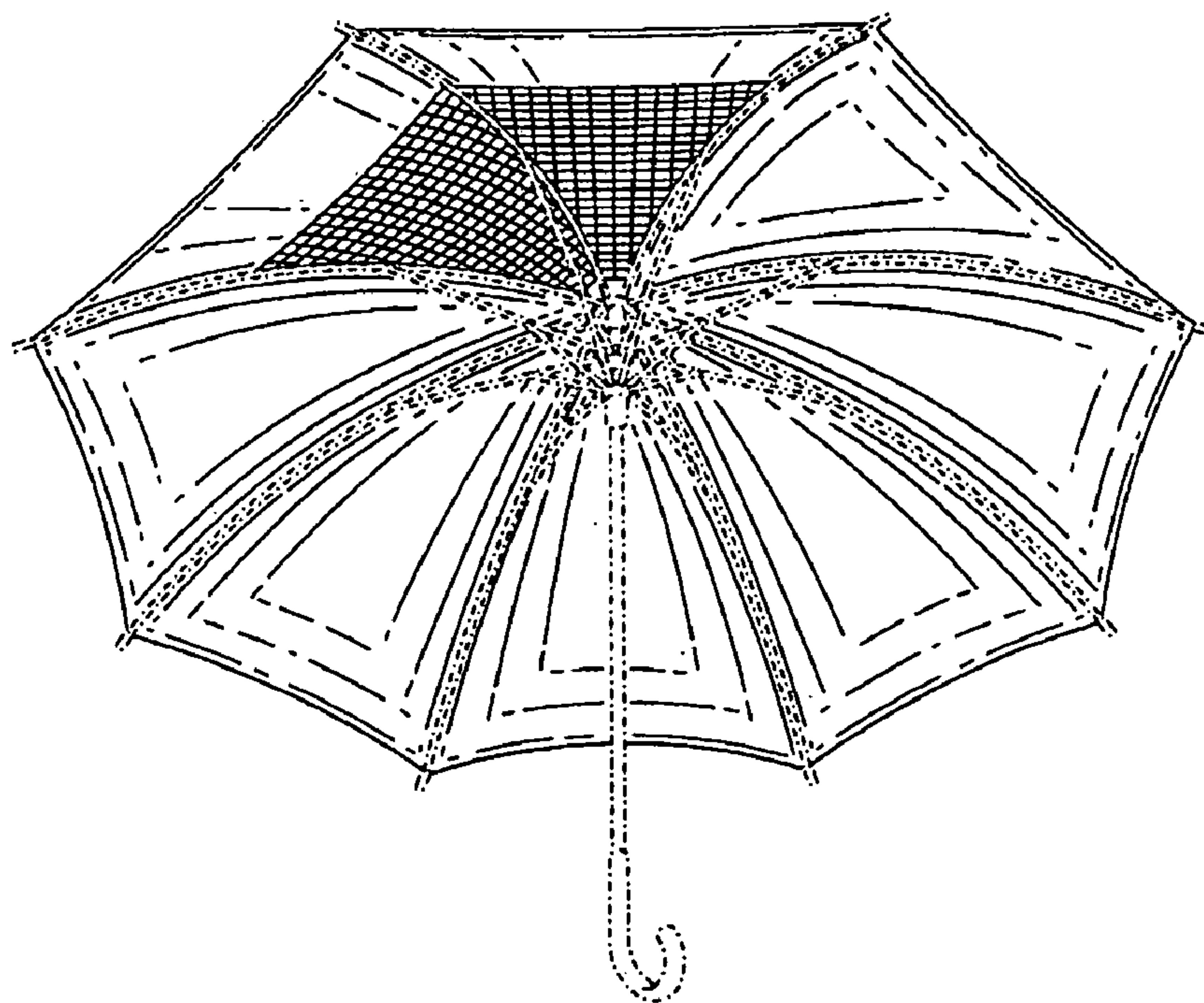

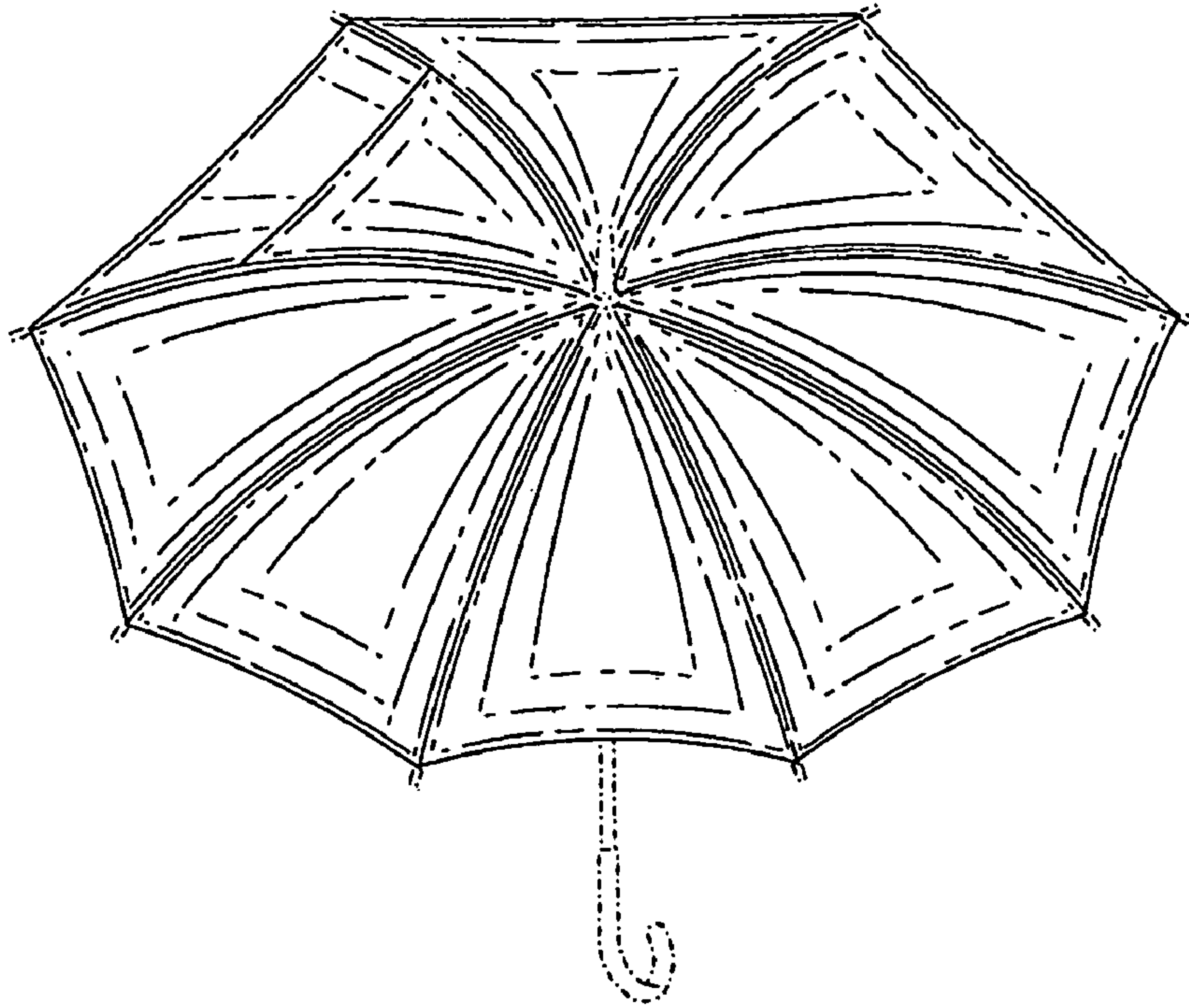

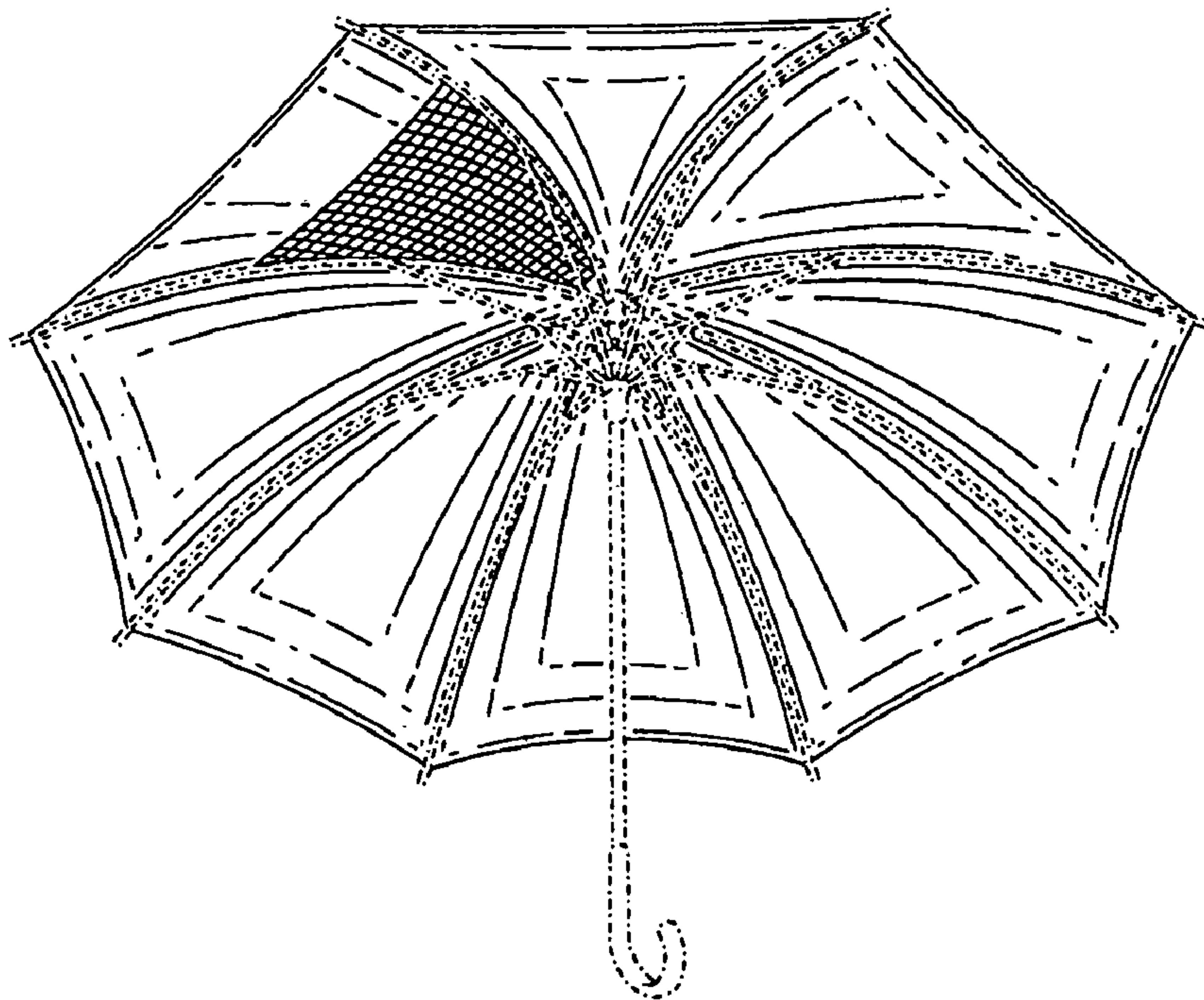
