(57) **CLAIM**

The ornamental design for a tool carrying case, substantially as shown.

DESCRIPTION

FIG. 1 is a perspective view of the tool carrying case as seen from the top of the case, having a viewing window in the center thereof;

FIG. 2 is a top plan view of the tool carrying case of FIG. 1; FIG. 3 is a rear elevation of the tool carrying case of FIG. 1; FIG. 4 is a front elevation of the tool carrying case of FIG. 1; FIG. 5 is a left side elevation of the tool carrying case of FIG. 1;

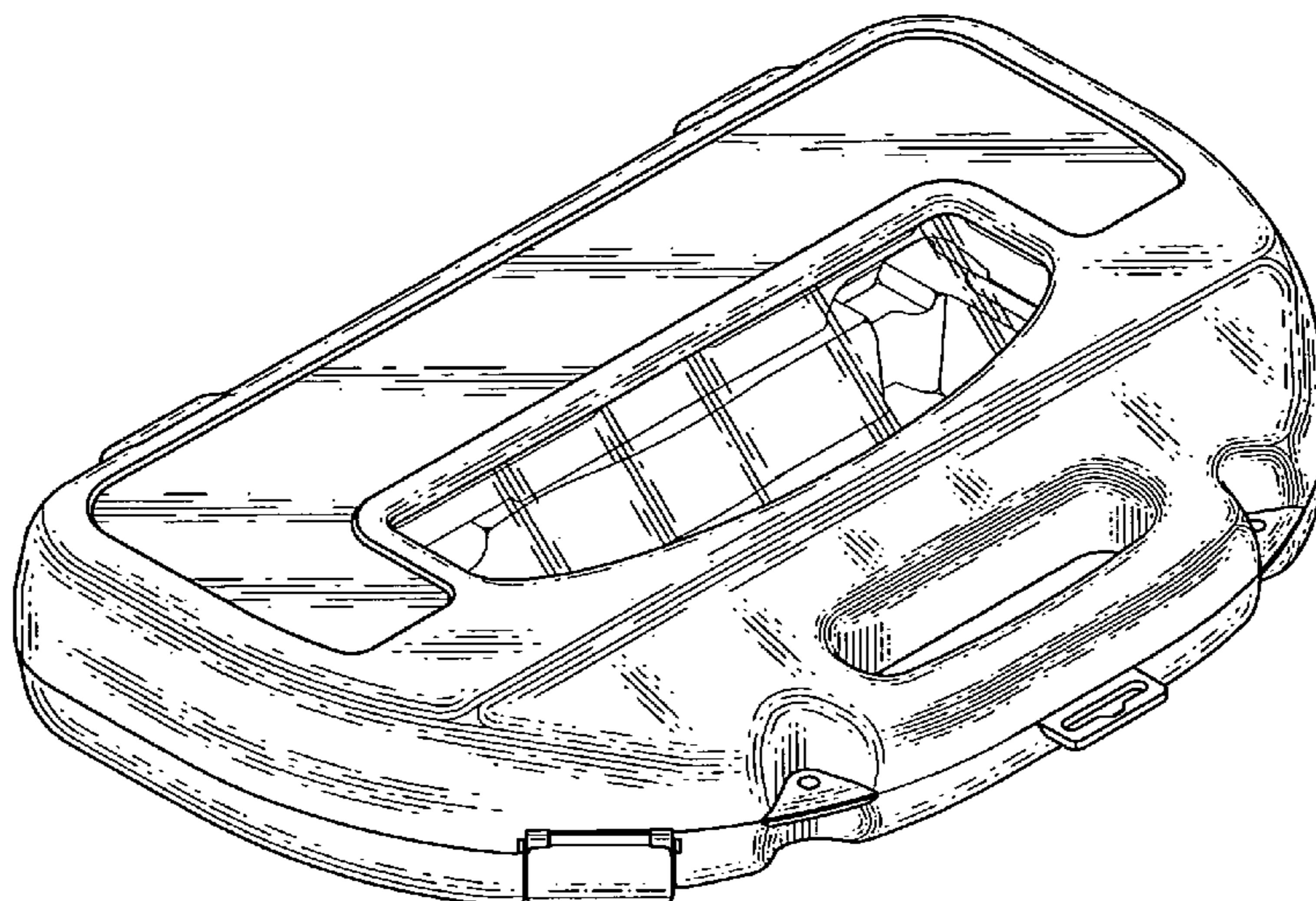
FIG. 6 is a bottom plan view of the tool carrying case of FIG. 1;

FIG. 7 is a perspective view of the tool carrying case of FIG. 1 opened to illustrate the internal features; and,

FIG. 8 is a top plan view of the opened tool carrying case of FIG. 7.

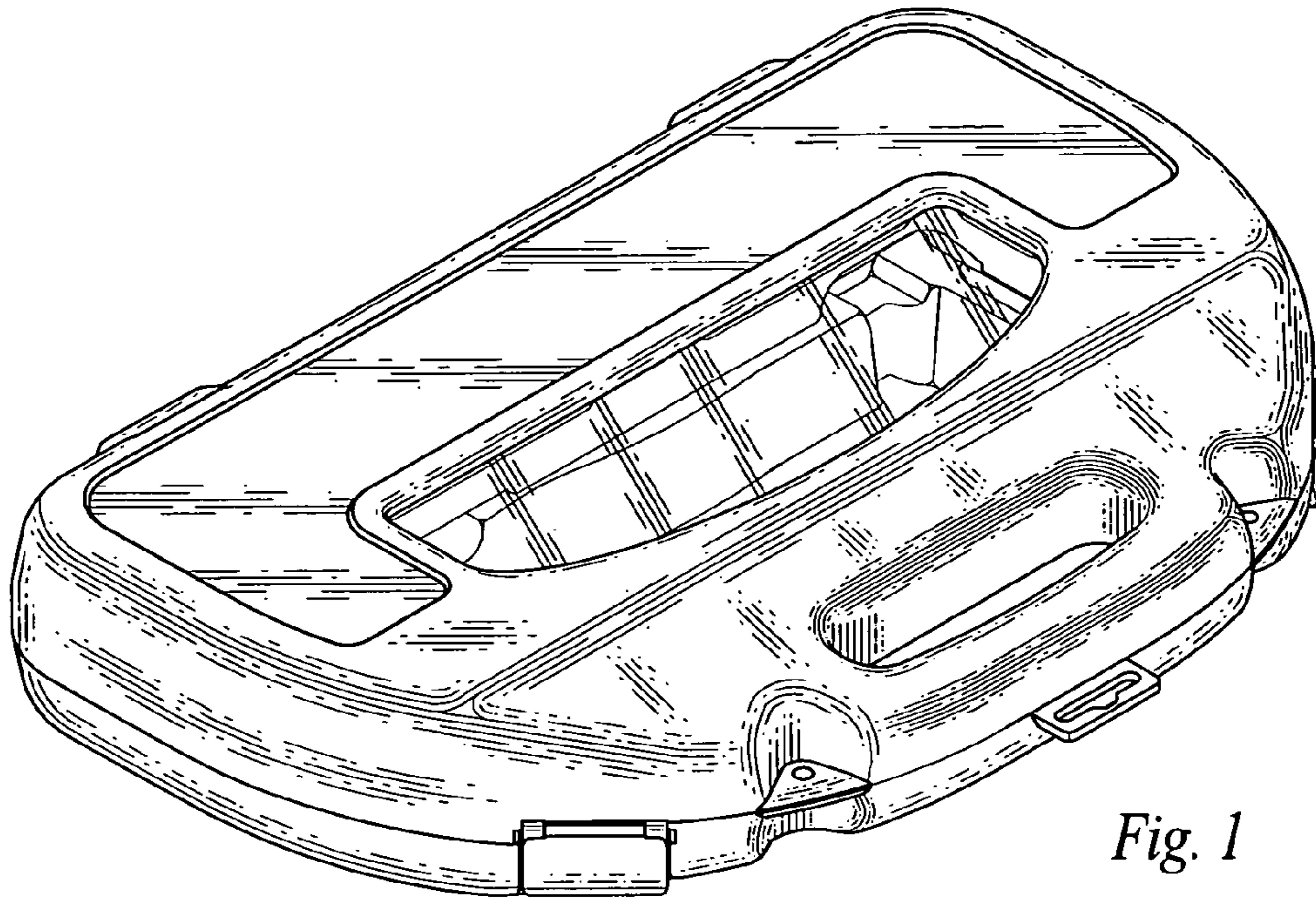

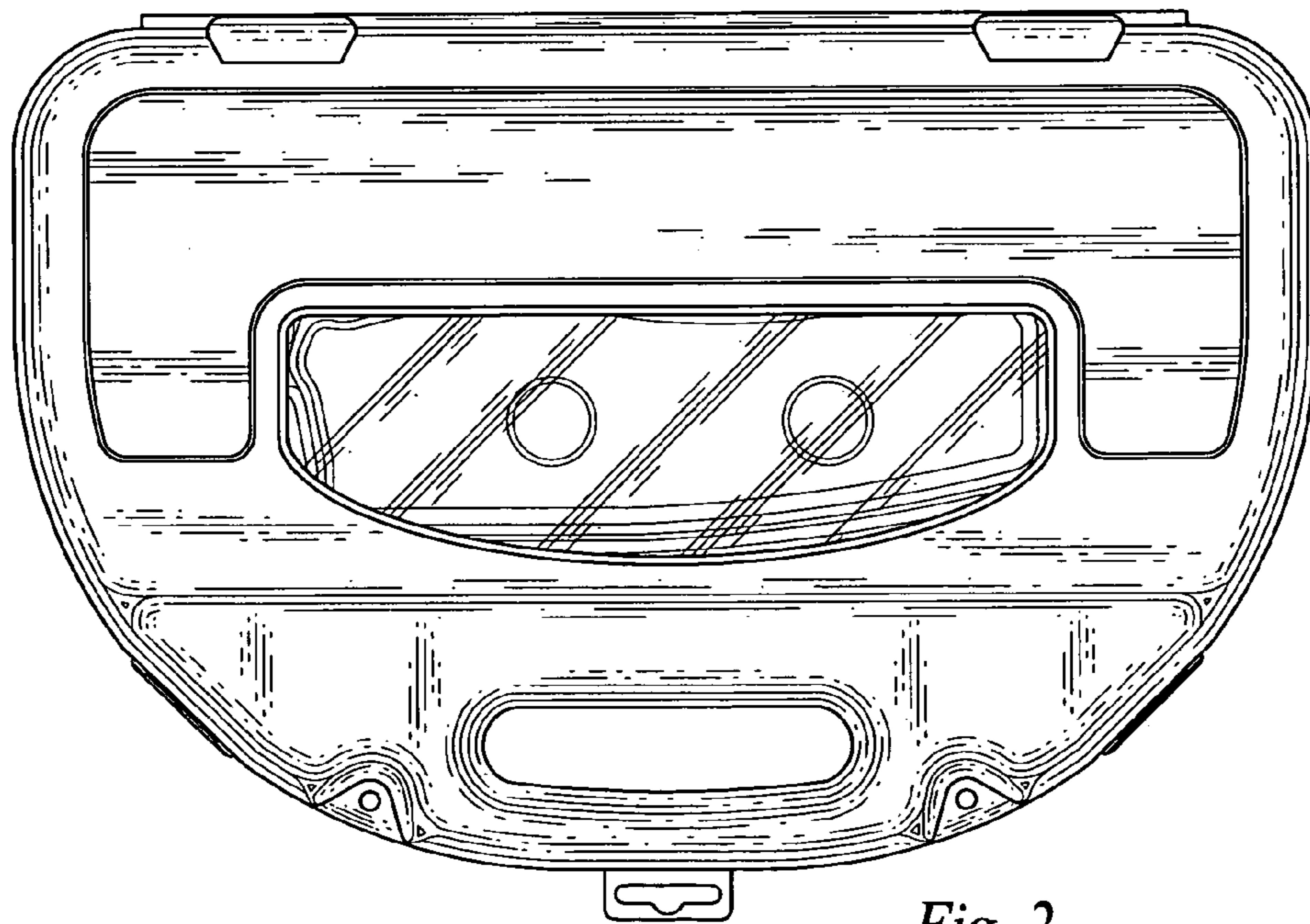

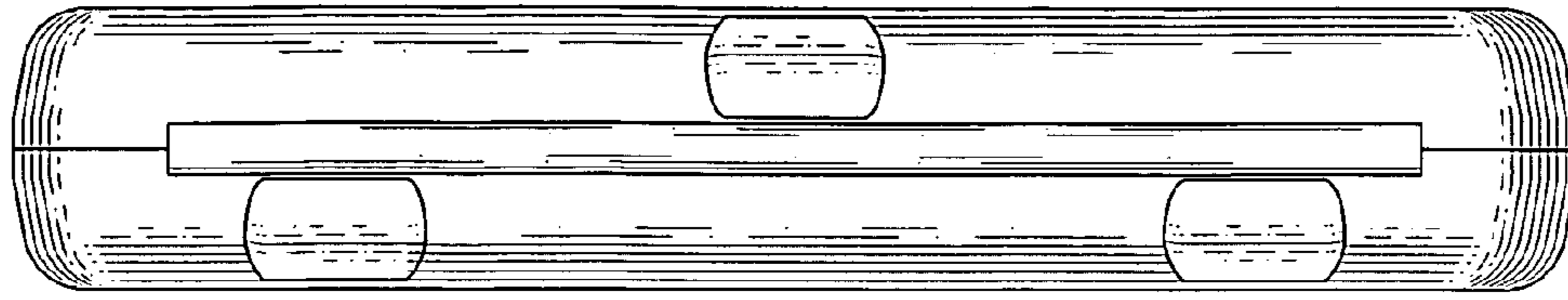

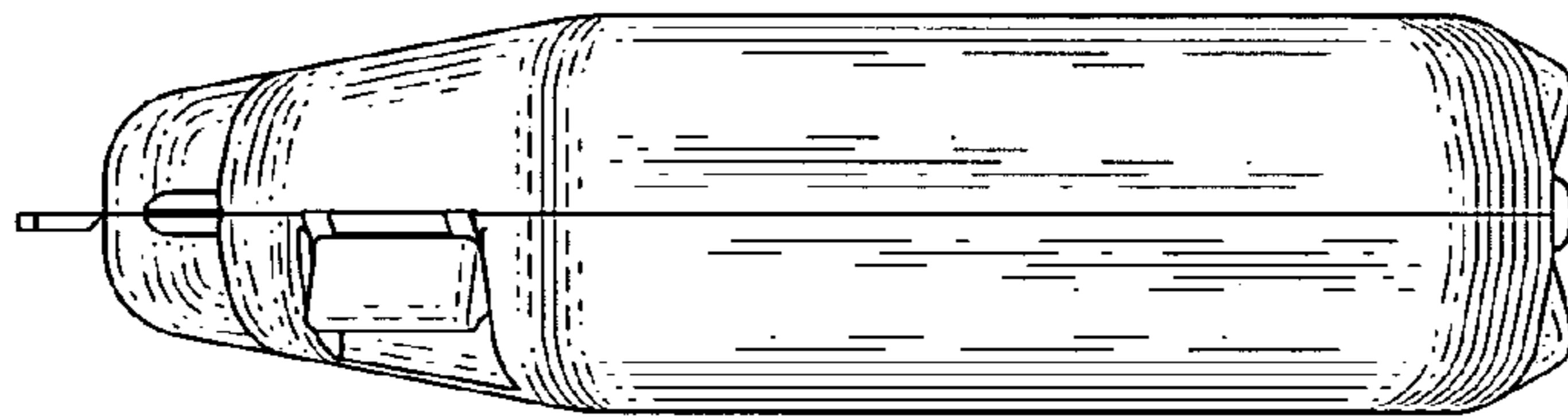

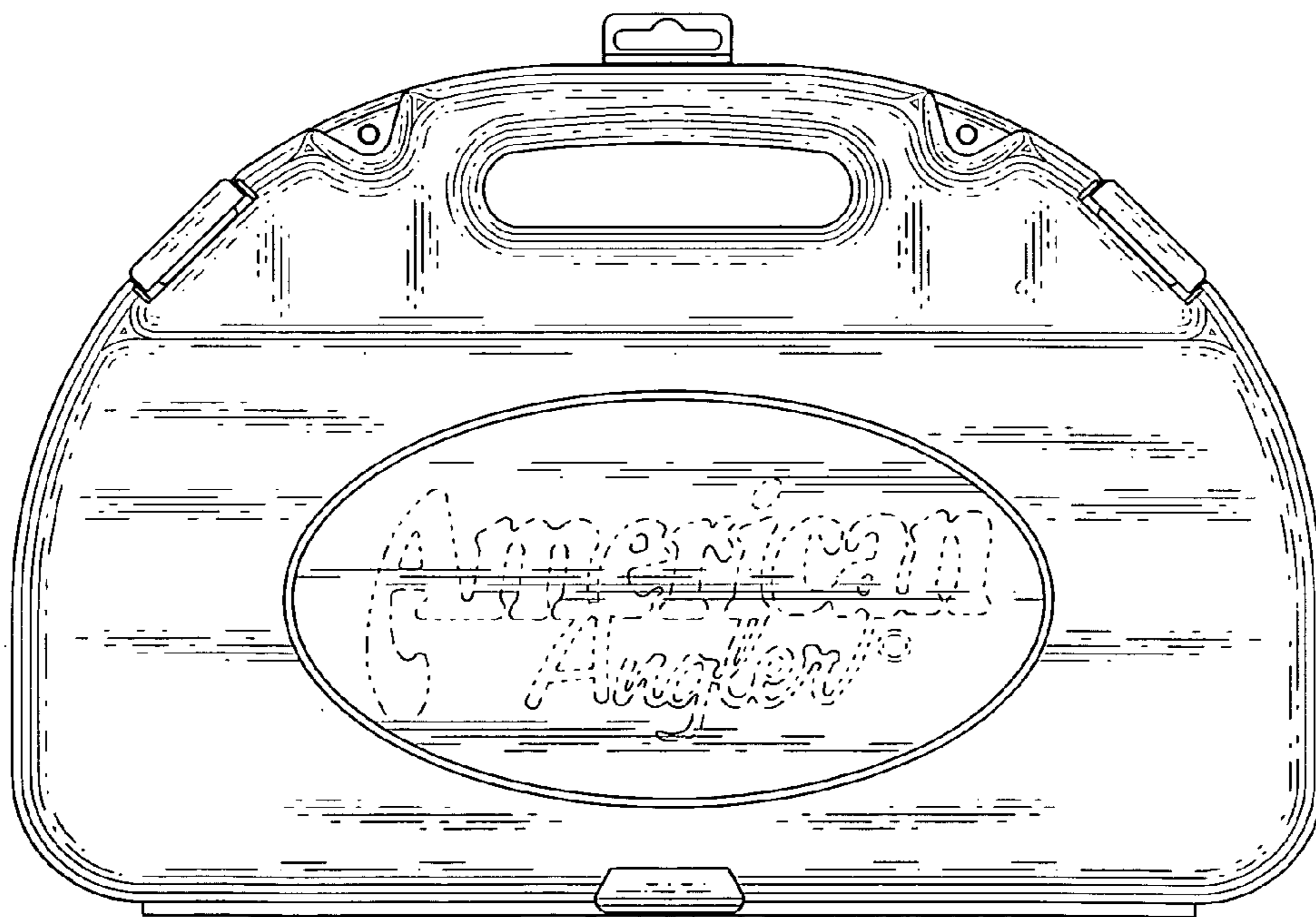

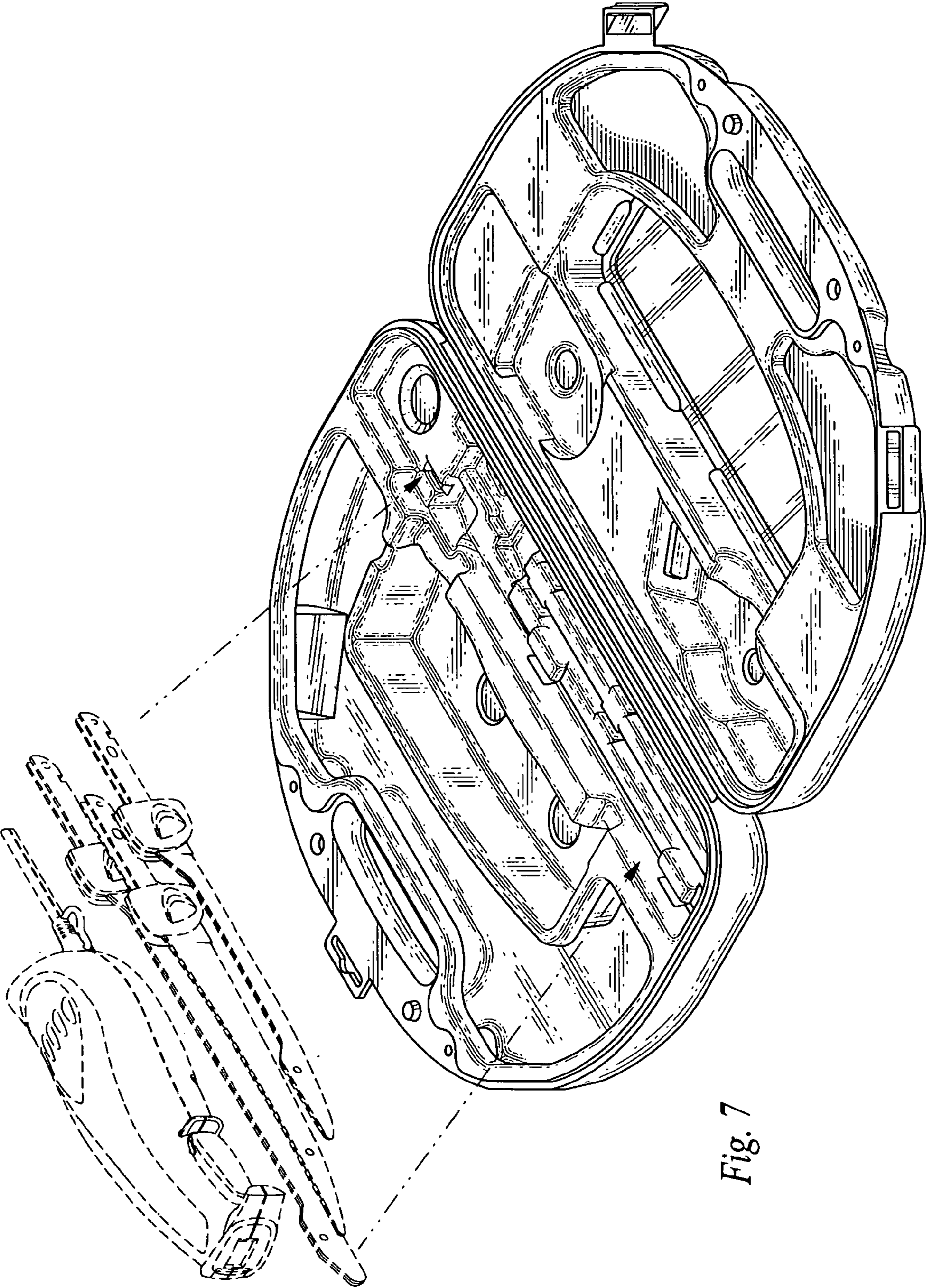

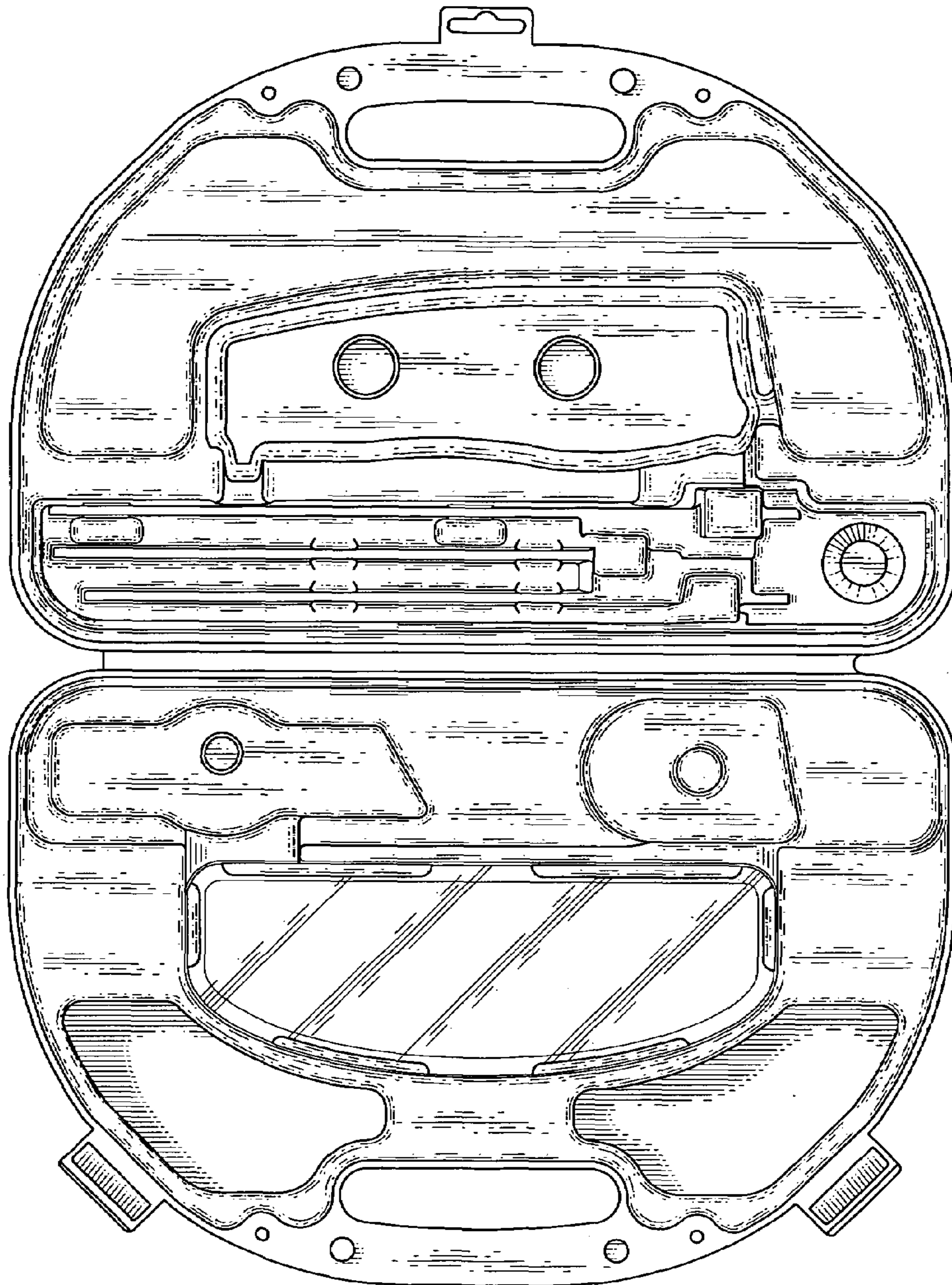
