The ornamental design for an plastic bags with embossed pattern, as shown and described.

DESCRIPTION

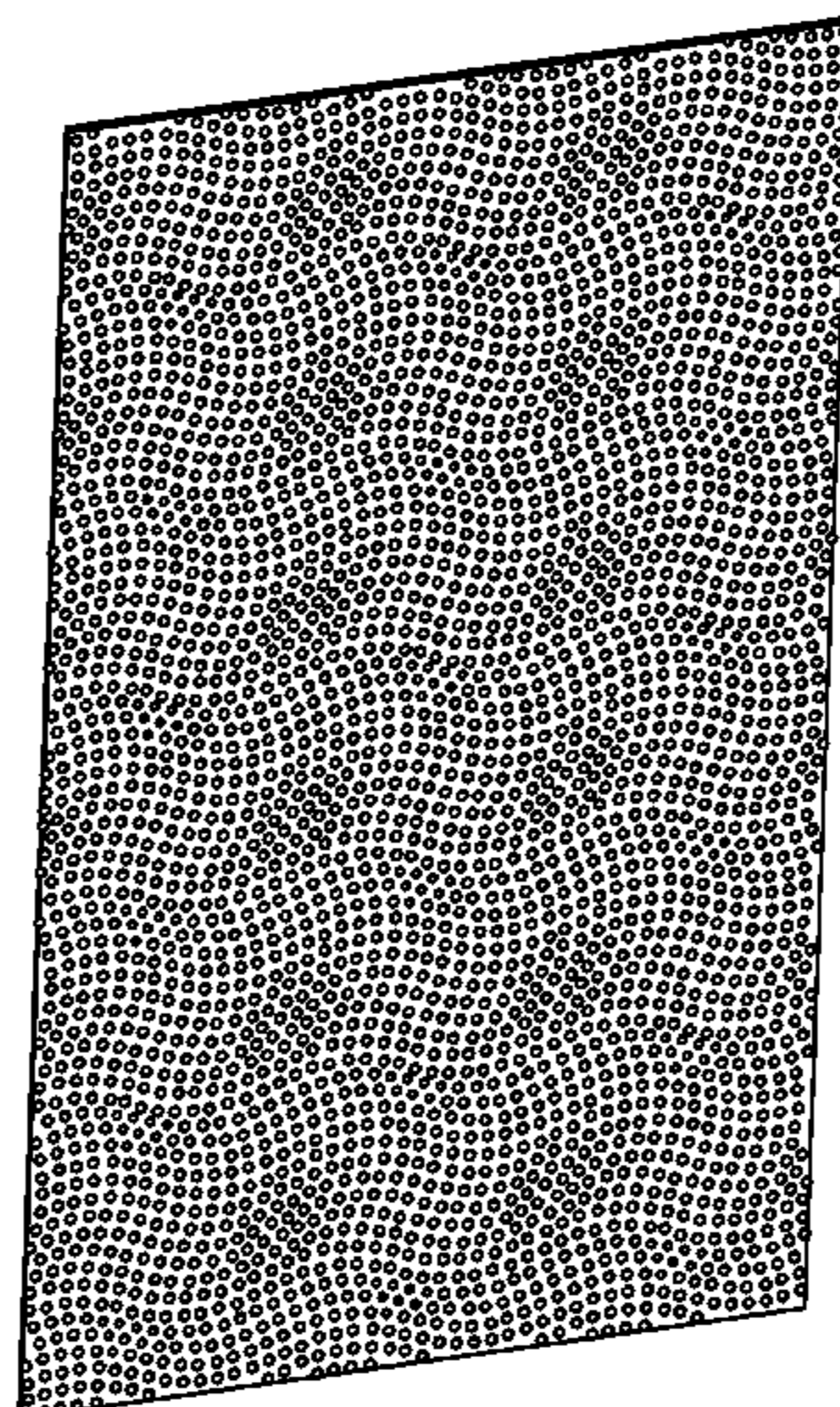
FIG. 1 is a perspective view of the top, front and left side of an plastic bags with embossed pattern in accordance with one embodiment of my new design, the top, front, and right side perspective view being a mirror image thereof;

FIG. 2 is a front elevational view of the plastic bags with embossed pattern in accordance with my new design, the rear elevational view being a mirror image thereof;

FIG. 3 is a right-side plan view of the plastic bags with embossed pattern in accordance with my new design, the left-side plan view being a mirror image thereof; and,

FIG. 4 is a bottom plan view of the plastic bags with embossed pattern in accordance with my new design.

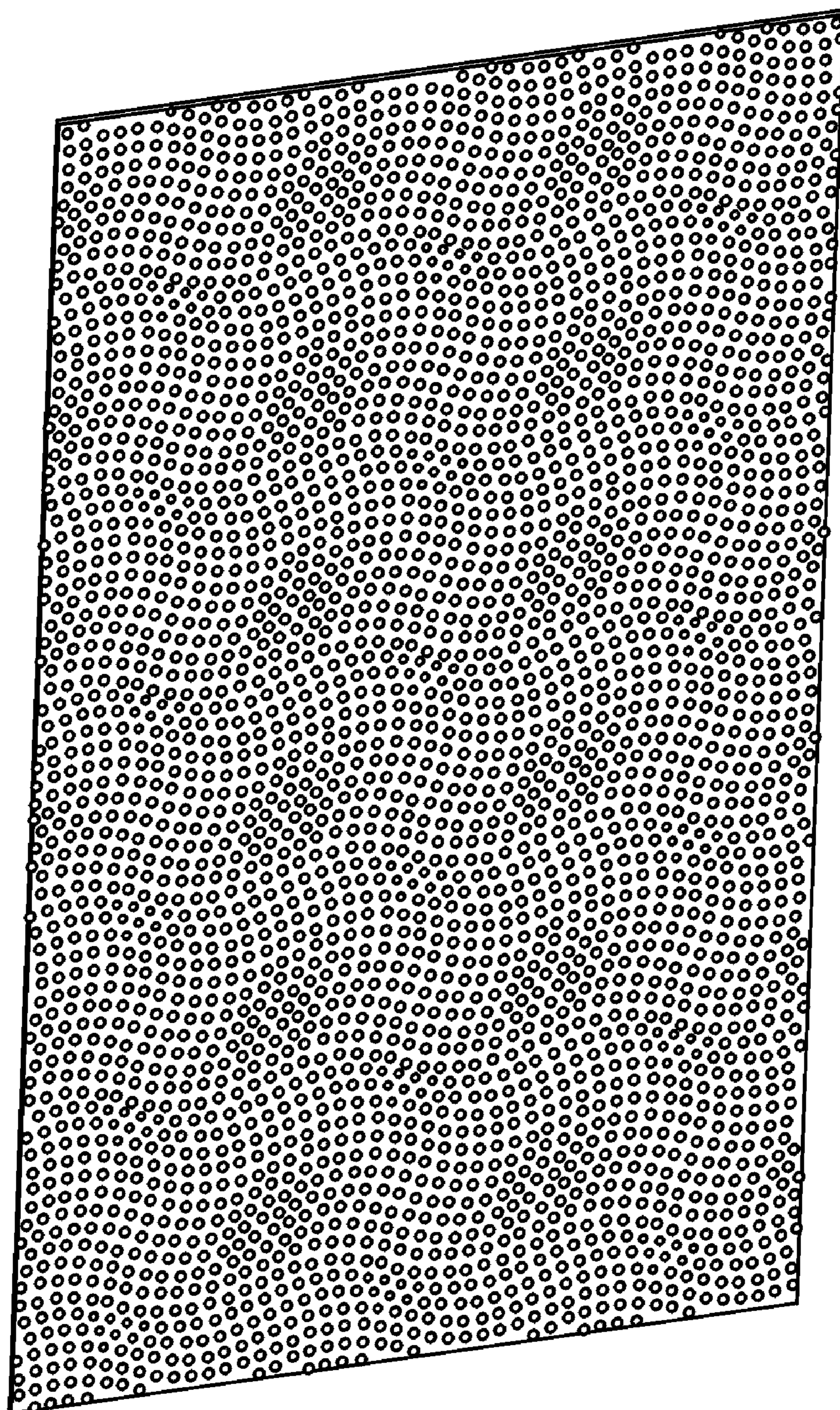

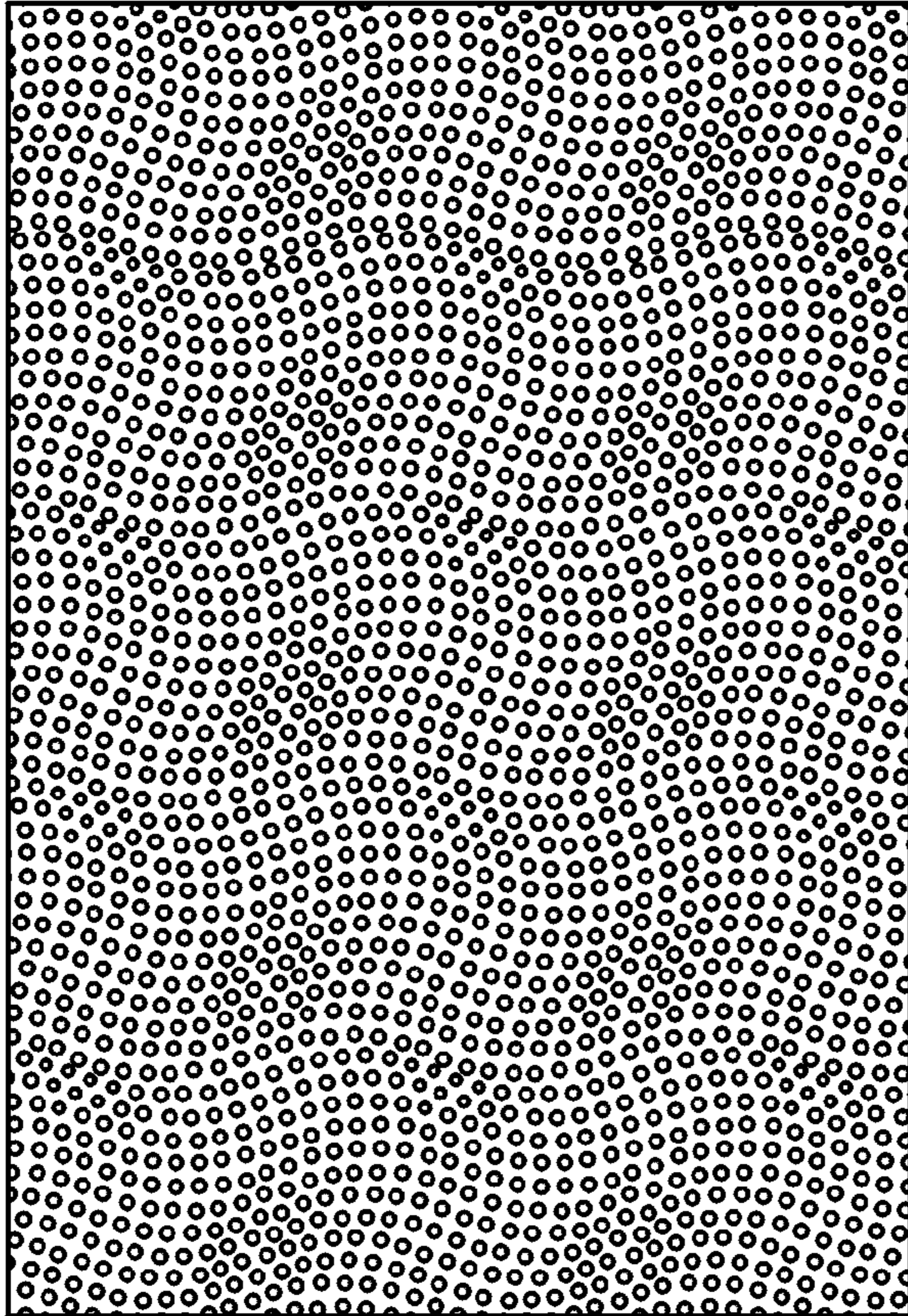
