FIG. 3 is a front elevation view thereof;

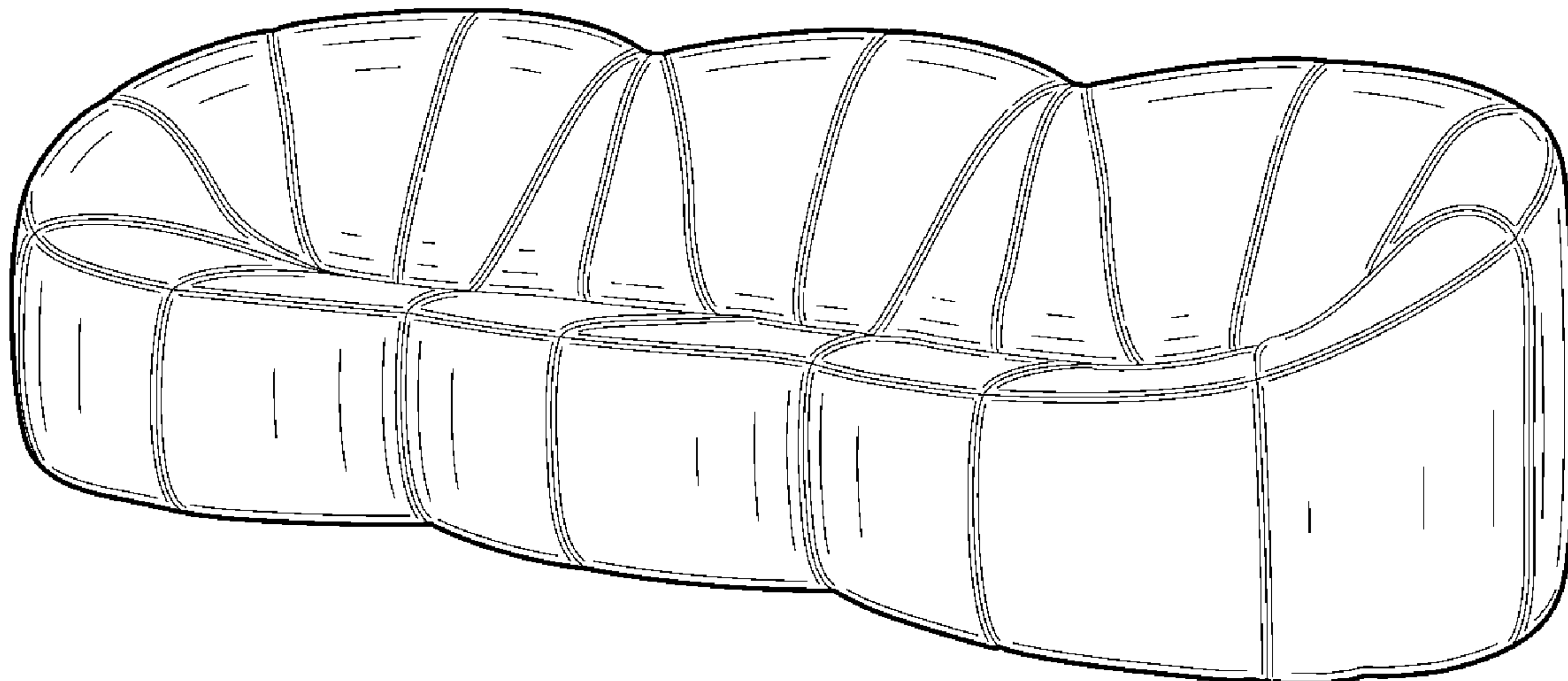
FIG. 4 is a side view thereof;

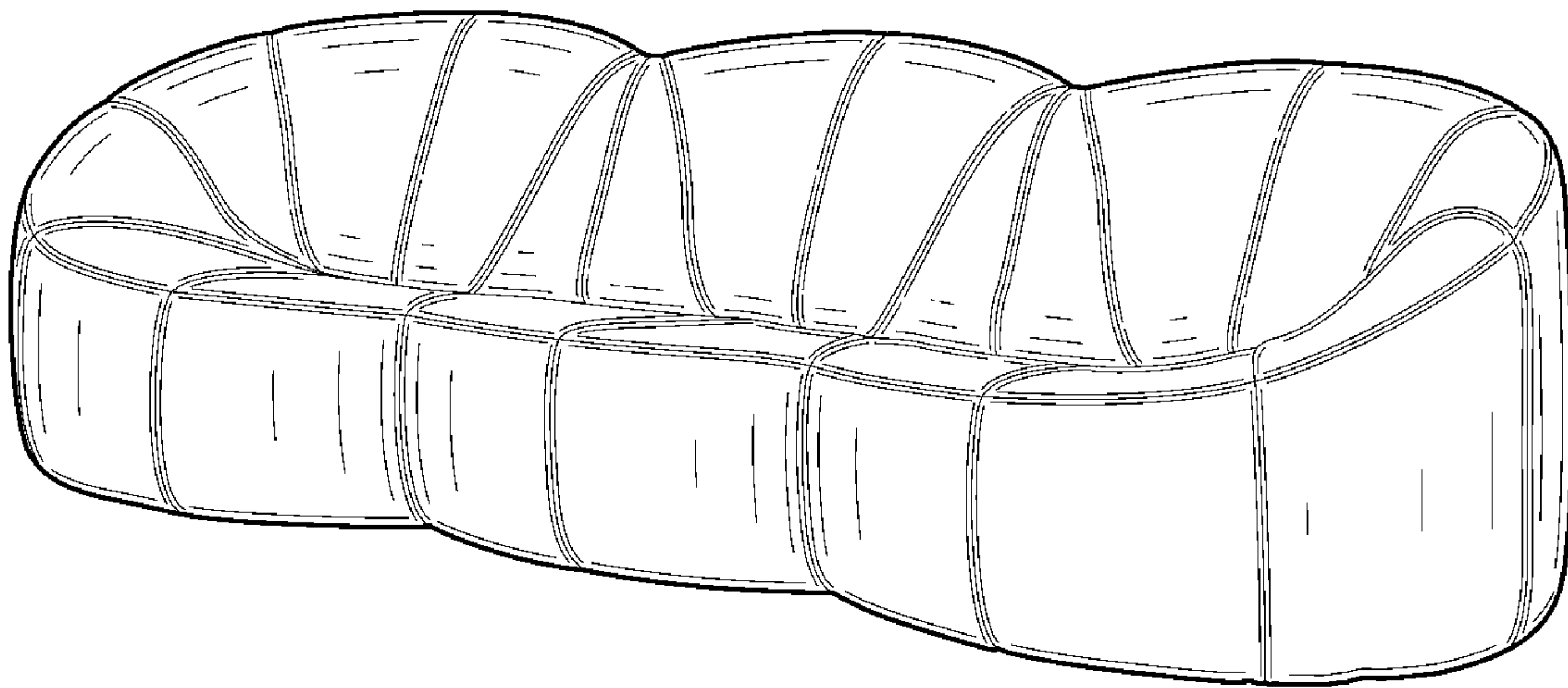
FIG. 5 is an opposite side view thereof;

FIG. 6 is a top plan view thereof; and,

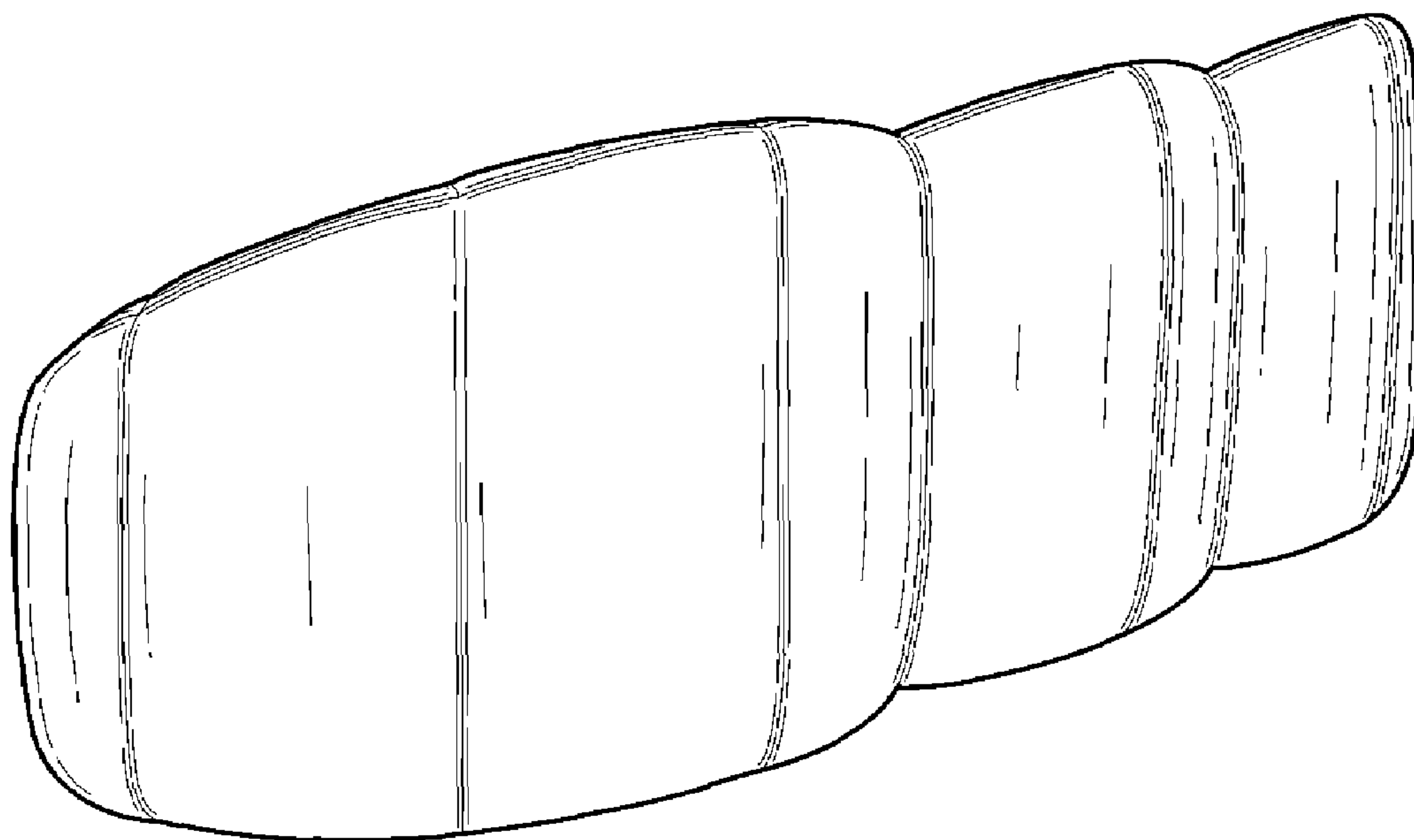
FIG. 7 is a rear elevation view thereof.

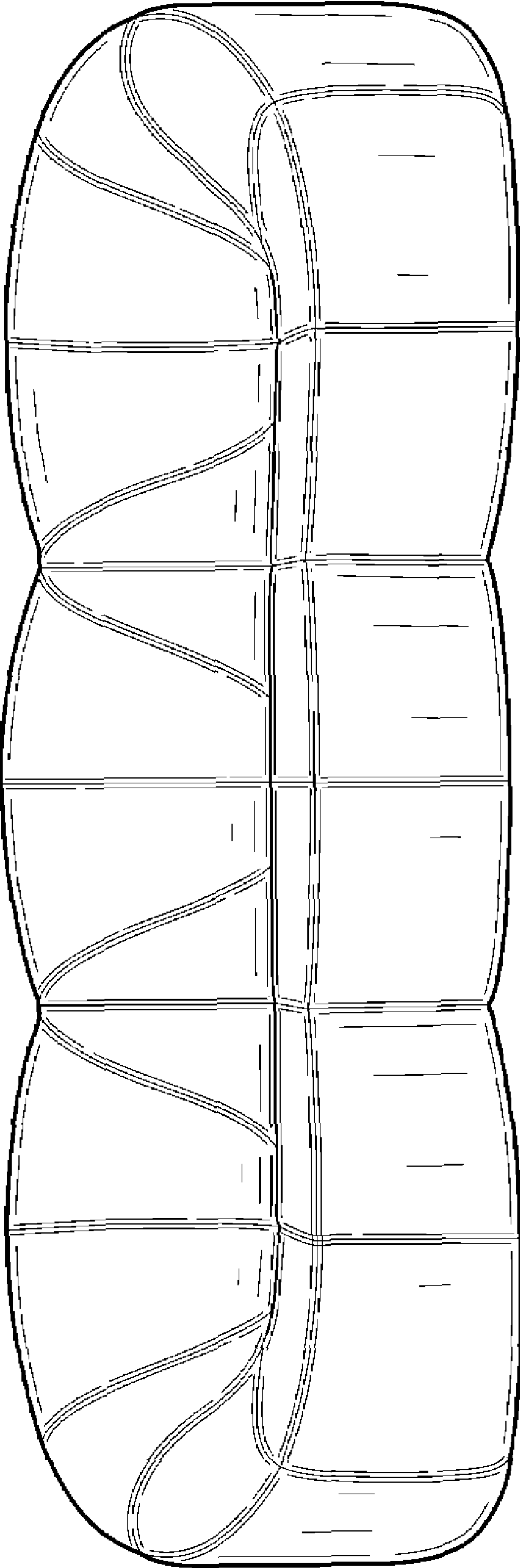
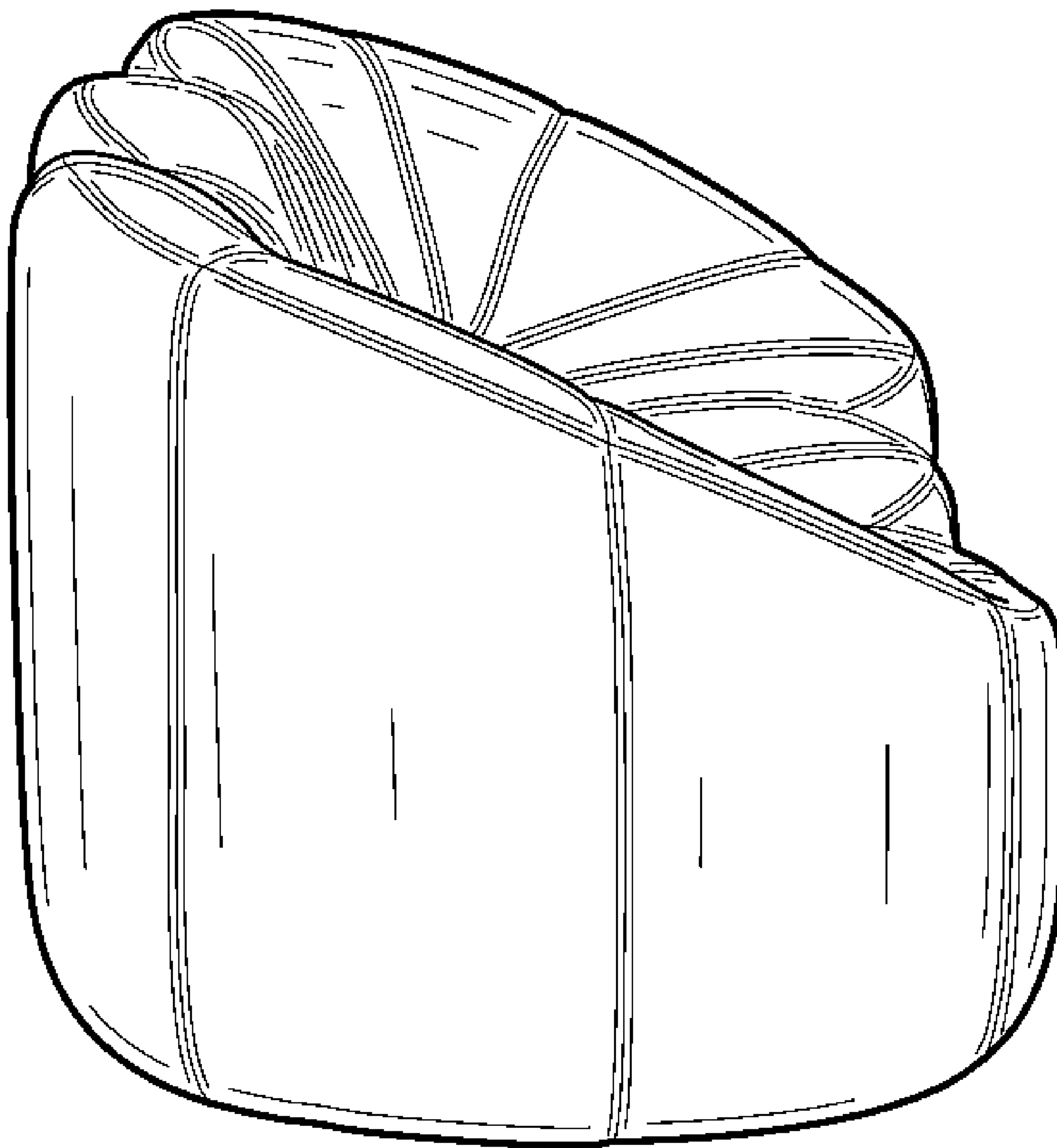
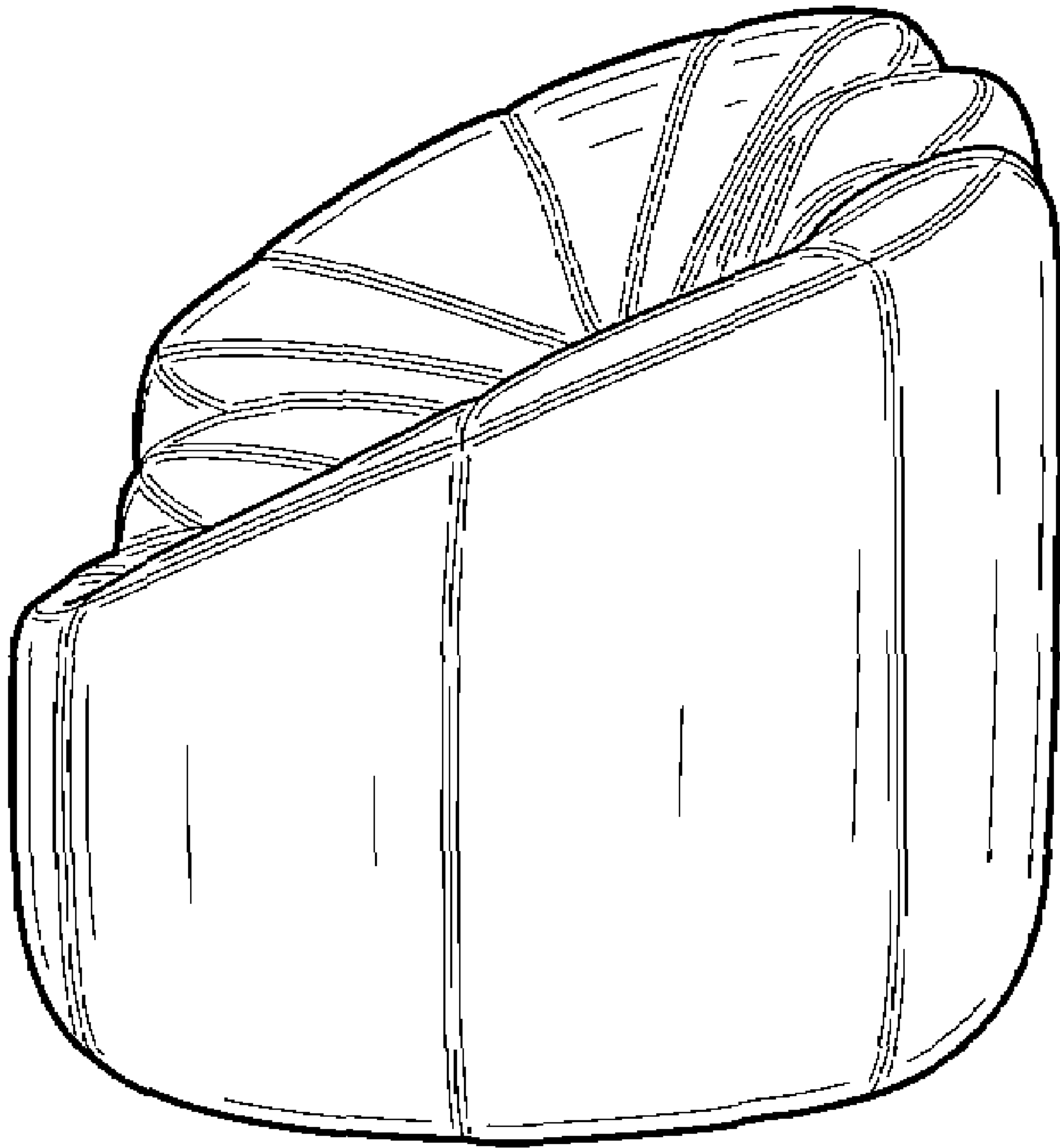

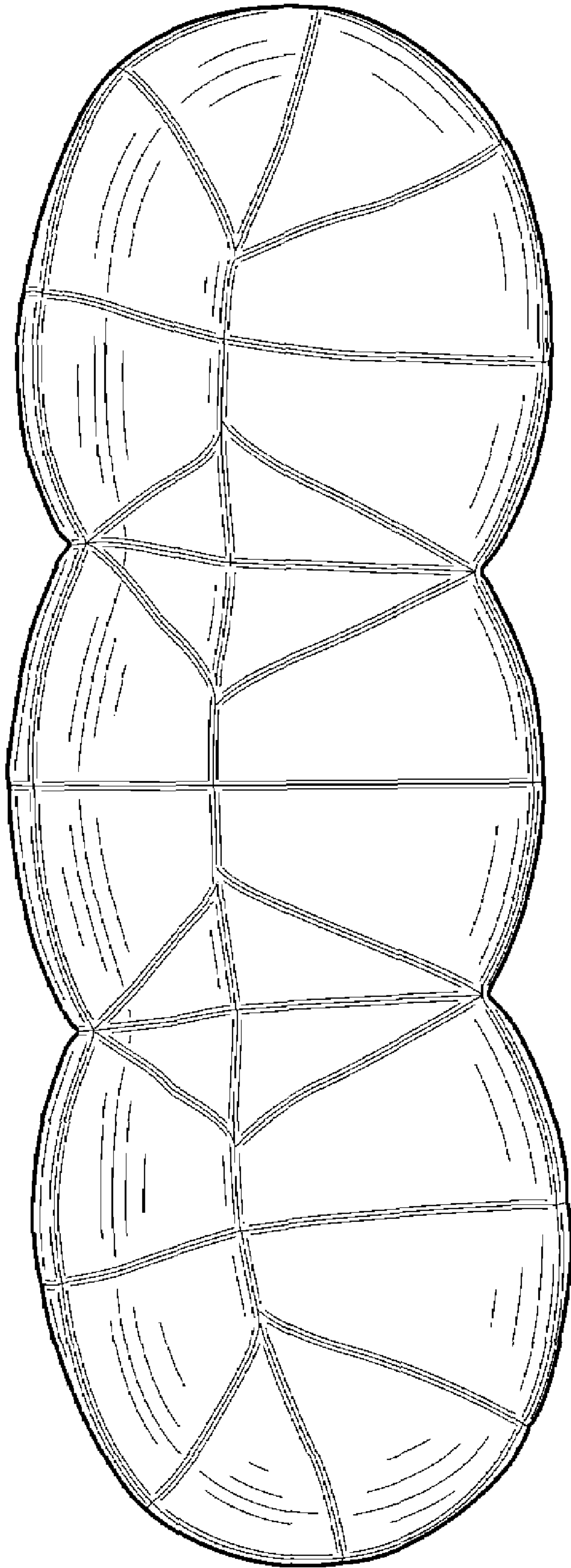

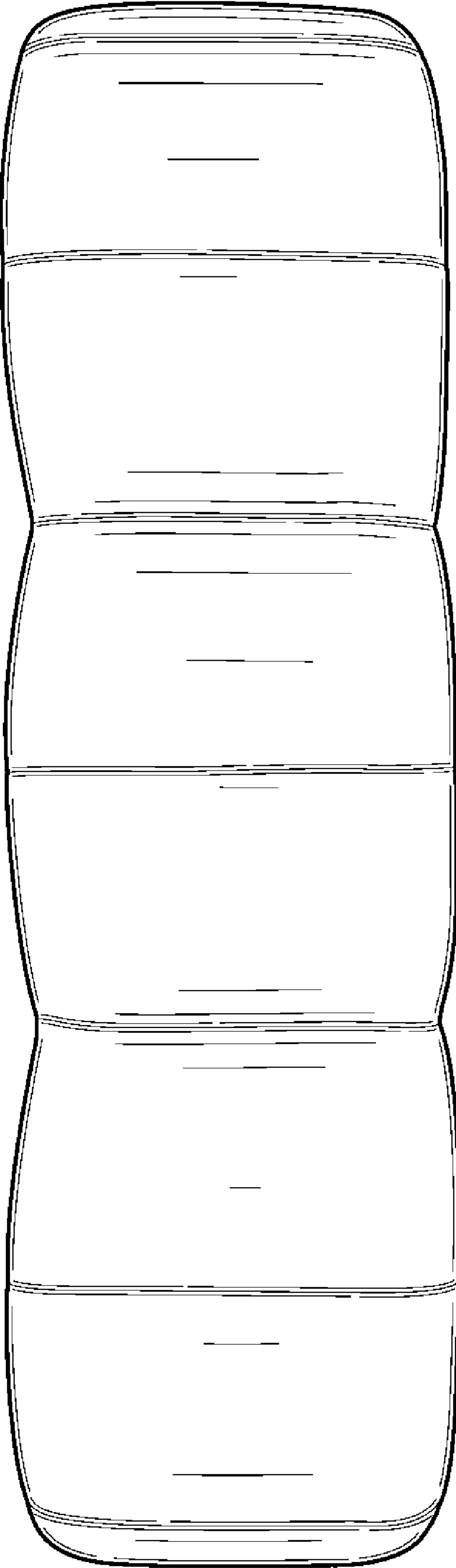
