FIG. 1 is a front corner perspective view of a television stand of the invention.

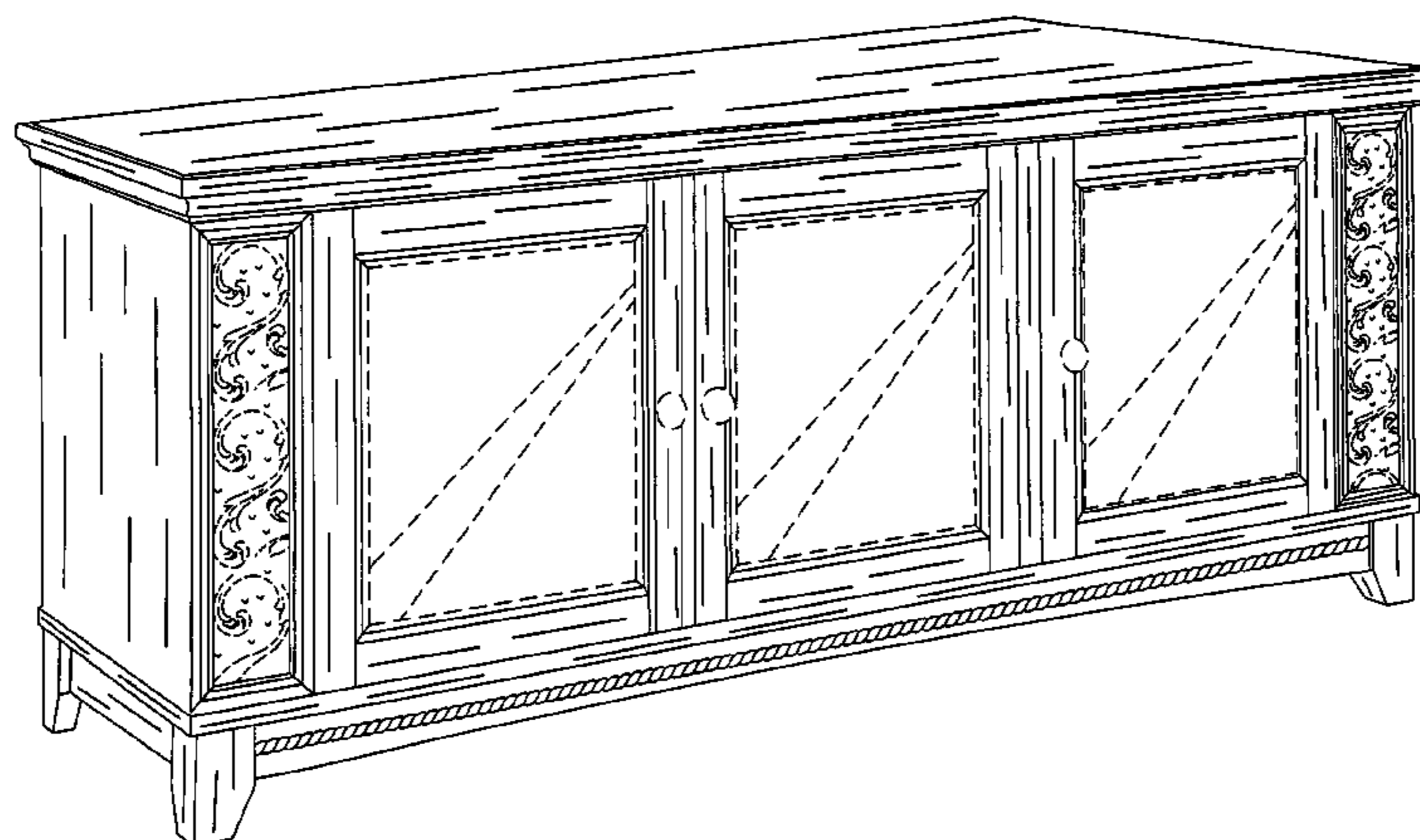
FIG. 2 is a front elevational view of a television stand of the invention.

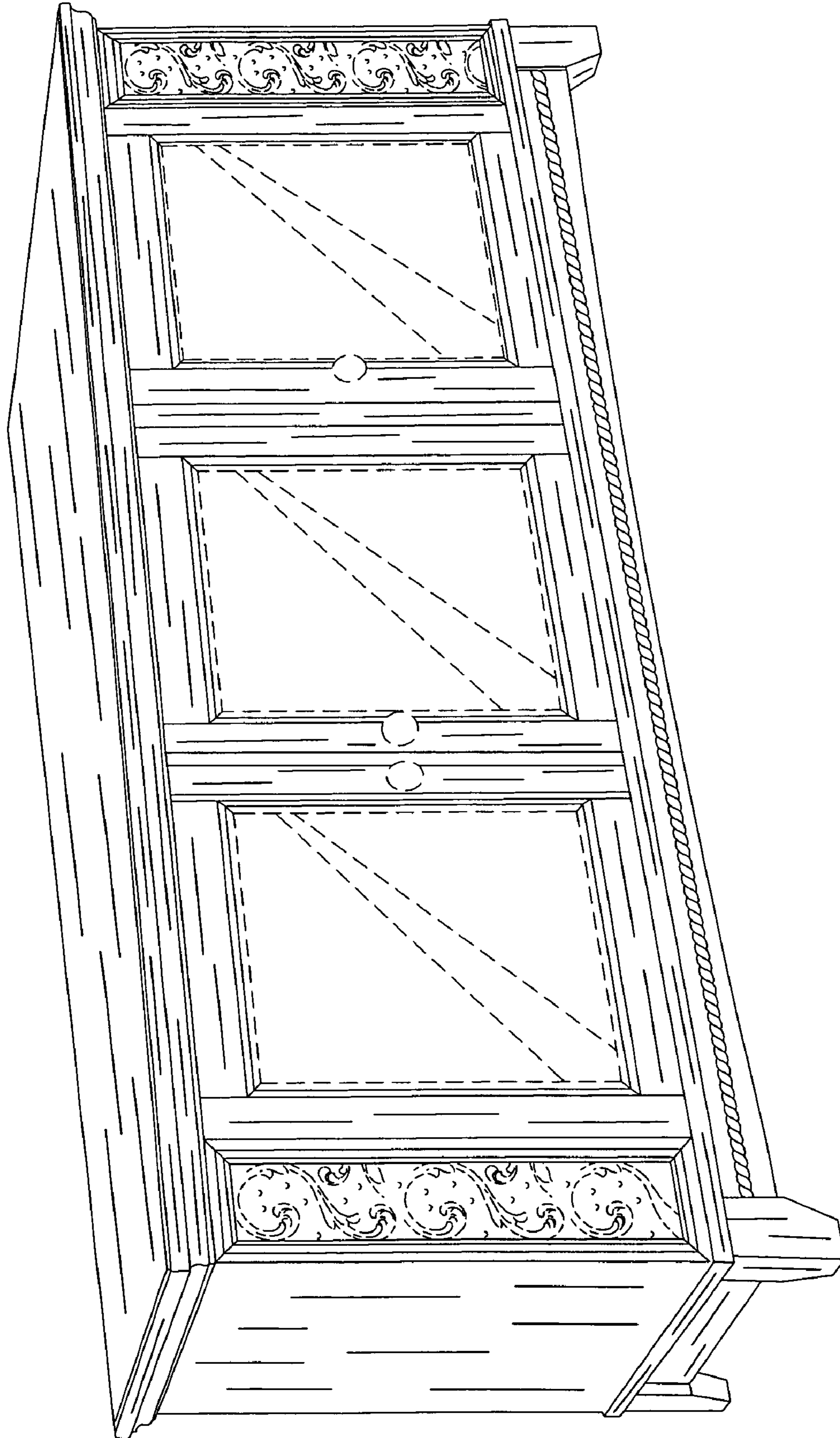

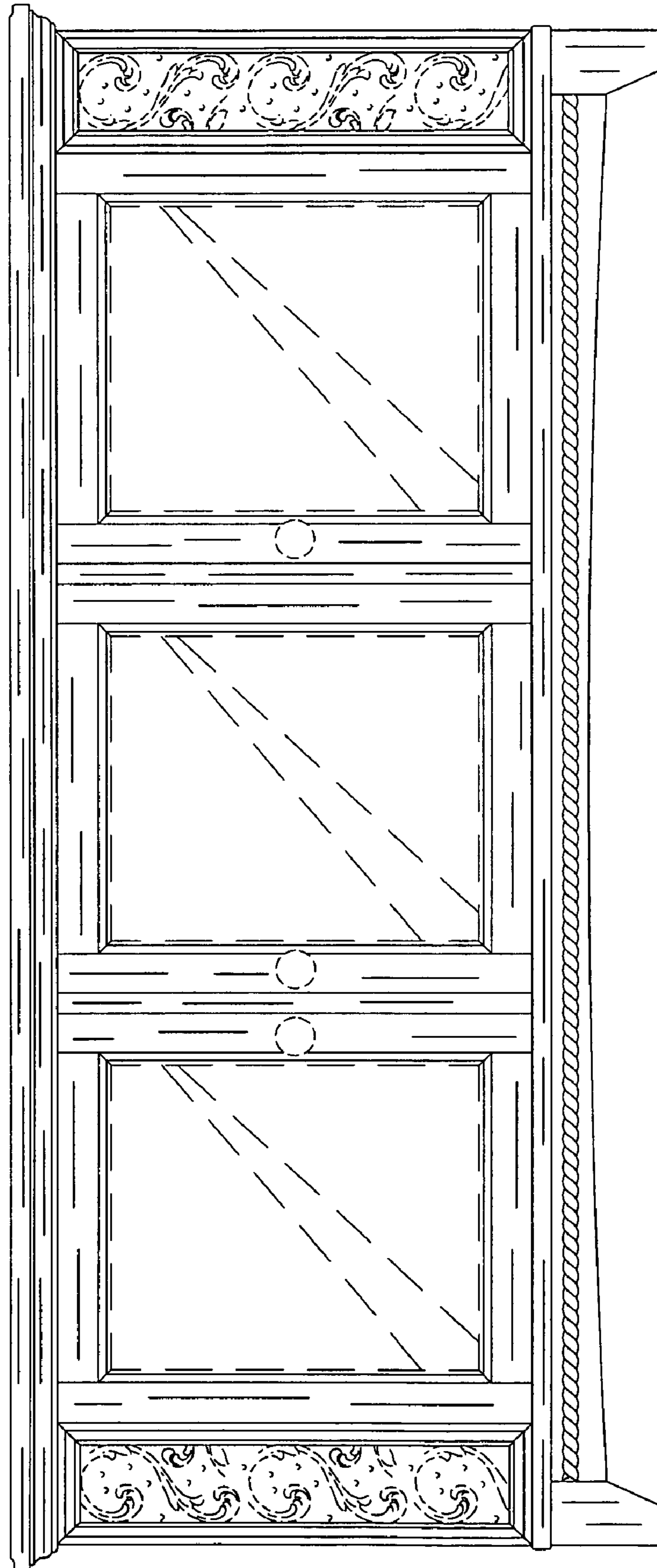

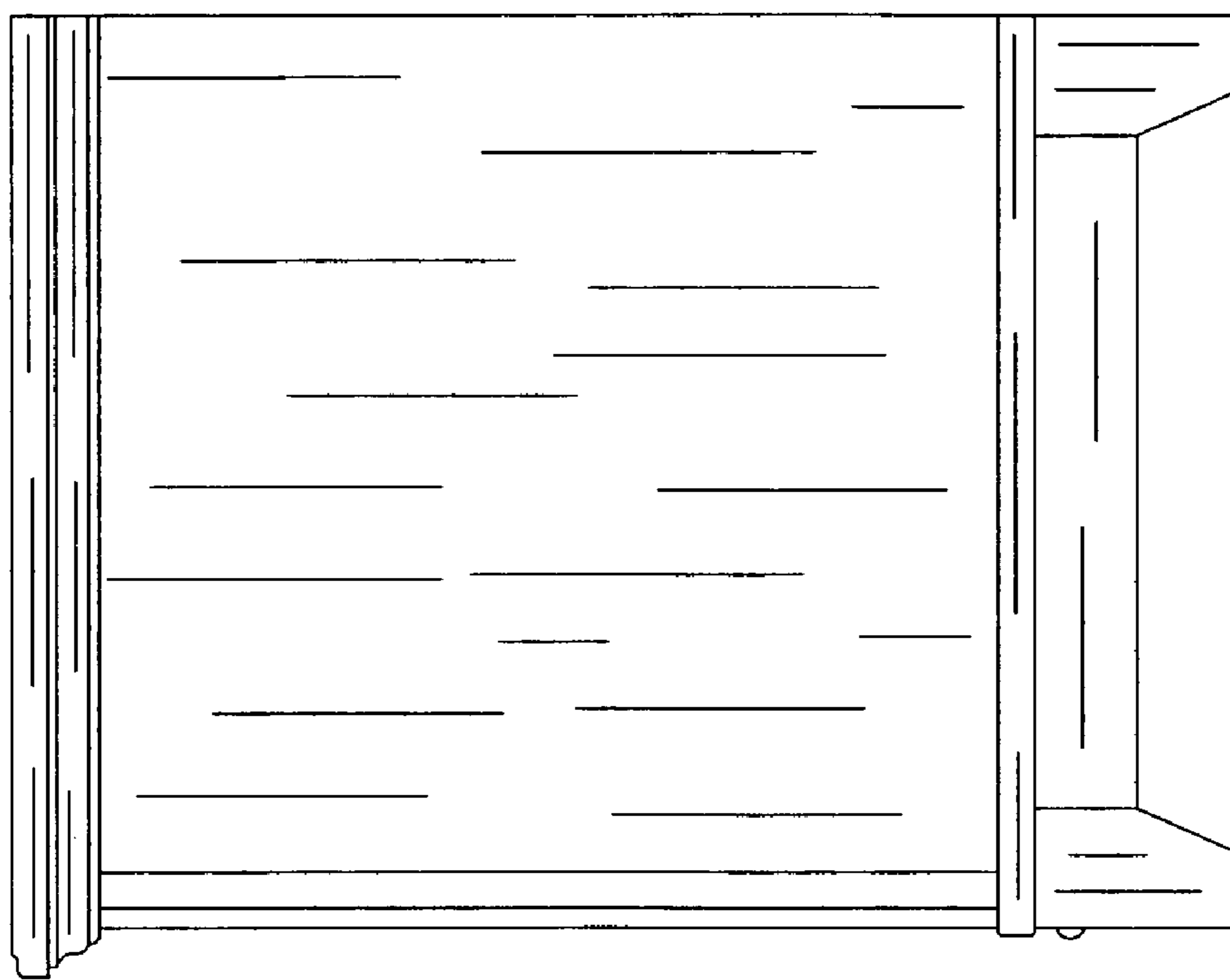

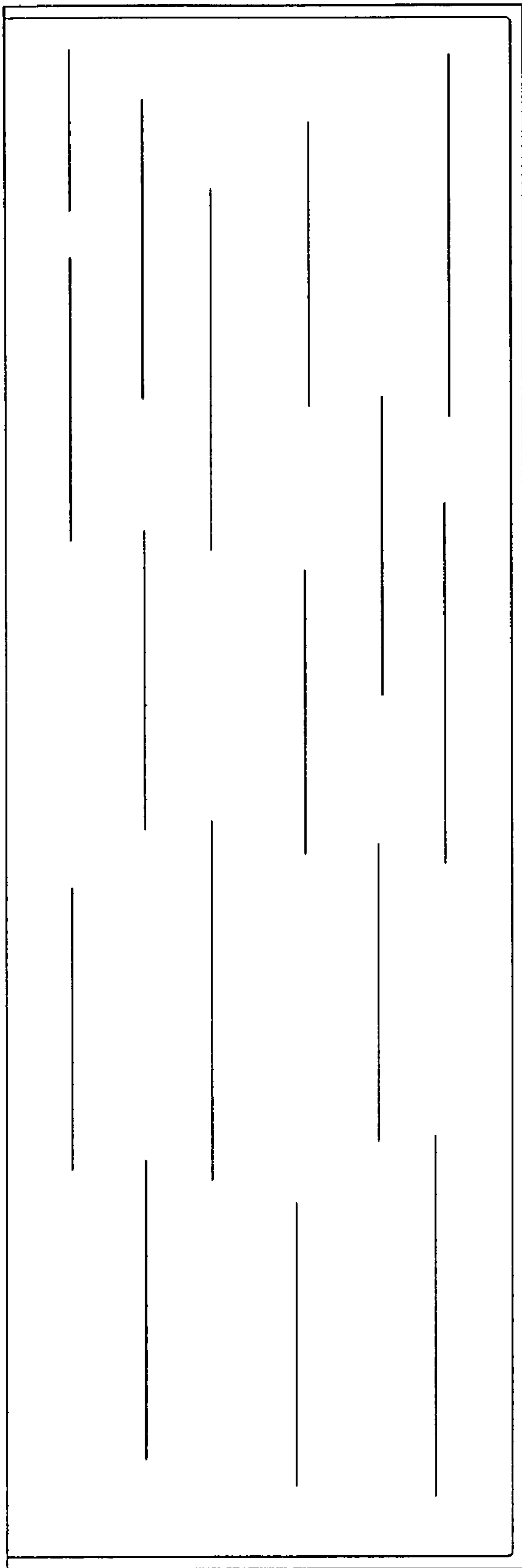
