The ornamental design for a cabinet panel, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the new, original, and ornamental design for a cabinet panel, wherein the cabinet panel, is attached to a cabinet;

FIG. 2 is a front elevational view of the cabinet panel of FIG. 1;

FIG. 3 is a rear elevational view of the cabinet panel of FIG. 1;

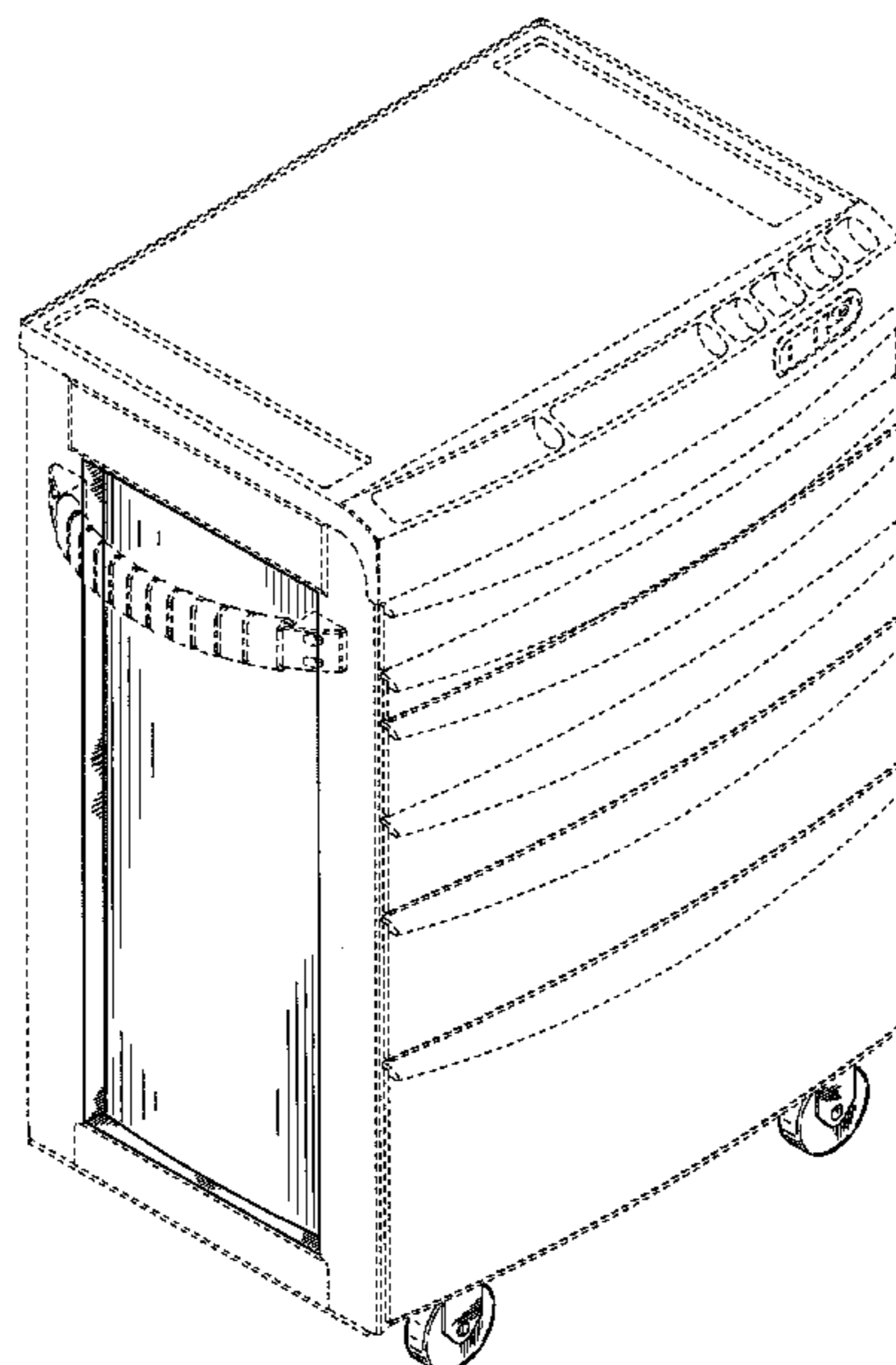
FIG. 4 is a right side elevational view of the cabinet panel of FIG. 1;

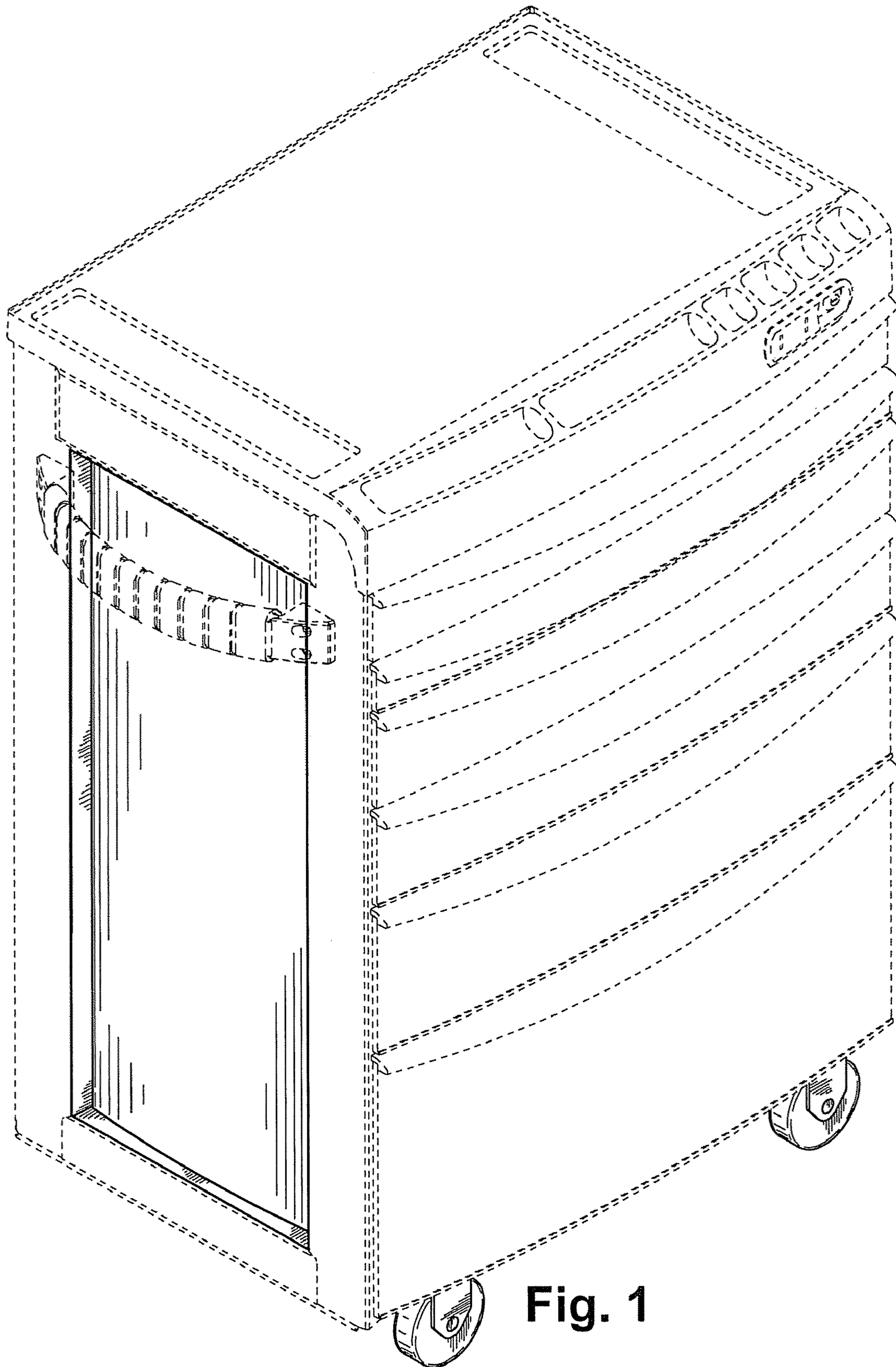

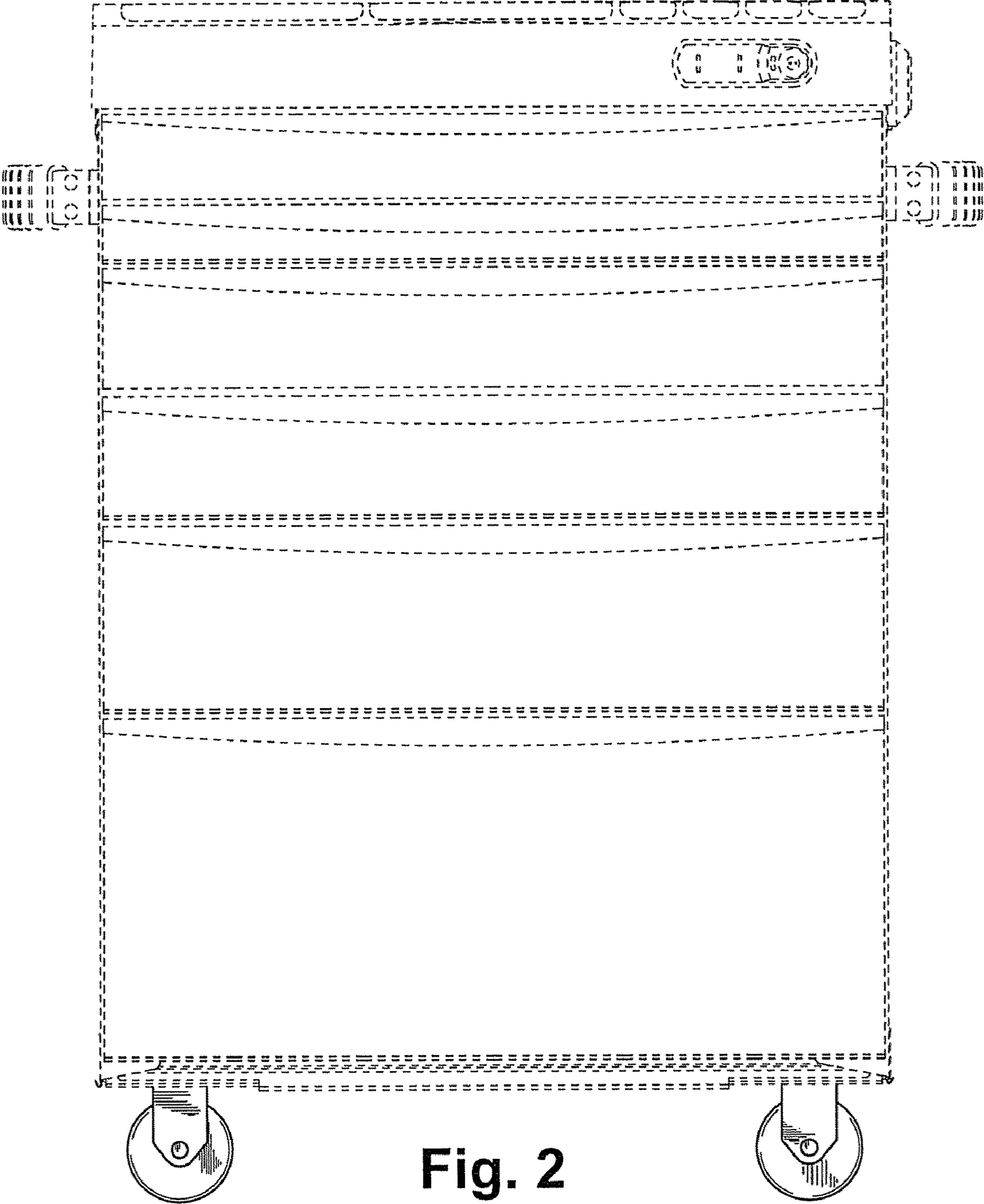

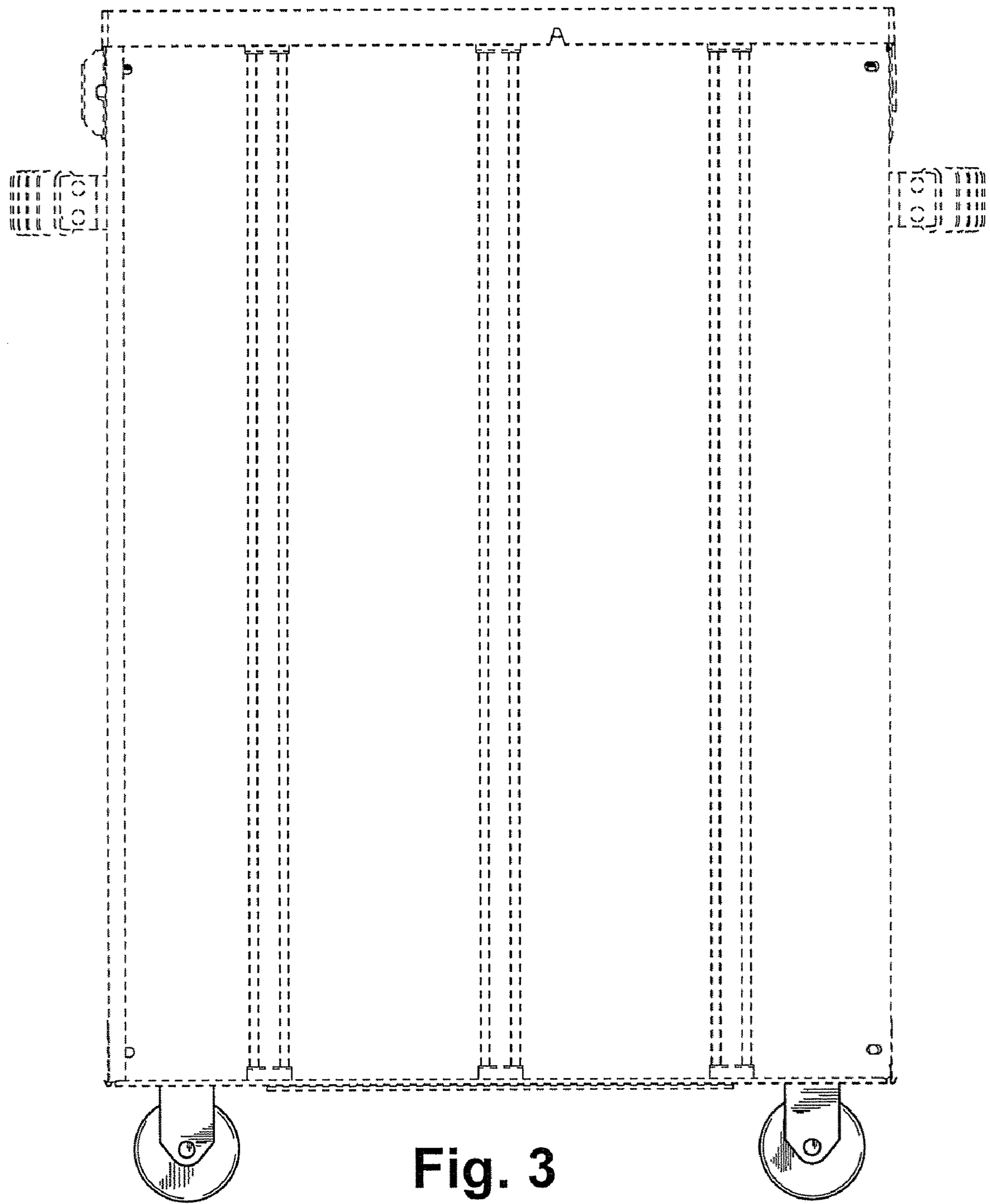

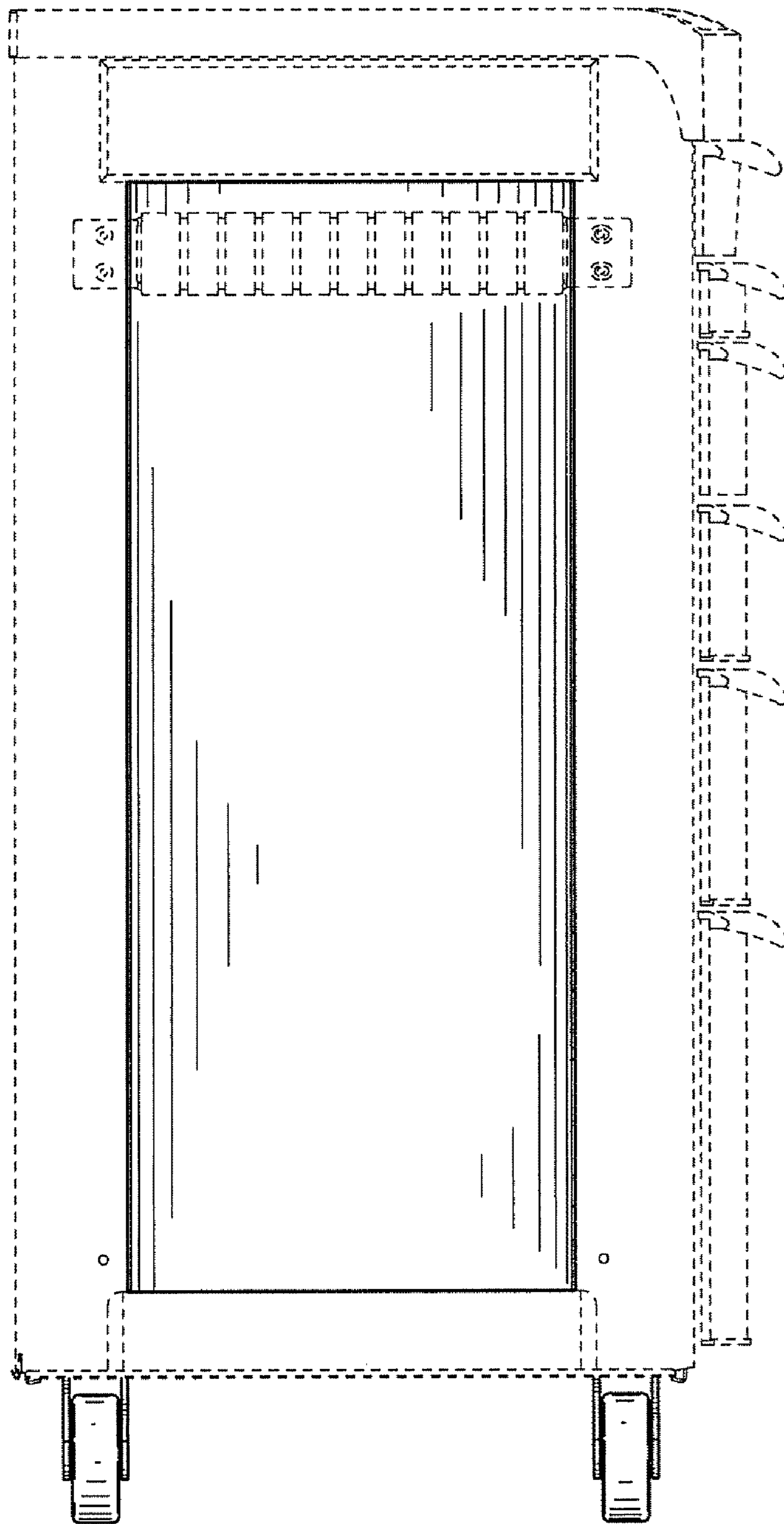

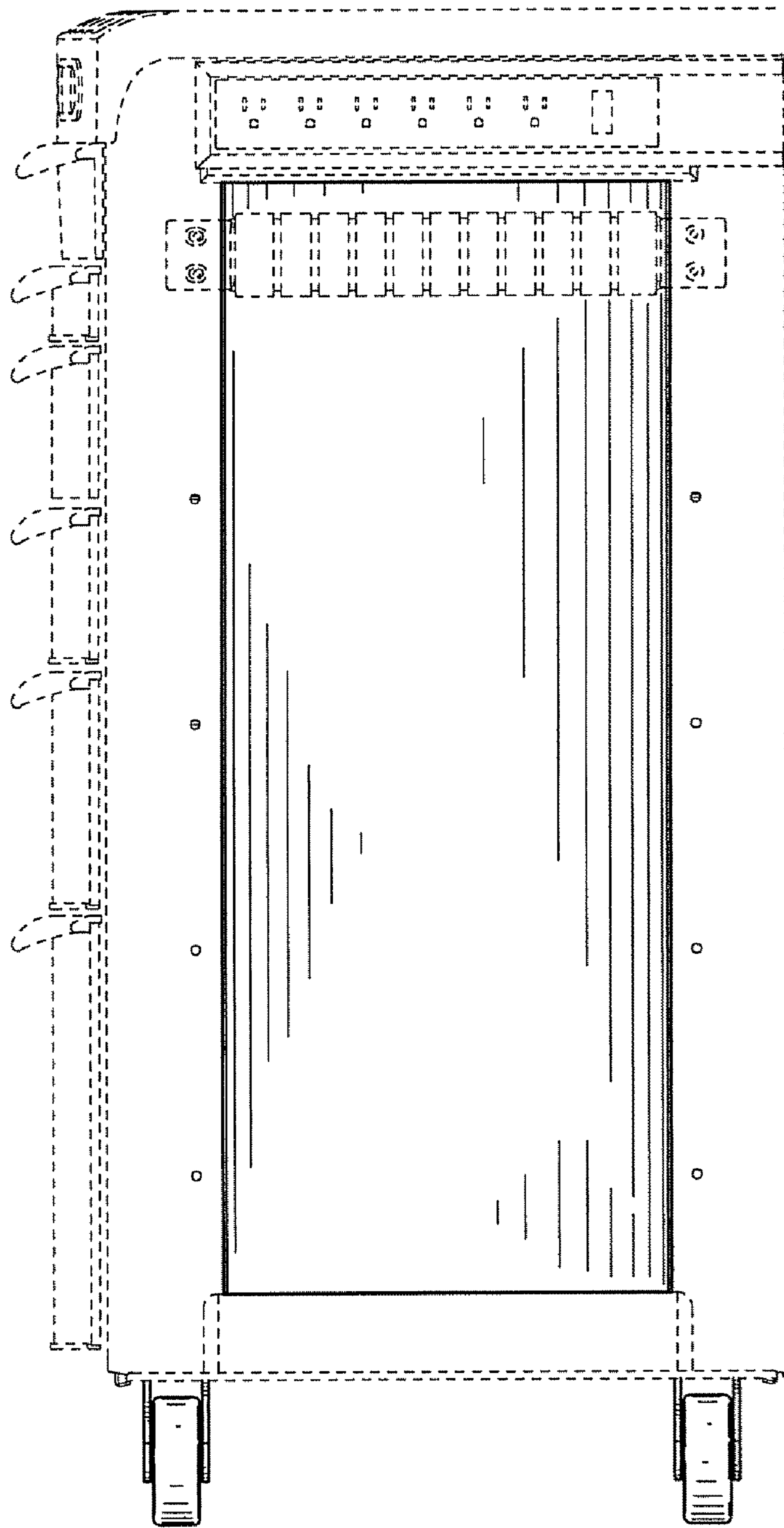

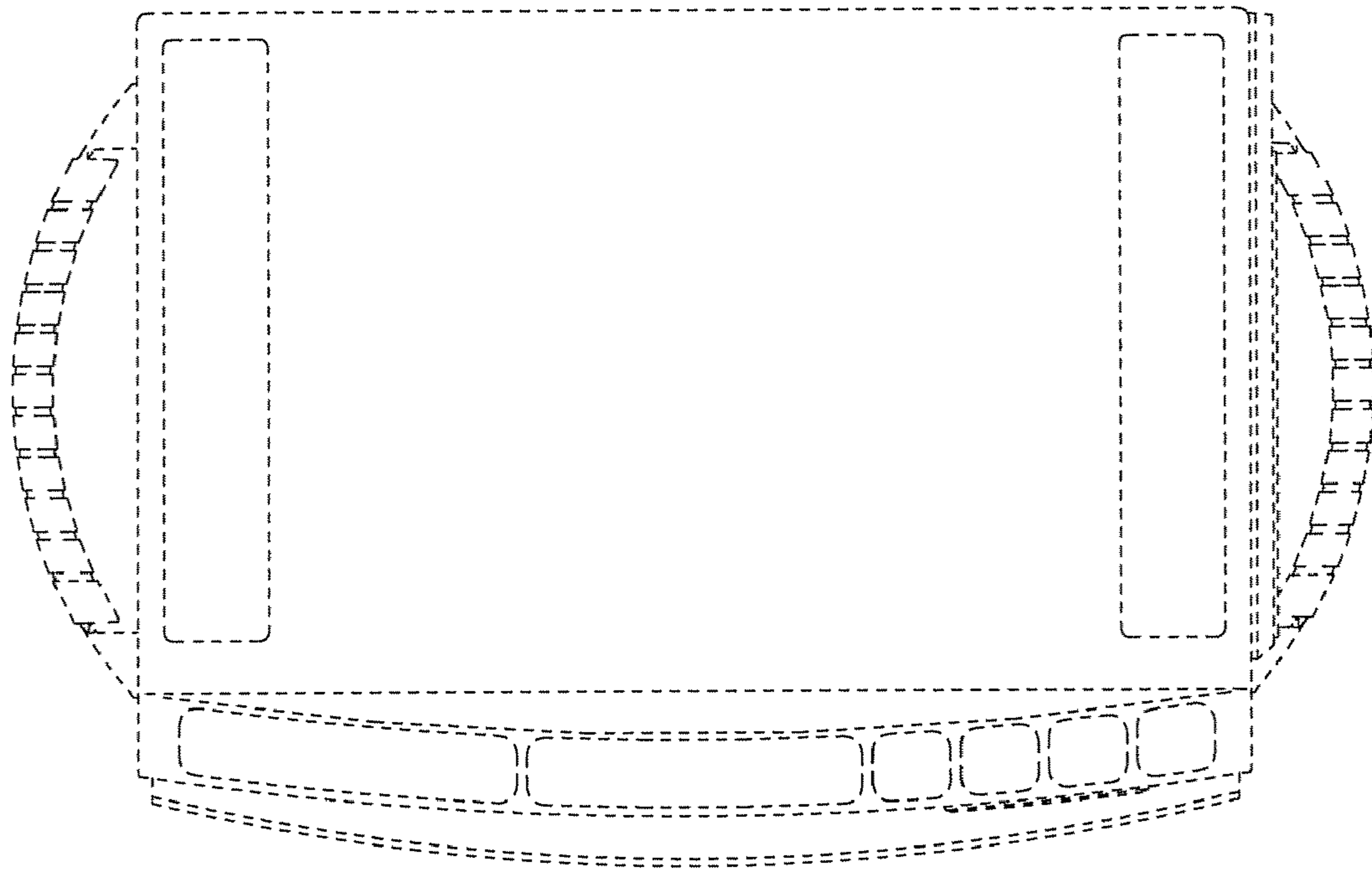

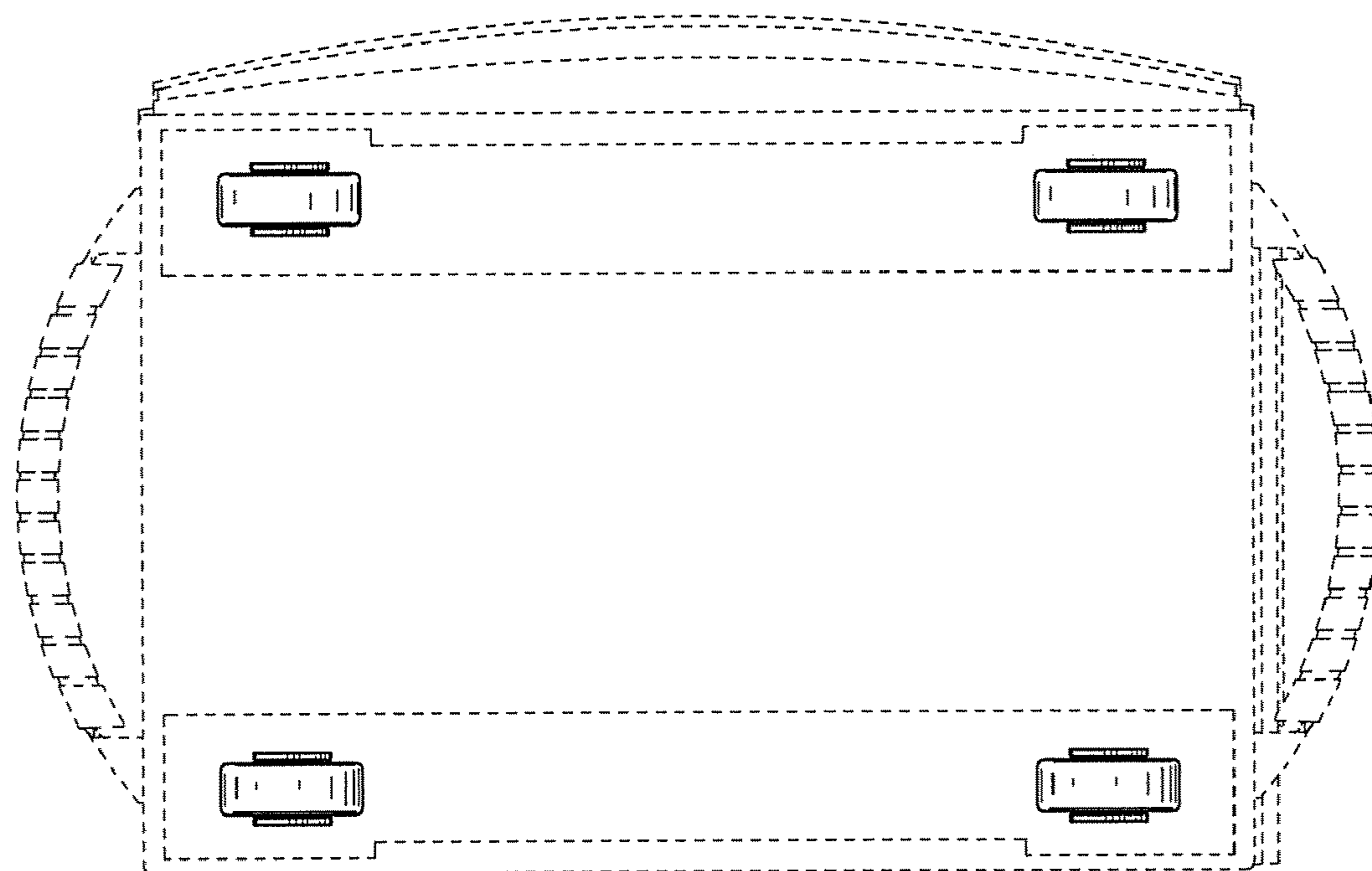
