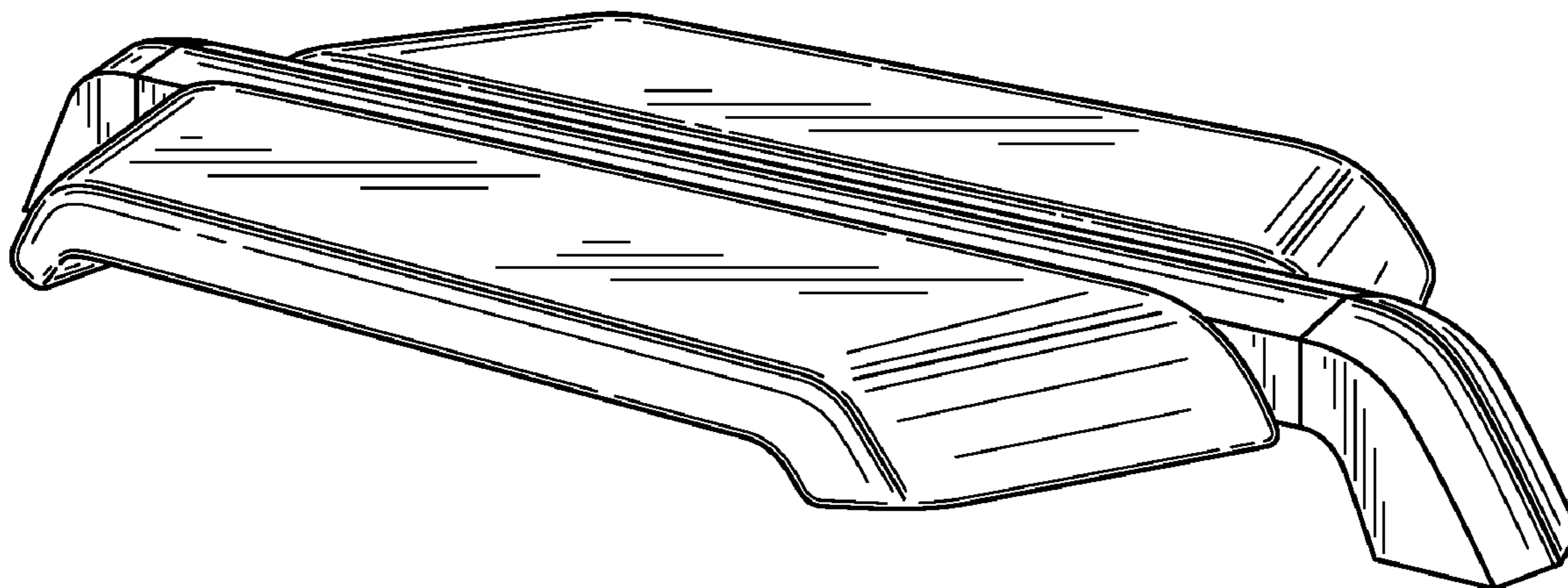
The ornamental design for a vehicle arm rest, as shown and described.

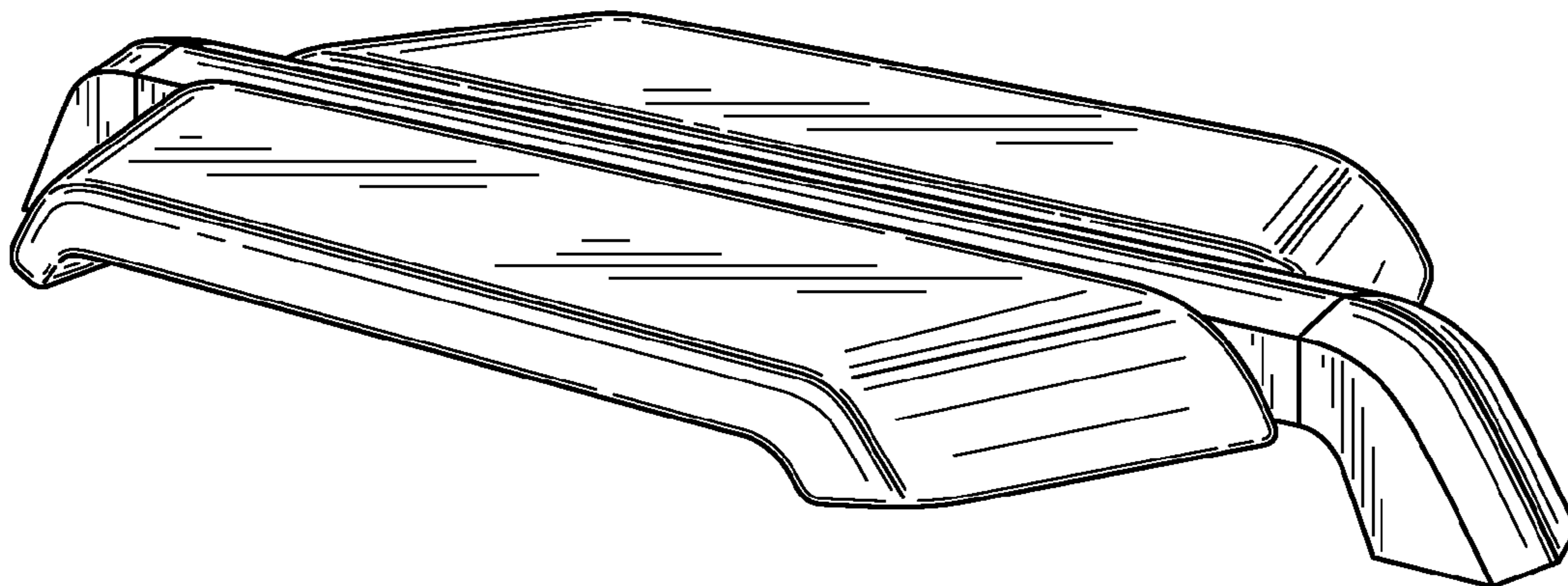

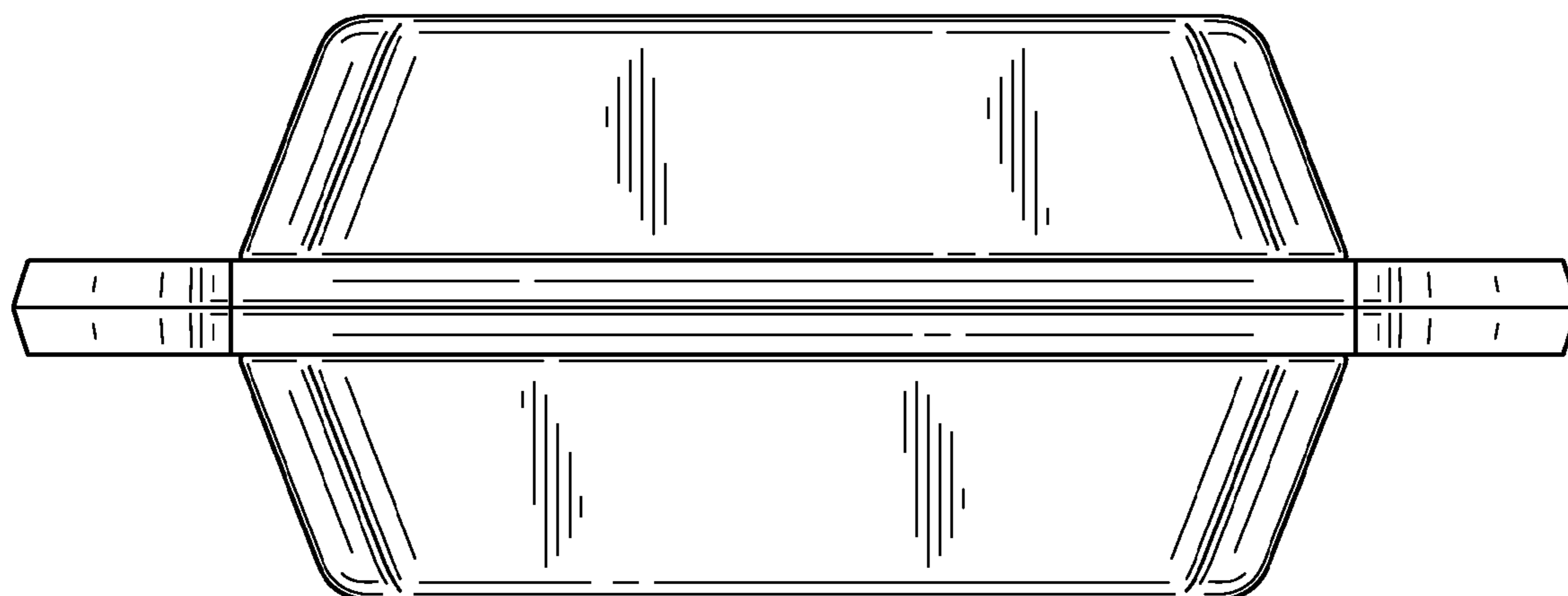
