(57) **CLAIM**

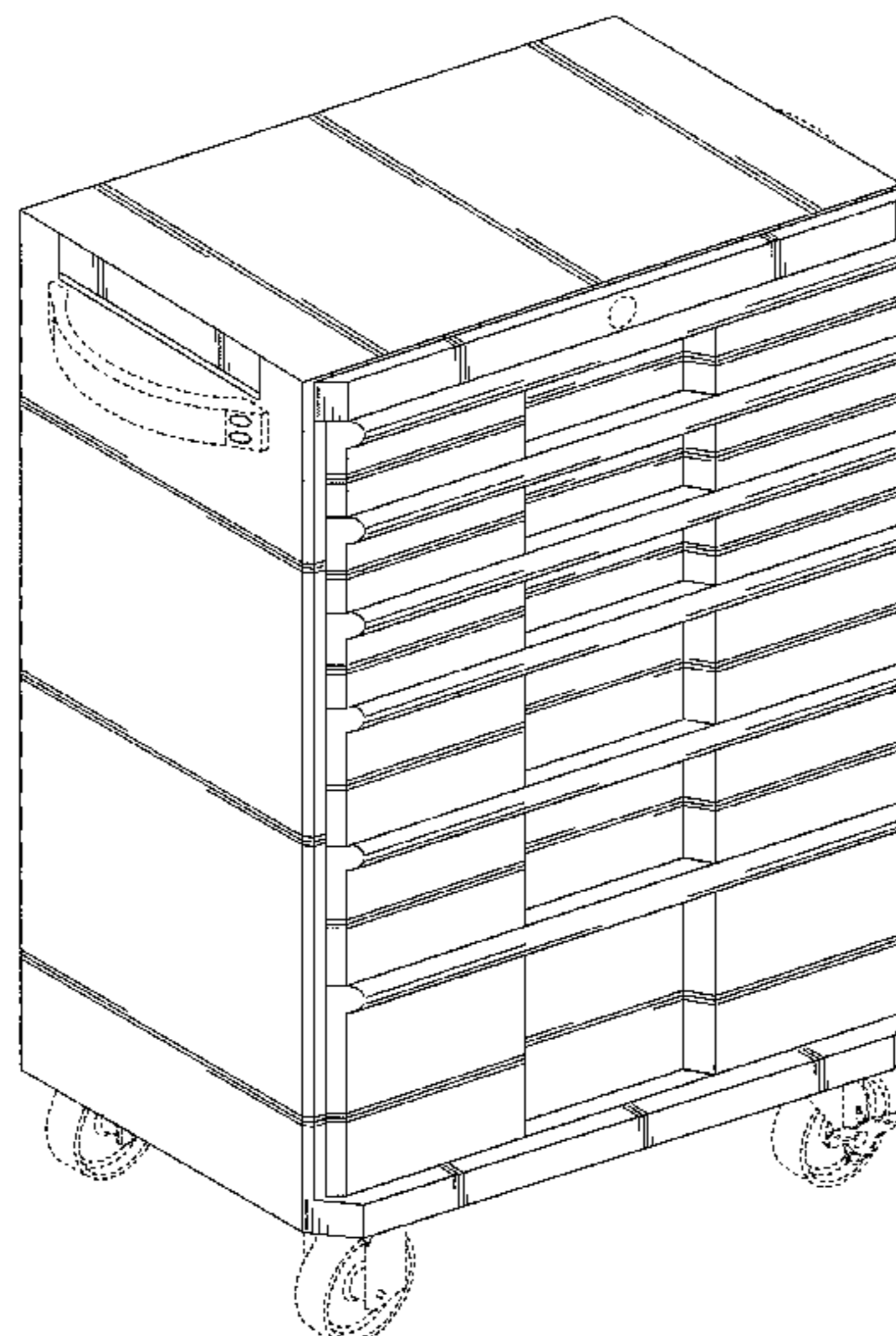
I claim the ornamental design for a cabinet, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a cabinet made in accordance with an embodiment of the new design;  
FIG. 2 is a front view of the cabinet of FIG. 1;  
FIG. 3 is a rear view of the cabinet of FIG. 1;  
FIG. 4 is a left side view of the cabinet of FIG. 1;  
FIG. 5 is a right side view of the cabinet of FIG. 1;  
FIG. 6 is a bottom view of the cabinet of FIG. 1; and,  
FIG. 7 is a top view of the cabinet of FIG. 1.

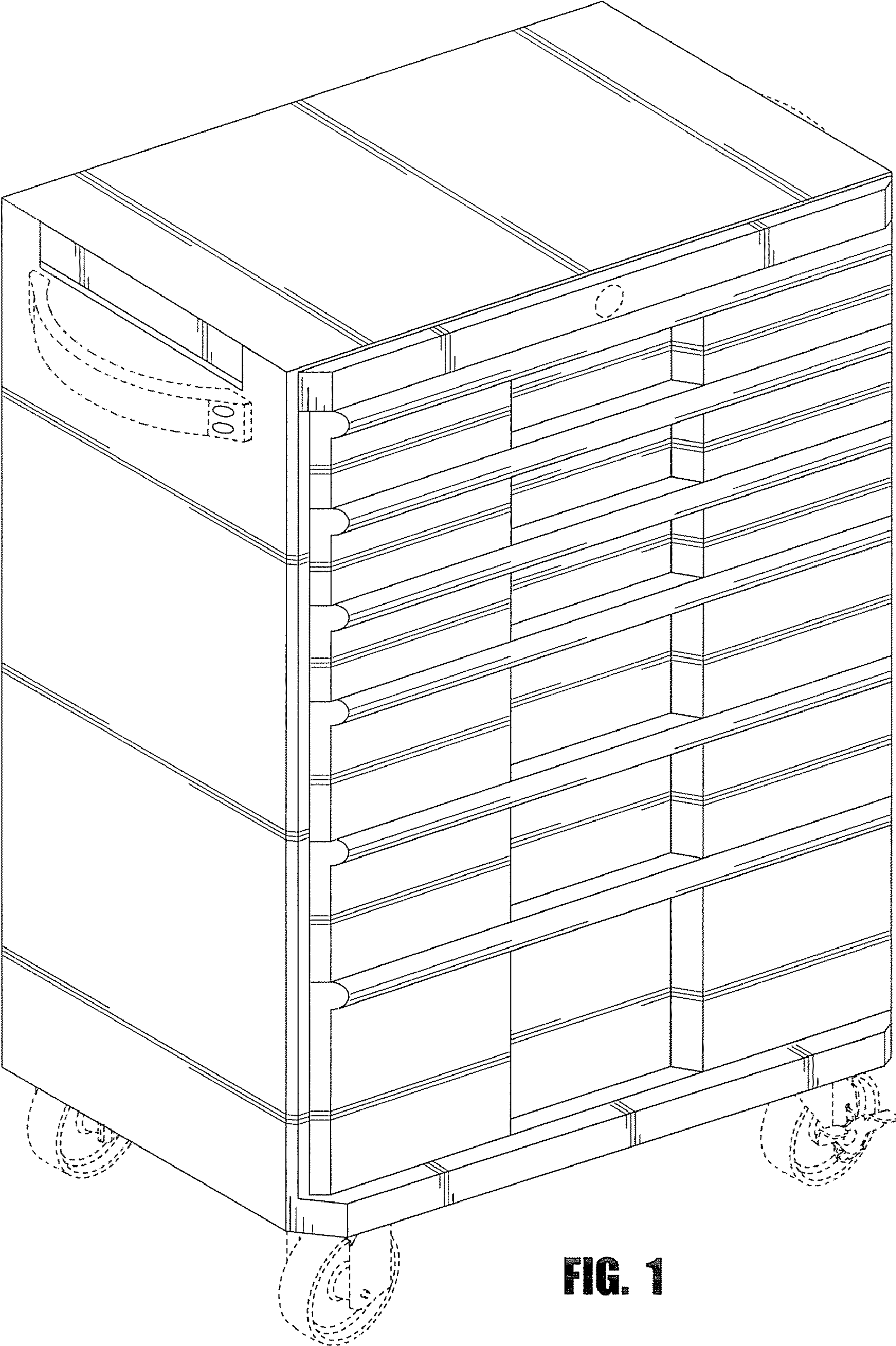
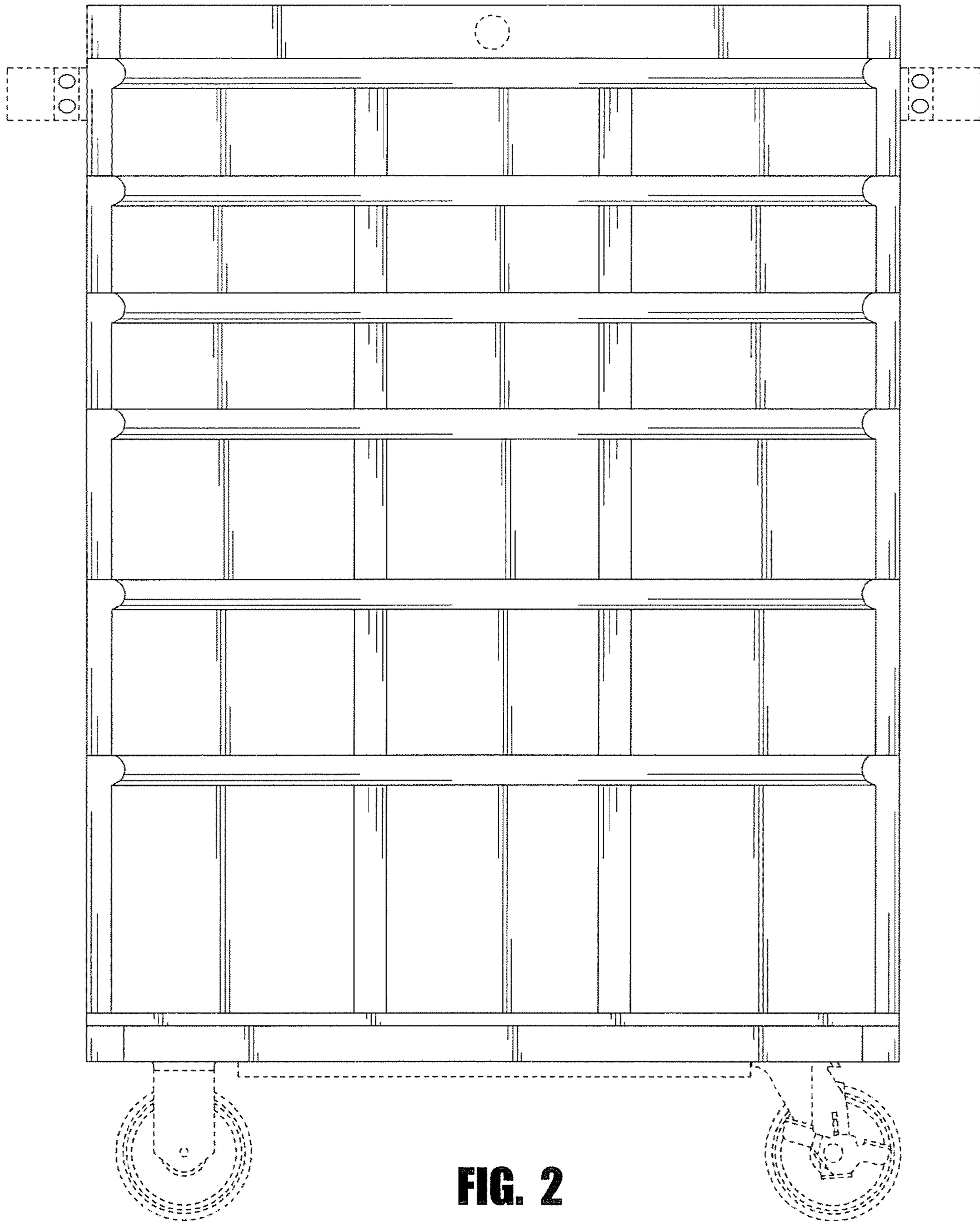
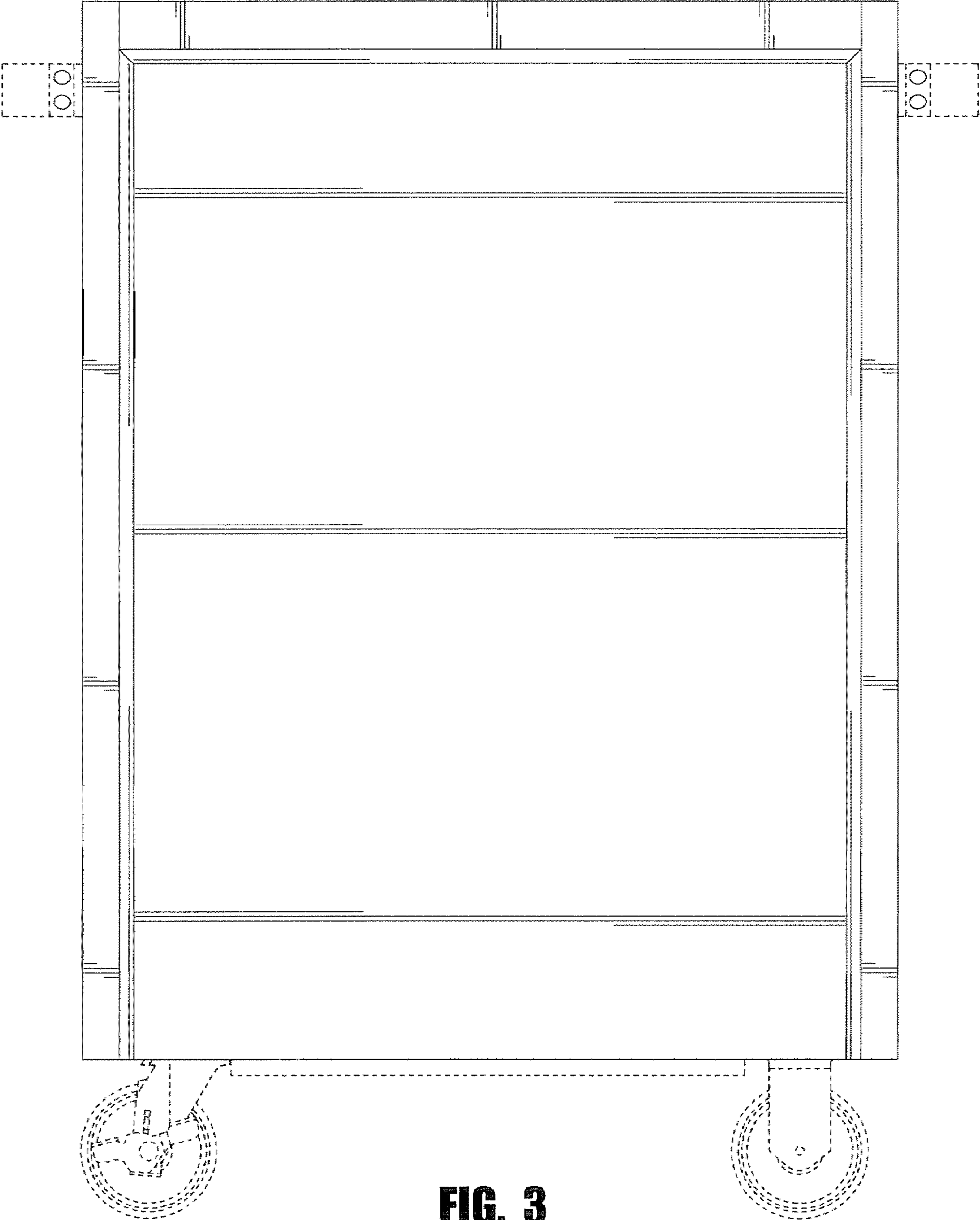


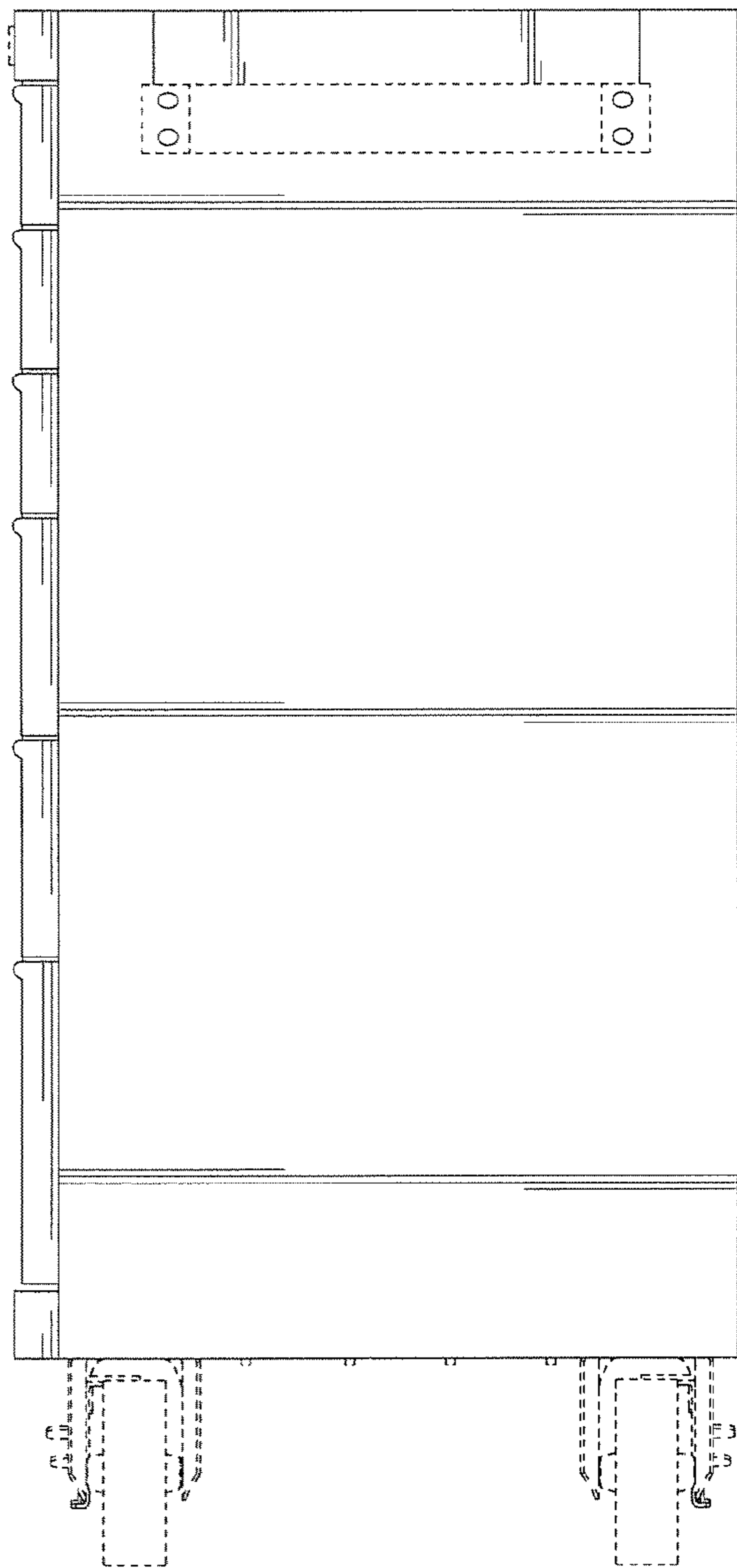

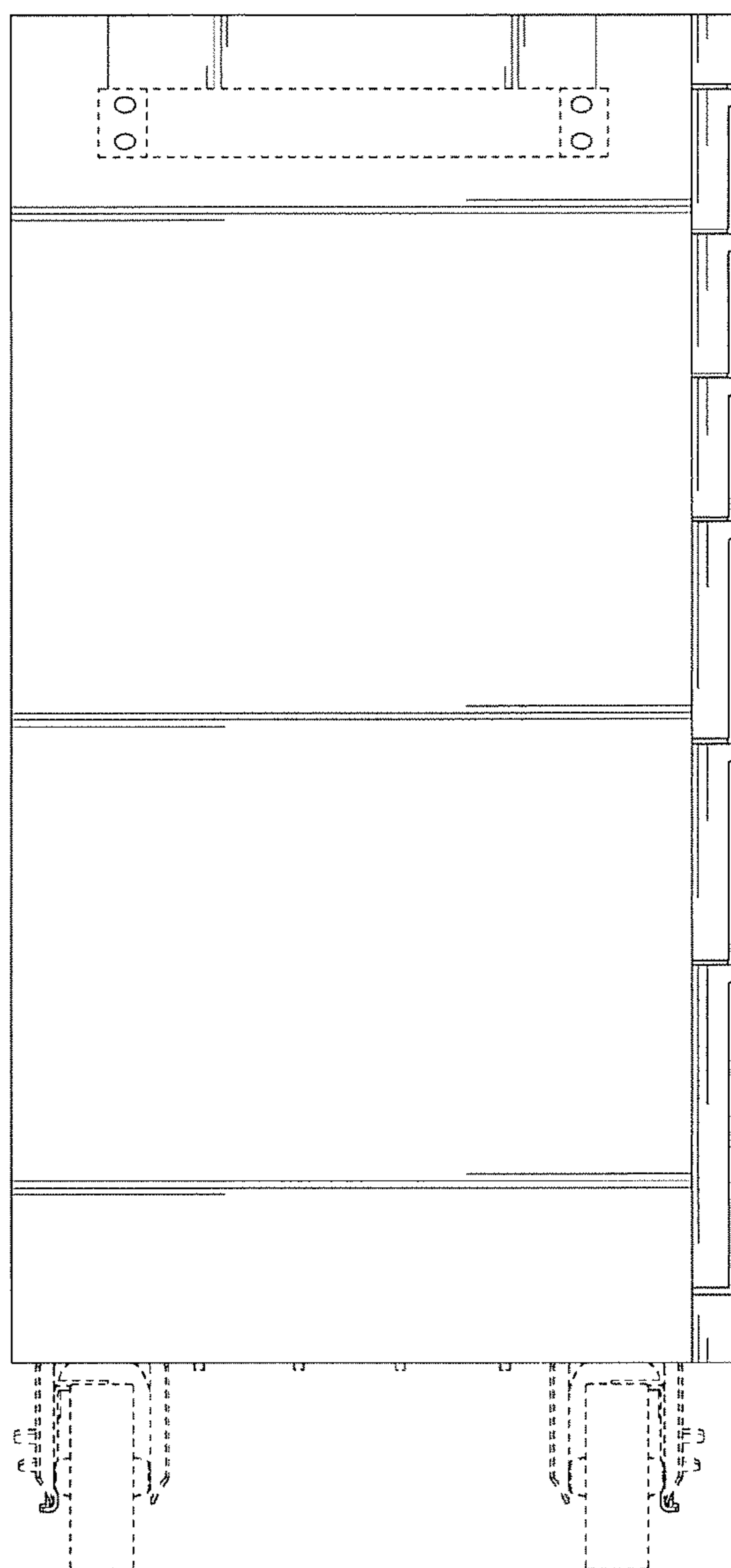

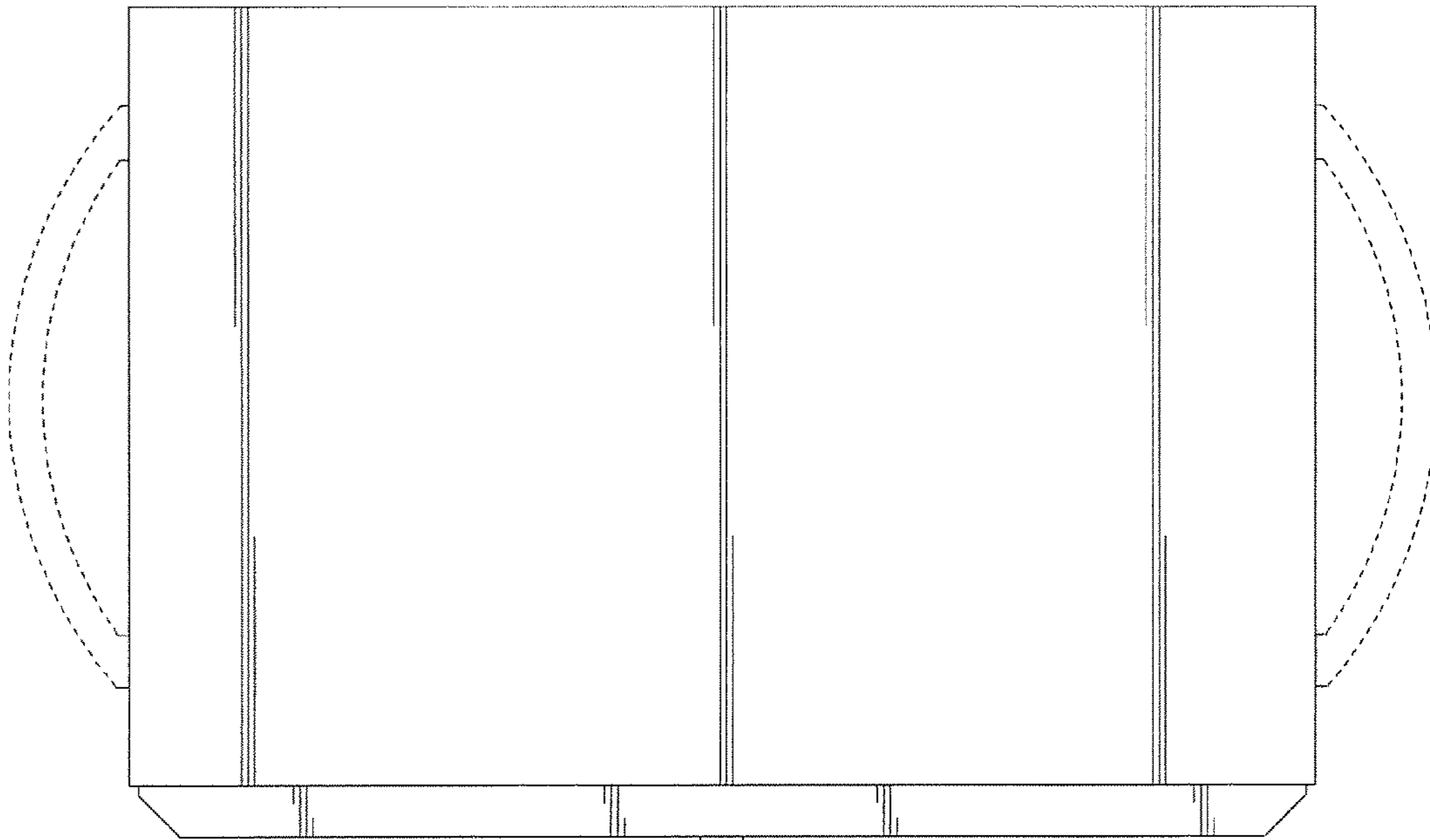

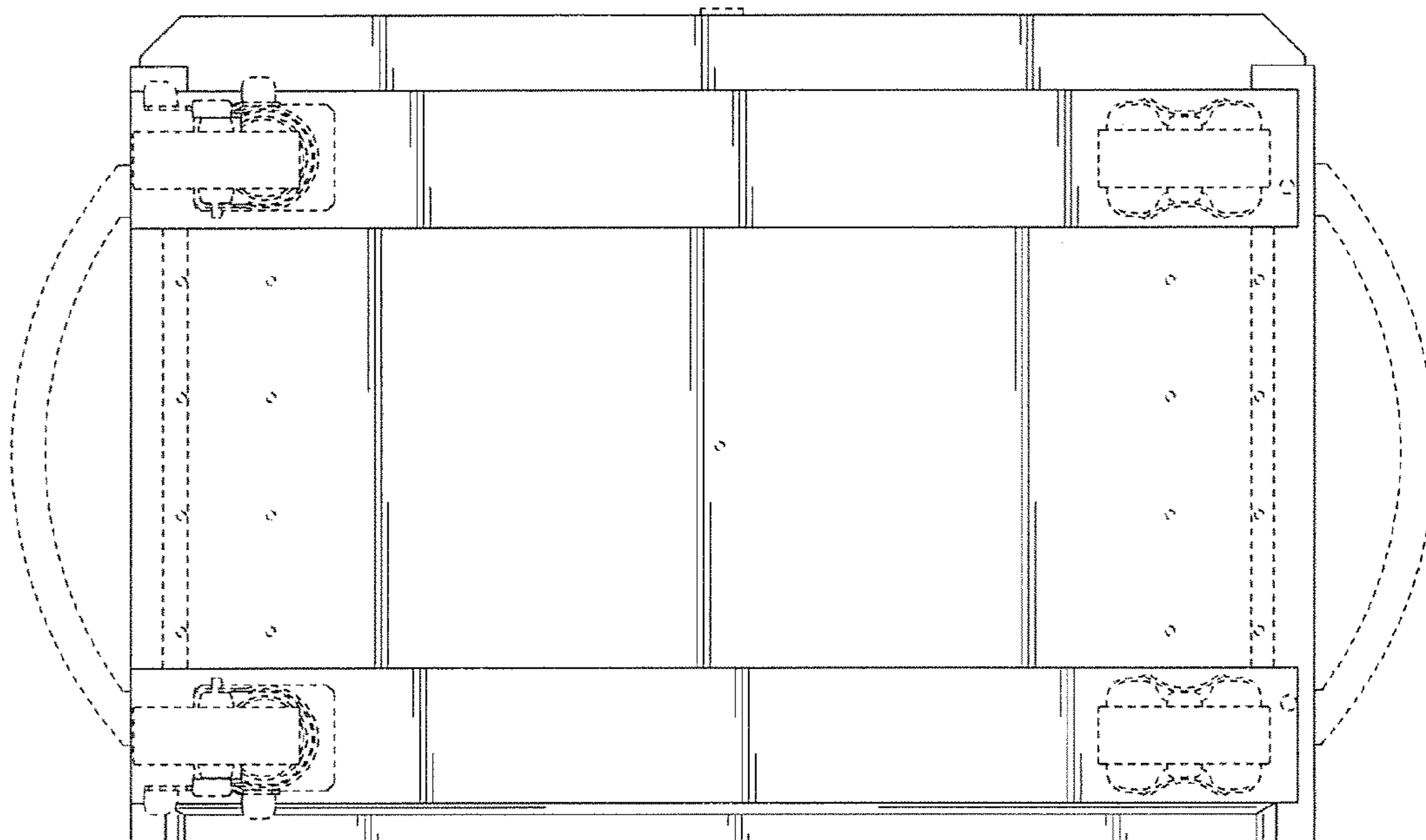
