FIG. 1 is a rear elevation view of a universal socket showing my new design;

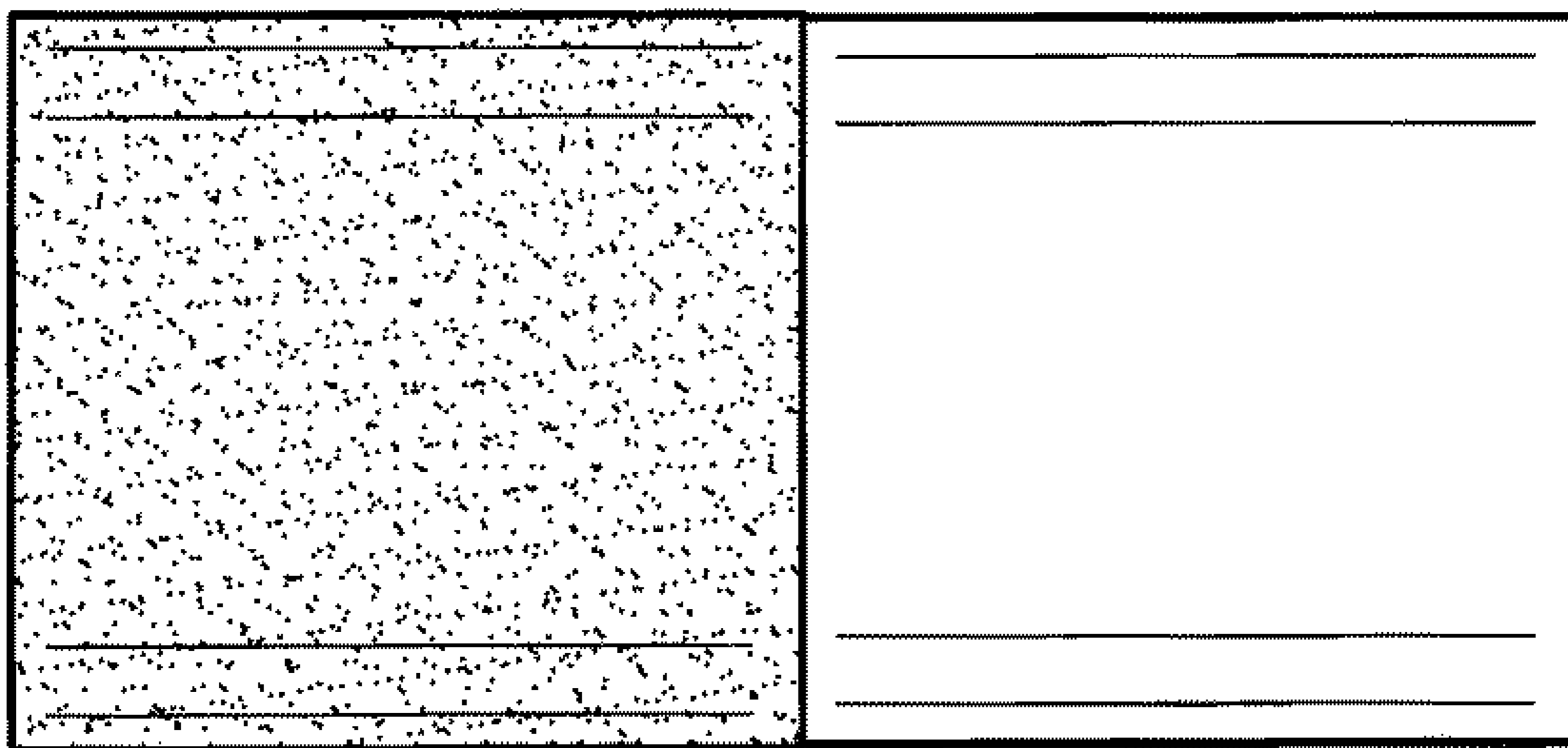
FIG. 2 is a right elevation view;

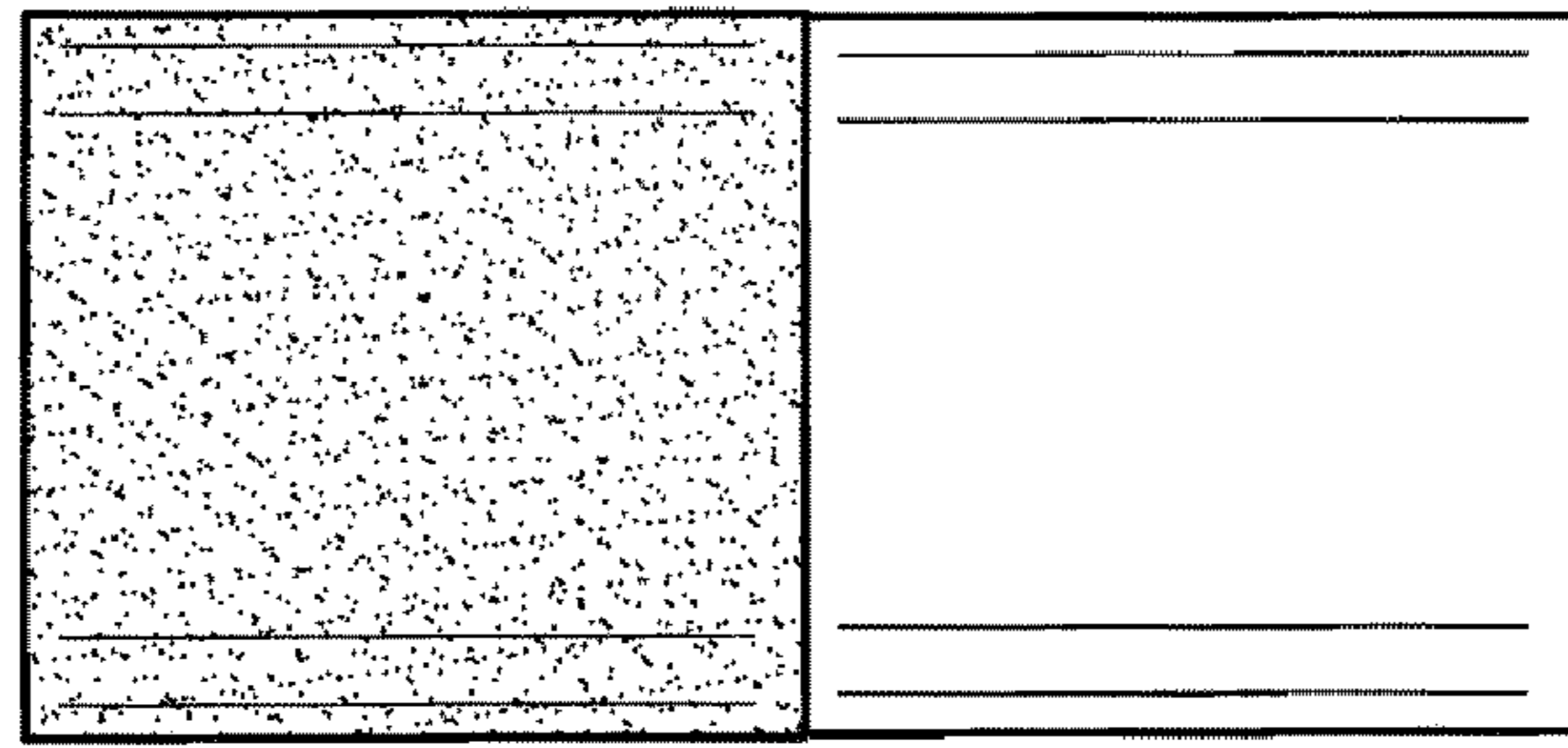

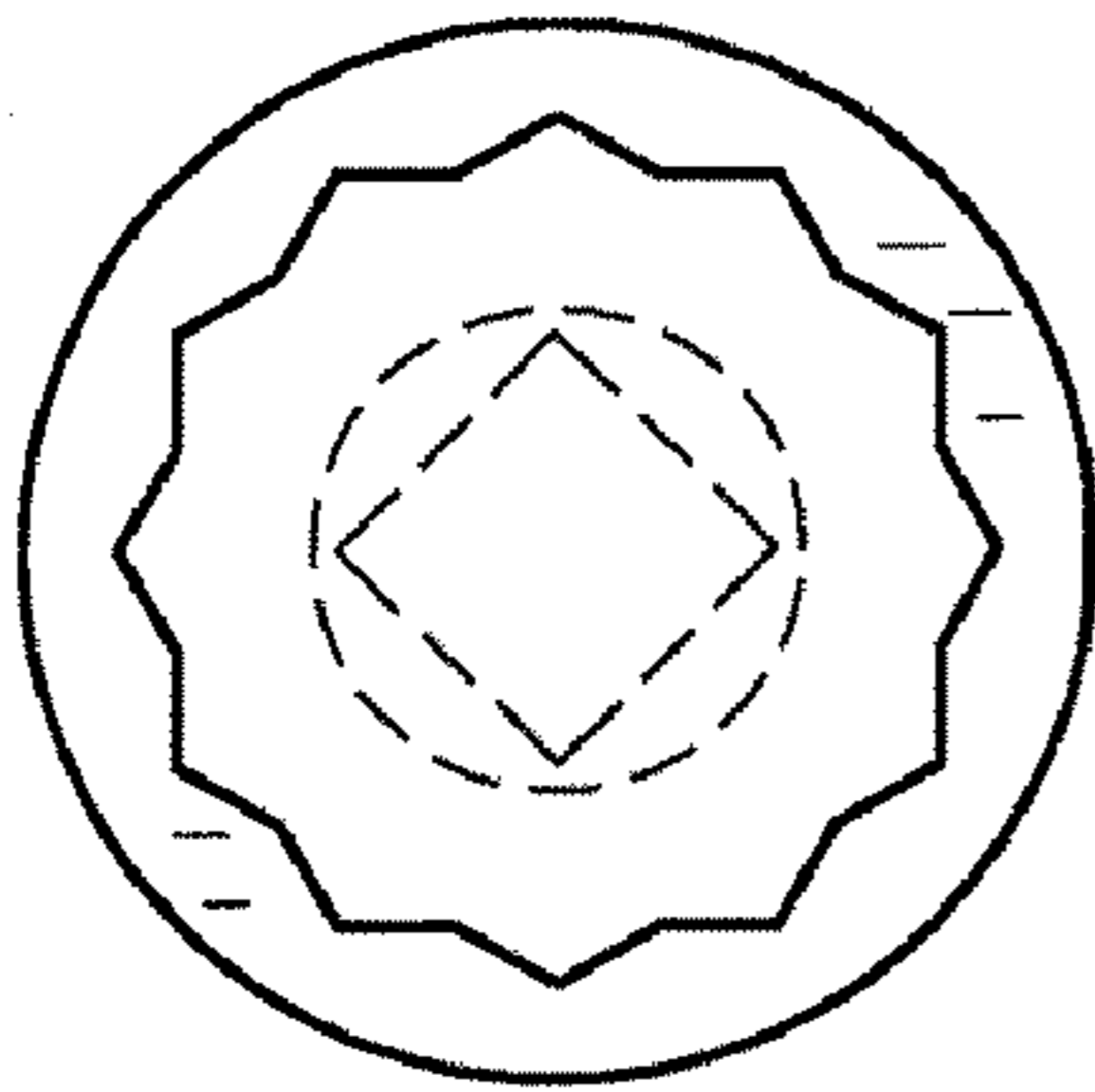

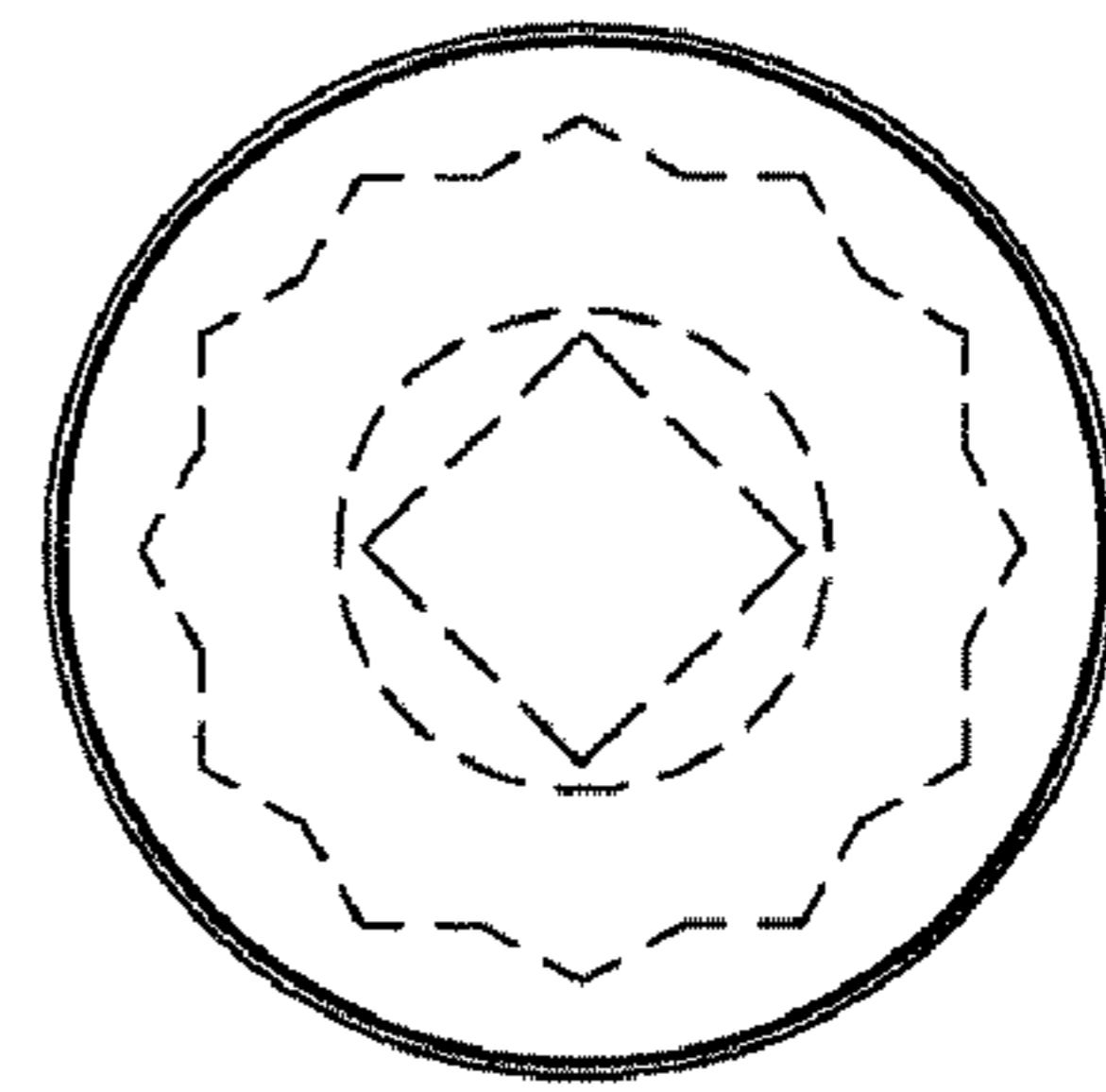

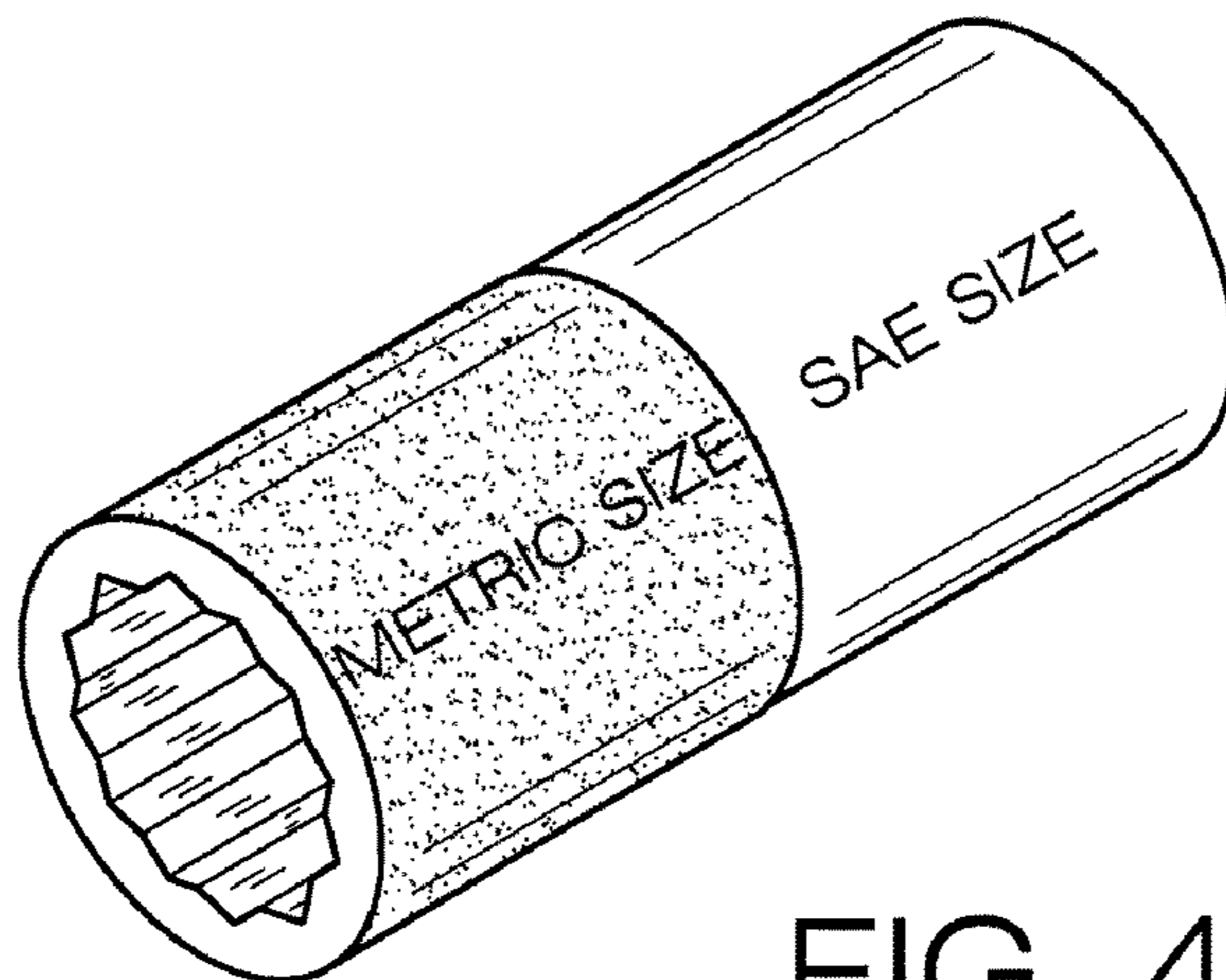
