FIG. 2 is another perspective view of my design from a different angle;

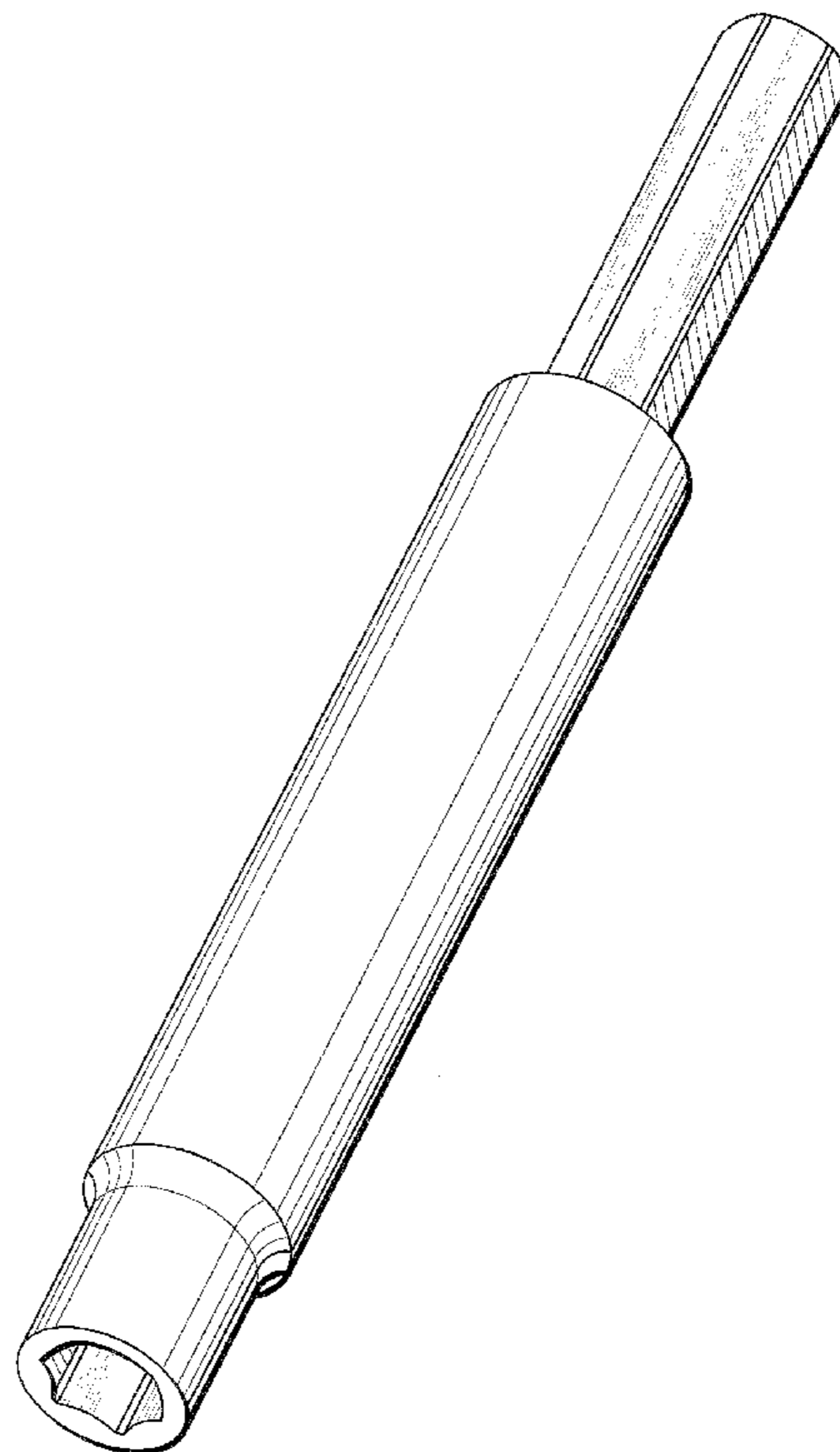
FIG. 3 is a side view of my design, the opposite side view being a mirror image thereof;

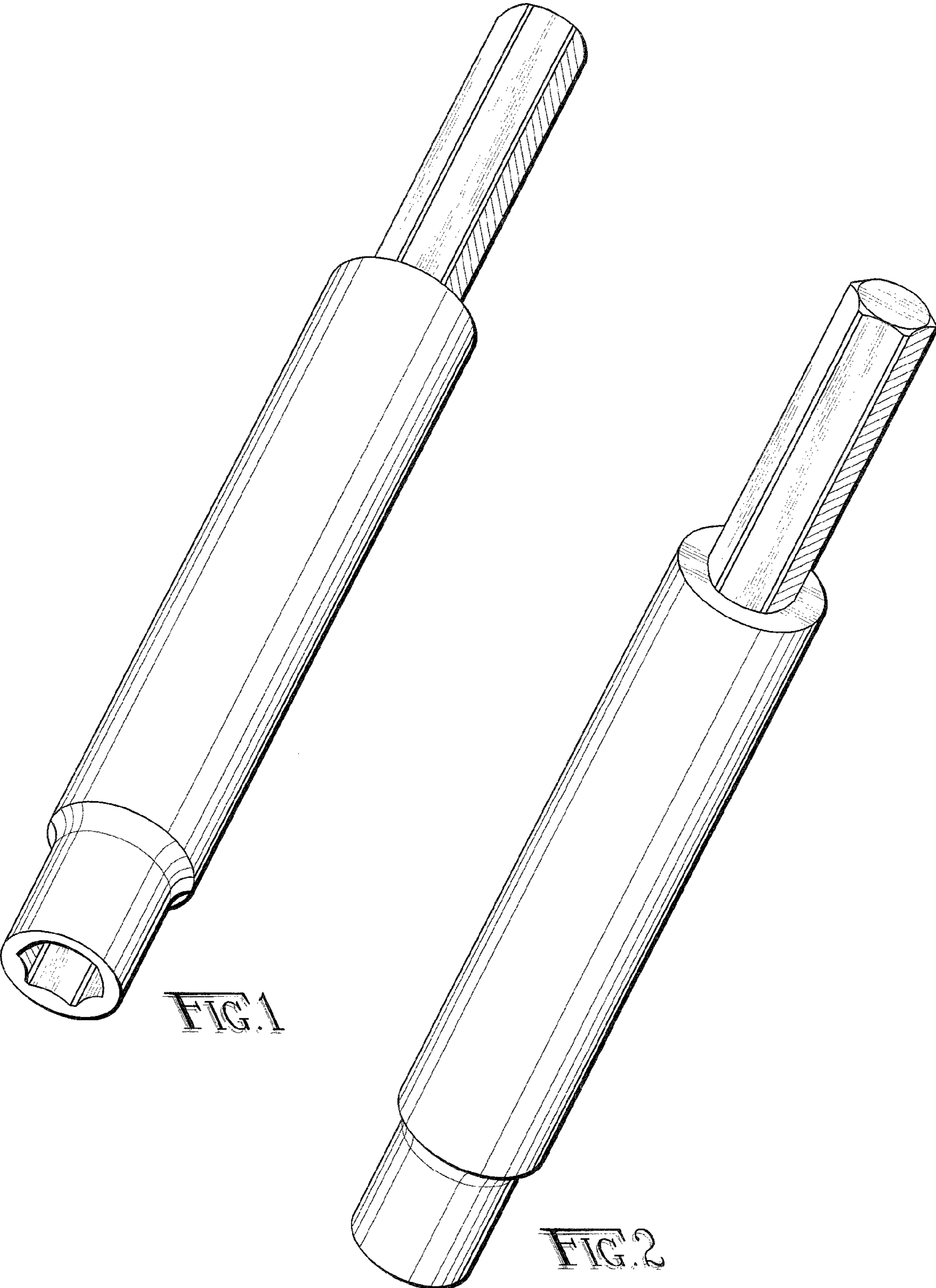
FIG. 4 is a front view of my design;

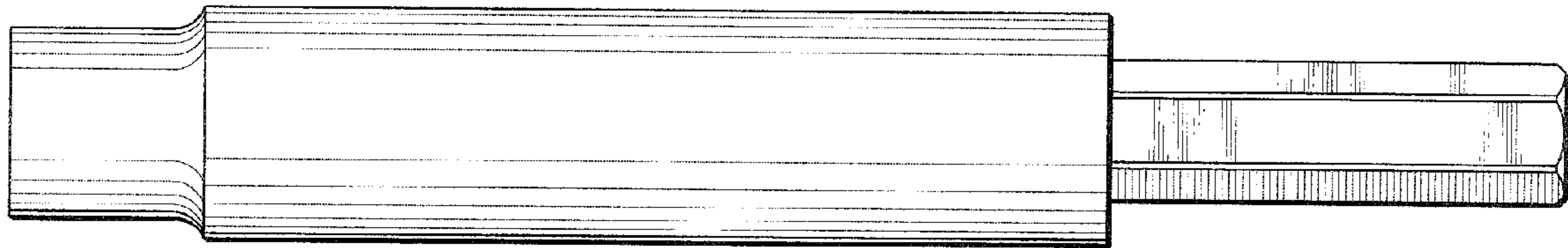

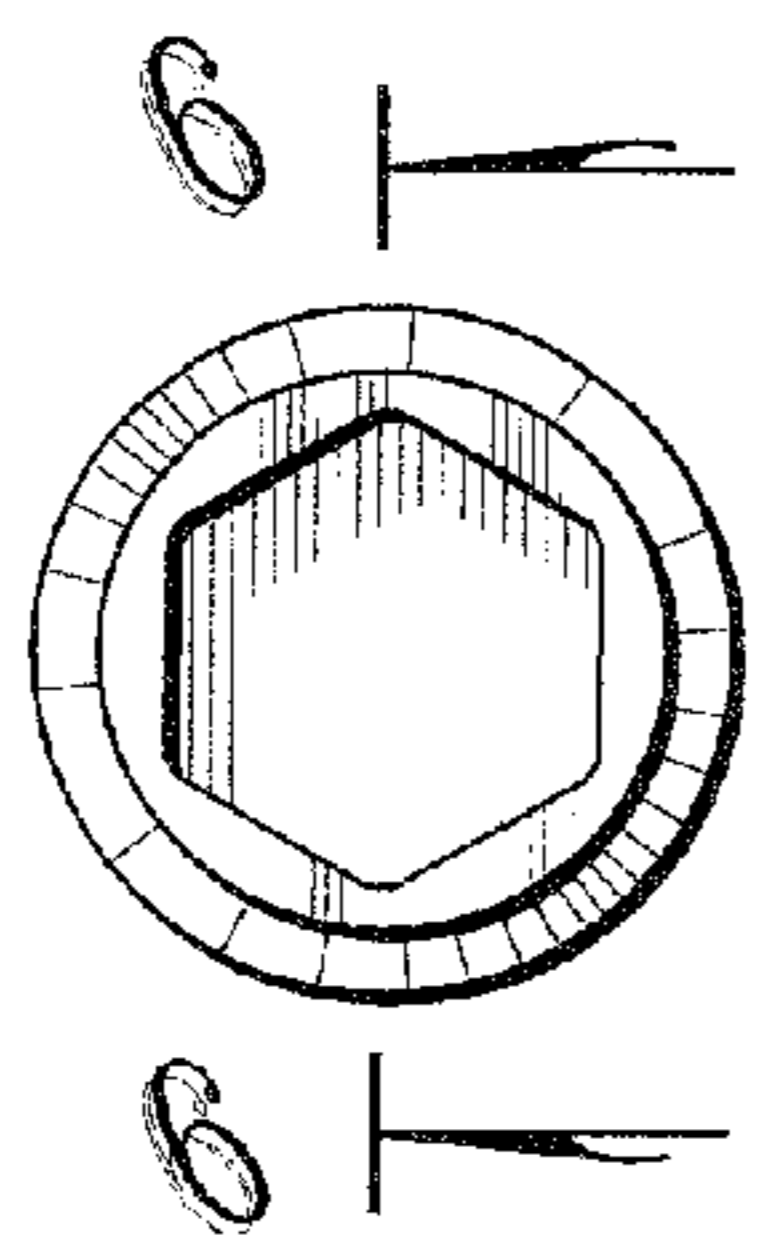

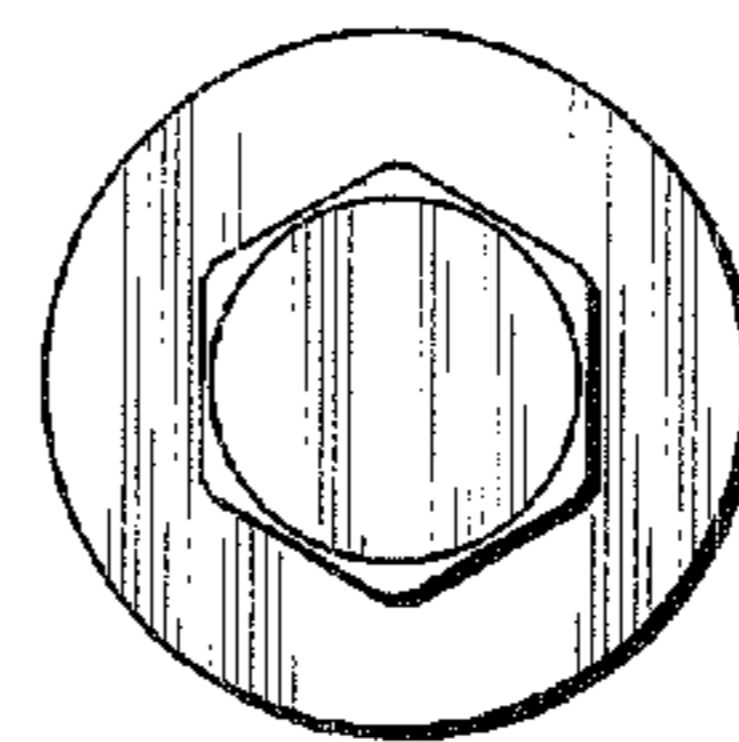

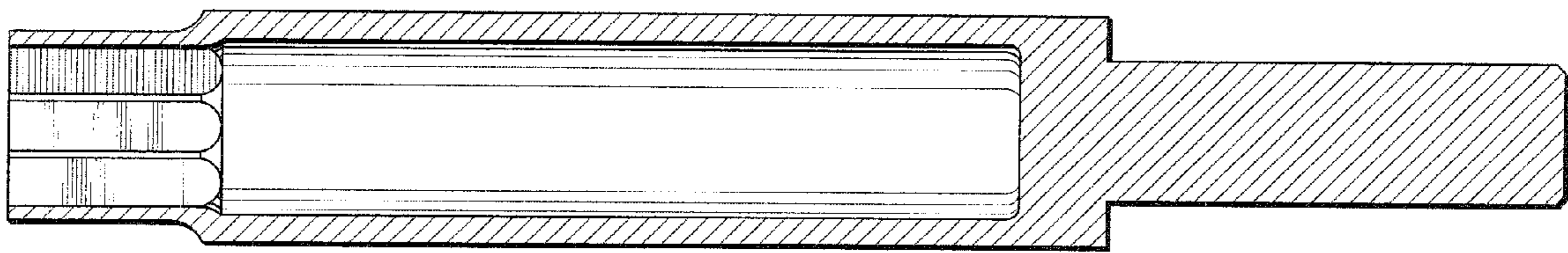
