FIG. 2 is a second perspective view thereof;

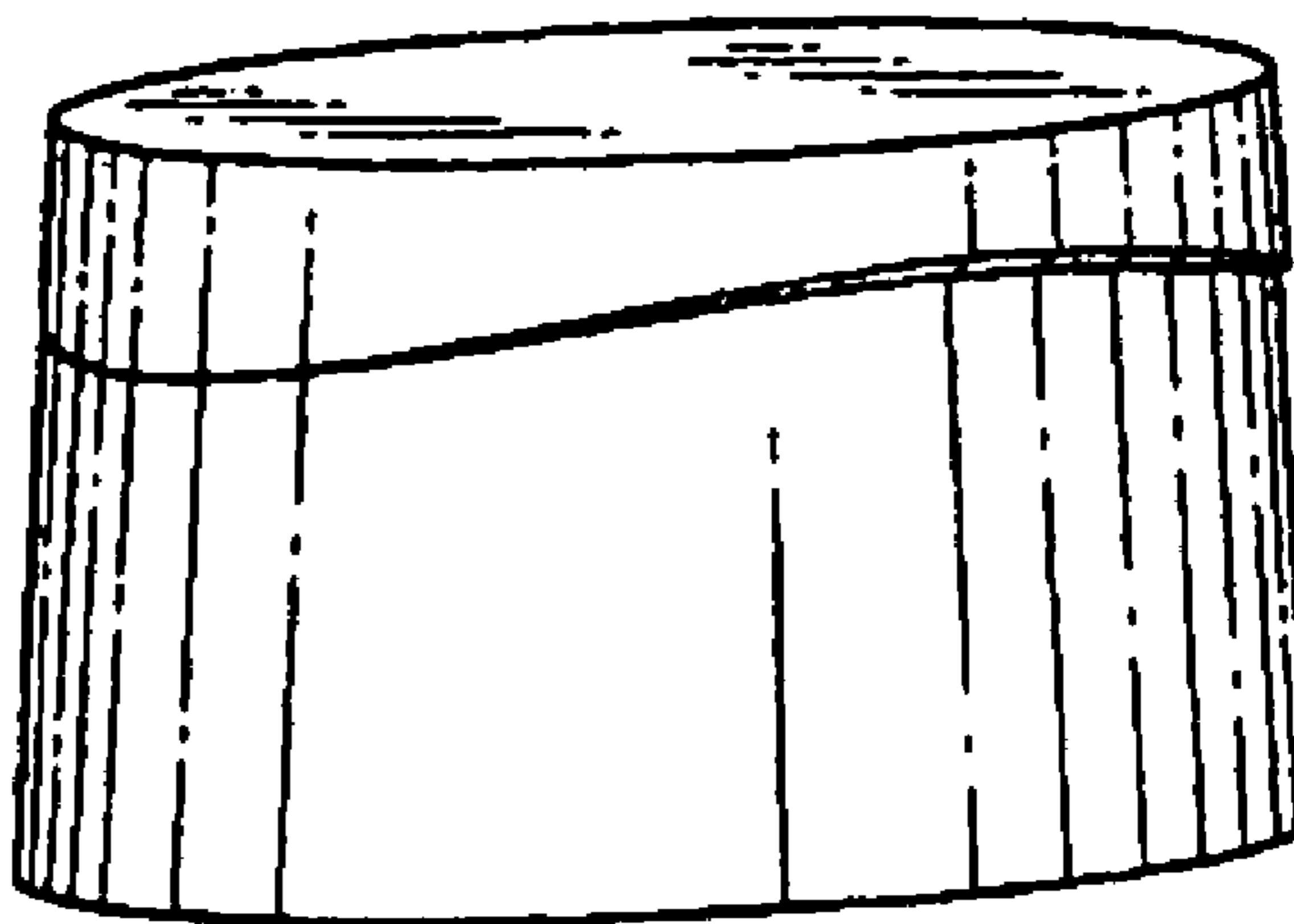
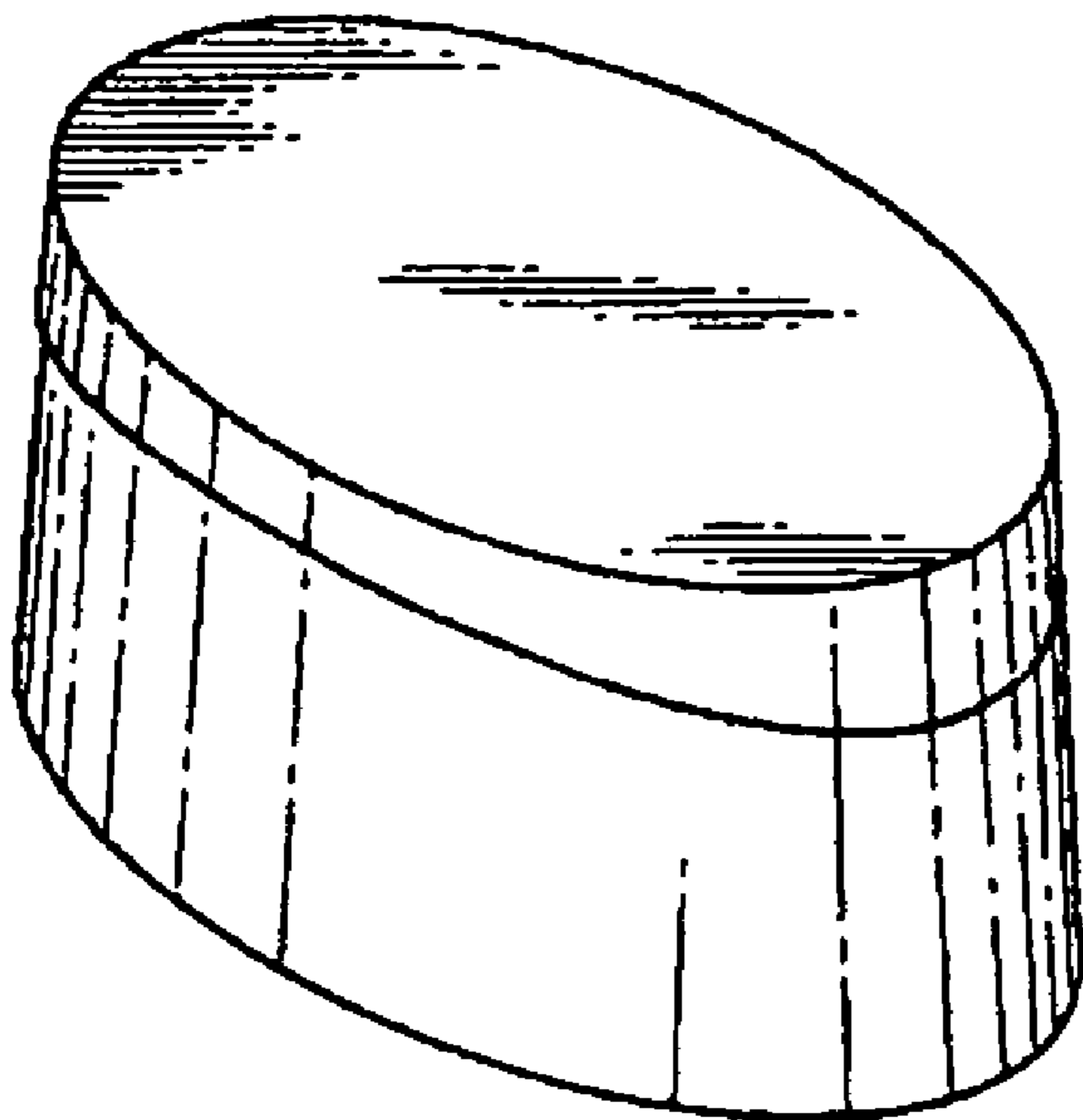
FIG. 3 is a front elevational view thereof;

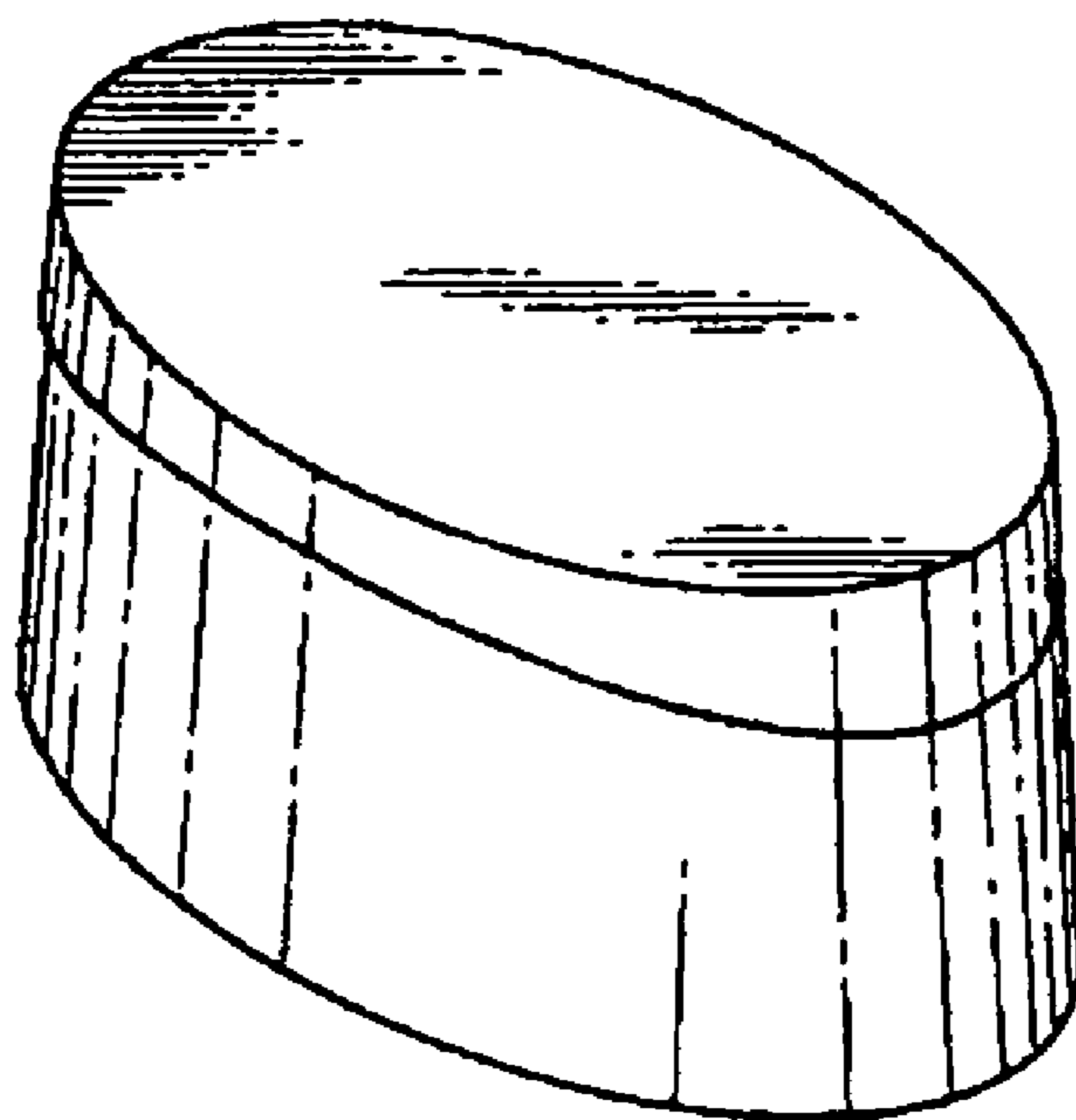

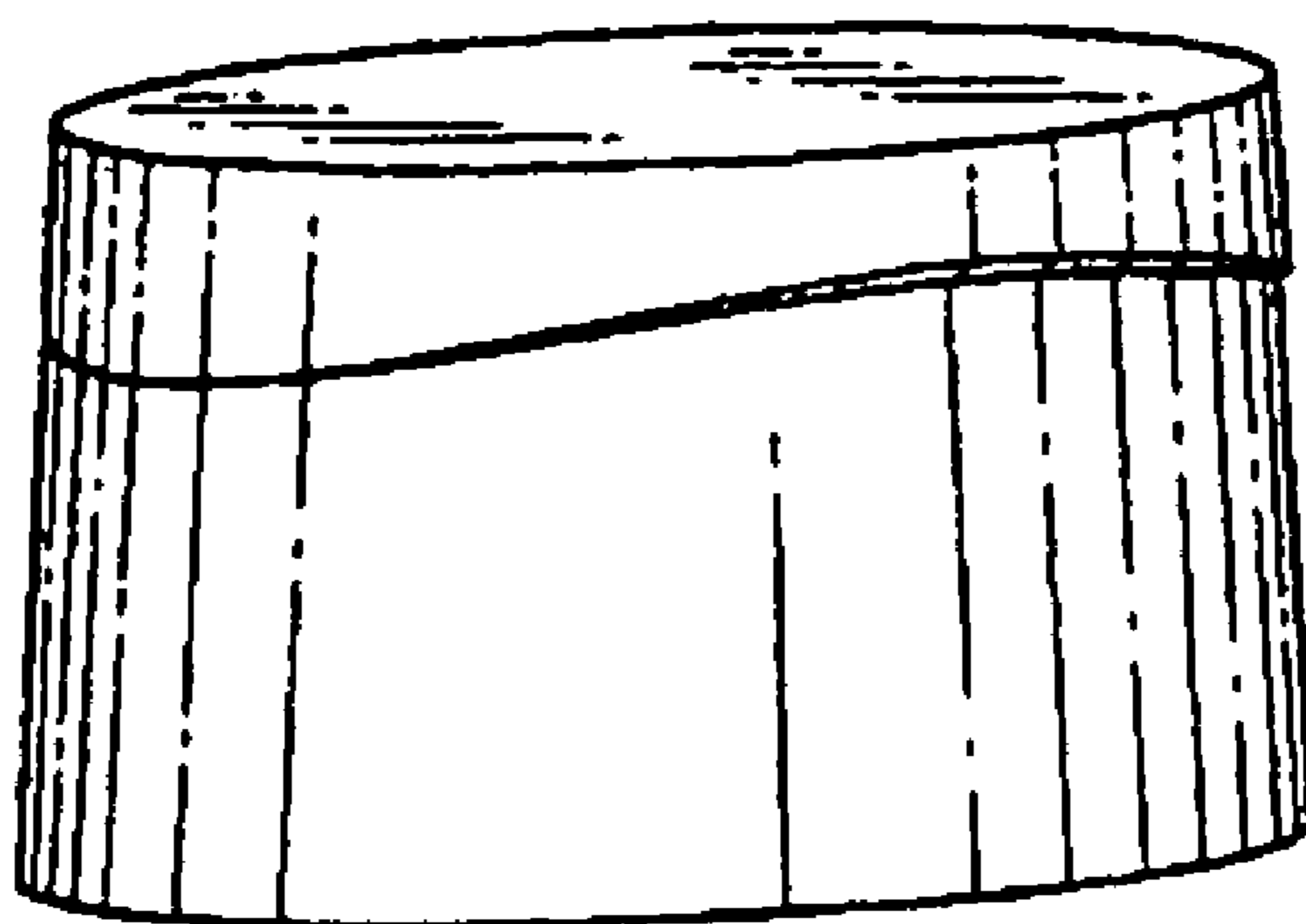

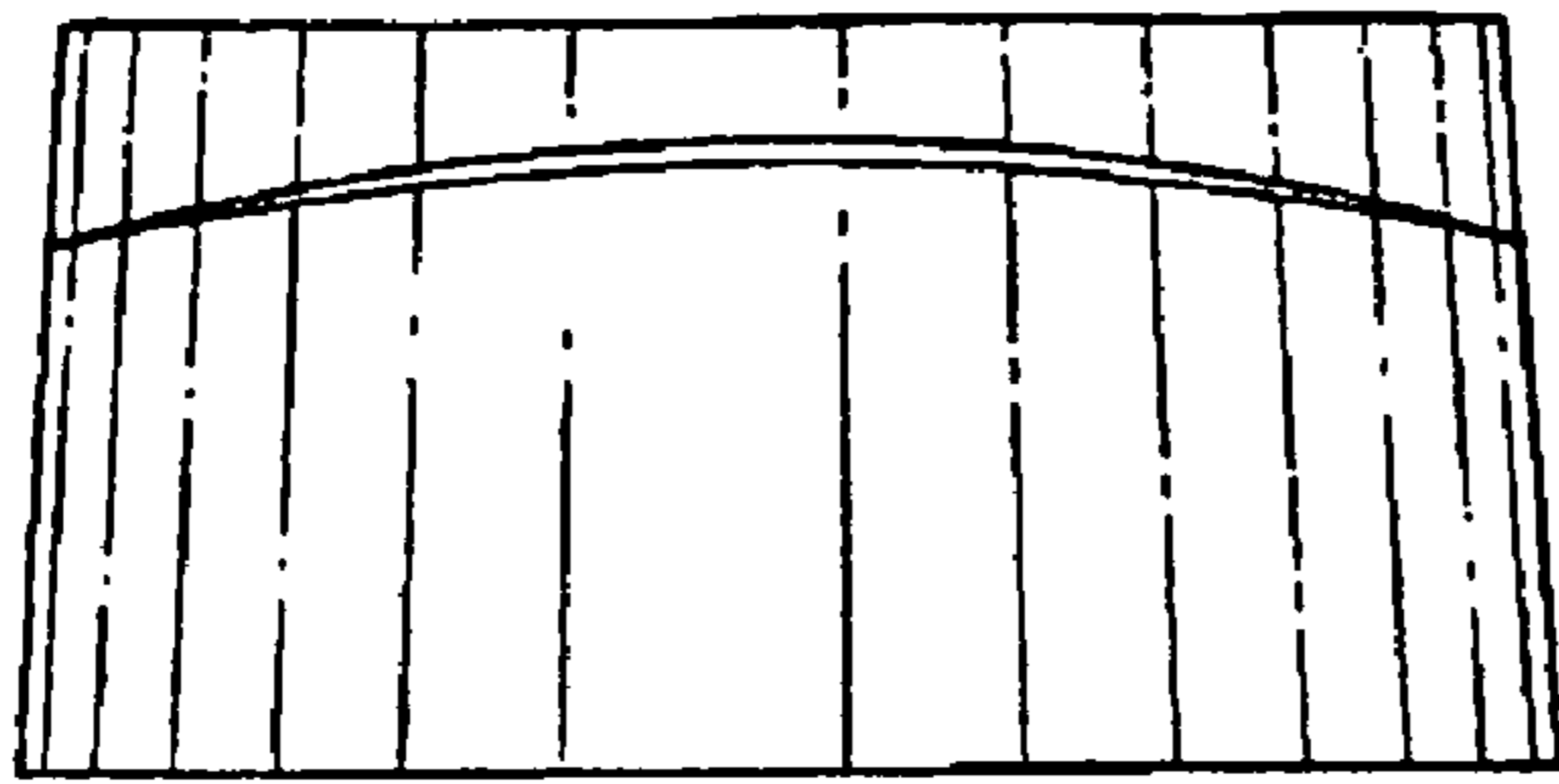

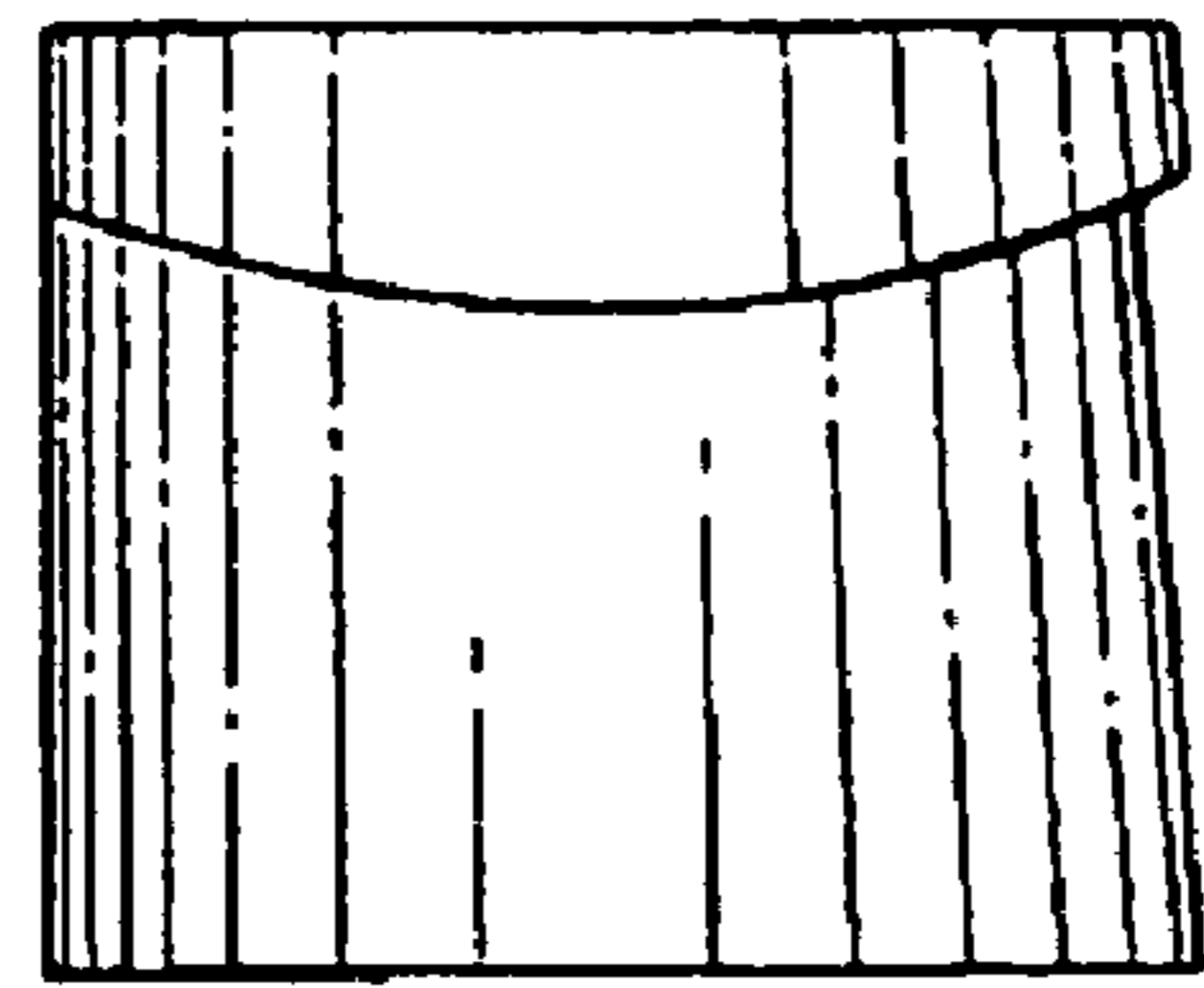

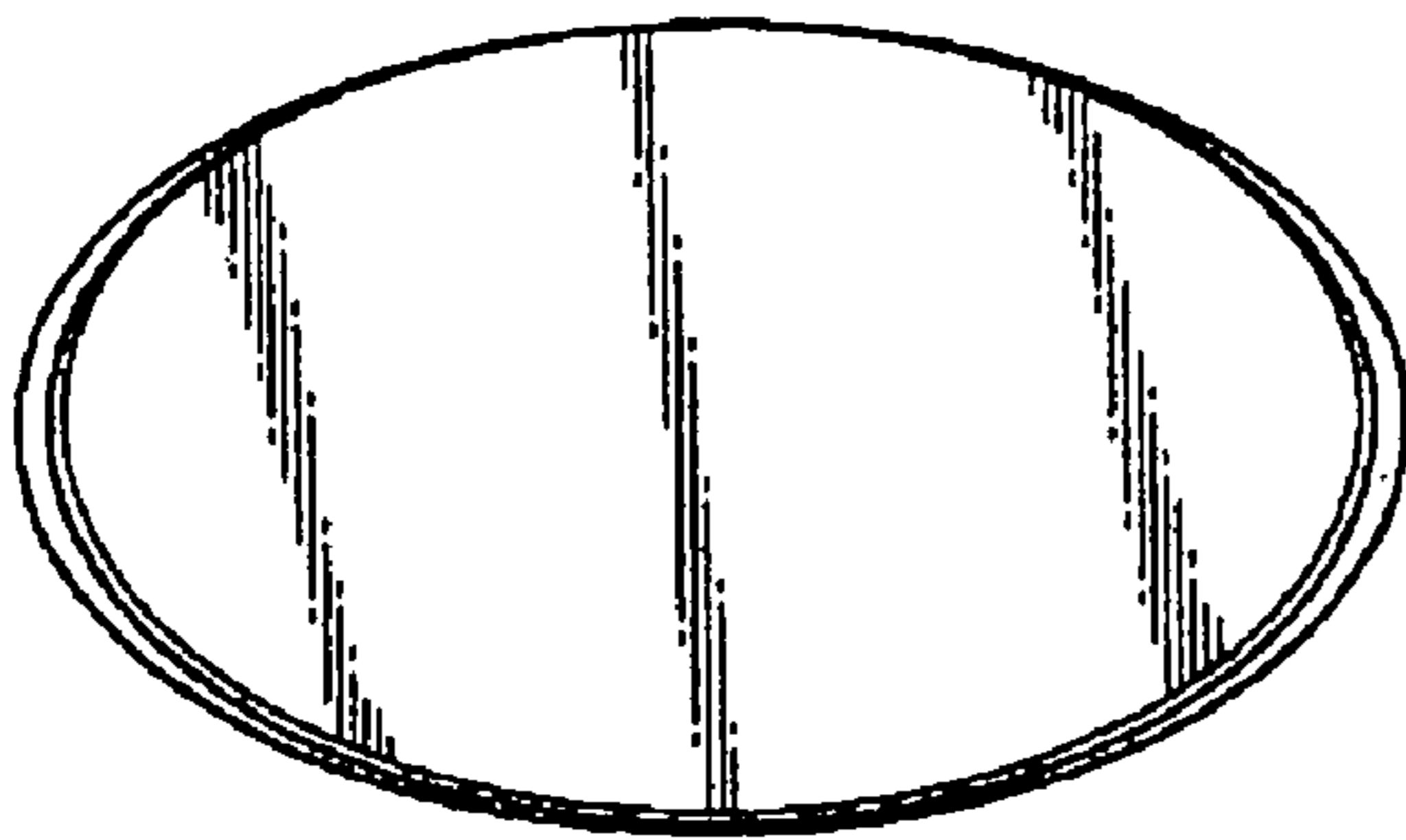

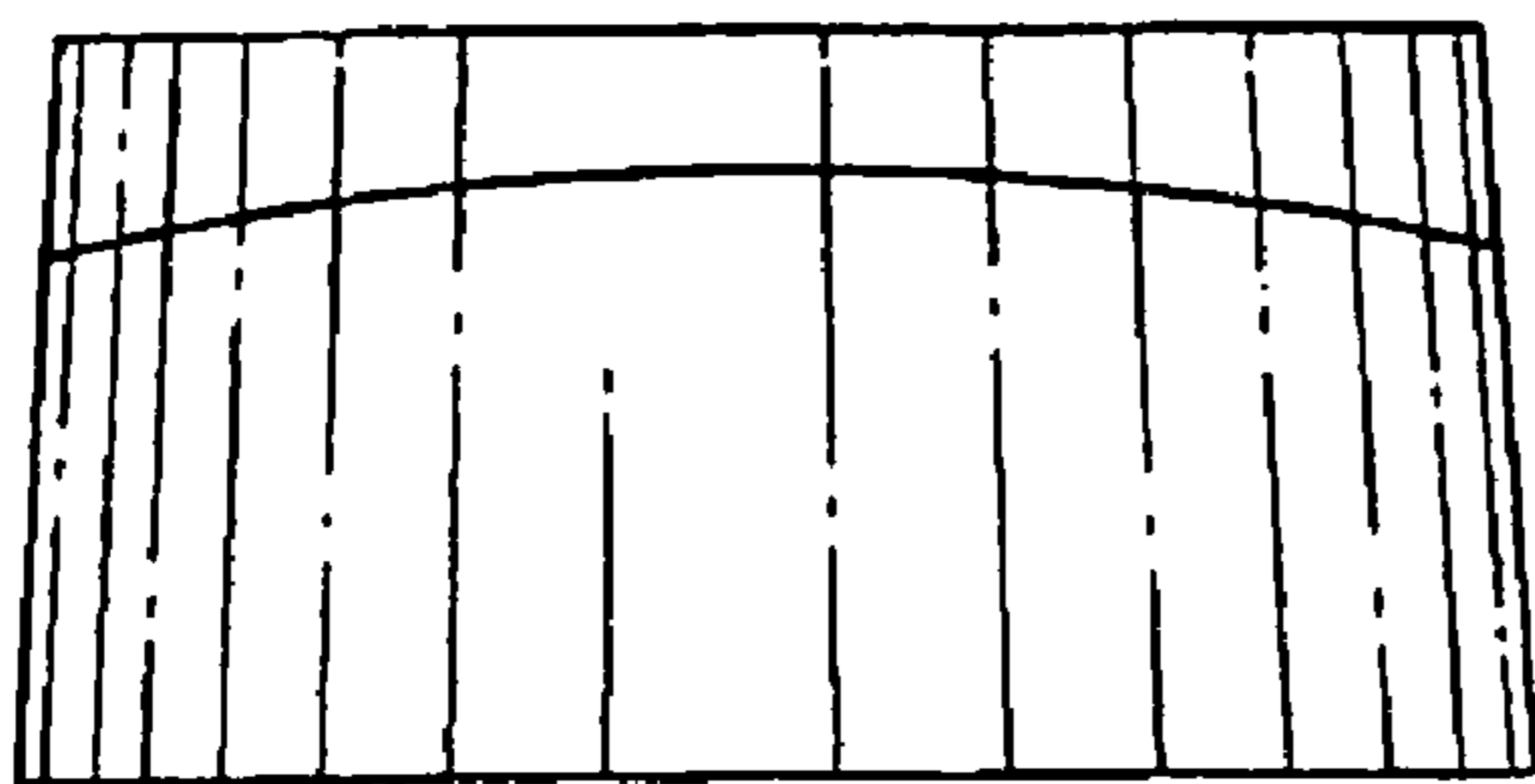
