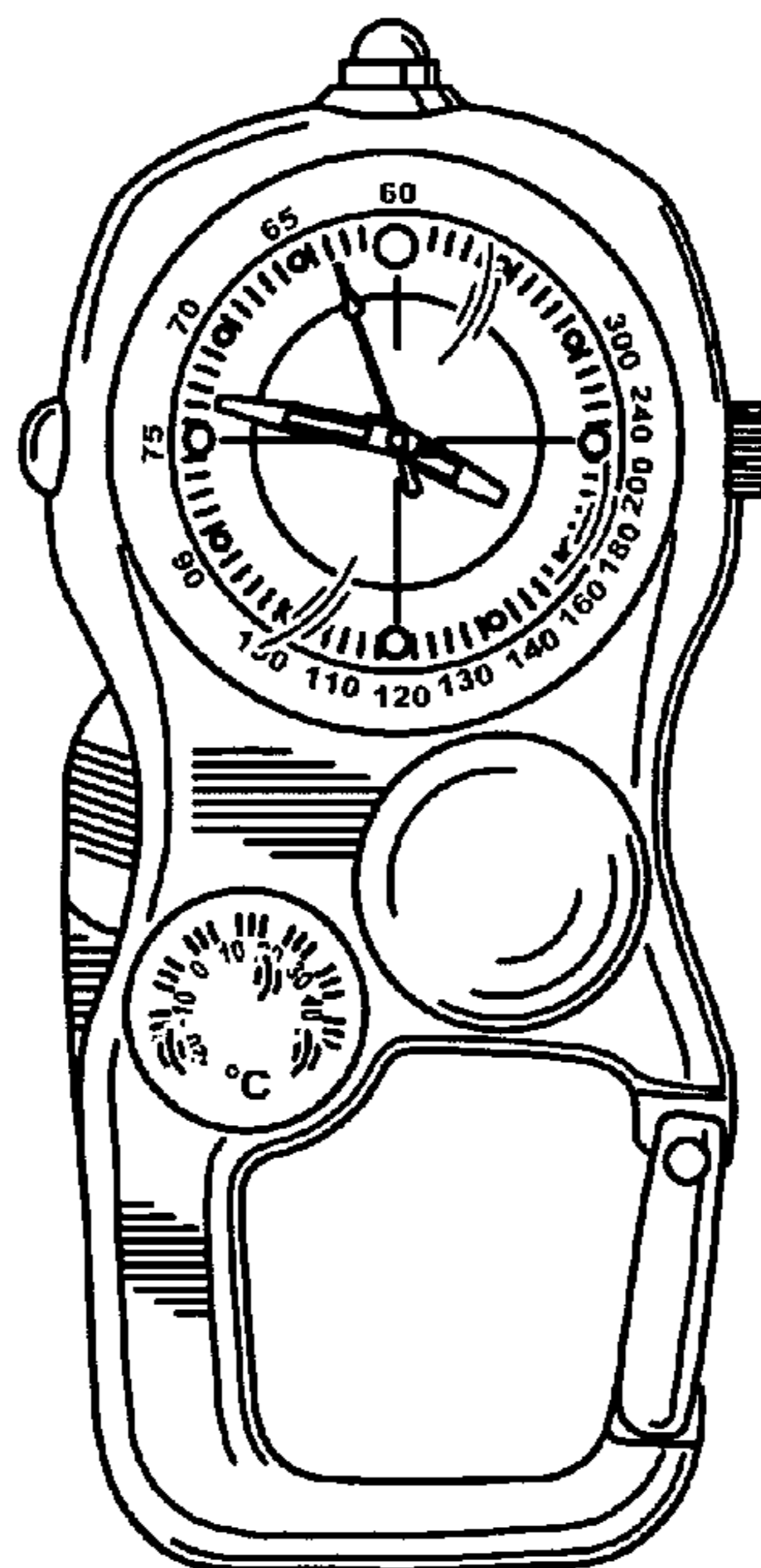
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is an upper front perspective view of the carabineer style pocket watch;

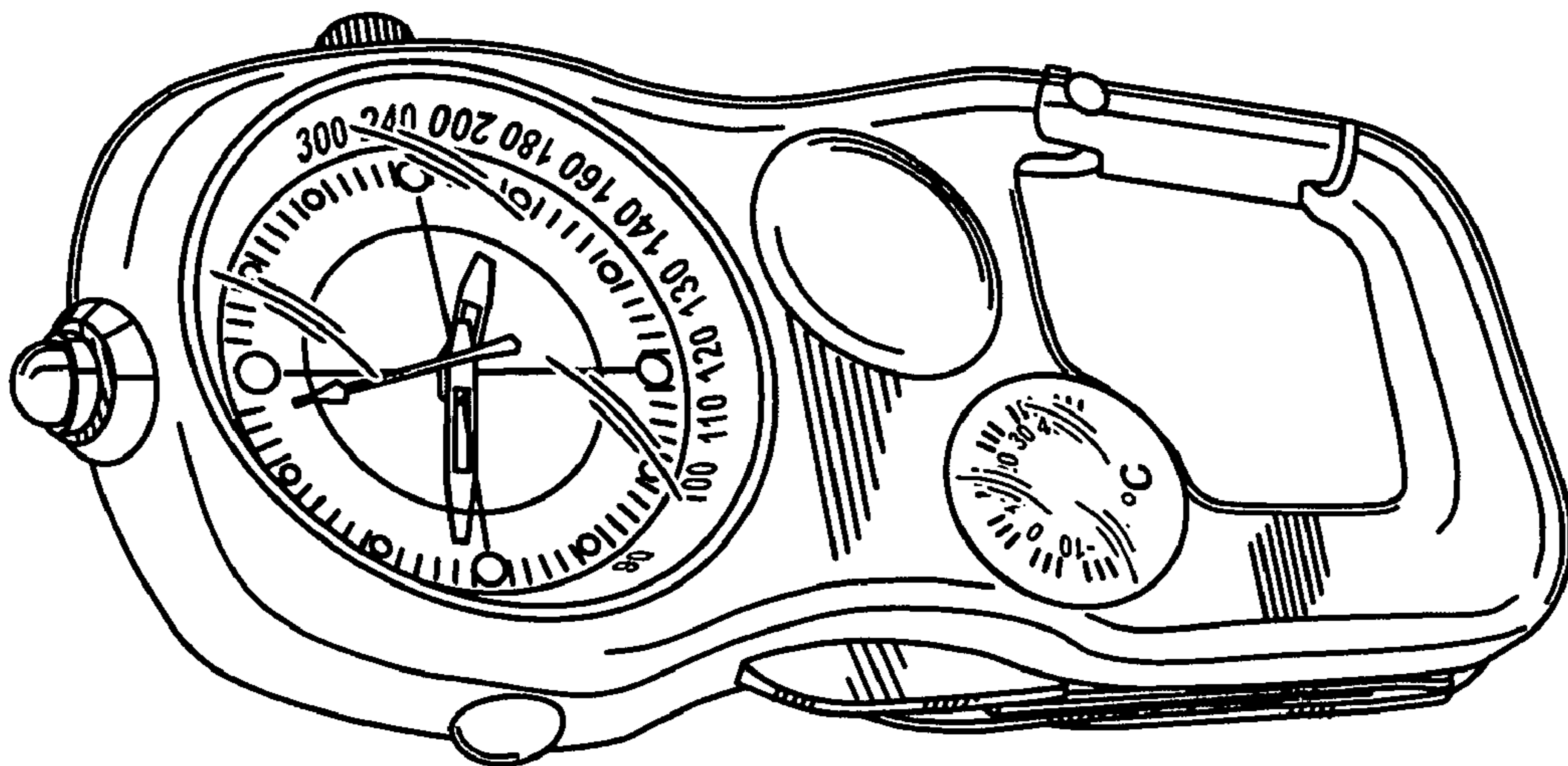

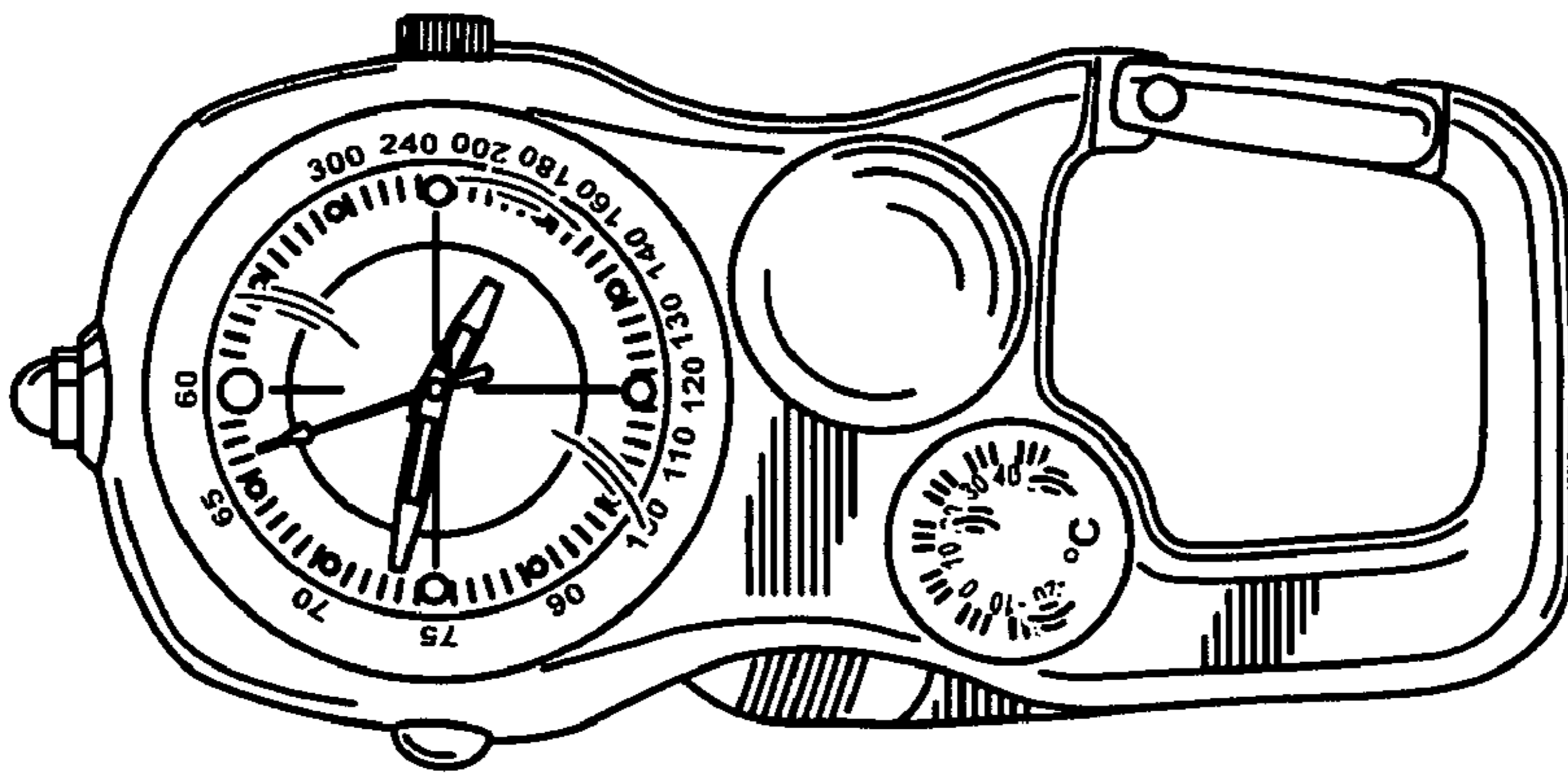

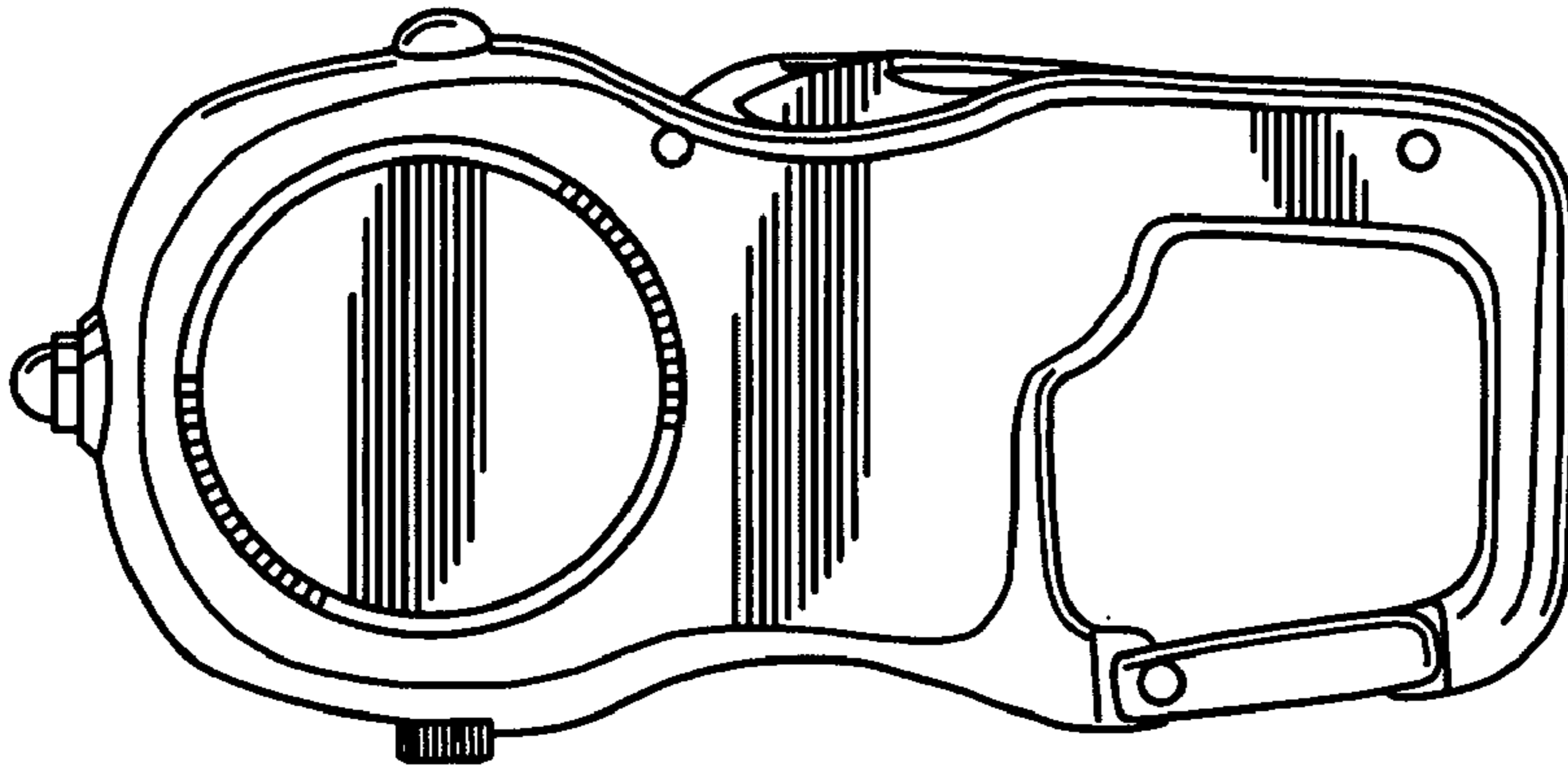

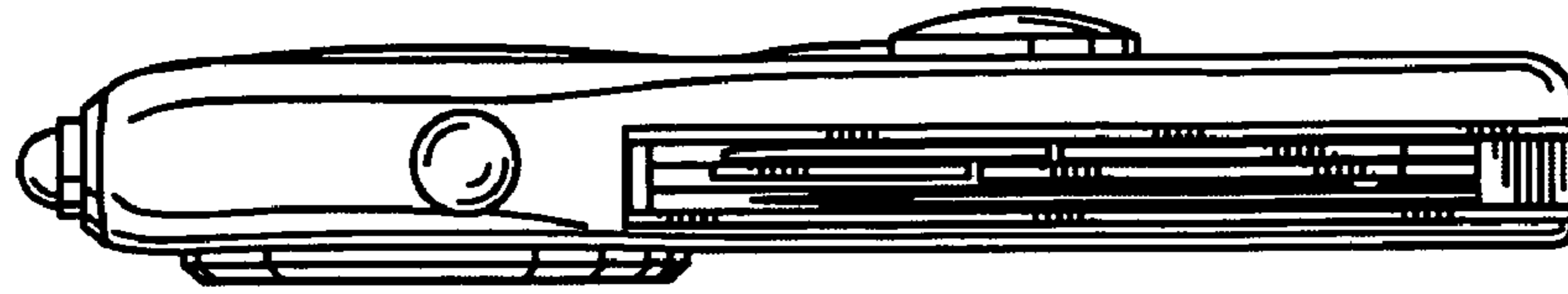

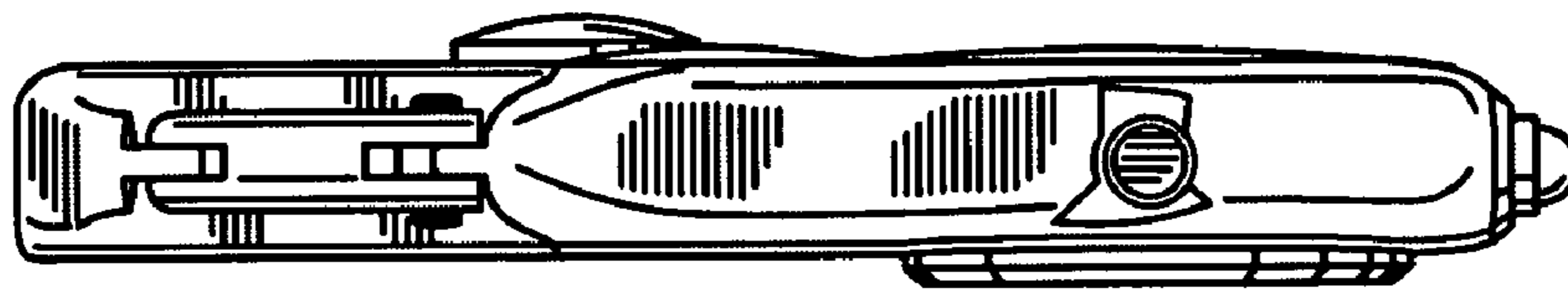

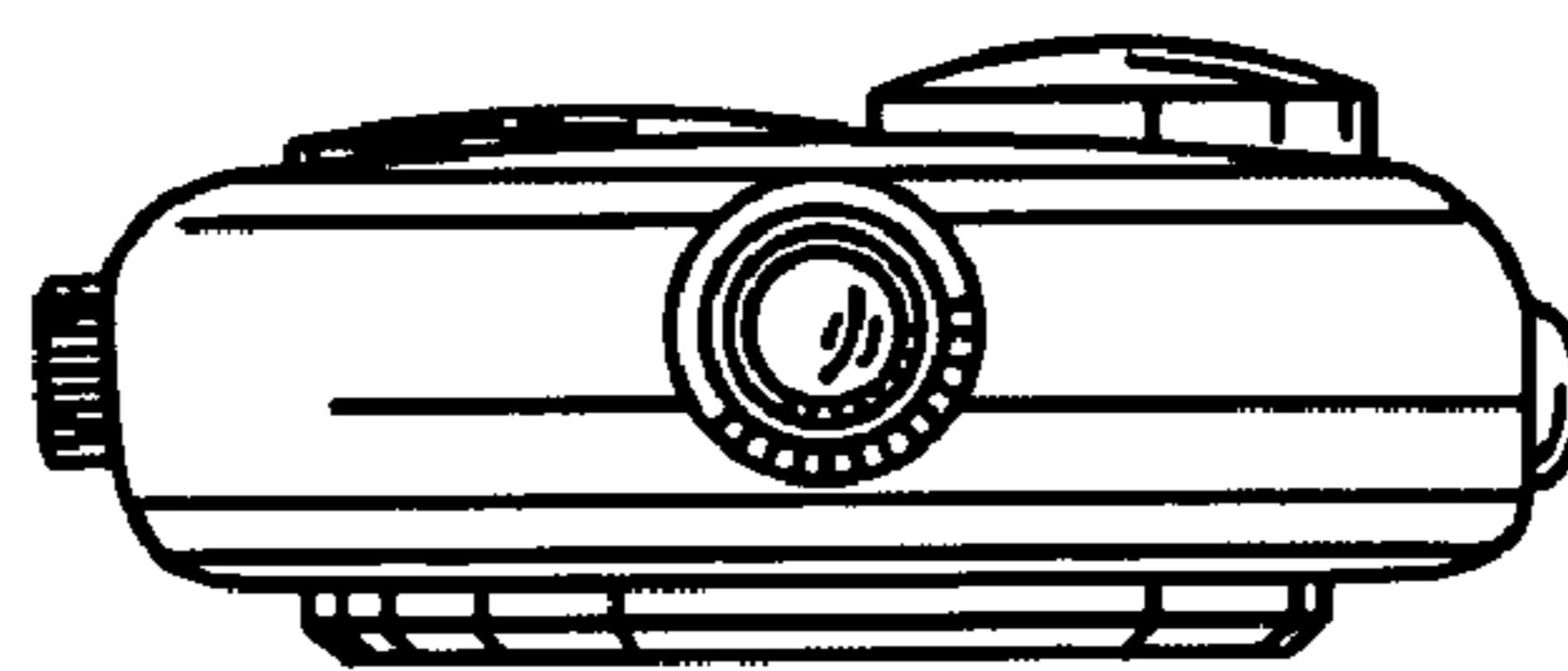

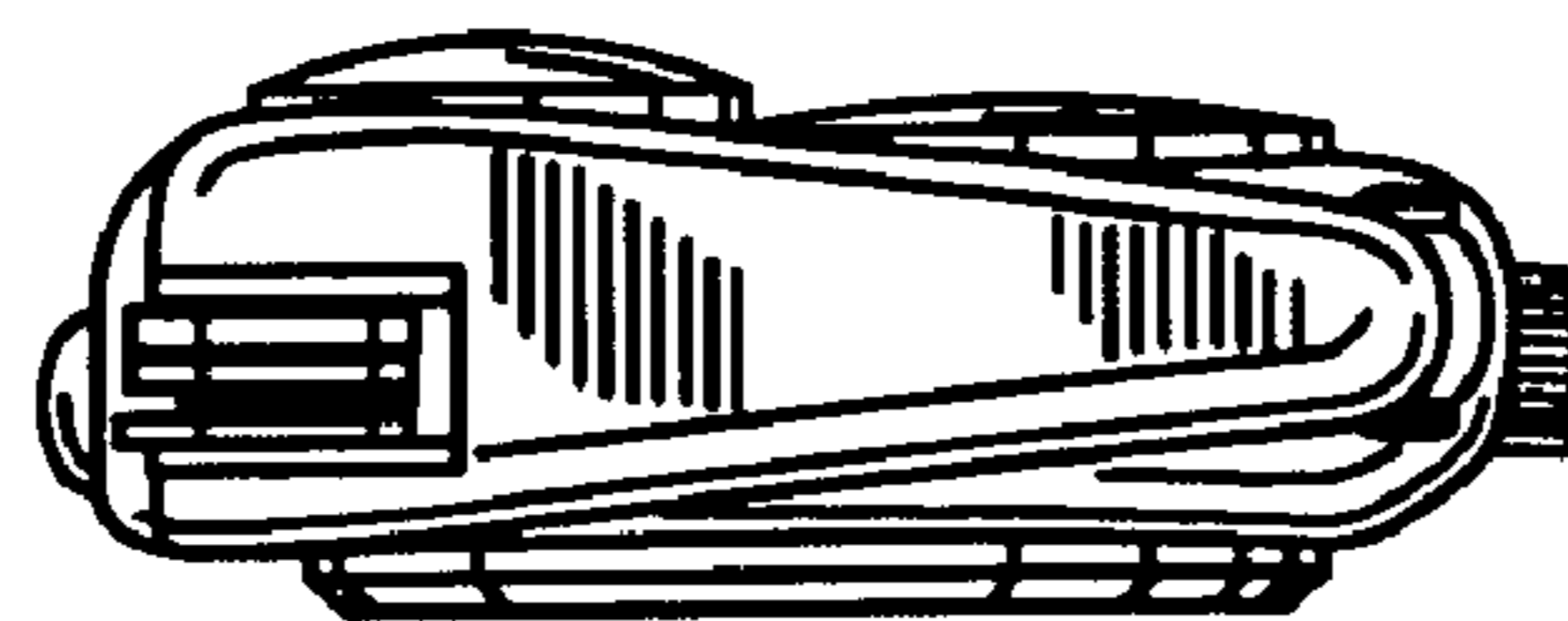
